
### In Search of the ArcheCosmos

 $Considerations \ on \ the \ Shape \ of \ Planet \ Earth$

There is currently a fluorescence of people querying the very nature of our Earth Plane/Planet; questioning if we are on a globe spinning at vast speeds, circling a photon-spewing nuclear furnace, insignificant random meat puppets doomed to paying our "fair share" as slaves to the humanitarian evolutionary grind. This is an encouraging sign.

The main contenders of world views are Heliocentric, Geocentric, Geocosmic (concave), and Planar (flat). This is an overview of the different theories, with evidences of support and denial, in light of

looking to the greater picture. Links are provided to further research the data provided.

In the Goethean approach to the Natural sciences one does not take a plant at any particular stage of its development and state that it is the whole of the plant. Rather one utilizes their cognitive and intellectual capacities to observe and ingest the evidence of the plant growing in metamorphic stages from seed to seed in its natural realm in order to allow for higher order processing and comprehension of the archetypal source of the ideated plant from which the one under observation is both a cause and effect example of planetary faunal life.

The sign of a true intellect is retaining a suspended judgment until all the facts are in and all data is assessed, but apparently such is most difficult or impossible for some, and the dark side of this questioning fluorescence is the persistence of *ad hominums* and general abuse of people who cross into these fields of endeavour holding different opinions. This probably is the signature of a psyop at some level, hijacking of the fluorescence, at least the signature of people whose claim to spiritual insight is a mere characterological shell bolstered by dogma, regardless of its appearance to the uninitiated.

Hidden knowledge is so vast most folks wouldn't believe all of what is going on behind the scenes and has been for centuries, and how much of what they believe about history is false or misrepresented, including natural and scientific history.

One's ability to process data is limited by their worldview, and thus totally factual objective data is often considered false and rejected. If it hits too close to home it causes a biopathically-driven emotional response, usually starting with name calling towards the source. But at the same time those whose worldview is flexible are more open to challenging information. The problem lies in people's inability to keep a suspended judgement, so once they think out of orthodox bounds they don't have the critical capacity to discern the most probable reality and wander off into fantasy.

In the original liberal arts the Trivium consists of Grammar, Logic and Rhetoric, in that order, i.e.

respectively: input-definition, coherence-processing and explanation-knowledge. It is far too common that people put the "logic" of their worldview prior to grammatical assessment of objective reality, so they are never able to define said reality properly, their worldview is sustained, and their output is flawed. This extends to current and historical events, and qualitative and quantitative assessment of the universe and all that which is in it.

So the rule of thumb is to rely on people who have done their research and can objectify their evidence in a logical framework independent of beliefs. If that then fits larger frameworks then one is usually on the right track.

One exploring these realms would be wise to develop the ability to entertain these diverse ideas by thinking out what stages of logic do exist if you were assigned to defend one of these diverse positions in a debate exercise; entertain the idea without necessarily accepting it. Perspective is the greatest of teachers.


As for world views, naturally I grew up with the standard heliocentric model as part of the status quo paradigm, and learned how we scientifically progressed from silly old folks pre-Copernicus who were knuckleheaded enough to consider that the world is in the center of Creation (like they actually experienced). However, I've extended my search openly to fully understand the ongoing search for relationships between cosmologies and a verifiable cosmography. Feel free to do the same.

The extant world views can be put into four general categories with which to consider the arguments for and against them, Heliocentric, Geocentric, Geocentric, Geocentric, and Flat. Here is an overview of these diverse perspectives, with links to further research.

### Heliocentric - Acentric model

"You are insignificant!"

According to the orthodox paradigm Earth is a sphere travelling in an elliptical orbit around the Sun along with the other planets of our solar system, the Sun being one of billions of stars moving



through space at vast speeds in an arm of a spiral galaxy known as the Milky Way, one of billions of galaxies in the so-called "known universe." There is no center; everything is expanding from a hypothetical "Big Bang" allegedly some 13 Billion Earth-years ago.

This view has developed from the time of Nicolas Copernicus, who usurped the ancient views of the flat or spherical Earth as the center of creation, with the heavens cycling around, and replaced it with the concept of Earth rotating upon an axis while orbiting the Sun.

This heliocentric model explains varying brightness of planets and the retrograde motion of planets can be explained through

simple geometry.

It is not that Copernicus directly measured any phenomena from which to evidence his theory, rather he mathematically reduced the geocentrically-observed complex motions of the planets to

their lowest common denominators resulting in the simple orbits of the planets around the Sun. In fact he didn't really do that, he learned from Greek (Euclid, Ptolemy) and Islamic sources (Nasir al-Din al-Tusi, 13th Century) the later from whence he copied diagrams directly.




The concept of Earth as a sphere requisite to the heliocentric model predates the Copernican Revolution.

The ancient Cyrenian scholar Eratosthenes is credited with being the first to calculate the circumference of the Earth globe, as well as the tilt of the globe's axis to its orbital plane. Eratosthenes was librarian at Alexandria, and no doubt accessed vast data.


Eratosthenes measured the angle of the shadows of two vertical sticks at Syrene and Alexandria in Egypt, and from the angles, knowing the distance between the two cities, calculated the Earth's circumference with a fair degree of accuracy.

Flat earthers claim Eratosthenes' experiment supports the flat earth model and that the results can be used to calculate the Sun's height above the Earth by dividing the difference of latitude (7.2°) by the tangent of the angle cast by a shadow at Alexandria (7.2°) when the Sun was directly overhead at Swenet. The oft cited flat earther result is that the Sun is at a height of 3419 nmi. But this method yields different heights for the Sun when other locations are used. This will obviously lead to the paradox that the Sun must be at different heights simultaneously when more than two locations are used.

If the angle were measured at the June solstice at Swenet and at the equator, the result would be the Sun is now at a height of 3243 nmi. The farther away one moves from Swenet the more the height of the Sun decreases. At 40°S the calculated height of the Sun would be a mere 1900 nmi. The graphic below is the flat earth representation of Eratosthenes' experiment on the June solstice with a few more locations added. The red lines are the angles above the horizon of the Sun at local noon (i.e. when the Sun is directly north or south of the location) on the June solstice. Where the red lines meet the black vertical line is the required height of the Sun necessary to match observed reality.



developed the system of latitude and longitude.

It is said that the ancients believed the world was flat, and some certainly did, with a widespread cultural subscription from Eurasia to the Americas. We'll look into this in the **Flat Earth** section ahead.


In the Western stream of knowledge, Pythagoras (6<sup>th</sup> century B.C.) is credited with introducing the spherical Earth concept, with expansion from Aristotle on. <u>How Aristotle</u> <u>Proved the Earth is Spherical</u>: https://youtu.be/vzImgJCgUkg

Ptolemy (2<sup>nd</sup> century A.D.), in his **Geographia**, used the globe model, and

This spherical model used by the Greeks was geocentric, Earth at the center of creation, with the heavens rotating around. Ptolemy, in his astronomical work "Mathematical Treatise" proposed a system with multiple spheres for planets and stars, spheres within spheres (of crystal clear *aether*) to account for the apparent forward and retrograde motions of the planets against the fixed stars, (using epicycles and deferents).


In essence there are main spheres for the Luminaries (Sun, Moon, visible planets) and the fixed stars.

The major turning point in consciousness of Earth's place in the Universe came with the overturning of the Ptolemeic system by the Copernican. Galileo compared the two systems in his Dialogue Concerning the Two Chief World Systems, 1632, an endeavour which found him labelled as a heretic by the Inquisition.


Galileo ignored the Tychonian system which was preferred by astronomers of the time, not taking it seriously. Tycho Brahe, in his Introduction to the New Astronomy (1588) presented a hybrid of the Ptolemaic and Copernican systems. Mercury and Venus orbit the Sun, the Sun orbits Earth, Mars, Jupiter and Saturn orbit the Sun at greater distances.



Tycho Brahe hired Johannes Kepler to help interpret his data on the motions of the planets as observed. Kepler believed in the Copernican system, and after Tycho's death he moved forward with his reconciliation of observation vs calculation, the Tychonian vs the Copernican.

Kepler discovered his three laws of planetary motion:

- 1. The orbits of planets are ellipses with the sun at one focus of the ellipse.
- 2. The line joining the planet to the sun sweeps out equal areas in equal times as it moves along its orbit.



3. The ratio of the squares of the orbital periods for two planets is equal to the ratio of the cubes of the radii of their orbits

This allowed him to discover what is known as the harmony of the spheres, an idea he presented in his *Harmonices Mundi* (*The Harmony of the World*, 1619), the relationships between geometry, music, and the structure of the solar system. Thus was presented an orderly heliocentric system based on the nested geometry of the Platonic solids.

The Tychonian system is mathematically the same as the Copernican system, the difference being that Tycho considered the Earth to be at rest at the center (with Moon and Sun orbiting the Earth, the rest of the planets orbiting the Sun), and Copernicus reduced Earth's position to as merely one of the planets orbiting the Sun. The only way to tell these two systems apart would be stellar parallax, which is predicted by the Copernican system. Tycho's system relied, like Ptolemy's, upon epicycles and deferents, and not simple spheres as diagrams of his system imply.





Parallax is the change in apparent position of an object from different perspectives. Stellar parallax is expected motion of closer stars against more distant ones from different positions of the Earth's orbit around the Sun, say six months apart.

Tycho Brahe's precise measurements of the stars over time showed zero parallax; hence his geocentric model in the midst of the Copernican Revolution. One of Tycho's chief arguments against the Copernican system was the lack of observable stellar parallax, which indicates an unlikely vast empty void

between the outer orbit of the planets and the realm of stars.



Astronomer Royal James Bradley's experiments measuring the position of gamma Draconis from London in 1727 indicated stellar aberration only, due to what he considered Earth's motion around the Sun. Think of aberration as similar to rain coming at an angle when you run into it rather than standing still. However, Bradley did not measure parallax.



Bradley's experiments were followed

by Astronomer Royal George Biddell Airy's negative detection of parallax in his experiments of 1871, the famous "Airy's Failure".

Airy's Failure indicated that the stars move relative to a stationary Earth and not the other way around. By first filling a telescope with water to slow down the speed of light inside, then calculating the tilt necessary to get the starlight directly down the tube, Airy failed to prove the heliocentric theory since the starlight was already coming in the correct angle with no change necessary, and instead proved the geocentric model correct.


This led through the years of ether drift experiments, seeking to find an ether which would be moving with the Earth, pulling the starlight along with it as it rounded the Sun. Of course this was because the Copernican view had settled in and the apparent geocentric results were anathema, so eventually orthodoxy concocted Relativity to



explain it all away (and prevent people from understanding Tesla to boot!).

We will revisit this matter in the **Geocentric** section.

As technology advanced more precise measurements of the stars have been able to be made.




Friederich Bessel measured the parallax of the star *61 Cygni* in 1838, prior to Airy, which is curious that it is never mentioned in discussions of Airy's Failure. But stellar parallax is so minute that that the distances are vastly extended beyond what perhaps may be visible if light intensity decreases by the inverse square law (though if starlight is longitudinal, as in Tesla's LMD currents, the inverse square law would not apply).

The satellite Hipparcos was put up specifically to measure parallax, and it has been relied upon heavily. However, comparing Hipparcos data with parallax measurements from Hubble and ground measurements the "Hipparcos anomaly" of an error of about 55 light

years to the Pleiades was found. It appears this anomaly applies only to star clusters!? So a new satellite, Gaia is now in L2 orbit and the first major data release will be in mid-2016.

So this field of endeavour shows that the movement of the Earth around the Sun is indicated by the measurements, as tiny as they are. We are clearly reliant on the readings of equipment, we cannot directly experience the change of position so measured.

Astrophysicist Millenium Twain has recalculated the parallax data and claims that there is a 'fudge factor' added in, that the stars are actually much closer, e.g. Sirius is 1.8 light years distant rather than the assigned nine (9).

While the parallax experiments are meant to derive Earth's orbit around the Sun, what direct measurable evidence is there to verify Earth as a sphere rotating upon its axis?

Foucault's Pendulum is said to demonstrate that a pendulum of sufficient proportions can track the

rotation of Earth. This was first exhibited in the middle of the 19th Century and is a fixture at many museums around the world.

However, Maurice Allais, in his testing of Foucault's pendulum effects, discovered that during a solar eclipse the pendulum is deviated for the period of the eclipse. This has been proven in further experiments.

This strikes at the validity of the theory of gravity, and brings into question whether or not Earth is rotating beneath the pendulum.

Yet we find in the U.S. Marine Corps Artillery manual **Tactics**, **Techniques**, **and Procedures for the Field Artillery - Manual Cannon Gunnery (FM 6-40; MCWP 3-16.4)** the following chart for calculating corrections "to compensate for the rotation of the Earth". But this then begs the question as to why airplanes flying east and west don't notice more of an effect.


Traditional Celestial Navigation on the oceans is based upon the Earth as a sphere. While using a sextant to derive position from Sun or star is based on simple planar geometry, the actual calculation of position (via longitude and latitude) requires spherical trigonometry.


For short distances where the route is generally known simple Plane Sailing can be used, but this method is useless for long distance sea voyages where knowing one's longitude is essential to arrive safely at one's destination.


Commonly used equatorially mounted telescopes will only work on a spherical earth in order to track the stars so they don't move out of the field of vision during observation, it is programmed to rotate at the same rate as the earth but in the opposite direction. <a href="https://vimeo.com/83318947">https://vimeo.com/83318947</a>

The great suppressed scientific genius Nikola Tesla certainly considered Earth a sphere, and used his view in explaining his Worldwide Wireless transmission of superluminal electric currents. In effect he was converting the Earth from an infinite resistance to a single electrical point, a concept germane to projective geometry.



Superseding the orthodox gravity-based model of the universe is the Electric Universe model. The EU model basically turns the gravity model on its head and allows for experimental investigation and reproduction of cosmic phenomena. This development in the sciences provides a new platform from which to reconsider calculations and measurements of cosmic phenomena such as cosmological redshifts, which are taken as distance measurements, with problems arising such as widely discordant redshifts in connected galaxies, and quasar redshifts up to the equivalent of 200 billion light-years (which if designating time into the past, puts them some 180+ billion years before the alleged Big Bang).






**Binary Orbit:** It has been proposed that our Sun (Sol) is in a binary orbit with Sirius, this being the cause of precession and the Yugas, or World Ages. 



### Hollow earth

There are numerous variations on the Hollow Earth Theory, from ancient legends of peoples of the



interior from around the world, on through Edmund Halley's concept, Jules Verne's & Edgar Rice Burrough's use as a plot device in their fiction, on through numerous books detailing the diverse hypotheses.

Halley proposed an Earth with concentric hollow shells, and an inner luminous atmosphere, said shells having different magnetic fields which he used to explain anomalous compass readings.

John Symmes, in the early 19th Century, proposed a Hollow Earth model consisting of a shell about 800 miles thick with other concentric inner spheres as per Halley, and proposed huge openings at the poles.

Marshal Gardner, in the early 20th Century, proposed a Hollow Earth with a Sun in the center, he patented a Hollow Earth globe, U.S. Patent #1096102

Some writers developed more the idea of an inner world, appearing much as our outer world, by metaphysical mechanics, with the inner Sun being plasmic or organic in nature, and functioning in such a manner as to cause the appearance of day and night.

Also, it was a general theme positing the openings at the poles. It is said that Admiral Byrd flew into one of these at the North Pole, but the data supporting that story ("Secret Diaries") is suspect, and there is a dearth of useful satellite photos of the poles to follow this claim up. The Hollow Earth Theory is not reliant on the holes at the poles claim, which is but one perspective.

There is the theory that we are on the inside of the Hollow Earth, and that subject will be dealt with in the next section. Pictured here is a Hollow Earth Qabalah proposing metaphysical archetypes as a methodology for cognising the hollow Earth as a functional reality.



While this theory doesn't fit all the data, it does provides many interesting considerations as far as the origins of the geological column itself, along with some of the petroleum deposits. 



### **Geocentric - Anthropocentric Universe**

"People need to be aware that there is a range of models that could explain the observations... For instance, I can construct you a spherically symmetrical universe with Earth at its center, and you cannot disprove it based on observations... You can only exclude it on philosophical grounds... What I want to bring into the open is the fact that we are using philosophical criteria in choosing our models. A lot of cosmology tries to hide that." - George Ellis, Scientific American, October 1995,

Geocentrism is the belief that Earth is in the center of the universe. Whatever Earth model people believed in, spherical, flat, etc, in general prior to the Copernican Revolution all models assumed Earth at the center of Creation. This is certainly understandable, as this is how we directly perceive our place in the world.

The Tychonian geocentric model is still used today for astronomical calculations, so there is definitely a very real 'apparent' aspect to it as far as functionality.




Figure 7.3 The So-Called Ether Drag' Experiment Of Fizeau Which Paradoxically Determined The Velocity Of Light In A Moving Medium (Water)

Orthodoxy also uses the negative results of the ether drift experiments as a platform to launch Einstein's Relativity Theory.



Except the Michelson-Morely paper says no such thing.

It specifically says: we find the aether drift to be probably less than 1/6 the orbital velocity of the earth and perhaps as high as 1/4 the orbital velocity of the earth. (Top of page 341 in the original.)

An aether drift of 1/6 the orbital velocity of the earth would be about 5.7 kilometers per second, which is well within the 4-40kps predictions of the time. Obviously a velocity of 1/4 the orbital velocity of the earth would be even faster.



Rudolf Steiner's anthroposophical indications to scientists and agriculturalists in his erudite circles supports an anthropocentric functional system.

Lilly Kolisko, for example, did four decades of crystallization experiments with metallic salts. Steiner tasked her with physically describing a link as considered in alchemy between the noble metals and the 'planets' of old (the luminaries); Sun-gold, Moon-silver, Venus-gold, Mars-iron, Jupiter-tin, Saturn-lead. 



Rudolf Hauscka, founder of Wala Pharmaceuticals (Dr. Hauscka's cosmetics are named after him) did experiments following on from earlier experiments, where sprouts were grown from standardized seeds in distilled water inside sealed containers, and their weight was measured by accurate scale. It was shown that matter appears and disappears as the Moon goes through its phases,



then they were autoclaved and mineral analysis performed. The mineral content was then charted on a timeline. Over a dozen years Hauscka showed that specific elements have a measurable connection into the plant world at specific times of the year, as the sun processes around the ecliptic.

Then there is the obviously related cosmological botany dealing with plant tropisms and forms, based on both the helio and geocentric motions of the planets, and also providing comprehension of gravity being the common name one pole of the gravity-levity polarity:

We find that in the realm of life. Gravity is not a single force, but one pole of a primary polarity, the other pole is levity. Levity is natural in the older forms of consciousness, it was the mid-15th century Platonic Academy, also knowns as the Florentine Academy that put stop to that with their *Contra Levitatem* dictate at the birth of modern chemistry and materialistic science. 


Fig. 46 Inflorescences of the *Umbelliferae* with their double structure in the space above the shoot in its relationship to the spheres of Mars and Jupiter containing the sun.

diameter, instead of on the outside of a convex globe.





The premise for this is that it is a more compact, functional Creation, for creation happens within shells and wombs, our shell being the generative container for our development.


This concavity allows for explanations of such phenomena as the horizon always being at eye level at great elevations above sea level, at least up to the outer atmosphere. Appearances of Earth being beneath at greater heights are explained by light ray curvature and atmospheric refraction. Also, the apparent flatness of the Earth, as seen across the seas, is also attributed to this curvature of light.

The fact that buildings and mountains can be seen at a greater distance than Earth curvature will allow has long been held as proof of the Geocosmos.

The visible Sun, Moon and stars are projections on our outer atmosphere from higher metaphysical mechanics.



To prove his contention as to the shape of the Earth Koresh and his followers used a device called the Rectilineator, invented by his associate Professor Ulysses G. Morrow, to geodetically measure



There was a top secret Nazi program to research the geocosmos. In 1942 Dr. Heinz Fisher, an expert



in infrared, led an expedition to the Baltic island of Rügen. This was under the express approval of Goering, Himmler and Hitler, and was considered by the Admiralty General Staff to be of critical importance to the war effort.

The experiments were to obtain infrared imaging of the British fleet in the North Sea from the Baltic by pointing their equipment at a 45° angle to the sky.

Reports are that the experiments failed, and some of those involved, Peter Bender and others, were imprisoned.

Nonetheless, top German scientists using precious resources at the height of WWII makes one wonder what info they had to consider and execute this operation (and they did much more along those lines too!)

Some say that such efforts were part of the purpose of the German base at Neuschwabenland in Antarctica, to get out of the hollow earth and see the outside world.

Another indication of Earth's concavity is the so-called Tamarack Mine Mystery, where 4250 foot long plumb bobs were suspended down parallel minshafts at the


Tamarack Coper mine in Michigan. Simple geometry could then be used to measure the size of the planet, but instead of the bob ends being closer together they were farther apart. Teed and Morrow utilized the results of this experiment in their thesis.

## A GEOCOSMOS: MAPPING OUTER SPACE INTO A HOLLOW EARTH

### Abstract


We regard the earth's surface as a sphere and apply a purely mathematical mapping taking outer space in the Copernican universe (C) into a hollow earth, Geocosmos (G). The enormous galaxies and other remote objects are mapped inside as microscopic objects, and our moon as by far the largest of the celestial objects, all of which revolve daily around the earth's axis. Straight rays of light are mapped as arcs of circles, so that all celestial phenomena appear to inside observers in G just as they do to outside observers in C. We next consider the hypothesis that, conversely, our actual universe is this finite G. Then there seems to be no way of testing this, except by drilling a hole right through the earth's centre. However, In C the origin of cosmic rays of super-high energies is very controversial, whereas in G it is unequivocal. The idea of G was first conceived qualitatively by Karl E. Neupert in 1900: our revival is somewhat different. The main appeal of G stems from the very grave difficulty of believing in the fantastic vastness of C, and the consequent reduction of the earth to an infinitesimal.

The concave model does not deny the possibility of other worlds with life, rather the universe can be infinite and filled with life, yet we're still concave. In this model space is dimensional, projective.

Space is not 3D, the three dimensions are imposed by our consciousness in its assessment of objective reality. The three dimensions are proprioceptive, that is, internalized and requisite to our orientation. Steiner indicated it was a grave error of materialistic consciousness to externalize them as a metric of space. Space functions on projective geometry, with a spatial-counterspatial polarity.

In ancient cosmological diagrams the "spheres" of the heavens are shown. If one considers these as true dimensionally layered formative spiritual stages seen in the light of projective geometry and spatial-counterspatial polarities in extension, then it is no problem fitting a universe inside such an anthropocentric sphere.

Whether or not this can be proven, whether the true nature of our Earth plane, convex, concave, or



flat, can be absolutely determined by measuring and calculating, these are certainly fascinating considerations most interesting to research.



These flat Earth models existed in part as both cosmology and cosmography, though these connections were progressively severed as cosmologies lost touch with the inner spiritual structures and cosmographies became more materialistic in their search for the true nature of objective manifestation.

While scientific and philosophical observations over the last 2500 years have been in general support of the spherical model of the Earth, there is now a resurgence of interest in the flat Earth model, with fascinating questions being posed. What is important here is that people are questioning the very pillars of reality, though it

appears much is based on fundamental beliefs and limited knowledge. Nonetheless, it signals another stage in the awakening of humanity, whether it is engendered into a larger scope or used to limit and detain consciousness is a matter to be discerned as time progresses.

It is often said that in the past all people thought the world was flat, and Columbus set out to prove it was spherical. However, Columbus believed the Earth was round, he was simply wrong on the size calculations, assuming he would find Asia where the Americas are. The consideration of this flat Earth myth has been shown to be incorrect:




With debate, open challenges, and experiments people are actively seeking evidence for either flatness or curvature of the Earth. The Flat Earther's are at a disadvantage, as there is much data to confirm a definite spherical nature to our Earth Plane, but that does not daunt the hardcore and no doubt that if this matter is pursued with an open mind that we will be able to further refine our cosmographical universe.

There are certainly what appear as anomalies with the horizon, it looks flat and remains at eye level to great heights (which is one of the claimed proofs for the Geocosmos). For example, many lighthouses can be seen from far beyond what Earth's curvature should allow, according to certain mathematical equations and understandings of our perspectives given


Earth's size and diverse atmospheric optical phenomena.

One common response to a ship disappearing into the horizon line by spherical Earth adherents is that this is proof of the curvature of the globe. This false belief can easily be disproven with a telescope. A ship that appears to disappear over the curvature will come back into view with a telescope. The ship is disappearing into the horizon line.



Oft repeated examples of distant 'over the curve' sightings from the Flat Earth community:

- The Egerö Light in Norway is 154 feet above high-water and visible from 28 statute miles where it should be 230 feet below the horizon.
- The Light at Madras, on the Esplanade, is 132 feet high and visible from 28 miles away, where it should be 250 feet below the line of sight.
- The Cordonan Light on the west coast of France is 207 feet high and visible from 31 miles away, where it should be 280 feet below the line of sight.
- The light at Cape Bonavista, Newfoundland is 150 feet above sea-level and visible at 35 miles, where it should be 491 feet below the horizon.
- The lighthouse steeple of St. Botolph's Parish Church in Boston is 290 feet tall and visible from over 40 miles away, where it should be hidden a full 800 feet below the horizon!
- The Isle of Wight lighthouse in England is 180 feet high and can be seen up to 42 miles away, a distance at which modern astronomers say the light should fall 996 feet below line of sight.
- The Cape L'Agulhas lighthouse in South Africa is 33 feet high, 238 feet above sea level, and can be seen for over 50 miles. If the world were a globe, this light would fall 1, 400 feet below an observer's line of sight.
- The Statue of Liberty in New York stands 326 feet above sea level and on a clear day can be seen as far as 60 miles away. If the Earth were a globe, that would put Lady Liberty at an impossible 2,074 feet below the horizon.



This link is to a demonstration showing the Hawaiian island of Oahu being visible from Kauai airport 90 miles away, where it should supposedly be below 5400 feet of Earth curvature at that distance according to the calculations used, which is about 8 inches per mile, squared over distance on a sphere. The presenter uses camera footage and calculations from a CAD program to show that what is being seen in the distance is supposed to be beyond the curve, there are many such presentations, this one shows precision measurements, but doesn't consider atmospheric refraction or looming effects, and doesn't tell us if this happens at all times or changes with atmospheric optical density and related phenonenon:





Illustration Showing that Refraction Increases the Perceived Distance to the Horizon.

### **Distance to the Horizon:**

**d=h+SQRT(2Rh)** is the proper equation (d= distance, h=height, R=radius). Then adjust for eye height and refraction.

An excellent discussion from the orthodox perspective is given here, which is interesting because it confirms long distance sightings:

Here in San Diego, we rarely can see San Clemente Island, about 125 km offshore. The top of the island should just be visible above our horizon with normal refraction, but it's concealed by "airlight" during the day. Even in the clear air of a "Santa Ana," which causes <a href="looming">looming</a> and raises more of the island above the apparent horizon, it's often hard to make out.

But just after sunset, the island is often visible, if you know where to look. The air between you and the island is only dimly illuminated after sunset, but the sky behind the island — i.e., the air beyond the horizon that is still in direct sunlight — is still fairly bright. Then the silhouette of the island is striking, even if it had been invisible a few minutes before sunset.

The Sun itself <u>can be seen</u> through a long duct when it is several degrees below the astronomical horizon; however, its image is then so <u>distorted</u> that any intervening terrestrial object (such as an island, a mountain, or even a cloud) would probably also be so distorted that its silhouette against the Sun would be unrecognizable. Some extreme claims can surely be discounted, such as <u>Jessen's 1914</u> illusion. (Jessen claimed to have seen a mountain nearly 900 km away, but he certainly did not; <u>Korzenewsky (1923)</u>, who refers to this report in a footnote, somehow inflated that to 1177 km.)

What's the record for visibility without help from the silhouetting effect? I think that might belong to the report of the expedition led by Korzenewsky (1923), who reported seeing snow-capped peaks of a mountain range 750 km away. Conditions were perfect: the lower atmosphere was in shadow at sunset; the peaks were quite high (4650 meters, or over 15,000 feet); they were covered with white snow, increasing their visibility; and there must also have been considerable looming to bring these distant features above the observers' horizon. As the observation was made on June 1, near the peak of superior-mirage season, the looming is not improbable, though the amount required is hard to believe. The observers themselves were in the deserts of Turkestan [now southeastern Kazakhstan] at a height of nearly a kilometer, where the dryness of the air favored extreme clarity, and looking across a broad, sandy depression. And, of course, much of the air path was in thinner air well above ground level, because of the mountains' height.

For less extreme, but very reliable, observations, consider some listed by Commander C. L. Garner of the Coast and Geodetic Survey in 1933. He says that instrumental measurements were made in both directions "between Mt. Shasta and Mt. St. Helena in California, a distance of 192 miles." [That's 309 km.] Apparently this was done in normal conditions, with no looming; heliotropes having 12-inch [30-cm] mirrors were used. He also credits the 1911 sighting of the Fairweather Mountains in Alaska from the ship *Explorer* from

So we can see that there is much contention to get an exact answer to how far one can see a distant object on a spherical Earth, with all matters, proper equations, atmospheric phenomena, time of day, etc, are taken into consideration.

The flat Earth school claims these flat horizon anomalies are

proof our world is a flat plane and there has been a massive conspiracy to cover this up. NASA's various photo releases over time of Earth from space suspiciously show definite differences in continent size in comparison to the apparent curve.

Scientists have claimed Earth is an oblate spheroid, flattened at the poles and bulging at the Equator, and possibly pear shaped, but where do you see that in the NASA photos?

"The shape of the Geode, as it is called, is nearly a perfect sphere, but because the earth is spinning, it is about 21.5 kilometers flatter at the poles, and bulged-out at the equator by about the same amount. There are also other 'higher-order' shape deviations which make the Earth slightly pear- shaped with a larger southern hemisphere surface area than in the northern hemisphere, but at a level of a kilometer or so in radial girth. The biggest effect, though, is its polar flattening. If you had a basketball to represent the Earth's spherical average shape, the flattening would be 21/6500 = about 1/300 the radius of the basketball or 1/32 of an inch...give or take."







There are certainly large scale engineering projects such as railways and canals which are constructed as though the Earth is flat.

The Suez Canal which connects the Mediterranean Sea with the Gulf of Suez on the Red Sea is a clear proof of the Earth's and water's non-convexity. The canal is 100 miles long and without any locks so the water within is an uninterrupted continuation of the Mediterranean Sea to the Red Sea. When it was constructed, the Earth's supposed curvature was not taken into account, it was dug along a horizontal datum line 26 feet below sea-level, passing through several lakes from one sea to the other, with the datum line and the water's surface running perfectly parallel over the 100 miles. The average level of the Mediterranean is 6 inches above the Red Sea, while the floodtides in the Red Sea rise 4 feet above the highest and drop 3 feet below the lowest in the Mediterranean, making the half-tide level of the Red Sea, the surface of the Mediterranean Sea, and the 100 miles of water in the canal, all a clear continuation of the same horizontal line! Were they instead the supposed curved line of

globe-Earthers, the water in the center of the canal would be 1666 feet  $(50^2 \times 8)$  inches = 1666 feet 8 inches) above the respective Seas on either side!

"The distance between the Red Sea at Suez and the Mediterranean Sea is 100 statute miles, the datum line of the Canal being 26 feet below the level of the Mediterranean, and is continued horizontally the whole way from sea to sea, there not being a single lock on the Canal, the surface of the water being parallel with the datum line. It is thus clear that there is no curvature or globularity for the whole hundred miles between the Mediterranean and the Red Sea; had there been, according to the Astronomic theory, the middle of the Canal would have been 1,666 feet higher than at either end, whereas the Canal is perfectly horizontal for the whole distance. The Great Canal of China, said to be 700 miles in length, was made without regard to any allowance for supposed curvature, as the Chinese believe the Earth to be a Stationary Plane. I may also add that no allowance was made for it in the North Sea Canal, or in the Manchester Ship Canal, both recently constructed, thus clearly proving that there is no globularity in Earth or Sea, so that the world cannot possibly be a Planet." -David Wardlaw Scott, "Terra Firma" (134)

"If the earth be the globe of popular belief, it is very evident that in cutting a canal, an allowance must be made for the curvature of the globe, which allowance would correspond to the square of the distance multiplied by eight inches. From The Age, of 5th August 1892, I extract the following: 'The German Emperor performed the ceremony of opening the Gates of the Baltic and North Sea Canal, in the spring of 1891. The canal starts at Holtenau, on the south side of Kiel Bay, and joins the Elbe 15 miles above its mouth. It is 61 miles long, 200 feet wide at the surface and 85 feet at the bottom, the depth being 28 feet. No locks are required, as **the surface of the two seas is level**.' Let those who believe it is the practice for surveyors to make allowance for 'curvature' ponder over the following from the Manchester Ship Canal Company (Earth Review, October, 1893) 'It is customary in Railway and Canal constructions for all levels to be referred to a datum which is nominally horizontal and is so shown on all sections. **It is not the practice in laying out Public Works to make allowances for the curvature of the earth**." -Thomas Winship, "Zetetic Cosmogeny"

However, we also find that Earth curvature is calculated into large-scale construction projects in our present day:

Verrazano Narrows Bridge: "Because of the height of the towers (693 ft or 211 m) and their distance apart (4,260 ft or 1,298 m), the curvature of the Earth's surface had to be taken into account when designing the bridge—the towers are 15/8 inches (41.275 mm) farther apart at their tops than at their bases; they are not parallel to each other." https://en.wikipedia.org/wiki/Verrazano%E2%80%93Narrows\_Bridge

Earth curvature is also taken into account in the construction of particle accelerators such as the Japan Proton Accelerator Facility (J-PARC) and the SLAC National Accelerator Laboratory in Menlo Park, California, the latter is known as the "straightest object in the world."

Right now, I'm at "the straightest object in the world". The SLAC National Accelerator Lab. As others have mentioned, the curvature of the Earth is something like "8 inches a mile".



Well our linac is 2 miles long and we need it to be actually straight and not follow the curvature of the earth. Otherwise the electrons will hit into the walls and the whole thing won't work. So the center of our linac is in fact closer to the Earth's center than the edges by about 8 inches.

So yes, curvature of the Earth does matter for some buildings.

"There's a landmark reflecting pool in Boston that is 670 feet long. It's at the Christian Science Center. They originally aligned the edges of the pool with lasers, which resulted in perfectly straight walls, but didn't account for the ~1" of curvature at that distance. (editor: would be much less) At the midpoint of the structure, the water spilled over the walls. Of course precision was only an issue here because it was filled with water and designed to look edgeless as you can see in this. But that's an example where you absolutely can't neglect the curve!"

So we can find evidence both for and against these positions.

One question often asked is, if the Earth is flat, why don't we fall off the edge? There is of course an answer.

One of the pillars of Flat Earth thesis is that Antarctica is actually a ring of ice encircling the flat Earth and keeping the waters in. The Antarctic Treaty is the only international treaty which has been honoured by all parties, which does make it very unique. And the Flat Earth folk claim that it is forbidden to go to Antarctica, than anyone attempting will be met with military force to prevent them from discovering what is past the ice wall. The United Nations map, based on the Azimuthal Equidistant Projection map is claimed to represent the Flat Earth, with sprigs of leaves where Antarctica should be.




However, many of the claims about Antarctica don't hold up under basic scrutiny.

In Eric Dubay's "200 Proofs Earth is Not a Spinning Ball", which has many wild statements easily refuted, we find "proof" number 42:

In the ball-Earth model Antarctica is an ice continent which covers the bottom of the ball from 78 degrees South latitude to 90 and is therefore not more than 12,000 miles in circumference. Many early explorers including Captian Cook and James Clark Ross, however, in attempting Antarctic circumnavigation took 3 to 4 years and clocked 50-60,000 miles around. The British ship Challenger also made an indirect but complete circumnavigation of Antarctica traversing 69,000 miles. This is entirely inconsistent with the ball model.

This claim has been repeated endlessly as gospel in online forums, but a simple check of the historical record shows that this is clearly not true. Unfortunately, the Flat Earth movement is rife with these false statements, carried forward by a strong fundamentalist core.

A lot of the Flat Earth claims about what stars can be seen where on Earth, such as that Polaris can be seen up to 20 degrees Southern latitude, show not only a propensity for exaggeration, but also a complete



misunderstanding of observable celestial mechanics, even from the Tychonian perspective (which is what we actually observe). However, it is certainly a most curious affair that if we are moving through the universe relative to all other cosmological bodies that we see the same star patterns over millennia. Either the distances are extremely vast, as is claimed to uphold that model, or they are closer in and we need to consider advancing our paradigms. Nonetheless, the stars are observable and calculable as if we are on a sphere and either rotating under the heavens or the heavens rotate around us.

We can credit the Flat Earth movement with getting people outside to look at the Earth and sky. It is most surprising to hear numerous people being astonished by seeing both Sun and Moon in the sky at the same time, and claiming such as proof of a flat Earth, while many of us have noticed such normality since young.

One of the claims is that there have been impossible lunar eclipses, with the Sun and Moon visible at same time; but this phenomenon, known as a selenelion, is easily explained:

This year's second total lunar eclipse on Saturday (Dec. 10, 2011) will offer a rare chance to see a strange celestial sight traditionally thought impossible.

For most places in the United States and Canada, there will be a chance to observe an unusual effect, one that celestial geometry seems to dictate can't happen. The little-used name for this effect is a "selenelion" (or "selenehelion") and occurs when both the sun and the eclipsed moon can be seen at the same time.

#### Seeing the impossible

But wait! How is this possible? When we have <u>a lunar eclipse</u>, the sun, Earth and moon are in a geometrically straight line in space, with the Earth in the middle. So if the sun is above the horizon, the moon must be below the horizon and completely out of sight (or vice versa).

And indeed, during a lunar eclipse, the sun and moon are exactly 180 degrees apart in the sky; so in a perfect alignment like this (a "syzygy") such an observation would seem impossible.

But it is atmospheric refraction that makes a selenelion possible.

Atmospheric refraction causes astronomical objects to appear higher in the sky than they are in reality.

A horizontal eclipse of the Moon takes place when both the Sun and the eclipsed Moon are visible for a short time above the horizon. According to Pliny the Elder, the phenomenon had been recognized two centuries earlier than his time by Hipparchus; and in the most important discussion of the phenomenon in antiquity the Hellenistic astronomer Cleomedes correctly ascribed what he called the 'paradoxical eclipse' to atmospheric refraction, whereby the observed altitude of bodies near the horizon exceeds their actual altitude.1 The fact of atmospheric refraction itself was well known, and although Ptolemy's *Optics* remained in manuscript until modern times, its discussion, in the fifth

book, of atmospheric refraction influenced medieval students of optics, including Witelo, Roger Bacon and John Pecham, and through them their early-modern successors.2

The horizontal eclipse continued to exercise early-modern astronomers. Some simply denied its possibility. Others supposed it to be due to atmospheric refraction or the operation of vapours rising from the Earth. Kepler's teacher Michael Mästlin claimed to have observed a horizontal eclipse in 1590, and Kepler recalled this observation in his 1604 *Ad Vitellionem Paralipomena* in the context of his own discussions of the refractive properties of the atmosphere. Kepler himself apparently managed to observe a horizontal eclipse in Linz on 26 August 1616, and Pierre Gassendi was frustrated three times by bad weather between 1643 and 1648, before a domestic servant of his caught sight of one at sunrise on the plain of Avignon. By the mid-century, therefore, three horizontal eclipses had been recorded as observed, and the emphasis now shifted to explanation.

Another claim is that the moon is somehow transparent, that stars can be seen in front of the Moon. The transparency claims are no more than a misunderstanding of atmospheric color phenomena. However, stars and planets have been noted passing part way in front of the moon, what we can call delayed disappearances. These are most interesting, but appear to be some sort of refractive phenomenon, always briefly by the limb. Here is one classic example:

At the occultation of Zeta Tauri on March 28th, 1868, I had the good fortune to witness the phenomenon myself, and the event is indelibly fixed in my memory by the surprising beauty of the spectacle as well as by the entirely unexpected nature of the occurrence. The disappearance too place at the dark limb which was distinctly visible, and the atmospheric circumstances were eminently favourable. The star remained on the disk for at least five seconds, and very possibly longer and its distance from the limb was considerable. Sun: Golden, warm, drying preservative, antiseptic, increases combustion, dries, shrinks, coagulates




<u>Moon:</u> silver, cool, damp, putrefying and septic, inhibits combustion, putrefies and decays

A thermometer in the shade reads lower than one in the Sun, as makes sense to us; however, it is claimed a thermometer placed in direct moonlight will read lower than one in the shade, with the Lancet Medical Journal, March 14, 1856 reports particulars of experimental measurement of concentrated moonlight reducing the temperature readings on a thermometer.

Interestingly, we find in a report on Baron Karl von Reichenbach's research on the Odic Force, which he discovered through studying sleepwalkers found to be triggered by moonlight, these effects of sunlight and moonlight filtered down wires into a darkened room where the sensitive sleepwalker was:

Sensitives were again asked to rest in a completely darkened room and report their sensations. They were not told what to expect. In the dark, the Baron introduced the wire braid. He had placed it into various portions of solar or lunar spectra, waiting for their honest responses. Without prompting or coaching, each independently reported the very same sensations and impressions. As the braid came within a set distance, each immediately felt the strange sensations, which radiated from the end. Moonlight always produced hot irritations and cramps. Sunlight violet always produced cool pleasantries, the reversal of night fears. Here was a more scientific distinction, which differentiated the historical preferences for sunlight or moonlight in different individuals. 
Back in August 1993, the Perseids were expected to be anything but normal; Comet Swift-Tuttle had passed Earth's orbit in 1992, and astronomers predicted an unusually intense shower. Spacecraft operators took steps to protect their vehicles.

But one spacecraft, the European communications satellite OLYMPUS, could not take precautionary measures. OLYMPUS already had been dealt an unlucky blow by a sporadic meteoroid, which disabled one solar array's pointing system. So OLYMPUS was stuck facing the oncoming Perseid stream.



So yes, the world is round, and yes, the world is flat. Perhaps not the answer one expects, but worthy of some Zen-like ponders.




