## TOWARDS INDUSTRIAL FREEDOM

#### INTRODUCTORY

ALTHOUGH the following papers were mostly written before the Great War broke out, vet it will be noticed that the consciousness runs through them of a great impending crisis and transformation of our social arrangements, both in this country and in Western Europe. It may not have been clear at that time exactly how that crisis would come about: but now that the War is on us we can see how inevitable in a sense it has been, and how this deadly strife of nations has flowed (in the main) from the hopeless falsity of the social and industrial conditions prevailing in the countries concerned—the falsity of undemocratic societies divided into classes whose chief object in life was to prey upon each other; the falsity of a so-called social order which ignored the rights of women; and the falsity of an industrial system whose real object was not public welfare but private gain, not the production of goods for use but the exploitation of labor for

profit. Robbery and strife, more or less covered over and concealed by canting phrases, have eaten deep into the heart of these nations, and that over a long period; and now at last we see that it was inevitable that some time this spirit of enmity and inhumanity, this internal disease, which has for so long afflicted us, should break forth and come to the surface, if even in the thunder of guns and the drenching of Europe with blood.

In a way the fact that some of these causes of disaster were traced and exposed (as they were by many Socialist thinkers) long before the disaster itself arrived, gives their exposure additional validity and force. Whatever sideissues there may be in the present catastrophe, we cannot doubt that financial greed and profitmongering, made all the more possible by the domination of the profit-mongering classes, have been at the bottom of the trouble. The war began with the speculative plotting of Germany for the development of Mesopotamia and the Baghdad Railway, and now England is apparently showing her high moral disapproval of this by taking over the development herself! Whatever may be thought about individual and isolated instances. it is evident that commercial ambitions, and the consequent demand for the annexation of territory, have for long enough in all the nations concerned been leading up to a crisis of deadly conflict: and the connexion of this with classdomination is well illustrated by the fact that

Russia with the change of her Constitution has immediately repudiated the desire for annexation, while the Socialists of Germany and the other countries repudiate it also.<sup>1</sup>

But the long foreground of this tragedy, and its deep and intimate genesis out of the very heart and habits of the various nations, must persuade us of something else—namely that it is not destined to pass over very quickly; and that its results will be profounder, longer-enduring and more far-reaching than we have even vet dared to imagine. Guglielmo Ferrero, the Historian of Republican Rome, points out in a late article in Il Secolo, the extraordinary shortsightedness of the views held about the present European situation by the politicians generally. "Great things," he says, "are maturing in the world. From one end to the other there is preparing the most gigantic trial or test (ordalia) that ever has been seen, of States, dynasties, nations, parties, religions and philosophical doctrines. It is like a universal Judgment day. Worldly crowns

It is interesting to find that so long ago as 1805 a certain Dr. Hall writing on the evils of modern civilisation said: "In consequence of the rich of most of the different civilised nations of Europe all coveting the same things, the countries producing those things are the continual objects of contests and wars between these different powers. These wars are easily excited by the rich, who are either themselves the persons with whom lies the power of making war and peace, or are the persons who have great influence with those who have that power" (The Effects of Civilisation on the People in European States, by Charles Hall, M.D., 1805).

and powers, with their ancient glories, their idols, their altars and their faiths are apparently ready to roll in the dust"; and yet while the one living idea which can save society is that of a new social order resting on reason and on justice "there have so far only appeared on the scene, old men, professing old ideas, making use of old principles, repeating ancient discourses, and seeming to be willing to do anything rather than change their old habits of the courtier, the official, and the Parliamentarian."

I have no intention here of entering into political questions: but certainly in the social and industrial field the limitation of outlook among our British leaders is little short of astonishing. all the talk lately about the renovation of the country after the war, about the finding of employment for returning soldiers, the planting of the people on the land or in industrial life, and so forth, it seems to be taken for granted that when things settle down again, our general industrial system will return as before: that "employers" will once more "find work" for their men, that the "employed" will be only too thankful to escape from prowling the streets: and that (of course) nothing will be produced unless it yields a "profit" to some one—a dividend to a shareholder or a rent to a landlord. There seems to be no suspicion of the possibility of any other arrangement—or if there suspicions they are indeed kept dark!

Similarly with regard to our foreign trade, great caucuses and conferences are being held with the object of diverting trade from its natural channels in such a way as to benefit ourselves and do despite to our "enemies." It is of course a case of trying to make water run uphill. Yet there seems to be no foresight of the fact that with the growing internationalisation of world-traffic (not to mention the growing internationalisation of the peoples themselves) such schemes are doomed to failure, or at most to a very short-lived success.

Nothing seems to me more certain than that our whole commercial system, both as regards internal economy and as regards foreign trade, is on its last legs, and that it is doomed to dissolution -or at least to such a transformation in spirit as will be equivalent to a dissolution of its present form. And surely such a dissolution is not only to be expected, but truly to be prayed for. After a career of a century and a half during which it has defiled the world with every kind of moral stain and physical ugliness, it is surely time that the Shop-keeping Age should pass away. Doubtless it has had, for its time, a function to fulfil -it has had uses in the winning for mankind of all sorts of external facilities and values, and in the scattering of "comforts and conveniences" -telephone- and water-closets and the like-all over the habitable globe; but now surely it will be seen that its main use can only have been as

a preparation for something infinitely more valuable, to come after.

As a matter of fact Bankruptcy, in more senses than one, impends over the nations of Europe, and it is curious, as Ferrero says, that, despite that obvious fact, the statesmen and politicians of the various countries go on playing the old trivial games, like gamblers in the midst of an earthquake, oblivious or unheeding that at any moment the house they are in may come tumbling about their heads.

In this country the absence of any real grasp of the situation among our leaders—even among our Labour-leaders—is most curious. Mr. Bonar Law tells us, in a quite jaunty way, that we are spending £7,000,000 a day—but confesses that he has no effective knowledge of, or control over, the accounts. Everything goes smoothly so far; and there is a general impression that we "shall come out all right." Certainly, just above Niagara the water does flow very smoothly, though with a swift and ever swifter course. "Sit still and shut your eyes," says the War Office, "and we will censor the Press so that the public shall not be able to look ahead, even if it wants to."

And supposing for a moment that Bankruptcy (in the strictly financial sense) does not ensue. What then? Why, for the United Kingdom so enormous a permanent debt that some 300 or 400 millions sterling will have to be paid yearly to the bondholders for the rest of mortal time!

Does any one for a moment suppose that the people of this country—already weighed down to the ground by mortgages, dividends, and taxation of all kinds—are going to bear this added burden, that they possibly can support it? Great as the sufferings would be which Bankruptcy would entail, they would not be a tenth of those caused by this alternative. And yet we talk glibly about "winning the War"!

Germany—whether in Socialist or Imperialist hands—will probably repudiate her debts. We might, if we like, say that being accustomed to tearing up scraps of paper she will make no great demur about doing so—and of course the fact of her debts being all internal, among her own people, will make this course easier. England will be more unwilling to repudiate, but may of course in the end be forced to do so. France will follow suit, and possibly also Italy and Russia. The Americans will be left to boss the world.

The outlook is not cheerful. But these and many other things all point to the same conclusion—the necessity of considering very seriously, as far as this country is concerned, what are to be its industrial forms in the future. I feel myself that to lay down any hard and fast doctrine on this subject would be rash. It would certainly be foreign to my intention. On the other hand we can see some very distinct directions in which men's minds are moving, and certain clear con-

ditions for the coming organisations, without which we should not be satisfied; and I have thought it best, in the following papers, to make suggestions with regard to these without attempting to be too Utopian or doctrinaire. The course of evolution is always difficult to forecast, and to turn beforehand even the very next page of the history of one's own country is impossible. Nevertheless, like a good sportsman, one can prepare oneself for every emergency, one can guess from the lie of the ground what game is likely to appear and with what kind of situation one may have to deal.

In the first of the following chapters I have sketched rather roughly the evils which arose from the industrial arrangements of the early part of the last century, and the reforms into which these evils forced us. In the later chapters I endeavour to infer what further transformations we may expect in the future. These transformations will, I take it, be largely of a psychological character that is, they will depend on a changed mental attitude towards life, on a changed estimate of values, even more than on a change of institutions. When people come to value beauty in our daily life more than they do now, when they long intensely for that kind of industrial freedom which causes men's handiwork to become an art and a joy, when they perceive that the glory and the sweetness of the blue sky and a clean air are assets which we cannot neglect without peril to our souls and bodies, when they understand that

co-operation is not only valuable because it increases the productive efficiency of men, but much more valuable when it liberates their dormant instinct of mutual helpfulness and love—when they see that all these inner things and many others are of more importance for human happiness than the mere increase of external riches—then indeed the Shop-keeping Age will have passed away. It is with a view to this psychological transformation that I have gathered together in this volume papers on "Industry as an Art," on "Beauty in Everyday Life," on "Non-Governmental Society," "Agricultural Co-operation," and so forth.

It becomes increasingly evident, I think, that over and beyond any formulas of reform what is needed is a new spirit of social and industrial life. Without that even the best institutions will be of little avail. As Mr. Clutton Brock says: "The desire for spiritual freedom is the basis, the only basis, for Socialism. . . . And Socialism should endeavour to prove that it is the natural and inevitable product of the desire for spiritual freedom." This spiritual freedom means the opportunity to evolve from oneself what one thinks right and true and beautiful. It means a co-operation of all the members of society, and this in a way not merely technical and external, but in a real spirit of mutual help and equality. Only on such conditions, we may be sure-only on the condition of spiritual and creative freedom-can a society be really human and healthy.

At the conclusion I have introduced a long paper on "Social and Political Life in China" —partly because I think the study of the conditions that exist in a land so remote in every way from our own may (especially at this time when our own institutions are in the melting-pot) be of great assistance. When one reflects that China has come down unbroken through a period of over forty centuries, and with her general polity during that period very little altered: that she has survived internal convulsions and the shocks of Time and the external attacks of many nations: one cannot refuse to see that there must be something very substantial and very well worth studying in that spirit which has inspired her and those institutions which she has adopted. It has been the fashion of a cheap Western criticism to ridicule China and to represent her as enduring agelong in a state of slumber and fatuity. Apart from the improbability of such a theory, it is absolutely rejected by all those travelers who have made the land of Sinim a subject of intimate and prolonged study, nor do all the foolish political efforts of the Western nations during the last seventy or eighty years, and their complete failure to break up that great Organism, lend any countenance to the theory. China is as strong to-day as she ever was-as the world will presently find out. And as an instance of the value and power of the general public spirit ruling a nation in comparison with formal laws and institutions I may here mention one thing. In China it is thought rather disgraceful to live on the rent of land. There is no law, as I understand, against it, but there is a strong public opinion—and though, as a matter of convenience, it is not uncommon for one small holder who has more than he wants to rent out an acre or two to another who has less. it is really rare for any one to attempt or to dare to live entirely from the tribute of his tenants. In England, I need hardly remark, it is just the opposite: there is a common public opinion in the other direction, and a man is respected. and even thinks himself respectable, just in proportion to the length of his rent-roll. Apart then from all legislation one can see in these two instances the vastly differing results of a differing spirit of life-in China an immense and far-flung peasant-class rooted comfortably in small tenures on the land, the most productive and the most stable on the whole Earth, and in England huge private estates half cultivated by a paralysed and inefficient population, and a country in perpetual danger on account of the inadequacy of its foodsupply.

As there has been a recrudescence lately of the effort to break up Trade Unions I have included in the Appendix a paper on "The Minimum Wage," showing the valuable and indeed indispensable work the Unions have done, if only in the establishment of this principle.

## THE TRANSFORMATION OF OUR INDUS-

ABOUT the middle of last century there arose a great belief that the world was somehow going to be saved by Trade and Commerce. With the rise of the huge Machine-industries in the end of the eighteenth century, and the immense development of Locomotion in the early part of the nineteenth. the commerce of the world increased by leaps and bounds. The Crystal Palace in 1851 was the first of a series of Exhibitions which were held as monuments and milestones of human industrial progress. The lines of the Railways and Steamships, spreading rapidly like a wonderful web over the world, linked land to land: and it was said, and said again, "Leave these forces to their natural issue, let each man pursue his own profit, his own interest-each country the same—and by the inevitable operation of trade and industrial exchange the whole world will ere long be united in one great Brotherhood. The Sheffield forger and grinder will manufacture sickles for Russia; and the Russian peasant,

cutting his wheat crop with the same, will send back a portion of it for the sustenance of the Sheffielder. The Lancashire girl working in the mills, and helping to turn out cotton goods by the mile for the natives of India, will run home in the evening, with shawl thrown over her head, to her little cottage, and sit down to a cup of tea whose leaves have been plucked by her dark-skinned sister in the tea-gardens of Assam." Tennyson, who more than any other poet gave voice to this period and these aspirations, said in a passage often since quoted:—

For I dipt into the future, far as human eye could see, Saw the Vision of the world, and all the wonder that would be,

Saw the heavens fill with Commerce, argosies of magic sails,

Pilots of the purple twilight, dropping down with golden bales,

Till the war drum throbbed no longer, and the battle flag was furled,

In the Parliament of man, the Federation of the world.

It was a glorious dream, this apotheosis of Commerce! this vision of an international Brotherhood founded on trade and barter! And who shall say that, in a sense, it may not some day be fulfilled—that some day earth's children may not in freedom create and in freedom and friendliness interchange, the products of their labors? But so far, alas! the dream

has not been fulfilled. The Trade and the Commerce truly exist. But the freedom and the friendliness—where are they? Only wage-slavery, and the nations and the peoples armed to the teeth in enmity against each other!

And the reason why the dream has not been fulfilled is clear enough. You cannot make a silk purse out of a sow's ear. And out of a Trade and a Commerce founded on greed and self-seeking, and chicanery, and the law of deviltake-the-hindmost, you cannot get, and you cannot expect to get, a society of brotherhood and trust and mutual help. The spirit has been deficient from the beginning; and the tree will bear no other fruit than its own seed.

From the beginning, and before Tennyson, there were warning voices. Thoreau, from his New England hermitage, said, "Trade curses everything it handles," and again, "I have tried Trade; but found it would take ten years to get on in that, and that then I should probably be on my way to the devil." And before him again, Shelley in his youthful inspiration of Queen Mab spoke of

Commerce! beneath whose poison-breathing shade No solitary virtue dares to spring; But Poverty and Wealth with equal hand Scatter their withering curses.

Strong words!—perhaps even a trifle over-charged—but alas! how true, how true in the main, even down to to-day!

It may be worth while to consider some of the ways or respects in which this modern Commerce has proved itself a failure—as thus supplying us with some hints towards the future. And first I will take its foundation principle of *Internecine Competition*.

Now every one will allow that Competition. in the sense of a reasonable emulation in good work and efficiency, is a very sensible and proper thing. But it must be remembered that the Political Economists and the Industrial leaders of the early nineteenth century went far beyond this. They laid it down, in their great principle of laissez-faire, that no restraint should be placed upon individual effort in the midst of the great struggle for existence—and even that if every man (short of actually breaking the law) went straight for his own advantage, regardless of others, the total result for society at large would be favorable and harmonious. In consequence of this doctrine-or rather, perhaps, in concurrence with it-came a period of the wildest competition-in which, in the struggle for Trade and for Profit, almost every law, human and moral (which did not happen to be written in the Statute Book), was broken; and in which the sufferings of those trampled underfoot in the struggle-the suffering of women and tiny children in the coal-mines, of strong men in glassworks and steel-works, of girls in chemical works and cotton mills, of chimney-sweeps, of farmlaborers, of sweated workers in city slums, and so forth—were so frightful, that in spite of the theories of the Professors, and the fierce protests of the great Lords of trade, the nation insisted from time to time on new Statute-laws restraining and restricting the freedom of the strong man as against the weak, and defining and defending equitable relations between employer and employed. Thus the later part of the nineteenth century and the whole Victorian era witnessed a slow but inevitable reaction against laissez-faire; and so ensued the very decided, though mostly tmacknowledged, beginnings of our modern socialism.

This period of wild competition, and the readjustment under it of all industrial relations, is perhaps unique in human history. In all the old societies—look where you will—you will find individualistic competition having a very restricted sway. The old societies were mainly customary. Trade in old days was a matter of custom. The word "customer" indicates this. If you dealt with one man for your boots, and with another for your bread, and with another for your meat, you were the customer of these various people; the prices too were customary; and these forms of custom were not changed except for strong and necessary reasons. In any one district there established itself in consequence a kind of equili-

brium; and each tradesman could know pretty. clearly what his prospect and outlook for the coming year might be. But with the comingin of the world-wide Trade of which we are speaking all this was changed. The Sheffield cutler who, with his forbears, had manufactured table knives for centuries suddenly found a deluge of such knives coming in from Germany; the Coventry watchmaker discovered that watches were pouring in from Switzerland or Massachusetts: the farmer stared in dismay at sacks of flour arriving from Canada or the Danubian plains, and at thousands of heads of cattle consigned from the Argentine. Prices were hopelessly cut down and mangled, and men who had before been making a fairly prosperous and reliable living found themselves plunged in failure and debt. At the same time the world-wide Trade brought new sources of employment: great new industries sprang up; the wage-working populations migrated from place to place in search of new work. The old steady-going humdrum order of things was shattered, and in its place there set in a confused but fierce struggle -men dislocated from their old occupations fighting with each other at the doors of factories and workshops for admittance; masters underselling each other in the home and foreign markets; employers, in order to keep their footing against rivals, beating down the wages of their own men to the lowest possible point; and

the workers, in order to keep body and soul together, banding with each other to fight the employers.

It is in the midst of this cut-throat commercial warfare that we have been living. No one can look out upon the Industrial World of to-day without seeing that it is so. And no one can look upon it without seeing that to continue living in it is intolerable—that things cannot remain as they are. It is a time of Transition. The old customary order of society is behind us; the rational and humane order lies in front; and it is towards this latter that we have to press on.

The second instance of the failure of Modern Commerce which I will take is that of *Fraud and Adulteration*, with their inevitable accompaniment, *Waste*.

In the old social order, in which production was local, and the origin of nearly all articles consumed was well-known to those who consumed them, there was not much room for this trouble. The coat one wore was certified in all respects. Its wool came from a neighboring farmer's sheep, and was spun into yarn by some village grandmother; it was woven into cloth on a cottage loom, and made up into a garment by the parish tailor or the local housewife. If there were scamping or deceit anywhere it was pretty sure to be found out. If the local pork butcher

displayed an unwonted abundance of sausages. and at the same time there occurred a mysterious disappearance of the neighbors' cats, it was easy to put two and two together, and to affix the blame and the discredit! But when the worldwide Trade came in, all this was changed. Fraud and Adulteration became positively practicable. comparatively safe, and superlatively profitable, and the rush in that direction became so enormous that to catalogue all the forms these evils took would be simply impossible. Books like The lungle and Tono-bungay have familiarised the world with certain aspects. Years ago Herbert Spencer pointed out that silk goods were commonly loaded with such heavy dyes as to convert 1 lb. of pure silk into 21 lb. of the marketable commodity! To-day (I have reason to know) there are "pure linen" goods turned out in Manchester which are made entirely of cotton, with an admixture of size! And so far has this habit penetrated that (according to Phil May) the little slum-girl nowadays, who buys half a pound of margarine from the grocer says: "And please, Sir, mother says, would you stamp the cow on it, as we have company coming to tea?"

The progress of science has reached such a point, and the chemicalising of products has become so subtle, that inspection and regulation are non-plussed, and the pursuing of the evil by Law is plainly seen to be only a

temporary remedy—which must ultimately give way before the only radical cure, namely the merging of this unholy scramble of the markets in a serene and orderly form of communal production.

And under this head it is perhaps not unfair to dwell for a moment on the whole present system of Advertisements and Travelers. A few years ago (1901) it was calculated that in Great Britain alone 80,000 folk were employed in the advertisement trade, besides 64,000 commercial travelers. How near these various activities run to the line of Fraud we must leave the parties concerned to judge, but of their signification as illustrating the intolerable Waste of our present system every one can form an opinion. For all this vast expense of labor and treasure represents only the internecine warfare of firms with one another -each bent on destroying its rival or rivalsand whatever Trade one firm gains in the process is lost by some other, so that the total advantage or profit to the community is absolutely zero. Many years ago Mr. Pears boasted that he spent £100,000 a year in advertisements; and now probably the sum is far larger. But of all the hundreds of thousands of pounds thus spent in the British soap trade what advantage does the community reap—except that its soap is so much dearer in consequence? The public in fact. through this extra price, pays and supports the great army of travelers and advertisers. But

far wiser and better off would the public be if, instead, it simply planked down the same sum in some such other way, as would provide the said army with really useful work—useful to themselves and to the community. And if any one is so futile as to maintain that by this enormous expense of advertisement and travelers the public is enabled to judge the merits of various soaps for various uses, the obvious answer is that a jury of washerwomen for a few pounds a year could fulfil this function for all practical purposes with the greatest ease and efficiency—and probably with far more satisfaction to the general customer.

The third trouble which I wish to consider in connection with Modern Industry is the Fluctuation of Trade. This is a very serious matter. and one which I think will demand more attention in the future than it has hitherto received. We saw that in the old society, when custom ruled and production was local, industrial conditions were comparatively steady. Changes of course took place; but they were slow and partial and there was fair time for readjustment. Now on the contrary changes are rapid, sweeping, and unexpected. A small margin of profit flings a whole body of trade across the Atlantic: new invention, as we have already seen. paralyses a whole industry in one place, and sets it humming and buzzing in another. The country

boot-maker in old days supplied his own locality year in and year out with a certain class of hand-made article. Now suddenly arrives from Northampton or perhaps from New England a consignment of machine-made boots at breakneck prices; and he sees ruin staring him in the face. A sense of painful Insecurity affects all the trades, small or large, in the country or in the town. It becomes impossible to forecast the future. At any moment these causes of fluctuation may arise. The employer suffers; he is timid and anxious; he fears to lay down capital. The worker suffers; he is haunted by the prospect of the "sack," and the long weary walking of the streets.

This fluctuation is a great evil. We may say that however bad conditions may be, yet if they are fixed human ingenuity and necessity will presently devise a way to make the situation tolerable. If for instance the demand for British coal suddenly fell to only one half of the present demand, and remained there, and it was known that it would remain at that low figure, thenalthough for the moment there would be dislocation and great suffering-yet in a short time the excess of coal workers would migrate elsewhere and those that remained would soon continue working under normal conditions. But when the fluctuations are continual and unforeseen, the pain so caused in the body politic is extreme. At one moment men are drawn in thousands to a district.

only a few months later to be starved out for want of employment, and cruelly dispersed to other centres. A kind of alternate inflammation and atrophy of industrial tissue takes place, and the consequent pain and anxiety to all concerned, both employers and employed, are terrible. One result, as far as the employers are involved, is the abandonment of "stocking." With the swift fluctuations of demand for any class of goods. due to world-wide Trade (and collaterally also to new Fashions and new Inventions), the manufacturer does not to-day venture to lay in a large stock or store of any one article, lest with the cessation of demand it be thrown useless on his hands. He knows there is always a great army of unemployed waiting outside his gates (and modern Industry and Manufacture positively now depend and rely on this fact): and he sees that for his purpose the best plan is to live from hand to mouth, as it were—to just supply the demand of the moment, if necessary by calling in extra workers from outside; and then when that is over, and the ebbtide comes, to discharge a lot of hands, taking them (or others) on again later when a boom occurs. In the old days of course fluctuations were much less in extent and slower in operation; and those that did occur were greatly alleviated by the custom of stocking, by which in slack times the work was continued much as usual, and the surplus of stock thus created was stored up to be ready for the

next busy season. In those days old hands were seldom discharged, and new ones were but slowly taken on; and the Industrial machine ran smoothly and evenly, like an engine with a big fly wheel. But now with the abandonment of stocking the jolting and self-destruction of the whole organism are terrible and ruinous.

.With the constant "on and off" of employment which our general industrial system entails. the condition of large masses of the workers is fatally bad. If their wages when actually in work are fair, yet their total and average in the long run are wretchedly small; saving becomes hopeless: long periods of unemployment occur: and the effect on the character of the man is most baneful. The sufferings entailed in the process are so great, that he loses his courage. he loses hope and object in life, he loses the habit of steadfast industry, and in cases where ill-fortune continues he loses actual skill and efficiency. Finally, if a long period of want of employment brings about the break-up of the home and the adoption of the life of the tramp, the tragedy of this transition is so great that (as statistics show) a return afterwards to normal life is rarely possible. The man becomes adapted to an aimless existence. "When shall I get work again?" inquired the needy workman of the old fortune-teller. "You will have bad luck for two or three years," said she, "but after that . . ." "Yes, after that?" hurriedly asked

the anxious querist. "You will get used to it!" was the fatal reply.

Such are some of the awful problems which loom up in connexion with modern industrial life. and make us feel that we are nearing the end of one dispensation, and must be preparing for the arrival of another. The present system hastens to its crisis and its close. As competition becomes keener and keener, as the worldwide Trade draws its currents from farther and farther shores, so does the whirlpool at the centre become more and more fatally swift. Every day the machines spin faster and faster, every day the "drive" in the workshops is intensified. Production of wealth increases with enormous strides. and every day with less actual cost of labor. Thus it comes about that while the needs of the world are being supplied by the toilers, and an enormous portion of the wealth so produced is being appropriated by the shareholder and the landlord, the actual number of wage-receivers in the process is if anything being reduced. As the machines spin faster, in fact, so much faster do they throw off on the one hand the unemployed poor, and on the other hand the unemployed rich.

This double problem of unemployment is the master problem of our time, and its solution the key to the future. It is both a threat and a hope. For the failure to solve it will mean the ruin and destruction of modern society; it will

mean the continued and increased production of futile and imbecile crowds on the surface and in the upper ranges of social life, and the continued and increased production of hopeless and despairing crowds of incompetents in the lower ranges—a double burden which, unremoved, must inevitably crush Society beneath it. But the solution of the problem will lead the way to the promised land of a new era.

The sufferings of the unemployed—to any one who at all knows them-have indeed been very terrible-terrible even to think of. But there is this hope in them, that these very woes have forced the attention of the world, they have compelled us at last to face the problems which lie behind them, and are the origin of them. man who stands at the dock-gates asking not for alms but for a pittance of work. and stands there, ill-clothed and ill-fed, for hours and hours in the rain and cold, if so he may win bread for his little ones, is (though we do not always see it so) the Christ knocking at the door of modern society, knocking at the door of our hearts. He is ourself in another guise. Long have we turned a deaf ear, long have we hardened our hearts. But now we can do so no longer. For humanity's sake, for the sake of our common life, we must open the gates and let him in.

And this opening of the gates—what is it? It is the acknowledgment of his Right to Work.

Let us pause on this a moment. Some folk would deny that there can be any such right. as a right to work. But surely if they deny that, in a society constituted as ours is, they deny the existence of any right. For a man can ask no more modest, no more reasonable, no more unassailable right than the right to support him-Observe, it is not the right to beg that is claimed, though that to a starving man can hardly be denied; it is not the right to steal, or in some way to live on the labor of others, though that is certainly claimed and taken by large sections of society; it is not the right even to be supported out of the rates, though that is granted by the Poor Law. No, it is a claim much more modest and humble than any of these-simply the right to have an opportunity of earning one's own living I

And can such a claim be resisted?—The more we think about it, and the more Society at large thinks about it, the more we see that in all reason and humanity, it cannot be resisted.

But some say 1 We admit that the claim in itself seems a reasonable one, but the real difficulty is this, that there is no practicable way in which the claim can be granted—in which work can actually be provided, however willing we may be to provide it. To such objectors we may reply:—Very well, then, if we can show that there are many ways in which self-supporting work can be provided, you will surely feel bound to adopt

them, or at least to make sincere and thorough trial of them.

That methods can be found by which, after the lapse of a few preparatory years, remunerative work could be provided for everybody—and with great general advantage to the whole community—there can be no reasonable doubt. Any one who has looked into the subject must I think agree to this. The real doubt lies in the willingness of those at present in power to adopt the methods—and the reason for this unwillingness I will refer to later. For the moment let us consider what these methods are.

In the face of the detailed and masterly handling of this subject in the Minority Report of the Poor Law Commission it would be superfluous for me to enter into them very minutely, as well as impossible within the limits of this paper. Suffice it to say that the main points are (1) The gradual shortening of the working day—especially to begin with, in public industries like the Railway, tram and omnibus services; 1 (2) the diminution of Boy and Girl labor, and the raising of the School age; 2 (3) the institution of great and ultimately greatly remunerative public works, like Afforestation and

Land Reclamation; 1 (4) the founding of Labor and Farm Colonies.2

Most of these points explain themselves. The shortening of the hours of labor would cause an absorption of extra workers into those industries in which such shortening was carried out. The curtailing of Boy and Girl labor and the raising of the School age would, of course, not only cause an extra demand for adult labor, but would give an opportunity for the methodical technical training of young folk, and the turning them out into the world as efficient citizens—a most important matter. With the institution of great and permanent Government works of Reclamation, Afforestation, Canal restoration. extension. etc., not only would there be a great increase of employment, but it could be arranged—as the Minority Report recommends—that such works should proceed more rapidly in seasons of general Trade depression, and less rapidly in seasons of prosperity, so as in this way to counteract in some degree the fluctuations of general industry, which we have seen to be so harmful. And by the foundation of Labor and Farm colonies industrial training could be provided-compulsory in some cases, but voluntary in most-for those who are now incompetent and unskilled; while by degrees and with extended experience and improvement in the general level of skill and

efficiency, such places could be rendered quite self-supporting and even remunerative.

A word upon this last point. The Minority Report, wisely perhaps, does not dwell upon the question of self-supporting colonies. The English labor colonies, like Hollesley Bay-largely owing to their half-hearted management—have not been a great success; but the work done on the Continent in this line has been quite remarkable; and already it has become clear that in certain places of this kind-like Merxplas in Belgiumvery inefficient human material, which in England becomes a heavy charge upon the rates, may be taken and rendered "practically self-supporting": while in other cases, as at Witzwill in Switzerland, similar material, well fed and lodged and gradually trained, vields an actual balance to the good, after all the expenses of the establishment have been paid.2

Both these colonies, just mentioned, are of a more or less compulsory character, and deal with material of most unlikely kind—inefficient, unwilling, and constantly fluctuating. And the question arises whether, with these results obtained in such places, we may not fairly look forward to the founding of other Colonies of really skilled

and alert workers in all departments-Industrial Villages and Garden Cities we might call them -which should be greatly successful and prosperous, and yield a high rate of wages or return for their labor to those co-operating in them.1 That skilled and efficient men and women must be able-with all modern appliances and industrial science—to produce from the ground, and supply each other with all the necessaries of life and an abundance over and above, is, one may say, a truism of Social economy. And for the success of some such experiment all that would seem really necessary would be the provision of an ample area of land, and of a wise and experienced management, (After all, England itself, taken as a whole, is such a colony-only very badly organised, or scarcely at all, and with a vast number of quite helpless and useless members -and yet it supports itself year by year with a perfectly astonishing superfluity and profit.)

In all this matter we have to remember that reaping—as we are now doing—the harvest of our unholy commercial system of the last century or more, we cannot expect all at once to undo its ill-effects and dissipate its deadly accumulation of dregs below and of scum above. There

must necessarily be a considerable period of preparation, and of training of these helpless crowds to become useful and efficient. But once that is allowed, and it is understood that in the near future practically every boy and girl that comes of age will be qualified to do useful work for the community—why the nightmare about the difficulty or impossibility of finding employment will surely vanish quite naturally.

Why then-it may be asked-why are not efforts made at once to work out such proposals as above outlined, for the provision and extension of employment? Why are not large schemes adopted in the direction of shortening the working day, the curtailing of luvenile labor, the institution of great national and remunerative public works? Why is not serious consideration given to the subject of industrial villages—to be composed of efficient workers of all trades (of whom there may soon again be thousands walking about the streets)—while in the meantime other preparatory colonies, not entirely self-supporting, and the technical schools, might be tackling the problem of qualifying the young and the inefficient for the future time when they will be able to take their place as worthy and useful citizens? Every one admits the urgency of the Unemployment problem, they "deeply sympathise"—and yet, and yet, when these simple and obvious remedies are put forward, they are somehow ignored! Why is it? The answer is simple—and instructive. It is

because all these remedies involve the idea of industry being carried on not for Profit but for Use—not for the profit and gain of an individual man, a shareholder, a bondholder, a landlordbut for the use and advantage of the workers and the whole community; and this idea is so appalling that it dislocates people's minds—and they cease to think: just as people cease to walk when their legs are dislocated! Folk are so accustomed in fact to think that industry can only go on when it pays a big man to get 3 big profit out of it—they are so ingrained to our commercial system—that some of them genuinely believe that no other state of affairs is possible: while others (not so innocent) see in any such change the beginning of the end of legalised robbery. To such folk the reclamation of vast lands from the sea and the dotting them over with farm-steads and a prosperous population seems a useless and meaningless enterprise, for it would give no scope for speculation, nor yield any profit to individual shareholders: the same of a home-colony; while the shortening of the working-day in the various trades would certainly bring a danger of some slight diminution of dividends, and therefore, however important it might be for the health or safety of the workers, ought decidedly to be opposed.

Such then is the state of affairs in the United Kingdom to-day. The Commercial system and

the commercial ideals of the last century have had their full fling; and while creating a Trade and a Wealth perfectly astounding and unparalleled (as. for instance. Total exports and imports in 1830, £88,000,000 t the same in £957,000,000), they have at the same time developed evils and inhumanities so monstrous (e.g. Fraud and Adulteration unprecedented, Robbery of the poor by the rich, vast accumulations of diseased wealth, deadly masses of Poverty) that it is felt that the process cannot and must not any longer continue. And yet at the same time, so ingrained is the habit of the past—so persuaded are the workers that the only source of employment is the self-interest and speculative advantage of "masters," so determined are the employing classes not to countenance any industry which does not yield them dividends—that the next steps, which are of course in the direction of production for Use. though perfectly obvious, seem strange and almost impossible.

It is evident that nothing but a new conception and spirit will avail—nothing but a new germinating principle of industrial life. For, as said before, the tree will bear no other fruit than its own seed. We cannot get grapes from thorns. Out of the seed of the plant called devil-take-the-hindmost, sown in the beginning of last century, has sprung for this age no ordered and gracious social life, of friendlinese and

humanity, of beauty and of joy, but only a wilderness of briars—as any one may plainly see who merely glances around. Briars, vigorous perhaps, strong-growing, and covering all the land—but after all, only briars. Nothing but the grafting of a new life upon these, a new spirit, a new germinating principle, will so transform them that they will blossom at last into the rose of our devotion and our love.

And this change, this new inspiration (which is already coming to us) is coming, as ever, from the outcast and the rejected. It is from the pitiful figures scarce able to hold their rags together, who flit past us like ghosts in the midnight of the richest city of the world, or huddle crouching on the riverside seats-or from those dreary cues of hopeless thousands who wait at dockyard and factory gates-that the congregated cry of suffering has gone up, which is at last awakening the slumbering soul of our modern civilisation to its human destiny, its real life. "Abandon this mad, this inhuman struggle," It says, "in which we and such as we are hourly and eternally crucified-in which your own hearts and lives are blasted. Look on us, and know that we are but vourselves in another form. Grant our claim, so unassailable, so elementarythe simple Right to Work-that we may be allowed to support ourselves—that the industrial machine may be so modified that all may bear their part, and none be excluded. Do this, and

lo I in the hour that you do it you will have sown the Seed of a new Society—as far superior to the present one as the perfect rose is superior to the bramble—the society in which industry shall actually be carried on for human Use instead of for fraud and robbery.

"But do it not, and the hour of your ruln is at hand. The writing is already on the wall. No nation can continue for long, without serious disaster, to harbor huge masses of its population in a decaying and diseased state—forbidden from the land and all the conditions of healthy industry and life—its very own limbs and members mortifying. The crisis draws rapidly near. Whether it comes from within, by the disorganisation of your own internal affairs, or whether from without, by direct foreign attack—unless you set your house in order, and that right soon, a great catastrophe awaits you."

This element, then, in the breakdown of our present Commercial system—this strange and ominous evolution of huge masses of unemployed poor and unemployed rich—is bringing us such a lesson as the above, and pointing us such a cure, largely on what may be called the moral plane. Another element in the same—namely the evolution of great industrial Trusts and Combines—is pointing a strictly practical direction for us to take, and a practical means by which we may possibly pass to the new Society.

The Trust of course is the halfway house to

the Public Administration of Industry. It prepares the way-in those larger wholesale industries to which it applies—for their being taken over and administered by the Public. Yet to say "prepares the way" is hardly correct, seeing that for years now, as already pointed out, legislation has gone in the direction of Socialism. that is to say of restraining the wild race of commercialism and introducing human order where before was a self-seeking chaos; for years, too, it has gone in the direction of municipalising industries and taking them over into public control: and of necessity it has done so, for there is no other direction to-day in which progress in such matters can well take place. The Labor and Socialist parties in the State have recognised and acknowledged this necessary movement, and are deliberately and consciously helping it on; the Liberal and Conservative parties, with their eyes more or less shut, do not perhaps always know what they are doing, or see where they are going! yet the Statute Book of the last 60 years shows plainly enough —from the Ten Hours Act for women and children of 1848 to the Minimum Wage and Wage-boards Act of 1908 1-and it is too late now for these parties to make a bogey of a movement which they themselves have been nursing so long.

The advance, the growth, the conquest of the general socialist conception are assured. The

gradual transformation of our industries and activities is inevitable—so that they will be carried on in the main for public advantage and use. How far the process begun in the Post Office. the Telegraphs. Telephones, Railways, Trams, Electricity, Gas. and Water Supply (not to mention Munitions and the general Regimentation connected with the Great War)-how far exactly Nationalisation and Municipalisation will go—we cannot of course vet see. it is that before long the greater portion of the land and the greater number of the large industries will be collectively handled. And certain it is that these changes will bring a considerable alleviation of the evils of the commercial era.

Public administration allays the evil of excessive Competition, and the cut-throat warfare and waste which go on still in the outside trades. (Imagine for a moment what the Post Office would be to-day if in the hands of a hundred little competing letter-carrying firms!) Public Administration practically puts an end to the evil of Adulteration; it curbs an enormous amount of Fraud and Waste. Under it, Fluctuations of employment, which we have seen to be so great a curse, are much more easily controlled; Hours can be shortened at need, and sections of unemployed so absorbed; Wages and conditions made much more equable and favorable or just to the worker; and in general the

Robbery of the poor by the rich minimised and gradually extinguished.

But—and this is a most important "but"—
it brings with it the very great danger of the
growth of officialism, bureaucracy, and red-tape,
than which, if allowed free sway, few things can
be more fatal to the real life of a nation. The
multiplication of officials—as has been seen in
the past history of Russia—strangles the spontaneous vitality of the people; it creates a vast
body of parasites, as bad as the dividend-drawing
parasites of Commercialism; and betrays the
public into the power of a class hostile to change
and to progress.

We see this alas! only too clearly in connexion with the present War. In this country officialism is tightening its grip in a fateful way; and administered as it is from above by a class which is out of touch and sympathy with the needs of the people it is becoming a great danger. The ignorance displayed by the War Office and the high Civil authorities concerning the common and necessary conditions of life among the masses is something astonishing; it has led to perpetual altering of regulations and to every kind of vacillation and uncertainty; it has bred a deep distrust in the minds of the people, and in this hour of national crisis, if carried much farther, might easily lead to something like revolution. At a time when national unity is above all things needed, the tendency to treat the unions and other

#### TTT

### INDUSTRY AS AN ART

MR. BERTRAND RUSSELL in his excellent book The Principles of Social Reconstruction accentuates strongly the fact that men's impulses may be divided into two great classes—the Possessive and the Creative—and suggests indeed that the Western nations are even now preparing for a period of transition, in which the possessive instinct will cease to be so influential as it has been in the past, and will begin to yield place to the creative. Let us hope that this change is really taking place. The possessive desires, as Mr. Russell points out, are those which commonly bring people into conflict with one another, and make for warfare on a big or a small scale; the constructive impulses, on the other hand, those which on the whole tend towards cooperation and harmony.

That a period of profound and wide-reaching Change is already upon us is a thing to which a thousand indications point; and it is well that at such a juncture we should pause and peer forward, as best we may, into the future. In the foregoing paper (Ch. II) I have sketched the

Industrial transformation which has been going on during the last fifty or sixty years and the slow modifications of our Capitalist system which have been forced upon us from point to point by the glaring and obvious defects of the latter: but I confess that for myself I can see nothing really adequate and satisfactory in this direction except a complete change of Heart-a change of the very guiding principles of our modern life. A mere tinkering at our existing industrial arrangements will never do what we want: and now that the War has brought us face to face with some of the facts of life and given people furiously to think in a way that they have never done before, the need of a radical Change stands out more clearly before us, and the realisation of such a thing seems less distant and a good deal more feasible.

Are we approaching (I hardly dare ask the question) an age of good sense in the affairs of mankind? Is the long-deferred Coming-of-Age of Humanity at last to be celebrated? Let us not pray the gods for any stupendous gifts for the coming generations—for towering genius or intellect or universal heroic character—but only for a modest boon, such as they surely cannot grudge or refuse to grant—to be able, namely, to conduct our own affairs with a little good sense, just a very little, as much for instance as a sheep might have!

. Here we are, the human race, planked down

upon this planet with '(at the present day) most marvelous powers of industrial production at our command, amply sufficient, if decently used, to supply every one with all the necessaries of life—and only requiring a very moderate degree of intelligence so to make use of them; <sup>1</sup> and lo! instead of settling down to make the best of so excellent a situation we deliberately leave nine-tenths of our brothers and sisters to live in squalid and abject poverty, while the rest of us employ our precious time and energies in mad and destructive warfare!

We have got to get down to the root, and to begin again, so to speak, from the beginning. We have got, it seems to me, to realise two things: first, that Life itself can be made and has to be made something good and beautiful—worth living for, in fact; secondly, that work itself must be so transformed as to become a pleasure. I will discuss these two points more at length presently. Sufficient just now to observe that the second point necessarily follows from the first. For since work occupies, and

must always occupy, the major part of our waking hours, it is clear that our lives generally cannot well be a joy to us if our work is a burden and detestable. And if to some people these two objects of our future endeavor seem too remote and impossible, let us remember that since the experience of the Great War nothing need seem to us impossible, and that here in these two directions we have a thing indeed worth working for—something even worth giving our lives for—such as we have never had before in all the days of our boasted modern Civilisation.

One serious obstacle to the amelioration indicated, is what Mr. Russell terms the 'Possessive' impulse—chiefly exhibited among the Well-to-do: and it may be worth while to say a few words Through long centuries this impulse has been cultivated and evolved, and to such a degree that it has become in many cases a mere mania—the "mania of owning things"—without rhyme or reason. In pursuance of this mania vast numbers of people not only make miserable their own lives (which would not so much matter). but also the lives of thousands around them, from whom they derive their ill-gotten gains. (Even sheep are not so senseless as this.) It is the possessive or grabbing mania which stands in the way of our human approach to the new world that awaits us. Let us hope that the power and vitality of this delusion are fading away, and that soon it will be but a ghost and

a bogey through which we shall walk, and find that it has no substance.

The other serious obstacle is the Timidity and want of self-reliance of the mass-peoples in almost all countries: who—though their hearts. so to speak, are in the right place-have not thought out the logical issue of their feelings and have not in consequence the courage of their opinions. Though there is ample evidence that among all peoples, in some early or pre-civilisation period, life has appeared as worth living, and work as something attractive and enjoyable, vet there is no doubt that in the later centuries the conditions of industry have ingrained into men's minds an opposite view. If any enthusiast to-day were to descend into one of our big towns and. standing at a street corner, to preach to the passers by about the "pleasure of Work," or to urge them to the easy task of making Life "really enjoyable and beautiful," the crowd I fear, putting their thumbs to their noses, would break out in scornful laughter, or perchance turns ing on the speaker would stone him with stoneseven as they stoned Stephen at Jerusalem when for him the heavens opened and he saw in a vision the Son of man standing at the right hand of God.

The truth is that Life and Work to-day under the commercial-industrial régime have become so hideous and monotonous and altogether detestable that to the plain man the very notion of their possible charm and beauty has become ludicrous, and not to be entertained. Nevertheless there are plentiful indications that this hideousness and hatefulness has already reached its climax, and that a new order of world-history is setting in. It is naturally difficult for the mass-people to believe in such a divine possibility of change; yet I most certainly think that if they once beheld the vision and realised what it meant, they would set their faces towards it in real earnest, and would say in the words of William Blake; "I will not cease from Mental Fight, nor shall my Sword sleep in my hand, till we have built Jerusalem in England's green and pleasant Land."

What then are the necessary conditions for / making Work a pleasure?—They are so extraordinarily simple that it is a marvel that they have so far escaped attention and been neglected. Work is a pleasure when it is free and creative in character-and that is the whole mystery of the matter. There is little else to be said. Every human being, like every animal or plant or tree, has a law of growth of its own, whose expression and utterance is a joy to it. One tree bears oranges, another bears roses. The joy that any such healthy tree has in its work is evident. But only on condition that it is free. to produce according to its nature. To try to compel a rose-tree to bear oranges would be madness—a madness similar to that which prevalls at present in the whole of our industrial world. So great is the pleasure of free creative work that thousands and hundreds of thousands of folk-as is well known-after their day of leaden and slave-like labor in the factories, do actually on their return home plunge into some sort of hobby of their own—whether gardening. or cabinet-work, leatherwork, copper-embossing, painting, or what not. Tired as they are they still are drawn onwards by the desire to express themselves, to create something of their own: nor do fresh fatigues deter them from this joyful quest. I know a boy who slaves in a dirty workshop for ten hours or so a day. When he gets home-and a very poor home at that-he actually, after he has had his tea, descends into the cellar and by the dim light of a tallow candle and with poor tools begins work again, making little cabinets or corner-cupboards, or a model of an aeroplane. Such people are true artists; and all work of course ought to be of a similar nature—that is, of the nature of an Art.

Artists, in the wide sense of the word, are the only natural and healthy people, and in line with the rest of creation—with the trees and the animals. They are indeed happy. But to confine the name to those who dabble in paints or letters or music is foolish. For the greatest of arts are the arts of Life; and the washer-woman who takes a real pride and interest in her work, to make it as perfect as she can,

independently of any so-called profit or gain which she may derive from it, is an artist in her way, and indeed more truly so in the essence of things than many a man who merely paints pot-boilers for the Spring exhibitions.

Every one ought to be an artist and to take pleasure in his or her work, feeling that the work was a true self-expression and self-liberation. Then there would be joy over the land. '(Is the song of a lark work, or is it play?) If Production became free then nearly every one would work in that spirit. And in order that production should become free the conditions are also extraordinarily simple—the only condition being that people generally should desire it to be free.

Such an Ideal has by statesmen for some centuries never been but into practical shape, or even apparently contemplated with that end in view. Yet one would say that its realisation in a sensible community would not be a very difficult matter. All that would be required would be that every person or group of persons who desired it should have access (at a State or community rent) to a small plot of land on which to establish his or their industry, and access also, under similar conditions, to such power, in the form of electricity or steam or water, as the community could provide. I say "or group of persons" because it is clear that for many industries the work of a group is more appropriate and effective than the work of isolated

individuals, and such spontaneously co-operative work (provided the group were self-governing and not enslaved to any master) would be free in character and would carry with it for each worker the charm of authenticity and of being (through the group) the expression of each worker's will. Thus it would be truly artistic, and truly a source of pleasure—being both creative and free. Something of such conditions was certainly realised in the best days of the mediæval guilds. Where on the other hand it happened that the industry was carried on by a single individual, its self-expressional and artistic character would probably be enhanced—though something no doubt might be lost on the social side, and in the pleasure of co-operation.

As I say, there does not seem to be any serious reason why a scheme of this kind (in more adequate detail) should not be worked out, provided the nation desired it. The real obstacle—both to the spread of any such Ideal, and to the practical working of it out—lies in the matter we have mentioned above, the excess of 'possessive' instinct which pervades large classes. The very extensive and wealthy classes who to-day control production and derive their riches from the enslavement of labor, dread above all things the freeing of the worker and the prospect of the latter becoming self-determining and master of his fate. Though it is notorious that the present dispensation produces a rather futile,

mean, and miserable master-class, together with a dismal, weary, and sad-eyed worker class, yet the whole political and social engine is concentrated on the effort to maintain it as it is, and to disguise or conceal its evil character. The lifting of this coffin-lid would be the signal of a Resurrection such as the world has hardly yet dreamed of

A second result would follow from the freeing of the worker. Not only would Work, being authentic and creative, become a joy and a blessing; but the things created would '(at any rate after a brief period of adaptation to the new order) take on the quality of Beauty. The world would be irradiated with a new light. The things produced and sold or exchanged in the markets and the shops, having been made in joy and gladness, and having absorbed into themselves the spirit of those who produced them, would actually radiate back the same spirit on the purchasers and users-not otherwise than as the luminous paint with which we paint our clockdials, after having been exposed to the sunlight during the day, radiates back a fairy gleam of the same in the watches of the night. The wares in the windows, the objects round us in our rooms, would reflect the conditions of their They do so now: and that production. part of the terror, in the present day, of walking through the streets! The abject aimless articles that we see exposed there for sale are the sorry

reflection of the kind of life the mass of our people lead.

The degree to which Beauty, with the inspiration which it affords, is absent from the surroundings of our modern life is a thing which—though it has been dwelt on by a few Artists and Socialists, like Ruskin and William Morris—has generally passed unnoticed by the multitude. Beauty has in truth been so far exiled from our current Works and Days that we have lost the sense of it; and of that which we have never experienced we have naturally ceased to feel the need. I propose in the following chapter to explain more in detail what this loss is and what it means.

### NOTE

It is sometimes said, and even strenuously maintained, that with due regimentation and officialism such as to-day we see existing and extending all around us—with a thoroughgoing system of servile labor, in fact—more and better articles could be and would be produced, than by any such free creative method as above proposed. Personally I very much doubt this assertion. The "more" is just possibly, though not certainly, true; but the "better" I think is assuredly false—unless, indeed, explosive shells and big guns are to be adopted as the measure of goodness. However, allowing for the moment that the argument is feasible, what does it really at most amount to? It amounts to this—that cheap and serviceable wares are the main object of life, and that

if these are produced it really does not matter about the welfare of the Producers, or whether *their* souls are liberated to a nobler and more human utterance. It is indeed the final conclusion and condemnation of the "Nation of Shopkeepers" theory—and there I think we may leave it!

#### IV

#### BEAUTY IN EVERYDAY LIFE:

IT is difficult sometimes to make clear what exactly one means by Beauty in daily life. Perhaps one can best attack the subject by pointing out first what one does not mean. Not long ago, in walking over the hills on my way to Sheffield, I saw a sight which, alas I is far from uncommon. I saw one of those charming wavside wells or fountains, which I remembered was gracious, years ago, with sparkling pure water and overhanging ferns and mosses-I saw it neglected and shattered, dried up, and its place filled with broken bots and pans and old salmon tins. The sight afflicted me and, remembering how this was only one instance out of many, I could not help thinking:—Is the love of beauty and the sense of the sacredness of Life and Nature lost to this people? It is impossible (I thought) to imagine the Greeks of old permitting such a crime. They would have slain the man who perpetrated it. For, for them, deities and spirits dwelt in the streams and foun-

tains, and in the woods and all the sylvan world. and to defile these things was an act of sacrilege. And even our own forefathers, a few centuries ago, had their well-dressings and festivals of gratitude to the gods for all creatures of beauty and use. But we-we have lost the sense of divinity in Nature and Life, and instead. when we ask what is holy and what is sacred. we are pointed to some stuffy chapel or church. with greasy pews and ill-smelling hymn-books. and ever-closed windows-and told that there was must doff our hats and speak with bated breath ! Not that I have anything to say against churches and chapels-for those who like them; but I do think it sad that all our reverence should be piled upon these things to the neglect of those others; and that while we sing our hymns to God on the Sundays we should employ the rest of the week in emptying our slops in the streams and pouring foul volumes of smoke up into the glorious and crystal vault of heaven-I can hardly believe that God likes that sort of worship !

And it is not only Nature that is thus desecrated, but that Man himself, who ought to be the crown and pride of Nature, has become a blot upon her face. The other day I was passing in the train along the coast not far from the shore. It was a Spring day; the sun shone brightly; before me was a field in which men were plowing and beyond it stretched the sea.

It was a beautiful scene—the sky above, flecked with fleecy clouds, the darker blue, foam-broken waves, the rich brown of the land: the white birds (sea-gulls) following in the furrow: the splendid well-equipped horses. All (I was going to say) was full of life and promise.—And then I looked at the men I and saw with sorrow two ill-dressed, poverty-stricken, poorly-built, and obviously weary "farmhands" trudging there behind their teams—the one note of sadness and disharmony in the scene. Why should this be? They say that in China at the Spring Equinox. it has been the custom of centuries for the Emperor to go forth with a silver plow and plow a few furrows in ceremonial state—this in token of the honor attaching to so important a work—an honor so great that even an Emperor may covet to stand thus "as Mediator between Earth and Heaven," Can we in the end of time devise nothing better or more worthy than our method? The work of the plowman, in all pagan times and since the dawn of History has been honored. Why should it not be so now?

And if there is a Festival which in the Old World has been celebrated with dance and with song, more even than the Spring-sowings, it has been the garnering and the threshing of the corn. To-day, what do I see when this period comes round? I declare that I fairly dread its arrival! I hear a horrible rumbling ill-omened

sound. I look forth, and behold a foul and dirty and splay-jointed engine creaking along the road, belching forth clouds of filthy smoke, and followed by a threshing machine and a dozen or so of the most god-forsaken, wretched men who have been picked up for next to nothing among the 'unemployed.' This Machine and this crew pass into a farmyard, there to proform their horrid rites, and through the belly of the former and the hands of the latter passes the beautiful corn, in a fashion so inhuman that I cannot help wondering whether, after the process, the grain is fit to be eaten.

And when we leave the fields and pass into the factories—away from the redeeming influences of the open air-the case, as we all know, is worse. Where in the long drab rooms, filled with drab-coloured men and women and children, in the stifling air, and amid the clatter of machinery and the wicked scream of wheels,-where are the most beggarly elements of beauty and of joy in life? Alas! they are not to be found. Commercialism says they do not pay; and Puritanism, her handmaid, has declared them to be wicked. On one occasion, at Kilbowie, near Glasgow, I stood on the bridge (not at midnight but at midday) at the hour when Singer's great sewing-machine factory is loosed for its dinner time. A human torrent—some ten thousand men and girls as it was then reckoned -passed rapidly over. And I, ensconced in a

sheltered corner, stood and looked at their faces. It was not necessary for me to go inside. Standing there I could see only too clearly the conditions which prevailed within the factory [(no worse probably than elsewhere in the Kingdom); they were written on the listless tired faces, the lightless eyes, the monotone expressions, the pallid skins, the peaked features, the perkily sexual physiognomies. I came away feeling depressed indeed.

When living at Brighton as a boy, more than fifty years ago. I used to hear of the miners in the North whose coal-often brought in sea-borne ships to the neighboring little harbor of Shoreham—we were in the habit of burning. And I used to think what grand fellows those miners must be, who faced danger and death in the pits, and heavy toil, in order to obtain this so necessary fuel-what strong and wellgrown men, and honored by the nation, as of course they ought to be. Fate or destiny have led me, in these later years, to live within three or four miles of the coal pits of North-East Derbyshire: and now I know the miners of that locality well. Sometimes it happens to me to be in the station at Chesterfield when the "Paddy Mail" comes in—the train which brings the men back from the outlying pits. I shall never forget the moment when first I watched the arrival of this train. Instead of the fine hearty fellows my boyish imagination had pictured, there

descended from the overcrowded carriages and hurried away across the platform as if ashamed of themselves a shambling ragged crew, whose thin legs and worn features spoke only too clearly of want and overwork. Of course there were some sturdy and comfortable specimens among the crowd, but they were the exception. Rickety limbs, contracted chests, hacking coughs and hollow cheeks, abounded: and now, with more intimate knowledge of the subject. I am conscious that that first impression was very near the mark. Somehow, despite occasional bursts of good times and good luck, these men who do some of society's most needed work are left. through ignorance, neglect, and oppression, to become its bitter enemies. And one can only ask, Where are the splendors and the joys of life which should be their portion?

Finally when we follow the workers—of either sex—from the factories and furnaces and shops to their own homes, what do we find? Every one unfortunately knows something of the miles of mean streets in our great towns, which, as John Burns once said, "make mean men, weary women and unclean children." What elements are there in these surroundings, to feed the soul and give it nourishment? What stimulus to save it from the deadly pall of monotony? Those who are sufficiently well off to command frequent change do not know how paralysing is the effect of monotony; but those who have had the good

fortune to be confined in prison for a long period. or have been compelled to work in a factory. do. On one occasion, some manual worker friends of mine, man and wife, who resided normally in a small country cottage, took their two children for a little holiday to the seaside. They let down at a lodging there—a house in a row, of the usual type; and while they were unpacking their few belongings they told the children to run out and play in the street. The children did so. and for some minutes all went well. Then suddenly heartrending screams were heard. The parents rushed to the window, thinking the kiddies had, by chance, been run over. But no, nothing of the kind. There were the boy and girl safe and sound, but crying their little hearts out in a paroxysm of despair. What was the matter? They had run a little way along the street, and lo! there they were staring up at the senseless row of tall houses in front of them, all exactly alike, of which it was impossible to tell which was the one whence they had lately emerged, and where their parents would It was a veritable nightmare—this be found. row of grinning idiotic house-fronts all exactly the same, down to the very lace-curtains-and a nightmare which they would never forget to the end of their days.

I tell this story in order to illustrate the sad, the paralysing effect of uniformity and monotony in the present day lives of our mass-peoples,

both children and adults. I think anyhow I have said sufficient to indicate-by illustrations drawn from their absence—what I mean by the need and the importance in our industrial world. of the positive things-of Health and Toy and Love and Beauty—the things without which our mortal days on Earth are of little or no account. And I think I now begin to understand why to thousands, and one may say millions, this War (even with all its horrors) has been a relief and an escape, why it has brought alertness of mind and brightness of eyes with it. the answer is :- Because-dreadful and wicked though it be-it has meant to so many a life in the open-air; it has meant health, good food, a common cause, comradeship with others, and a dozen positive things, instead of the inhuman monotonies and negations of a life of slave labour under the heel of commercialism. I understand that wicked as the War is, it is in its essence the outcome and result of something more wicked; and I pray that when afterwards the millions return to their homes they will see to it that never again shall the soulless régime of the past be reinstated, but that industrial life shall go forward into a new land—the land of freedom and of joy.

There is one thing which the War has done, in which we are all agreed. It has convinced us that it will be no use in the future pleading Poverty as our excuse for the continuance of

the past conditions. This People of ours, which has been able to rise up and pour out money like water for the purposes of the present conflict. can never again say that resources are wanting for the far more important purpose of creating for itself a really worthy and great national life. We have indeed discovered the amazing extent of our industrial wealth, and its amazing growth. In 1830, as already said (Ch. I.), the combined value of our Imports and Exports amounted to £88.000.000: shortly before the War this had risen to £1.000,000,000. The National Income at the same time reached £2,000,000,000. Yet during that period—when individual merchants and manufacturers were making enormous fortunesit was commonly said that such things as oldage pensions, shorter working days, free meals for children and so forth, were too expensive to be contemplated. We know now what these excuses amounted to.

We are beginning to understand too the falseness of the plea, sometimes put forward, that the mass-peoples are indifferent to such things as Health, Freedom, and the real joy of creative industry, and are quite content as long as they have their bread and butter, and their few trumpery amusements. It is certain (as I have noted in the previous chapter) that the creative instinct and the feeling for beauty are widespread and deeply rooted in the hearts of the people, and that in all times and lands the peasants and

the craft workers in their potteries, or wrought iron-work, or textile fabrics, have-when left with a little independence to their own devices-felt and found their way to results quite admirable and beautiful. Why is it that great artists like Ruskin and Morris and Walter Crane have for long enough pointed this out to unheeding generations. and that travelers going to out of the way places and the ends of the earth have brought us back countless specimens of such native talent? Lately. at the Exhibition of the Design and Industries Association, held in London (November 1916). there were shown some colored cotton cloths copied from designs made by the native tribes of West Africa in connexion with their handloom industry: and certainly the beauty of these things, the richness of the colors and the excellence of the fabrics, were an eve-opener to those who thought that on such matters Manchester and South Kensington had said the last word. The truth is that the love of beauty is natural among all free peoples—though of course its standard may vary in quality and character; and we may well believe that some aboriginal folk living in the open air and the light of the African sun have an acuter sense of color and form than many of our populations who are surrounded by the monotonous and drab conditions of which I have spoken.

Mr. Chester Holcombe, for some time Acting Minister of the United States at Peking, says of the Chinese people 1:-"They have a keenly sensitive esthetic taste. Evidences of this fact are to be found in every direction and among all classes throughout the empire. . . . Their love of the odd and grotesque, in imitation or variation of nature, is more apparent than real, and is mainly shown in dwarf copies of natural objects of grandeur or beauty. This is the result of necessity rather than of choice, and should be credited to a hunger for the beautiful, so keen that in the absence of the originals they can find pleasure in the merest toy-copies. Hence all over China, in the homes of the poorest as well as of the wealthy, in door-yards and dwellings, are to be found tiny landscapes, dwarf trees, mimic caves and grottos, artificial rockwork, and mountains of a few feet in height, threads of running water, or lakes that a child might spring across. All this is the struggle of poverty to surround and satisfy itself with the beautiful. And as such it has a right to recognition and respect. . . . Throughout the empire," he goes on to say, "hillslopes, mountain-crags, and similar points commanding a wide range of vision, were chosen centuries ago as sites for their temples, pagodas, and other sacred and important edifices. writer stood one autumn day by a ruined building placed upon the highest point in the Imperial Summer Palace, west of Peking. On every hand,

marring what must once have been a scene of exquisite beauty, were blackened, broken and roof-less walls, and other marks of the desolation wrought by British and French troops when they plundered and burned this palace in 1860. Where the writer stood were to be seen a few Chinese characters recently written upon one of the posts of a finely wrought but broken gateway. Translated, they read as follows:—'A gentleman would not so far demean himself as to consent to the mutilation and destruction of this wonderfully beautiful landscape.'"

I think we must admit that the Chinese citizen who scrawled this on the broken gate-post had not only a fine sense of beauty but also a keen faculty for polite yet searching rebuke.

The truth is that the germ of the Beauty-sense is slumbering in the hearts of all peoples, not only in the Chinese or Japanese peasants whose productions we admire, but even in our more solid and stolid British stocks. But it is very commonly starved out on the one hand by sheer poverty or paralysed on the other by mere superfluity of wealth.

I have spoken in the preceding chapter of the charm of the technique of the mediæval guilds, as seen in their architecture and other craftwork, and suggested how much of the charm derives from the freedom and spontaneity and authenticity of these productions. I do not think we yet perceive what a large element in the con-

sciousness of Beauty is our recognition of a personal factor behind it. I mean that the sense that here is an intelligence seeking for expression adds greatly to our appreciation of the beautiful. It is not every thing of course, but it is an important element—and one that has not been sufficiently considered by the professors and the schools. A rose is presented to you, whose color and form appear perfect; a living creature, it seems. unfolding its life to the world-in some way striving to express itself. But when suddenly vou discover that the flower is an artificial one, what a sense of loss supervenes! Certain elements of beauty remain, it is true, but one most important element—the consciousness of touch upon a kindred life-is gone.

This is so far true that I think it largely explains the ugliness of machine-made things. Here is a row of iron railings. From the South Kensington point of view it may be a very desirable row. The design of each shaft and of the scroll which connects it with the adjacent shaft may be excellent; but when a thousand such shafts and scrolls appear in regimental monotony the mind is paralysed; there is no sense of expressiveness or of personality, only a sense of weary repetition; and one great factor of beauty is lost. So it comes about that, though one may look at a single artificial rose or wrought-iron scroll with pleasure and in admiration of the ingenuity and skill of the artificer, one turns

away from the thousand mechanical copies in disgust.

To be quite practical. Though one can see that there may be not a few intermediate stages to be passed through before this ideal of Industry as an Art can be realised, vet one can see that to keep one's eve fixed on that ideal is the best way of arriving there. The mechanical organisation of Industry may have to be retained for a period, but it must be retained only with a view to the liberation beneath it of the human spirit and of human creativeness. A purely mechanical industry may be retained long in some trades—like the weaving of cotton sheeting or the turning out of steel rails (where uniformity is the main thing required)—longer than in other trades where the human impress is more important. But in such cases the actual length of hours worked under machine-conditions might be so reduced that each employee still had the major part of the day for his own personal and authentic activity. A four hours' shift in many trades would be quite feasible; and practically no worker would object to giving this amount of time provided he had the rest of the day free for the industry in which he was really interested.

As said before, a Wealth which exists only for the purpose of producing *more* Wealth is the most foolish and futile thing imaginable. It is worse—it is poisonous and disease-producing.

For a hundred years now, in this and other Western countries, this Dispensation has lasted; and it has resulted (as many of us foretold years ago) in the deposit of a mass of mere dregs in the bottom of the social chalice, and the spread of a quite foul scum on the top. Possibly nothing but the strain and suffering of a great War could avail to purge the body politic of these evils. We have given endless thought and labor to the perfecting of breeds of Cattle and Cabbages and to the awarding of prizes for the same in countless shows and exhibitions; but we have only thought of the men and women themselves as machines for the grinding out of profit. And now the Nemesis is on us.

Let me recount, in illustration of my meaning, what happened in Manchester three or four years ago. The old Infirmary had been pulled down, leaving a large open space at the end of Market Street, and nearly in the centre of the city. The question naturally arose. What should be done with this open space? and the idea was widely favoured to convert it into an ornamental garden, with plentiful seats and resting-places for the busy public. At a meeting of the City Council a resolution to that effect was proposed, and seemed likely to be carried—when a Councillor got up and said "No-no, you cannot do this; for if you plant an ornamental garden there with seats, what will be the consequence? Why, all the dirty, unclean, poverty-stricken loafers that you

see about the streets now will flock there, and after them it will be impossible for any clean and self-respecting citizen to use the place—so that plan had better be abandoned." After the Councillor had spoken there was a dead silence in the Council. It was seen that no reply was possible, and that the scheme would have to be abandoned. As a matter of fact I have known almost identical things happen in other Northern towns, and schemes for their improvement similarly paralysed.

We need a new gospel of Wealth—namely the liberation of the *real* wealth of this and other nations—the up-building of a glad and free creative Life among the millions, and the growth of a healthy, alert, handsome, and capable population, having in their midst the priceless flower of beauty, and faithfully tending it in their daily life.

### NON-GOVERNMENTAL SOCIETY

MOST people agree nowadays in the view (to which I have alluded already) that the growth of bureaucracy and officialism in the modern State is a serious evil, and that the extension of Government interference and the multiplication of Laws are a great danger. We all know that the institution of the Law and the Courts actually creates and gives rise to huge masses of evil-bribery, blackmail, perjury, spying and lying, wrongful accusation, useless and deliberate suffering and cruelty; that it publicly sanctions and organises violence, even in extreme forms; that it guite directly and deliberately supports vast and obvious wrongs in Society—as for instance land-monopoly; that it is absurd and self-contradictory in much of its theory and practice; that (as Herbert Spencer so frequently insists) it paralyses the folk that submit or trust to it; and finally that it is to-day for the most part so antiquated and out of date that (even if this were thought desirable) it might well seem impracticable to patch it up for real human use.

Yet in these cases—though we admit that the

things are evil—our defence usually is that they carry some compensations with them, and that anyhow they are *necessary* evils, which we cannot dispense with, and without which disorder, violence and social disruption would ensue.

It may be worth while to consider this defence more closely; for curiously enough the history of nations and peoples is, on the whole, to contrary effect. Not only have all the early tribes of the world got on and cohered together in order and social amity without any rigid and ponderous system of laws: but even among the peasant peoples of to-day-like the Irish or the Swedes or the Swiss or the Chinese—where they are still living in moderately primitive conditions, we find the same thing. Governmental law and its operations and institutions occupy but a very small part in their lives. It is true that Custom is strong among all primitive folk, no doubt as a very necessary backbone or framework to their society; but Custom is a very different thing from Law. It is law in its inception-when it is yet in a tentative, rudimentary condition; and however harsh, rigid, or senseless the customs of many savage tribes may be, they are yet easier to alter than when they have become ossified into written forms, with their huge weight of age and ceremony, and the authority of armed men to enforce them.

That human societies can subsist without a considerable amount of Custom we may well doubt: but that they can subsist and maintain themselves in good order and vitality without written law and its institutions there is no reason at all to doubt. And when Custom, among a reasonable and moderately advanced people. leaving behind the barbarities of the savage age, takes on a gentler form, and while exercising considerable pressure on individuals is itself fairly plastic and adaptable to the general movements of society—we seem to see in such pressure a force as far superior to Law as life itself is superior to mere mechanism. A vast amount of our social life to-day in all departments of its activity is ruled by Custom, and some of these customs, like those of "society" and fashion, have a very powerful sway. There is no law, for instance, for the recovery of betting debts, yet their non-payment is extremely rare.

Of course, accustomed as we are to "call the policeman" on every emergency, we find it hard to imagine life without this institution; and our life being largely founded on it, it is so far necessary, and its removal would cause dislocation. That is, since without the police the present spoliation of the poor would not be possible,

even or headmen among these people; but the old men constitute an informal council, which punishes "crime" and the breaking of marriage rules, organises the ceremonies, and from time to time inaugurates reforms.

and the enormous existing inequalities of wealth. and poverty could never have been heaped up -without them the society founded on these artificial inequalities could not well be maintained.1 But to say that because a certain institution is necessary to build up and retain society in a certain abnormal and unnatural form, therefore society cannot exist without that institution, is the same as to say that because to a Chinese woman of rank foot-bandages are necessary. therefore women generally cannot exist without foot-bandages. We have to realise that our present social forms are as ugly and inhuman as a club foot; and then we shall begin to realise how little necessary are these institutions. like law and police, whose chief concern and office is to retain and defend these forms.

The chief difficulty, then, which arises in people's minds at the thought of a free nongovernmental society does not concern its desirability-they are agreed as a rule that it would be desirable—but concerns its practicability. And much of this difficulty is derived from the society of the present. People see, in fact, that an internecine competition for subsistence is the ruling force of life to-day, and the chief incentive to production, and they infer that without government society would dissolve

into a mere chaos of plunder on the one hand, and of laziness on the other. It is this difficulty which has first to be removed.

Though it seems a hard thing to say, the outer life of society to-day is animated first and foremost by Fear. From the wretched wage-slave. who rises before the break of day, hurries through squalid streets to the dismal sound of the "hummer," engages for nine, ten, or twelve hours, and for a pittance wage, in monotonous work which affords him no interest, no pleasure: who returns home to find his children gone to bed. has his supper, and, worn out and weary, soon retires himself, only to rise again in the morning and pursue the same deadly round: and who leads a life thus monotonous, inhuman, and devoid of all dignity and reality, simply because he is hounded to it by the dread of starvation: to the big commercial man, who, knowing that his wealth has come to him through speculation and the turns and twists of the market, fears that it may at any moment take to itself wings by the same means; who feels that the more wealth he has, the more ways there are in which he may lose it, the more cares and anxieties belonging to it; and who to continually make his position secure is, or thinks himself, forced to stoop to all sorts of mean and dirty tricks :-

over the great mass of people the same demon spreads its dusky wings. Feverish anxiety is the keynote of their lives. There is no room for natural gladness or buoyancy of spirits. You may walk the streets of our great cities, but you will hear no one singing-except for coppers; hardly a plowboy to-day whistles in the furrow, and in almost every factory (this is a fact) if a workman sang at his work he would be " sacked." We are like shipwrecked folk clambering up a cliff. The waves are raging below. Each one clings by handhold or foothold where he may, and in the panic if he push his neighbor from a point of vantage, it is to be regretted certainly, but it cannot be helped.

But such a state of affairs is not normal. Allowing that the struggle for existence in some degree or form is unavoidable, history still, except at rare crises, presents us with no such spectacle of widespread anxiety; the study of native races—whom we might consider in a state of destitution—reveals no such dominion of dread. I want the reader to imagine for a moment this burden of fear lifted off the hearts of a whole people; and the result.

Let us imagine for a moment that some good fairy—some transcendental Chancellor of the Exchequer—with a stroke of his wand, has assured to us all not only an old age pension, but a decent provision for all our days of the actual necessaries of life (to go no further than that);

so that for the future no man could feel any serious or grinding anxiety for his own material safety, or that of his family. What would be the result on our actions?

Perhaps, as many would maintain, nine-tenths of the population would say, "I'm blessed if I'll ever do another stroke of work." Like the organ-grinder who came into a little fortune, and who forthwith picked up an axe and fell upon his organ, shouting as he hacked it to pieces, "You shall neffer play dat tam Alabama Coon any more," we should feel so sick of our present jobs that we should want to turn our backs on them for ever. Very likely, I should say—and rightly enough too; for "work" in the present day is done under such degrading and miserable conditions by the vast majority of the population that the very best and most manly thing would be to refuse to continue doing it.

But let us suppose, since a bare living has been assured to us, and we are in no danger of actual starvation, that we all take a good long holiday, and abstain religiously from doing anything. Suppose that we simply twirl our thumbs in idleness for two, three, four, or six months. Still, is it not obvious that at the end of that time nine-tenths of the population would find sheer idleness appallingly dreary, and that they would set themselves to work at some thing or other—to produce comforts or conveniences rising above the level of sheer necessity—objects of

use or beauty, either for themselves, or for their families and neighbors, or even conceivably for society at large; that, in fact, a spontaneous and free production of goods would spring up, followed of course by a spontaneous and free exchange—a self-supporting society, based not on individual dread and anxiety, but on the common fulness of life and energy?

That people relieved from care do spontaneously set themselves to work is sufficiently shown by the case of the well-to-do classes today. For these people, though having everything provided for them, and not merely the bare necessaries which we have supposed, exhibit the most extraordinary and feverish energy in seeking employment. A few decades of years have been quite sufficient to make them feel the utter failure of picnics as an object in life; and now we are flooded with philanthropic and benevolent societies, leagues, charity organisations, art missions to the poor, vigilance crusades, and other activities, which are simply the expression of the natural energies of the human being seeking an outlet in social usefulness. It is, of course, to be regretted that owing to the very imperfect education of this class their ideas and their capacities of social usefulness should be limited. However, this is a defect which will no doubt be remedied in the future. All that concerns us here is to see that since the rich, though in many ways ill-adapted by training and

tradition, do spontaneously take up a life of this kind, there is nothing extravagant in supposing that the average man, surrounded by so many unfulfilled needs, might do the same.

And if any one still doubts let him consider the thousands in our large towns to-day who would give their ears to be able to get out and work on the land-not so much from any prospect of making a fortune that way, as from mere love of the life; or who in their spare time cultivate gardens or plots or allotments as a hobby; or the thousands who when the regular day's work is over start some fresh little occupation of their own—some cabinet-making, woodturning, ornamental iron-work or whatnot; the scores of thousands, in fact, that there are of natural gardeners, cabinet-makers, iron-workers, and so forth: and then think how if they were free these folk would sort themselves spontaneously to the work they delighted in.

Thus it appears to be at least conceivable that a people not hounded on by compulsion nor kept in subjection by sheer authority, would set itself spontaneously to produce the things which it prized. It does not, of course, at once follow that the result would be perfect order and harmony. But there are a few considerations in the positive direction which I may introduce here.

In the first place, each person would be guided in the selection of his occupation by his

own taste and skill, or at any rate would be guided by these to a greater extent than he is to-day; and on the whole would be more likely to find the work for which he was fitted than he is now. The increase in effective output and vitality from this cause alone would be great. While the immense variety of taste and skill in human beings would lead to a corresponding variety of spontaneous products.

In the second place, the work done would be useful. It is certain that no man would freely set himself to dig a hole, only to fill it up again -though it is equally certain that a vast amount of the work done to-day is no more useful than that. If a man were a cabinet-maker and made a chest of drawers, either for himself or a neighbor, he would make it so that the drawers would open and shut; but nine-tenths of the chests made on commercial principles are such that the drawers will neither open nor shut. They are not meant to be useful; they are meant to have the semblance of being useful; but they are really made to sell. To sell, and by selling vield a profit. And for that purpose they are better adapted if, appearing useful, they turn out really useless, for then the buyer must come again, and so vield another profit to the manufacturer and the merchant. The waste to the community to-day arising from causes of this kind is enormous; but it is of no moment as long as there is profit to a certain class.

Work in a free society would be done because it was useful. It is curious, when you come to think of it, that there is no other conceivable reason why work should be done. And of course I here include what is beautiful under the term useful.—as there is no reason why one should separate what satisfies one human need, like the need of beauty, from another human need, like the need of food. I say the idea of work implies that it is undertaken because the product itself satisfies some human need. But strangely enough in Commerce that is not so. The work is undertaken in order that the product may sell, and so yield a profit; that is all. It is of no moment what the product is, or whether bad or good, as long as it fulfils this one condition. And so the whole spirit of life and industry in the other society would be so utterly different from that of the present, that it is really difficult for us to compare the results. But it is not difficult to see that if on the principles of freedom there was not so much produced in mere quantity, and folk did not (as may indeed be hoped) work so many hours a day as now, still, the goods turned out being sincere and genuine, there would really be far more value shown in a year than on the strictly commercial system.

In the third place, it follows—as William

Morris so constantly maintained—that "work"
in the new sense would be a pleasure—one of
the greatest pleasures undoubtedly of life; and

this one fact would transform its whole character. We cannot say that now. How many are there who take real pleasure and satisfaction in their daily labor? Are they, in each township, to be counted on the fingers? But what is the good of life if its chief element, and that which must always be its chief element, is odious? No, the only true economy is to arrange so that your daily labor shall be itself a joy. Then, and then only, are you on the safe side of life. And, your work being such, its product is sure to become beautiful; that painful distinction between the beautiful and the useful dies out, and everything made is an artistic product. Art becomes conterminous with life.

Thus it will be observed that whereas the present society is founded on a law-enforced system of Private Property, in which, almost necessarily, the covetous hard type of man becomes the large proprietor, and (supported by law and government) is enabled to prey upon the small one; and whereas the result of this arrangement is a bitter and continuous struggle for possession, in which the motive to activity is mainly Fear; we, on the contrary, are disentangling a conception of a society in which Private Property is supported by no apparatus of armed authority, but as far as it exists is a perfectly spontaneous arrangement, in which the main motives to activity are neither Fear nor greed of Gain, but rather Community of life

and Interest in life—in which, in fact, you undertake work because you like the work, because you feel that you can do it, and because you know that the product will be useful, either to yourself or some one else!

How Utopian it all sounds! How absurdly simple and simple-minded—to work because you like the work and desire the product. How delightful if it could be realised, but, of course, how "unpractical" and impossible.

Yet is it really impossible? From Solomon to Dr. Watts we have been advised to go to the Ant and the Bee for instruction, and lo! they are unpractical and Utopian too. Can anything be more foolish than the conduct of these little creatures, any one of whom will at any moment face death in defence of his tribe? while the Bee is absolutely so ignorant and senseless. that instead of storing up the honey that it has gathered in a little cell of its own, with a nice lock and key, it positively puts it in the common cells, and cannot distinguish it from the stores of the others. Foolish little Bee, the day will surely come when you will bitterly rue your "unthrifty" conduct, and you will find yourself starving while your fellow-tribesmen are consuming the fruits of your labor.

And the human body itself, that marvelous epitome and mirror of the universe, how about that? Is it not Utopian too? It is composed of a myriad cells, members, organs, compacted

into a living unity. A healthy body is the most perfect society concelvable. What does the hand say when a piece of work is demanded of it? Does it bargain first for what reward it is to receive, and refuse to move until it has secured satisfactory terms, or the foot decline to take us on a journey till it knows what special gain is to accrue to it thereby? Not so: but each limb and cell does the work which is before it to do, and (such is the Utopian law) the fact of its doing the work causes the circulation to flow to it, and it is nourished and fed in proportion to its service. And we have to ask whether the same may not be the law of a healthy human society? Whether the fact of a member doing service (however humble) to the community would not be quite sufficient to ensure his provision by the rest with all that he might need? Whether the community would think of allowing such an one to starve any more than a man would think of allowing his least finger to pine away and die? Whether it is not possible that men would cease to feel any anxiety about the "reward of their labor": that they would think first of their work and the pleasure they had in doing it, and would not doubt that the reward would follow?

For indeed the instinct to do anything which is obviously before you to do, which is wanted, and which you can do, is very strong in human nature. Even children, those rudimentary savages,

are often extremely proud to be "useful," and it is conceivable that we might be sensible enough, instead of urging them as we do now to "get on," to make money, to beat their fellows in the race of life, and by climbing on other folk's heads to ultimately reach a position where they would have to work no longer,—that we might teach them how when they grew up they would find themselves members of a self-respecting society which, while it provided them gratis with all they might need, would naturally expect them in honor to render some service in return. Even small children could understand that. Is it quite inconceivable that a society of grown men and women might act up to it?

But it is really absurd to argue about the possibility of these things in human society, when we have so many actual examples of them before our eyes. Herman Melville, in that charming book Typee, describes the Marquesas Islanders of the Pacific, among whom he lived for some time during the year 1846. He says: "During the time I lived among the Typees no one was ever put upon his trial for any offence against the public. To all appearances there were no courts of law or equity. There was no municipal police for the purposes of apprehending vagrants or disorderly characters. In short, there were no legal provisions whatever for the well-being and conservation of society, the enlightened end of civilised legislation." Nevertheless, the whole

book is a eulogy of the social arrangements he met with, and with almost a fervor of romance in its tone: and vet, like all his description of the natives of the Pacific Islands, undoubtedly accurate, and well corroborated by the travelers of the period. An easy communism prevailed. When a good haul of fish was made, those who took part in it did not keep the booty to themselves, but parceled it out, and sent it throughout the tribe, retaining only their proportionate share. When one family required a new cabin, the others would come and help to build it. He describes such an occasion, when, "at least a hundred of the natives were bringing materials to the ground, some carrying in their hands one or two of the canes which were to form the sides, others slender rods of hibiscus, strung with palmetto leaves, for the roof. Every one contributed something to the work; and by the united but easy labors of all the entire work was completed before sunset."

Similar communistic habits prevail, of course, through a vast number of savage tribes, and indeed almost anywhere that the distinctively commercial civilisation has not set its mark. They may be found close at home, as in the little primitive island of St. Kilda, in the Hebrides, where exactly the same customs of sharing the hauls of fish or the labors of housebuilding exist to-day, which Melville describes in Typee; and

they may be found all along the edges of our civilisation in the harvesting and house-warming "bees" of the backwoods and outlying farmpopulations. And we may fairly ask, not whether such social habits are possible, but whether they are not in the end the only possible form: for surely it is useless and absurd to call these modern hordes of people, struggling with each other for the means of subsistence, and jammed down by violent and barbaric penal codes into conditions which enforce the struggle, societies: as it would be absurd to call the wretched folk in the Black Hole of Calcutta a society. If any one will only think for a minute of his own inner nature he will see that the only society which would ever really satisfy him would be one in which he was perfectly free, and yet bound by ties of deepest trust to the other members; and if he will think for another minute he will see that the only conditions on which he could be perfectly free (to do as he liked) would be that he should trust and care for his neighbor as well as himself. The conditions are perfectly simple; and since they have been more or less realised by countless primitive tribes of animals and men. it is surely not impossible for civilised man to realise them. If it be argued (which is perfectly true) that modern societies are so much more complex than the primitive ones, we may reply that if modern man, with his science and his school-boards, and his brain cultivated through

all these centuries, is not competent to solve a more complex problem than the savage, he had better return to savagery.

But it is getting time to be practical.

Of the possibility of a free communal society there can really, I take it, be no doubt. The question that more definitely presses on us now is one of transition—by what steps shall we, or can we pass to that land of freedom?

We have supposed a whole people started on its journey by the lifting off of a burden of Fear and anxiety; but in the long, slow ascent of evolution sudden miraculous changes are not to be expected; and for this reason alone it is obvious that we can look for no very swift transformation to the communal form. Peoples that have learnt the lesson of "trade" and competition so thoroughly as the modern nations have -each man fighting for his own hand-must take some time to unlearn it. The sentiment of the common life, so long nipped and blighted, must have leisure to grow and expand again: and we acknowledge that—in order to foster new ideas and new habits—an intermediate stage of definite industrial organisation may be quite necessary.

When one looks sometimes at the awful residue and dregs which were being left as a legacy to the future by our present commercial system the hopeless, helpless, drunken, incapable men and women who drift through London and the country districts from workhouse to workhouse, 94

or the equally incapable and more futile idlers in high places, one feels that possibly only a rather stringent industrial organisation (such as the War has brought upon us) could have enabled society to cope with these burdens. The hand of the nation has already been forced to the development of Farm-colonies. Land-reclamations. Afforestation. Canal-restoration, and other big industrial schemes, and these are leading to a considerable socialisation of land and machinery. At the same time the rolling up of companies into huge and huger trusts is, as we plainly see. making the transference of industries to public control and to public uses, daily more easy to effect. On the other hand, the Trade Unions and Cooperative Societies by the development of productive as well as distributive industries, and by the interchange of goods with each other on an ever-growing scale, are bringing about a similar result. They are creating a society in which enormous wealth is produced and handled not for the profit of the few, but for the use of the many; a voluntary collectivism working within and parallel with the official collectivism of the State.

As this double collectivism grows and spreads, profit-grinding will more and more cease to be a lucrative profession. Though no doubt great efforts will be made in the commercial world to discountenance the public organisation of the unemployed (because this will cut away the ground

of cheap labor on which commercialism is built). vet as we have seen, the necessity of this organisation has reached such a point that it can no longer be denied. And as it comes in more and more it will more and more react on the conditions of the employed, causing them also to be improved. Besides, we are fain to hope that something else of which we see growing signs, on every hand, will also come in-namely a new sense of social responsibility, a new reading of religion, a healthier public opinion—which will help on and give genuine life to the changes of which we speak. If so, it might not be so very long before the spread of employment, and the growing security of decent wages, combined with the continual improvement of productive processes and conditions, would bring about a kind of general affluence—or at least absence of poverty. The unworthy fear which haunts the hearts of nine-tenths of the population, the anxiety for the beggarly elements of subsistence, would pass away or fade in the background, and with it the mad nightmarish competition and bitter struggle of men with each other. Even the sense of Property itself would be alleviated. To-day the institution of Property is like a cast-iron railing against which a human being may be crushed. but which still is retained because it saves us from falling into the gulf. But to-morrow, when the gulf of poverty is practically gone, the indicating line between one person and another

need run no harsher than an elastic band. People will wake up with surprise, and rub their eyes to find that they are under no necessity of being other than human.

Simultaneously (i.e. with the lessening of the power of money as an engine of interest and profit-grinding) the huge nightmare which weighs on us to-day, the monstrous incubus of "business"—with its endless Sisyphus labors, its searchings for markets, its displacement and destruction of rivals, its travelers, its advertisements, its armies of clerks, its banking and broking, its accounts and checking of accounts—will fade and lessen in importance; till some day perchance it will collapse, and roll off like a great burden to the ground! Freed from the great strain and waste which all this system creates, the body politic will recover like a man from a disease, and spring to unexpected powers of health.

Meanwhile in the great industrial associations, voluntary and other, folk will have been learning the sentiment of the Common Life—the habit of acting together for common ends, the habit of feeling together for common interests—and once

this has been learnt, the rest will follow of its own accord.

In the course of these changes, moving always towards a non-governmental and perfectly voluntary society in the end, it is probable that some Property-founded institutions, like the payment of labor by wages, though not exactly ideal in their character, will continue for a long It may perhaps be said that in some ways a generous wage-payment convention (as for instance sketched in the last chapter of Carruthers' Commercial and Communal Economy) on a thoroughly democratic basis, gives more freedom than a formless Anarchism in which each one takes "according to his needs," simply because under the first system A could work two hours a day and live on the wage of two, and B could work eight and live on the wage of eight, each with perfect moral freedom-whereas if there was no wage system, A (however much he might wish to loaf) would feel that he was cheating the community—and the community would think so too-unless he gave his eight hours like everybody else.1

The great point however to bear in mind in all this matter is that though the Cash nexus may and no doubt will linger on for a long time

It is difficult also to see how things like railways and the immense modern industries (if these survive) could be carried on without some such system of wage-payment and the definite engagement to fulfil certain work which it carries with it.

in various forms of Wages, Purchase, Sale, and so forth, it must inevitably with the changing sentiment and conditions of life lose its castiron stringent character, and gradually be converted into the elastic cord, which while it may indicate a line of social custom will yield to pressure when the need arises. Private Property will thus lose its present virulent character, and subside into a matter of mere use or convenience; monetary reckonings and transfers, as time goes on, will seem little more than formalities—as to-day between friends.

Finally, Custom alone will remain. The subsidence of the Property feeling will mean the subsidence of brute-force Law, for whose existence Property is mainly responsible. The peoples accustomed to the varied activities of a complex industrial organism, will still—though not suffering from the compulsion either of hunger or of brute authority—continue through custom to carry on those activities, their Reason in the main approving.

Custom will remain—slowly changing. And the form of the Societies of the future will be more vital and organic, and far more truly human, than they have been or could be under the rigid domination of L'aw.

#### VI

# SMALL HOLDINGS AND AGRICULTURAL CO-OPERATION

In my experience Small Holders are among the best and most capable of our rural populations. I include as small holders those who work farms up to forty acres or so.1 They generally exhibit good deal of all-round capacity, and are versatile and handy at a variety of jobs. And this for the simple reason that having to look after a small place mainly by themselves they are obliged to be a little ingenious and versatile. Such a man, besides the farmwork connected with the animals and the crops, generally knows something of joinering and iron work; he has a bench and a few tools, and an old anvil picked up at a sale; he personally repairs his sheds and outhouses, or (if he is a freeholder) builds new ones: he does a little thatching; and in many cases—especially if his holding is really small he is compelled to earn something by outside work for neighbors, by doing a bit of gardening. or masoning or walling from time to time. Thus

The Small Holdings Act of 1907 includes anything from one acre up to fifty acres.

such a man is often very resourceful, and in a sense well-educated, even though he may only read or write with difficulty.

On a large farm there is almost too much division of labor. There are several farm-hands, and one is cowman and another plowman and a third horseman, and so on; and I find they tend consequently to drop into grooves and become rather limited in their outlook and activities. The farmer, instead of compelling a change of occupation now and then, takes the easiest line and allows the young men—even though they be his own sons—to remain in their grooves, and consequently to grow up somewhat stunted in ability and ignorant of a large portion of their proper business.

For this reason alone—namely, the production of handy capable men (and women)—Small Holdings are much to be encouraged. If the men and women of a country are (as they certainly are) its most important crop, this is a matter which demands attention. The decay of the townbred peoples—the puny sickly character of the crowds that are the product of the factories and offices of our big towns—is a menace to our civilisation; and if at the same time the present depopulation of the country-sides is going to continue the situation will become very serious. We want to get a far larger population on the land, and so to produce a far larger amount of home-grown food than we do at present. Pro-

ductive self-support has in fact become imperative. It has been calculated that if the United Kingdom were only cultivated to the same degree that Belgium was before the Great War it would supply home-grown food for 37 million people instead of for 17 million as now: and there is no doubt that an equal or even greater degree of cultivation is quite possible here—with due organisation and intelligence. We have heard a good deal lately about our dependence on the imports of food from abroad. In 1905 the imports of butter, cheese, milk (condensed), bacon, lard, fowls, eggs, onions and potatoes. amounted to £58,000,000 in value—the value in eggs alone being nearly £7,000,000. All these articles, and many others, including apples, pears, small fruits, honey, and many vegetables. are particularly suited for being grown on small holdings, but (partly owing to the dearth of such holdings) have been much neglected, and their place taken by foreign produce. The importance of getting the additional population on the land which an extension of small cultivation would mean, and at the same time of securing so great an augmentation of our food supply, can hardly be overestimated. It ought to be one of the very first things to be considered in the reorganisation of our industrial system.1

"In France, before the loss of Alsace-Lorraine there were about five million proprietors owning seven and a half acres each on the average; and in Würtemburg 260,000

It must not be forgotten too that an increased (productive) country population would supply an extra market for our townmade manufactured goods, and so again be helpful in making the whole community self-contained and independent of foreign influences. Not that foreign trade is in itself a thing undesirable; but it always has to be remembered that to be dependent on influences which we cannot control is a mistake; also that, other things being equal, to exchange goods at home is better than to exchange the same abroad, simply because the cost of shipping or carriage is so much less in the former instance.

There are other things to be said in favor of small holdings. One is that they constitute a 'ladder' by which the agricultural laborer or even the townsman may climb up to a substantial position on the land. The younger son of a farmer, for instance, does not generally see any prospect of coming into the farm himself. He cannot command enough capital to take another large farm and stock it, and if he cannot find a small holding suited to his means there is nothing left for him but to become a farm servant or to migrate into town life. Naturally he adopts the latter alternative. It is often said that the depopulation of the country-sides is due to the inordinate desire of country lads for

peasant owners with less than five acres each, and 160,000 with over five acres each" (pamphlet by J. B. Paton on the Peasantry of England, Manchester, 1901).

the excitements of city life. I do not find it so. More often they are simply driven into the towns by the necessity of earning a living somewhere, and by the closure of all avenues of decent life in the country. It goes without saying that long hours, wretched wages, and the dulness of life under the régime of the squire and the parson, contribute to this result. If we are to have an intelligent and alert population on the land (a sine qua non of any nation's greatness) the land must be made attractive and accessible, and one means towards this is the encouragement of small holdings.

Hitherto we may almost say any development in this direction had been discouraged in this country by those who have most sway in the matter-the landlord class. There are several reasons for this. One undoubtedly is that small holders as a rule—whether freeholders or tenants -are not 'respectable' enough to suit the gentry. They are too democratic. People who have a little independence of habit and manner, who do not salute their superiors becomingly, or who build with their own hands ramshackle sheds and outhouses in their fields, are obviously not to be encouraged. And what is more serious, such people are a great bar to 'sport.' Foxes are liable to be trapped or poisoned by them. To hunt or shoot over their little holdings is to run the risk of having a wasp's nest stirred about one's ears and to court all sorts of unpleasant-

nesses. For indeed a landowner who has five or six large farmers for his tenants can fairly easily come to terms with these in the matter of hunting and shooting, but what could he do with fifty or a hundred small holders? The thing would be impossible.

It is somewhat the same with regard to Rents. The landlord or his agent finds it much easier and simpler to collect rents from a few large holders than from a great many small ones. Hence there is a tendency for convenience' sake towards large holdings. In the middle and later part of last century the rolling up of small farms into large ones went on apace. To-day there is beginning to be a tendency the other way; but the breaking up process and the providing of barns and cottages for the subdivided portions is a laborious and expensive matter, and at present is only moving slowly. Of course this matter of the size of farms is also largely a question of the kind of crops arranged for or desired. Where cereals or root crops are wanted large holdings and agricultural machines of various kinds are much to the point, but the equally valuable and often more valuable supplies of vegetables, small fruit, orchard fruit, eggs. etc., are best grown on small places where individual attention is the main thing and machinery is less important.

One common objection brought against the \*See Ch. VII, infra.

small holding idea is that little industries work at a disadvantage in point of capital, division of labor, sheer productiveness, etc., as compared with large-scale industries. Of course there is a certain amount of truth in this—though it would not do to say that all small-scale industries suffer in the comparison—and if it were the case that the absolute and only object of industry was the money-value of its product there would be still more truth in it; but we have seen through that delusion already, and need not again be led astray by it.

JiThe limitation, however, of his Capital, in the case of a small man, his disadvantage in the markets, both in buying and selling, his being compelled sometimes to invest in a horse and cart or in some kind of machinery which the exiguity of his estate will not permit him fully to use, the difficulty that he has in borrowing money in a time of need, and the danger of falling into the hands of the money-lender—all these things undoubtedly do militate against the small holder; and the cure for them equally undoubtedly is to be found in Co-operation.

The classical instance of the value of Cooperation in connexion with small holdings is to be found in Denmark. After 1864, when Germany had wrested Schleswig-Holstein from the Danes, there was nothing left for the latter but to make the best of what remained to them.

Tutland was little better than a sandy heath: but with extraordinary energy the people threw themselves into its development: the soil was worked and enriched in every possible way; the land was broken up into holdings of seven to ten acres each: sheds and cots and cottages were erected: co-operative societies were formed among the settlers; the government helped with agricultural organisation, the creation of High Schools for the peasants, and the loan of funds: and before long there were beside large farms some 150,000 little holdings of seven to ten acres successfully running there, whose activities were largely carried on by combined labor. first co-operative dairy was started in 1882; by the year 1904 there were over 1,000 such dairies. Bacon-curing, the collecting and sale of eggs. poultry, honey, the manufacture of butter and cheese, the purchase of seeds, food-stuffs, manures, machinery, were all negotiated by the same method: insurance and banking the same: and in this short period of time sandy Jutland became a large exporter of food, and poured even into England (with its really richer soil) great quantities of farm-produce which England might have been growing for herself. In the form of butter, eggs and bacon alone Denmark before the War was supplying the United Kingdom to the value of 15 or 20 million sterling.1

France, Belgium, Holland, Norway, Sweden, Finland, Italy, Roumania, Bulgaria, have followed on the same lines of agricultural co-operation. Nor must we forget Ireland. The noble efforts of Horace Plunkett and afterwards of George Russell (A.E.) were scoffed at at first. But gradually they won their way. In 1889, I believe, the first Irish Creamery was started; in 1895 there were already 67; and in 1902, over 320, effecting sales to the value of £1,000,000 per annum; to-day there are agricultural societies without end, for the production and sale of poultry, eggs, flax, fruit, honey, and a variety of other things.

Mr. George Russell, in his excellent book The National Being, shows from his own experience what the co-operative association can do. says (p. 46): "The Society is a better buver than the individual. It can buy things the individual cannot buy. It is a better producer also. The plant for a creamery is beyond the individual farmer: but our organised farmers in Ireland. small though they are, find it no trouble to erect and equip a creamery with plant costing £2,000. The organised rural community of the future will generate its own electricity at its central buildings, and run not only its factories and other enterprises by this power, but will supply light to the houses of its members and also mechanical power to run machinery on the

farm. One of our Irish societies already supplies electric light for the town it works in. In the organised rural community the eggs, milk, poultry, pigs, cattle, grain and wheat produced on the farm and not consumed or required for further agricultural production, will automatically be delivered to the co-operative business centre of the district, where the manager of the dairy will turn the milk into butter or cheese, and the skim milk will be returned to feed the community's pigs. The poultry and egg department will pack and dispatch the fowls and eggs to market. The mill will grind the corn, and return it ground to the member, or there may be a co-operative bakery to which some of it may go." And so on. A picture follows of how the rural labourers under this regime will gradually become skilled co-workers with one another, and the co-operative community have its own carpenters, smiths and mechanics how there will be common laundries and kitchens. and village halls with libraries and gymnasiums and rooms for recreation and dancing. All very feasible, and one may say already realised in part in various different localities.

The matter of co-operative banks is important. At present a small man who wants £20 to pay his rent with is very much put to it if he does not happen to have that amount in hand—even though he knows that in a couple of months he will be quite well off. If he goes to the

ordinary Bank to borrow he is treated with scant respect and made to understand that owing to deficient security he will have to pay a high rate of interest. The alternative for the wretched man is to sell a cow, which he often has to do. owing to the forced sale, at a decided loss. [And there are, I need hardly say, some speculative dealers who count on this sort of thing and make a practice of purchasing from small men in distress. The co-operative Bank is a quite different affair. The farmers of a certain district club together for financial purposes. Having between them all a great amount of valuable farm stock, machinery, etc., it becomes possible for the Club to go to an ordinary commercial Bank and borrow on this joint security. The security in the mass being thoroughly good the Bank will probably, as things are, lend at 4 per cent. interest. The Club will borrow just as much as it needs, and lend the money out, if required. to its members—of course at a rather higher rate of interest, say 5 per cent. The extra 1 per cent, so coming in will pay the secretarial and other expenses of the Club. Now the Club. or its committee, knowing well the financial circumstances of its members, will have no difficulty in deciding in each case on what conditions, of interest or repayment, the loan shall be afforded. It will only perhaps be very rarely that interest exceeding 5 per cent. will be demanded. Suppose a small man wishes to borrow, as above,

a sum of £20 to pay his rent. He only wants the loan for a couple of months, as he will be able to repay it before then, and he gets the money from his Club at 5 per cent. Five per cent. on £20 for a year would be £1; but for those two months it will only amount to 3s. 4d.; and he obtains this great accommodation for that trifling sum. This is a good deal better than having to sell his cow at a breakneck price.

In many cases the combination of a large farm with a number of small holdings and village industries in a kind of co-operative Colony may prove very desirable, and it is much to be hoped that this form of settlement on the land may be carried out in the future. Let us suppose that 2.000 acres of good farm land are purchased and properly equipped with buildings and machinery and live stock, and that out of this or in connexion with it sufficient land is set apart for twenty or thirty small holdings, with suitable cottages and barns. Then a good farm-manager working the central farm would have beside his regular staff a supply of men from the small holdings to do wage-work when necessary on the farm. On the other hand as a skilled agriculturist he would be able to advise the small holders about their crops and their animals; he would organise for them co-operative purchase of food-stuffs, etc., or co-operative sale of their produce. Moreover a number of the small men would probably have command of useful trades,

such as blacksmithing, building, joinering, tailoring and so forth; and so a competent head man might in this way build up a largely self-contained and at any rate self-supporting Colony—in which all the members would take some share in the work, and of course derive a corresponding share of the profits.

Colony or no Colony, the combination of a small holding with some technical or industrial occupation is a great help. There are always times when work on the land is not needed, or if needed not feasible, and in such times a small trade is a great financial resource. In this way smithing, as I have said, or joinering or cabinet-making, or masoning, or boot or sandal making, or bookbinding, engraving, literary and art work, teaching, commercial traveling, and many other activities may be worked in with the agricultural life, and with really great advantage to both sides.

In the matter of the purchase or acquirement by individuals of such holdings—either freehold or on a long lease—Co-operation naturally comes in again. In the neighborhood where I am living—while fields adjacent to the roads and eligible for building command something like £100 per acre—large farms of 50 or 100 acres can often be bought in bulk for £25 per acre. Needless to say that it is good business for a group co-operatively to purchase such a farm and subdivide it themselves according to their needs—the low price enabling them jointly to

make accommodation roads, erect fences, etc.: and such a group may naturally combine for further purposes. like buying and selling, when once the holdings are fairly established and in operation. When the Land Valuation Acts are once supplemented by a "Tax and Buy" ordinance, allowing public bodies to purchase lands on a fair basis of their estimated rental for rating purposes, some millions of acres now held up in private ownership for sporting or other non-productive uses will come into the market. and be available for the objects indicated in this chapter. I have on more than one occasion had reason to mention the case of some moors near here which till lately carried for rating purposes an estimated rental of only 2s. 6d. per acre, and which yet were charged to a public body for reservoir needs at the rate of over £100 per acre | I

In England the Small Holdings and Agricultural Co-operation movement progresses only slowly—though a few large owners like Lord Carrington and Mr. Winfrey in Norfolk and Lincolnshire, and Sir Robert Edgcumbe in Dorset, and a few societies like the A.O.S., have done their best for it. But the Government and the official people have been very slack and have not seemed to realise the importance of the matter; while the farmers have commonly been rather hostile than otherwise. Thus it has come

about that while Ireland in such things is on the forefront of the wave of progress England is still waterlogged (water on the brain!) and in the trough of the sea.

The English mind, being relatively incapable of reasoning, only moves as a rule under the stimulus of felt necessity or of a visible objectlesson. Start a Creamery or Co-operative Dairy in a certain locality, and the people of the neighborhood will come to see, and will possibly in the end follow the example in their own villages, but you may talk and lecture to them without end and still without result. An amusing illustration of this concrete habit of the English mind occurred at Brandsby in Yorkshire at the beginning of the County Council's agricultural lectures in that region. An expert came there weekly to give lectures on Dairy Work and butter making. The attendance at the first lecture was poor and disappointing. At its conclusion a farm-man got up and said that he didn't see the good of a "gentleman" coming down to lecture to them on dairy work "what had probably never milked a cow in his life." Luckily the lecturer knew his business and immediately replied, "Well, I'll milk a cow against you any day." Great excitement! The challenge was accepted, and it was agreed that at the next week's meeting there should be two cows on the platform, and the competitors should toss up for their choice. The news spread through the

village, and whereas the lecture-room at the first meeting had been almost empty, at the second it was full to overflowing. The lecturer fortunately won easily, getting more milk from his cow, and in less time, than the other; and after that, needless to say, the course was a great success.

This concrete habit and tendency to rely only on actual experience has, of course, its good side; and our County Councils and other authorities, taking up the cue, should do their best to dot the country-sides with effective examples of small holdings co-operatively organised.

#### VII

#### THE VILLAGE AND THE LANDLORD:

My object in this paper is simply to describe the economic conditions of a single country parish, here in England, and from the consideration of these conditions to draw some inferences towards our future policy with regard to the land. modern life-in every department of it, one may say-bedrock facts are so veiled over by complex and adventitious growths that it is difficult to see the proper and original outline of any problem with which we are dealing: and so it certainly is in this matter of the land question. Any one glancing at a country village, say in the neighborhood of London, probably sees a mass of villas, people hurrying to a railway station, motorcars, and so forth; but as to where the agricultural workers are, what they are doing, how they live, what their relations may be to the land and the land owners-these things are obscure, not easily seen, and difficult to get information about. And yet these are the things, one may say, which are most vital, most important.

The parish which I have in mind to describe is a rather large and straggling parish in a rural district, with a small population, some 500 souls. almost entirely agricultural in character, consisting of farmers, farm laborers, woodmen, and so forth, with a few miners and small artisans—on the whole a pretty hard-working, industrious lot. Fortunately, one may say, there is hardly anything resembling a villa in the whole parish; there is no resident squire, and the business man is conspicuous by his absence. The place therefore forms a good example for the study of the agricultural land question. The farms are not over large, being mostly between fifty and one hundred acres in extent. There is just the land. and the population living mainly by the cultivation of it. This population, as I have hinted, is not lacking in industry; it is fairly healthy and well grown; there is no severe poverty; and (probably owing to the absence of the parasite classes) it is better off than most of our agricultural populations. Yet it is poor, one may almost say very poor. Probably, of the hundred families in the parish, the average income is not much over £60 a year; and many, of course, can by no means reach even that standard.

Let us consider some of the financial and other conditions which lead to this state of affairs. In the first place, I find that the inhabitants have to pay in actual rent to their landlords about £2,500 a year. In fact, the gross estimated rental of the parish is about £3,250, but as there are quite a few small freeholders the amount actually paid in rent is reduced to £2,500. Nearly the whole of this goes off out of the parish and never comes back again. The duke and most of the other landlords are absentees. This forms at once, as is obvious, a severe tax on the inhabitants. One way or another the hundred families out of what they produce from the land have to pay £2,500 a year into alien hands or, averaging it, £25 per family! and this, if their average income is now only £60, is certainly a heavy burden; since, if they had not to pay this sum, their income might be £85. No doubt it will be said. "Here we see the advantage of having resident squires. The money would then return to the parish." But would it? Would it return to those who produced it? No; it would not. The spoliation of the toilers would only be disguised, not remedied. In fact, let us suppose (a quite ordinary case) that the parish in question were owned by a single resident squire, and that the £2,500 were paid to him in rent. That rent would only go to support a small extra population of servants and dependents in the place. One or two small shops might be opened; but to the farmer and farm worker no advantage would accrue. There might be a slightly increased sale of milk and eggs; but this again would be countervailed by many

disadvantages. "Sport" over all the farm lands would become a chronic nuisance; the standard and cost of living, dress, etc., would be raised; and the feeble and idiotic life of the "gentry," combined with their efforts to patronise and intimidate, would go far to corrupt the population generally. In this parish then, of which I am speaking, the people may be truly thankful that they have not any resident squires. All the same, the tax of £25 per family is levied upon them to support such squires in some place or other, and is a permanent burden upon their lives.

Less than a hundred years ago there were in this parish extensive common lands. In fact, of the 4,600 acres of which the parish consists, 2.650, or considerably more than half, were commons. They were chiefly moors and woods; but were, needless to say, very valuable to cottagers and small farmers. Here was pasture for horses, cows, sheep, pigs, geese; here in the woods was firewood to be got, and bracken for bedding; on the moors, rabbits, bilberries, turf for fuel, etc. In 1820 these commons were enclosed: and this is another thing that has helped to cripple the lives of the inhabitants. As is well known, during all that period systematic enclosure of the common lands of Great Britain was going on. In a landlord House of Parliament it was easy enough to get bills passed. Any stick will do to beat a dog with; and it was easy to say that these lands, being common lands, were not so well cultivated as they might be, and that therefore the existing landlords ought to share them up. The logic might not be very convincing, but it served its purpose. The landlords appropriated the common lands; and during the 120 years from 1760 to 1880, ten millions of acres in Great Britain were thus enclosed.

In 1820 the turn of this particular parish came, and its 2,650 acres of commons "went in." I used to know an old man of the locality who remembered when they "went in." He used to speak of the occurrence as one might speak of a sinister and fatal event of nature—a landslide or an earthquake. There was no idea that it could have been prevented. The commons simply went in! The country folk witnessed the proceeding with dismay; but, terrorised by their landlords, and with no voice in Parliament, they were helpless.

It may be interesting to see some of the details of the operation. In the Enclosure Award Book, still kept in the parish, there remains a full account. The then Duke of Rutland, as lord of the manor, as impropriator for tithes, as proprietor, and so forth, got the lion's share, nearly 2,000 acres. The remaining 650 acres went to the other landlords. Certain manorial and tithe rights were remitted as a kind of compensation,

Thus we find, in exchange for the ducal tithes, nearly a third of the whole area of the parish handed over—most of it certainly not the best lands, but lands having considerable value as woods and moors. We find some acres adjudged to the duke in consideration of his kind "consent" to the transaction. And, most wonderful of all, nearly 450 acres surrendered by the parish to defray the expenses of getting the Act through Parliament! And now to-day in the said parish there is not a little field or corner left—absolutely not a solitary acre out of all the vast domain which was once for the people's use—on which the village boys can play their game of cricket!

Indeed, most valuable tracts were enclosed quite in the centre of the village itself—as, for instance, a piece which is still called "The Common," though it is no longer common, and many bits on which little cottages had been erected by quite small folk. It would be a very desirable thing that the enclosure award books in other parishes should be investigated, and the corresponding facts with regard to the ancient commons brought to light generally over the country.

A third thing which cripples the agricultural interest very considerably is the incidence of the rates. The farmer's dread of a rise in rates has become almost proverbial. And it is by no means unnatural or unreasonable. For there is probably no class whose estimated rental is so large. compared with their actual net income, as the farmer class. A farmer whose farm, after deducting all expenses of rent, rates, manure, wages, etc., yields him a clear profit of no more than £100 a year for his household use is quite probably paying £70 a year in rent. But a superior artisan or small professional man who is making £150 a year will very likely be only paying £20 in rent. It is obvious that any slight increase in the rates will fall much more heavily on the first man than on the second. The rates, therefore, are a serious matter to the farmer;

and something in the way of shifting their incidence, and distributing the burden more fairly, ought certainly to be done.

As an instance of this latter point, let me again refer to the parish in question. We have seen that some 2.600 acres of common lands passed over to the landlords in 1820, ostensibly for the public advantage and benefit. Of these, more than 1.500 acres of moor land, held by the duke, are rated on an estimated rental of less than 2s. 6d. per acre. The general farm lands of the parish are rated on an estimated rental of 14s. or 15s. per acre on the average. Thus the moor lands are assessed at about one-sixth of the value of the farm lands. This is perhaps excessively low; but the matter might pass, if it were not for a somewhat strange fact-namely that a few years ago when some twenty acres of these very moor lands were wanted for a matter of great public advantage and benefit, that is, for the formation of a reservoir, the ducal estate could not part with them under £50 an acre; and a little later, when an extension of acreage was required, the district council had to pay a much higher price, so that the total purchase, first and last, comes out at more than £150 per

I am not here discussing the question of how far a rise of rates falls upon the landlord; for, though this may ultimately and in the far distance be so, it is clear that the farmer primarily feels the pinch, and not till he is nearly ruined is there any chance of his getting a corresponding abatement of rent.

acre! Now here is something very seriously out of joint. Either the moor lands are worth a capital value of £150 an acre, in which case they ought to be assessed at, say £5, instead of at 2s. 6d.; or else, if the rating at 2s. 6d. is really just and fair, surely it is monstrous that the public, having to carry through a most important and necessary improvement, should be "held up" and made to pay a ruinous price, simply because the land cannot be obtained elsewhere. The conclusion is: Let such lands be rated in accordance with the capital value set upon them by their owners, and we shall have a much fairer and more equitable distribution of the public burden.

And this matter of the moors leads to the consideration of a fourth cause which cripples the land cultivator terribly in this country. I mean Sport. The nuisance and detriment that this is to the farmer has become so great that, unless strict measures are soon taken, widespread ruin will ensue. In many subtle ways this acts. With the enormous growth of wealthy and luxurious classes during the last fifty years, the tendency has been to turn the country districts into a mere playground. The very meaning of the word. sport has changed. The careful working of covers by the occasional sportsman has been replaced by clumsy battues, with wild shouts and shrieks of "drivers," and huge slaughter of birds, half tame, and specially bred for the purpose.

Mobs of people, anxious to appear fashionable. and rigged out by their tailors in befitting costume, are formed into shooting parties. Rich men, wanting to get into society, hire moors and woods, regardless of expense, regardless of animal slaughter, regardless of agricultural interests, as long as they get an opportunity to invite their friends. In Devonshire to-day the farms in many parts are simply eaten up by rabbits, because the landlords, in order to provide plenty of shooting. insist on spinneys and copses and hedgerows and waste bits being retained in their wild state for purposes of cover! On the northern moors the rabbits simply devastate the farms along the moor edges-not because the rabbits are preserved, for the shooting is mainly of grouse and pheasants. but because the moors, being uncared for except in this way, the rabbits are allowed to multiply without check. They are the gamekeeper's perquisite. Yet if the farmer who has a farm adjoining the moor carries a gun to protect himself against their invasions, it is conveyed to him (if a

The financing of these affairs is funny. A large moor will let for the grouse season for £3,000, say on the condition of grouse being bagged up to, but not beyond, 2,400 brace. Mid-week parties hurry in by rail and motor, stay for two or, perhaps, three nights, and hurry off again, to be succeeded by other parties the following weeks. The whole thing is conducted in the most mechanical way, with "drives," batteries," and so forth. And when the expenses are added up, including men employed, guests entertained, and rent paid, they certainly do not fall far short of the proverbial guinea a bird!

tenant of the same landlord) that he had better not do so, lest he should be suspected of shooting the grouse! Thus he is paralysed from his own defence. In the parish of which I am speaking there are lands along the moor edges which used to grow oats and other crops, but which now, on account of the rabbit nuisance, are quite uncultivable in that way, and only yield the barest pasture.

In and about 1850, when wheat more than once reached £5 a quarter, the farmers and landlords were doing a roaring trade. Rents were high, but the land could afford it Farmers were anxious to increase the size of their holdings, and landlords were not averse to this, as it saved them trouble. And so set in that tendency to roll small holdings into big ones which continued, with baneful effect, during all the second half of the century. Sport at the same time came in to increase the action. It was easier to pacify the few than the many over the matter. It was simpler to hunt a pack of hounds over two or three large farms than across a network of small holdings. Besides, the New Rich, as well as the elder gentry, wanted widespread parks, and not a democratic rabble of cottagers at their very doors. And so the game went on. Soon prices of farmstuff fell heavily. But it is easier to get rents up than to get them down again. The alleviations of rent which have taken place since 1854 have been only painfully gained and

grudgingly yielded. Wheat which was at 100 shillings a quarter then fetched only about 30 shillings at the beginning of this century! And though other farmstuffs have not fallen in like degree, yet during all that period of declining prices, the British farmer has been pinched and pined all over the country. The landlord has been on top of him; and with holdings often much too large for his need, and a yearly balance too small, he has employed far less labor and tillage than he ought to have done; his land has lost heart; and he has lost heart—till he has become to-day probably the least enterprising and least up to date of all the agriculturists of Western Europe.

Such are some at least of the causes which have contributed to the decay of agriculture in this country; and their consideration may indicate the directions in which to seek for a cure.

What is needed, first and foremost, is very obviously security of tenure, under such conditions as shall give both farmer and cottager a powerful interest in the land and its improvement. It is often said, and supposed, that the countryman nowadays does not care about the land and the rural life, and is longing to exchange it for town life. I do not find this so. I find that he is compelled into town life by the hard conditions

which prevail in the country-but not that he wants to leave the latter. Indeed, I am amazed at the tenacity with which he clings to the land. despite the long hours and the heavy toil: nor can one witness without wonder and admiration the really genuine interest which he feels in its proper treatment, quite apart from any advantage or disadvantage to himself. It is common to find a farm laborer expressing satisfaction or disgust at the good or bad tillage of a field with which he is in no way connected; or to see a small farmer's son working early and late, perhaps up to the age of thirty, with no wages but a mere pittance in the way of pocket-money, and only a remote prospect of inheriting at some future date his share of the farm-stock and savings, and vet taking a wholehearted interest in the work not really different from that which an artist may feel. There is some splendid material here -in these classes neglected by the nation, and overlaid by a tawdry and cheap-jack civilisation.

I say it is clear that they must be given a secure and liberal tenure of the land and be free once for all from the caprice of the private landlord with his insolences of political intimidation and sport, and his overbearance in parochial affairs. The absolute speechlessness of our rural workers to-day on all matters of public interest is clearly, to any one who knows them, due to their mortal dread lest their words should reach the powers above. It has become an ingrained

habit. And it has led of course to a real paralysis of their thinking capacity and their enterprise. But place these men in a position where the fruits of their toil will be secure, where improvements can be made, in cottage or farm, with a sense of ownership, and where their vote and voice in the councils of the parish will not be dependent on squire or parson; and the world will be astonished at the result.

There are two main directions in which to go in the matter of secure tenure. One is the creation of more small freeholds: the other is the throwing of lands into the hands of public authorities, and the creation of permanent tenures under them. Though the latter embodies the best general principle, I do not think that forms a reason for ruling out freeholds altogether. In all these matters variety is better than uniformity: and a certain number of freeholds would probably be desirable. In the same way with regard to public ownership, if anything like nationalisation of the land is effected. I think it should decidedly be on the same principle of variety-creating not only State and municipal ownership, but ownership by county councils, district councils, parish councils, etc.—with a leaning perhaps towards the more local authorities, because the needs of particular lands and the folk occupying them are likely on the whole to be better understood and allowed for in the locality than from a distance.

Let us suppose, in the parish which I have

taken for my text, that by some kind of political miracle, all the lands on which rents are now being paid to absent landlords were transferred to the ownership of the Parish Council. Then at once the latter body would come into an income of £2.500 a year. At one blow the whole burden of the rates would fall off, and still a large balance be left for public works and improvements of all kinds. It might be allowable, for a moment, to draw a picture of the utopian conditions which would ensue—the rates all paid, the rents milder and more equal than before, the wages of parish workers raised, free meals for school-children provided, capital available for public buildings, free libraries, agricultural engines and machinery, also for improving or administering common lands and woods, and so forth. There is no danger of course of so delirious an embarrassment occurring! for any scheme of nationalisation would take a long time. and would only gradually culminate; and no scheme would place the whole lands of a parish at the disposal of a single body like the parish council. But the example helps us to realise the situation. Every farmer and cottager whose holding was under a public body would know and feel that whatever rent he might have to pay, it would come back to him in public advantages, in the ordaining of which he would have a voice; he would know that he would be in no danger of disturbance as long as he paid his rent; and in the matter of capital improvements in land or building he might either make them himself (with the council's consent), in which case if he should decide later on to quit the holding, the council would compensate him, knowing that the rental paid by the new tenant would be correspondingly increased; or he could get the council (if willing) to make the improvement, and himself pay a correspondingly increased rent for it. In either case he would have as good a bargain, and almost as free a hand, as if he were on his own freehold.

Security of tenure, largely through public ownership, must certainly be one of the first items of a land-reform program. Another item, the importance of which is now being widely felt, is the making provision for the effective supply of small holdings. The Small Holdings and Allotments Act (of 1907) has not so far borne much fruit. Indeed, one rather gathers that forces purposely hostile to it have been at work. But this state of affairs must not continue; and some advance in that direction will certainly have to be effected. By small holdings I mean holdings, freehold or leasehold, from twenty-five acres down to one or two acres in extent, each with cottage and buildings attached. Of holdings of this class '(largely owing to the "rolling up" policy of last century) there is an absolute famine in the land. The demand, the outcry, for them is great, but the supply is most scanty. Yet this class covers

some of the most important work of modern agriculture, and a great variety of such work. It includes, in its smaller sizes, market gardens, with intensive culture of all kinds, and glass, besides the kind of holding occupied by the professional man or other worker who supplements his income by some small cultivation; and in its larger sizes it includes nurseries, as well as small arable and pasture farms. The starvation that exists to-day in Britain of all these classes of industry is a serious matter.

In the parish with which we are dealing, owing partly to its distance from a market, the demand for such holdings takes chiefly the form of a demand for small arable and pasture farms. But the need of these is great, as indeed it is nearly all over the country. A holding of this kind, of any size from five to twenty acres, forms an excellent stepping-stone, as I have said (p. 102), for a farm laborer or farmer's son towards a position of independence. A second or third son of a farmer, not likely to follow his father in the occupation of the

farm, has to-day only a poor prospect. Unable to command enough capital to stock a large farm himself, and unable to find a small one, he has but two alternatives—to drift down into the fruitless life of the farm laborer, or else to go off and try his luck in town. If, as is most often the case, he is twenty-five or so before the need of making a decision comes upon him, his chances of learning a town trade are closed, and the first alternative is all that is left. Vet the small holder of this kind is often one of the most effective and useful types of agricultural worker. holding, say of fifteen acres, while he cannot get an adequate living for himself and family by ordinary farm methods, yet he can gain a considerable amount, which he supplements by working as a useful hand for neighbors at harvest and other times. Being thrown on his resources. and not having too much land, he gains more than the average out of it, and his own ingenuities and capacities are developed; so that, as a rule, he is the most resourceful and capable type of man in the district. It is of the most vital importance to the country that this type of man, and his class of holding, should be encouraged.

There is one method which I have so far neglected to mention by which both security of tenure and small holdings can be obtained—I mean Co-operation. The formation of co-operative societies for the purchase of large farms, for the division of them, the building of cottages,

and the leasing of small holdings so obtained, is one of the most hopeful directions for the future. It ought to be easy for the public authorities to lend money on perfectly safe terms for this purpose. What co-operation has done and is doing for agriculture in other countries-in the way of establishing banks, land-holding societies. societies for butter-making, egg-collecting, buving of feeding stuffs and manures, sale of produce. etc., is now perfectly well known. Ireland even has left England behind in this matter; but England and Scotland will have to level up. It is a sign, at least of good intentions, that the late Act gives power to the County Councils to promote and assist the formation and working of co-operative agricultural societies of all kinds.

One of the very first things, I think, which ought to be taken up is this question of the commons. If ten million acres between 1760 and 1880 passed so easily from the public use into the exclusive hands of the landowners, surely there ought not to be much difficulty in passing them back again. As I have said, they were appropriated mainly on the plea that, being commons, they were inadequately cultivated. The main cultivation they have received from the landlords has been of rabbits, grouse, and other game! The public has been simply played with in the matter; and agricultural interests, instead of being extended and improved, have been severely,

damaged. When we realise, in addition to this, that, owing to the increase of the general population and its needs, these tracts which passed into private hands with such slender compensation to the public, are now held up at ruinous prices, we realise that it is high time that the game should cease: and that the lands which Parliament voted away from the public in those days should now be voted back again-and with "compensation" on a similar scale. These lands are still largely in the hands of the families to whom they were awarded: and the transfer could perhaps be most fairly and reasonably effected by their simple reversion to the public on the expiration of existing life interests in them. But of course there would have to be land courts to deal with and compensate 'special cases, as where the land had changed hands, and so forth.

The value of such ancient common lands to the public would now be very great. Large portions of them would be suitable for cultivation and for allocation in small holdings; the villages would again have a chance of public playgrounds and cricket grounds; the Parish councils would have lands (so much needed and so difficult to obtain) for allotment gardens; the District councils might turn many an old woodland into a public park; while the wilder moors and mountains could be held under. County councils or the State, either for afforestation, or as reserves for the enjoyment of the public, and

the preservation of certain classes of wild animals and birds, now in danger of extinction.

Let a large measure of this kind be passed retransferring the main portion of the common lands into public hands; and at the same time a measure compelling owners in the future to declare their land values, and giving power to the public bodies to purchase on the basis of the values so declared; and already we should have made two important steps towards bringing the land of the nation into the possession of its rightful owners.

#### VIII

# BRITISH ARISTOCRACY AND THE HOUSE OF LORDS

It has often been said that our victory at Waterloo was a great misfortune to England; and in general terms the truth of this remark can hardly be gainsaid. Our successes as against the armies of the French Revolution certainly kept the current of new human forces and ideas associated with that movement at a distance, and warded it off from our shores. The feudal system, broken down and disorganised all over the Continent by Napoleon, preserved its old tradition in these islands. And one consequence has been that, in the matters of our Land-system and our Aristocracy, we are now a hundred years behind the rest of Western Europe.

Our land-system, with its large estates breeding a servile and poor-spirited population of tenantry and farm laborers, has had the effect of clogging and depressing British agriculture—to such a degree, indeed, that the latter has become a thing despised and neglected by our-

selves and derided by our neighbors. And our Aristocracy has developed to so monstrous and importunate a form that, like some huge parasite, it threatens disease and ruin to the organism upon which it has fastened. It is with the latter trouble that I am at this moment concerned.

It is indeed curious that Britain, which has for so long a time boasted herself in the fore-front of human progress, should now be saddled with this institution—a reactionary institution of such magnitude and dead weight as no other nation in the world can show. And more curious still is it that, all the time, with great diligence and apparent zeal, she is enlarging and building up the absurd incubus which weighs her to the ground.

Poor Britain! with all her other burdens—her burdens of crying poverty, of huge population, of limited land, of distressing fogs both in the mental and physical atmosphere—to be actually fastening and riveting this extra one upon her own back! What must one think of such a nation? Has she lost her wits, and does she at all divine what she is doing? Is she still lost in a sleep of centuries, and living in dreams of three or four hundred years ago?

There has in the past been a certain glamour and romance about the Feudal Aristocracy. Perhaps distance lends enchantment. We like to lose ourselves in a kind of Tennysonian dream of knights and ladies; we know that once

there were bold bad barons, who certainly were a terrible pest to their contemporaries, but whom we rather admire in the far perspective: we do not forget the great historical families, whose largesses and whose crimes were on a splendid scale, whose petty jealousies and quarrels with each other were the ruin of peasants and the devastation of country-sides, but whose noblesse oblige had elements of heroism and sacrifice in it, even on account of the very fact of its meaning the maintenance of their own Order as against the world. We may readily concede that these people did some work that had to be done, we may allow that there was a certain poetry and creative power in it: but what has all that to do with the modern Aristocracy?

Of the 550 hereditary peers who to-day constitute the bulk of the House of Lords, it is very doubtful if a single one had a relative present at Runnymede and the signing of the Charter. It is said that only five can even trace their families back to that century. In the reign of Elizabeth the lay Lords numbered no more than sixty. Even the Stuarts, who lavished honours on the most dubious favourites, only increased the list of peers by about 100. It was—and the moral is easily drawn—in the reign of George III that the great growth of the modern peerage took place. George himself, anxious to strengthen his weak hand in the Government, insisted on nominating a large contingent—his

congeners and equals in point of brains and education—a crass and fat. snuff-taking and portwine-bibbing crew. William Pitt—and this was part of his settled policy—drowned out the old Whig families in the House of Lords "by pouring into it members of the middle and commercial class, who formed the basis of his political power -small landowners, bankers, merchants, nabobs, army-contractors, lawyers, soldiers, and seamen. It became the stronghold not of blood, but of property, the representative of the great estates and great fortunes which the vast increase of English wealth was building up." The whole process was a sort of strange counterblast to the French Revolution. But with Pitt's successors it continued to such an extent that actually the total number of peerages created during George the Third's reign was 38812

And from that time forward the same. Britain, to accentuate her victory over Napoleon, and to assure the world of her anti-revolutionary principles, steadily added and added to her tale of titled heads: till now—instead of the feudal chiefs and royal boon-companions and buccaneers and sea-dogs of old days—we have a wonderful

breccia of brewers and bankers, colliery owners and Stock Exchange magnates, newspaper proprietors, wine dealers, general manufacturers and industrial directors, among whom the old landlords lie embedded like fossils I It must be confessed that whatever romance a title may have once carried with it has now quite gone. is hardly possible, one would think, for the most Philistine Briton or world-foraging Yankee to perceive any glamor in the present aristocracy. Indeed, one may say that—although, of course, it includes some very worthy persons—a certain vulgarity attaches to the class as a whole, and that it is doubtful whether any really self-respecting commoner would consent to be included in it.

But the curious fact is, as I have said, that it continues to grow and be added to. At present the United Kingdom is blessed with 750 peers in all (not all of them in the House of Lords), besides an innumerable host of lesser dignities. The late Conservative Government, during its ten years of office, scored fifty-seven additions to the House—not a bad count; but Campbell-Bannerman beat all records by creating twenty in the course of his first eighteen months! If the accretions to the ranks of Rank are to continue at similar rates, imagination gasps at the probable situation, say in fifty years.

With regard to this extraordinary freak of "C.-B.'s," it is difficult to find a rational explana-

tion, which—in view of the debate at that time about the sale of honours to wealthy party supporters—is not also a rather unpleasant one. In the story of "Bel and the Dragon," when Daniel determined to destroy the great Idol which the people worshipped, he fed into its capacious maw fresh lumps of "pitch and fat and hair" (of which ingredients, no doubt, the monster was already composed). He seemed to be nourishing and fattening it, but in reality he destroyed it, by causing it to "burst in sunder." But whether the Liberal party really wishes or thinks to break up the House of Lords in the same way is extremely doubtful. It is certainly an odd way of doing battle.

That it can be for a moment supposed that that House can be converted into a progressive institution by ample creation of Liberal peers is out of the question. In the first place, there is the huge existing Conservative majority there, to be overcome before anything like a balance can be established. In the second place, there is the undeniable and portentous fact that for turning a man into a Tory, a day in that House is better than a thousand (outside). For reasons and in ways not very difficult to see there is a steady social and conventional pressure going on in those surroundings, which gradually transforms well-meaning and progressive folk into rigid obstructives. Of the ninety-two peers (and their successors) created by Liberal Prime Ministers

in the last fifty years, only forty-six, that is one half, are now Liberals. Thirdly, it must be remembered that of those who do thus call themselves Liberals, and under that head are created peers, their real liberality and culture and public spirit (for the most part, and with a few very genuine exceptions) are only skin-deep. They have worked mainly for their own private ends and advancement; they have been successful men in business or in law; they have engineered society influences: they have made themselves grateful to highly placed personages; they have dumped down enormous funds on occasions for election and other purposes; they have even obtained what they wanted by forbearing to press for the payment of debts! In a variety of ways they have been useful to their own side: and sometimes they have been so little useful that for that reason it has been thought better to remove them to "another place." But whatever the cause of their advancement, the end to which it leads will in most cases be the same. It is hard to believe-as Mr. Joseph Clayton says in his excellent little book. The Truth about the Lordsthat the cause of "temperance legislation will be assisted in the Upper House by Lords Burton and Blyth"; or that "the progress of labor legislation, in favor of a shorter working day and the abolition of child-labor, will be hastened by Lords Nunburnholme, Pirrie, Glantawe, and

Winterstoke." Having climbed the Liberal ladder, the great probability remains that they will scorn the base degrees by which they did ascend, and retire finally to swell the obstructive influences in the Second Chamber.

Lastly—and most important of all—the probability that the House of Lords can be converted into a progressive institution by the creation of Liberal peers is practically nil, for the simple reason that the Liberal party itself is not essentially progressive; and as time goes on gets less and less differentiated in all important respects from the Conservative party—into which in the end it will probably merge.

The whole magnification and bolstering-up of both the House of Lords and the "Aristocracy" generally in this country is certainly an extraordinary phenomenon, and one which would hardly be possible in any other country of the world in this year A.D. Pausing for a moment to take a bird's-eye view of it, and guarding ourselves against undue self-depreciations or too-sweeping comparisons of the Briton with other nations, let us just make a plain matter-of-fact estimate of the situation.

One might suppose that here in the general Aristocracy, among the pick and pink of the nation, endowed with wealth, education, and farreaching influence, would be found the leaders and pioneers of every great movement; that art and science, sociology and politics would be

filuminated and inspired, organised and marshalled by this class; that abroad it would stand as representative of what was best and most vigorous in our people: and that at home and in the country-sides it would set the tone and animate the centres of the most healthy and useful life. What do we actually find? A waste of duliness. commonplaceness and reaction. This Aristocracy does nothing—next to nothing that can be said to be of public utility, for even the really useful work of the ordinary country gentleman on County Councils and as a member of the Great Unpaid can hardly be placed to its account. It produces (in the present day) no artists, no men of letters of any distinction, no inventors, no great men of science, no serious reformers, hardly even a great military general or political leader. And this is certainly astounding when one considers the exceptional opportunities its members have for success and advancement in any of these directions, and the ease with which thev can command a hearing and a following.

It is true, of course, that occasionally a man of decided note and ability—a Kelvin or a Tennyson, a Beaconsfield or a Kitchener—on account of real of generally admitted service to the nation, and *not* on account of his swollen

money-bags or his scheming self-advertisement, is collated into the Aristocracy. But such individuals are not numerous, and they are not the *product* of the Aristocracy. They are importations into it which, alas! do not modify its general character, but too often, like good building materials thrown into a swamp, simply sink into it and disappear. The amount of useful genius or talent which the institution, from its hereditary deeps, supplies to the world is an almost negligible quantity.

Again-not to make too great a demand in the way of world-wide genius or service, but to keep to humbler spheres—we may point out that the class in question does not rise to the occasion of its most obvious duties. Despite the efforts of Lord Carrington to arouse its activity. it does not remodel villages on its estates, or create experimental colonies on its broad acres; it does not meet the very genuine demand now existing for small holdings, it does not even lend farm lands to Boards of Guardians for the use of the unemployed. If these things have to be tackled, they are left to the generosity and philanthropic zeal of wealthy Americans, who come across the water to polish up the old country. It does not exhibit any pride in making its factories or its quarries or its collieries '(where its revenues spring from such sources) models of excellent and cleanly management, with the best

conditions possible for the workers concerned in them. It organises none of the social reforms in town or country which are so cryingly needed, and which it ought to be so well qualified to initiate. It sometimes appears (though, of course, this is not really the fact) as though it could think of nothing more beneficial for its rural demesnes and their populations than to shoot over them, or more appropriate for its town duties than to employ plenty of dressmakers for Society functions.

One must not certainly deny that these good people move up in squadrons, and are greatly in evidence as Patrons and Patronesses of Bazaars, or of Hospitals, or of philanthropic institutions of various kinds. Anything that is colourless and non-committal, which is popularly helpful, without being a severe tax on pecuniary funds or physical energies, and in which a name or a title carries weight, is peculiarly favoured. As Mr. Clayton says (p. 102), "For the laying of foundation-stones, opening of important buildings, presiding over religious and philanthropic meetings, the directing of limited liability companies, the 'governing' of self-governing colonies. and the entertaining of political followers, they are in great demand." And with all these duties, and the demands of "Society" generally, it really would not be fair to call them idle. We may even say that they are enormously busy.

It would be foolish also to deny-what is

sufficiently obvious—that among the titled people, especially the older families, there are found some folk of a humane and cultured class of mind, with charming and genuine good manners, simple habits, and a real sense of responsibility and even affection towards those dependent on them; and for the existence of such people, in whatever sphere, we may be grateful, especially in these days when they are in danger of being drowned out by tawdry newcomers.

But all this-in the way of benefits or advantages accruing from the Aristocratic system -is very negative. On the other hand, the positive evils of the system do not admit of being overlooked. To the mass of meaningless fashion and expensive idleness created by our social arrangements generally, it accords an imprimatur of distinction and desirability. The flagrant sale of high honours—worse, apparently, in the beginning of this twentieth century than ever before -corrupts the nation with the resultant lesson that to make a fortune anyhow and to spend it for personal aggrandisement is the best way to gain distinction and public respect. Trafficking in titles has become quite a profession, and a rich man has now little difficulty, through the mediation of diplomatic but impecunious ladies of rank, in getting himself made a knight or a baronet. A quite uncalled-for and disproportionate power is put into the hands of persons who are really not worthy of it, whose aims are

vulgar, whose education is poor, on whose tables hardly a book of real merit is to be found (often. certainly, not as good literature as is seen in a better-class workman's home): and among whom the questions most important to be discussed are whether golf or motoring, baccarat or bridge. shall be the order of the day. Gangs of similar folk use their "influence" to get important positions in Army or Navy or official circles filled up by relatives or favorites; and the resultant scandals of incompetence or maladministration. which later years inevitably unfold, are hushed up by the same influences. The nation is heavily injured, but the damage does not recoil on the heads of those most responsible. "Society" twaddle fills the newspapers and impresses the uninitiated and unlearned: the aimless life and ideals silting downwards infect the masses of the people with a most futile and feeble conception of life: and in little matters of dress and etiquette ultimately make the middle classes even worse than those whom they imitate, and from whom they suppose the fashions to originate.

To return to the House of Lords. I have no intention here of dwelling on its record of inefficiency and obstruction. Of its political history during the last century; of its meagre and scanty attendances, even over the most important questions; of its marvelous inefficiency and want of comprehension in dealing with the same; of its indifference when any human or humane inte-

rest has been concerned of its dead obstructiveness when such things seemed to endanger in any degree its "rights of property": of its clinging to the death-penalty (in 1810) for the stealing of values over 5s., and to the same (in 1820) for values over £10, and to the same again (in 1839) for sheep-stealing; of its maintenance by large majorities of vivisection (1879), and of trap pigeon-shooting (1883); of its turning deaf ears to the pleading cry of children in the coal mines (1842), or of little chimney-sweep urchins in the chimneys (1849), or of evicted and faminestricken peasants in Ireland (1880-2); of its steady refusal, until fairly forced, to grant the rightful and natural demands of citizens for suffrage and self-government and religious equality and the education of their boys and girls; or to grant the demands of women for rights over their own property and persons, and of men for the protection of their own labor-power:-are not all these things written in the great books of the Chronicles of the last hundred years, as well as in the pages of the Almanacks and the manifestos of the late Mr. Stead? There is only one opinion about them; and what has been said a thousand times it is needless to repeat.

Nor can we fairly expect anything else. If we indulge in the absurdity and scandal of making men high legislators because they have heaped together huge fortunes by selling "purge" and "kill-devil" to a drink-sodden public, or have

made themselves wealthy and notorious by circulating lying and sensation-mongering canards among ignorant populations, we must expect the absurdities and scandals and misfortunes which are the logical result. And if it only stopped there! But to go further, and to make the bodily heirs of these people our future High Legislators, even to the crack of doom—well, that is surely midsummer madness, and a gilding of the refined gold of folly! As a precise and practical writer has remarked: "Our toleration of this costly absurdity is the wonder of the world. Its like is not to be found in any other civilised nation."

The real question which remains is. What is to be the cure? Dismissing the supposition that a syndicate of American millionaires will buy up the House of Lords complete for the purposes of a world-exhibition, and, on the other hand, the supposition that a violent wave of socialist revolution will drown it suddenly out of existenceas being, both of them, though feasible, beyond the range of immediate politics, we may at least, and as a practical issue, discuss what considerable and radical changes would really bring this institution, and that of the Aristocracy generally, into the line of human usefulness. There is fair reason to suppose that in a few years the Labor party or parties in the Lower House will have a decisive influence there: and in view of that probability some suggestions for a future policy

with regard to the Peers may be useful—though the following proposals (it must be understood) are merely individual, and would not perhaps be accepted in block by any of the Socialist organisations.

I think we may assume that, short of a violent catastrophe, the Second Chamber will be retained. Its total abolition would not be in accordance with the temper and tradition of the British; and, personally, I think that—as long as our present general Constitution remains—a Second Chamber is desirable: because our House of Commons-though with an intelligent voting public it might become intelligent, and even get to know a little political economy-must always, from the method of its election, be largely composed of professional politicians, and must represent mainly popular ideals, views, and currents of opinion. There is no harm in this. but it requires to be corrected by a more searching, accurate, and experienced spirit (if only, for example, in order that Bills passed by the popular Assembly may be intelligible, and may not become law while still containing hopelessly contradictory clauses). Also a Chamber with some intelligent and public-spirited initiative about it would be very helpful.

A Second Chamber, then, seems to me on the whole advisable, and will, I have no doubt, for a long time to come be demanded by the

British people. It will not necessarily be the House of Lords; but here again the British love of tradition and continuity will come in, and will probably insist on its being called the House of Lords—even long after it has come to consist mainly of manual workers and advanced women!

The practical question therefore is—how to begin immediately to remodel the Upper House with a view to rendering it (in time) a useft Second Chamber.

The first and immediate need obviously is to drop the hereditary qualification. No son of an existing peer should sit in a future House simply on account of being an eldest son. He may succeed to his father's title (of that more anon). but not therefore to his father's seat. The present House will not be wiped out, but in the twinkling of an eve it will be changed, as far as its legislative functions are concerned, to a body of lifepeers. The descendants of the existing peers will (possibly) carry on their ornamental functions in Society, but they will cease to be our hereditary Legislators. This is so very indispensable a reform, and the scandal and absurdity of the present arrangement is so monstrous, that without making this first step practically nothing can be done; and the public must simply choose between this and eternal disgrace. Moreover, it is a reform which could be carried out almost imperceptibly, and with a minimum of friction.

The present House would remain, for the

moment, undissolved; but its numbers would slowly dwindle with the decease of its members. All future peers created in order to supply the consequent vacancies would be life-peers, Whatever other titles they might carry, or if they carried no titles at all, in either case their right to sit in the House would not descend to their offspring. Thus in the course of not so very many years we should have a Second Chamber wholly consisting of life-members appointed on their own merits, and neither claiming nor exercising hereditary power.

What would be the general principles of appointment to such a Chamber? It might be urged that (after it was once fairly established) it should be made self-elective—say like the Chinese Academy, which for more than a thousand years has exercised so tremendous a sway over

the destiny of China. As every one knows, the Chinese Academy consists of some 240 members. the best scholars and savants in the empire, to each of whom by immemorial provision is allowed a house and a small salary. The duty of the body is to debate and turn its critical acumen and enlightenment on any or every public question that may arise. It has no direct legislative or executive power: but the results of its debates and its recommendations are widely circulated through the empire, and have an immense influence on the popular mind, while at the same time the body exercises or has exercised a very outspoken censorship over the acts of officials and even of the Emperor himself. This body is self-elective. When a vacancy occurs the remaining members elect the new one. It is thus independent of patronage, and no doubt (as the remarkable history of the Chinese Academy shows), when once a good tradition is started, this method of election may be very effective.

With regard to the House of Lords, however, there might (at present) be objections to this method—and we may take it as probable that new (life) peers will continue to be created, and writs of summons issued, on the recommendation of the Premier at the time in office. Assuming this, I think it must follow, as the second absolutely necessary reform, that in all cases a reason (of distinguished service) must be given for each creation. Sir Wilfrid Lawson on one occasion,

in 1887 I believe, proposed this. And it is clear that to leave the distribution of high honours and the position of Hereditary National Legislator to the irresponsible appointment of any Government, is simply to court bribery, corruption, and malversation. A distinct and sufficient reason must be given for each creation, just as is done in the case of the award of a medal or decoration, a V.C. or a D.S.O. and though this in itself might not always secure the best men. it would certainly go a long way to keep out the commonplace and really harmful types. whose real recommendation to-day consists in services which would not bear public scrutiny. Of course this reform will be strenuously resisted by certain classes, just for the very reason that irresponsible patronage is so dear and so very convenient to those who can exercise it: but the change is absolutely necessary and indispensable

It would probably have to be accompanied by some indication as to the kind of distinguished service which should be regarded as a qualification. Personally, I think that in this Second Chamber, or House of Life-peers, as far as possible, every class or section of the nation should be represented, and represented of course by well-known and well-tried members of such class, or by those who have done good service to their class or to the nation. Lord Rosebery, in 1884, in moving for a Select Committee on the reform

of the House of Lords. "specified nine classes which were entirely without representation in that House. The first were the Nonconformists, the last the Workmen. The other seven were as follows-medicine, science, literature, commerce, tenant-farmers, arts, and colonists. He suggested that life-peers should be created, and that the ancient system of assistants, by which judges were called into council, might be revived." I at any rate, as far as it went, was a practical suggestion towards making the House an efficient and useful body. But the details of such membership. ex officio and other, would of course need careful consideration, and into that question we need not go now. What is clear, at present, is that the future House of Peers (and here the word "peers" comes in very appropriately) will consist of able men of all classes and so-called ranks in society. And this is in the line of a very obvious and natural evolution. In early times the Lords Spiritual, who often outnumbered the Lords Temporal in the House, were not a little jealous of the latter. Towards the close of the eighteenth century the old landed families, who alone beside the Church were there represented, were furiously disgusted at the accession to their ranks of large bodies of commercial and professional gentry. Again, in 1856, there was a storm in the House over the granting of a

life-peerage to Lord Wensleydale; the highest legal and historical authorities, however, maintained that it was the ancient right and privilege of the Crown to create life-peers; and in 1887 the Appellate Turisdiction Act was passed, in accordance with which certain Law-lords now take their seats for life ex officio. Finally, in the last twenty years, classes of men have been admitted to the House whom even George III would not have dared to propose. Sir Erskine Mav. in his Constitutional History of England, speaking of the great growth in numbers of the Upper House in modern times, says "With this large increase of numbers the peerage has undergone further changes no less remarkable, in its character and composition. It is no longer a council of the magnates of the Land-the territorial Aristocracy, the descendants or representatives of the barons of the olden time: but in each successive age it has assumed a more popular and representative character." Thus, although the present House would, no doubt, be much shocked at the idea, it does not seem at all improbable that a time may come when a Joseph Arch, for instance, as an eminent farm-laborer and representative of farm-laborers, might be called to sit on its councils.

Another reform which will probably be advisable will be the limitation of the new House of Life-peers to a definite number of members

—although, of course, such limiting number might be alterable from time to time. One great advantage of such a limitation is, that on any occasion the number of vacancies existing is known, and the question of their replenishment comes naturally before the public, so that, whoever the appointing authority may be, he or they cannot easily act in a secret or underhand way in the matter, as is indeed too possible with the present method.

The reforms thus proposed are practically

- 1. Life-peerages (the actual title a matter of little importance).
- 2. Adequate reasons of useful service to be given for each creation—on democratic grounds more or less scheduled and recognised.
  - 3. Limitation of number of members.

Under such conditions as these reforms would induce, the Second Chamber would probably turn out satisfactorily, and there does not seem any reasons why its powers should be seriously curtailed. To propose to keep the House of Lords as it is, is practically to ask for the curtailment of its powers and the suspension of the right of veto—for it is evident that things cannot go on very long as they are; but to remove the right of veto would in effect be to reduce the House to a mere revising body—whose work

could, of course, be better done by a committee of experts. If a Second Chamber is to be retained at all, far more sensible would it be to make it a really useful and intelligent institution, with power of initiative and power of veto—the latter at any rate to some degree, though of course guarded. Short of our securing such useful and intelligent body, Abolition would be the only alternative.

There remain a few words to say about the Aristocracy generally, and the possibilities of bringing it into line as a serviceable or even tolerable institution. It is fairly clear that the same arguments which have been brought forward in favor of a life-seat only in the House of Peers, and in favor of a declaration of the reasons for conferring that distinction, apply equally—though not perhaps equally pressingly -to the conferring of titles generally. Of course. it would be possible to raise a man to a baronage or an earldom, and in doing so to give him a life-seat only in the Second Chamber, while at the same time continuing his title to his heirs: but the question arises, Why-because a man has done useful service to the nation (assuming, of course, that he has), and the nation to show its gratitude confers some title upon him-why should the irresponsible heirs of this man, and of other such men, be allowed in perpetuo to sport similar titles, and so to form (as we see) a class of

Society idlers (or busybodies) who, to say the least, exercise an enfeebling and unworthy influence on the rest of the people? It may be replied to that, that as long as you take from such folk direct legislative power, the thing does not matter. If any such classes like to whirl round in their little coteries, and have their smart dinner-parties and their scandals, their punctilios of precedence and their privileges of heading lists of subscriptions, why should the nation interfere to deprive them of these simple pleasures? And there is so far truth in this, that we must admit that as long as the present commercial system continues. and there remains, as to-day, a sum of some 600 millions sterling of unearned income, or more, to be divided every year among the capitalist and landlord classes, this feeble and unworthy life will probably continue among such classes, whether titled or not. That is so far true: but it forms no reason why the nation. by a system of rank without service, should give its imprimatur of distinction to such a life.

Again, there may be some people who believe in Blood so far as to think that the descendants of a really great man inherit his virtues to a remote posterity. And it certainly seems possible

that some day—when there is a State department of Eugenics-whole families may be granted a pedigree and diploma on account of their excellent breed: but then I need hardly say that such patent of nobility would be immediately cancelled for any person who should breed children outside the regulation of the State—as I fear many of our aristocracy at present do! And as to the Blood descending with the Name, a very brief calculation will dispel that illusion, for it is easily found (doubling at each generation) that ten generations back one had over a thousand ancestors living (say in 1600 A.D.), while ten generations again before that (say in 1300) one had over a million. Any one, therefore, who can trace his descent from some ancestor living in 1300-and there are few indeed who can do that-will have the satisfaction of knowing that one-millionth part of the blood in his veins will be due to that ancestor!

I have referred—in speaking of the House of Lords—to the Chinese Academy, which seems an extraordinarily practical and sensible institution. We might do worse than take a hint from China as to the handling of titles generally. Greatly and devoutly as John Chinaman believes in heredity, descent, and ancestor-worship, he is not

such a fool as to close his eves to the fact that blood very soon runs out and becomes intermixed. Chester Holcombe, for some years Acting Minister of the United States at Peking, says of the Chinese in his excellent blook. The Real Chinaman: "There is no titled nobility, with its long list of elder and vounger sons, sons-in-law, and cousins near and remote, to be supported from the public funds, and to fill all the more important positions of honor and profit. The few titles that are from time to time bestowed carry nothing with them but the nominal honor: they are bestowed as rewards for distinguished services, and have never been recognised as forming the basis of any claim whatever upon either offices or treasury. In a way they are hereditary, but soon run out, since the rank decreases one grade with each generation. Even the imperial clan forms no exception to this rule. The author has many a time had in his employ a man who, as a relative of the Emperor, was entitled to wear the imperial yellow girdle; but he was a hod-carrier, and earned six cents a dav."

With this suggestion—for the benefit of some future Government—I will close. Let our Aristocracy, as far as it is hereditary, be "let down gently" by the rank descending one grade with each generation. This already happens with the younger children of our higher ranks, who

receive courtesy titles for life. Let a system of such courtesy titles be extended for two or three generations, and let all children in that respect count as younger children; and in a few years we should have got rid of a foolish and somewhat vulgar anachronism.

#### SOCIAL AND POLITICAL LIFE IN CHINA:

Ι

In speaking of China, it is necessary to guard against a misconception still greatly current, namely that the Chinese are a backward, ignorant nation, slumbering in a kind of agelong lethargy. In many respects this notion is the reverse of the In many respects the Chinese are the most wide-awake of races. They are certainly one of the most remarkable. Intelligent, observant, accurate, industrious, kindly, polite, tenacious of custom, having an immense history stretching back thousands of years, they are at once among the oldest and the most childlike of peoples-old and wise in the accumulated experience of their own past, yet little more than children in face of some of the problems which to-day the West presents to them. It is only in the latter sense that any awakening of China can be spoken of or expected.

Their historical records come down in a con-

tinuous stream from some 4.000 years ago: and, though there has been constant development during that time, there has been no great break in their institutions. There is no record of a time when they did not occupy the country they now occupy: no record of a time when they had not a monarchical system, in general outline the same as they now possess 2-never a time when the great masses of the people were not agricultural as now, never a time when they were not practically self-sufficing and independent of other countries and peoples. Time and time again they have been invaded. Tartars, Manchurians, Mahommedans, Christians, Japanese, Dutch, Portuguese. English, and Russians have poured in upon them; yet they have never been very greatly disturbed. With a smile that is childlike and bland John Chinaman has pursued the even tenor of his way. And his teeming millions, instead of being conquered, have simply swallowed up the invader and continued much as before.

Printing, as is well known, was invented in China 500 years before it was used in Europe; gunpowder even before that—though it shows sadly for the intelligence of the Chinese that

they did not use it for killing people with till they were taught by the Europeans'! Their astronomical observations are among the oldest in the world, dating some 2,000 years B.C. As much as seventeen or eighteen hundred years ago they adopted changes of a socialist character, and began to establish their land system on a reasonable basis. Seven or eight hundred years ago they tried the use of an irredeemable paper currency, and found it wanting. And for centuries past '(till quite recently) the military profession has been lapsing into contempt and disuse as unworthy of a great people.

After these considerations it is not very surprising to find that this great nation coming down from the remote past found itself in the early centuries of our era—or at any rate had good reason to think itself—the most advanced and civilised on the whole earth. We read that Marcus Antoninus in A.D. 166 sent an embassy by sea to China to procure the rich silks which that country produced. The culture of silk was brought thence into Europe during the Emperor Justinian's reign. Tea plants were carried from India to China in A.D. 315, and Chinese physicians and Chinese engineers were employed in

Persia in the twelfth and thirteenth centuries ! From that period onwards its experiences of other peoples were not very favorable. French. Portuguese, Spaniards, Dutch, Russians, and Britons appeared in turn, but their conduct was more that of pirates than of civilised men. More and more did the Celestial Empire learn to look on all outsiders as 'barbarians' and 'foreign devils.\* More and more it shut itself away from the world. It established a ring-fence about itself, and lived in isolated superiority. It remained sublimely ignorant of the rise of the great Western nations, and of what we call modern Progress; and so came about the extraordinary result that in 1835 or so, a little before our Opium war with China, that ancient nation, from Emperor to peasant, was living in profoundest ignorance of what we call Modern Civilisation; in sublime, celestial, and indeed quite ludicrous sense of its own superiority over "the red-haired, green-eved, hairy-faced monsters of the West, with feet one cubit and two-tenths long," who were supposed to inhabit Europe; and in the sharpest possible contrast to them, both of life and ideals.2

It may be that our ignorance of China is in reality little less remarkable than theirs concerning us. We most of us think we know something about the subject. We have relations or friends who have been along the Coast, and who have brought back outlandish tales: we have read similar accounts in the columns of the daily Press: but such things hardly touch the fringe of the matter. In all such cases where along a seaboard one race or civilisation comes into direct contact with another race and civilisation the result is-just what one might expect-a disorganisation and corruption of both. Probably there are few more corrupt European populations than those you find at Hongkong, Shanghai, and the other ports along that coast. And, on the other hand, the Chinese populations in those places give you no more just idea of the great interior of China than a stroll down Ratcliffe Highway and the London Docks would give you of British home life and industry. The mass of books and print dealing with China describe this motley, mongrel, and degenerate civilisation of the seaboard. Nevertheless there is a literature dealing with the true Interior, and sufficient, at any rate with a little study-and with plentiful allowance for dark patches '(as for superstitions, cruelties, ignorance, poverty, famines, etc.)-to give us a glimpse of a vast ocean of population, not to be counted at much less than 400,000,000, and probably the most stable, the most well-rooted,

the most content, equal, agricultural and peaceloving on the whole earth.

This may sound too strongly worded; but, in order to show that there is some foundation for the view, I will first quote a few general remarks by well-known and reliable authorities on the subject, and then proceed to a more detailed account.

Professor Giles, in his Historic China and Sketches, says (p. 124): "Food and lodging are cheap in China, and it may be roundly stated that every man, woman, and child has something in the way of clothes, two full meals a day, and a shelter at night"; also, "The normal state of the people of China is one of considerable prosperity and great natural happiness." Fortune, in his Residence among the Chinese, says: "I doubt if there is a happier race anywhere than the Chinese farmers and peasantry"; and A, J.

Little in *Through the Yangtse Gorges*: "Riches are fairly distributed, and the contrast of grinding poverty with arrogant wealth, which is the rule in Europe, is the exception here."

I will now sketch out very roughly some of the leading ideas and institutions of the Chinese polity, premising of course that over a country so vast as China, with its various climates, races, dialects, etc., there is necessarily a considerable variation in details; 1 also that my object is not to excite an ignorant attention by the recital of wonders and absurdities, nor to flatter our own complacency by dwelling on the follies or failures of a distant civilisation, but to point out the great constructive lines and inspirations of that civilisation (surely one of the most remarkable in the world); and then to pass on to a consideration of what great changes are likely to ensue both in itself and abroad owing to its contact with the civilisations of the West.

One of the most salient, and to us most interesting, characteristics of China is the essential Democracy of its institutions, and the sense

It is interesting, however, to find that writers agree on the essential homogeneity of the Chinese people. and practice of Equality among its populations. Unlike India, we may almost say that there is no hereditary class or caste in China. The only caste is the Literary Caste, from which all officials are taken, and admission to this '(by examination) is so free and open that the ascent of a boy of the poorest family to the highest positions and honours is quite usual and excites no special notice. Eugène Simon, whose knowledge of China is most intimate, asserts '(La Cité Chinoise, p. 62) that it is rare to find a family, however lowly, which has not some member, close or distant, of highest rank: and that owing to this perpetual rise and fall in station the whole population is leavened through with the sentiment of equality: and of course. correspondingly, with the sense of its own dignity. While Chester Holcombe, in The Real Chinese Question (p. 62), goes so far as to say that "during many centuries the heads of the Government, always excepting the Emperor, have commonly been the sons of poor unknown parents."

In all countries class divisions create arrogance, insolence, servility, and boorishness. In China a necessary result of the general sense of equality is good manners. Nothing is more cultivated than politeness. Even the beggar must be treated with the respect due to a perfect gentleman. And it is said that the early Christian missionaries, accustomed to the behavior of

carters in their own Western lands—where, if two met in a narrow lane, they would often fall to violent language and sometimes to blows—were astonished to see Chinamen in a similar situation bowing to each other with the utmost deference, and apologising profusely for getting in each other's way!

Again, this sense of equality and good manners is closely connected with the whole manner of life of these vast populations. There is no country in the world where a large population is spread out over the land in secure cultivation of innumerable small holdings, and in modest family independence and prosperity, to a like degree as in China. Everything in Chinese history is ancient, and at an early period the phases, first of the village commune and then of the agglomeration of lands into private hands, were passed through. The evils of the latter state of affairs were realised, and many laws and regulations were adopted for the purpose of checking the growth of large estates and of a landless class. Among these was a special tax on arable land not cultivated. doubtless with the object of discouraging indolent ownership. And the result of all these measures and movements, extending over many centuries, has been that, at the present time, not only is it most rare for any one to own or occupy more than, say, 250 acres, but there is an unwritten law of See Primitive Civilisations, vol. ii, p. 50,

public opinion which makes it discreditable to do so, or to live upon the rents of land without being actually engaged in their cultivation. The State from the very earliest times has exercised a kind of overlordship over the lands and assessed a tax upon them, which in the present day runs to about 20d. to 22d. per acre. Subject to this tax a family is perfectly secure in its tenure, or may rent out portions of its land to others—a thing not infrequently done as a matter of convenience between bona-fide cultivators, though not approved of on such a scale as would lead to mere landlordism.

The consequence of all this is that all the more productive parts of China—the plains of the great rivers and the slopes of the lower hills—present to-day a scene of extraordinary fertility and of widespread democratic industry. For hundreds of miles together the land is covered by an immense patchwork or network of small holdings—of an average size, perhaps, of five or six acres, and rarely exceeding fifty acres—running together into small hamlets or clusters of cottages, each with their school or meeting house, their wells and lift-pumps worked by buffaloes, their tanks

and irrigation channels. Here are grown crops of the most varied and valuable kind-tea-bushes planted in orderly lines and patches, groves of oranges, clumps of bamboo or sugar cane, verdant squares of young rice, pollard mulberries for the silkworms, plots of cotton and maize and wheat and vam and clover, not to mention less known things like wax trees and varnish trees. John Chinaman, as is well known, is about the best agriculturist in the world. For centuries and centuries the country has been face to face with the problem of supporting its immense population off its own lands, and though necessarily at times and places, in seasons of drought or social disturbance, the pressure of population on the means of subsistence produces frightful famines and widespread distress, vet. on the whole, the manner in which this problem is solved is the admiration of all observers. Simon gives very detailed and interesting accounts of the Chinese agricultural methods, and says it is not uncommon for a Chinaman to obtain five or six crops in a year off one plot of ground.1

Over all this land may be seen the silver threads of irrigation-canals and ditches, skirting the hills for scores and hundreds of miles—often three or four tiers of them one above another—and serpentining down to the lower slopes and plains. Irrigation for thousands of years has been one of the main public objects, and

innumerable public or private efforts and benefactions have enriched the country with its present complete system, without which of course its agriculture could not be carried on. The larger canals too form waterways for boats and traffic, and the hamlets, villages, and occasional large towns are knit together by innumerable footpaths and a few but not many highroads for wheel traffic. Of this industrial and commercial life we read:—

China is one great hive of commerce. Every part is reached from every other part. The whole business certainly is done under the most antiquated, cumbersome, and expensive methods, and with an enormous waste of time. But it is done. The inns everywhere are full of business travelers. The rivers and canals are crowded with cargo-carrying craft of every description, and bound in every direction. The roads and mountain passes are clamorous with the shouts and calls of drivers of camels, drivers of horses, mules, and donkeys, and with porters of every age and both sexes, all loaded to the extreme limit of endurance with every nameable class or description of goods, bound for a market. There are native banks of exchange in every city of size. by means of which money may be safely remitted to any part of China, however remote. And, in addition to the Government service of couriers, there are postal and express companies which transmit letters and parcels everywhere.

But the cultivation and occupation of the Land is the main thing. Every family in China desires to be rooted in the land—to have a few acres of its own, a family burial place, and a spot sacred to ancestor-worship. Though folk emi-

grate to the towns (and towns of a million population are not so rare), still, it is but for a time. The great object is to make a little money, purchase a plot, and establish oneself and descendants on the land.

Thus one great root of Chinese life is the Land. The other is the Family. And I must give a few lines to the family.

The family in China does not mean quite the same as with us. It is a term of wider import. It not only means man and wife and their children, but it often also includes married sons and their wives and children, and may also include brothers of the man and their families and descendants. It largely goes with the land. When a younger son marries he may stay on with his wife and young family in the household of his father: but as soon as he can afford it he will generally obtain a plot of land for himself and plant himself out (since his elder brother or brothers will remain on the ancestral plot). He will thus found a new family or ancestral branch. and secure a place where his own memory and presence may be kept green and sacred. Ancestor-worship lies at the back of the whole life of China and of Japan; but it is a very difficult thing for us Westerners to understand. It is not at all what we at first think-namely a pious respect paid to the virtue and character of a predecessor-or at least it is something much more, and more intimate, than that. It is a very real sense of the presence of that ancestor, and of his or her continued life within and around the living person. He (or she) is here still, though unseen, is looking out of our eves, hearing with our ears, is moving and working and influencing events in our neighborhood. Hundreds, thousands of the dead surround us. We shall in time join their company.2 All life is given a kind of sacredness through this cause.

The Chinaman sets apart a room for the worship of his forbears. If he is too poor to afford a whole room, he still sets apart one end of a room. There, on shelves, are placed the memorial tablets of his ancestors, or of deceased members of his family. On a table in front flowers are placed, and on occasions incense is burnt. Here he comes to meditate: and here. once a fortnight or once a month, is held the family conclave or meeting.

This is a weighty affair, and holds an important place not only in the life of the Family, but of the Nation. As we have said, the family group may form a numerous body. The

members gather together, dressed in holiday attire. The head of the family—who is generally of course a man, but occasionally a widowed mother or grandmother - conducts a sort of service. There is an invocation to Heaven and to the spirits of the departed ancestors: and then, turning to the table in the centre of the room, the head of the family opens the record book-in which all family events and histories have been inscribed—and reads from it the life of some one or other of the ancestors or predecessors: changing of course each time, so that in the course of two or three years the younger members of the family become quite familiar with the histories of those who have gone before them, and can surely profit by them for encouragement or warning. The history having been read, the head of the house goes on to fill up the book to date from the last meeting with the events which have happened in the interval -the births, deaths, marriages, and lesser happenings-and then the meeting resolves itself into a sort of tribunal to pass judgment, if necessary, on the actions of the various members.

This is a very important and very interesting function of the family assembly, and it has a bearing far beyond the immediate life of the family, for it in reality takes the place and does most of the work of our magistrates and police courts. In China the honor of the family is of the most sacred character, and is upheld before

all things. To strike a father or mother is punishable by death-whatever the provocation may be. And anything which tarnishes or slurs the family name is resented to the highest degree. The family therefore keeps the strictest watch upon its own members: and if at any monthly meeting there is an accusation lying against a member—perhaps preferred by some neighboring family—as of quarrel, or theft, or any misdemeanor, this is gone into with punctilious care: and the relative is either cleared or, if found guilty, punished by his own people! (the punishment may be a fine, or even blows, and, in quite extreme cases, expulsion from the family.) So careful are families in these proceedings, and so great is their sense of public honor, that it appears that in the proceedings of the public and higher courts of the land an entry in a family record book as to any matter of fact is taken as sufficient proof and evidence of that fact—the falsification of a record book being a thing almost unknown and unthought of.

According to Simon, one of the first questions asked when the meeting resolves itself into a tribunal is whether every member has duly paid his taxes! and this to us forms a very impressive testimony to their sense of civic honor. Certainly, the institution of the family meeting must produce a great impression on the children, who are thus brought up in an atmosphere alive with the consciousness of public duty and respon-

sibility. And the schools work in the same direction. Their teaching as regards anything resembling science or matters of fact is lamentably bad and absurd, and as regards literature and manners it is overloaded with petty rules and regulations: but as regards the general Confucian principles of justice and sincerity, straightforward dealing, and duty to neighbor and State, it is quite excellent, and indeed superior to our school teaching, which for the most part ignores these things. It may be in consequence of this that the standard of public honesty in China is really very high—though this fact is not always admitted by us. and a good deal of official corruption (which certainly exists) is quoted to prove the contrary. Our merchants, however, all agree that the Chinese trader is most reliable to deal with, and that his word is as good as his bond.

The family tribunal—by thus at one stroke, as it were, sweeping off the cases that come before our petty courts—disposes of a vast number of evils which fester round our police-courts and police system. Police are reduced to a minimum, and are almost non-existent in the country districts. The public courts are few in number,<sup>2</sup>

and have only the more serious cases to tieal with, often those in which the criminals concerned have been expelled from their families; and though the methods of the courts are summary and often barbaric, yet it is a query whether on the whole they are so much worse than ours.

The results of all this on the national life-of the widespread sense and practice of Equality, of the rooting of so vast a population in the Land, of its rooting in the Family, with its own indigenous tribunals, rites, and customs—is to produce a social organisation extraordinarily simple and stable, though loosely compacted, and a people more thoroughly democratic, more independent of government and self-determining, and less infested by parasitic classes, than perhaps any in the world. There is no Priestly caste in China. The only priests are Buddhist priests, who attend to the little temples scattered here and there on the wilder bits of land, among groves or rocks. And they, in accordance with their religion, are perfectly quiescent and unwilling to interfere with the life of the people. There is, for the reasons mentioned above, no Lawyer caste or profession. There is no Military caste. The profession of arms, as already hinted, fell into contempt and

neglect a thousand years past, and until the date of the late Boxer movement there was no attempt to revive it. The Manchu dynasty, since its 'settlement in Peking, 250 years ago, has had a bodyguard of some 100.000 men permanently stationed in the neighborhood, but these soldiers. if soldiers they can be called, were till 1808 or so armed with bows and arrows, and were a mere rabble incapable of discipline or concerted action. The rest of the army in China consisted a few years ago of some 400,000 militia organised by the vicerovs and governors of the different provinces, and constituting really fifteen different and independent armies, of which Chester Holcombe savs that some were passably effective. while others he has seen were armed with old matchlocks and spears, and fans imbrellas !! It is evident from this that there has been till lately no military profession. China cannot even be said, as a whole, to have an army, for though the viceroys have each their bodies of militia, these act independently of one another.<sup>2</sup> And though doubtless, as I shall presently point out, there will be a united national

army, it will probably be a very long time, if ever, before the evils of militarism and the military caste grow up in this favored land.

That a country should exist in the world absolutely free from the dominance of the Priestly, the Legal, and the Military castes seems to be too good to be true, and difficult indeed for the Western mind to believe! But when we realise also that the Landlord living on rents and the Share or Bond holder living on the interest of capital lent out to others are as to be practically negligible—that there are, in fact, no landlord or capitalist classes—our wonder must surely deepen into admiration, possibly even to envy; and we can hardly avoid asking ourselves the question whether what we have been pleased to call China's awakening may not, after all, mean the awakening of Europe!

However, do not let us go too fast. If in the socialist or semi-socialist nature of her institutions China is undoubtedly admirable, she equally certainly suffers from a defect which Socialism in Europe will have to be on its guard against, i.e. the bribery and corruption of officials. This

is the weak point of Chinese public life. The 'squeeze' is universal.

The native residents of Peking have a saying, as describing the universal peculation, that when the Imperial milk-wagon reaches the outer gate of the city the official on duty there takes out a cup of milk and puts in a cup of water. At each gate and police-station within the city passed by the wagon this process of extraction and substitution is repeated, with the result that when the fluid eventually reaches the Imperial table no trace of milk, even in color, can be detected. They are also somewhat fond of saying that the Emperor is the poorest man in all China.

This illustration of the Imperial milk-wagon apparently applies to the collection of taxes and revenue all over the country. A tax is collected by a minor official (often at considerably higher than the legal rate), and is handed over to superior officials, who in their turn deliver it to the viceroy of the province. He finally has to transfer it, or the balance of it, to the Imperial Treasury. But the 'squeezes' taken out at each and every step of the process are so considerable and so numerous that the balance is only small, and the Imperial Government remains poor.

Chinese apologists for this state of affairs say—and certainly with a good deal of truth—that the salaries allowed to officials by Government are merely nominal, and are recognised to be so. The regular salary, for instance, of a viceroy is only about £100 a year; special allowances

for this and that increase it to about £1,000,3 but of course the quite unavoidable expenses of the office far exceed the latter amount, and the public who pay the taxes are quite content that a portion of them should go to provide irregular additions to the regular allowance. So with other and lower officials. There is a good deal of give and take all through; every family has relatives among the official classes, and these relatives in turn assist the family, so that the latter has an interest on both sides of the account, and if it is plundered it also shares in the plunder l—or, to put the matter less rudely, it permits and condones the 'squeeze' as part of a system of necessary balances and adjustments.

So far the apologist; and, as we have said, with some reason. Nevertheless we must feel that the system is a bad one, with all its irregularities and temptations to peculation, and not conducive to public morality. Especially in the towns and larger centres is this the case. In the country, probably, where everything has to be done more openly and publicly, the evils may be less.

What we have said about the smallness of the revenue flowing in to the Central Government and its small payments to officials—the "poverty of the Emperor" in fact—is important; and there is no understanding of China without it. The Central Government is essentially feeble. It has little money; it has no army; it has next to

no police. What can it do? The people go their own way. The taxes run to about 2s. 6d. per head of the population. Even if that were all spent (say £50,000,000) on public purposes. it would be a small amount for a nation of 400,000,000 population.<sup>2</sup> (What does our United Kingdom. with a tenth of the population, spend?) The Central Government is weak, and has no power to coerce the people or compel them into forms which they do not like. They go their own way, rooted in the land and in the family, and in their own customs 3 Even the local mandarins and officials-though sometimes doubtless they abuse their powers—are not by any means independent of the people. Simon describes a case in which a new mandarin

having been appointed, who was disliked by the people, the people simply refused to have him, and, politely but firmly turning his sedan-chair round, sent him back to the place whence he came. And other instances of the same kind are quoted. There is complete liberty of meeting and of the Press 2—rights which are by no means always accorded in Western countries—and, as a matter of fact, discussion and the formation of public opinion are constantly going on even in the smallest hamlets.

It is Western ignorance as to the real relationship between the Central Government and the people of China which is constantly leading even our diplomatists (who ought to know better) into all sorts of blunders. We make a treaty with the Government at Peking (generally under threats of force), and the Chinese Minister of course smilingly defers and procrastinates, and finally yields and signs the treaty. Yet he knows all the time that it is waste paper. What power

has he, or the Government, or the Emperor, to enforce the observation of the treaty by his own people? None at all. It may be a treaty to open up certain districts to our commercial agents. or for the remission of certain likin dues on foreign goods sent into the interior. Who can compel the people of that district to receive the hated foreigner, or who knows whether the local mandarins will remit those likin dues or not? The Government can only send an order to the vicerov of each province; the vicerov will use his own discretion: he may pass the order on to the mandarins beneath him, or he may not. If he does they also will use their discretion: finally the mandarins may bully the people, but the people, when all is said, will take their own ways, and on them will largely depend the final issue. China, in fact, is like an organism of the jelly-fish type, not very highly sensitive, not having any very marked and ruling centre to which everything is referred; but for that very reason perhaps the more stable and persistent because its vitality is distributed throughout the whole mass.2

But the most interesting-and indeed astonish-

ing—feature in the constitution of China is the Han-Lin Academy and the influence it exercises. In that country, where the military profession is held in contempt and the merchant class accounted lowest in public rank. literature has for centuries been held in the highest honor. Thousands of candidates press to Peking and other cities every year for the examinations. To take the degrees, to become a member of the privileged and literary class, respected everywhere, and so to have a chance of gaining official position, is the aim of millions. The poorest families will make heroic sacrifices to enable one of their members to become a scholar. It is said that there must be some 700,000 Chinese graduates now living. So widespread indeed is the interest in literature that it is quite common to find holiday-folk (as is seen also in Japan) spending their afternoon in the country capping verses or writing odes in amicable rivalry.

The Han-lin College or Academy was founded in A.D. 740,<sup>2</sup> or nearly 1,200 years ago, by an Emperor of the Han dynasty, as a sort of advisory body. It now consists of some 240 members, each of whom is granted by the State a house

and garden and a modest pecuniary allowance. But it has these privileges as an immemorial right, and is in no way dependent on the Government; on the contrary, it has the right, and it is part of its duty, to criticise the latter, and even the Emperor himself. The College elects itself—that is, when a vacancy occurs it elects the new member, and of course always from those who are already most distinguished as scholars. Thus, like our Fellows' bodies and learned societies in the West, it keeps up its own traditions. Its duties are (1) discussion, (2) dissemination of its conclusions throughout the nation, and (3) censorship of individuals (officials).

It discusses anything: any question which affects the welfare of the people. This may be a foreign treaty, or it may be a new method in education, or it may be some small detail in agriculture. But the College has no legislative or executive power. It can neither pass a law nor issue a command of any kind. All it can do is, when it has arrived at a conclusion, to issue a leaflet or pamphlet on the subject. This may be a leaflet recommending some method of dealing with an insect pest in the gardens, it may be a pamphlet protesting against a foreign treaty, or it may (as happened lately) be one urging the adoption of Western science in the schools. Whatever it is, the circular has an enormous publicity; it goes by millions of copies through the land, and is read and debated in

every little hamlet. And if the recommendations suggested meet with a wide and warm public approval it not infrequently happens that the Government takes them up, and they pass into the laws or institutions of the country. Very little, I believe, ever passes into the public law in China without this previous circulation and approving discussion—for the simple reason that without this there would be no security that the people would conform to it.

#### TT

I have dwelt thus long upon the conditions of life in China without coming to the gist of my paper, namely the results which may be expected from the contact of that life with Western civilisation—because, in fact, without a fair understanding of the former it is impossible to estimate the latter.

The first awakening of China to the growth of what we call the modern Western world undoubtedly occurred in 1839-40, when the guns of British frigates at Canton boomed out our demand for the admission of opium into that port. Into the details of that oft-told tale, so dishonoring to Britain, it is not necessary for us to go. China for centuries had taken her own way in complete ignorance and indeed oblivion of the outer world. Now suddenly the whole proceedings opened her eyes to two great facts:

(1) The existence of nations there in the "West" possessed of demonic powers and hellish engines of destruction: (2) their apparently entire unscrupulousness in the use of these powers in the service of gain and trading profit. Considering that the trader, as we have already pointed out, ranks as the lowest class in the Chinese polity. and that trade (as apart from industrial production) has always been looked upon as beneath the notice of the ruling classes and officials—that it is, in fact, almost impossible to get them to take any interest in it-one can begin to understand the strange and sinister impression produced. Naturally it was many years before the new tidings about the "barbarians" and "foreign devils" penetrated the whole mass of the nation. But unfortunately succeeding events did nothing to remove the first impression, only confirmed it. Envoys from Britain, France, and the United States pressed for right of residence in China. always in the name of Trade, and backed their demands always by Force. China persistently refused their admittance, but in 1860 a combined force of English and French destroyed the Taku forts, captured Tientsin, and the Peking Legations were established. Other events of the same character followed, and with the same result. The Chinese, overwhelmed by force, had to give

way. Always the Western war vessels grew larger and more threatening, always their cannon more terrible and destructive. Till in 1894-5 came the Japan and China war, and, with the defeat of China, loud and open talk among the Western Powers of her dismemberment.

It was only then, just at the close of the last century, and after some fifty or sixty years of rude awakening cuffs and blows, that China en masse began to rouse herself to meet the situation. Her haughty and ignorant contempt of the Western peoples as mere hordes of savages 1 was giving way to astonishment at their mechanical and scientific powers, if also with added hatred of them because of their powers. Japan had already tackled the problem, had educated and armed herself, but China lay helpless and incapable. What was to be done? A huge popular movement-the 'Boxer' movement-ignorant and superstitious, but full of enthusiasm and determination to oust the foreigner, began to grow up. And the Han-Lin Academy came in to make appeal to the more thoughtful part of the nation.

The action of the Academy in this matter is full of interest and suggestion, and I must dwell on it for a moment. As a rule it would appear that the Academy is a somewhat conservative

body, bound up, no doubt, to a great extent with the old national ideals and the Confucian tradition: but, having debated this matter of the foreigner, it seems that a majority was in favor of issuing an appeal to the country—a call to arms, in fact, and a call to Western science and education. The writing of this appeal was committed to Chang Chih Tung, China's "greatest viceroy," and the pamphlet, presented by the Academy and endorsed by the Emperor, was duly printed and circulated. It has probably by now circulated by millions of copies. China's only hope, the author explains, consists strengthening of her army and military power by the adoption of modern methods and implements of war: in the improvement of her schools by the introduction of science and Western teaching; and in getting into touch with Western ideas by means of travel, translation of books. etc. At the same time the solid and world-old bases of Chinese life and citizenship, the laws of Confucius, and the worship of the ancestors, must by no means be deserted, for it is only on these that a secure edifice can be erected.

The following are some quotations from the book. Speaking of education in the schools, the author says (page 100):—

The old and new must both be taught; by the old is meant the Four Books, the Five Classics, history, government, and geography of China; by the new, Western government, science, and history. Both are imperative, but we repeat that the old is to form the basis, and the new is for practical purposes. Under the head of Western Government come the comparative study of governments and science, colleges, geography, political economy, customs, taxes, military regulations, laws, and expositions. Under Western science are classed mathematics, mining, therapeutics, sound, light, chemistry, and electricity.

Among other suggestions for providing money for these improved schools, he says —

Convert the temples and monasteries of the Buddhists and Taoists into schools. To-day these exist in myriads. Every important city has more than a hundred. Temple lands and incomes are in most cases attached to them. If all these are appropriated to educational purposes we guarantee plenty of money and means to carry out the plan (p. 99).

We must put the useful books of the West into Chinese, and scatter them far and wide among those who are ignorant of Western languages, among the wide-awake officials, the impecunious *literati*, the scholars replete with Confucian lore, the merchants, workmen, the old and the young, to be used and appropriated by them in their different spheres (p. 113).

Travel must not be neglected.

The diminutive country of Japan has suddenly sprung into prominence. Ito, Yamagata, Yanomoto, Mitsui, and others

visited foreign countries twenty years ago, and learned a method by which to escape the coercion of Europe. Under their leadership more than one hundred Japanese students were sent to Germany, France, and England to learn foreign systems of conducting government, commerce, war, etc. After these had completed their course they were recalled and employed by the Japanese Government as generals and Ministers. When the Government was once changed they developed into the Heroes of the Orient (p. 92).

And he goes on to urge the sending of Chinese students to Japan and the West, for a similar purpose. Railways must also be constructed.

Let us build railways, and then the scholars can have easy communication with distant friends, the farmer can utilise much that is now waste, the merchant can readily meet the demand for supply, forwarding the heaviest material, the workmen will soon find machinery everywhere, the abundant products of the mines will be beneficially distributed, and our China coast will be securely protected and guarded by myriads of efficient troops. . . . The whole country will become really ours, and China will be one great united family, with no fear of famine or war (p. 126).

As to the nations of Europe, there is no trust to be placed in their promises; they are

like tigers with dripping jaws (p. 81). They talk of peace and mean war. Austria first instituted the Disarmament Society. Immediately afterwards the war between Russia and Turkey broke out. Then Germany attacked Africa, England attacked Egypt and Thibet, France conquered Madagascar, and Spain Cuba. . . . Germany has seized upon our Kiaochou, and Russia has appropriated our Port Arthur. . . . If we talk of disarmament to the other countries without the force to back up our words we will become the laughing-stock of the world. . . . Drilling troops is better than disbanding them. With fifty warships on the sea and thirty myriads of troops on land

with daily additions to both ships and troops, with the daily strengthening of our forts and equipping them with the best engines of modern warfare, and with the railways intersecting the land, what country would dare to begin hostilities with China or in any way infringe upon her treaty rights? Under these conditions Japan will side with China, Europe will retire, and the Far East will be at rest (p. 140).

Finally, comparing China with the West, he says:—

- Although China is not so wealthy and powerful as the West, her people of whatever condition—rich or poor, high or low—all enjoy a perfect freedom and a happy life. Not so all the inhabitants of Western lands. Their Governments may be strong; but the lower classes of the people are miserable, unhappy, and maliciously wronged. Their liberties are restrained, and there is no redress. They rise in rebellion on every opportunity, and not a year passes without an account of the murder of some King or the stabbing of some Minister. These Governments certainly cannot be compared with our China (p. 41).

I have given these copious extracts from the book because I think they are surely very interesting—not only as giving the words of a great Chinese statesman, but as representing the views of, at any rate, a large section of the Han-Lin Academy, and a résumé of the program which is now, one may say without exaggeration, being discussed by peasant and prince alike all over the vast demesne of Chinese territory.

This program is in fact—though of course there are dissentients to it—being rapidly carried out. We know what Japan has done; but China is far older and more experienced than Japan.

If on the one hand she is more warv and slow to move, she is, on the other, equally capable, and, when she moves, inclined to move more permanently and more irresistibly than the younger nation. The Boxer uprising was, and is, largely the instinctive solution of the problem by the popular masses. It put power into the hands of the Empress Dowager for her coup d'état, and she and her party in turn supported and reinforced it. It led to the attacks on the Peking Legations in 1900. It meant, and means, "Out with the foreigner" and "China for the Chinese." And the movement has come to stay. Sir Robert Hart, who probably knew China as well as any living Englishman, said: "In fifty vears' time there will be millions of Boxers in serried ranks and war's panoply at the call of the Chinese Government: there is not the slightest doubt of that." 2 Nor can we for a moment doubt that the Chinese, though averse to change, have just as great technical ability as the Japanese, and if they once come to realise the need of its application in modern arts of war or peace will excel, just as the Japanese have done. The telegraph and telephone, at their first appearance, were resisted to the utmost: but now already their wires reach like a web all over the Flowery Land. The people are like

that—tenacious of old custom, yet once in motion exceedingly quick to take up a new position. And Sir Robert Hart warmly endorses the words of Wên Hsiang, the Prime Minister of China in the early sixties, who said:—

You are all too anxious to awake us and start us on a new road, and you will do it; but you will all regret it, for, once awake and started, we shall go fast and far—farther than you think—much farther than you want!

To this movement of China against the foreigner and towards her own independence the victory of Japan over Russia gave something like a seal of security. The autonomy of the Far East is now established, and China has only to follow the lead of Japan in cultivation of the arts of war, and the two in combination may set the world at defiance. Already for some years Chinese emissaries and inspectors have been keeping their eyes open in our big steel workshops. Indeed as far back as 1872 the Viceroy Li Hung Chang sent 120 Chinese boys of good family to be educated in the United States, with a view to studying military and naval methods there. Now there are some thousands of young Chinese studying military science either in China or Japan. There are nineteen modern military academies in China, three arsenals turning out rifles and quick-firing guns, and more in process of forma-

tion. Very soon, says Putnam Weale, they will have a thoroughly effective army of some 400,000 men, all trained on the Japanese system. Needless to say the European Powers and the United States have learned a lesson, and all talk of dismemberment has ceased.

We may take it, I think, as good as certain that China will rehabilitate her military power, and that (even though there may be attempts against her) there will be no dismemberment. There remain other questions. What about the "Yellow Peril" of invasion?—400,000,000 of Chinese let loose upon the world! What about the awakening of China to trade and commercial life, and the result upon our trades? What about the infiltration of Chinese ideas and social standards among the Western peoples?

I. I think that whoever has followed the general outline of Chinese life and character will find it very difficult to imagine this people deliberately making an armed invasion of other countries. The whole tenor of their temperament and institutions is "Let alone!" "Don't meddle!" They have no dogmatic religion (a frequent cause of wars) to carry at the point of the sword into other countries. They have no strong central government (another frequent cause) ready to serve private ends by the wholesale sacrifice of

its own subjects. Their ancestral worship precludes them from forming permanent homes in other lands. In all the long history of the Chinese Empire there is. I believe, hardly a single instance of their invading, in a military sense, another country.1 The habits of the people are agricultural and social-not military: the Government, as I have said, is weak and diffused, and though the latter may, in the face of foreign menaces, pull itself together (and is doing so) sufficiently to present a good front against invasion, it seems very improbable that it will ever concentrate to the much greater degree necessary for the invasion of other lands. On the other hand, the eternal problem of Chinese life—namely the sustenance of so enormous a population on an area of land which, though large, is limited-may one day reach a point of acuteness compelling some kind of irruption beyond their borders. In that case—though it be rash to prophesy-I should think a huge (but peaceful) migration is the most likely thing to happen. And if the infiltration of Western ideas were to go so far (which does not at present seem probable) as to break up the Chinaman's conception of the sanctity of home, and to deaden his urgent desire for burial in ancestral ground -then indeed such migrations might assume proportions quite alarming, and even threatening to

the stability of our own civilisations. However, I think we may put migrations of this magnitude off to a rather remote period, and say for the present that while there is going to be no dismemberment of China by the Western or other Powers, there is, on the other hand, going to be no "Yellow Peril" in the shape of armed invasions of these lands by China.

- 2. The question of the commercial relations of the New China with Europe and the West is a very interesting one, I think myself that,

Our physical machinery requires a fuel too costly to pay for the running of it in a perfectly conceivable future period of race-competition and pressure of population,"

though there is a large party in China in favor of the "ring-fence" policy, the "open-door" party, supported by Chang Chih Tung, and reinforced by the general tendency of trade development, etc., will almost inevitably gain ground. The more obvious advantages of this policy, the influx of cheap goods, etc., will appeal after a time to the masses of the people; and once the nation, by the establishment of its military strength, has come to feel itself secure, it may possibly be considerably more disposed to admit the trader and the commercial traveler than it has hitherto been. Having mounted its guns, it will not be so afraid of opening the door.

If we suppose the door opened, and (what is already part accomplished) a network of railways giving access to the interior of China, then—for good or evil, and let us hope, for good—a big trade with the Western nations must inevitably spring up. There will, for many years and until the people can manufacture these things for themselves, be a great demand for our steel rails, girders, edge tools, machines, etc., as well as for some classes of our textile fabrics; <sup>1</sup> and we in return shall be buying Chinese silks, tea, porcelain, spices, etc., more freely. Both parties will no doubt so far be benefited. Then a time will come when, for good or evil, our manufactures and methods of manufacture, our factory

system in short, will make headway in China—when they will produce steel rails, big guns, and calico sheeting for themselves; and their workers, as wage-workers, will begin to be crowded by thousands in huge workshops to the sound of machinery.

What will happen then? It is hard to sav. Already in Japan, in a few short years, the introduction of Western commercialism has brought with it problems unknown before-dire increase of poverty, multiplication of unemployed.2 What will it do in China? There already the supply of labor is so great that the land is like a cup full to the very brim. Introduce labor-saving machinery, and instantly it will overflow. Millions will be thrown out of work. Terrible commotion and uproar will ensue. Will China plod through all this, through a long period of bloodshed and confusion, to land herself at last only where the Western nations have landed themselves, in the production of a futile society composed of two great classes antagonistic to each other, and both

unsatisfactory—one living idly on dividends and the other in a state of monotonous and squalid slavery? It is hardly thinkable. Or will her genius, already so deeply Socialistic, seize on and transform this factory system into a free organisation of guilds, self-dependent and autonomous, sweated by no masters, and ready to use the surplus productiveness of machinery for the shortening of the hours of labor and the absorption of unemployed into the working ranks? We cannot tell. The world can only at present wait, in profound suspense and interest, to see what solution will be given.

That a considerable and important movement in China is imminent seems at least very probable; and this may lead, at any rate for a time, to a great influx of Chinese into Western countries, and to some amount of dislocation of Western trade. With regard to the latter, the production on a large scale of factory-made goods in China and at a very low cost has been held up by not a few writers 2 as heralding a period of great disaster to the Western nations; but we think this view is based on a misconception.

The entry of China into the world-market, with cheap goods in her hands, would undoubtedly alter the currents of Western trade, causing some items to increase and others to diminish in magnitude. An offer from her, for instance, of good and inexpensive cotton cloths to the world would strike a heavy blow at Lancashire. But -since exports always demand imports in returnif China came into the world-market as a seller. she would also come to the same extent as a buyer. The total volume of Western trade would not be diminished, rather increased. Even if Britain lost in one branch of her trade she would probably be the gainer in another. The new arrival would mean & temporary dislocation of Western trade, but it would by no means spell disaster.

There are some also who think that with the development of self-supply through machine and factory production, combined with her own enormous natural internal resources, China will be tempted to abate and ultimately to drop her trade with the West, and to retire once more within her ring-fence. But again—though prophecy is rash—I do not think such a retirement is likely. There is much current misunderstanding of the laws of foreign trade, and the subject is a difficult one, without doubt; but this much is certain, that—granted Free Trade and no artificial walls of Protection around a country—that country, even though capable of producing everything it needs

within its own borders, will still prefer to exchange some of its products with other countries: and that the more flourishing it is within its own borders the more active probably will its outer exchange be.

It is often thought that if the cost of production of a certain article is higher, say, in Britain than in some other country, there is no chance of that article being demanded from Britain by the said country. But J. S. Mill has conclusively proved that this is not so (Principles of Political Economy, Book III, ch. xvii). To use his classic example, if the cost of production of both cloth and corn is greater in Britain than in Poland. it may still happen that British cloth will flow steadily to Poland, and Polish corn flow steadily to Britain, simply because cloth is cheaper relatively to corn in Britain, and corn cheaper relatively to cloth in Poland.1

If China, conscious of her own strength, should cast off her prejudice against mercantile relations with the outer world, there is little doubt that she will always find advantage to herself in such relations-both buying and selling. And if the Western nations desire to make her their customer, it seems to me that there is probably

no better way to do so than to acknowledge her autonomy, give her every pledge of security, and favor in all ways her internal prosperity—and so leave the natural laws of trade and exchange to work themselves out. Lord Salisbury, in a moment of inspiration, once said:—

If I am asked what our policy in China is, my answer is very simple. It is to maintain the Chinese Empire, to prevent it from falling into ruins, to invite it into paths of reform, and to give it every assistance which we are able to give it to perfect its defence or to increase its commercial prosperity.

And surely a wise and generous national policy in the future will recognise this great principle in all foreign trade, that the prosperity of the peoples we deal with also spells our own prosperity.

3. We now come to the third and final question, namely the effect of China's awakening in the way of the interchange of ideas between her and the West. This contact between West and East is one of the most remarkable characteristics of the present age, and one surely fraught with great and important issues for the future. On all sides we see both Eastern and Western peoples being modified by it. The commercial system is breaking down caste in India. The interest in modern science there is growing. Huxley and Darwin seem for the moment to

be taking the place of the Vedic sages. On the other hand, in Europe our philosophy is being profoundly altered by Eastern thought, and among the peoples at home doctrines of Karma and Reincarnation are being widely (and even wildly) circulated. Japan has adopted battleships, tall chimneys, and chimney-pot hats; and we are making a pious cult of Japanese art and Japanese simplicity of life. How far is this going to go? Are Asia and Europe going to blend in a uniform color of civilisation, all alike for the whole globe? and is humanity entering on a last stage of universal Esperanto and Equality? To suppose this would. I think, be a little too previous. While it is perfectly true that India and Japan are being greatly modified by contact with the West, and that the Western nations are being largely colored by Eastern thought and custom-and greatly to the benefit of both—it is also true that. looking deeper, there is no sign of a radical change of base. India. in view of mercialism, may sweep away many absurdities of her present caste system, but there is no sign that she will abandon its great main outlines. which she has preserved inviolate for thirty. centuries. Something the same with her religious philosophy. She will correct that to the data of modern science, but she will not desert it. And so with Japan. While it was thought a little time ago that Japan was becoming completely transmogrified in her blind devotion to Western

ways and manners, it has now become clear that her full and conscious intention is in a very different direction—namely, merely to adapt and make use of these Western things for the better protection and ultimate expression of her own ideals. She is returning to her own base again instead of going farther from it. As Lafcadio Hearn says (Out of the East, ch. vii, "Jiujutsu"):—

Despite her railroad and steamship lines, her telegraphs and telephones, her postal service and her express companies, her steel artillery and magazine rifles, her universities and technical schools, she remains just as Oriental to-day as she was a thousand years ago. She has been able to remain herself, and to profit to the utmost possible limit by the strength of the enemy. She has been, and still is, defending herself by the most admirable system of intellectual defence ever heard of—by a marvelous national jujutsu.

We may apply these remarks to China. The vast probabilities are that China, adopting like Japan a great deal of Western civilisation and thought, will still not move perceptibly from her ancient base of 4,000 years. And when we consider how excellent that base is—fixed deep in the Land, in the Family, in the great moral principles of good Citizenship, and in a Religion spiritual yet void of all dogma—there seems indeed no reason why she should leave it. That the challenge and intrusion of the Western world will benefit China one can hardly doubt. Wrapped and isolated in her own life for

centuries, she has certainly lapsed into much feebleness, ignorance, and mere stupid routine; but the sleeper is very far from dead or disabled. Awaking from her dreams she may any day now astonish the world by activities as remarkable as those of Japan, though probably along a different line; and she may, with her long past of experience, leap to the solution of social problems which are almost the despair of the West.

In the West itself the growing knowledge of China, and familiarity with her institutions. hitherto so little understood, will surely have a profound influence—a greater influence than that exercised by Japan. About the Japanese civilisation there is a certain lightness of touch. almost a thinness: but China is massive and solid to a degree. When it comes to be recognised what are the causes of China's immense duration down the centuries—the democratic simplicity of her institutions, her affection for the land and determination that every one shall have a share in it, her freedom from parasite classes, and her recognition of the farmer and the artisan as superior to the merchant in importance; the respect, too, paid to letters, to the clan and to the family, the easy handling of domestic, social, and legal matters through these powers, the little power of central government, the genius of the people for the formation of free guilds and societies, and so on-it is not

difficult to see that the European peoples will be inclined to rub their eyes and take many a hint from those they have hitherto despised. Again it is rash to prophesy—but it may be that the fact of the Awakening of the East coming now, at a time when Europe '(as we hope) is growing out of her commercial régime into nobler ideals, may make a rapprochement between East and West all the easier. It has been the fatal and vulgar commercialism of the Westerners which has for long been the greatest harrier between us and the East "The entire Western atmosphere," says Chester Holbrook, "is intensely repugnant to the Chinese. They have never understood nor admitted that the main purpose for which governments were created was to foster commerce and money-making. From their view-point that is the petty business of petty men." When this obstacle on our side is partly removed there will be the less temptation to China to retire behind her own walls. The peaceful infiltration, too, of Chinese folk into Western lands -which, apart from any more serious movement, will surely go on-and of Chinese of better class (not as hitherto the mere riff-raff and family butcasts), will lead in the same direction and to a better understanding; and may contribute to that great change which one day perhaps will be called the Awakening of the West.

# THE UNEMPLOYED RICH AND THE UN-

(See ch. ii, p. 9.)

A MOMENT'S thought shows that as machinery perfects and perfects itself there is a tendency for fewer workers to produce more goods or wealth. The balance of increased wealth goes to the profit-receiving classes: and so there is a double result, namely, the increase of the wealthy unemployed, and the increase of the unemployed workers. The increase of these two classes may not go on simultaneously, and there may and must be fluctuations on both sides; but the general tendency is clear. It might, of course, be counteracted by shorter hours of labor and increased wage, which by bringing a greater number of workers in under better conditions would immensely improve their lot, and at the same time by reducing profits would clean up and improve the lives of the wealthy: but as the entire tendency of the present system is the other way (in order to keep up profits), this double shrinkage of employment must go on—as long, in fact, as the system goes on, and until the whole attitude of the nation towards these questions changes.

#### THE MINIMUM WAGE

A Paper read at the Conference on Sweated Industries, at Glasgow, October 12, 1907.

THE subject of the Minimum Wage has been very widely considered in various aspects and from various points of view; and I do not propose now to go into the general question. There is evidently a growing public opinion in favor of the constitution of Wages Boards and the establishment of some kind of legal minimum; and doubtless something will be done in that direction. There will be difficulties, of course, in drafting regulations, and there will be drawbacks to their operation, but these are things we must expect in any such case. I am now only desirous to establish a point which has, I think, not been sufficiently insisted on; and which will, I hope, remove one class of prejudice against, or objection to, the proposal.

It is generally tacitly assumed that a legal Minimum, by raising wages in low classes of labor, will handicap the employer, make the realising of a profit more difficult, and generally place a strain upon him, which latter, of course, he may overcome, but which will nevertheless remain a strain. I want to point out that in many respects this is the reverse of what will happen. And I believe that quite a few employers are beginning to realise that this is so, and therefore

are favorable to a legal enactment—though no doubt the majority still are opposed to it.

The case in reality is very simple. Every one knows that the employer to-day has a most anxious time. The dread of competition, the continual fluctuations of prices, the fear of being undersold in the market. haunt him. He has no certain foundation for his business. He is like a man standing or working on boggy ground, with no firm footing anywhere. At any moment a competitor may undersell him; and one of the commonest causes of such underselling is the employment of cheap labor. Here are three manufacturers, say, in some particular branch of industry, all fairly equal with one another, and all going along fairly well. Then, all at once, a fourth comes in, with sweated labor, undersells the others. and breaks up the trade. Painful fluctuations and disturbances set in, prices come down, ruinous alike to employers and employed; and ultimately perhaps the former, even against their own wish, are forced to adopt the wage-cutting devices of their new competitor.

Now we must contend that to rule out or prevent this operation by fixing a minimum below which the wage shall not go, is a benefit, not only to the employed, but to the employers themselves. It gives them at last some firm ground beneath their feet. It takes away one large cause of doubt and risk and uncertainty; and simplifies greatly for them the problem which they are handling.

Imagine ten or twelve men—a sight you may often see in large ironworks—standing round in a circle and holding a heavy iron plate, which they have to handle and perhaps pass on to some machine; and imagine the ground on which those men stand to be partly big boulders and partly mud. You will appreciate

at once the dangers and difficulty of their work. At one moment the plate will be tilted in this direction. throwing an unbearable weight on one man: at another moment it will be tilted in that. No man will have certain footing or be able to use his strength properly. Now suppose them all to step up 6 inches onto a solid and level stone pavement. It may be a slight exertion to get there, but once there, the whole conditions will be different. The work will be carried on with a certainty, an ease, and an economy of labor, out of all comparison with what existed before. Somewhat corresponding will be the advantages to employers when by the fixation of a minimum wage the financial ground beneath their feet shall have been made comparatively solid, and the conditions so far equal for all.

Trade Unions, of course, have already done something of the kind in the higher grades of industry; and I believe that many employers are quite ready to admit that their action has been helpful. The Unions have, in fact, secured their trades to some degree against ruinous fluctuations. It is only necessary to imagine for a moment the effect of the total disappearance of the Unions—say in the Lancashire Cotton trade—to realise that such a disappearance would mean widespread confusion—the pushing in of new competitors with cheap or sweated labor, the bankruptcy of old employers, and endless disturbance and chaos in a great industry.

The truth is that, within limits, it does not matter to an Employer if wages are high, provided all other employers have to pay equally high. It may matter to the *Public*, of course (who may have to pay a higher price for the article), but not to the Employer. We come, therefore, now to the question of the interest of the Public.

That the absence of a Minimum Wage (whether that minimum be obtained by Trade Unions or by Wages Boards) may mean a cheapening of price to the public. must of course be admitted. But, at this time of day, I think no one will say that that in itself constitutes a sufficient reason. We all feel that any such gain to the Public might be very ill secured by the degradation and misery of a large body of workers. And in the case of the so-called Sweated Industries—with which we are specially dealing—there are reasons for supposing that the enhancement in price (due to the minimum regulation) would be almost imperceptible. In these industries wages often bear such a very small ratio to cost of materials, profits, salaries of superintendence, etc., that a rise of wages need make but little difference in the price of the article.

Take the case of shirts that are "made" at from 8d. to 1s. a dozen—say, one shirt made for 1d. shirt is sold for 2s. Doubtless in some cases for more. Suppose the woman's wage doubled, so that she will get 2d. instead of 1d. Her week's wage will in consequence rise from, say, 7s. to 14s.—which latter, though a poor enough wage, will be positive affluence to her. The price of the shirt, other things remaining the same, will rise 1d. The shirt, therefore, would cost 2s. Id. instead of 2s. Can we suppose that it would be hard on the public to ask them to pay 2s. Id. for the shirt, in order that a whole class of miserable workers should be redeemed to better conditions? or can we suppose that the demand for shirts would be diminished by this extra charge? The more probable result of it all, of course, would be that the 2s.

The term "making" does not include cutting out, sewing on buttons, and making buttonholes, but it includes practically everything else.

price would remain as before, and that the employer would accept a slightly reduced profit.

Nor must we forget a thing which is constantly being overlooked when these questions of better wages are being discussed, namely, that markets, instead of being ruined by better wages, are greatly stimulated thereby—for to-day Political Economy is beginning to see, much more clearly than of old, that markets and trade rest on the well-being of the mass of the peoples—that is, on the mass-wages. Whatever, therefore, cripples wages and the welfare of the masses necessarily cripples trade and the markets. Into such a general question of Political Economy, however—interesting as it might be to discuss—we must not go now.

I would say a word on the difficult subject of Foreign Trade—because it almost necessarily links up with the question we have in hand.

My argument has run upon the assumption that a Minimum Wage, though it might raise the cost of production of an article to some degree, need in nowise handicap an employer, because it would apply to all employers alike. And this argument I consider perfectly just, as long as it is applied, say, within the limits of the United Kingdom. But we have to consider besides (what is undoubtedly a fact) that trade runs nowadays on such small margins that a slight enhancement of the cost of production may—I do not say necessarily will, but may—drive an industry abroad.

There are two points I should like to bring forward in this connexion: (1) That the difficulty will have to be met, and is being met, by the extension of the principle of the Minimum Wage to other countries; (2) that in general, the bogey of Foreign Competition—though not without a certain basis of reality—has

been made far too much of, and has become a cause of alarm far greater than there is any reason for.

With regard to (1), we know that Australia and New Zealand have for some time had Wages Boards and Arbitration Courts in operation (Sir C. Dilke's Bill was founded on the Victorian Wages Boards), while America has had a system of licensing home-work-rooms. Germany, our chief rival in the sweated trades, is strong against Sweating, and an Imperial Commission is considering now the question of steps to be taken. So that these facts should rather encourage us in the direction we are going, and towards the establishment of an International Agreement on the subject.

With regard to (2), namely, Foreign Trade, there is no doubt a great deal of nonsense talked on the subject. I fear folk nowadays do not read their John Stuart Mill as they ought to! Of course, it would be absurd to deny that sometimes a rise in the cost of production at home may cause a foreign demand to cease; but this is by no means always the case, and (paradoxical as it may sound) it may often happen that a foreign country may demand from us an article which it is actually producing all the time at less cost than we are at home.

Trade, in fact, does not follow absolute cheapness, but relative cheapness. It may happen that a thing (a razor, say) is produced cheaper in Germany than here, and yet the Germans may continue buying it from us because relatively to some article the Germans export to us that razor is cheaper here than in Germany. Germany sends butter to Britain because, relatively to certain other things, it is of more value here than in Germany. A keg of butter, say, will buy twenty razors here, but only fifteen of the same class in Germany. It will pay a German merchant, therefore,

to send butter to England, and take our razors in exchange—and a steady interchange of butter and razors will go on—even though the cost of razors in both countries is the same, say is, each. That is, we shall export razors to Germany, even though they are produced equally cheaply there as here. Now, suppose the cost of razors in Britain to rise a little. so as to be actually greater than in Germany—say. only nineteen can be obtained for a keg of butter instead of twenty. Still the exchange will go on. because there will still be a gain of four razors on each keg. (I am, of course, not mentioning costs of transit, etc., because those things, though they will alter the figures, will not alter the general principle.) In this case, then, we shall actually be exporting a certain class of razors to Germany, although their cost of production here is greater that in Germany!

I dwell on this case merely in order to show how paradoxical is the subject of Foreign Trade, and what a mistake it is to be led away by cheap arguments which are really of a very superficial and delusive character.

You will find a careful exposition of the above subject in J. S. Mill's *Principles of Political Economy*, Book III, ch. xvii, § 2, from which I may as well give some extracts. Quoting his father, Mr. James Mill, he says: "If the cloth produced with 100 days' labor in Poland was produced with 150 days' labor in England, while the corn produced in Poland with 100 days' labor could not be produced in England with less than 200 days' labor;—then an adequate motive to exchange would immediately arise. With a quantity of cloth which England produced with 150 days' labor, she would be able to purchase as much corn in Poland as was there produced with 100 days' labor; but the quantity which was there produced with

100 days' labor would be as great as the quantity produced in England with 200 days' labor."

Then he continues: "By importing corn, therefore, from Poland, and paying for it with cloth, England would obtain for 150 days' labor what would otherwise cost 200, being a saving of 50 days' labor on each repetition of the transaction, and not merely a saving to England, but a saving absolutely; for it is not obtained at the expense of Poland, who, with corn that costs her 100 days' labor, has purchased cloth which, if produced at home, would have cost her the same. Poland, therefore, on this supposition, loses nothing: but also she derives no advantage from the trade, the imported cloth costing her as much as if it were made at home. To enable Poland to gain anything by the interchange, something must be abated from the gain of England—the corn produced in Poland by 100 days' labor must be able to purchase from England more cloth than Poland could produce by that amount of labor; more, therefore, than England could produce by 150 days' labor, England thus obtaining the corn which would have cost her 200 days' at a cost exceeding 150, though short of 200. England, therefore, no longer gains the whole of the labor which is saved to the two jointly by trading with one another."

I would say in conclusion that though I am in favour of the institution of Wages Boards, etc., I think all this legislation which is being proposed with regard to Sweating, etc., is a very detestable thing. The evils of legislation generally are very obvious: Interference, Inspection, Expense, Officialism; and it is only because they are a cure for worse evils that we must endure them for a time. We have got our social system and social habits into such an inhuman state that I suppose we shall have to go through a painful period

of social drill and discipline and interference with individual liberty before better and more human ways of treating each other will become natural to us.

When Lafcadio Hearn—that greatest of writers on the subject of Japan—first visited that country he was struck, as most travelers are, by the extraordinary atmosphere of consideration, kindness, and civility to each other which existed there, by the general devotion to the common good, by the absence of poverty, and so forth. In his latest book (Japan: An Interpretation) he traces this state of affairs, which now appears spontaneous and natural, to the fact that in past centuries the people went through a period of considerable discipline in these directions, which, in fact, ingrained these habits into their lives.

Let us hope that the period through which we are now passing is one in which the Western nations are waking up to the enforcement of a more human morality in matters of Wealth and Industry than has existed heretofore; and that it will result in a period in which such laws will not be necessary—because it will have become natural and instinctive for the employer to do his best for the employed, and because folk will have ceased to care for Wealth which has been obtained through the misery and degradation of others; also perhaps because in Co-operation the distinction between employers and employed will have ceased to exist.
