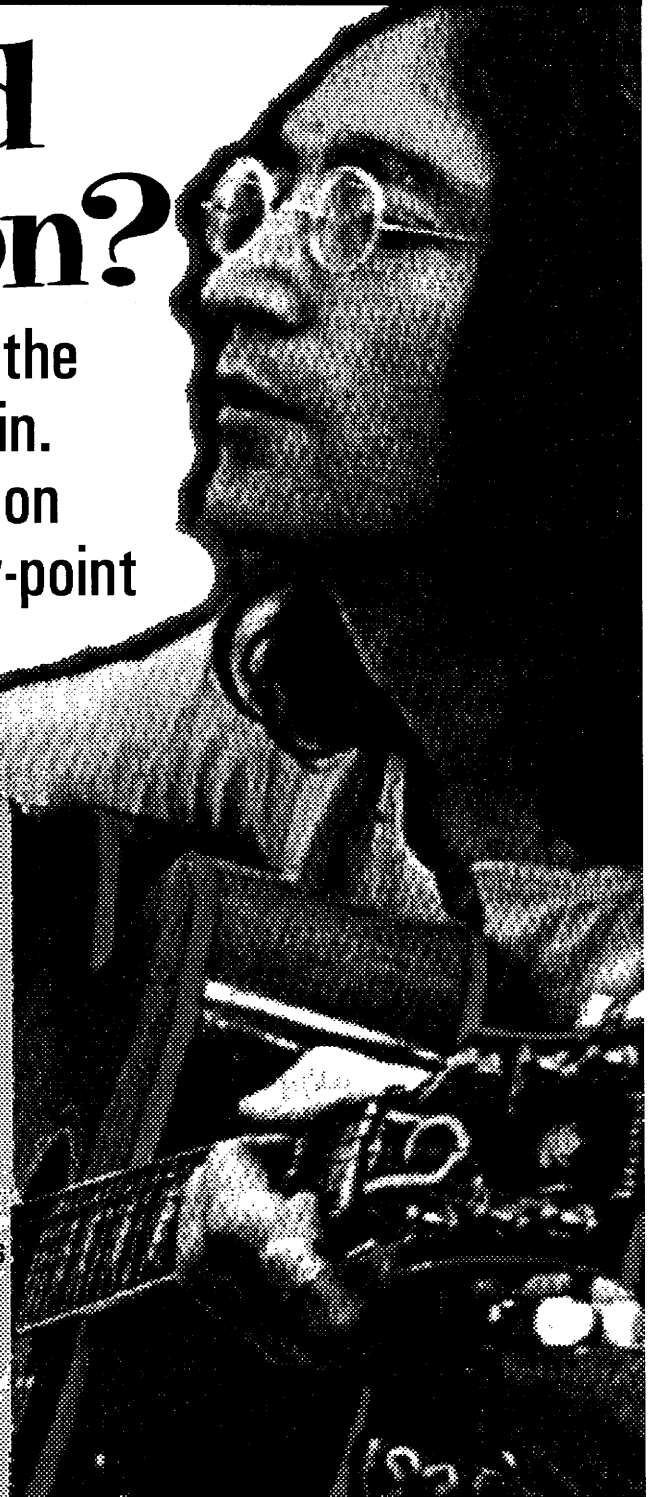

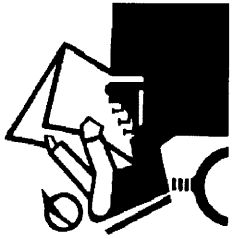

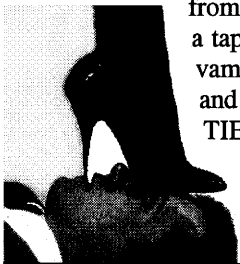

Feminism's hidden history

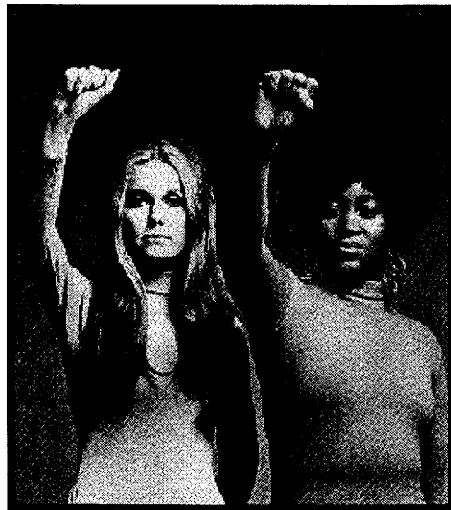

The World Festivals of Youth and Students for Peace and Freedom were the products of the World Federation of Democratic Youth and the International Union of Students, both formed at the end of World War II. Beginning in Prague, Czechoslovakia, in 1947 and every two years thereafter through 1959, these groups jointly sponsored a World Youth Festival. After a first-time lapse of three years, the eighth festival was held in Helsinki, Finland in 1962.

The March, 1967 *Ramparts* magazine revealed that the CIA had subsidized a number of domestic groups including the National Student Association (NSA) and the Independent Research Service (IRS), which Gloria Steinem helped found in 1959, ostensibly for the purpose of encouraging American students to participate in the Communist-dominated World Festivals of Youth. Steinem was the Director of the Independent Research Service from 1959 through 1960 and attended the 1959 and 1962 festivals. The article exposed the intricate funneling of money by the CIA to Steinem's front organization. Through a series of five foundations (the Borden Trust, The Price Fund, the Becon Fund, Edsel Fund and Kentfield Fund) the money was sent to Steinem's IRS.

Shortly after the *Ramparts* article appeared, Gloria Steinem was interviewed by the *New York Times* (February 21, 1967, "CIA Subsidized Festival Trips.") According to Steinem, her group had encouraged Americans to attend the festivals in order to open up the lines of communication between the East and the West. Steinem maintained that the CIA's involvement was benign, if not enlightened, when she stated: "Far from being shocked by this involvement, I was happy to find some liberals in government in those days who were farsighted and cared enough to get Americans of all political views to the Festival . . . the CIA's big mistake was not supplanting itself with private funds fast enough." In the December 3, 1967 issue of the *Washington Post* Steinem was quoted as saying that "in my experience the Agency was completely different from its image; it was liberal, nonviolent, and honorable" and she stated flatly that "she would again accept its funds to support her ideas." The full story can be found in the *Berkeley Barb*, May 30-June 5, 1975.

The 1959 World Youth Festival was to be held for the first time in a neutral country, Austria, in the city of Vienna. The CIA quickly and covertly organized members of the Independent Research Service to seed an "anti-Communist" delegation into the Festival. The goal of Gloria Steinem's delegation was to "disrupt" the Festival and gather intelligence on Americans and foreign nationals who were present. Three years later, her group was mobilized again to the 1962 Festival in Helsinki,

which was plagued by four days of rioting with forty arrests. In the August, 1962 issue of *Newsweek*, the Soviet newspaper *Pravda* blamed the rioting on well-financed CIA and FBI agents. The Soviet newspaper may have been accurate in stating as such because the IRS was mobilized in various delegations by the CIA to "disrupt" the World Youth Festival. (As punker Jello Biafra once sang: "But we ain't the Russians / political trials are taboo / we got secret ways of getting rid of you / if you demonstrate for something we don't like / I'll slip on my wig and see if I can cause a riot / transform you into an angry mob / and your leaders will go to jail because of my job.")

Further substantiation comes from Eugene Theroux, an NSA official knowledgeable in the recruitment of students by the Independent Research Service. He also believes that the Americans went to "cause trouble." In *The Pied Piper: Allard K. Lowenstein and the Liberal Dream* Richard Cummings states that Steinem recruited Eugene Theroux to work for her in 1965. This was about two years after Steinem first began to pretend to be a feminist.

In 1975 a feminist organization called the Redstockings, who were doing research for a book on feminism, began raising serious questions about Gloria Steinem's association with the CIA, insinuating that Steinem was a CIA front. A few chapters on Steinem's CIA ties were to be included in their book *Feminist Revolution*. When it became known that

Random House was planning to publish this book, Clay Falker, publisher of *New York* and *Esquire* magazines, along with Ford Foundation President Franklin Thomas and Gloria Steinem, threatened to sue Random House if the chapters regarding Steinem and the CIA were included in the book. When Katherine Graham, owner and publisher of the *Washington Post* and *Newsweek*, as well as Warner Communications, also complained, the "offending chapters" were deleted.

The *Village Voice* assigned journalist Nancy Borman to write about the censorship surrounding the Redstockings' book. Steinem's attorneys immediately threatened a lawsuit against the *Village Voice* if any mention of the CIA and Steinem appeared in the article. The *Voice*, after long consideration, went ahead and published the article on May 21, 1979. In the same year the NYC newspaper *The Heights and Valley News*, published by the Columbia Tenants Union Corporation, planned a series on censorship. Once again Steinem's attorneys threatened suit by letter addressed to each of the thirty-two board members of the corporation individually. *Heights and Valley News* published the series anyway. As the Redstockings stated, "All this legal harassment was in response not to any actual instance of fabrication or malicious defamation but to the potential raising of embarrassing questions about some feminists' relationships with the power elite." In a nutshell, if Steinem had nothing to hide about her past, why all the legal fuss?

It was feminist Susan Brownmiller's idea to establish a mass circulation feminist magazine but she could not raise the necessary seed money. Brownmiller and her friends once met with Steinem on this idea and she recalls that Steinem asked what they might put in a feminist magazine. When someone suggested that they could print feminist reviews of books and movies, Steinem replied "I never thought of that." Although Steinem lacked Brownmiller's vision, she received funding from Clay Falker, publisher of *New York* magazine.

It is a common complaint among "ex-CIA" employees that they have a hard time finding employment in other occupations. Gloria Steinem didn't have this problem because Clay Falker helped her out. Clay was Steinem's editor at *Esquire* Magazine where her first freelance articles were published. She was hired as contributing editor for *New York* magazine in 1968 and Clay also booked publicity spots on radio and television talk shows for her, which boosted her fame. Clay was also with Gloria during the 1962 Helsinki Youth Festival editing the English language newspaper published by the CIA-financed delegation.

Katherine Graham bought \$20,000 of stock before the first issue of *Ms.* magazine was ever

published. Warner Communications Inc. purchased one million dollars worth of stock after the preview issue. Warner put up the money but only took 25% of the actual stock holdings. Ms. editors viewed this as a bit odd saying: "We are especially impressed that they took the unusual position in becoming a major investor but a minority stockholder."

The Redstockings were also suspicious of the "curious financing" of Ms. magazine by Warner Communications, stating that "Warner put up nearly all the money but relinquished corporate control by taking only 25% . . ." They were curious as to whether this financing was connected to the lesson Gloria Steinem said she learned in 1967, which was that "the CIA's big mistake was not supplanting itself with private funds fast enough." They called for the Ms. editors to "come forward with information about their unusual stockholders." Redstockings contended that the formation of Ms. magazine had given Steinem a strategic position from which "feminist politics can be influenced" and they warned that "information . . . is being gathered on the personal and political activities of women all over the world."

The first publisher of Ms. Magazine, Elizabeth Forcling Harris, had reputed involvement in the Kennedy assassination. Harris accompanied Gloria Steinem when she made appearances in Dallas. Elizabeth Harris worked for the Bloom Agency, the public relations firm which planned for JFK's trip to Dallas. She and co-worker Jack Putterball planned the entire Dallas trip. Jack Putterball held the lunch in the Trademark "because of the close proximity to Love Field" (*Forgive My Grief, Vol. 4*, by Penn Jones). He also planned the timely, unauthorized, unnecessary and deadly detour into Dealey Plaza. Putterball is up to his neck in the conspiracy surrounding Kennedy's demise and was never questioned by the Warren Commission. Another person who worked with the Bloom Agency was Lee Harvey Oswald.

Katherine Graham, who provided money for the publishing of Ms. Magazine, owner and publisher of the *Washington Post* and *Newsweek* magazine, has extensive ties to the CIA. This is shown in the book *Katherine the Great* by Deborah Davis. Graham's husband, the late Philip Graham, helped found "Operation Mockingbird," which was a CIA operation to infiltrate the media. Philip Graham's still strange and mysterious death in 1963 left Katherine the task of taking control of both publications. The CIA, with its extensive ties to the *Post*, used the newspaper to guide the spotlight away from

any CIA involvement in the Watergate scandal.

In an interview with *Steamshovel Press* (Winter 1992), Deborah Davis details the friendship between Philip Graham and Alan Dulles. Apparently, the *Post* was having financial problems and Graham was looking for a way to pay his foreign correspondents. Dulles, then Director of the CIA, was looking for a cover for CIA operatives to get in and out of places without arousing suspicion. The two hit on a plan: Allen Dulles would pay *Washington Post* reporters and they would give information to the CIA as well as giving it to the *Post*. This program, called "Operation Mockingbird," subsequently spread to other newspapers and magazines. *Post* and Watergate reporter Carl

Bernstein, in a 1977 article for *Rolling Stone*, examined the relationship between the CIA and the media, outlining consistent co-operation in spreading disinformation, disseminating propaganda, introducing CIA agents to "potential foreign spies" and passing money or information to spies already active.

Ever since the CIA created the thoroughly exploitive and highly sensationalized Ms. magazine, Gloria Steinem has been regarded as the leading proponent of the feminist movement. Ms. Steinem advances the cause of "women's liberation" by exploiting her celebrity status to win dates with right-wing politicians and professional athletes. She frequently dated Henry Kissinger, who liked to say "power is the ultimate aphrodisiac." It must be true, after all there's nothing attractive about him, though he does have nicer legs than Nixon and larger breasts than Cher. This is interesting because Kissinger was a key Nixon aide, and feminist organizations turned out en masse at the 1972 Democratic convention to demonstrate against Nixon and support his opposition, George McGovern. Also interesting is that feminist support for McGovern helped Nixon get elected.

For about fourteen years Gloria was involved with J. Stanley Pottinger, a Washington attorney. Pottinger was involved in the coverups of the Martin Luther King and Orlando Letelier assassinations. In the book *Death in Washington*, Donald Freed states: "At the Department of Justice, J. Stanley Pottinger and Michael Sheehan were working overtime to blunt the charge that the FBI might have murdered Dr. King." When elements of the CIA began to emerge in the Orlando Letelier assassination, George Bush, Director of the CIA in 1976, met with Eugene Propper and J. Stanley Pottinger and promised "cooperation in exchange for FBI caution in any National Security matters." Pottinger was also investigated in 1984 for his

Valerie Solanas, the founder of SCUM (Society for Cutting Up Men), attempted to assassinate pop artist Andy Warhol on June 3, 1968. Warhol was seriously wounded, but survived the shooting. The assassination attempt was soon overshadowed by the killing of Robert Kennedy later that summer, but Solanas' fantastic rant against the weaker sex lives on.

SCUM is too impatient to hope and wait for the debrainwashing of millions of assholes. Why should the swinging females continue to plod dismally along with the dull male ones? Why should the fates of the groovy and the creepy be intertwined? Why should the active and imaginative consult the passive and dull on social policy? Why should the independent be confined to the sewer along with the dependent who need Daddy to cling to?

A small handful of SCUM can take over the country within a year by systematically fucking up the system, selectively destroying property, and murder.

SCUM will become members of the unwork force, the fuck-up force; they will get jobs of various kinds and unwork. For example, SCUM salesgirls will not charge for merchandise; SCUM telephone operators will not charge for calls; SCUM office and factory workers, in addition to fucking up their work, will secretly destroy equipment. SCUM will unwork at a job until fired, then get a new job to unwork at.

SCUM will forcibly relieve bus drivers, cab drivers and subway token sellers of their jobs and run buses and cabs and dispense free tokens to the public.

SCUM will destroy all useless and harmful objects—cars, store windows, "Great Art," etc.

Eventually, SCUM will take over the airwaves—radio and TV networks—by forcibly relieving of their jobs all radio and TV employees who would impede SCUM's entry into the broadcasting studios.

SCUM will couple-bust—barge into mixed (male-female) couples, wherever they are, and bust them up.

SCUM will kill all men who are not in the Men's Auxiliary of SCUM. Men in the Men's Auxiliary are those men who are working diligently to eliminate themselves, men who, regardless of their motives, do good, men who are playing ball with SCUM. A few examples

of the men in the Men's Auxiliary are: men who kill men; biological scientists who are working on constructive programs, as opposed to biological warfare; journalists, writers, editors, publishers and producers who disseminate and promote ideas that will lead to the achievement of SCUM's goals; faggots, who by their shimmering, flaming example encourage other men to de-man themselves, and thereby make themselves relatively inoffensive; men who consistently give things away—money, things, services; men who tell it like it is (so far not one ever has), who put women straight, who reveal the truth about themselves, who give the mindless male females correct sentences to parrot, who tell them a woman's primary goal in life should be to squash the male sex (to aid men in this endeavor SCUM will conduct Turd Sessions, at which every male present will give a speech beginning with the sentence: "I am a turd, a

lowly, abject turd," then proceed to list all the ways in which he is. His reward for so doing will be the opportunity to fraternize after the session for a whole, solid hour with the SCUM who will be present. Nice, clean-living male women will be invited to the sessions to help clarify any doubts and misunderstandings they may have about the male sex); makers and promoters of sex books and movies, etc., who are hastening the day when all that will be shown on the screen will be Suck and Fuck (males, like the rats following the Pied Piper, will be lured by Pussy to their doom, will be overcome and submerged by and will eventually drown in the passive flesh that they are); drug pushers and advocates, who are hastening the dropping out of men.

SCUM will keep on destroying, looting, fucking-up and killing until the money/work system no longer exists and automation is completely instituted or until enough women co-operate with SCUM to make violence

unnecessary to achieve these goals,

that is, until enough women either unwork or quit work, start looting, leave men and refuse to obey all laws inappropriate to a truly civilized society. Many women will fall into line, but many others, who surrendered long ago to the enemy, who are so adapted to animalism, to maleness, that they like restrictions and restraints, don't know what to do with freedom, will continue to be toadies and doormats, just as peasants in rice paddies remain peasants in rice paddies as one regime topples another. A few of the more volatile will whimper and sulk and throw their toys and dishrags on the floor, but SCUM will continue to steamroller over them.

Prior to the institution of automation, to the replacement of males by machines, the male should be of use to the female, wait on her, cater to her slightest whim, obey her every command, be totally subservient to her, exist in perfect obedience to her will, as opposed to the completely warped, degenerate situation we have now of men, not only existing at all, cluttering up the world with their ignominious presence, but being pandered to and groveled before by the mass of females, millions of women piously worshipping the Golden Calf, the dog leading the master on the leash, when in fact the male, short of being a drag queen, is least miserable when abjectly prostrate before the female, a complete slave. Rational men want to be squashed, stepped on, crushed and crunched, treated as the curs, the filth that they are, have their repulsiveness confirmed.

The sick, irrational men, those who attempt to defend themselves against their disgustingness, when they see SCUM barreling down on them, will cling in terror to Big Mama with her Big Bouncy Boobies, but Boobies won't protect them against SCUM; Big Mama will be clinging to Big Daddy, who will be in the corner shitting in his forceful, dynamic pants. Strategic Services, forerunner of the CIA. This novel was also owned by Ronald Reagan's attempted assassin John Hinckley, Jr. (See related article, *Is The Catcher in the Rye a mechanism of control?*)

* * * * *

When he died on December 8, 1980, Lennon, the most politically active rock star of his generation, had been due to fly to San Francisco to march in support of striking Japanese-American workers. The radical ex-Beatle was "returning to the streets" and, as suggested by London lawyer Fenton Bresler in his book *Who Killed John Lennon?*, he "was likely to prove a rallying point for mass opposition to the policies . . . of the new U.S. government headed by Ronald Reagan."

However, the murder of John Lennon was never investigated by a Commission. It was not filmed or photographed. And the alleged assassin avoided a trial by pleading guilty. Consequently, there is little available evidence, and Bresler can only present a largely circumstantial case for conspiracy.

Not insane

First, he demolishes the popular conception of the "lone nut" assassin, noting that Mark David Chapman was *not* ruled insane. In fact, between 1835 and 1981, fifteen men and two women have attacked nationally prominent political leaders. Only three have been ruled insane by law. (Three were killed before they could stand trial: Huey Long's assassin Carl Weiss, Lincoln's assassin John Wilkes Booth, and Lee Harvey Oswald.)

Three theories

Bresler then argues against three major theories of Chapman's motivation:

- *He killed Lennon to become famous and gain attention.* If this were the case, why does Chapman continue to turn away "thirty or forty" media requests for interviews every year? And why did he plead guilty, losing the spotlight and attention of a trial?
- *He believed that he was himself John Lennon, and the act was a twisted kind of suicide.*
- *He was a devout fan who now hated John Lennon because he'd become a "phony," just another rich capitalist rock star.*

Here, Bresler's argument is weak. He dismisses these last two theories because "both cannot possibly be right." This is like saying, "The sky cannot be both blue and purple, so the sky is not blue." Nevertheless, the thought-he-was-Lennon theory does not fit a person who acted "coolly and rationally" and who was ruled legally sane. The Lennon-was-a-phony theory is at least plausible, given the increased

coverage of Ono/Lennon's wealth and business dealings in the months before his death. (They owned the entire seventh floor of the Dakota, their New York apartment building. This "radical" couple also owned a weekend home on Long Island, a Florida mansion, a 63-foot yacht, and 250 prize Holstein cattle.)

"He could have been programmed"

Whatever his motive, witnesses saw Chapman pull the trigger, and he freely admitted his guilt. Police officials considered it an open-and-shut case. And yet, at least one of them now has nagging doubts. As Arthur O'Connor, NYPD lieutenant of detectives admitted to Bresler in 1988, ". . . It's possible Mark could have been used by somebody. I saw him the night of the murder. I studied him intensely. He looked as if he could have been programmed."

YMCA?

If Chapman was programmed to kill John Lennon, who did the programming? An ex-CIA case officer suggested one possibility to Bresler. He told the writer that the YMCA is one of many CIA-infiltrated front organizations. With offices in nearly ninety countries, it is certainly possible that the CIA would use the YMCA in its intelligence operations. This also makes sense given the CIA's known history of financing and infiltrating such domestic organizations as the National Students Association.

A YMCA/CIA connection was confirmed by former agent Philip Agee in his book, *Inside the Company: CIA Diary*. In it, he lists the YMCA as one of the organizations used by the Agency. At the very least, some YMCA offices and officials have likely been used for agent recruitment and contacts.

Perhaps it is merely coincidence, but Mark David Chapman had a clear and long term involvement with the YMCA throughout his life. In 1975, he

went to Beirut for them. (Mark, by then a fundamentalist Christian, had asked to be sent to the Soviet Union.) He also worked for the Y at a camp for Vietnamese refugees (also in 1975) and at a YMCA camp in Georgia (1969-1976). In 1978, he toured the world, staying in several YMCA youth hostels. Despite these connections, Chapman's name does not appear in the YMCA's central archives. The Chapman File, if it ever existed, is missing.

Assassin training

Bresler cites research conducted by the Christic Institute, which claims the CIA has trained assassins at a location in Hawaii. Hawaii has also been named as a CIA training site by conspiracy researcher Mae Brussell. These islands, with their strong U.S. Naval presence, were also the home of Mark David Chapman in the three years before he killed John Lennon. (It is known that Mark was trained as a "security guard" while in Beirut.) But could the CIA have actually programmed this previously anti-gun Christian to kill? Bresler says yes, and cites evidence of CIA mind control experiments begun in the early 1950s.

"It wasn't an accident"

After recounting Lennon's increasing involvement in left-wing politics, Bresler reports that the FBI had a file on Lennon of over two-hundred pages, some marked "Copy to CIA." The files make clear the government's concern about John Ono Lennon. In April 1972, J. Edgar Hoover directed his New York office to "locate subject (Lennon) and remain aware of his activities and movements . . . careful attention should be given reports that subject is heavy narcotics user."

The files make much of Lennon's "Revolutionary Activities" and consider him a legitimate security threat. (Lennon was, indeed, a threat: to Richard Nixon's presidency. He was involved in several left-wing causes, including a planned demonstration at the Republican national convention.) Bresler has found a 1973 FBI memo that refers to "the illegal electronic surveillance" of Lennon's phone calls. And at least one FBI memo urges agents to "neutralize" Lennon's "disruptive" activities. Lennon was well aware of the government's concern, and of its relentless surveillance. Bresler reports that, in 1972, he told publisher Paul Krassner, "Listen, if anything happens to Yoko and me, it wasn't an accident."

Preferred Rundgren

While Lennon fought government harassment, and a threatened deportation based on a 1968 marijuana conviction, Chapman was supposedly his "devout fan," right? Like most teenagers, Mark was a Beatles fan. But, according to the New York County Assistant DA who prosecuted him, Mark "had no particular interest in John Lennon between age fourteen and twenty-four." In fact, part of the prosecution's strategy, had a trial occurred, was that Chapman simply wanted to kill a famous person, any famous person, to become famous himself. In addition, classmate Newton Hendrix has recalled that, "(Mark)

never expressed strong views on Lennon or the Beatles. He played the guitar and may have written some songs, but it was not 'Beatle-type' music." Honolulu Police Captain Louis Souza told Bresler that, "he was (not) a John Lennon nut. It appeared that he was just the opposite. He . . . was not a particular fan of John Lennon." And Brook Hart, the Honolulu lawyer who represented Chapman's wife, has stated, "I have more Beatle records in my collection than Mark had." Based on his belongings, Bresler reports that Mark was, in fact, a major Todd Rundgren fan. In fact, it was a Rundgren tape, not a Lennon tape, that he left for police to find in his room.

Altered evidence

An altered airline ticket is one of the few solid pieces of evidence of conspiracy. The airline ticket conveniently left by Chapman on display in his hotel room suggests that Mark flew *straight from Hawaii to New York* via a Chicago connecting flight. The ticket found in his hotel room had a departure date of *December 5*, and it is undisputed that Mark landed in New York on Saturday, December 6.

But the ticket purchased by Mark (on November 28) was not, in fact, for a flight leaving Hawaii on December 5. It was for a flight leaving Hawaii on Tuesday *December 2*. Bresler reports that United Airlines had confirmed, to Honolulu police Captain Souza, that Chapman used the ticket on December 2. On December 9, Chapman's wife Gloria seemed to confirm the earlier date when she stated that Mark had left Hawaii "eight or ten days" ago. In other

words, we know that Chapman flew from Hawaii to Chicago on December 2, and from Chicago to New York on the night of December 5. Bresler concludes that someone has altered the airline ticket, which originally had the correct departure date of December 2, to cover up the fact that Chapman spent three days in Chicago before he flew to New York.

Even more puzzling is the fact that the airline ticket purchased by Chapman was for a flight from Hawaii to Chicago on December 2, and a return flight from Chicago to Hawaii on December 18. In other words, it was a *round trip ticket to Chicago*, with no mention of New York. Even if Mark purchased a round trip ticket just to save money (round trip tickets often cost less than a single one-way ticket to the same destination,) this does not explain why he did not purchase a Chicago-New York ticket at the same time. To Bresler, this suggests that Mark initially intended to go to Chicago, and only "decided" to fly to New York during his mysterious three-day stay in Chicago.

But why would Mark have flown to Chicago in the first place, if not with the intent of flying on to New York to kill Lennon? A possible answer was suggested to Bresler during his interview with Gloria Chapman's friend Ruth Brillhante. She stated, "When we heard that Mark had shot Lennon, we couldn't believe it. Not only because we could not believe he could do a thing like that, but because *we did not know he was in New York. We all thought he was in Chicago.* That is where he had gone to take his grandmother home after she was visiting out here." It is known that Mark had a grandmother in Chicago, but there is some confusion over whether he was taking her back to Chicago, or simply visiting her there. (Or, the story could have simply been a lie on Mark's part.)

Ringo's cryptic comment

As the Medical Examiner was conducting the autopsy, Beatle drummer Ringo Starr arrived at the Dakota with his fiancée Barbara Bach. He was there to console Yoko, and was the only surviving Beatle to make the journey. As Starr later told *People* magazine, Yoko had asked to only see him by himself. In response, he said, "*Look, it was you who started all this. We're both coming in.*"

Now, what on earth could he have meant by this statement? Although Bresler makes no such speculation, and there is no hard evidence to prove it, Starr may have been referring to the highly-publicized "feud" between Lennon and his former partner, Paul McCartney. Unfairly, perhaps,

the feud is thought to have begun when Yoko Ono "broke up" the Beatles.

If this is the case, could Starr have considered the Lennon murder to be some kind of *finale* to the feud? Keep in mind that, at the time, McCartney had recently been jailed in Japan on a marijuana possession charge. Facing an extremely stiff prison sentence, he had been imprisoned and humiliated. (His Japanese guards had gotten their kicks by forcing their famous prisoner to sing *Yesterday*.) Was this the incident behind Ringo's comment? And did McCartney suspect that John or Yoko had been involved, and in turn take his extreme revenge? Although this theory is far-fetched, it is clear that Yoko or her banking family had the means to pull strings in Japan. And it might explain McCartney's seemingly sarcastic response to a network news crew in response to the assassination: "It's a drag," he said disinterestedly (or words to that effect.)

Justice denied

Once again, a liberal voice for justice has been silenced. (Why is it that violent deaths seem only to happen to left-wing entertainers and politicians? Do their more conservative peers lead charmed lives?) His death brought about an unprecedented wave of grief and sadness, but precious little investigation. It seems we owe it to his memory to at least ask why. After all, we may know who shot John Lennon, but do we really know who killed him? ●

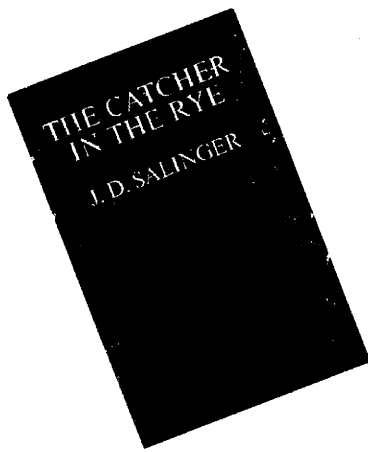

Is the Catcher in the Rye a Mechanism for Control?

One night not long ago—while my brain was dozing softly off to sleep—I was stirred from hypnagogia by the radio faintly humming by my head. When I heard the name J.D. Salinger, I was instantly summoned from semi-consciousness and turned the volume up. It was a brief news item, relating the event of Salinger's home burning down back East. The news announcer described how Salinger and his wife had watched the conflagration helplessly from a distance, as the fire fighters battled futilely to save their home. Anyway, this was the last I'd heard of this story, which isn't surprising given the elusive nature of Salinger, dropping from view as he did in '65 and becoming a virtual recluse behind the shuttered windows and walls of his world, from there writing the final passages of his life. Rumor has it, Mr. Salinger had two manuscripts laying in wait behind those secretive walls. I wonder if perhaps they are now but ashes? In fact, I'd assumed—before I heard this story over the radio airwaves—that Salinger was soiled worm food himself. I was aware he'd been a long time recluse, but given his advanced age, I'd figured the old codger had exited this earthly plane years before.

Intelligence Connections

Curious as to what Salinger had done over the years since his disappearance from the public eye, I visited my local library and chanced upon a copy of an

interesting biography called *In Search of J.D. Salinger* by Ian Hamilton, who approached his subject from a distance without approaching too close and bugging ex-wives and sifting through garbage like Lennon biographer Albert Goldman, who creates fiction and tarnishes reputations with half-truths and whole lies. One area I was interested in was if Salinger ever had any connections with U.S. Intelligence. My reason for this line of inquiry was my suspicion that his classic novel *The Catcher in the Rye* had been used as a "mechanism of control" in the assassination of John Lennon, and the attempted assassination of Ronald Reagan. If you recall, *The Catcher in the Rye* was found in the possession of both Hinckley and Chapman after their respective rampages. In fact, when the New York City police found Chapman in the aftermath of Lennon's assassination, he was sitting glassy-eyed and weirdo, leaning against the wall of the Dakota, reading from Salinger's book.

Manchurian Candidate

When I refer to *The Catcher in the Rye* as a "mechanism of control" I mean in the sense of a triggering device which sets off a post-hypnotic suggestion, much like the queen of hearts did in Richard Condon's *Manchurian Candidate*, unleashing within it's mind-controlled

subjects the command to kill. According to Hamilton's biography, Salinger did in fact have connections with Defense Intelligence during World War II, serving with the Counter Intelligence Corps (CIC), his time spent mainly in the interrogation of captured Nazis. Later on, toward the end of the war, Salinger was involved in the denazification of Germany. Whether he was part of the infamous and insidious Project Paperclip is unknown. There's nothing in Hamilton's book to suggest this, except for Salinger's aforementioned involvement in denazification, though the book fails to elaborate further on just what aspects of denazification Salinger was involved with.

Re-Nazification?

The Catcher in the Rye was found in the possession of both Hinckley and Chapman after their respective rampages

Denazification—to a lot of people in conspiracy corners—could perhaps be construed as a code word alluding to the importation of high level Nazi

spies into the highest ranks of the American Intelligence community under the auspices of Project Paperclip. Project Paperclip was the secret operation which at the war's end smuggled Nazi General Reinhard Gehlen, Hitler's Chief of Intelligence, in addition to Gehlen's entire staff, into the U.S. At this same time, hundreds of other top Nazis were imported and given new identities and

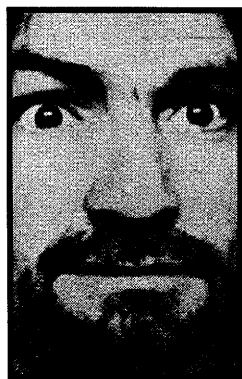

government positions, forming the core of the new U.S. Intelligence, defense, and aerospace establishments. And Reinhard Gehlen was at the forefront of this malignant movement of Nazis, almost single-handedly re-forming the old Office of Strategic Services (OSS) into it's new and improved Nazi-ized version: the Central Intelligence Agency (see related article, p.23.) Perhaps, in this instance, Re-nazification would have been a more apropos term. From this point of reference, it would take a rather fanciful leap to believe that Salinger was part of this diabolical importation; and going even further to suggest that under the auspices of this new American-Nazi Intelligence regime he wrote *The Catcher in the Rye* as a "mechanism of control" to be employed in CIA mind-control experiments such as Project Artichoke and MK Ultra.

Contemporary Christian conspiracy writers like Texe Marrs, Hal Lindsey and Salem Kirban continue a long tradition of Armageddon paranoia which began as a battle between the Catholic Church and Gnostic traditions. Staunchly set against the self-empowering doctrine of Gnosis, direct "knowing" of God without parlay through the religious specialist class, the Catholic Church waged war against Gnosticism's "heretical" practices all over the world. Any God who would be accessible to a commoner was surely the Devil in disguise. Thus, all of Europe and the New World was taught a harsh lesson.

The power of the Catholic Church waned after the Protestant Reformation loosened the shackles of the Inquisition. However, a new inquisition moved underground in the late eighteenth century with a paranoid literary movement throughout England. In fear of going to hell in a handbag with the godless sector of the planet, Christians cooked up perhaps the oldest conspiracy . . . could it be . . . Satan?

One of the first authors to rewrite history from the point of view of a new hysteria was John Robison in *Proofs of a Conspiracy*, written in 1798. He firmly believed that the Bavarian Illuminati had infiltrated Freemasonry in order to foment revolt. Mainstream historians react that while these secret societies were certainly influential during the course of revolution, the plot to undermine the Christian world order was Robison's own paranoid delusion.

This point of view took hold at about the same time that the Russian Revolution shocked the world, setting the stage for anti-Masonic, anti-Semitic and anti-Bolshevik hysteria. While the mainstream would agree that the great revolutions of the 18th and 19th centuries were influenced by the Masons and the Illuminati, the conspiratorial view of history holds that secret societies inflamed revolutions by creating mass schemes and ideological shifts, like Marxism and Evolution theory, in order to invoke a Godless New World Order.

Fantastic leaps in conspiracy theory were undertaken by three very important British women writers of the 1920's and 30s: Nesta Webster, Edith Starr Miller, and "Miss Stoddard." During this period, these three women brought the paranoid vision of Robison to crusade level. Nesta Webster (aka Julian Sterne) was the most prolific of the three. She believed the Jews, in league with Satan, to be at the bottom of the anti-Christian cabal. Her book *Secret Societies and Subversive Movements* details all of the organized underground movements against "civilized Christianity" and traces the origins of secret societies to the beginning of the Christian era. In *The Socialist Network*, Mrs. Webster

illuminates the origins and rise of an ancient occult secret movement which has penetrated the entire world and has grown into a global communist network. Another of her books, *World Revolution*, traces the growth of a world conspiracy from early Illuminism and the French Revolution through the rise of syndicalism, anarchism, bolshevism, communism and World War I. Edith Starr Miller, writing under the name Lady Queensborough, writes that Satan is the real force behind secret societies' plots to take over the world. Her book, *Occult Theocracy*, the most complete work on secret societies, has been described by liberal factions as a "paranoid masterpiece."

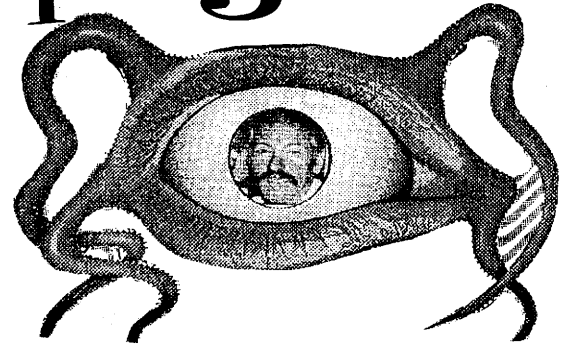
Miss Stoddard, writing under the pseudonym "Inquire Within," adds kundalini and sex magic to the bustling theories of her sister paranoids. The occult element which Queensborough and Webster saw as a front for Jewish manipulation is seen by Stoddard as a purely Gnostic menace. She claims to have been a Ruling Chief of the Mother Temple of the Stella Matutina. In her book *Light Bearers of Darkness*, she claims that the movement for world revolution is an age-long effort by secret illumined sects to dominate the world. The sequel, *Trail of the Serpent*, further investigates secret societies, their political affiliations, occult practices and pseudo-religious activities.

This trio of British conspiracy femmes laid the groundwork for contemporary Christian Armageddon hysteria. The claim that an international conspiracy is being perpetrated in order to destroy the Christian family has certainly taken hold in America.

If we are to give even an iota of credence to these three women for all of their zealous effort, at least a passing thought should be the realization that there are two sides to every coin. Either conspiracy theory creates its own demons, or systems of thought have been set in place so as to assess the conspiratorial view of history as ludicrous and impossible. Read for yourself and decide what is and isn't possible.

You have proof of the present evil underground activities of groups like the CIA, the KGB and "sanctioned" governments of this planet. The hard truth is, the world hasn't changed much and these kind of antics are nothing new. "They're dropping like flies"



The web thickens. Recently, PARANOIA has reported on two suspicious deaths: those of alleged spy Ian Spiro and conspiracy researcher Danny Casolaro. Incredibly, these seemingly unrelated deaths may be related, as described in the following article from the Sacramento Bee (4/15/93).

At least seven people linked to a purported British spy have been killed or found dead throughout the country since 1981, a newspaper has reported. Authorities say the FBI and state attorney general have spent years investigating a series of deaths that may be connected to covert activities involving Ian Stuart Spiro, according to the *Blade-Citizen* of Oceanside. Spiro, 46, was found dead of cyanide poisoning in the Anza-Borrego desert Nov. 8, one week after his wife and children were found shot to death in their rented northern San Diego County home. Sheriff's investigators think Spiro killed his family and then himself, but they admit that motives for his death seem to lurk everywhere but in San Diego.

"This is an intriguing case," Sheriff Jim Roache said. "It has a lot of nuances fraught with conjecture and possibilities." Sheriff's officials said Wednesday that they have contacted authorities in San Francisco and Riverside County who are investigating unsolved murders of people possibly linked to Spiro. Experts on covert government operations, documents and U.S. intelligence sources have implicated Spiro in the Iran-Contra arms-for-hostages affair and an alleged Justice Department conspiracy to pirate software from a private company and sell it to foreign intelligence agencies.

Heart attack?

The deaths of so many people linked to Spiro have caused his relatives and covert connections to question whether the family was murdered to cover up illicit activities, the newspaper reported.

The week of the family's deaths, Robert Corson, a business associate of Spiro's indicted in a savings and loan scam, was found dead in an El Paso, Texas, motel room. Corson, who reportedly worked for the CIA, died of a heart attack, officials said.

A Corson associate was among a group of businessmen, government officials, Contra commanders, CIA operatives and Cabazon Indian representatives at a Sept. 10, 1981 secret weapons demonstration by Wackenhut International Inc. on the Cabazon Indian Reservation near Indio, according to a document from the Riverside County district attorney's office. Several anonymous sources told the *Blade-Citizen* that Spiro had business ties to activities at the Reservation.

Riverside County sheriff's detectives are still investigating the slayings of Cabazon Indian leader Alfred Alvarez, 32, and two other Indians whose bodies were found July 1, 1981 behind Alvarez's home in Rancho Mirage. Alvarez was protesting Wackenhut's operations on the Reservation.

Found strangled

Paul Morasca, 31, who San Francisco detectives say was a

business colleague of Cabazon director John Phillip Nichols, was found strangled Jan. 14, 1982, in a San Francisco condominium. Grand juries in San Francisco and Riverside counties investigated the killings, but no one was indicted, officials said. San Francisco homicide inspectors Eddie Erdelatz and Jeff Borsch, who are investigating Morasca's death, say they were rebuffed when they tried to pass on information they uncovered to the FBI and state Department of Justice. "People walk away from you because they think you're making something up," Borsch said. "I don't know how people can operate like this without getting in trouble from the federal government."

Also attending the Wackenhut arms demonstration were Nichols; Michael Riconosciuto, a research director at the Cabazon reservation; and Peter Zokosky, then president of the Armtech weapons manufacturing firm, according to the Riverside district attorney's report. Riconosciuto, reportedly an ex-CIA operative in the Middle East, is serving 30 years in federal prison on drug charges he contends were trumped up after he testified before a congressional committee in the software piracy case.

He contends that the Spiro family, Spiro's business associates, high-level CIA officials and others were killed because Spiro had documents and computer files incriminating top government officials in the alleged conspiracy. San Diego Sheriff's Capt. Jim Marmack said detectives are investigating allegations by Spiro's relatives that his file cabinets and business papers are missing. Documents detailing the items authorities seized from his house have been sealed under court order.

Casolaro knew Spiro

Danny Casolaro, a Washington, D.C. area reporter, was working on a book about the software scandal and activities at the Cabazon reservation when he was found dead Aug. 10, 1991, in a motel room in Martinsburg, W.Va. Officials ruled Casolaro's death a suicide, but the judiciary committee that Riconosciuto testified before has recommended that it be reinvestigated. Intelligence officials say Casolaro knew Spiro.

Alan Michael May was found dead in his San Francisco home last June 19, four days after a newspaper story outlined his role in an alleged plot by Republican Party officials to bribe Iranian officials to delay the release of U.S. hostages until after President Reagan's inauguration.

"It's one of those terrible webs; it's just a horrible, horrible mess," said Zokosky, who has cooperated with the Riverside County investigation. "People are dropping like flies. It always seems to be peripheral people who don't know the whole story."●

Suspicious Death Update

Cuban Mystery Epidemic

- A house-to-house vitamin distribution program has put down an unprecedented epidemic that sickened more than 50,000 Cubans, but the cause of the malady remains a mystery. Bjorn Thylefors, head of a World Health Organization investigation team, said that a combination of an unknown poison and poor nutrition in Cuba apparently was to blame. American and Cuban scientists are working to identify the poison, probably an insecticide or a contaminated food product. (Chicago Tribune)

Fundamentalist Christian Sex Cult

- Authorities have taken 170 children into custody in Buenos Aires after allegations that many of them were being sexually abused by members of "The Family," an American-led cult that calls itself a worldwide Christian-missionary church. Nearly 60 of the children were American. The cult had produced comic books and videos depicting children and other members engaging in "Sex for Christ." A California branch of the cult claims they do not engage in such activities. (Time)

Perot Plot?

- As the NAFTA vote approached, opponent Ross Perot revealed that he was the target of a Mafia-Cuban assassination plot. The plot, relayed in an anonymous tip to the FBI, had a familiar ring to investigators of the Kennedy assassination. (LA Times)

Syrian Counterfeit Operation

- A large Syrian-run counterfeit money operation has helped produce at least \$200 million in bogus U.S. currency that may threaten the stability of the U.S. dollar. The operation involved the production of fake \$100 bills by printing presses hidden in the Bekaa Valley of Lebanon. As reported by NBC News, the counterfeiters used high-technology printing processes that made it impossible for the U.S. Federal Reserve Bank's scanning machines to identify the money as counterfeit. Former U.S. government official and terrorism expert Robert Kupperman told NBC the U.S. government was "in a state of near panic" over the forgeries, which he identified as "the product of Syrian intelligence." NBC quoted unidentified "intelligence sources" as saying the production has "skyrocketed" in recent months and it said billions of dollars worth of fake U.S. currency may now be in circulation worldwide. (NBC, UPI)

Innocents Beaten

- In late September, in the same Manhattan hearing room where the Knapp Commission investigated New York City police corruption twenty-one years ago, the Mollen Commission heard evidence that crooked cops have continued to abuse their power. Officers testified about doing lines of coke in their squad cars, accepting thousands of dollars in drug dealer payoffs, and participating in systematic, random beatings of innocent civilians. As onetime Bronx patrolman Bernie "The Mechanic" Cawley, 29, now serving three years to life for narcotics charges and for selling stolen guns, told the

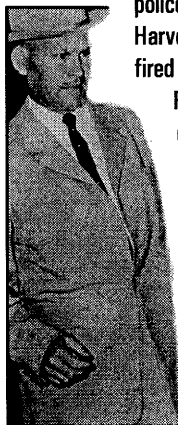

Zine Publisher Busted

- An anti-"War on Drugs" zine reports that Kif Davis, publisher of alternative zine *Ship of Fools*, was arrested on May 7, 1992 after a sheriff's officer posing as a UPS driver delivered a package containing marijuana to his home. The Davis home was ransacked by police and Kif's mailing list and computer equipment were seized. Although Kif was able to escape to the roof and eat most of the delivered pot, the police found less than an ounce of additional pot on his mother's nightstand. Three weeks later, Kif's mother was informed that the investigation had turned up no evidence linking her to illegal activities. She requested the return of her computer (also seized in the raid) and was told that it had been turned over to the IRS. Kif's own computer was kept by police because it contained "anarchist writings" and "articles about marijuana" on its hard disk. After a series of court actions, Kif pleaded guilty to possession and was fined \$1,000. His mother, meanwhile, has become a marijuana re-legalization activist. JFK Researcher Accidentally Shot

- Last year, a photographer documenting how a Dallas police officer tried to keep Jack Ruby from shooting Lee Harvey Oswald was accidentally shot himself. The bullet was fired from a replica of the gun that killed Oswald.

Photographer Bob Porter was at the home of former detective James Leavelle, the man who was handcuffed to Oswald when he was killed in the basement of the Dallas police headquarters. Porter was participating in an oral history project on the Kennedy assassination when, as Mr. Leavelle was demonstrating how he could have prevented the gun from firing, the gun went off and tore into Porter's right arm. After being treated at Parkland Hospital, he was expected to regain about 85 percent of the use of his arm. High-Level Drug Corruption Revealed

- Computer giant IBM submitted the winning bid to upgrade Mexico's air traffic control system. According to IBM negotiator Kaveh Moussavi, Mexican negotiators demanded a \$1 million bribe (a "Mexican handshake") to seal the deal. IBM refused to make the payoff and subsequently lost the contract. Moussavi also revealed the Mexicans expressed concern over the effect improved air traffic controls might have on illegal drug flights. "They unfolded a map showing areas of Mexico beyond the reach of controllers," Moussavi recounted, "They said this was far from accidental. When \$100 billion of narcotics goes through Mexico, \$15-\$17 million stays here, they said. 'Who do you think benefits? We must be sure those flights are not blocked, and for those that must be canceled, there must be compensation.'" (The Spotlight weekly, \$32/yr, 800-522-6292)

History of the Assassin

During the Crusades when Brotherhood military organizations were valiantly leading Christian armies to fight the Moslems, other groups in the Brotherhood network were rallying Moslems to battle the Christians! Of the several Brotherhood branches promoting the cause of Islam, one is of particular interest to us: the sect of the Assassins. Mohammed died in 632 A.D. A struggle immediately ensued over who was to become his successor. This caused the Islamic religion to break apart into competing sects, each having its own ideas about who was to succeed Mohammed.

One such Islamic faction was the "Shia" sect, which adheres to a strong "End of the World" tradition. Shiites believed in the "Millennium": a Day of Judgment followed by a thousand years of peace and spiritual salvation. Eventually the Shia sect itself split apart. One faction to emerge from the Shia split was the Ismaili sect, which gave birth to the Assassins. One Ismaili lodge member was a man named Hasan-i Sabbah. Mr. Sabbah's mystical conversion came about as the result of a "severe and dangerous illness" during which he believed that God had purged him and had given him a spiritual rebirth. In 1078, at the Grand Lodge in Cairo Mr. Sabbah asked the Ismaili caliph for permission to spread the Ismaili gospel in Persia. The caliph granted Mr. Sabbah's request on the condition that Sabbah agree to support the caliph's eldest son, Nizar, as the next (ninth) caliph. Sabbah accepted the deal and named his new Ismaili branch the "Nizaris" after the caliph's son. It was not long, however, before Mr. Sabbah's branch became known by its more famous name: the "Assassins."

The Assassins are usually referred to as a religious sect. They were, more accurately, a secret society. According to Masonic historian Albert MacKey, the Assassins adopted the organizational structure of the Ismailians. The Assassins practiced step-by-step initiations and possessed a secret mystical doctrine. Mr. MacKey adds that the Assassins appear to have practiced three of the very same fraternal degrees used in Freemasonry today: Apprentice, Fellow and Master. The Assassins had a religious code similar to the Hospitaler and Teutonic Knights. The Assassins were an integral part of the Brotherhood network. A distinguishing feature of the Assassin organization was its use of drugs, primarily hashish, for mystical and other purposes. In fact, the word "assassin" comes from the word "hashshishin," which means "users of hashish." The Assassins and several other Brotherhood groups in history extolled the virtues of mind-altering pharmaceuticals as a way to achieve mystical enlightenment.

The Assassins were also a fighting organization with an army. Grand Master Sabbah chose a fortress located high in the northern mountains

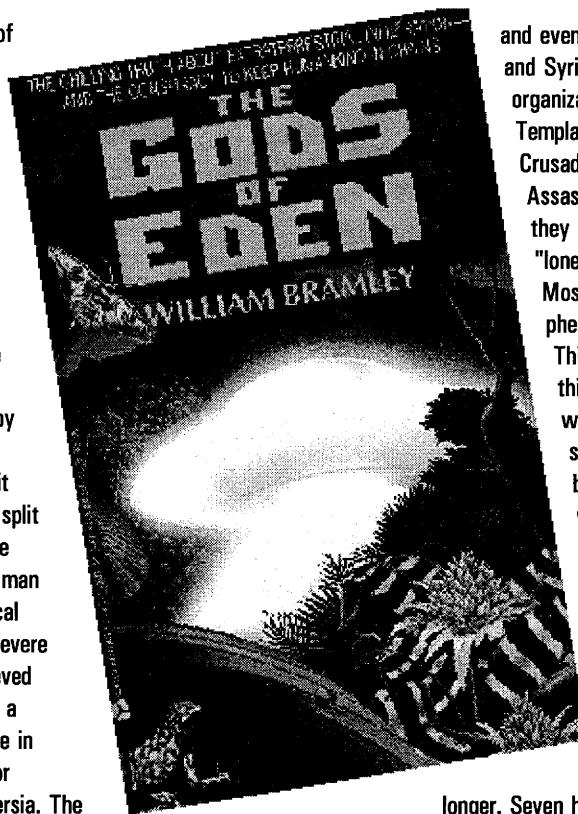
of Iran for the headquarters of his new group. This Assassin fortress was known as "Alamut," which means "Eagle's Teaching" or "Eagle's Nest." The Assassins became a formidable military and political power in the region

and eventually controlled other fortresses in Persia and Syria. The Assassins feuded with other Moslem organizations and fought against the Knights Templar and other Christian armies during the Crusades. To help win its feuds and wars, the Assassins developed the deadly tool for which they became famous and feared: the tool of the, "lone assassin."

Most people today are painfully aware of the phenomenon of the so-called "lone assassin." This is usually a young man in his twenties or thirties who is driven by crazed delusions and who displays little or no concern for his own safety as he murders an important leader in broad daylight, in public, and in front of witnesses. The killing has tremendous shock value and it can greatly affect the political direction of a nation. Many people believe that so-called "lone assassins" are products of our modern age. It is quite amusing to read ponderous psychiatric tomes to that effect. In truth, the "lone assassin" has been a political institution for over seven hundred years, if not

longer. Seven hundred years ago, however, no pretense was made that the "lone assassins" acted alone, as is done today. Back then, the "lone assassin" was known to

be an effective and terrifying tool of political and social control. It was a technique used by the Assassin organization to win its wars, increase its political influence, destroy its enemies, and enlarge its coffers by extortion. How did the Assassin sect get young men to commit the murders? It is not easy to make people kill others, especially when the murderer is likely to be caught and slain himself. The Assassin organization had an effective method for overcoming this natural resistance and programming young men to kill. One of the earliest people to describe the Assassin programming technique was Marco Polo, the famous European traveler of the 13th century who wrote a bestselling book about his journeys. Although Mr. Polo was accused by a few people in his own time of fabricating stories, subsequent investigation has verified nearly everything he described in his famous book. According to Mr. Polo, a portion of the Assassin fortress in Alamut had been converted into a beautiful secret garden fashioned after the paradise described in Mohammed's visions of Heaven. The garden grew almost every imaginable type of fruit and was watered with streams of wine, milk, and honey. The palaces were beautifully ornamented and had a company of singers, dancers, and musicians. If certain young men in the region showed promise as potential murderers, they were drugged, usually with opium or hashish, and taken to the secret garden. There

they were pampered for a few days and nothing was denied them, including women. They were then drugged again and returned to their homes. The young men believed that Assassin leaders had transported them to Heaven and back. Eager to return the young men would gladly follow the instructions of their Assassin leaders. The heaven-struck underlings were often told that a return to paradise lay in boldly assassinating a targeted enemy leader. The young assassin was instructed to wait in a public place and strike down the victim with a dagger as the victim passed by. Because the young assassins would often be killed on the spot or be later executed, they were made to believe that their death at the scene of the crime or by later execution would result in a return to the paradise they remembered.

The notoriety of the Assassins spread. It was rumored that some European kings were paying tribute to the Assassins to avoid becoming targets. Although the extent of Assassin activity in Europe is still debated today (some historians assert that the Assassins focused most of their deadly practices on the conflicts going on in the Middle East), the Assassins became famous far and wide. As a result, all people who attempt the murder of a political leader have come to be known as "assassins," or "users of hashish." Although most modern "assassins" have not been hashish users, many have shown evidence of considerable mental tampering. By the end of the 13th century, the Mongols had overrun the Middle East and had destroyed major Assassin strongholds. Interestingly, the Mongols were also inspired by mystical beliefs. The Assassins managed to survive the onslaught, and they exist today. Modern Assassin sects are reported to be peaceably settled in India, Iran, and Syria. Their titular head is the "Aga Khan," who is the spiritual leader of all Ismailians worldwide.

The Ismailians are estimated to number about 20 million people today. As of 1840, the Aga Khans have been operating out of India because of an unsuccessful rebellion in 1838 of Aga Khan I against the Persian Shah. When the rebellion failed, Britain offered sanctuary to the Aga Khan in India, which was then under British rule. Since then, the Aga Khans have been traveling in elite circles of Western society. Recent Aga Khans have received educations at Oxford, Harvard, and in Switzerland. The Aga Khans have also gained a place in the international banking community through their establishment of a central bank in Damascus, Lebanon.

It may be a coincidence that the "lone assassin" arose as an important phenomenon in the United States at just about the time that Aga Khan I was establishing a relationship with the British in the early 19th century. The first known "lone assassin" to strike a U.S. President did so in 1835. The intended victim was Andrew Jackson who was, interestingly, a member of a Knights Templar organization in America. Since then, U.S. Presidents have been the targets of "lone assassins" every ten to twenty years. Many other Western leaders and public figures have also been victims. Although I have seen no evidence that the Assassin sect itself is behind modern "lone assassin" episodes, it is clear that their technique has been picked up and used by influential political sources with Brotherhood connections in the Western world . . .

Behind today's political factionalism we continue to find evidence of

direct Brotherhood network involvement (although I have no evidence that the Brotherhood groups or religions discussed in this or the next paragraph are directly involved in the "lone assassin" technique). The Sovereign Military Order of Malta (SMOM), for example, was strongly anti-Communist and instilled anti-Communism in its adherents as a spiritual goal. There is nothing wrong with that until it becomes another justification to breed more violence, oppression and strife. One of SMOM's Knights in America, the late William Casey, headed the American CIA from January 28, 1981 until January 29, 1987. During his tenure as CIA chief, Casey did much to increase CIA covert operations, especially in Central America. There, CIA-backed Contra rebels and right wing "death squads" committed horrible atrocities against civilians in the name of fighting communism. Other SMOM Knights in national intelligence organizations have included James Buckley of Radio Free Europe/Radio Liberty, John McCone (former director of the CIA under President John Kennedy), and Alexandre de Marenches (chief of French Intelligence under President Giscard

d'Estaing, who was also an SMOM Knight).

The American CIA is also influenced by Mormonism, Freemasonry, and other lesser known Brotherhood organizations. Mormons are often sought by CIA recruiters due to the overseas experience many Mormons receive in their missionary work, and a few have reached very high positions within the American intelligence community. Some Masonic groups provide special scholarship for young members to attend the Foreign Service School in Washington, D.C. That school provides the nation with many of its State Department personnel, diplomats and spies. All of these Brotherhood influences have combined to create an ideological hotbed

in American foreign policy. The result has been the maintenance of the United States as an effective political faction for keeping conflict alive around the world. "Lone assassins" continue to be significant today. The substantial "conspiracy" evidence surrounding modern-day assassinations indicates that such killings continue to be crude political weapons. The primary difference today is that some "lone assassins" appear to be a cover for a second hidden assassin, and a pretense is made that the "lone assassin" really did act alone. In all other important respects, modern "lone assassins" are nearly identical to those programmed by the Brotherhood's organization centuries ago in the Middle East . . .

A significant element of nearly all recent "lone assassin" cases is the mental state of the "lone assassin" at the time of the assassination. The apparent "mental illness" exhibited by so many of them may very well be evidence of mental tampering. Sirhan Sirhan was known to have been repeatedly hypnotized by "friends" whom the police inadequately investigated.

Eyewitnesses reported that Sirhan seemed to be almost in a trance on the night he fired at Robert Kennedy. John Hinckley, Jr. had a great deal of psychiatric intervention during his pre-assassination days, and we still do not know what all of it consisted of. Did Hinckley receive any visionary implants similar to the ones that Adolf Hitler had received as a psychiatric patient at Pasewalk? Like the ancient assassins of Persia,

Hinckley was motivated by a crazed notion that he would attain to heaven by killing Reagan, except that Hinckley's heaven was the unattainable love of a certain female movie star. Hinckley thought that he would win that love by killing the President. The peculiar mental states of Mehmet Ali Agca and other modern assassins (such as "Squeaky" Fromme who tried to murder President Gerald Ford in 1975) are further indications that mental tampering may be a significant factor in most modern "lone assassin" episodes, just as it had been in medieval Persia.

In light of the above, it is perhaps not surprising to discover evidence of the Brotherhood network directly or indirectly linked to some modern assassinations. John Hinckley, Jr for example, belonged for a while to an American Nazi organization. Modern American Nazism, through such organizations as the Aryan Nations, is as deeply influenced by Brotherhood-style mysticism as was original German Nazism. "Squeaky" Fromme was a follower of Charles Manson, who preached a bizarre apocalyptic mysticism in a small California commune. Manson and his "Family" were the ones who committed the

horrific Tate-LaBianca murders in Los Angeles in 1969. Interestingly, Manson was once a police informer. As long as the "lone assassin" technique continues to go unopposed, those nations victimized by it will never rise above the level of a banana republic. That includes the United States and nations in Europe. One need only look at the way in which such assassinations have influenced the succession of American Presidents to appreciate just how damaging the technique is to a democracy. The problem with American leadership today is not so much a difficulty caused by the electoral process or by shortcomings in the Constitution. The problem is that the electoral process and Constitution have been severely undermined by the assassination of leaders and candidates. When police organizations contribute to this by ignoring and suppressing evidence, and by otherwise hindering proper investigations, those police organizations become accessories to the crimes in a very real and legal sense. That is when democracy dies. ●

At the bottom of the pyramid: An interview with U.K. conspiracy researcher Mary Seal

When did you first realize the enormity of the "secret agenda"?

My interest in conspiracy research started when I was 18, when I experienced a very clear daylight sighting of an UFO while sitting in the passenger seat of a stationary car. Following this incident I started seriously considering whether perhaps reality was in some manner entirely different than the way it is normally perceived. With this statement I do not wish to imply that UFO sightings are a paranormal event; I mean to state that our individually perceived reality model may simply be a false and engineered belief system, enforced on us as part of a conspiracy to control our free will. The UFO experience had been so psychologically powerful that it

triggered a determination to arrive at some truth behind this, and other officially denied, phenomena. I began reading a huge amount of books on seemingly unrelated topics: history, world religions, psychology, philosophy.

At some point I became aware of the many false historical facts which are currently being portrayed as classical truths, and of other less obvious inconsistencies and paradoxes, especially in the scientific disciplines. Very slowly, over the years, I accumulated a great deal of different evidence about various conspiracies which, at first, did not seem to be related. It was not until a few years ago that a picture started forming from all these facts, like a huge jigsaw puzzle.

Mary Seal is a conspiracy weaver, integrating strands of data and conjecture into a unique and dangerous tapestry. Unlike many conspiracy researchers, this former public relations officer will settle for nothing less than the Big Picture. A mainstay of the U.K. conspiracy scene, Mary and her partner Keith Mears organized the **First International Conference that Exposes a Global Deception** at Wembley stadium. The Conference featured speakers from both America and Europe and took place last January 9-10. English publishers appear to be too timid to accept her theories, and she is currently seeking a neutral and open-minded U.S. publisher to publish her manuscript. She may be reached at:

Has your research identified the origin of "flying saucers"?

Well, even though I was beginning to question many accepted paradigms, I made the initial mistake of allowing my own objectivity to be influenced, **without sufficient evidence**, by that UFO sighting. For quite a number of years I was under the mistaken assumption that those crafts must originate from an extraterrestrial source. This taught me an important lesson: never make an assumption about anything until all the facts are at hand.

The topic of UFOs tends to be treated as a separate issue in conspiracy research, but this is because there appear to be vested interests which aim to keep it isolated; however it is a very important facet of what is taking place. It is not until the various conspiracies are integrated and linked by other supporting evidence that one finds how perfectly everything fits together into the larger picture. I now believe I have sufficient evidence to show that UFOs are man-made terrestrial machines, capable of inter-dimensional travel and developed from secret technology. I am also convinced that the sightings reported worldwide form part of a huge global hoax, perpetrated with the sole intention of manipulating our belief systems.

I have accumulated a great deal of data which proves that mind control technologies are behind the genuine UFO-related abductions. Moreover, it is quite probable that the beings encountered during some of the physically real abductions are genetically engineered cloned beings, again utilizing secret technology.

Nonetheless, even accepting that all the rumors regarding crashed alien saucers are complete fabrications, I believe that the Roswell 1947 episode is the one truly outstanding occurrence . . . I do not, however, believe that extraterrestrials are visiting this planet.

Explain how conspiracies, like those involving UFOs, become entangled with other events.

First of all, I do not believe there are conspiracies as such. I am convinced that there is a common thread running through all the major events that have happened during the past 150 years (at least) and that this common thread is a manipulative one, working to a secret agenda and having a

specific goal. I do not think many conspiracy researchers are able at present to even remotely guess at the real goals being pursued through these manipulations, although quite a number of people are fairly close to part of the truth. This lack of knowledge has led many people to identify various conspiracies, such as the Kennedy assassination, as being isolated events and coverups which have nothing to do with any other anomalous happening.

The reality is that different conspiracies are simply various emerging tips of one single and huge iceberg. The reason it is relatively easy to ascribe certain events to a number of different conspiracies is that the hierarchy who have been and are pulling the strings behind all these happenings have contrived contingency plans to deal with any leaks of information. They have used other individuals and groups, willing to act as their shields, to carry out their plans. It is also probable that many others have unwittingly aided this hidden agenda by allowing themselves to be manipulated in exchange for money and power.

Also, consider that conspiracies have become a huge multi-billion dollar business worldwide, and that many researchers are making quite a good living from the sale of

books, journals, etc. Some of these researchers, unfortunately, are ignoring a great deal of important evidence which may not fit into their own particular theory.

Sometimes theories can be as dangerous as the conspiracy itself, and at the moment there abound more theories than facts. It is interesting to note that all these differing theories are based on the very same evidence which, as we know, has been circulating for decades. Quite a few researchers seem to be

picking around this so-called common pool of facts, selecting what suits them, then making it fit their own pet theory. I think a little discernment is needed.

What do you think of the mysterious crop circle phenomenon in England?

Crop circles have created even more theories and myths than the UFO phenomenon. These formations, and their tantalizing physical properties, have managed to mislead those scientists who have investigated the phenomenon, and have also deviated many researchers down seductive avenues leading nowhere.

My own research leads me to think that all of the crop circles which have appeared during the past two years are professionally executed hoaxes, utilizing microwave technology. However, I believe that the earlier crop circles, while originating from a microwave source, were the visible residue of some extremely serious experiments.

I believe that our planet is in a dangerous demise for reasons which are highly secretive, and that this demise is related in some manner to the energy matrix of the Earth. There are quite a few key energy centers in Britain. I also have reasons to believe that an artificial interference or maybe a downloading of some sort of energy was undertaken, resulting in those earlier crop (circle) formations; microwaves were utilized for the process, originating from geostationary satellites or helicopters and directed towards specific key sites.

If this is the case then, once finished with their task and having realized the enormous public interest shown in these formations, it may have been thought useful by those responsible to continue engineering these circles. The phenomenon would then further promote various belief systems useful to the manipulators.

Please detail exactly how the few elites manage to control the masses, and can you name any names?

A good analogy would be to liken the power structure that controls our planet to a global pyramid. At the very top there are less than 10 people, the majority of whom are completely unknown to the public. These individuals have the complete details of a secret Agenda which was worked out centuries ago and handed down through successive generations. The (aim) is total human control.

They are taking advantage of ancient occult sciences which have always been known to a select few individuals, and through this secret science they are able to manipulate us because of our ignorance.

This hierarchy controls, and perhaps intermingles with, the subsequent stratum of the power structure. Underneath these so-called elites there are no more than 200 individuals who have extremely important future roles to fulfill; some of them at present hold positions of very high office throughout the world. These people have been carefully chosen and maneuvered into their present position in certain key nations; this maneuvering and subsequent control of vital geographical locations has entailed decades of major and minor wars and huge political reshufflings. Needless to say these 200 or so individuals have managed to acquire an innocent and innocuous identity in the eyes of most people of the world, although some of them have been identified in their role by the more discerning researchers.

The next layer, controlled by the former, consists of various influential policymaking private groups and institutions, such as the Bilderberg, Council on Foreign Relations, Trilateral Commission, the Club of Rome, the Royal Institute for International Affairs, the United Nations, and so on.

Those making up the members of these groups include a small minority of the individuals from the 200 people mentioned above, whilst the bulk of the members hold key positions in Governments, the Military, the Intelligence community, the Media, Banking, Multinational Conglomerates, Education, University Boards, privately owned R&D Institutes, Law, and anything else which has policymaking powers, controls the

economy of the planet or influences public opinion.

These organizations control powerful institutions such as Stanford Research Center and Tavistock Institute for Human Relations and provide enormous funding for private R&D projects, as well as contributing financially and (in appearance) ideologically, to Environmental groups and movements (such as Friends of the Earth and Greenpeace), major

Religious movements, the World Council of Churches, Charities, the Arts, Labor-orientated organizations (such as Socialist International) and other legitimate-sounding causes. They are also responsible for the development of various governmental agencies, which they totally control.

They finance University Research grants, thereby controlling the scientific community; more importantly, they channel huge amounts of money into highly secretive black projects. The funding is derived from global drug trafficking which is policed and directed by some branches of the Secret Services, and is managed by the Mafia and other organized crime.

All of the individuals belonging to the former layers, and some of those belonging to the latter layer, also hold a very high degree status in a Secret Society or Freemasonry movement, in which a portion of the real Agenda would be discussed and various orders given. The Masonic movement has managed to twine its tentacles into most branches of society, from the very top to the most humble. It has taken the hierarchy at least 150 years to achieve this present position.

This type of pyramidal power structure ensures that orders from the very top manage to filter through and down to the very bottom without the majority involved being aware of the real and secret global working agenda, or

perhaps with just some of them being aware of a portion of its whole. It has to be understood that a great many people who play a part in this conspiracy do so without knowledge of the real goals behind it all.

From these major strata of the power structure there are in turn created a multitude of groups and organizations, all pursuing individual ideological goals, some of which entail strong elements of racism or religious and philosophical beliefs.

I have reasons to state that the majority of the people involved in these latter ideological groups are being manipulated through different and false ideologies and under the threat of some global demise, which may be quite legitimate, without being aware that they are contributing to an evil agenda.

The most perturbing and very real aspect of the conspiracy, and one which is largely ignored, involves an

international ring of Satanists, composed of influential public figures. These Satanic rings have been in existence for well over 100 years, and are working under direct orders from the top elites of this pyramid. Mars face mystery

The planet Mars has always held a certain fascination for us earthbound humans. Ancient societies attributed god-like qualities to our celestial neighbor. In later centuries, scientists peered through telescopes and wondered if other beings were peering back. Modern man, being more pragmatic, now considers Mars to be just another dead and inhospitable orb. Recent discoveries, however, suggest this wasn't always the case. There is tantalizing evidence that we may have too easily surrendered our sense of mystery about Mars.

In 1971 the NASA satellite Mariner 9 sent us many images of the Martian surface. Among the areas surveyed was the Elysium Quadrangle, photos of which seemed to show mountains with a distinctly pyramidal shape. This discovery led California-based scientist Dr. James J. Hurtak to comment that if they were truly pyramids, then we might someday find a Sphinx.

Five years later the twin satellites of the Viking mission began sending back more than 55,000 photos of the Martian surface. Within this vast portfolio was an image of Mars' Cydonia Region, designated Frame 35A72. The photo shows pyramids, like those from Elysium, and other artifacts which do not appear to be the work of natural forces. The most startling of these artifacts is an enormous face. At 1.6 miles long by 1.2 miles wide by 2,6000 feet high, this humanoid countenance has deep set eyes,

and a clearly delineated nose, mouth and chin. Carved onto the head is a representation of either hair or some kind of helmet.

It appeared as though Hurtak's "Sphinx" had been found.

NASA declared that the image was caused by erosion, and that any resemblance to unnatural structures was purely coincidental. This opinion was consistent with the NASA mindset. After all, the stated goal of the Viking mission had been to prove the absence of life on Mars. (Despite their own admission that the planet displayed historical evidence of massive water flow.)

However, two former NASA employees were not content with this "erosion" scenario.

Intrigued by the enigmatic face staring back at them from the surface of a foreign world, they wanted to see more. The two computer scientists, Vincent DiPietro and Gregory Molenaar, developed an image enhancement program called the Starburst Pixel Interleaving Technique (SPIT). Using SPIT, they determined that the face's deep eye sockets contain spherical eyeballs, and that its parted lips feature sculpted teeth. Most damaging to the official NASA "erosion" theory is that the Mars face is frontal and symmetrical, while most representations of faces in nature (simulacra) are usually in profile. Therefore, the odds

against erosion being the sculptor of the Cydonian face are astronomically high. Also, when we consider the fact that a second such face has been discovered in the Utopia region, these odds go higher still.

The total lack of interest displayed by NASA toward the Cydonian Face prompted researcher Richard Hoagland to form an investigative group, aptly named Mars Mission. The Mars Mission team has worked diligently to educate the general public, as well as their fellow scientists, that much evidence exists of an alien intelligence at

work on Mars. Scientists have always assumed that, if an alien race wanted to contact us, they would use universal symbolism, such as images and mathematics.

The face's deep eye sockets contain spherical eyeballs, and its parted lips feature sculpted teeth.

According to Hoagland, the Mars phenomena do, in fact, feature geometric patterns which repeat in a manner beyond the realm of chance. For example, the D&M Pyramid (named after DiPietro and Molenaar) is located seven miles from, and at a perfect right angle to, the Face. Furthermore, the D&M Pyramid is located at 40.868° north latitude, which happens to be the exact arc of tangent of e over π (e/π). The value e (2.72) is a constant logarithmic base used in both science and finance. π (3.14) is a constant used to find the circumference of a circle.

The formula "e over pi" is also the ratio of the surface of a sphere to the surface area of a tetrahedral pyramid when the points of the pyramid are touching the inside of the sphere. These points touch the sphere at a latitude of 19.5°. This 19.5 measurement occurs time after time when the D&M Pyramid is studied. According to Hoagland, this number is significant because, "On every major or minor planet we've mapped, the major geological disturbance lies on or about 19.5 degrees north or south."

The controversy and speculation surrounding these Martian mysteries must sound familiar to NASA's Russian counterparts. In July of 1988, they launched two probes to investigate the Martian moon Phobos, a moon whose peculiar orbital acceleration has lead some astronomers to speculate that it is hollow. The first probe, Phobos I, was lost en route. Phobos II did manage to send back images of the lunar surface, which Radio Moscow described as, "quite remarkable." The photos showed 20 to 25 kilometer-wide spindle shaped features which don't resemble any known geological formation. Another photo taken by Phobos II

shows a convex, cigar-shaped shadow being cast on the lunar surface by something in orbit beyond Phobos II. The last photo sent by Phobos II prior to its being struck by a meteorite (according to the official story) has never been released. It reportedly contains "sensitive information" which was presented to U.S. and British officials behind closed doors.

The Mars Observer was to perform the first detailed survey of the Cydonian region, home of the Face. Unfortunately, all signals from the craft were reportedly lost on August 23, 1993

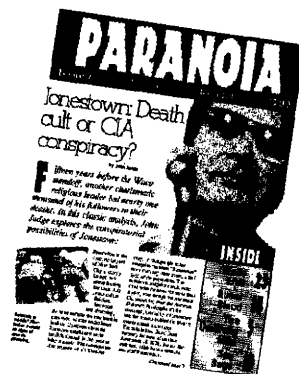

way the music business (strange as this may sound). I believe we have yet to hear the last of those extraordinary events which took place in the 1960s when a whole new generation of youth and drug culture was engineered; the so-called "Aquarian" conspiracy, related to the MK-Ultra LSD experiments, was the most far-reaching and in-depth social experiment ever carried out by the Intelligence Services. But the outcome is yet to be determined.

Part of the secret Agenda involves bringing about a very rapid and engineered shift of human consciousness which, if we are not extremely cautious, could be another complete hoax. Holographic science and advanced quantum physics are the disciplines involved in achieving this engineered shift of human consciousness, as well as the use of extremely sophisticated computer systems housed in part of the now debunked but very real Star Wars program.

American assassins are not mutants

The American Assassin is a different variety than history ever produced. This mongrel is not a pure breed nazi but the deformed and hideous baby produced from the marriage of nazi General Reinhard Gehlen and his mistress, Allen Dulles' CIA. It has taken a long time to recognize just what is different about this creation whose birth followed a quickie ceremony immediately after World War II.

The parents, who had helped finance Adolph Hitler's ascendancy, and the agencies still longing for revenge and war against most of mankind, changed their domicile but not their habits. The nursery moved from Germany into the United States and Jamaica. When the TV cameras turn their lenses away from the crowd or the hired man photographed with a weapon, the wide view screen will show the chambers of Washington, New York and Montreal where the real American Assassins shall be properly identified.

Europeans and Americans who find the explanation of our assassinations hard to grasp have not yet recognized the species. Every time we are ready to change domestic and foreign policies through the electoral process, the candidate who would effect a change gets smashed. If other parts of the world have their elaborate plots, none of them equal our murders, attempted murders or "accidents." Only one candidate gained from all this violence and that was Richard Nixon and Company.

Our American assassins, hired as decoys, are either killed or isolated in their cages. The "lone assassin" becomes an animal to be dissected by Pentagon social scientists and psychiatrists. Selected attorneys and privileged

biographers write their histories. Soon the puppet media and other "experts" pick up the lingo and pass along misinformation as facts . . . (Someday an entire book will be written about the part played by Time and Life in protecting conspirators. Their diversion away from evidence to alleged assassins' family life and personality served only to divert from the truth.) While this human being is turned into a patsy, . . . a group of cover agents manufacture what are supposed to have been his motives for becoming an assassin. That fictitious personality will be studied in order to become the model of assassins produced in America.

Creating the false motives for Lee Harvey Oswald's supposed killing of President John Kennedy was a project of ruthless individuals. Once his personality traits could be firmly established in our minds, it would then appear possible that Oswald actually killed somebody in Dallas. There was another purpose for creating a set pattern of personality traits to describe the assassin. This biographical profile would be used for future murders if other

candidates threatened the occupant of the White House or if it was time to kill the President again. If you believed the first time around that President Kennedy was killed by Lee Oswald, who was supposed to have been a "loner" and a "misfit," . . . and that he actually fired those amazing bullets in Dealey Plaza, you would buy the same story next time told in Los Angeles or Memphis.

Oswald supposedly inspired James Ray, alleged assassin of Martin Luther King, and Ray and Oswald would impress Sirhan Sirhan . . . Instead of using all methods of criminology to solve killings or accidents, a profile of assassins was created as a diversion from actual facts. The most important ingredient towards the success of concealing American conspiracies was to make the cover story sound good and repeat it so often that nobody followed up the source.

The Gehlen operation moved many of their agents, via Allen Dulles' CIA, into the Southwest long before John Kennedy was assassinated. Members of this close-knit emigre group in Texas that quickly adopted Marina Oswald as their own were part of a large espionage ring. When the Guns of November went off, thirty emigre canaries and a few Americans were singing for the news media and the Warren Commission. Nothing these people said about Oswald had any basis in fact and nobody questioned the source of their fabrications. There was no cross-examination of witnesses with

conflicting testimony; falsehoods were accepted without proof. The Warren Report then used this kind of testimony as the basis for concluding that Oswald was mentally capable of shooting John Kennedy, even though the rifle found behind some boxes was not. Allen Dulles thought it would be safe to print all the evidence and documents because "I don't think anybody would pay attention to it." That old spy master was wrong . . .

Oswald was not rejected by the society in which he lived. He received special favors in the Marines, being relieved of duty while meeting with secret persons. His discharge from the service was honorable and his entry ["defection"] from Helsinki into the USSR was speeded up in an "unusual hurry." Housing and finances in the USSR were superior to that of anyone around him and his Russian wife was later given speedy entry into the US. Lee and Marina stayed at the best hotels, were met by VIPs at the New York Harbor, and were driven in limousines. Oswald traveled in the USSR without passes, received an immediate US passport renewal [after his defection], and proved that with every gesture he made

somebody was catering to his wishes.

The unhappy marriage between Lee and Marina that the Warren Report uses as a motive for Oswald's behavior was actually no wedding at all. This union had all the appearances of a convenience between two espionage agents. Their engagement followed three public meetings and . . . no member of Marina's family attended the ceremony even though they were walking distance away. Three weeks before JFK and Lee Oswald were murdered, agent James Hosty of the FBI was offering Marina "protection" and told her she could remain in the US and "defect" from the USSR . . . It would be interesting to find out how the FBI takes over State Department decisions and makes such offers. Within a very short time, Marina was receiving protection and citizenship in the US and Lee Oswald was buried at Arlington Cemetery.

Allen Dulles, former Chief of the CIA, was removed from that agency by President Kennedy following the Bay of Pigs "invasion" of Cuba. John Foster Dulles and brother Allen had controlled the State Department's Cold War policies for eight long years. When newly-elected president John Kennedy

indicated that he was not taking orders from an invisible government, it was time for him to be assassinated. Lyndon Johnson then appointed Allen Dulles as a member of the commission to investigate JFK's murder . . . He set the tone for the investigation in the first meeting by suggesting that a certain compilation of personality traits ascribed to previous assassins would be seen in the present case . . .

This was one huge psychodrama where the stakes were high and the cover story had to hold all the loose pieces together. The total effect would be to sell for all time the profile of the assassin to explain the Dallas murders and any others that would follow . . . A "climate of violence" does not encourage or breed assassins. This excuse conceals the real assassins and allows plots and conspiracies to increase. When attention is focused away from "personality motives" our American Mutant will then be studied for what he is.●

MASS MURDER AS A MEANS OF MANIPULATING PUBLIC OPINION

In the political climate of December, 1989, an obvious motivation for programming a disposable assassin to murder women would have been to frighten and intimidate supporters of feminist movements, such as freedom of choice, and to frighten the public into supporting legislation that would ban semiautomatic weapons.

George C. Andrews has found four possible links between the CIA and Marc Lepine, the twenty-five year old mass murderer of fourteen female students at the Polytechnical College of Montreal on December 6, 1989:

- Lepine's father was employed with the Investors Overseas Services, a balloon that burst during the 1960s. Swindles of this nature [Savings and Loan, BCCI] are standard operating procedure for the CIA to raise money for its covert activities.

- Lepine's uncle was a former Canadian Forces paratrooper who trained with the U.S. Special Forces, an elite group integrated with the CIA. This uncle taught him how to use a gun.

- A "Big Brother" was provided to Marc at the age of fourteen by the Big Brother's Association after his parents divorced. This man, whose activities included extensive involvement with electronic gadgetry, suddenly disappeared when Marc was seventeen. Was this nebulous "surrogate father" a CIA monitor who initiated RHIC-EDOM? (This is the acronym for Radio Hypnotic Intracerebral Control - Electronic Dissolution of Memory, a mind control technique developed by the CIA, capable of programming an individual to carry out an act such as committing a murder while erasing all memory of that act).

- The Control Data Institute in Montreal, at which Marc Lepine enrolled in the Spring of 1988, is redolent of an Intelligence Agency front. It is a matter of public record that the CIA owns many businesses in different countries with similar names and functions.

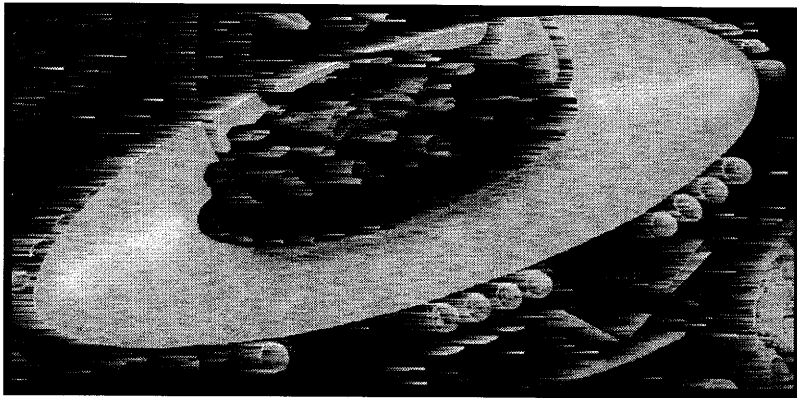
Andrews provides the following scenario for consideration. Two

months after enrolling at Control Data Institute, Lepine moved out of the apartment he had lived in for two years, indicating that he was "going off to join the armed forces." Had he been given reason to think that a career had opened up for him as an Intelligence Agent? . . . Lepine inexplicably dropped out of school, applied for a firearms acquisition certificate and bought a semiautomatic weapon. The first sentence of the suicide note he wrote days before committing the mass murders states: "I will die on December 6, 1989." Can we take this flatly factual statement to reflect the activation of RHIC-EDOM conditioning?

Andrews figures that the CIA's main motive for arranging the Montreal massacre would have been similar to its motive for arranging the Stockton, California schoolyard massacre of January 17, 1989, [and, we ask, countless other assassinations and mass murders?] perpetrated by "lone young drifter" Patrick Hurdy: to frighten the public into supporting legislation banning semiautomatic weapons.

Andrews closes with a warning that not only was FEMA (Federal Emergency Management Agency) set up to coordinate relief following natural disasters or nuclear war, but it is also responsible for managing response to rioting, terrorism and armed insurrection. This agency has been fused with Emergency Preparedness Canada, so that a State of Emergency in Canada would be declared within hours of such a proclamation in America. He warns: "When the President goes on TV to proclaim a State of Emergency, civil law based on the Constitution is to be replaced by martial law and police will be replaced by the black-uniformed Delta Forces, the resurrected Gestapo. The faceless FEMA replaces the President, allowing atrocities to be committed without anyone being held responsible. The concentration camps have already been built. Civilian resistance to the replacement of democracy by dictatorship will be far less effective if the citizens hand over their semiautomatic weapons before the state of emergency is declared."●

People in UFOs

UFOs, Psilocybin and
the New World Order

There is an extravaganza of UFO literature out there written from so many points of view it makes my head spin. This continuing article will compare, contrast and attempt to make some sense of these various theories. Presently, I will focus on a theory recently presented by Jay Katz in *Saucers of the Illuminati*, published by IllumiNet Press, along with alternative theories of William Bramley and Terrence McKenna.

The hypothesis put forth by Jay Katz in *Saucers of the Illuminati* is that covert mind control has come-a-long-way-baby since the fifties, and that UFO sightings and abductions are medically implanted or auto-suggested memories which mask real events of terrestrial origin. In other words, the "aliens" in these "saucers" are government/military/science personnel, and joy rides take place in dark vans which do not leave the ground at all. Furthermore, this author proposes that the symbols described by witnesses on these vehicles and on the "spacesuits" their occupants wear, as well as the symbolic nature of some abduction scenarios, seem to implicate modern secret societies which stem from the Illuminati of the 1700s. This is the secret government which runs Planet Earth.

The bad news is the world gameboard is being set up, and these pranks have something to do with the programming and dehumanization necessary for a jolly-good-New World Order. The good news is, with Armageddon just around the corner, we don't have too long to ponder the sinister motives behind these celestial proctologists and what starbase they call home. We'll know soon enough.

Jay Katz offers a compendium of information regarding such varied topics as time travel experiments, secret Soviet technology, the New World Order, experimental LSD trials of the sixties, the occult connection to UFOs and the odd disinformation campaigns carried out by "ex-CIA agents." He makes connections between

groups like the CIA, KGB, the Warren Commission, Masons, Cecil Rhodes' Round Table and its offshoots the CFR, Trilateral Commission, Bilderbergers and Yale Skull and Bones. This book is, in itself, an indispensable bibliography and Who's Who in the covert manipulation of political life on Planet Earth. It is a tome on peculiar connections between persons and groups whose relationships should be seen as

conspiratorial in nature, since they do not otherwise make sense. People who scoff at conspiracy theory would do well to ponder the meaning or purpose of meetings between such bizarre bedfellows.

One of the stark realizations Jay Katz brings to fore is the fact of an international covert intelligence organization through which certain separate organizations secretly hold hands and, apparently, other body parts. Since the thirties, this group has been infiltrated by a bizarre occult-drugs-bisexual element which continues to influence covert groups today. This brings to mind the crazed, drug-induced sex scene in Oliver Stone's JFK film, and a horrid vision of Jay Edgar Hoover dressed in drag.

An example of one of these tentacled beasts is the sixties-occult-LSD-Masonic-spy

connection wherein magician Aleister Crowley, as an international spy playing both sides in World War I, together with Rudolph Steiner, was involved in Freemasonic subversive activities which pre-empted or prompted the Bolshevik Revolution. Katz further states that secret meetings took place later in 1952 between CIA director Allen Dulles and others which planned and funded experimental LSD trials years before its purported discovery by Dr. Hoffman, and that the acid-missionaries of the sixties like Timothy Leary, Ken Kesey and Gregory Bateson were furnished by occultist Aldous Huxley. This covert mass trial of an experimental Peace Pill turns out to be associated with British Intelligence.

If we accept Terrence McKenna's belief (presented in *Archaic Revival*) that hallucinogens actually put people in contact

with other-dimensional reality, the occult-LSD connection would be established at right around the time when saucer sightings increased and were reportedly chased by our aircraft.

Some ufologists claim that magic rituals of Aleister Crowley, involving hallucinogens, opened the portals to our dimension inviting a panoply of lost souls, including spacemen.

In fact, he claimed to be in contact with an alien being called Lam. But humans were eating psilocybin mushrooms a long time ago and, as McKenna believes, this is the food of the Gods which allows humans to communicate on a higher plane. The psilocybin mushroom is found very suddenly in the fossil record of early man and may be "alien" in nature.

McKenna is probably the person closest to

understanding the UFO enigma, since this job requires an iconoclast who is thinking in Otherworldly terms; someone wearing a psilocybin thinking cap. He sees UFOs and aliens as a sign of the coming total transformation of the human mind and suggests that these perceptions may represent the cataclysmic end of the universe which is sending ripples back through time. Note the similar shape of his "holy trinity": mushroom, flying saucer and atomic explosion.

The problem I see with the UFO's terrestrial origin thesis is the late date of this collusion between secret societies, extraterrestrials and hallucinogens. Jay Katz gives secret societies a three-dimensional, terrestrial birth date of a mere few hundred years. His analysis becomes sort of one-dimensional given his inability to transcend this thinking. Perhaps flying saucers were seen on a wide scale beginning in the late forties, around the time that Wilhelm Reich was doing his cloud-busting, Crowley was doing his evil deeds and the first reverberations of the atomic bomb sent out a cosmic alert that those damn monkeys are playing with fire. However, was this the first recorded appearance of flying machines from other worlds? Not really. The Bible is full of them. So are legends of ancient Egypt and the myths of American Indians.

An alternative thesis is presented by William Bramley in *Gods of Eden* (Avon

Books). Bramley gives biblical history a new twist with Satan as an outcast ET who formed the first secret society, which Bramley calls the Brotherhood organization, a clandestine group feuding with the status quo since ancient times. William Bramley opens the portal into a new global history where our own ancestral extraterrestriality merges with the Brotherhood.

According to Bramley, the birth of secret societies converges with the creation of humankind. Paradise on Earth ended with the apeman's sighting of the Gods from the Sky, and with the gift of language we became like the Gods. (Was this gift simply the seeding of the Earth with the spores of the psilocybin mushroom?)

This concept is by no means unique in the UFO literature. Many books even claim that an alien being was sent to Earth 2,000 years ago to teach humankind a doctrine of love and non-violence. We were also introduced to the idea of Gods in spaceships when we watched the movie *2001: A Space Odyssey*, but the treatment was so esoteric as to be pure

entertainment. Mr. Bramley is dead serious and this is an amazing paperback. The concept of accidental history becomes a cosmic laughing stock in light of Bramley's version of the history of the Earth. Our myths turn out to contain more intrinsic truth than do our history books. The idea of free will is obliterated. The existential torch which Darwinism hands to humans is blown out in light of the fanagling of earthling DNA by cosmic travelers, making the most of Cro-magnon's animal existence.

In the last analysis, aliens or no aliens, through secret advanced technology in brain implants and radio-mind control, and covert corruption

and usurpation of top levels of world government, the Earth's Overlords (members of secret societies such as Skull and Bones, Knights of Malta, even the Trilats and Bilderbergers) have designed a warped plan to make it easy for the chosen few to control the minds of the many. An international billionaire banking elite, made up of a few of the Earth's wealthiest families, has put the world in an intractable collision course toward total financial ruin by stockpiling the real physical wealth of the planet — oil, gold, diamonds — and substituting it for paper money which will soon be worth diddley-squat. Double Crossed

Marilyn Monroe was more likely than not assassinated by a poison pellet inserted into her rectum by a gang of Chicago Mafia hit men in collusion with the CIA, asserts Sam "Mooney" Giancana's brother and godson, also named Sam, in the terrifyingly accurate account of Mob-CIA collusion, *Double Cross*.

Of all accounts of Monroe's death, this is the most accurate. Despite her "marriage" to long suffering baseball player Joe DiMaggio, Monroe kept up a long-standing dalliance with Jack Kennedy and, at the end of her life, with Bobby Kennedy. She was notoriously unstable and promiscuous in her relations with men and had many husbands and lovers.

Monroe was a heavy drug user, imbibing all sorts of potions cooked up by her two pusher quack shrinks Dr. Hyman Engelberg and Dr. Ralph Greenson. After administering narcotics by enema (her recreational and ostensibly medical habit) she was usually heavily sedated. Due to her drug habit, her motion picture company had hinted at wanting to fire her. Nevertheless, she was never so despondent that she had ever indicated to friends that she wanted to kill herself.

JFK carried on with her for many years, then indicated that he wanted to dump her. Bobby picked up where his brother left off, if only briefly. Both eventually dumped Marilyn who, in a fit of rage on August 4, 1962, threatened to go to the press with all she knew about the cuckolding Kennedys. The executive branch got wind of Marilyn's temper tantrum and a hit order was put in motion. The CIA contacted the Chicago Mob, and Mooney dispatched Needles Gianola and four henchmen to Los Angeles for the hit.

Bobby arrived on the afternoon of August 4, 1962 with a doctor who gained entry and administered

a sedative to Monroe, who purportedly conked out at about 8:00 p.m. by "doctors orders." She did, however, have a chance to make a phone call to fellow rat-packer Peter Lawford; she drawled in a drugged-out typically breathy voice the weird premonition of her impending death: "say goodbye to Pat (Lawford's wife), say goodbye to Jack and say goodbye to yourself because you're

such a nice guy." Mooney's boys were notified by unknown sources (Bobby? the CIA?) that Monroe was an easy target. They gained entrance by bribing a co-conspirator, housekeeper

Eunice Murray. The four assassins held Monroe down while Needles inserted a specially doctored tablet into her rectum. This concoction and the barbiturates already in her system killed her. Housekeeper Eunice Murray was found later by a non-plussed LA detective calmly laundering Monroes' bed sheets (evidence). Some conspiracy theorists claim that the Mob-CIA crew had bugged the house previous to their entry so they had the "inside dope" on both Kennedy's and Monroe's dalliances.

How do we know the suicide story was not true? Simple. No traces of barbiturates were found in Monroe's digestive organs by Coroner Thomas Noguchi, and her blood level did not contain anywhere near the level of barbiturates needed to kill an adult woman. Furthermore, the body was found in a neatly organized manner whereas most suicides by overdose are found sprawled.

Also, Eunice Murray's story did not make sense. Nobody could have gained entrance to Monroe's bedroom in the manner that the hoaxers described. It is curious also that Monroe could not lock her bedroom door from the inside, and that housekeeper Murray could never have detected a light emanating from under Monroe's door, as she claimed, due to the



bedroom carpeting.

In addition, Monroe died much earlier than when Eunice Murray purportedly found her body at 3:30 a.m. on August 5, 1962. The ambulance crew maintained that the body was in advanced stages of rigor mortis when they arrived, indicating that Monroe died at approximately 9:00 p.m. the previous night.

All evidence like telephone records, personal papers, diary and other personal effects disappeared. The LAPD and the FBI naturally clammed-up. Mooney's boys scooted back to hell and the Kennedy's pristine reputations were upheld.

To this day, Joe DiMaggio places fresh flowers on Marilyn's grave every week. Although the CIA-Mob-JFK-RFK connection actually carried out the whack, it was her "doctors" Hyman Engelberg and Ralph Greenson who made her so dependent on narcotics and psychological care that it could well be argued that Marilyn Monroe was "psyched to death." ●

What was Jonestown?

According to one story, Jim Jones was seeking a place on earth that would survive the effects of nuclear war, relying on an article in *Esquire* magazine for his list. The real reason for his locations in Brazil, California, Guyana and elsewhere deserve more scrutiny. At one point, Jones wanted to set up in Grenada, and he invited Prime Minister Sir Eric Gairy to visit his Peoples Temple in San Francisco. He invested \$200,000 in the Grenada National Bank in 1977 to pave the way, and some \$76,000 was still there after the massacre.

His final choice, the Matthew's Ridge section in Guyana is an interesting one. It was originally the site of a Union Carbide bauxite and manganese mine, and Jones used the dock they left behind. At an earlier point, it had been one of seven possible sites chosen for the relocation of the Jews after World War II. Plans to inhabit the jungles of Guyana's interior with cheap labor date back to 1919. Resources buried there are among the richest in the world, and include manganese, diamonds, gold, bauxite and uranium. Forbes Burnham, the Prime Minister, had participated in a scheme to repatriate Blacks from the UK to work in the area. Like all earlier attempts, it failed. Once chosen, the site was leased and worked on by a select crew of Temple members in preparation for the arrival of the body of the church. The work was done in cooperation with Burnham and the U.S. Embassy there.

But if these were idealists seeking a better life, their arrival in "Utopia" was a strange welcome. Piled into busses in San Francisco, they had driven to Florida. From there, Pan American charter planes delivered them to Guyana. When they arrived at the airport, the Blacks were taken off the plane bound and gagged. The deception had finally been stripped bare of all pretense. The Blacks were so isolated and controlled that neighbors as close as five miles from the site did not know that Blacks lived at Jonestown. The only public representatives seen in Guyana were white. Guyanese children were "bought," also. According to

survivors' reports, they entered a virtual slave labor camp. Worked for 16 to 18 hours daily, they were forced to live in cramped quarters on minimum rations, usually rice, bread and sometimes rancid meat. Kept on a schedule of physical and mental exhaustion, they were also forced to stay awake at night and listen to lectures by Jones. Threats and abuse became more common. The camp medical staff under Dr. Lawrence Schacht was known to perform painful suturing without anesthetics. They administered drugs, and kept daily medical records.

Infractions of the rules or disloyalty led to increasingly harsh punishments, including forced drugging, sensory isolation in an underground box, physical torture and public sexual rape and humiliation. Beatings and verbal abuse were commonplace. Only the special guards were treated humanely and fed decently. People with serious injuries were flown out, but few ever returned. Perhaps the motto at Jonestown should have been the same as the one at Auschwitz, developed by Larry Schacht's namesake, Dr. Hjalmar Schacht, the Nazi Minister of Economics, "Arbeit Macht Frei," or "Work Will Make You Free." Guyana even considered setting up an Auschwitz-like museum at the site, but abandoned the idea. By this point, Jones had amassed incredible wealth. Press estimates ranged from \$26 million to \$2 billion, including bank accounts, foreign investments and real estate. Accounts were set up worldwide by key members, often in the personal name of certain people in the Temple. Much of this money, listed

publicly after the massacre, disappeared mysteriously. It was a fortune far too large to have come from the membership alone. The receivership set up by the government settled on a total of \$10 million. Of especial interest were the Swiss bank accounts opened in Panama, the money taken from the camp, and the extensive investments in Barclay's Bank. Other sources of income included the German banking family of Lisa Philips Layton. Also, close to \$65,000 a month income was claimed to come from welfare and social security checks for 199 members, sent to the Temple followers and signed

over to Jones. In addition, there are indications that Blakey and other members were supplementing the Temple funds with international smuggling of guns and drugs. At one point, Charles Gary noted that Jones and his community were literally "sitting on a gold mine." Mineral distribution maps of Guyana suggest he was right.

To comprehend this well-financed, sinister operation, we must abandon the myth that this was a religious commune and study instead the history that led to its formation. Jonestown was an experiment, part of a 30-year program called MKULTRA, the CIA and military intelligence code name for mind control. A close study of senator Ervin's 1974 intelligence report, *Individual Rights and the Government's Role in Behavior Modification*, shows that these agencies had certain "target populations" in mind, for both individual and mass control. Blacks, women, prisoners, the elderly, the young, and inmates of psychiatric wards were selected as "potentially violent." There were plans in California at the time for a Center for the Study and Reduction of Violence, expanding on the horrific work of Dr. Jose Delgado, Drs. Mark and Ervin, and Dr. Jolyn West, experts in implantation, psychosurgery and tranquilizers. The guinea pigs were to be drawn from the ranks of the target populations, and taken to an isolated military missile base in the California foothills. Due to public pressures, the plans were abandoned in California.

The history of MKULTRA and its sister programs (ARTICHOKE, BLUEBIRD, etc.) records a combination of drugs, drug mixtures, electroshock and torture as methods for control. The desired results ranged from temporary and permanent amnesia, uninhabited confessions, and creation of second personalities, to programmed assassins and pre-conditioned suicidal urges. One goal was the ability to control mass populations, especially for cheap labor. Dr. Delgado told Congress that he hoped for a future where a technology would control workers in the field and troops at war with electronic remote signals. He found it hard to understand why people would complain about electrodes implanted in their brains to make them "both happy and productive."

In that same period, Jones began to move his Temple members to Jonestown. They were the exact population selected for the mind control tests. The meticulous daily notes and drug records kept by Larry Schacht disappeared, but other evidence did not. On the scene at Jonestown, Guyanese troops discovered a large cache of drugs, enough to drug the entire population of Georgetown, Guyana (well over 200,000) for more than a year. According to survivors, these were being used regularly "to control" a population of only 1,100

people. One footlocker contained 11,000 doses of thiazine, a dangerous tranquilizer. Drugs used in the testing for MKULTRA were found in abundance, including sodium pentathol (a truth serum), chloral hydrate (a hypnotic), demerol, thallium (confuses thinking), and many others. Schacht had supplies of halioparal and largatil, two other major tranquilizers as well. The actual description of life at Jonestown is that of a tightly run concentration camp, complete with medical and psychiatric experimentation. The stresses and isolation of the victims is typical of sophisticated brainwashing techniques. The drugs and special tortures add an additional experimental aspect to the horror. This more clearly explains the medical tags on the bodies, and why they

had to be removed. It also suggests an additional motive for frustrating any chemical autopsies, since these drugs would have been found in the systems of the dead.

The story of Jonestown is that of a gruesome experiment, not a religious utopian society. On the eve of the massacre, Forbes Burnham was reportedly converted to "born again" Christianity by members of the Full Gospel Christian Businessmen's Association, including Lionel Luckhoo, a Temple lawyer in Guyana. This same group, based in California, also reportedly converted Guatemalan dictator Rios Montt prior

to his massacres there, and they were in touch with Jim Jones in Ukiah. They also conducted the White House prayer breakfasts for Mr. Reagan.

With Ryan on his way to Jonestown, the seal of secrecy was broken. In a desperate attempt to test their conditioning methods, the Jonestown elite apparently tried to implement a real suicide drill. Clearly, it led to a revolt, and the majority of people fled, unaware that there were people waiting to catch them.

One too many Jonestowns

Strangely enough, almost every map of Guyana in the major press located Jonestown at a different place following the killings. One map even shows a second site in the area called "Johnstown." Perhaps there were multiple camps, and Leo Ryan was only shown the one they hoped he would see. In any case, the Jonestown model survives, and similar camps, and their sinister designs, show up in many places.

Inside Guyana itself, approximately 25 miles to the south of Matthew's Ridge, is a community called Hilltown, named after religious leader Rabbi Hill. Hill has also used the names Abraham Israel and Rabbi Emmanuel Washington. Hilltown, set up at about the same time as Jonestown, followed the departure of David Hill, as he was known in Cleveland, a fugitive of the U.S. courts. Hill rules with an "iron fist" over some 8,000 Black people from Guyana and America who believe they are the Lost Tribe of Israel and the real Hebrews

of Biblical prophecy. Used as strong arm troops, and “internal mercenaries” to insure Burnham’s election, as were Jonestown members, the Hilltown people were allowed to clear the Jonestown site of shoes and unused weapons, both in short supply in Guyana. Hill says his followers would gladly kill themselves at his command, but he would survive since, unlike Jones, he is “in control.”

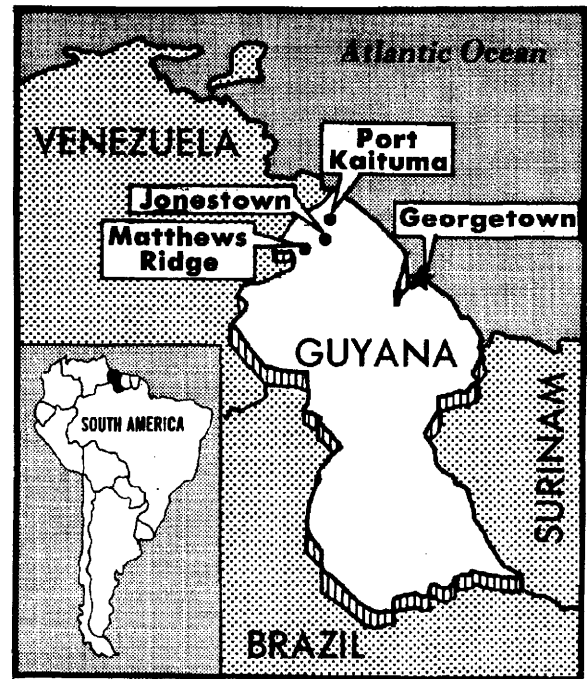
Similar camps were reported at the time in the Philippines. Perhaps the best known example is the fascist torture camp in Chile known as Colonia Dignidad. Also a religious cult built around a single individual, this one came from Germany to Chile in 1961. In both cases the camp was their “Agricultural Experiment” Sealed and protected by the dreaded Chilean DINA police, Colonia Dignidad serves as a torture chamber for political dissidents. To the Jonestown monstrosities, they have added dogs specially trained to attack human genitals. The operations there have included the heavy hand of decapitation specialist Michael Townley Welch, an American CIA agent, as well as reported visits by Nazi war criminals Dr. Josef Mengele and Martin Bormann. Currently, another such campsite exists at Pisagua, Chile. Temple member Jeannie Mills, now dead, reported having seen actual films of a Chilean torture camp while at Jonestown. The only source possible at the time was the Chilean fascists themselves.

In the current period, Jonestown is being “repopulated” with 100,000 Laotian Hmong people, many of whom grew opium for CIA money in Southeast Asia. Over 12,000 reside there already under a scheme designed by Billy Graham’s nephew, Ernest, and members of the Federation of Evangelical Ministries Association in Wheaton, Illinois (World Vision, World Medical Relief, Samaritan’s Purse, and Carl McIntyre’s International Council of Christian Churches). Similar plans devised by the Peace Corps included moving inner city Blacks from America to Jamaica, and other Third World countries. And World Relief attempted to move the population of the Island of Dominica to Jonestown. It is only a matter of time before another Jonestown will be exposed, perhaps leading again to massive slaughter.

Links to U.S. Intelligence Agencies

Our story so far has hinted at connections to U.S. intelligence, such as the long term friendship of Jones and CIA associate Dan Mitrione, but the ties are much more direct when a full picture of the operation is revealed. To start with, the history of Forbes Burnham’s rise to power in Guyana is fraught with the clear implication of a CIA coup d’etat to oust troublesome independent leader Cheddi Jagan. In addition, the press and other evidence indicated the presence of a CIA agent on the scene at the time of the massacre. This man, Richard Dwyer, was working as Deputy Chief of Mission for the U.S. Embassy in Guyana. Identified in *Who’s Who in the CIA*, he has been involved since 1959, and was last stationed in Martinique. Present at the camp site and the airport strip, his accounts were used by the State Department to confirm the death of Leo Ryan. At the massacre, Jones said, “Get Dwyer out of here” just before the killings began.

Other Embassy personnel, who knew the situation at Jonestown well, were also connected to intelligence work. U.S. Ambassador John Burke, who served in the CIA with Dwyer in Thailand, was an Embassy official described by Philip Agee as working for the CIA since 1963. A Reagan appointee to the CIA, he is still (1986) employed by the Agency, usually on State Department assignments. Burke tried to stop Ryan’s investigation. Also at the Embassy was

Chief Consular officer Richard McCoy, described as “close to Jones, who worked for military intelligence and was “on loan” from the Defense Department at the time of the massacre. According to a standard source, the Embassy in Georgetown housed the Georgetown CIA station. It now appears that the majority and perhaps all of the Embassy officials were CIA officers operating under State Department covers. Dan Webber, who was sent to the site of the massacre the day after, was also named as CIA.

Not only did the State Department conceal all reports of violations at Jonestown from Congressman Ryan, but the Embassy regularly provided Jones with copies of all Congressional inquiries under the Freedom of Information Act. Ryan had challenged the Agency’s overseas operations before, as a member of the House Committee responsible for oversight on intelligence. He was an author of the controversial Hughes-Ryan Amendment that would have required CIA disclosure in advance to the Congressional committee of all planned covert operations. The Amendment was defeated shortly after his death.

American intelligence agencies also have a sordid history of cooperative relations with Nazi war criminals and international fascism. In light of this, consider the curious ties of the family members of the top lieutenants to Jim

Jones. The Layton family is one example. Dr. Lawrence Layton was Chief of Chemical and Biological Warfare Research, at Dugway Proving Grounds in Utah, for many years, and later worked as Director of Missile and Satellite Development at the Navy Propellant Division, Indian Head, Maryland. His wife, Lisa had come from a rich German family; her father Hugo had represented I.G. Farben as a stockbroker. Her stories about hiding her Jewish past from her children for most of her life, and her parents' escape from a train heading for a Nazi concentration camp, seem shallow, as do Dr. Layton's Quaker religious beliefs. The same family sent money to Jonestown regularly.

Their daughter, Debbie, met and married George Philip Blakey in an exclusive private school in England. Blakey's parents have extensive stock holdings in Solvay Drugs, a division of the Nazi cartel I.G. Farben. He also contributed financially. Terri Buford's father, Admiral Charles T. Buford, worked with Navy Intelligence. In addition, Blakey was reportedly running mercenaries from Jonestown to CIA-backed UNITA forces in Angola. Maria Katsaris's father was a minister with the Greek Orthodox Church, a common conduit of CIA funding, and Maria claimed she had proof he was CIA. She was shot in the head, and her death was ruled a suicide, but at one point, Charles Beikman was charged with killing her. On their return to the United States, the "official" survivors were represented by attorney Joseph Blatchford, who had been named prior to that time in a scandal involving CIA infiltration of the Peace Corps.

Almost everywhere you look at Jonestown, U.S. intelligence and fascism rear their ugly heads. The connection of intelligence agencies to cults is nothing new. A simple but revealing example is the Unification Church, tied to both the Korean CIA (i.e., American CIA in Korea), and the international fascists network known as the World Anti-Communist League. The Moonies hosted the WACLs first international conference. What distinguished Jonestown was both the level of control and the openly sinister involvement. It was imperative that they cover their tracks. Maria Katsaris sent Michael Prokes, Tim Carter, and another guard out at the last minute with \$500,000 cash in a suitcase, and instructions for a drop point. Her note inside suggests the funds were destined for the Soviet Union. Prokes later shot himself at a San Francisco press conference, where he claimed to be an FBI informant. Others reported meetings with KGB agents and plans to move to Russia. This disinformation was part of a "red smear" to be used if they had to abandon the operation. The Soviet Union had no interest in the money and even less in

Jonestown. The cash was recovered by the Guyanese government.

Their hidden funding may include more intelligence links. A mysterious account in Panama, totaling nearly \$5 million dollars in the name of an "Association Pro Religiosa do San Pedro, S.A." was located. This unknown Religious Association of St. Peter was probably one of the twelve phony companies set up by Archbishop Paul Marcinkus to hide the illegal investments of Vatican funds through the scandal ridden Banco Ambrosiano. A few days after the story broke about the accounts, the President of Panama and most of the government resigned, Roberto Calvi of Banco

Ambrosiano was murdered, and the Jonestown account disappeared from public scrutiny and court record. The direct orders to cover up the cause of death came from the top levels of the American government. Zbigniew Brzezinski delegated to Robert Pastor, and he in turn ordered Lt. Col. Gordon Sumner, to strip the bodies of identity. Pastor is now Deputy Director of the CIA (1986). One can only wonder how many others tied to the Jonestown operation were similarly promoted. ●

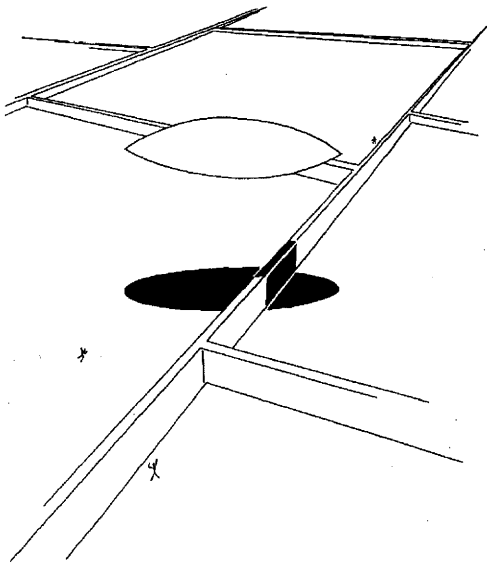

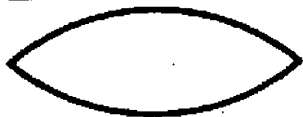

Hillary Clinton: New Age Jezebel?

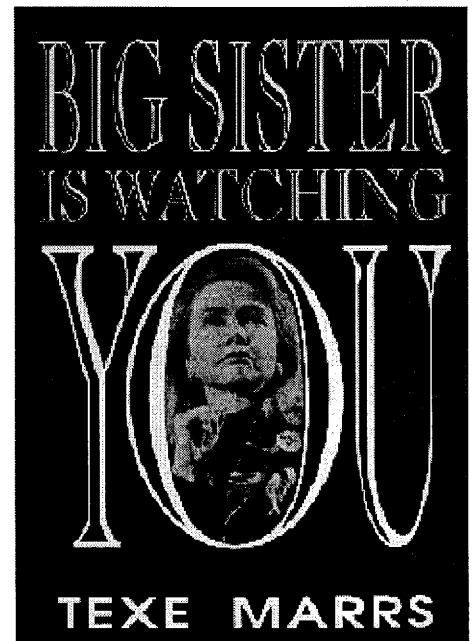

possible role in an illegal arms shipment to Iran in exchange for hostages. This incident later hooked up with the Iran-Contra Scandal.

There are certain political changes people could make in order to empower themselves and, obviously, those at the top don't want this. To make an issue or candidate unappealing to the majority the trick is to find the most obnoxious, perverted cretins to speak about these issues. An example of such a ploy is feminist Andrea Dworkin. CIA Agent Gloria Steinem helped found the organization Women Against Pornography, installing Andrea Dworkin as its head. Today, not only does Andrea Dworkin head Women Against Pornography, but she also writes books and gives lectures, making obnoxious statements like "all men think that all women are liars and sluts" and "when a man buys a woman a cup of

Satan seen in "Barney" video

Barney Assaulted

While making a Sunday morning appearance at a Texas K-Mart, the beloved Barney the Dinosaur was "harassed and punched" by four 10- to 15-year old boys. "They were trying to take his head off," explained a store spokesman. (USA Today)

In the last issue of **PARANOIA**, a reader questioned the eerie popularity of *Barney*, a mediocre PBS children's show. Now, a possible answer has emerged: A mommy saw Satan in a *Barney* video. A suburban St. Louis couple

purchased a videotape, *Barney's Birthday*, in June. Soon, their daughter began having nightmares. A few weeks later, the mother photographed her daughter watching the video. To her shock, the TV screen in the photo showed "what appears to be a demon with an upside down cross on its forehead," according to the St. Louis police chief.

The video went to the Motion Picture Association of America (MPAA) for testing. They determined that the tape had not been tampered with, but that the apparent satanic message was just "an accident." During one of the video dissolves from one image to another, the overlapping scenes created a temporary double image. The satanic image was simply a random, brief composite of two unrelated images.

But was it really an accident? The fact remains

that the video contains a satanic image, one which "cannot be seen during regular viewing," according to the police chief. Yet MPAA officials do not consider it to be a subliminal Satanic message. Even though the MPAA itself found another "demonic" scene during another dissolve on the same tape. "It showed Barney attacking a child," according to the chief, "But it's just a freak . . . Whether the devil caused that freak accident is open to interpretation."

Barney PR spin doctor Beth Ryan says that Barney has been cleared of any wrongdoing. She

assures parents that "we take a lot of care and time to make sure something like this doesn't happen." Which begs the question: Why do the creators of *Barney* tapes have to work so hard to keep Satanic messages out of their videos? Do they

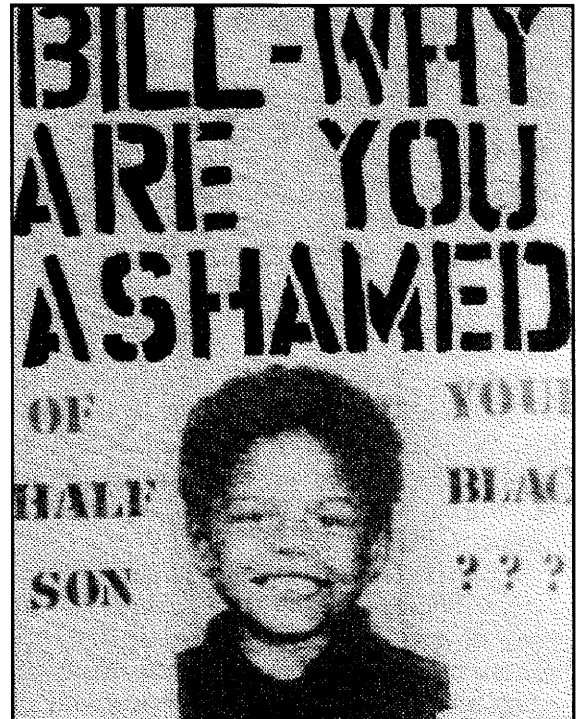
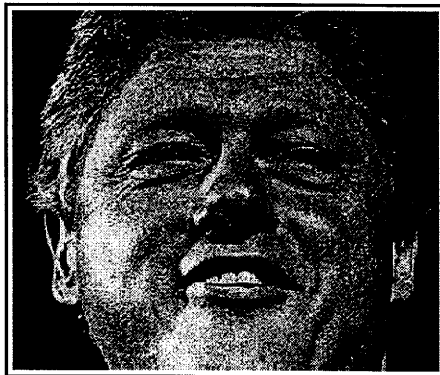

I recently listened to an audio tape about *Mind Control in America*, and now I feel a strange compulsion to tell you about it . . . The tape, the subject of the advertisement at right, presents an interesting overview of the persuasive techniques used in the media, politics, and academia. These techniques are often called "brain-washing" or "mind control," but I still question whether the techniques described (strategic repetition, subliminal messages etc.) have the degree of power that such terms imply. Nevertheless, this tape is a fun and educational listen.

Although you could buy a book that would provide more detailed information, the nature of the topic makes it particularly appropriate for an audio presentation. It's one thing to read about "backmasking" (the technique allegedly used by Satanic rock stars to embed subliminal

backward messages in their songs); it's quite another to actually hear that Aeorosmith/Run DMC's famous phrase "Walk this Way" does indeed sound like "Hail Satan" when played backwards.

The tape's creator, Steven Jacobson, even manages to discuss other conspiracy topics like the New World Order and the Trilateral Commission. But be warned. Things get kind of heavy-handed on side 2, which contains a seemingly incongruous religious message about God being the Answer etc.

In short, if you're the lazy type (or just curious) this tape will give you a quick and easily-absorbed overview of the subject of Mind Control.
