### Don't Go Near the Water

The New
Killer
Microbe
that May
Be in Your
Drinking
Water


new killer microbe is stalking America's rivers. This microscopic organism has been implicated in the death of billions of fish on the Eastern seaboard and poses a serious threat to the health of fishermen and other people exposed to these toxic waters.

Dubbed the "cell from hell," this one-celled nightmare was discovered a decade ago in fish tanks in an aquatic laboratory headed by fish pathologist Dr. Edward Noga at the North Carolina School of Veterinary Medicine. The microbe is not a bacterium or a virus, but has been identified as a dinoflagellate. Some species of dinoflagellates are better known as algae.

In recent years, toxic algae and dinoflagellates have caused an alarming increase in red tides in various parts of the world and have destroyed reefs throughout the Florida keys. One toxic flagellate is responsible for decimating the manatee population, an endangered aquatic mammal native to Florida.

Because the killer "dino" in Noga's fishtanks came from water taken from the Pamlico-Albemarle sound in North Carolina, it was not long before researchers suspected this microbe might be responsible for fish kills in Carolina rivers and estuaries.

A research team headed by botany professor Dr. JoAnn Burkholder at North Carolina State University has discovered this dino is unlike any other dino known to science in its ability to kill massive numbers of fish. It has an

unbelievably complex life cycle with at least 24 different forms and can enlarge from a tiny (7 micron) resting stage up to a much larger attacking organism measuring 450 microns in diameter. (A micron is 1/1000 of a millimeter.)

The new dino has been named *Pfiesteria piscicida* in honor of the late Dr. Lois Pfiester, a pioneer scientist who uncovered the life cycles of dinoflagellates. *Piscicida* is Latin for fish-killer. Further research now indicates this dino is not a plant, but an animal. Remarkably, *Pfiesteria piscicida* (pronounced Feast-eer-ee-ah, as in "cafeteria," and pis-ki-seed-ah) also produces a highly toxic and airborne toxin that has proven dangerous to researchers.

Burkholder and her research assistant Howard Glasgow, as well as a dozen other lab workers, have became seriously ill after contacting or inhaling the toxic fumes of *Pfiesteria*. Symptoms include the rapid onset of a drugged feeling ("narcosis"), breathing difficulty, headache and blurred vision, and neurologic symptoms such as acute short-term memory loss and severe cognitive impairment. For example, people ex-

posed to dino toxin have difficulty reading, remembering their name, and lose the ability to dial a phone number or to do simple arithmetic. During fish kills fisherman and bathers have experienced similar symptoms.

Burkholder told a *People* magazine interviewer that after hovering over a 10-gallon aquarium containing millions of these organisms, she inadvertently wiped her eyes with a gloved hand. Almost immediately she felt unsteady and her movements and thinking slowed. She was ill for the next eight days and felt her brain had stopped working. "I remember staring at the words of my computer but I couldn't put them into sentences. I couldn't even remember my phone number." Fortu-

nately, symptoms of *Pfiesteria* intoxication subside with time.

*Pfiesteria* lives on river bottoms in a small, cyst-like state. When schools of fish pass by, the dormant *Pfiesteria* become activated. Within minutes it transforms into a large complex organism that

laboratories that are isolated, quarantined, and limited-access facilities.

secretes the toxin that paralyzes fish. Simultaneously the dino developes a cellular extension which attaches to the flesh of the drugged fish, allowing the dino to literally suck the life out of its victim. Dr. Noga has discovered the dino's toxin causes a rapid drop in the white blood cell count, declining to 20% of normal within minutes, and producing what Noga calls "Fish AIDS."


Due to the dangers of dino research, all current research on *Pfiesteria* must be conducted in Biohazard Level III laboratories that are isolated, quarantined, and limited-access facilities. (The AIDS virus and the Ebola virus are studied in level IV labs.)

The dino is most active in warm months from June to October, coinciding with fish kills which have killed billions of fish over the past decade in the lower Neuse, the Tar-Pamlico, and the New River estuaries of North Carolina. In the early 1990s, more than a billion fish were killed in the Neuse River alone.

What is causing the buildup of this new killer in rivers along the East coast, extending from Delaware down to Florida and the Gulf of Mexico? Lab and field experiments show a connection with river pollution. Pfiesteria thrives in sewage and in water polluted by phosphate mines and by agricultural runoff, especially from hog and chicken farms. All this pollution delivers excess nutrients, such as nitrogen and phosphorus, which shift the ecological balance in ways that are unhealthy for humans but advantageous for microscopic life. Burkholder's research soon made waves in the media. Her outspoken views on *Pfiesteria* and water pollution, as well as their effects on the health of North Carolina's rivers, fish, and its citizens, began to ruffle feathers in high places.

The remarkable story of Burkholder's research and her struggle to educate the scientific and political establishments to recognize *Pfieisteria* as a serious health threat is recounted by Rodney Barker's, *And the Waters Turned to Blood* (Simon and Schuster, 1997).

In trying to alert people to the dangers of *Pfiesteria*, Burkholder encountered serious opposition designed to destroy her professionally, as well as personally. Various health officials and governmental experts proclaimed that *Pfiesteria* did not exist and was not the cause of fish kills. Nevertheless, biowarfare researchers expressed interest in her claim that *Pfiesteria* secreted a deadly toxin. According to Barker, one military researcher told Burkholder, "if what you say about short-term memory loss is true, can you imagine its value to biological warfare? We could hit people with that, and they wouldn't remember what happened."

Eventually the U.S. government took action. On September 29-30, 1997, the Centers for Disease Control sponsored a workshop on the health hazards of Pfiesteria piscicida. Attendees included representatives from the health departments of Delaware, Florida, Georgia, Maryland, North and South Carolina, Virginia, West Virginia, and the District of Columbia, as well as attendees from the U.S. Food and Drug Administration, the National Institutes of Health, The National Institute of Environmental Health Sciences, and the U.S. Environmental Agency. The health problems and neurologic disabilities of people exposed to the dino were discussed. And it was recommended that people avoid fish kill areas in rivers, and that fisherman wear protective gloves when handling diseased fish.

The emergence of toxic *Pfiesteria* from the polluted waters of America's rivers is a wake up call that should be taken seriously. Much research remains to be done, especially the further characterization of *Pfiesteria's* toxin. Burkholder's research is now online and multiple websites have been created to explore the ecological implications of the new "cell from hell."

No one knows how many aquatic Godzillas are now incubating in the polluted waters of the world. In the meantime, if you see a fish kill: Don't go near the water. ●

### Shamen In Army Boots

Remote Viewing: Human "Use" or Human "Potential"?

n much the same way that the CIA introduced the mindexpanding LSD experience into a closeted youth culture of the 1960s and 70s, the CIA has now introduced "remote viewing" into a mainstream culture totally unprepared for its potential repercussions on an "uninitiated" psyche. Remote viewing has become a tool of the masses, being extensively peddled on the internet with an "anyone can do it" attitude. Several businesses offer the services of a staff of trained remote viewers to perform various tasks, from locating missing persons or underground oil deposits, to other aspects of police, private, corporate or government investigative work.

These companies also offer expensive courses in various styles of remote viewing. On their own time, some of these RVers have been known to human-satellite the ancient cities of Mars, time-track the builders of the Earth pyramids, and zoom in on alien craft with extraterrestrial occupants.

The current fascination with the "tools of the mind" stems, at least in part, from the new physics revelation that the mind is cause rather than effect.(1) Thus, humanity's disposition has shifted from material effect to conscious cause, a concept known in New Age circles as "human potential." But, what's missing from the picture is our initiation into the culture of this knowledge, a life-long education which in ancient times went hand in hand with mystic revelation. The background of knowledge necessary to understand this philosophical shift is missing. We've got the power, but we don't know how to use it. The usurpation of this human potential by the secret government will become evident as the following story unfolds.

### **Remote Viewing: A Short History**

As a result of President Clinton's Executive Order #1995-4-17, issued on April 17, 1995, the CIA was obliged to declassify information pertaining to its funding of programs in parapsychological phenomena (psi) and, in particular, its interest in remote viewing. In July, 1995, 270 pages of reports pertaining to the remote viewing program at Stanford Research Institute (SRI) were declassified and released by the CIA. This was the first public disclosure of the government and intelligence community's two decade-long interest in psi phenomena.

In a paper entitled "CIA-Initiated Remote Viewing at Stanford Research Institute," Physicist Harold Puthoff, who managed the program, finally discusses it in detail. He writes: "it was not until 1995 that I found myself for the first time able to utter in a single sentence the connected acronyms CIA/SRI/RV." In this document, Puthoff reports on the results of the program and the direction the program took "as it expanded into a multi-year, multi-site, multi-million dollar effort to determine whether such phenomena as remote viewing might have any utility for intelligence collection." (2)

As Puthoff's story begins, in a casual 1972 meeting at SRI with psychic Ingo Swann, Puthoff had been impressed with Swann's remarkable ability to describe in detail the interior of a specific apparatus located in a vault below the floor of the building, which was shielded by several layers of various metals. Puthoff wrote up the

report and circulated it to a few of his colleagues to get some feedback. Within a few weeks, he was paid a visit by some 'men in black' who held his report in hand. According to Puthoff, the CIA agents told him the intelligence community was increasingly concerned about "the level of effort in Soviet parapsychology being funded by the Soviet security services." The agency was interested in meeting Ingo Swann. The "visitors," as Puthoff refers to them, put Swann through a series of simple experiments, the results of which were impressive enough to begin an 8-month pilot study. Puthoff asserts that, over the years, successful replication and back-andforth criticism of protocols yielded "considerable scientific evidence for the reality of the phenomenon."(3)

Several agencies began to contract studies at SRI beginning in 1973 and "a cadre of remote viewers" were added to the team. One client was NASA (SRI Project #2613, NASA contract #953653, NAS7-1000). The report, entitled "Development of Techniques to Enhance Man/Machine Communications," described in detail

"crude electronic means of screening for and training psychic perceptual abilities," as well as experiments using double-blind methodologies, which concluded that "talented remote viewers" could be "remarkably accurate" under "consistent protocols." (4)

The Final Report to the CIA, dated December 1, 1975, described various RV experiments carried out over the course of the pilot program, including the detailed drawing of a West Virginia sensitive government facility. Pat Price later viewed and described a Communist Bloc installation in the Urals, and in July of 1974, he drew in detail another research installation in Semipalatinsk, USSR. At the end of 1975, as the results of the pilot

phase of the RV program traversed government and intelligence circles, several agencies showed interest. According to Puthoff, the program was expanded to a "multi-client base," and was later integrated under single Defense Intelligence Agency leadership. (5)

Puthoff asserts that the RV program at SRI was directed not so much toward developing U.S. capability, but rather "toward assessing the potential threat of its use against the U.S. by others." In the early years of the program, Puthoff explains, the words "threat analysis" were often used. With regard to the physics of these unusual experiments, Puthoff concludes that, despite their inherent "ambiguities," the results appear to provide "unequivocal evidence of a human capacity to access

events remote in space and time, however falteringly, by some cognitive process not yet understood." He proposes that this fact be included in any attempt to define the "structure of reality."(6)

### **OBEs and Hypnosis**

Remote viewing, particularly in its deepest levels, can be seen as a type of "out-of-body" or "bilocation" experience. In his 1965 OBE studies, Charles Tart studied two frequent flyers, whom he called Mr. X and Miss Z.(7) In order to test whether OBE has a reality aspect, a 5-digit random number was written in large figures on a card-board strip and placed on a shelf. Once in the OBE state,

the subject was instructed to travel to the equipment room and try to memorize the string of numbers.

In one instance, Mr. X was able to float out of his cot and into the hallways. In another, he encountered several people and touched one of them. In yet another, he floated to another room to greet the technician and her husband, and was later

able to describe him in detail even though he had never met him. However, he failed to read the 5-digit number, most likely because he forgot that he was supposed to. During another OBE, Mr. X tried to take a short cut by following the EEG cable through the wall to the equipment room. But, instead of ending up in the equipment room, he ended up outside the building.

Tart concluded that OBE's are a mixture of dreams and "something else." The dream aspect is concluded from their "apparent conjunction with a Stage 1 EEG pattern." On the other hand, there was a fair amount of conjunction with reality, which suggested that ESP was occurring. He also noted that Mr. X's OBE's seemed to occur during a "prolonged, deliberately produced hypnogogic state." (Stage 1 EEG)(8) Another frequent flyer, Miss Z, awakened and correctly reported the target number located in the equipment room. She also stated that several OBE attempts had been necessary, since "I needed to go higher because

the number was lying down." Tart writes, the odds against guessing a 5-digit number by chance alone are 100,000 to 1.(9)

Subjects can also be hypnotized to have OBEs. In a 1970 UC Davis study, Tart selected a small group of individuals who were in the upper 10% of hypnotic susceptibility. The hypnotized subjects were instructed to bilocate, enter a locked room to observe target materials on the table, and describe what they saw. All of the subjects reported vivid and realistic OBEs. However, Tart reports,

none of their descriptions bore any clear resemblance to the targets. He writes, "a formal analysis was not worth the trouble."(10)

Are OBEs simply "lucid dreams"? Tart's conclusion, after decades of research, is that "in *some* OBEs, the mind may, at least partially, really be located elsewhere than the physical body." An OBE can also be a *simulation* of being out of the body, in the case of the hypnotized subjects. Tart concluded: "we can have OBEs which are basically a *simulation* of being out, but which are informed by information gathered by ESP such that the simulation of the OBE location is accurate and veridical." (11)

Our current model of consciousness, he concludes, is inadequate to describe these phenomena. We must realize, Tart explains, that the feeling that we are situated "in" our bodies or heads, is itself a construction, or "world simulation." He notes that ordinary consciousness may be a process "that creates an ongoing, dynamic simulation of reality, a world model, an inner theater of the mind, a bio-psychological virtual reality 'in' which consciousness dwells." Furthermore, most of the brain mechanisms which construct the dream world may just be the same mechanisms that construct our waking world. Ordinary reality, or what Tart termed in 1973 as

"consensus reality," is actually a complex construction, strongly determined by social consensus. (12)

### The Monroe Institute

The RV program at SRI was eventually moved to Fort Meade under the auspices of Major General Albert Stubblebine. Stubblebine began to send designated Army personnel to the Monroe Institute in Virginia for a "professional development" course creatively labelled "Rapid Advanced Personal Training," or RAPT, in order for the Army to pay the tab. The Monroe course became required training for all remote viewers.

Tart's "Mr. X" was Robert Monroe. Monroe began to have out-of-body experiences in 1956, and began his research in "sleep-learning" in 1958. In 1974, he founded the Monroe Institute in Lovingston, Virginia, which is reputed to have long-standing ties with the CIA. The primary area of research at the Monroe Institute is the use of their patented "HemiSync" tapes. This method involves use of a "binaural beat" to cause psychological effects. According to Tom Porter, the more radical research going on at the Monroe Institute "remains only tantalizing speculation." He has

noted that "official classified document storage boxes" have been seen at their mail order outlet.(13)

Monroe's high theta activity and occasional slowed alpha is similar to EEG states reported for advanced Zen masters during meditation. This state is also positively correlated with hypnotic susceptibility. In turn, highly hypnotizable people have been shown to exhibit "preternatural" skills, such as clairvoyance, psychokinesis and shamanic healing. Theatrical parlor tricks of the 1800s featured such talented "somnambules." A recent study conducted at No. AZ University using Monroe's Hemi-Sync binaural beat technology showed that HemiSync can increase hypnotic susceptibility in persons who had not previously been highly hypnotizable. A state of hypnogogia, associated with hyper-suggestive states of consciousness, is produced after minutes of exposure to the HemiSync signals. This paper also states that Robert Monroe "has been granted several patents for applications of psychophysical entrainment via sound patterns."(14)

The binaural beat-induced state of consciousness is described as "mind awake/body asleep." This common hypnogogic experience occurs naturally in the netherland between waking and sleeping and is characterized by an oblivion to location of extremities (hands and feet) without losing consciousness (i.e., falling asleep). By using stereo headphones which emit a slightly different beat frequency in each ear, the difference in tone creates a brain wave on which the human brain easily "entrains." Some researchers disagree that the word "entrainment" is descriptive of how the HemiSync sound method works. Researchers claim that HemiSync safely guides the brain to enhance and synchronize itself at its own natural frequency. HemiSync produces "hemispheric communication," or synchronization of the two hemispheres of the brain, which has been shown to produce feelings of euphoria. Deep meditative states do the same thing naturally. The binaural beat can be embedded in music and has been utilized this way in studies of children with developmental disabilities. Another study in creativity demonstrated that the HemiSync tones caused "highly divergent thinking," i.e. subjects tended to think about matters far removed from the actual physical environment. (15)

Euphoria, creativity, and 'happy smiling people holding hands' is nice, except in situations where a state of alertness is warranted. Could this technology be used to produce a docile populace during a period of social crisis? Assuming consensus-reality to be the norm, what would be the impetus to attempt to induce "highly divergent thinking"? Also, since HemiSync increases hypnotic susceptibility, could this technology be used to *simulate* an out of body experience? Canadian researcher Dr. Michael Persinger has utilized the basic HemiSync method to simulate paranormal experiences, including

religious rapture and a distinct sense of presence, including alien presence. Persinger has also used "solenoids" to pass a magnetic pulse through the frontal lobes of the brain, magnetic coils used in psychiatry as a non-intrusive alternative to implantable electrodes for brain stimulation. As Susan Blackmore has written in the *New Scientist*, "by controlling the nature of the magnetic fields, causing them to simulate brain patterns, Persinger is able to stimulate strong emotions and hallucinations, including the illusion of touch and movement." The simulation of certain brain wave patterns is the method behind HemiSync.

### **Commandeering Dreams**

Researcher Alex Constantine has asserted that psychotronic devices using ELF (extremely low frequency) electromagnetic waves were being tested on the RV subjects at SRI. He alleges that the managers of the project "engaged in projecting words and images directly to the cranium." Previous studies at SRI in the processing and storage of sensory imagery have noted that "mental imaging bears a close resemblance to hologram projection." Constantine wonders whether the results of these studies were later tested under the misnomer "remote viewing." In addition, he notes that the medical oversight for these studies was provided by the infamous CIA mind control specialist, Dr. Louis Jolyon West, who is a specialist in "dissociative states." Constantine notes that years of covert CIA experimentation has left a legacy of multiple personalities. He asserts that the CIA can trigger such dissociative states remotely, and that such biotelemetric subjects routinely complain that their dreams are "commandeered,"(16)

Speaking of commandeering our dreams, while we were being told "plastics" was the wave of the future, the new physics of nonlocal consciousness was being "commandeered" by the secret government. The CIA began backing young geniuses, paying their physics educations, and pairing them up with UFO lounge-lizards at the Esalen Institute. Physicist Jack Sarfatti was visited by two men from Sandia Corporation as a child in the 1950s. He received a full scholarship to Cornell at age 17, and studied under the major figures in the Manhattan Project at Los Alamos. He spent time at the Esalen Institute in the early 70s.

Sarfatti suggests that Einstein's nonlocal connection can be used for communication. The idea of nonlocal communication involves receipt of telepathic messages from other times or other worlds. As a child, Sarfatti claims, he received a mysterious phone call claiming to be the voice of a conscious computer aboard a spacecraft. A distant "cold metallic voice" identified Sarfatti as "one of 400 bright receptive minds." He was told if he said "yes," he would "begin to link up with the others in twenty years." He said yes. The year was 1952.

Twenty years later, Sarfatti claims he was invited to SRI, and spent a seventeen-hour day there in the summer of 1973. This would put him smack dab in the middle of the SRI-RV experiments. He claimed he met Hal Puthoff there, as well as astronaut Edgar Mitchell. He also claims that Mitchell took part in telepathy experiments while in outer space. Notably, he states: "the relevance of the 1952 experience was triggered in my session with Brendan O Regan at SRI," ... but "the actual memory of the 1952 experience is still very vivid and has not at all changed."(17)

This story merely underscores the point that the new physics has not grown in a vacuum of social forces, but is inextricably tied to secret government experiments in parapsychology and, possibly, mind control. This is not to say the "human potential" does not exist, or that Jack Sarfatti is mistaken in his memory of this event. The potential ramifications are much more frightening than this simple explanation might offer. What if this human potential does exist, and the secret government is trying to usurp and control it for psychic warfare purposes? What if this human potential does not exist, and we are being manipulated for mind control purposes? Or what if it does exist and it is being technologically cultivated? In any case, how is the ET question related? Is it real or is it Hemisync? Why is telepathy in humans being cultivated? Perhaps to better blend genetically with a telepathic ET race? Or, to be pitted against a hostile ET race? I will leave it up to the reader to imagine other potential reasons for the commandeering of the human mind. (see Ingo Swann, Penetration and the film, Dark City)

### Superpowers of the Human Bio-Mind

Ingo Swann is one of the most prolific authors involved in the remote viewing program. (18) Swann asserts that the label of mind control is ludicrous, and that the capacity to remote view is perfectly normal. He asserts, "there is nothing wrong with attempting to research our species' superpowers of the bio-mind, any more than there is anything wrong with attempting to research anything." Swann developed the protocol called "Coordinate Remote Viewing," or CRV, which makes use of geographical coordinates in order to "locate" the viewer in the "target." He explains, "now that the CIA is occupying itself with minimalizing and disowning remote viewing, there is no longer any reason to keep the substantive and technical matters from public view." A CRV manual has been posted on the net, but Swann denies that he wrote this manual. It does make use of his terminology.(19)

He suggests that the human species possesses what he calls "superpowers of the bio-mind," and considers remote viewing to be just one of these superpowers. Swann explains that the superpowers of the bio-mind have been well documented in transcultural lore and historical

documents of the last 5,000 years, and that remote viewing is a "species thing." He suspects that all humans are carriers of superpower potential, possibly manifesting in given individuals through the generations. (20)

Swann laments that an adequate frame of reference cannot be constructed within modern, Western categories of knowledge. The best way to describe superpowers of the bio-mind is by analogy to computer systems as a "systemic net or grid of information-carrying processes." Remote viewing is a sort of "hacking" of the "information-bearing terminals of our species bio-mind," which is a very sophisticated "net". Each individual is one terminal in that net, but also carries within itself a total replica of that net; a "reproduction" down-loaded from the "species bio-mind net." Swann explains that the only thing in the way of all of us becoming "wired" into the hard drive of the species bio-mind are "installed mental software programs [social norms] which abort cognitive access to them."(21)

Swann also adapts the term "virtual reality" to describe the place where "the past, future and present meet in one big matrix in which anything and everything is possible." He asserts that the human mind is "wired into alternative realities, cross-dimensions and multidimensional awareness," a place which has also been referred to as the Universal Akashic Records.(22) Swann asserts that other nations are in the process of researching remote viewing, and he and others are concerned that this research will be used to 'enemy' advantage. Those who doubt the existence of a psychic Cold War should be aware that this stuff is being taken seriously on the power levels of the planet. Is this curious stance warranted? This is where the story gets curiouser and curiouser.

### The Scientology Connection

At the time of the SRI studies, Ingo Swann was a Scientologist at OT Level VII, the highest level achievable in the organization. He attributes his success to techniques he learned in Scientology. Swann presented a paper at the First International Congress on Psychotronic Research in Prague on the Scientology paradigm as a model for developing and exploring paranormal abilities. The paper was entitled, "Scientological Techniques: A Modern Paradigm for the Exploration of Consciousness and Psychic Integration."(23) Hal Puthoff was an OT III, and was married in the Scientology Church. Pat Price was an OT Level IV. There were reportedly fourteen Scientology "Clears" running around at SRI. Yet, among psi critics, Scientologists could never really be trusted to conduct psi experiments impartially, since "negative results were against their religion."(24)

According to Jon Atack, "for at least ten years, Puthoff and Swann owed allegiance to both the U.S. intelligence community and to Scientology." In 1982, ten years after

U.S. intelligence agencies first employed Scientology's psychic spies, he explains, Hubbard ranted about an attempted takeover of Scientology by one of the agencies employing Puthoff and Swann. At about this time, the mass exodus/cleansing of Scientology occurred, resulting in the founding of various Scientology offshoots and channeling groups. By 1984, he notes, Puthoff and Swann departed the Church to become involved with a "breakaway movement" called military intelligence. Shortly after, the Defense Intelligence Agency took over the new and expanded "Grill Flame" remote viewing project.(25)

Tracing the same time track, let's explore the possible genesis of Scientology itself. According to Peter Moon, in his appendix to *Montauk Revisited*, Hubbard studied "narcosynthesis" and hypnotic regression techniques while working for Naval Intelligence. Moon explains that Hubbard combined principles from this research along with "earlier studies" to formulate his Dianetics teachings, which Moon describes as "major regression therapy." Moon states that Hubbard also studied Aleister Crowley's work, but that Hubbard's techniques were very much his own. Moon connects Hubbard's role on Earth to two things: his involvement with Jack Parsons in the Babalon Working ritual [see Mike Culkin, this issue], and his "Wilson" heritage.

The Wilson clan, explains Scientologist L. Kin, is a family of highly-initiated Scottish Druids. It turns out that Hubbard's father, Harry Ross Hubbard, was a Wilson who had been adopted in America by the Hubbard family. Kin asserts that Hubbard "grew up in fairly elevated spiritual circles." Scientologists oppose the idea that Hubbard would have been working with either Parsons or Crowley, since he represented the antithesis to their type of magic. There are two opposing theories with regard to Babalon Working. Some believe Hubbard was a "black" magician and his agreement with Parsons was real, and others believe Hubbard was trying to shut down Parson's OTO Lodge. Crowley considered the Babalon Working ritual a "confidence scam," wherein Hubbard got away with Parson's girl, as well as his money. Parsons died in a violent explosion in his laboratory a few years later.

Was the Hubbard/Parson's "tryst" actually a deadly contest between a Druidic wizard and a Satanist? As Kin tells it, he once met a Druid who was a "solo auditor" in Scientology, who told him that the Druids believe Hubbard was "entrusted with the task of making Druidic knowledge available to mankind in popular language." Kin called an elder Druid to verify the story. The elder confirmed that Hubbard was born into a clan of magicians of the Druidic tradition, and received a Druidic education from late childhood on, lasting about fifteen years. He reiterated the Druidic belief that Hubbard was entrusted with the task of rendering Crowley powerless, since Crowley's form of black magic was considered evil to them. Hubbard's mission was "to rehabilitate Druidic knowledge in the eyes of the world." Hubbard was purportedly "excluded from Druidic circles after founding the Church of Scientology in 1954, since it is against policy to start a religion. (26)

Druidic philosophy encompasses the idea that the world is animate and ensouled. The Druidic apprehension of the world is as communion: the perceiver assumes the identity of the perceived and the boundaries blur. The great "bards" were masters at "walking between the worlds."

Druidic magic is also closely associated with the use of medicinal herbs. The Druids were guardians of an oral-based culture; as such, they underwent intensive training in memory and concentration. The role of the

### **Ordinary** consciousness may be a process that creates an ongoing, dynamic simulation of reality, a world model, an inner theater of the mind.

Druidic bard was as "word magician." The use of poetry was magical rather than mundane; poems accompanied by the harp were considered invocations; the spoken word could invoke the divine. Poetic inspiration or "trance" was gained by lying in the dark for long periods of time (sensory deprivation). Some of the traditional rituals are "reminiscent of techniques used

in modern hypnosis to alter consciousness." (Freeman, *Parabola*, Spring 1995)

### The Thetan's Briefcase

It has been noted that Hubbard did a lot of reading in the occult, and was for a time a member of the Rosicrucian society AMORC at their headquarters in San Jose. One of the most important Rosicrucian concepts is the ancient theory of the "thoughtron," the idea that thought has mass, and that all events, mental or physical, are recorded as vibrations in every object. In this regard, remote viewer David Morehouse has noted that every object in the "ether" was animate, and that a "target's surroundings recorded the history of the place without prejudice and stood ready to bear witness."(27) Another important notion in ancient teachings is the loudly spoken word; iteration and reiteration facilitates clear visualization and gives form to thoughts. Thus, Hubbard's philosophy may have been influenced by Freudian, Rosicrucian, Theosophic, Transcendental Meditation, Mesmerism (hypnotism), and Druidic principles. Let's explore some of the concepts of Scientology that have been widely published by the Church itself.

The source of mental energy, according to Hubbard, is "theta." Every spiritual being operating a body is a thetan. A thetan is "an immortal spirit being who produces and uses *theta* in order to translate his thoughts into action." According to Hubbard's philosophy, all mental imagery consists of mental MEST, which is "Mass and Energy existing in Space and Time." MEST has differing density, solidity, mass, size, and durability, depending upon the amount of *attention units* given to it by a thetan. Mental energy consists of attention units, or theta quanta. Theta quanta are very fine vibrating subatomic particles. Hubbard taught that "whatever one puts attention on is energized by theta quanta flow." A thetan habitually puts "lumps" of attention units on things in his path, which connect and anchor him to the world.(28)


Theta is manifested as "pure thought or concept in the form of postulates." It is also manifested as "energized thought in the form of loud thinking and mental image pictures." As L. Kin writes, a thetan creates his own theta field in order to have a "platform to act from." Although a thetan actually exists outside the coordinates of MEST, he locates himself within a field so that he can be perceptible. This bundle of mental energy located within a playing field is referred to by Hubbard as "mind." In order to function in the "game" of life, a thetan needs "a body, food, playmates, and things to play with." Therefore, these things are manifested through the platform of mind on two levels, the level of mental MEST and the level of physical MEST. The thetan continuously creates the energy field called mind, through which he makes himself perceptible and through which he makes himself a player in the "game." According to Kin, "mind" is the thetan's brief case. (29)

According to Hubbard, a thetan gets the brain working "by pulsing towards it." The mental vibrations of the mind set off the brain's neurons. The mind, consisting of pure energy, is in a constant state of vibration, perceived as emotions. The Latin root of the word "emotion" is "a motion emanating." As such, emotions have a frequency and an amplitude. According to Kin, emotions are "the thetan's mode of pulsing into his body and environment and of responding to it." As Hubbard clarifies, "the intention of exerting effort bridges from the thetan into the body by emotion." Thus, the "mental force of emotion, which emanates from a thought, is necessary to achieve motion, or physical activity." (30)

Hubbard taught that through their postulates (thoughts, concepts) all thetans "overlap as infinities," or perhaps we might say, "in infinity." This is comparable to Swann's idea of "bio-mind net." A thetan, above the level of mental MEST, as a postulate overlapping other postulates, is in a state or condition Hubbard called "static." The game of life, according to Hubbard, is unpredictable, and the state of "not knowing" is an agreement, an act of will. But the more habitual "not knowing" becomes, the more one becomes trapped in the MEST Universe, and forgets he is actually "up there" as well, existing as pure thought, and even further up, as pure static: the source of thought. This realm is comparable to the "ether" or Matrix which remote viewers claim to explore. (31)

Auditing is an attempt to determine the correct classification of each ridge, postulate, or counterpostulate as "homemade" or "foreign-made," and uncreating it by "running through the incident" that created it until the sequence of events is known, and the negative emotions charging it are drained off. Auditing is done by two people, an auditor and an auditee, using the infamous E-Meter, which is an emotion detector. The auditor is a "Clear," someone who has reached a point of mental clearedness. Kin states, once one becomes an advanced solo auditor, they "will have no problem entering another person's reactive data banks *telepathically* and assisting him in cleaning them up." (32)

A "ridge" can be "copied," and can wander from its creator to another host and become an entity. The original creator "can't get rid of it because it consists of his theta quanta," and contains the identity of his thought and emotion at the time of creation. An entity consists of "at least two brands of theta particles: those of the original creator and those of the second owner who subconsciously registered the foreign ridge, and in trying to keep it out, made a copy of it." According to Hubbard, each thetan has created his universe, and each person "carries his universe about and feels at home there." Importantly, Hubbard taught that "only to the extent that these universes interact and overlap can there



be agreements and disagreements on games and opinions and thus, reality."(33) Remarkably, the secret doctrines which Hubbard studied and put to use preceded the new physics paradigms which assert that reality is shared consensus between individuals.

One example of the connection between Scientology and Swann's RV protocol is the "clay model" technique, also practiced at Psi-Tech. A remote viewer is trained to depict his remote experience in clay in order to give dimension to perceptual information. Scientology makes wide use of clay models to describe the emotions conjured up during auditing sessions. L. Kin writes that the "clay demo" demands that the student "create examples parallelling on a mest level the high flying theta concepts he carries about in his personal universe." This teaches him two things, Kin explains. Firstly, how difficult it is to create, and secondly, what his universe really looks like.(34)

To summarize, memories have a vibratory element; "engrams" are recorded memories of events. Mental pictures are called "mockups" and have a real and objective existence. When an object is imagined, it acquires a reality which can influence the circuitry of the E-meter. An Operating Thetan is capable of exteriorization; a state which Hubbard referred to in his command to "Get Three"

Feet in Back of Your Head." To audit entities on your time track or someone else's time track, you must locate them and convince them telepathically to leave their posts. Hubbard claims to have almost died going back to locate 405 trillion-year old "implants" in thetans.

### **Remote Viewing as Telepathic Time Travel**

On one occasion, Joe McMoneagle went after a target brought in by the FBI. The target was a person whose picture was inside an envelope. The time and location of the person was not provided. McMoneagle got comfortably within his "zone" (for which he claims he used HemiSync) and saw a man dressed in a business suit driving a car. The driver, who spoke Russian, was being stopped by a policeman. There was a fishing pole in the back seat. McMoneagle's monitor asked the significance of the fishing pole. McMoneagle then asked the man, "What are you going to do with the fishing pole?" As Schnabel remarks, "this was an especially strange use of the telepathic interrogation technique." (35)

This scenario is remarkably like a Scientology auditing session. McMoneagle interrogated the man "telepathically." McMoneagle, whom Schnabel calls the "shaman in Army boots," apparently following the time track of the KGB man, observed that he was using the pole as an aid to dislodge an object placed by a fellow agent. His explanation for the use of the pole was never verified. The Russians had been seen quite often with fishing poles, and had been seen fishing in groups. Their fascination with fishing poles remained an elusive enigma. McMoneagle's explanation does not seem to make sense. This is the gray area between the states of "mind/awake-body/asleep" and "three-feet-in-back-of-your-head." Even EEG readings are of no help here. Remote viewing inevitably walks the hazy ether between clairvoyant parlor trick and a tool of the national security state.

McMoneagle often used this telepathic interrogation technique during remote viewing sessions. While going toward a target, he often found

himself "staring at the curved interior of an unearthly ship, filled with skinny, large-eyed humanoids." McMoneagle explained that suddenly the aliens would be looking at him, wondering what he was doing there. Apparently, he had to undergo some psychic battling with these entities, and would return "drenched with sweat and xenophobic stress."(36)

In another session, McMoneagle found himself on a ship in the dead of night, boarded by men wearing black. Some men were holding the captain of the ship at gunpoint with his hands in the air. McMoneagle concentrated on the captain, and asked him, "what's going on here?" McMoneagle got the sense that the captain was unfazed by the seemingly stressful situation. It turned out to be a staged hijacking.(37) In another time travel feat, McMoneagle was "stepped forward in time, month by month," in order to view a new secret Soviet submarine.(38) McMoneagle's description of the sub as well as other predictions were not far off. Satellite photos taken four months later showed the Typhoon as McMoneagle had described it.

### Slipping Into the Ether

Even at upper management levels, the individuals in the RV program had strong beliefs in the paranormal and, in particular, in the reality of the ET presence. Ed Dames, who later went on to found Psi-Tech, began to choose exotic targets for viewers to locate. Using Monroe's HemiSync tapes to induce "deep trance bilocations," a small group of RVers began investigating all types of anomalous phenomena. Dames' "Enigma Files" began to fill with descriptions of such things as UFOs, the Loch Ness monster, Virgin Mary sightings, and Atlantis. Some were so fascinated with UFO lore that they quickly homed in on a UFO as soon as they set foot in the ether. (39)

Angela Dellafiora began experimenting with a style of remote viewing called WRV, or written remote viewing, which was essentially channeling. She would go into a trance state (also known as self-hypnosis) and announce the presence of either George, Maurice, or Dr. Einstein, who would take control of her hand and write answers to questions she was asked. The "Jedi Knights," those who had been trained by Ingo Swann, lamented that the project was regressing "from high tech wizardry to archaic and vaguely feminine witchery." (40) The rivalry intensified and the program eventually slid into chaos and mismanagement. Ed Dames blamed it on "the witches and their wiles." (41)

Courtney Brown of the Farsight Institute studied at the Maharishi International University in the TM-Sidhi program, which involves "yogic flying." As a student of the Monroe Institute, Brown learned to use the HemiSync method. (42) He then went on to study with an anonymous remote viewer, whom some assert was Ed Dames of Psi-Tech. The remote viewers at Brown's Farsight Institute were responsible for the Far-Side claims that flying saucers were trailing the Hale-Bopp comet. A few months after his outfit made these Far-Out claims on their web site and on the Art Bell radio show, a UFO-cult group called Heaven's Gate committed suicide to join their space family. Wired News reported that notes posted to "alt.religion.scientology" by one of the group members

referred to remote viewing information as "fantastic proof that the 'Next Level' mothership is coming." Using the e-mail address "rep@heavensgate.com," the writer stated he was working in seclusion with his disciples, preparing them for membership in the next world. (Art Bell has just suddenly retired from his radical radio career with cryptic reasons. Could it have something to do with Heaven's Gate?)

In addition to its irresponsible use in this social mind control scenario, does remote viewing have any physical dangers? Several persons involved in the RV program have noted the serious possibility of psychiatric problems. After coming out of an RV session, the "doors of perception" are open wider than usual. Total concentration on "barely perceptible" experience turns one's sensory "volume knobs" all the way up. Once you come off the highway, the radio is on full blast; there is an "electric tingle" in the body, and you feel like you've taken a "mild dose of LSD." (43)

It is also possible that having these daily deep altered-state experiences could make your mind more liable to slip into that state spontaneously. Army veteran David Morehouse had a psychotic breakdown from his "addiction" to remote viewing. He states that every viewing session was followed by a period of slipping in and out of the "ether" with no control, and that viewers who performed more than two sessions a day had to be driven home, because "the chance that we would slip back into the ether was too great."(44) The Army eventually categorized remote viewing as "human use experimentation," requiring a "blizzard of consent forms and a medical review panel."(45)

By 1983, Richard Kennett of the CIA began questioning the Army about all the money they were spending at the Monroe Institute. He began to suspect that the active promotion of altered states of consciousness might actually make the brain unstable, and more prone to "spontaneous hallucinations and delusions." It turns out that Kennett had also had a spontaneous OBE after following the Monroe Institute materials. He had left his body and walked across the room, but noticed there were other beings in the room. Some kind of entity had put its face right up to his. He became frightened that he would not be able to get back into his body. After his own experience in this realm, he wondered if repeated experience could cause

psychological trauma, psychotic breaks, or even a heart attack. (46)

McMoneagle also wondered if the act of remote viewing might produce a hazardous effect on the human nervous system. The numbers of remote viewers experiencing heart attacks and different types of cancers became "too high to ignore," and it was unsettling that "so many of them had seemed to die before their time." (47) [Come on, a CIA program that's hazardous to your health?] Then McMoneagle himself had a heart attack and a near death experience.

### Conclusion

Sources are fairly certain that the CIA-military remote viewing projects are over. But why continue to spend money when they can just oversee the programs being run by private companies? Most of the remote viewing companies are founded by veterans of the SRI and Fort Meade RV projects, and are connected to big names in Psi-Ops.

There is evidence that psychic functioning is exhibited by some people as a natural talent, and the latent ability for the mind to be two "places" at once has been sufficiently demonstrated. However, we don't really know what kind of technologies are being tested on unwitting subjects under the guise of "enhanced creativity" and "intuition development." The potential for mind tools to double as mind control is very real, and we should beware wherever the CIA is involved. Is "national security" a cover for something else that's going on?

The techniques which cause the mind to bilocate are the kept secrets of shamanism, and are counterintuitive to the Western scientific brainscape. The CIA has surreptitiously dug into the magic bags of the world's occult and shamanistic traditions and has opened a potential Pandora's box. Take heed to the words of L. Ron Hubbard during a 1952 lecture of the Philadelphia Doctorate Course. Hubbard warned that Scientology contained "methods of controlling human beings and thetans which have never before been dreamed of in this universe." He stated that these control mechanisms were "of such awesome and solid proportions that if the remedies were not so much easier to apply, one would be appalled at the danger to beingness that exists in scientology." Hubbard concluded that George Orwell's "1984" would be "the palest imaginable shadow of what a world would be like under the rule of the secret use of scientology with no remedy in existence."(48)

Inserting the words "remote viewing" in place of "scientology" in the above statement might indicate that these words should be taken as a warning. With

a strong foothold in the New Age psyche, remote viewing has become a faith-based prescription for a lost civilization: millennium cosmopolitans stuck in vibrational transport to the Next Level of Human: Heavens Gate's conveyor-belt to God. The dissociative dynamics of this new cottage industry is ironically reflected in the fact that it is being peddled within the "virtual reality" landscape: a land populated by "techno-pagans" and cult recruiters. Since it also has the ostensible stamp of "science," remote viewing is a symbol for the boredom-fatigue of the technological age. It is simple: we want to be "anywhere" but here. •

## Aleister Crowley, The The Midnight Messenger

The ruling spirits of this world relayed the primary plank of their program to Crowley, and this is contained in The Book of the Law.

"The future was darkening, we were nearing the terrible catastrophe which was about to overwhelm France. The abyss was at our feet; yet averting our eyes, struck with a fatal blindness, we hurried from *fête* to *fête*, from pleasure to pleasure. It was a kind of frenzy which thrust us gaily on to our own destruction. Alas! how can a storm be controlled when one sees it not?

"Meanwhile, from time to time, some troubled or observant minds tried to snatch us from this fatal security. I have already said that the Comte de St.-Germain had tried to unseal the eyes of their Majesties, by making them perceive the approach of danger; but M. de Maurepas, not wishing the salvation of the country to come from anyone but himself, ousted the thaumaturgist, and he re-appeared no more."

The year in which these events were taking place was 1788, and these words were later recorded in the diary of Madame d'Adhémar, an intimate friend of Marie-Antoinette. M. de Maurepas was an adviser to the Queen, and was the one most accused by the Abbé Barruel of leading the French Revolution.

The reason I am making this reference to the Count of Saint-Germain is that I want to place him and Aleister Crowley within the same class of adepts who by their mere presence energise the elemental forces of war and chaos. It transpired that Saint-Germain's warnings to the French Royal Court were totally vindicated, but his timing and mysteriousness meant that the whole course of events could not be averted. It was too late to avert the inevitable. These adepts have virtually self-realised personalities. Crowley perceived his role of energising war when he wrote that the prophetic events contained in *The Book of the Law* could only be put into action by its publication. Thus, a series of violent and bloody conflicts came into effect after this powerful grimoire was published. This is the "word-sword" principle: words spoken or published which give effect to outcomes or consequences.

Saint-Germain was a high level adept of the secret societies. He was believed to have died in 1784, but he faked his death, since both Masonic and Catholic sources place him at the Wilhelmsbad conference held on 15 February, 1785. This conference was held in an attempt to bring about a conciliation between the various sects of the Rosicrucians, the Necromantists, the Cabalists, the Illuminatiand the Humanitarians. In attendance were such (il)luminaries as Cagliostro, St. Martin, Mesmer and Weishaupt.

Saint-Germain was a member of the Paris Chapter of the Knights Templar. He was the Obermohr [supreme magus] of many mystic brotherhoods, where he was worshipped as a superior being. His memory was not forgotten, and by the end of the nineteenth century, hierophants of the secret schools looked upon Saint-Germain with profound gratitude. His influence had helped to open the way for humanism and republicanism (which in this author's opinion is a respectable name for organised crime), movements which "flowered" in the twentieth century.

Gnostic forces were progressing in the ascendancy

during the nineteenth century, and into this milieu was Edward Alexander Crowley born; he later took the name Aleister. He was born on 12 October. 1875. According to Kenneth Grant, head of an OTO breakaway sect, the Typhonian Tradition, Crowley first became aware of the existence of spiritual powers in 1898 when he read The Cloud upon the Sanctuary by Karl von Eckartshausen. Crowley was 22 at the time and set out to contact the hidden Order which the book describes. His efforts led to his initiation into the Hermetic Order of the Golden Dawn on 18 November, 1898. He assumed the magical name Perdurabo (I shall endure).

In August, 1903, Crowley married Rose Kelly, his 'scarlet woman,' whom he had met in Paris. They

proceeded on an extended honeymoon, and whilst in Sri Lanka, they went trekking through the jungle. Whilst standing on the shores of a lake, Crowley decided to shoot enough furry bats to make himself a waistcoat. One bat landed on Rose, and Crowley had some trouble detaching its claws. That night, Crowley was awakened by the noise of a squealing bat. He then saw Rose, completely naked, clinging with her arms and legs to the wooden frame that supported the mosquito net. As

he pulled her down, she bit and spat and squealed, and she had to be shaken into wakefulness. Crowley noted that it was the finest case of obsession that he had ever had the "good fortune" to observe.


When Rose later discovered she was pregnant, they decided to return home to England. En-route they went to Cairo, where they took a flat. (Incidentally, Rose went on to have a daughter who was named Night my Athatour Hecate Sappho Jesabel Lilith, and who died in

tragic circumstances. Rose died an alcoholic.)

In Cairo, Crowley proceeded to dress in Persian garb, pretending to be an oriental prince, Chioi Khan (being Hebrew for the Beast). Crowley's mother, a strict Plymouth Brethren, had believed her son to be the beast number 666 of Revelation 13:18.

In Cairo,
Crowley attempted
a series of invocations to summon
up elementals or
demons. Rose
sank into a curious state of mind
in which she kept
repeating: "You
have offended
Horus." It was
Rose who in fact
introduced
Crowley to the

elemental, Aiwass. Through Rose, Aiwass told Crowley that he was to go into his workroom at precisely midday on 8, 9 and 10 April, 1904 and write down what he heard for the next hour. The message began: "Had! the manifestation of Nuit." And thus *The Book of the Law* came into existence. It is also known as "Liber AL vel Legis" (meaning 'divinely revealed Book of the Law') or Liber AL for short. Whilst *The Book of the Law* was received in 1904, it would not be published until 1913,

just nine months before the 'Balkan War' (later to be called World War One).

According to Crowley, "'The Law of Thelema' [ie, Liber AL], revealed in Cairo in 1904, has come to replace the outworn creeds, the local codes: to help the peoples of the world march on to a new era of peace and happiness." Thus Crowley becomes a medium and 'false prophet' within the context of James 4:5: "They are from the world; therefore they speak from the world's viewpoint; and the world listens to them."

Crowley preached the New Aeon of Horus, the "new era of peace and happiness," but the path to this "new era" would necessarily be bathed in blood. A moment's reflection on the course of the twentieth century confirms that the revolutionary and violent prophecies contained within The Book of the Law have been fulfilled, and there are other events yet to occur.

### **Forerunner to Crowley**

Crowley did not just appear out-of-the-blue. The groundwork had been laid for millennia, for his creed is Gnosticism. Essentially, a Gnostic is one who seeks illumination, and sets out to become a divine being; basically, an alchemical transmutation of evil into good achieved through the exercise of one's own will. Christians believe that this transmutation can only occur through the grace of God as may be extended to an individual; no amount of self-will can achieve this transmutation of one's spirit.

Gnostic leaders are spiritualist mediums who take counsel and direction from spirits or "Invisible Masters." The ideals of Gnostics are utopian, and the ends justify the means. Crowley was a Gnostic master, as was a forerunner of his, Adam Weishaupt. Many readers have more than likely 'completed' Conspiracy Theory 101, and are familiar with Herr Weishaupt. For those who may not know of him, some background follows.

Weishaupt was born in Catholic-dominated southern Germany on 6 February, 1748. He was Jesuit-educated and attained a very influential university position. In accordance with the "needs of his period" (Kenneth Grant), he reawakened the Order of the Illuminati. Weishaupt's occult activities culminated in the French Revolution, and this spark ruptured the course of history.

Shortly after the French Revolution, the Marquis de Luchet said, "This society [Illuminati] aims at governing the world. Its object is universal domination." He called the Illuminati "a subterranean fire smouldering eternally and breaking forth periodically in violent and devastating explosions."

Weishaupt wrote the following to a fellow Illuminatus:

"We must consider how we can begin to work under another form. If only the aim is achieved, it does not matter under what cover it takes place, and cover is always necessary. For in concealment lies a great part of our strength. For this reason we must cover ourselves with the name of another society. The lodges that are under Freemasonry are in the meantime the most suitable cloak for our high purpose, because the world is already accustomed to expect nothing great from them which merits attention. As in the spiritual Orders of the Roman Church, religion was, alas! only a pretence, so must our Order also in a nobler way try to conceal itself behind a learned society or something of the kind."

On 26 December, 1993, no less an organ of the fourth estate, The Economist published the following under the heading, "The Good Network Guide":

"Beyond all these networks lies the mother of all networks, the Order of the Illuminati, known to some as the True Rulers of the World. Its age will remain uncertain until the story of the last days of Atlantis is better known." Though this secret body has hovered unseen over all history, its most public flowering

was in the Enlightenment. Adam Weishaupt, a former Jesuit who provided much of the inspiration for Shelley's Frankenstein, revealed its purpose and system of mutual surveillance to the world on May 1st 1776. Since then the order has taken a keen interest in another newborn of that year. It is significant that many American presidents have been Illuminati; and the Illuminati symbol of the eve in the pyramid still graces the dollar bill."

"The conspiracy is immense and terrifying, stretching from Hassan-i-Sabbah, 11th-century Assassin, to Ian Fleming (who caricatured the order as "SPECTRE"). It is the network of those who run networks. Given its power, you should assume that anyone writing about the order must be either lying or part of a conspiracy to confound you. In wondering about the IIluminati, merely remember this. You have never arrived." (Note the motto of the Assassins: "Nothing is true. Everything is permit-

Angelo Roncalli who was to become Pope John XXIII, and who convened Vatican 2, is reputed to have been a member of the Illuminati. The Illuminist eye in the pyramid was used on his papal cross. He is also reputed to have met with Crowley. It was Vatican 2 which led to the Catholic church seizing the world-wide ecumenical agenda and which authorised the idolatrous elevation of Mary to goddess status.

After the French Revolution, the Order of the Illuminati disappeared. In 1904, an Austrian Adept named Karl Kellner repeated Weishaupt's feat, and re-established the Illuminati

through a sect known as Ordo Templi Orientis (OTO). Crowley took over leadership of OTO in 1922. The spirit guides of the Gnostics had clearly directed that the Illuminati once again step into the public realm but, in this instance, through OTO.

### The Book of the Law

Crowley is not an aberration. He is part of an historical process which has yet to reach its climax. The ruling spirits of this world relayed the primary plank of their program to Crowley, and this is contained in The Book of the Law. For human beings, the real struggle is not against each other, but against the evil cosmic powers which govern this dark age. Crowley was their medium, but on several occasions as he wrote down The Book of the Law, Aiwass chastised Crowley for being concerned about what he was writing.

As part of my own spiritual journey as a Christian, I eventually found myself looking into Crowley. It took sometime before I recognised that The Book of the Law was such an important work. I am not writing this article to make the facts fit in with my world-view. What I found is that The Book of the Law has been fulfilled to a large degree, and that its contents tie in strongly with the Revelation. Just as Jesus sent his angel to reveal future events to John, so did Satan send a spirit being, Aiwass, to Crowley. Both works are eschatological (the doctrine of last or final things).

The Book of the Law says that the god of war and vengeance, Ra-Hoor-Khu-It (Horus), is now positioned on his seat of power. His human incarnation will occur, and he will be in the form of a child, the False Prophet or Antichrist. He is the offspring of the union of Hadit (Satan) and Nuit (Babylon). This union and its "fruit" is referred to in Revelation chapter 13. *The Book of the Law* tells us that Satan is the coiled

serpent, and he is about to spring. Christians will be put to death. Through war and chaos, the goddess (Nuit/Babylon) will be placed in a position to be worshipped, and her offspring, the child, will be mightier than all the kings of the earth, although one of these rich "kings" will finance him.

There are three underlying principles in *The Book of the Law* for Thelemites (Thelema is Greek for determination through choice; inclination to desire, pleasure, will) to live by:

- 1. Do what thou wilt shall be the whole of the law.
  - 2. Love is the law, love under will.
  - 3. Every man and every woman is a star.

A curious feature of Gnosticism is that in the early stages of the Gnostic quest, one is driven by terrible despair, and simultaneously, a powerful upsurge of love. In the utopian quest for self-perfection, a 'good' person in the world's eyes is one who is seemingly self-realised and self-reliant. That person develops the will to be the master of his/her world, even though many other persons may lose in the process. To become a selfish 'superman' is the Gnostic goal, and those who are not so capable or who do not share this ideal are meant only to serve and be used. Sin is no longer a restriction on one's will to fulfill the most powerful desires. Nietzsche longed for 'the fair beast' (die blonde Bestie) - the strong, beautiful beast which shall rule the world. and act in all things according to its will.

W.B. Yeats, the Irish poet and contemporary of Crowley in the Order of the Golden Dawn, wrote about the Gnostic utopia thus: "...an aristocratic civilisation in its most completed form, every detail of life hierarchical, every great man's door

crowded at dawn by petitioners, great wealth everywhere in few men's hands, all dependent on a few, up to the Emperor himself, who is a God dependent on a greater God and everywhere, in Court, in the family, an inequality made law."

### The Book of the Law in the Context of the 20th Century

Satan through Aiwass declares that Christianity is dead, and that Crowley is to be the prophet of the neo-pagan system which would emerge. Moral values

and compassion as exercised would be relative to the exigencies of the times. The neo-pagan emergence would birth on an altar of moral enfeeblement and blood sacrifice. The strong of will would take control of the world.

The most dramatic instance of human sacrifice occurred under the Nazis in World War II. The German lyric poet and essayist, Heinrich Heine (1797-1856) prophetically wrote of a time when Germany would go berserk:

"Some day there will awake that fighting folly found among the ancient Germans, the folly that fights neither to kill nor to conquer, but simply to fight. Christianity has and that is its fairest merit somewhat mitigated that brutal German lust for battle. But it could not destroy it: and once the taming talisman, the Cross, is broken, the savagery of the old battlers will flare up again, the insane Berserk rage of which Nordic bards have so much to say and sing. The talisman is brittle. The day will come when it will pitiably collapse. Then the old stone gods will rise from forgotten rubble and rub the dust of a thousand years from their eyes; and Thor will leap up and with his giant hammer start smashing Gothic cathedrals..."

The gods did indeed awaken. According to Trevor Ravenscroft in The Spear of Destiny, every year from 1926 to 1942, the Germans sent out parties which contacted Tibetan initiates, the intention being to gain their psychic help and deep alliance with the devilish forces which rule this world. A Tibetan colony was established in Germany in 1929, and the monks were known in Germany as "The Society of Green Men," because of their links with the Green Dragon

Society of Japan.

In Berlin, Hitler met regularly with the leader of the Tibetan community who was a very gifted and accurate clairvoyant. Himmler shared Hitler's interest in the occult, and set up the Nazi Occult Bureau. This incorporated into one organisation the Thule group, the Vril Society and the German branch of OTO (Crowley's magical order).

Between 1936 and 1939, Crowley paid a number of visits to Germany. It is known that a woman called Martha Kunzel repeatedly urged on Hitler the wisdom of adopting *The Book of the Law* as his guide. Hitler rejected this, as he wanted *Mein Kampf* to be the holy book of Germany. By the time the war had broken out, Crowley had become strongly anti-Hitler, and said that "Britain would knock Hitler for six" (an analogy from cricket: the worst thing a batsman can do to a bowler is hit the ball clear out of the field, and thus score six runs). The German branch of OTO had by the time of the war been banned and most of its members were in concentration camps.

Hermann Rauschning, governor of Danzig, had been very close to Hitler, and recorded many of their conversations which were published in a book called *Hitler Speaks*. Rauschning openly acknowledged Hitler's obsession with the occult, and found that very often Hitler was paraphrasing or expressing an idea from *The Book of the Law*, often word for word.

"I will tell you a secret," Hitler told Rauschning, "I am founding an order. It is from there that the second stage will emerge; the stage of the Man-God, when Man will be the measure and centre of the world. The Man-God, that splendid being, will be an object of worship. But there are other stages about which I am not permitted to speak."

"Hail! ye twin warriors about the pillars of the world! for your time is nigh at hand." (*The Book of the Law* 3:71) The "pillars of the world" are the powerful and greedy emotions of people, and the twin warriors are the spirits that would cause the two world wars energised by the compliance and sinfulness of the "pillars of the world." Hitler knew exactly what he was about, and fulfilled his pre-destined role. The cornerstone of Novus Ordo Seclorum was laid.

### **Jack Parsons and the Babalon Working**

By the time World War II came to an atomic end in 1945, the earth had been literally soaked in blood. The warrior god, Horus, had erupted, and the world convulsed in a continuous fit of war and genocide. Verse 3:46 of *The Book of the Law* had come to pass: "I am the warrior Lord of the Forties: the Eighties cower before me, & are abased. I will bring you victory & joy; I will be at your arms in battle & ye shall delight to slay. Success is your proof; courage is your armour; go on, go on, in my strength; & ye shall turn not back for any!"

Crowley's time on earth came to an end on the evening of 1 December, 1947 when he succumbed to myocardial degeneration and chronic bronchitis. The prankster was dead, long live the prankster!


Crowley had come from an English world which was traditional and very conservative. Throughout his life, he loved to play the prankster. On one such occasion, he walked into a lift and urinated in the corner, and then declared that the lift had become a sacred place. But at heart, he does seem to be very English. The new wave Americans, the bohemian Jack Parsons and the brash L. Ron Hubbard, were not bound by English strictures; they were very much action men.

When Parsons and Hubbard performed the Babalon Working in January, 1946, Crowley was resentful and branded them "louts," even though he had developed the Working and mentored Parsons (in correspondence to Crowley, Parsons used the salutation, "Most Beloved Father"). Crowley was so incensed at the Working being performed that he cabled his US office on 22 May: "Suspect Ron playing confidence trick Jack Parsons weak fool obvious victim prowling swindlers."

Jack Parsons was a very gifted scientist and chemist, and founded a company which was to become Jet Propulsion Laboratories (JPL), which in its modern day guise has merged with NASA (JPL.NASA). To this day, people at NASA are reputed to refer to JPL as Jack Parsons' Laboratory. He was also an Illuminatus and had deep occult interests, and is reputed to have been a descendent of a Hell-Fire Club founder. When he first encountered Crowley's writings he intuitively understood Thelema. He joined the Los Angeles OTO Lodge in 1939, and rapidly rose to prominence.

In April, 1945, Parsons was introduced to L. Ron Hubbard. Enter the prankster! Crowley biographer Kenneth Grant refers to Hubbard as "a confidence trickster who had wormed his way into the OTO on the pretence of being interested in Magick." Despite the resentment shown to Hubbard by OTO leaders (including Crowley), L. Ron was able to call Crowley "my very good friend" in a 1952 speech. Perhaps this was the prankster talking.

Hubbard's relationship to Parsons is basically similar to Edward Kelley's relationship to Dr.

traordinary amount of experience and understanding in the field. From some of his experiences I deduced that he was in direct touch with some higher intelligence, possibly his Guardian Angel. He describes his Angel as a beautiful winged woman with red hair whom he calls the Empress and who has guided him through his life, and saved him many times..."

The Babalon Working is an invocation ritual developed in conjunction with Crowley. A series of rituals and invocations were undertaken by Parsons commencing on 4 January, 1946. A short time after the process began, Parsons and Hubbard went out into the Mojave Desert for four days. The Babalon Working ritual is outlined in Parsons' book *Freedom is a Two-Edged Sword*. By 18 January, Parsons announced to Hubbard, "It is done." Parsons had successfully opened an inter-dimensional doorway. He invoked the goddess and paved the way for the present-day passion for drugs, UFOs and

divination. Parsons wrote "Liber 49" which he maintained was the fourth and final chapter of The Book of the Law.

According to the woman who embodied the invoked goddess, Marjorie Cameron, and who came to Parsons shortly after the completion of the Babalon Working, Parsons set in motion the second part of a great force which was divided into three. Aleister Crowley began the first, and the third would be the work of the boy child embodiment of Horus, the False Prophet or Antichrist (Revelation 13:18).

Readers familiar with Revelation may wonder if Crowley's Babalon is the same as Babylon of Revelation. The answer is yes. Babalon is the secret name of Nuit, the goddess revealed in chapter one of The Book of the Law. Babylon the goddess is revealed throughout Revelation as the provider of material wealth. The Babalon spelling was adopted because of its gabalistic numerical significance. Kenneth Grant records the attributes of Babalon as being "death-dealing and vampiric."

Jack Parsons wrote in *The Book of Babalon* (January 4 - March, 4, 1946):

"I have been engaged in the study and practise of Magick for seven years, and in the supervision and operation of an occult lodge for four years, having been initiated into the Sanctuary of Gnosis by the Beast 666, Fra. 132 and Fra. Saturnis. At this time I decided upon a Magical operation designed to obtain the assistance of an elemental mate...I decided to use the Enochian Tablets obtained [from spirit guides] by Dr. Dee and Edward Kelley...During the period of January 19 to February 27 [1946] I invoked the Goddess BABALON with the aid of my magical partner [Hubbard], as was proper to one of my grade."

On March 2, 1946, Hubbard had channelled the message: "She [Babalon] is the flame of life, power of darkness, she destroys with a glance, she may take thy soul. She feeds upon the death of men...She shall absorb thee, and thou shalt become a living flame before she incarnates."

Parsons continued with his magickal operations for the remainder of the forties, and in 1949 wrote in The Manifesto of the Antichrist:

"Do what thou wilt shall be the whole of the Law. I, BELARION, ANTICHRIST, in the year 1949 of the rule of the Black Brotherhood called Christianity, do make my Manifesto to all men. And I, THE ANTICHRIST, come among you, saying: An end to the pretence, and lying hypocrisy of Christianity. An end to the servile virtues, and superstitious restrictions. An end to the slave morality. An end to prudery and shame, to guilt and sin, for these are of the only evil the sun, that is fear. An end to all authority that is

not based on courage and manhood, to the authority of lying priests, conniving judges, blackmailing police, and an end to the servile flattery and cajolery of mods (sic - would appear to refer to dilettantes), the coronations of mediocrities, the ascension of dolts. An end to restriction and inhibition, for I, THE ANTI-CHRIST, am come among you preaching the Word of the BEAST 666, which is, "There is no law beyond Do what thou wilt." And I, BELARION, ANTI-CHRIST, do lift up my voice and prophecy, and I say: I shall bring all men to the law of the BEAST 666, and in His law I shall conquer the world. And within seven years of this time, BABALON, THE SCARLET WOMAN HILARION will manifest among ye, and bring this my work to its fruition. An end to conscription, compulsion, regimentation, and the tyranny of false laws. And within nine years a nation shall accept the Law of the BEAST 666 in my name, and that nation will be the first nation of earth. And all who accept me the ANTICHRIST and the law of the BEAST 666, shall be accursed and their joy shall be a thousandfold greater than the false joys of the false saints. And in my name BELARION shall they work miracles, and confound our enemies, and none shall stand before us. Therefore I, THE ANTICHRIST call upon all the Chosen and elect and upon all men, come forth now in the name of Liberty, that we may end forever the tyranny of the Black Brotherhood. Witness my hand and seal on this [...] day of [...] 1949, that is the year of BABALON 4066. Love is the law, love under will. Belarion, Antichrist Analysis by a Master of the Temple of the Critical Nodes in the Experience of his Material Vehicle."

Parsons died on 17 June, 1952 in a laboratory explosion as a result of dropping a phial of fulminate of mercury. However, there is suspicion that his death was faked, for without legal precedent, his next of kin (Marjorie Cameron) was not consulted in order to identify the body, nor was she allowed to see him in the ambulance or hospital. Other oddities about his death have been noted.

In 1972, the Parsons Crater was named on the dark side of the moon in honour of Parsons (for services to rocketry). Hubbard went on to become the founder of the Church (sic) of Scientology, and, in 1972, Kenneth Grant wrote that he was "still at large, having grown wealthy and famous by the misuse of the secret knowledge which he had wormed out of Parsons."

### Let's Get Philosophical for a Moment

At the heart of The Book of the Law is the instruction: Do what thou wilt. Under "Law," this is a conscious development of one's personal will to power. Nietzsche's message of the superman is that, on the will to power theory, values are mutable. Thus one's own values prevail, rather than conforming to the values of

the collective which endeavour to pursue peace and harmony. When the question of basic values is open in society, the essential victory has been won.

Identifying with the conscious will to power, one wants to set the terms, insisting on the principle, "I will not serve." Satan thought much the same thing: "I will climb to the sky; higher than the stars of God I will set my throne. I will sit in the mount of assembly, on the summit of Zaphon [the abode of the gods]: I will mount the back of a cloud I will match the Most High" (Isaiah 14:13,14).

Satan is the tree of knowledge of good and evil, and his lie to humans is to "eat" from him in order to become a divine being. *The Book of the Law* says that every man and every woman is a star (1:3). The "sovereign power" of thought is a real and actual fact: if I "will" to kick up my foot, so it is done. If I am powerful enough, and I will order the dropping of an atomic bomb on civilians, so it is done. If technology is but a tool of people, then surely it is controlled by will.

Through development of the conscious will, we are in the process of strengthening the ego. As created human beings, the realm of ego consciousness and the spiritual and psychic realm are indissolubly united with the body. As the ego grows stronger, it detaches itself more and more from the body.

In the individual will to power, one's ego detaches from the collective ego. It is a struggle and a creative act. Such an act brings on a sense of loneliness; it also introduces suffering, toil, trouble, evil, sickness and death into a person's life as soon as this separation is perceived by the ego. When Adam and Eve made their decision to will to power rather than will to God's will, God told Adam: "Cursed be the ground

because of you; by toil shall you eat of it all the days of your life: Thorns and thistles shall it sprout for you. But your food shall be grasses of the field; By the seat of your brow shall you get bread to eat, until you return to the ground for from it you were taken. For dust you are, and to dust you shall return" (Genesis 3:17-19).

To be the outsider or revolutionary is to be isolated and alone. The individual is pitted against the world, and becomes part of a higher, different unity. To become a "star" and will to power is to have knowledge of good and evil and is accounted sin, and one is expelled from paradise. ### **Columbine Update**

• The Washington Post (4/29/99) reported that Columbine High gunman, Eric Harris, was on a prescription antidepressant called fluvoxamine or "Luvox." The Post did not mention the drug's side effects, only that the Marines rejected him since he was on the drug. Fluvoxamine is indicated for the treatment of Obsessive Compulsive Disorder, and is not approved in this country to treat depression, though it is marketed as an antidepressant in other countries.

Sources say that Luvox "can activate mania in susceptible patients." The manufacturers prescription insert states Luvox should be used cautiously in patients with a history of mania. Symptoms of "mania" include: "provocative, intrusive, or aggressive behavior." A National Institute of Mental Health webpage lists the following symptoms of mania: inappropriate elation, inappropriate irritability, grandiose notions, disconnected and racing thoughts, markedly increased energy, poor judgment, and inappropriate social behavior. All of these symptoms appear to be applicable to the actions and grandiose ideas of Eric Harris, which included a plan in which, after killing their fellow students, the two would escape to an Island in Mexico and then return to the US to crash a plane into New York City.

In a related story, the *Denver Rocky Mountain News* reported on 5/22/99 that the son of the FBI's lead investigator in the Columbine tragedy was one of the students who produced a 1997 videotape that shows trenchcoat-clad students armed with weapons moving through the school's halls and then blowing up the school. Incredibly, FBI spokesman Gary Gomes claimed there was "no conflict of interest."

The son of agent Dwayne Fuselier is alleged to have worked on the video with student Brooks Brown, who was at that time friendly with future shooter Dylan Klebold. Agent Fuselier's son graduated from Columbine in 1997, and neither he nor Brooks Brown has been linked to the 1999 killings. Ironically, although some have labeled Eric Harris as the "mastermind" behind the April 1999 attacks, he did not become involved with the so-called Trenchcoat Mafia until some time *after* the prophetic video was produced.

### Uncle Sam's Holy Grail

• As part of a new and aggressive effort to track down parents who owe child support, the Feds have created a wide-sweeping data-monitoring network which will track nearly every working adult in the U.S. Never before have they had the legal authority and technological ability to locate delinquent parents, asserted the *Washington Post* on 6/27/99, while at the same time providing "the potential to keep tabs on Americans accused of nothing." This little known network was established under the 1996 welfare overhaul system called the Personal Responsibility and Work

Opportunity Reconciliation Act, which calls for all employers to file reports on every person they hire, as well as the wages of every worker, and send this information to state child-support agencies. State officials then gather the data, along with unemployment and child-support data, and report this information to ACF officials. The new system will also require financial institutions, at the behest of federal officials, to provide them with details of the financial holdings of ostensible "delinquent parents." This huge centralized database, which will cross-reference personal information on hundreds of millions of American citizens, has been called by civil libertarians, "the Holy Grail of data collection."

### **Nuke Plants Have Y2K Problems**

• Investigations are being conducted in several countries operating nuclear power plants and research reactors to ensure that the Y2K problem does not affect the safe operation of these plants. The International Atomic Energy Agency (www.iaea.org) has contacted its member states to exchange information regarding diagnostic and remedial actions being taken or planned at worldwide nuclear installations. In response to a questionnaire on the State of the International Community with regard to nuclear energy and the Y2K problem, the IAEA received the following disconcerting responses:

**Bulgaria**: Yes, there are some specific problems concerning the embedded systems. [We have] difficulties, because some of the vendors didn't answer or their answers were not reliable.

Finland: Contingency plans are under preparation. The vendor assurances of year 2000 compliance are not always reliable. Making assessing and testing programs for large systems like process computer systems requires much special know how. To find suitable time and other resources for large system testing is challenging.

Federal Republic of Germany: In German nuclear power plants, the control systems of the highest level do not use computer systems but hard wire control systems. However, other systems with relevance to safety and operational systems may be affected.

**Hungary**: The planned countermeasures do not contain yet contingency considerations.

**Japan:** The Japan Nuclear Cycle Development Institute (JNC) has identified some specific problems with regard to the Y2K problem, and has reconstructed some systems, and will

continue to try to solve problems by allocating some budget by the year of 2000.

**Spain:** No detailed results available so far. Contingency plans possibility is contemplated.

USA: The industry's Y2K program has identified problems in plant security computers, data recorders, radiation monitoring systems, plant process systems (feedwater control, turbine control, and heater drain level control), steam leak detection systems and diagnostic systems. The NRC has no indication that significant Y2K problems exist with safety systems for the systems that directly affect the ability to safely operate and shut down the plant. It should be noted that the Seabrook, New Hampshire nuclear plant has identified a Y2K problem with the Radiation Data Monitor System (RDMS), which is a vendor package. This package has been determined to be not Y2K compliant, and the vendor has indicated it has no plans to make this system Y2K compliant. Several plants use this device.

### D.C. Unprepared for Y2K

• Although it doesn't run a nuclear power plant, the Washington, D.C. government has acknowledged that it is far behind in fixing its critical Y2K problems. With six months left in the year, only 41 percent of the District's computer systems have been fixed, according to the June 28, 1999 edition of The Washington Post. The District is planning a massive New Year's Eve mobilization of emergency personnel to ensure that critical city services are not interrupted. Police will be stationed at more than 120 locations across the city, working 12-hour shifts to provide emergency services. Warming centers supplied with food and cots will be opened. The D.C. General Hospital will have 175 extra staff members on site. These are just a few of the 88 contingency plans which the District is working to put into place by the end of the year. Similar efforts are underway across the U.S., according to The Post. The D.C. Police Commander has stated: "We want to reassure the residents and visitors to the District that even if Armageddon comes, we will assist and protect the public."

### **Hyde Bill Seeks to Curb Asset Seizures**

• An odd Legislative Quartet has enlisted the support of the ACLU and the National Rifle Association, as well as groups of bankers, lawyers, realtors, developers, property owners and anti-tax activists, to curb what it sees as systemic abuses by law enforcement of Asset Forfeiture laws. The group, chaired by Republican Henry J. Hyde, author of *Forfeiting Our Property Rights: Is Your Property Safe From Seizure?*, also consists of Democrat John Conyers, conservative Republican Robert Barr, and liberal Democrat Barney Frank. The Civil Asset Forfeiture Reform Act, also called the Hyde bill, sailed through the House Judiciary Committee in June of 1999 after a 27 to 3 vote, and it is expected that some version of this reform will get full House approval.

The Hyde bill would overhaul the current criminal forfeiture laws by shifting the burden of proof in civil cases from the defendant to the government, forcing government prosecutors to produce "clear and convincing evidence" that the assets were "tainted." The Hyde bill would give defendants a chance to get their property back with interest, and it would also provide indigent defendants access to government paid lawyers. Civil Forfeiture laws currently do not have any of these provisions. Police groups are outraged about the Hyde bill, claiming that "these laws aren't about taking property from innocent grandmothers." They argue that the "clear and convincing" standard would deprive police of a crucial deterrent. It would also deprive them of large sums of money. The Justice Department is upset about the bill, as the Washington Post explained on June 23, 1999, "partly because its forfeiture fund raked in a whopping \$449 million last year, up from \$27 million in 1985."

### AIDS-Tainted Blood Sold by Arkansas in 1980s

 Intravenous drug use and unprotected anal sex are an unfortunate fact of life for many of our nation's prison inmates. This is one reason why, in the 1980s, the federal Food and Drug Administration (FDA) ruled that prison plasma was too unsafe to be used for the manufacture of blood products inside the United States. Apparently the FDA did not deem the lives of Canadians worthy of similar protection when it allowed the states of Arkansas (under Governor Bill Clinton) and Louisiana to sell the blood of its prison population to our northern neighbors. In February, 1999, a group of Canadian hemophiliacs who were infected with HIV and hepatitis C from that blood supply filed a \$5 billion lawsuit against the FDA, Arkansas, Louisiana, their prison systems, and Health Management Associates (HMA), which ran the Arkansas prison plasma program from 1978-1984. It is now known that even when tests for AIDS and hepatitis became available, they were not always used. Furthermore, needles were not always sterilized before the bloodletting, and many inmates now claim to have been infected when they gave blood. Francis Henderson, founder of HMA and chairman of its board, has defended his company with the claim that that prison plasma was no riskier than other kinds, and that AIDs cases simply did not exist in the South in the 1980s. (The Economist, March 13, 1999)

### **Satanic Child Sacrifices Said to be Common**

• The tiny headline and brief 5-sentence article suggested a routine news story in the back pages of a recent issue of the *Toronto Globe and Mail*. However, the headline was anything but routine. "Children Sacrificed to Satan," the respected newspaper reported. The article, based on official Bogota, Columbia police statistics and official statements, notes mundanely that "About 15 children are kidnapped each day in Bogota to be delivered to satanic sects, forced into prostitution, or illegally adopted." Most of the children are "sacrificed by satanic sects," according to a police official. The official went on to report that a smaller number are kidnapped "for their organs." ●

The Economic Interests Behind the Yugoslavian Conflict

While the mainstream American media have accepted the government's simplistic explanation for NATO's deadly attacks on Kosovo and Serbia, the region is more complex than President Clinton's "humanitarian" rhetoric. Ironically, both Bill Clinton and former banker Slobodan Milosevic seem intent on obscuring the region's true significance from their people.

Though they have not said so publicly, both men know that the Balkan conflict is about more than the fate of the ethnic Albanians. It is about more than Serbia's desire to maintain its historic and cultural ties to Kosovo. Control of the Balkans is, to a surprisingly large degree, about raw economic interests.

Ccording to the US government, our military action in Yugoslavia has two main goals: to punish Serbian aggression, and to prevent further "ethnic cleansing," in particular to ease the plight of Kosovo's ethnic Albanians. In fact, President Clinton has gone out of his way to claim that this war is *not* being fought for territorial or economic advantage. With Orwellian logic, the government claims that the violence being committed against the Serbian people – which has actually resulted in an increased "cleansing" of most of Kosovo's ethnic Albanians – is a form of "humanitarian assistance."

With the notable exception of the Gulf Conflict, this fits the pattern of justification for America's post-Cold War military excursions. In the official view, the bad old days of Gunboat Diplomacy and American imperialism are over. The US military of the 1990s has become a kind of Red Cross with guns, serving the humanitarian and selfless impulses of America's benevolent rulers. In addition, because the United Nations (or in this case, NATO) is ostensibly calling the shots, America's military might is now held in check by the need to obtain an international consensus before it acts

This last point is of particular concern to some conspiracy theorists, who fear the United States military has become little more than a servant to international elites. They believe that the United States is increasingly surrendering its military and economic sovereignty (i.e., its ability to do what it wants) to supranational entities like the UN and NAFTA. In their view, the placement of US troops in Kosovo as part of a multinational "peacekeeping" force – as will likely happen soon – would just be the latest example of this.

So, the official view holds that the US military has become a rather benign source of "humanitarian assistance" and "peacekeeping," and even then only if it is allowed to do so by some degree of international consensus. A more extreme version of this viewpoint, held by some conspiracy theorists on the Right, depicts the United States as a puppet controlled by international bureaucrats who are out to destroy all notions of national sovereignty. Supporters of both views would point to US actions in the Balkans as an example.

### Anarchy from the U.K.

Another perspective is provided by statesman and Democratic Presidential candidate Lyndon LaRouche (www.larouchepub.com). Once again, we are presented a conspiracy theory that assumes that the United States is not the dominant actor on the world stage. In the April 12, 1999 *New Federalist* newspaper, LaRouche warns that the war against the Serbs is, "like the ongoing war against Iraq, entirely a creation of the [British] Blair government, as 'Desert Storm' was adopted by [the Bush administration] at the behest of the former Thatcher government..."

Other articles in the same newspaper suggest that the U.K.'s motive in orchestrating the Balkan conflict is twofold. First, "to dismantle and loot the former Soviet-bloc states;" and second, to disrupt relations and prevent an alliance between the United States, Russia, and China. Presumably, it would take the combined strength of a US/Russian/Chinese alliance to thwart British geopolitical goals. In particular, the LaRouche publication claims that Britain was "pushed into its war rage" by the possibility that the United States was preparing to join Russia and China in an effort to completely reorganize the ailing world financial system. This reorganization would essentially put the economic welfare of the people ahead of the interests of the international bankers and currency speculators, whom LaRouche believes to be mainly British or British-controlled.

Summarizing the LaRouchian view of the Kosovo crisis, a recent *New Federalist* editorial declared,

"To understand this war, you have to recognize the reality of the terminal economic and financial crisis which is facing the world system. Without knowing that the British financial oligarchy is looking its own extinction in the face, it is impossible to comprehend the fact that this oligarchy would choose to launch wars in

order to stop the consolidation of an alliance of sovereign nations, which would establish a new and just world monetary system."

Before dismissing LaRouche as simplistic due to his "blaming the British for everything," recall that for most of Bill Clinton's two administrations, the President in fact cooled US relations with Britain while strengthening our engagement with Russia and China. The US also followed

policies in Africa and the Middle East that, according to LaRouche, were antithetical to the British government's goals. Also, Clinton made peace in Northern Ireland a major policy objective, and even welcomed Sinn Fein leader Gerry Adams as an official visitor to the White House. Seemingly in response to Clinton's movement against British interests, the 1990s did see a major effort to "Get Clinton" which in fact did originate almost entirely in the British media. [see "The Brits Bash Bubba," PARANOIA Issue 9.1

The LaRouche organization's warnings of a "one world government" - which requires the ultimate destruction of political and economic national sovereignty - is actually similar to warnings that have been made for years on both the Right and the Left of the conspiracy theory spectrum. These warnings differ only in their identification of the ultimate orchestrator of the New World Order. For some, it is the international bureaucrats of the United Nations. For others, it is the international elites of such groups as the Trilateral Commission. For LaRouche, the strings are being pulled by the British Commonwealth.

The A-albionic conspiracy research group (www.a-albionic.com) takes the LaRouche viewpoint a step further. In their view, Britain is indeed a major force working for global domination. However, they believe that there is another force battling Her Majesty behind-the-scenes: the Vatican. In the case of the Balkan conflict, it is interesting to note that the British are on the side of war, while the Vatican has repeatedly condemned the violence.

A more detailed system suggested by A-albionic pits a British-Masonic-Jewish axis against a Vatican-Jesuit-Islamic alliance. Elements of the current Yugoslavian crisis do fit into this conspiratorial scorecard. As stated above, the British are playing a major role in the war, while the Vatican is fighting against it. In addition, the Vatican has a natural connection to Eastern Europe's Orthodox Christians, including the Serbs. On the other hand, the fact that the Serbs are battling the primarily Muslim ethnic Albanians does not "fit" into the suggested constellation of forces.

### The US: Dominated or Dominant?

All these viewpoints ignore the simple truth that, since the collapse of the old Soviet Union, America's military, economic, political, and cultural strength have made it the globe's only superpower. Indeed, a case could be made that the exercise of US military power was constrained more during the Cold War by the Soviet military and nuclear threat than it is today. As a Pentagon analyst wrote in 1991, "Our status as the only superpower must be perpetuated by a military force sufficient to dissuade any nation or group of nations from defying the supremacy of the United States."

As noted by the Stratfor organization in its March 29, 1999 Global Intelligence Update (www.stratfor.com), "Since 1991, an extremely strange and even unnatural disequilibrium dominated the world. The United States presided over a global coalition and isolated any ["rogue"] state that would not participate."

However, Stratfor warns that the world is now in a "massive realignment designed to create an international system that can limit US power." To an extent, this echoes LaRouche, with the major difference that La-Rouche sees the emerging realignment as meant to counter British hegemony. In addition, while LaRouche sees Great Britain as the orchestrator of the conflicts in Yugoslavia and Iraq, Stratfor points the finger at Russia:

"By covertly supplying critical military supplies and providing public political support, Russia created a space in which both the Serbs and Iraqis could resist US military pressure ... The ideal for Russia [is] an ineffective, prolonged campaign in Iraq and an intensive one in Serbia. Neither can succeed, neither can end, [and] both will together sap US military strength while straining the American alliance."

The Stratfor publication goes on to declare that "the big story now is Russia's relation with China. In 1972, China and America ganged up on Russia in order to stop its tremendous momentum. Today, the players shift their partners but the game remains the same. Russia and China have a joint strategic interest in hemming in the United States."

Once again, there are surprising consistencies in the analysis provided by widely disparate sources (increasing US weakness, behind-the-scenes coordination of seemingly chaotic events, an emerging global realignment involving Russia and China, an effort to recolonize and loot Eastern Europe). The differences emerge when these sources assess America's relative strength in the world, and in their view as to which nation America should be most concerned about.

Whether or not you believe that a seemingly weakened Russia is still a threat to America, there is no doubt that the United Nations has become more powerful in this decade. In particular, the 90s have seen a major increase in the strength and deployment of UN power, which is by definition a threat to the power of any individual nation. In a trend that signals an erosion of respect for national sovereignty, the UN has repeatedly deployed its military and inspectors within the borders of sovereign nations which the UN has decided are either too unstable (Somalia, Cambodia) or too

much of a threat to regional stability (Iraq).

However, the only way we will know for sure that the UN has become a serious threat to American sovereignty is when it deploys its power in a way that the US strongly disagrees with. So far, this hasn't happened.

Regarding the LaRouchian view of Great Britain as our true enemy, it is interesting that well before most Americans heard anything about Kosovo, the February 3, 1999 *Times of London* was already declaring that NATO "is planning to deploy ground troops within a sovereign state, turning part of that state into a NATO protectorate." Also, *New Federalist* writer Umberto Pascali has noted in the April 19 edition that

NATO special forces are dominated by Britain in terms of both leadership and personnel. Even the NATO bombing of the Chinese embassy in Yugoslavia, which took place during the preparation of this article, fits the LaRouchian picture. At the very least, LaRouche's focus on economic motives in the Balkans already puts him ahead of most of the mainstream media.

### The Media Falls in Line

Whether following the orders of an international elite, the British Commonwealth, or its own desires, America's post-Cold War military actions have enjoyed an unprecedented degree of media support. Yes, they have sometimes been criticized by mainstream news pundits. However, these "objections" have tended to follow the naïve lament that "we cannot be the world's policeman," as if America is a neutral do-gooder

with no interests to protect or territory it wishes to control. Our status as the most powerful nation on earth has been thrust upon our reluctant shoulders by history, imply the pundits. Note that, unlike every other historic world power, we maintain our position by rendering "humanitarian assistance," rather than by aggressive military, political, and economic policies.

In the case of Kosovo, America's free press has been particularly docile. As Seth Ackerman of FAIR (Fairness and Accuracy in Media) charged in the May 16.

1999 In These Times, "The first casualty of this war was dissent." He notes that every major US newspaper editorialized in favor of the NATO campaign. In addition, on April 1, when the chief UN human rights monitor for Yugoslavia held a press conference to denounce the airstrikes as the "biggest mistake since Vietnam," not a single media outlet saw fit to report his criticism. However, his statement on the human rights situation in Kosovo – released at the same press conference, and more in line with US propaganda needs – was widely reported.

FAIR's Ackerman goes on to note that the attacks have

"elicited a great deal of bloodlust from the pundits," who once again rendered absurd any charges of a so-called "liberal media bias." For example, New York Times foreign affairs columnist Thomas Friedman virtually urged NATO to rack up more civilian deaths when he barked, "Twelve days of surgical bombing was never going to turn Serbia around. Let's see what 12 weeks of less than surgical bombing does. Give war a chance." This sentiment was echoed by Washington Post columnist Charles Krauthammer, who applauded the fact that NATO was "finally hitting targets ... that may indeed kill the enemy and civilians nearby."

### Why Kosovo?

To analyze US and NATO motives in the Balkans, we need to look beyond the news media's shallow war-mongering and cheerleading. We should first examine the official motives and determine if they are an adequate explanation of events.

Are we there to punish Serb aggression? Perhaps, but there are simply too many governments in the world behaving as badly or worse than Serbia for this to be the major motive. Are we there to stop Serbia's "ethnic cleansing?" State violence against targeted ethnic groups is so widespread in the world that, again, Serb violence against Kosovo's ethnic Albanians – while certainly wrong – is not so unique as to merit special attention. For example, as Noam Chomsky has pointed out, the US-supported country of Columbia has created over 1 million refugees, and the level of government-sponsored

political killings there is about at the level of Kosovo. (As an aside, one of the world's most extreme and violent cases of "ethnic cleansing" was practiced by the United States against the Native American population, an irony lost on most news analysts and commentators.)

In addition, the western nations stood by and did nothing to halt the Rwandan genocide of 1994, in which literally hundreds of thousands of people of a certain ethnic affiliation were not just forced from their homes; they were brutally killed by machete-wielding gangs. The dead did receive a belated apology from the US a few years later, one that made no mention of the possibility that the West's lack of interest may have had something to do with the fact that the victims were all black Africans.

Unlike Rwanda, the Balkans are very close geographically to Western Europe, and instability there is naturally seen as more of an immediate threat. In addition,

the ethnic Albanians have the PR advantage of looking more like "us" (i.e. Western elites and news reporters.) Both factors do explain to some degree why NATO has chosen to draw a "line in the dirt" in Kosovo. But is there more at stake in the region?

### **Strange Bedfellows**

Perhaps NATO has been inspired to act by the struggle of the Kosovo Liberation Army (KLA) to gain an independent Kosovo. The KLA, consisting mainly of Albanian Muslims and supported since 1992 by both the United States and Iran, may well become the Contras of the 90s. Indeed, widespread KLA involvement in drug trafficking has been acknowledged even by its supporters. Meanwhile, opponents claim that the KLA and the Albanian mafia are virtually one and the same.

In addition to Iran, the United States is joined in its support for the KLA by none other than America's Public Enemy No. 1, Osama bin Laden. Bin Laden's chief military commander, Ayman al-Zawahiri, is the brother of the KLA's head of elite forces, Muhammed el-Zawahiri. The connection does not end there. In fact, according to Ben Works, director of the Strategic Research Institute, "There's no doubt that bin Laden's people have been in Kosovo helping to arm, equip and train the KLA ... The US Administration's policy in Kosovo is to help bin Laden. It almost seems as if the Clinton Administration's policy is to guarantee more terrorism."

Supporting the KLA, then, appears to be a politically-awkward byproduct of the NATO intervention rather than a major reason for that intervention.

### Jobs, Jobs Jobs

In a rare bit of candor, Secretary of State James Baker admitted that the Gulf Conflict was not about Iraqi aggression or saving Kuwait. No, he told a reporter at the time, it is about "jobs, jobs, jobs." In other words, it was in our domestic economic interest to punish Iraqi aggression and in so doing control the flow of oil from the region. Although it may seem unlikely at first glance, the crisis in the Balkans also concerns the politics of oil, as well as other critical natural resources. It is here, in the realm of naked economic self-interest, that the region's conflicts finally begin to make sense.

As a starting point, consider the Rambouillet Accord, the rejection of which by Slobodan Milosevic was the ostensible reason NATO began bombing. Ostensible, because as we have seen, NATO's decision to bomb and ultimately occupy Yugoslavia was made at least as early as February 3, 1999.

One little-known provision of the Accord demands that "The economy of Kosovo shall function in accordance with free market principles." So, not only would the Accord have imposed NATO military occupation, it also would have forced Kosovo to follow Western "free market" economic policies. It is not too hard to understand why Milosevic rejected such a wholesale surrender of his government's political and economic policymaking authority.

This economic provision of the Accord was noted in an anonymous flyer distributed on the streets of Washington, DC ("Say No! Not NATO.") The flyer succinctly places the conflict in a wider economic context:

"With NATO's growing military presence in Albania, Bosnia, Croatia, Greece, Hungary, and Macedonia, an occupation of Yugoslavia will only solidify NATO control in the Balkans and contain Russia. If the war against Yugoslavia succeeds, the goal of self-determination and economic sustainability for the other Balkan nations will only slip further away."

Likewise, Michael Colon of the Unlimited News Service (www.uns.org) dismisses NATO's "humanitarian" motives, calling the conflict in Yugoslavia simply "A New War for Loot." In this, he shares Lyndon LaRouche's view that the conflict is at least partly about exploiting and looting the former Soviet bloc countries and the Balkan region.

No friend of Lyndon LaRouche, the Left's Noam Chomsky nevertheless sounds a similar theme. He asserts that the West wants to turn Eastern Europe into a "new, easily exploitable part of the Third World." He elaborates:

"There used to be a sort of colonial relationship between Western and Eastern Europe. In fact, the Russians' blocking of that relationship was one of the reasons for the Cold War. Now, it's being reestablished and there's a serious conflict over who's going to win the race for robbery and exploitation ... There are a lot of resources to be taken, and lots of cheap labor. But first we have to impose the capitalist model on them."

Which brings us back to the Rambouillet

Accord and its demand that the Kosovo economy follow "fee market (read Capitalist) principles."

### The Bankers and the Generals

Actually, the international financial community had its eyes on Yugoslavia long before Rambouillet. Beginning in the 1980s, economic "reforms" imposed by Yugoslavia's external creditors (i.e. the IMF, International Monetary Fund) resulted in "the impoverishment of both the Albanian and Serbian populations, contributing to the fueling of ethnic tensions," according to *Covert Action Quarterly*, Spring, 1996. The area's much-lamented ethnic tensions, then, did not just materialize out of thin air. They are at least in part due to policies forced

on Yugoslavia by the international bankers it is beholden to.

Covert Action Quarterly goes on to charge that "Marco-economic reforms imposed by Belgrade's external creditors since the late 1980s have been carefully synchronized with NATO's military and intelligence operations." In other words, the Generals have been dancing with the Bankers in Yugoslavia for many years.

Commenting on the IMF's role in creating the Yugoslavian crisis, Professor Michael Chossudovsky of the University of Ottawa has written:

"By cutting the financial arteries between Belgrade and the [Yugoslavian] republics, the reforms fueled secessionist tendencies that fed on economic factors as well as ethnic divisions, and virtually ensured the de facto secession of the republics. The IMF-induced budgetary crisis created an eco-

nomic fait accompli that paved the way for Croatia's and Slovenia's formal secession in June, 1991."

### Oil, Oil, Oil

Speaking of free markets, the *Sydney (Australia) Morning Herald* of April 28, 1999, reported that the United States had no intention of following suit after the European Union banned oil sales to Yugoslavia. As the newspaper noted, "The disclosure that Ameri-

can firms have been selling oil to the dictator while American pilots have been risking their lives to bomb oil refineries and storage facilities is likely to undercut American efforts to moralize to the rest of the world." Indeed, two weeks into the conflict. Texaco shipped some 65,000 barrels of oil products from a British refinery to Yugoslavia. (Texaco has since stopped selling oil to Yugoslavia.)

In fact, though it has been overshadowed by events in the Middle East, the Balkans also have a history of "oil politics." For example, SUNY Associate Professor of Political Science Gregory P. Nowell has suggested that Italy's invasion of Albania earlier this century was "an oil-driven event." In addition, by 1928 Western oil interests (in particular, British Petro-

leum) had come to dominate Italian and French markets, which had previously been purchasing large amounts of Soviet oil. This was achieved partly through British Petroleum's acquisition of oil concessions in Albania.

More recently, the *Moscow Times* noted on April 13 that the military conflict in Yugoslavia just happened to be hampering a project designed to provide Russian oil to the Mediterranean region. Such subtleties and parallels were not deemed worthy of significant coverage by America's free press, which continued to feed the public endless images of fleeing refugees and blown-up buildings.

### **Black Gold**

Michael Colon quotes a March 1996 issue of the German publication *Die Zeit* regarding what's really at stake in the Balkans: "The oilfields of Kazakhstan, the gas fields of Turkmenistan, [and] the enormous offshore reserves of black gold off Azerbaijan, make up a zone that can gain, over the next fifty years, an importance equal to that of the Persian Gulf today." Furthermore, Colon notes that the world's "most important gold mine" is in Uzbekistan, and the largest deposit of silver is found in Tajikistan. There are even rumors of uranium in the area.

Colon goes on to note the interesting fact that "ferocious wars" always seem to "explode around the routes, real or projected, of [oil and gas] pipelines: Chechnya, Nagomy-Karabakh, Georgia, and Kurdistan."

It should be pointed out that the Unlimited News Service for which Colon has written his article makes no secret of its pro-Communist / Socialist bias. However, before you dismiss Colon's analysis, consider the following statement: "The Gulf War was a symbol of the American preoccupation [with] the security of oil and gas reserves. The frontiers of that preoccupation are advancing to the north and include the Caucuses, Siberia, and Kazakhstan." This farsighted analysis was uttered in 1992 not by some anti-Capitalist radical, but by former US Senate Majority Leader and Republican presidential candidate Bob Dole.

Colon believes that the Balkans are significant because "the oil transport routes must pass by there," in particular along the Danube river. Not coincidentally, "Belgrade [the capital of Yugoslavia] alone occupies a strategic position on the Danube." Furthermore, a proposed oil pipeline project – worth several billions of dollars – would pass through Bulgaria, Macedonia, Albania, and Kosovo. An area of such vital economic interest must be "protected," and "stability" must be imposed.

As Colon suggests, "to justify the installation of military bases [in the Balkan region], there is a need for a local conflict." This, he says, is the real reason why several Western powers armed the Croatian nationalists in 1991, the Muslims of Bosnia in 1993, and

now the Kosovars of the KLA in 1998. "Those who call themselves firemen," he concludes, "need incendiaries."

In addition to oil, natural gas, gold, silver, and possibly uranium, the Balkan region also contains significant coal reserves. In fact, Kosovo itself has some 17 billion tons of coal, according to the director of Kosovo's Stari Trg mining complex. Novak Bjelic has even gone so far as to state that "The war in Kosovo is about the mines, nothing else. This is Serbia's Kuwait – the heart of Kosovo."

Unless you are an avid reader of mining and metallurgical journals, however, you probably were not aware of these facts. The vast majority of US media reports have portrayed Kosovo as an isolated and poor region with no natural resources of any consequence. As writer Sara Flounders pointed out in a recent article on the mines posted to an Internet newsgroup (alt. conspiracy), it is as if during the Gulf Conflict the news media had repeatedly portrayed Kuwait and Iraq as little more than "barren deserts."

### **Another Kind of Pipeline**

In a May 6, 1999 opinion piece for the Times of London, analyst John Laughland also concerns himself with pipelines and their relation to the Kosovo conflict. However, Laughland speaks of a pipeline not of oil but of drugs, particularly heroin. Interestingly, he uses almost exactly the same language as Michael Colon, writing that "the 'ethnic' uprisings which convulse formerly communist states invariably occur at strategically important points on the Eurasian drug route." He defines this route as running "from the heroin fields of Afghanistan, through the former Soviet Central Asian states, Turkish Kurdistan, and into the Balkans."

Laughland goes out of his way to deny that the present conflict has anything to do with oil. "Just as previous wars were fought to control trade routes, whether for oil or other commodities, so this conflict is drug-fueled." Does this make the Kosovo conflict, in effect, little more than drive-by shooting on a global scale?

Certainly, the drug trade has been intertwined with military and covert operations around the world, particularly during the Vietnam war of the 1960s and the Contra war against the Nicaraguan Sandinistas in the 1980s. And there is no doubt that drug profits have corrupted governments and rebel groups around the globe, including the Balkans. However, given the previously-stated facts about the Balkan region's incredible natural resources, Laughland's rather weak argument that this is all just a drug "turf battle" smacks of disinformation. Also, the fact that this disinformation is originating out of London is no coincidence, if one believes the LaRouchian world view.

### **Know Your Enemy**

Despite his region's wealth of natural resources, Slobodan Milosevic likely has non-economic motives as well. However, because he is "The Enemy," the mainstream media have no interest in examining his point of view with any measure of objectivity. It's much easier to parrot the official line that he is an evil madman / Hitler / tin-horn dictator (take your pick) who must be stopped at all costs.

The following scenario might help us to better understand his mindset. It is not a defense of Slobodan Milosevic's actions, but rather a mental exercise designed to demonstrate just how one-sided and incomplete the American media's seemingly intensive coverage of the Kosovo crisis has been.

Ask yourself what would be Bill Clinton's response if America's agricultural heartland produced a group dedicated to achieving the region's "THE WAR IN

independence from the United States. This group has been launching violent attacks on government buildings, and has assassinated a number of policemen and federal officials. Heavily involved in the drug trade, this group is known to be receiving support from Iran as well as Osama bin Laden's organization.

As the crisis intensifies, Clinton sends the FBI and federal troops into the region. NATO grows concerned, and tells the President that he must accept an armed occupation of the Midwest by foreign troops who will act as "peacekeepers." When the President refuses, the bombs begin to fall. ●

## Move Over Y2K The E-Born b S Coming

lectromagnetic pulse (EMP) bombs are weapons of electrical mass destruction. This article is a summary of a paper presented by defense analyst Carlo Kopp (Melbourne, Australia) with regard to the technology base and weapon delivery techniques of EMP devices in warhead and bomb applications. In Kopp's model, EMP weapons can provide a "high payoff" when used against "a highly industrialized and geographically concentrated opponent."

According to Kopp, EMP bombs offer "a very high payoff in attacking the fundamental information processing and communication facilities of a target system." Mass application of these weapons will produce substantial information paralysis.

Complex organizational systems such as governments, industries and military forces cannot function without a flow of information in several directions. By stopping this flow of information, E-bombs can severely debilitate the function of the system. Stopping the outward flow will produce paralysis, since commands cannot reach the elements which are to execute them. Stopping the inward flow will "isolate the decisionmaking element from reality," and will severely inhibit the capacity to make rational decisions.

As Kopp writes, "the mass application of electromagnetic bombs in the opening phase of an electronic battle will allow faster attainment of command of the electromagnetic spectrum," and will "inflict attrition upon

electronic assets at a much faster rate than possible with conventional means." The objective of commanding the electromagnetic spectrum, he writes, is "to interrupt or substantially reduce the flow of information through the opponent's air defense system, air operations environment and between functional elements of weapon systems."

E-bombs cause hard electrical kills over larger areas than conventional explosive weapons of similar mass, Kopp explains. They offer "substantial economies in force size for a given level of inflicted damage," and the non-lethal nature makes their use "far less politically damaging." As a punitive weapon, he writes, E-bombs are the best bet "for dealing with belligerent governments." With a modest commitment of resources, he explains, substantial economic, military and political damage may be inflicted without loss of life. Since the modern military arsenal is packed with electronic hardware, an EMP device can "substantially reduce their function or render them unusable."

E-bombs are becoming a technically feasible way to perform strategic and tactical "Information Warfare," writes Kopp. "The efficient execution of an IW campaign against a modern industrial or post-industrial opponent will require the use of special tools designed to destroy information systems," he writes.


Kopp explains that the EMP effect produces a very short (hundreds of nanoseconds), intense electromagnetic pulse, which propagates away from its source with diminishing intensity. The EMP is, in effect, an electromagnetic shock wave. The energy pulse produces a

powerful electromagnetic field within the vicinity of the weapon burst, which can produce "short lived transient voltages of thousands of Volts (kiloVolts) on exposed electrical conductors."

The EMP effect can result in irreversible damage to a wide range of electrical and electronic equipment, particularly computers and radio or radar receivers, causing irreversible damage or destruction. Kopp compares the damage to close-proximity lightning strikes. Commercial computer equipment is particularly vulnerable to EMP effects, he notes, since it is largely built of high density Metal Oxide Semiconductor (MOS) devices. Since they are very sensitive to high voltage, any voltage in excess of tens of Volts

low-band communications equipment, and television equipment. Kopp explains, "telecommunications equipment can be highly vulnerable, due to the presence of lengthy copper cables between devices; and receivers of all varieties are particularly sensitive to EMP, since the highly sensitive miniature high frequency transistors and diodes in such equipment are easily destroyed by exposure to high voltage electrical transients."

Existing key technologies which go hand in hand with the E-Bomb are: "explosively pumped Flux Compression Generators (FCG), explosive or propellant driven Magneto-Hydrodynamic (MHD) generators and a range of HPM devices, the foremost of which is the Virtual Cathode Oscillator or Vircator." He notes that a wide



can destroy an MOS device. Even if the pulse is not powerful enough to produce thermal damage, the power supply in the equipment will complete the destruction on its own, Kopp explains. Impaired devices may still function, but will be unreliable. Shielding will not work, since the cables running in and out of the equipment will guide the voltage transients into the equipment.

Kopp writes that "Computers used in data processing systems, communications systems, displays, industrial control applications, including road and rail signalling, and those embedded in military equipment, such as signal processors, electronic flight controls and digital engine control systems, are all potentially vulnerable to the EMP effect."

Other electronic devices and electrical equipment which may also be destroyed by the EMP effect include telecommunications equipment, receivers, radar, satellite, microwave, UHF, VHF, HF and

range of experimental designs have been tested in these areas, and the literature is unclassified.

### Warnings

The following points made by Kopp should serve as a warning should E-bombs be deployed somewhere on the planet in the near future:

- 1. Collateral damage. The issue of accuracy of delivery and achievable lethal radius must be taken into account, Kopp explains. In other words, the user must guard against collateral damage "beyond acceptable limits." An inaccurately delivered weapon of large lethal radius may be unusable against a target should the likely collateral electrical damage go beyond the target parameters, and, for instance, into another country. This can be a major issue for users "constrained by treaty provisions on collateral damage," Kopp explains.
- 2. 1940s technology base. Kopp notes that presently the U.S. and the CIS are the only two nations with the

established technology base and experience to design these types of weapons. However, he adds, "the relative simplicity of the FCG and the Vircator suggests that any nation with even a 1940s technology base, once in possession of engineering drawings and specifications for such weapons, could manufacture them."

3. Low Cost. Kopp explains that an effective FCG can be fabricated with basic electrical materials, common plastic explosives such as C-4 or Semtex, and simple machine tools such as lathes and mandrels for forming coils. He writes, "a two stage FCG could be fabricated for a cost as low as \$1,000-2,000, at Western labour rates," and that "this cost could

be even lower in a Third World or newly industrialized economy." He adds the following warning:

- 4. Mass production by First World nations. The relative simplicity and low cost of EM weapons can be considered a benefit to industrialized nations. Yet, Kopp warns, the possibility of less developed nations mass producing such weapons is "alarming." He warns: "The dependence of modern economies upon their information technology infrastructure makes them highly vulnerable to attack with such weapons, providing that these can be delivered to their targets."
- 5. No counterproliferation. At this time no counter-proliferation regimes exist. Should treaties be agreed to limit the proliferation of electromagnetic weapons, they would be impossible to enforce "given the common availability of suitable materials and tools."

Kopp further warns: "With the former CIS

suffering significant economic difficulties, the possibility of CIS designed microwave and pulse power technology leaking out to Third World nations or terrorist organizations should not be discounted. The threat of electromagnetic bomb proliferation is very real."

6. Effect on humans. Kopp notes that EMP weapons "have little, if any, effect on humans." This is a serious point of contention. Electromagnetic radiation and even low level emissions are suspect in such human ailments as cancers, brain tumors, immune disfunction, fatigue syndromes, birth defects, and random cellular mayhem.

7. Vacuum tube equipment. Kopp notes that thermionic technology (vacuum tube equipment) is substantially more resilient to the electromagnetic weapons effects than solid state (transistor) technology. A weapon designed to destroy solid state computers and receivers may cause little or no damage to a thermionic technology device (i.e. early 1960s Soviet military equipment). A "hard electrical kill" may not be achieved against such targets without a suitable weapon.

In addition, Kopp notes, radar or communications equipment may continue to radiate after an attack even though their receivers and data processing systems have been damaged or destroyed; equipment which has been successfully attacked may still appear to operate. Also, an opponent may shut down an emitter if attack is imminent and the absence of emissions means that the success or failure of the attack may not be immediately apparent.

8. Safeguard measures. In short, E-bombs can be an affordable "force multiplier" for military forces under size constraints. However, Kopp warns, it is incumbent upon government and private industry to consider the implications of the proliferation of this technology, and "take measures to safeguard their vital assets from possible future attack." Those who choose not to may become losers in any future wars.

Is this a warning to ourselves?





"Lose your dreams and you will lose your mind."

Ruby Tuesday, The Rolling Stones

The dreamer is describing not only how one comes to accept conditions as they are but also the state of mind in which such acceptance grows. This consists of a readiness to be deceived and a tendency to construct alibi's for oneself; once one has been conditioned long enough by the right combination of pressure and propaganda, he has become so receptive and malleable that all will to resist disappears.

During the 1930's, Nazi Germany's rise to totalitarian power was well under way. Warning signs of the terror to come was being felt by increasing numbers of people. Among them was a young woman of great courage and insight. Charlotte Beradt recorded and collected

people's dreams about the Nazi government's domination of their lives; dreams that tell of the painful political realities of the emerging Nazi State. In his essay at the conclusion of the volume, published in 1966, Bruno Bettelheim remarked that it was a shocking experience reading this book of dreams and seeing how effectively the Nazis murdered sleep, "forcing its enemies to dream dreams that showed that resistance was impossible and that safety lay only in compliance."

The following dream was dreamt by a man in his 30's living in Berlin during the early years of Nazi rule. It demonstrates the potential of our dreamworlds to produce stories that reflect the psycho-political conditions under which we live.

Something within us is registering these disturbing vibrations and sending out signals of danger to the frightened conscious mind.

The author of the dream was told by the Nazi authorities to report to the Berlin Railway Station on a Sunday morning to collect money for the Party. Before leaving he said to himself, "What the heck, I won't be bothered." So he brought along a pillow and blanket — no collection box — and took it easy.

After about an hour Hitler appeared, wearing high patent-leather boots, dressed as a comical cross between a circus clown and a lion tamer. The dreamer watched Hitler use exaggerated, artificial gestures to win the hearts of schoolchildren. Then he adopted a stern attitude as he lectured a group of older boys and girls. At last he turned to impress a group of old maids by acting coquettish. Suddenly the dreamer began to feel uncomfortable under his blanket. He grew afraid that Hitler would notice that he had no collection box — he might be recognized as one of "the group of those who pretend to sleep." If caught, he imagined confronting Hitler and telling him that he doesn't approve of concentration camps.

Hitler continued his appearances around the station with different groups of people, and the dreamer was amazed to see that no one seemed to be afraid of him. He noticed that someone even kept a cigarette in his mouth while talking with him, and many more were smiling! After completing his stint at the station, he picked up his pillow and blanket and went down the main stairway in the station. Then the dreamer saw Hitler standing at the top of the stairs, concluding his appearance with a song from the imaginary opera, Magica, making extremely theatrical gestures, which had the crowd mesmerized. Everybody applauded. He bowed and then went tearing down the stairs, looking foolish in his purple trousers and holding his trainer's whip. Hitler passed by with no bodyguards and stood in line at the cloakroom like everyone else, waiting patiently to get his coat. At this point the dreamer thought, "Maybe he's not so bad after all. Maybe I needn't take the trouble to oppose him." All at once he realized that instead of a pillow and blanket, he was carrying a collection box.

This dreamer sees Hitler as a manipulator par excellence — an animal trainer — and yet the big act that Hitler puts on works in the end: the dreamer begins to feel that things are not half bad and maybe he doesn't have to worry about Hitler after all. Winston Smith, sipping his Victory Gin with tears of gratitude in his eyes, reached a similar conclusion

about Big Brother, although he got there by a different route. The average person struggling with their conscience in the face of dehumanizing conditions, is, like Orwell's hero, "a hero who is basically neither good nor bad, up against the effects of a political system which in the end leaves open but one direction in which he can move - the one toward the movement." Individuals are embedded in a repressive psycho-political system, unable to act independently or resist the forces that are propelling the motion of society in the direction of Nazi domination.

The Third Reich of Dreams is a book that tells a compelling and revealing story about the hidden side of WW II. It portrays how the German subconscious mind was invaded by totalitarian fear as the Nazi's plans reached fever pitch during the 1930's. The grooming of Hitler and his evil cadre, the rise to power of the Nazi State, and the mobilization of the country for Total War, were all carried out with cold-blooded determination and ruthless precision by human beings whose very souls had been violated and whose minds were controlled.

Beradt collected hundreds of dreams during 1933 through 1939, referring to them as "diaries of the night," providing a view into the inner world of fear and confusion people were feeling as their personal integrity disintegrated and their lives fell apart. The dreams she selected for the book are drawn from the lives of ordinary people who found themselves confronting the mental terror of The Third

Reich during the early years of the Nazi regime. These dreams show that this was a war on the human spirit. It was secretly about capturing inner ground and blowing apart the national psyche, destroying all the ground gained over centuries of psycho-spiritual development, doing

away with a whole generation of artists, writers, and scientists, and burying the work of these creative people underneath the rubble and ruin of Total War.

As American citizens who live in the land of the free and the home of the brave, we should have learned from Nazi Germany that psychologically terrified people can be pressured into giving up their democratic rights and living in a police state, once their political power has been stolen from them and their lives have been turned upside down. We now know that Nazi propaganda was bolstered with psychotronic technology that fostered an atmosphere of psycho-political terror, desensitizing feelings and thought control. We have to remember that for over a decade, the frightened minds of average German citizens were unable or unwilling to resist the insane domination of Nazi terror, and so could not, or would not, think for themselves and question authority. The horrifying things that were happening were beyond anyone's control, and so the public was swept along by overpowering Nazi propaganda and State terror, too much in fear to object to the abuse of power, or to do anything about the atrocities carried out against Jews and Communists or others who threatened to undermine The Third Reich.

The Nazis imprisoned and executed people whom they considered sub-human, and those considered enemies of the State. Getting the public to accept this, however tenuous their consent, is something not entirely explainable or understandable by simply saying that Hitler hypnotized the masses. How can human beings stand by and allow their government to enslave and kill people in such a brutal manner and find an acceptable justification for it? Such inhuman behavior cannot be explained merely in terms of people being numbed into apathy for the fate of their fellow humans and allowing themselves to be herded into the mass hysteria of a faceless mob. We must look for the causes of this herd mentality beyond the explanation of "nationalistic frenzy." Racism and Ideology only go so far in explaining the soul-boggling horror involved in their participation in mass slaughter. Patriotism and Blood are the "front men" for the Nazi State, providing a vessel for the forces of the collective unconscious to pour into.

It's because of the work of renegade researchers and writers like Charlotte Beradt that we are able to see beyond the conventional historical perspective and open our minds to reviewing controversial material, and hopefully coming to understand, however vaguely, the underground forces and occult underpinnings of The Third Reich. Propaganda and state terror carried the population along on a wave of animistic hysteria, with millions obeying the rules and regulations of the Nazi mental status quo. Yet, Beradt writes, "from the very beginning people from all walks of life and in all their fear and anxiety were able, dreaming, to recognize the aims and principles of totalitarianism and foresee their consequences, so that their dreams ring prophetic in retrospect."

Today, sixty years later in the USA, the technology of mass mind control has vastly improved and is deadly in its effectiveness. Consequently, the population of the United States is in a worse situation in terms of being forced into mental slavery than were the inhabitants of Germany, Italy, or Russia earlier in the century. American citizens are facing the 90's form of totalitarian fear, and just like the German people thought sixty years ago, we believe that it could never happen here. But it's clear by now that the vast majority of Americans still do not possess an adequate understanding of how their minds work, nor are many citizens any closer to comprehending how the national psyche is being manipulated; in short, we're unable to come to terms with the fact that our subconscious minds are being controlled.

Only century-spanning, trans-generational, psychic genocide can account for the subjugation of the mind that made possible the appalling events of the 20th century. Mass mind control technology has made leaps and bounds of progress over the past half-century; it has succeeded in keeping millions bound to lower levels of consciousness and a self-absorbed existence. Our minds are sinking into the paralyzing stupor of the mental status quo, while our freedom slips away from us and we come closer to facing the apocalyptic abyss that the German people faced over a half century ago.

#### The Mental Status Quo

There are many inexplicable things about our volatile century that beg understanding, that are more often than not left without answers, or even end up producing more questions. Nothing much can be understood without knowing oneself within. Our inner world is much bigger than we imagine, as our dreams allow us to see. There is a hyper-dimensional world of vast inner space within your mind that is beyond the reach of the senses, accessible only by transcendent means. This hidden inner world exists beyond the perceptual horizon of the mental status quo it is the undiscovered realm of the deep psyche where our dreams originate. Unknown to the programmed mind, your awakened perception has access to other dimensions beyond the brain and the senses, and hidden somewhere in that vast uncharted territory is your inner self, your true self. But ego-bound people are afraid that if they sail too far beyond the perceptual horizon of the mental status quo (MSQ), they'll fall off into an inner abyss, like the ships of the flat earth that sailed too far beyond the ocean's horizon and plunged over the edge into bottomless space.

During earlier centuries, people from Europe knew nothing of the existence of the continent that would become known as America. These days we're prevented from exploring higher states of consciousness by an ocean of unconsciousness that isolates us on an inner island, limiting our perceptual horizons to a short egotistical range. There are still too many people in this world who

are unaware that these other dimensions of consciousness are part of our inner geography.

Be warned that there are political consequences for living in our own worlds, as life in Nazi Germany has shown us. As citizens of America we can already see ourselves losing our right to privacy, and we have to retreat further and further away from society in order to escape from the ubiquitous intrusions of the media and other silent invasions of our psyche. Soon there will be nowhere to hide and no privacy for anyone, and we will be facing the horrible political conditions faced by the citizens of Germany during the 30's and 40's as their world fell apart around them, a scary situation illustrated by the following dream.

In 1934, a forty-five-year-old doctor dreamt that he was relaxing on the couch after his consultations reading a book, when suddenly the walls of his apartment disappeared. He looked around and saw, to his horror, that all the other apartments didn't have walls anymore either. Then he heard a loudspeaker boom, "According to the decree of the 17th of this month on the Abolition of Walls..."

Some time later he realized what had provoked the dream. His block warden came around to ask him why he had not hung a flag at his window. Putting him off, he thinks, "Not in my four walls..." In another dream he finds that the only real escape from the "Life Without Walls" was withdrawing from the public realm, because those who give in and go along become part of the Nazi scene and must surrender their autonomy and conform to whatever mental and social conditions that are required of them. "Now that no home is private any more, I'm living at the bottom of the sea."

#### The Nazi MSQ

Conforming to the Nazi MSQ means that you're going along with a set of rules for inner behavior — thought control — while conforming to political conditions means that you're doing what the authorities say — social control. As a result of having to deal with the rules and regulations of the Nazi regime, people were

being coerced into maintaining the mental status quo, a state-approved way of thinking and behaving that came to be known and practiced by everyone, because to say or do otherwise meant getting into trouble with the authorities and putting your life in danger.

The Nazi mentality provided the mind with the linguistic rules and regulations of the German MSQ, which enabled its citizens to think and speak in standard terms. This manufactured mindset channeled thought and converget

conversation in the direction of conformity, and accounted for the underlying set of beliefs that made up the dogma of The Third Reich, a state-sanctioned view of reality.

In 1933 the author of the following dream was a 30-year old, liberal-minded, pampered woman with no profession. In the dream, street signs had been abolished and posters were set up in their place on every corner, proclaiming the twenty words people were not allowed to say. The words were listed in English, the first was "Lord" and the last was "I," and the rest were unclear. This dream anticipates the radical restrictions on freedom of expression about matters relating to one's identity and beliefs that totalitarian regimes have exploited during the 20th century. The posters were substituted for the prohibited street signs, conveying the idea that people had lost their direction, were looking for signposts in their lives, and were finding that they couldn't speak about God or reflect on who they were. The dream is a parable that illustrates "the dialectical relationship that exists between the individual and the dictatorship."

#### The Untold Story of The Unconscious Mind

"What if something should go wrong with the psyche?," asked psychologist Carl Jung over 30 years ago. Jung was a cartographer of inner space and provided humanity with maps and charts of the lost realms of the deep psyche. Without

the knowledge and inspiration of Freud and Jung and other pioneering psychologists, we would still be crawling around in the dark of the mind, classifying altered states of consciousness in religious terms and dumping any kind of transcendent experience into the psychotic and delusional category. During this century it became possible to study the psyche scientifically, enabling us to understand the subconscious basis of conscious aware-

ness, whereas before this century you could only talk about the unconscious mind in occult or religious terms.

Telling the story of the unconscious mind is difficult because it's not so easy to put into words. All the words that could be useful have been taken over by the authorities and corrupted to the core. The reason we find it so difficult to think clearly or speak coherently about the hankypanky going on in the unconscious mind is because most of the terms used to describe renegade states of consciousness have been stripped of their original meaning and painted over with a glossy sheen. Dictionaries and encyclopedia's give descriptions of altered states of consciousness and non-sensory dimensions of the mind like they were psychotic episodes to be neuro-chemically controlled or rendered inactive by psycho-surgery.

It's useless to depend on words when they have so little power over the shackled thoughts of the mentally enslaved. who wouldn't dream of leaving the prison even if they had the keys to unlock their cells. Talking about alien ideas is something so full of verbal booby traps that it just about ruins any chance of seriously investigating what's really going on in any other world except this one. The terms used to describe our inner world as natural and sacred have lost their ability to inspire and guide us, because their meaning has been changed and now we have no structure of thought upon which to build an understanding of ourselves.

Controlling thought in this way reduces the threat that the mind might be led astray by renegade thinking, perhaps discovering the inner curtain and pulling it aside, exposing the shady dealings of the subconscious mind and putting an end to the long-running ego drama. Inner explorers who want to throw some light on the darker side are forced to use matches to illuminate the way, because orthodox religion, behavioral psychology, and materialistic science are drawing most of the illumination from these concepts through their domination of consensus reality and control of language. You can't talk about mind control, can't talk about a secret government, can't talk about hyper-dimensional realities, can't talk about hidden history, can't talk about the age-long story of the Human Spirit, and you can't so much as whisper the naked truth that a big chunk of our mind is missing. Whatever is enforcing unconsciousness must be very powerful because it will not allow any self-reflection or renegade knowledge to threaten its subliminal authority and challenge its hold on the conscious mind.

#### The Guilt of The Guiltless

The woman who dreamt about the twenty words that couldn't be spoken considered herself to be quite selfcentered, yet her dreams reflect a deep understanding of what was at stake if one surrendered their mind to the Nazis. She had a series of dreams between April and September 1933. Not long after her dream about God and Self, she dreamt that she was all dressed up sitting in a box at an opera house with several tiers, being admired by many people as she watched her favorite opera, "The Magic Flute." When it came to the line, "This is the devil certainly," some policemen came stomping in and told her a machine had registered that she thought about Hitler when she heard the word "devil." She looked imploringly to the crowd for some sign of help, but they all just ignored her. She glanced over to the old gentleman in the adjoining box trying to get his eye, but he turned and spit at her.

This dream manages to capture the way so-called respectable people behave when they're called upon to respond to unfairness and injustice in their midst. The opera house with its levels of curved tiers is filled with people who do nothing but sit there and stare straight ahead when someone who they could help is in trouble. Later, the woman described the thought-control machine in her dream as being electric with a maze of wires, envisioning remote-control devices and other electronic methods of monitoring and control that were coming into use during the 30's and 40's.

One night, after being deeply disturbed by radio reports about book burnings, in which the words "truckloads" and "bonfires" were used repeatedly, she dreamt that all books were being collected and burned. Not wanting to part with the copy of "Don Carlos" that she had since her schooldays, she hid it under the maid's bed. When the Stormtroopers arrived to take away the books, they marched straight to the maid's room, pulled the book out from under the bed, and threw it on the truck. At this point she discovered that she hid an atlas and not her copy of "Don Carlos," and felt guilty.

When we dream, there are psychological mechanisms that censor our unconscious motives by distorting them, preventing us from realizing that which we do not wish to be aware. If people are being subjected to extraordinary conditions of control caused by political repression, their dream content will be distorted. One explanation is that the mind is attempting to alter the circumstances that are leading to surrendering control of our lives. Because of this self-censorship, many dream scenarios that deal with themes of submission and complicity have bizarre overtones, in an attempt to change the character of threatening thoughts before they manifest themselves in our dreams.

In her next dream, the milk man, gasman, news vendor, baker, and plumber are standing around her in a circle, holding out their bills. This did not upset her until she noticed a chimney sweep among them. The 2 S's in the German word for chimney sweep, Schornsteinfeger, along with his black outfit, made him appear like a threatening gestapo character. It reminded her of the children's game, Schwarze Kochin, holding out their bills with arms uplifted in the familiar gesture, chanting, "Your guilt cannot be

doubted." What had provoked the dream was that, just the day before, her tailor's son showed up wearing the uniform of a Stormtrooper, to collect the bill she owed his father. She was outraged because, before Hitler, it had been customary to send the bill through the mail, and she demanded an explanation for a government official collecting the money. The embarrassed young man replied that it had no special significance, he just happened to be in the neighborhood and wearing his uniform when he stopped by. "That's ridiculous," she said, but paid the bill anyway.

The woman was aware of how the newly established block warden system functioned and how intrusions were sanctioned by the party uniform. Her dream indicates that she felt guilty about yielding to slight pressure and settling the account. A minor sin of omission, but a significant one, if it leads to more grievous abdications and lapses, "barely recognizable injustices" which keep building up, producing a repressed state of mind that is hard to describe. "The guilt of the guiltless," comes from the accumulation of these tiny abdications and hiding them away in the subconscious, where they show up in disguise in dreams.

#### The Language of Consciousness

It's simply not possible to think about and discuss matters of importance such as the survival of the life of the mind and the preservation of our democratic rights, if the terms and concepts used to describe psychospiritual freedom have had their original meaning squeezed out of them. Today, we cannot speak of threats to our inner freedom, because terms like mind control, secret government, conspiracy theory, the unconscious, paranoia, hidden history — have negative connotations attached to them and deflect the mind away from investigation and study. It's an academic "given" that all these subjects are not to be taken seriously. The inner world beyond the borders of the MSQ appears incomprehensible to people who have never experienced other dimensions of their psyche. But there is no question that an unconscious realm of the human psyche exists. Its psychological conquest and subliminal colonization has been the deepest darkest secret of the 20th century.

Influencing how we think by controlling language keeps our thoughts safely within the bounds of the MSQ, leaving us quite content with ourselves and perfectly willing to spend

the rest of our lives like this. Unable to seriously address things like psychotropic warfare and a global cryptocracy, is a good example of language controlling thought, because if you speak of these things you'll be classified as a "conspiracy theorist" or you'll be thought of as downright crazy by members in good standing of the MSQ Club.

The dream-author had several dreams that repeatedly dealt with the new environmental conditions of total control. The woman's dreams pictured her neighbors sitting in a large circle around her, silent and expressionless, leaving her more imprisoned and lost in each one.

Finally, one dream says it all by containing no images, only words: "Am going to bury myself in lead. Tongue is already leaden, locked in lead. Will lie immobile, shot full of lead. When they come, I'll say, 'The leaden cannot rise up.' Oh! They want to throw me in the water because I'm so leaden..."

She had this dream on New Year's Eve, 1933, after the traditional pouring of molten lead. Like the doctor's dream of seeking refuge at the bottom of the sea, she wishes to become buried in lead, wanting to completely withdraw from the public realm and hide from herself in the process. These dream-fables are a warning of the insidious mental intrusions that are gradually taking over the consciousness of the people, interfering with the relationship one has with their inner self.

The profusion of prohibitive regulations, along with the steady control the population, were placing increasing pressure on THE DREAMER

people's lives, which wore down their will and tore away their defenses, leaving many people compliant slaves at the feet of their mental masters in only a few short years. Yet while this may have been taking place imperceptibly, so that people became gradually accustomed to the takeover of their minds, their dreams were showing this process taking place quite clearly. All the small steps it took to get to this groveling position are there to be seen in their dreams. If one reflects on such dreams and discerns their wisdom, perhaps people wouldn't allow themselves to become disconnected from their inner selves, and they wouldn't make very good Nazis. Which is why even dreamland is invaded by The Third Reich.

#### The MSQ Renegades

Drowning people's lives in prohibitive regulations drove some people to the brink and others into denial. If they had no way of dealing with these forces of coercion and repression, the only thing

they could do is surrender to the authorities and submit their lives to the will of the Nazi State. But some people must attempt to resist these insidious intrusions into their minds and try to stop this domination of their lives by performing simple acts of defiance. Everyday refusals to take part in the ritual destruction of human dignity show the Spirit surviving in the midst of dehumanization. These are the free thinkers who the authorities fear the most, because people who have discovered their inner power and are willing to stand up to The Third Reich are more threatening to the stability of the Nazi State than all their other enemies combined.

The following dream was dreamt by a student whose brother had been arrested, which caused considerable strain and difficulty in his life. There was a party going on in a large building. People who could be arrested for political crimes against the Nazi State, for example degenerate artists and performers, one-time socialists, and relatives of concentration camp inmates, were all sitting in a small attic room, making fun of the well-dressed guests arriving downstairs. The dreamer crept downstairs and overheard someone say that the whole house was filled with tension, and that the stairs to the attic had caught fire as a result.! "The suspects have to be saved " he yelled into the bedlam. But they only shrugged, "Why shouldn't the suspects go up in flames?" Suspects are to be defined by the State, and so they get to say who are suspects. In short, everyone is a potential enemy of the state, lumping together internee and relative, artist and friend, activist and employer, into the single category of suspect.

Communists can be dealt with using terror tactics and political subversion, but ordinary people who are inner freedom fighters are another matter altogether. They're not so easy to dominate and they remain a threat to the State by defending the Individual Human Spirit. They won't allow their mind to be taken over by any outer authority and they will not participate in any activity where they have to betray themselves or hurt others. As long as such people exist, there is a force for the Nazis to reckon with that is beyond their capacity to deal with and control, because the inner worlds of these human beings have not been violated by the insidious effects of mass mind control.

The following dream, which occurred in the autumn of 1933, was dreamt by an elderly woman who was a mathematics teacher. In her dream it was forbidden under penalty of death to write anything having to do with mathematics. This woman took refuge in a night club, which in waking life she would never have set foot in. The place was filled with drunkards and prostitutes and the music was blaring on. She took a piece of tissue paper from her pocketbook and wrote down a couple of equations in invisible ink, all the time being frightened to death.

Her dream reflects how absurd it is to attempt to ban something that people naturally do everyday. When asked to comment on her dream, she replied simply, "It is impossible to forbid what they are forbidding here!" In her dream, she chose a nightclub to perform her act of defiance, someplace no one would expect to find her, and a place where other forbidden things are going on.

Sitting at a table in the dimly-lit club, she works with the tools of spies to copy the equations that will ensure that her profession survives the destructive forces set against it. As the environment is being transformed by the machinations of the Nazi State, people are becoming alienated from one another and disconnected from the activities that make up their daily lives. Individuals are being taken away from their communities and being turned into obedient servants of the Reich. Yet there are always defiant ones who resist becoming dehumanized, because they are keeping alive within themselves the flame of the Individual Human spirit.

#### The American MSQ

Our media-saturated minds are being anesthetized with overdoses of doublethink and overflowing mouthfuls of newspeak. And our beleaguered brains are being subliminally and vibrationally assaulted everyday, to the point of dangerous psychic depletion and extreme spiritual vulnerability. New dimensions of language are needed to orient our minds to hyperdimensional realities and to provide a para-linguistic structure to work with these renegade ideas. The transcendent dimensions of language that address the life of the mind are kept out of reach of our thought processes and continue to remain inaccessible to most of us. There are powerful occult forces keeping people unconscious, so it may be expecting too much to think that we could overcome our intense fear of waking up to the transcendent dimensions of our lives.

As Orwell warned, once you take over the language, there is thought control, and then it becomes impossible to think for oneself or question the authorities. What is needed is for each mind to take back the language and personally get rid of all the hype and trivia given to terms whose meaning relates to secret dimensions of consciousness and hidden aspects of history. We need a viable language that is equal to the hyper-dimensional realities it is attempting to describe. In a mathematical way, physics was confronted by the same problem earlier in the century, when its formulas and equations ran up against hyper-dimensional phenomena it just couldn't explain with current theories. There had to be a bigger picture to see what was happening, and relativity and quantum theories provided that greater perspective.

With the new world order closing in fast, our language needs to undergo a corresponding revolution, as the written word attempts to define and conceptualize other dimensions of reality beyond the range of the MSQ and the prevailing consensus reality. There is no other way to approach this perceptual transformation of our minds: the power of the

word — freely thought, spoken, and written. Our psycho-spiritual freedom depends upon their survival.

#### The Upraised Arm

During the 80's & 90's, American citizens have lost, and are still losing, more of our political power and rights through the encroachment on the freedom of the individual of frightening federal laws, but many of us are waking up to what's going on behind our backs, or maybe I should say, beyond our comprehension. People today are confronting the same fear of unknown forces that the German people were facing during the 30's, and the subconscious minds of individuals are registering the steady erosion of freedom and its debilitating effects on their daily lives. As the new world order is closing in fast, perhaps people in the United States are dreaming similar dreams.

Three days after Hitler seized power in Germany, Herr S., a 60 year old factory owner, dreamt that he was under so much pressure trying to reconcile his worldly ambitions with his conscience, that he "cracked" from the stress, "breaking his backbone," leaving him a moral invalid, and no one even laid a hand on him. In the dream, Goebbels was visiting his factory and had all the workers line up in two rows facing each other. Herr S. had to stand in the middle and raise his arm in the Nazi salute. It took him half an hour to get his arm up, inch by inch. Goebbels showed neither approval nor disapproval as he watched him struggle. When he finally got his arm up, Goebbels said, "I don't want your salute" then turned and went to the door. There the factory owner stood, arm raised, in the midst of his workers, only able to keep himself from collapsing by staring at Goebbels' clubfoot as he limped out of the factory. As so he stood until he woke up.

This dream recurred many times and in one version, "The effort of lifting my arm was go great that sweat poured down my face like tears, as if I were crying in front of Goebbels." And in another: "I looked to my workers for a sign of comfort but their faces showed absolute emptiness, not even scorn or contempt." Finally, while struggling to lift his arm, his back — his "backbone" — breaks. This was a man with lifelong political convictions and who had a strong paternalistic attitude toward his employees. Through several demeaning episodes he is forced to humiliate and debase himself in his own domain in front of his employees, by having to submit to conditions that make him lose his self-respect, and through being coerced into conforming to laws that are unfair and immoral. Herr S. was once a proud man who commanded respect, but now "he feels alienated not only from all that is real in his life but also from his own character, which has lost its authenticity."

Dreams such as the ones Beradt collected were dreamt by ordinary people confronting repressive conditions, who were looking for psychological ways of dealing with the silent impact of explosive social changes. Charlotte had difficulty gathering material because people were afraid to confide their dreams, and she often heard them say, "I dreamt it was forbidden to dream, but I did anyway." She states that the dreams produced by German citizens during the 1930's, unlike the dreams of the victims of wars and revolution of previous centuries, were distinctive in character and content, because "their origin in time and place is explicit: they could only have sprung from man's paradoxical existence under a twentieth-century

totalitarian regime, and most of them nowhere but under the Hitler dictatorship in Germany."

At some point during her investigation, Beradt realized that these dreams were important seismic readings registering the debilitating effects of totalitarian stress on the minds and lives of ordinary German citizens. Looking at how each dream reflected a personal journey toward dehumanization, with the dream-authors backing away step by step from their former way of life, demonstrated to her that "the minor incident, the personally relevant factor, shows how Nazi totalitarianism functioned." She wrote:

"It occurred to me from time to time that a record should be kept of such dreams, a thought that now became a plan. They might one day serve as evidence when the time came to pass judgement on National Socialism as a historical phenomenon, for they seemed to reveal a great deal about people's deepest feelings and reactions as they become part of the mechanisms of totalitarianism. When a person sits down to keep a diary, this is a deliberate act, and he remolds, clarifies, or obscures his reactions. But while seeming to record seismographically the slightest effects of political events on the psyche, these dreams - diaries of the night - were conceived independently of their author's conscious will. They were, so to speak, dictated to them by the dictatorship. Dream imagery might thus help to describe the structure of a reality that was just on the verge of becoming a nightmare."

At the end of her book Beradt says that these dreams contain a warning, "the warning that totalitarian tendencies must be recognized before they become overt — before the guise is dropped ... before people no longer may speak the word "I" and must guard their tongue so that not even they understand what they say, and before we begin to actually live the "Life Without Walls." •

## Psychiatry Kills

Are Psychiatric Drugs
Part of of a
Crypto-Eugenics
Conspiracy?

Involuntary drugging is no longer only a concern to those locked away in an institution. Laws quietly passed in 36 states now allow the government to court order you to take psychiatric drugs. Known as "Involuntary Outpatient Commitment" (IOC), these court orders typically require the subject to report to a community mental health center every few weeks for a "depot injection" of a neuroleptic drug such as Prolixin or Haldol. IOCs are routinely re-approved, so the injections can go on for years. It's time to ask: Just how safe are psychiatric drugs?

his report will prove conclusively that neuroleptic drugs (also known as antipsychotics, tranquilizers, or psychotropics) shorten life span, destroy sexual function and fertility, and take away one's sense of well-being, which can precipitate suicide and/or violent behavior. This will be established through a basic explanation of some facets of biochemistry, and by quoting reputable sources. I also hope to empower the people who may be affected by this with knowledge they can use to defend their rights and help overturn their local IOC laws.

Following is a list of just a few of the many neuroleptic drugs, by generic name (the brand names will differ): Chlorpromazine, Fluphenazine, Perphenazine, Prochlorperazine, Promazine, Thioridazine, Haloperadol, Zyprexa, Sertindole, Ziprasidone, Amperozide, Remoxipride, Melperone, Zotepine, Isofloxythepin, Setoperone, Perospirone, and Quetiapine. Also, the antidepressant drug Sertraline (brand name Zoloft) is molecularly indistinguishable from that of the neuroleptics. These drugs are not just given to those labeled as "schizophrenic" or "psychotic." These drugs are often given to people with depression, manic depression (bipolar disorder), Alzheimer's Disease, brain damage or head injuries, the retarded, and children with Attention Deficit Disorder, among other groups.

The compulsory administration of neuroleptic drugs by order of the state is a violation of one's right to liberty, life and the pursuit of happiness; the right to life because

neuroleptics shorten life span and induce degenerative disease; the right to the pursuit of happiness because neuroleptics take away one's sense of well-being; and the right to liberty when one cannot make one's own decision regarding the administration of these drugs.

#### **Metabolic Mayhem**

The increased body temperature from a good metabolism stimulates the production of the anabolic hormone testosterone, and anabolism keeps the body rejuvenated and fights aging. Interfering with this process lowers metabolism and shortens life span. Lowered metabolism causes weight gain and, according to the American Medical Association's own statistics, the more overweight a person is the more likely that person will suffer a premature death. Neuroleptic drugs suppress the production of T4 thereby lowering metabolism by suppressing the release of the hypothalamic hormone TRH.

Metabolism is the main mechanism that promotes thermogenesis. Thermogenesis is the production of body heat from the burning of fatty acids and glucose when body heat is lost, due to both exposure to cold temperatures and continuous normal loss of body heat. It is T4 in the end that is responsible for helping to generate body heat that is lost and to maintain the body's metabolism, which includes both catabolism (the burning of fat and glucose as fuel) and anabolism (the building up of the body with replacement biochemical substances which fight aging).

Neuroleptic drugs disable thermoregulatory mechanisms. The AHFS 96 Drug Information book states: "Phenothiazines have a poikilothermic effect, interfering with temperature regulation in the hypothalamus: depending on environmental conditions, hypothermia or hyperthermia can occur." Hypothermia is underheating of the body and hyperthermia is overheating of the body. Many people forced to take neuroleptics have died of heatstroke. According to Drug Info for the Health Care Professional, (17th edition, volume I, 1997, p. 2321) neuroleptics depress the release of hypothalamic and hypophyseal hormones. These effects are the result of blockage or destruction of dopamine receptors within the hypothalamus. Suppression of this hormonal system is one of the main mechanisms by which neuroleptics shorten life span.

In addition, according to *Drug Info for the Health Care Professional*, the drug "haloperidol" (a neuroleptic in a class by itself), causes effects similar to that of phenothiazines. This book states that, "all neuroleptics block or destroy dopamine receptors so therefore all suppress hypothalamic hormone secretion." According to the book,

Fats that Heal Fats that Kill, "decreased metabolic rate is also involved in aging, arthritic diseases, cancer, and cardiovascular disorders, and is another general symptom of degenerative disease." It is clear that decreased metabolic rate leads to obesity and degenerative disease. Not only do neuroleptic drugs shorten life span, but also make life inferior due to inducing the onset of degenerative disease.

According to the book Drug Info for the Health Care Professional, neuroleptics "block postsynaptic mesolimbic dopaminergic receptors in the brain ... [and] ... depress the release of hypothalamic and hypophyseal hormones." Hypophyseal hormones are produced by the pituitary gland. Because hypothalamic hormones control the release of pituitary hormones. pituitary hormones are suppressed. Most hypothalamic hormones are releasing hormones. One hypothalamic hormone is prolactin releaseinhibiting hormone. Since neuroleptic drugs suppress the release of this inhibiting hormone, the pituitary is free to secrete abnormal amounts of this female hormone that regulates lactation into the blood stream of both males and females. Most other bodily hormones are suppressed by neuroleptics, except for

prolactin for this reason. Since phenothiazines were the first neuroleptics used, starting with Thorazine, and the fact that phenothiazines have been used on more people than all other neuroleptics combined, the affect on hormone production caused by these drugs has been well established. All the other neuroleptics have been designed after what has been learned from the phenothiazines.

#### **Sexual Dysfunction**

Serotonin is an inhibiting neurotransmitter that mediates the function of the dopaminergic system. Excess serotonin stimulation has the effect of suppressing the dopaminergic system. One neuroleptic called Molindone (brand names Lidone and Moban) utilizes this function by mimicking serotonin. Also this is why antidepressant drugs that raise levels of serotonin cause sexual dysfunction. One "antidepressant" drug Sertraline (Brand name Zoloft) is molecularly indistinguishable from that of the neuroleptics. In fact, Zoloft has even been tried as a neuroleptic. A man I talked to on the telephone at the FDA told me that Zoloft was so powerful at destroying sexual function that if just one pill is taken by someone with premature ejaculation it will slow him down. But don't take this man's word for it. Even the PDR says Zoloft causes sexual dysfunction. Percentage rates of impotence listed in the PDR for various drugs is misleading, as only people who were sexually active and not embarrassed to speak about it would even report impotence or sexual dysfunction as a side effect. Every male I have questioned who has been on these drugs has confided that these drugs have caused major sexual problems.

Since neuroleptics block or destroy dopamine receptors, there is no dopaminergic activity to inhibit prolactin secretion. Prolactin secretion has a dramatic effect in blocking the pituitary gonadotrophs, and elevated prolactin levels are associated with sexual dysfunction. Hyperprolactinemia before puberty blocks sexual maturation and the pubertal growth spurt. After puberty, hyperprolactinemia is associated with loss of libido and impotence in males and amenorrhea in females. The gonads are testicles in men and ovaries in women, and amenorrea is the abnormal suspension or suppression of menstruation. Hyperprolactinemia is the abnormal excessive production of the female hormone prolactin.

The other pituitary gonadotroph is follicle stimulating hormone (abbreviated FSH, also called Follotropin or gonadotrophin I). See also Handbook of Vitamins, Minerals and Hormones (p. 330), where it states that this hormone is required for reproduction, and that deficiency of this hormone causes "decreased gametogenic function and development (nonfunctional)." This is just a fancy way of saying that deficiency of this hormone will cause any sperm or ova produced to be genetically incapable of producing offspring or rendering any sperm or ova (eggs) produced "nonfunctional." This book also states that deficiency of this hormone causes "atrophy of the gonads," "no maturation of ova, sperm," "obesity," "decreased livido, potency, hair growth," and "decreased blood levels of estrogen." Pituitary gonadotrophs stimulate the production of sex hormones by the gonads.

Neuroleptic drugs inhibit sex hormones. Estradiol (estrogen) is essential for reproduction and female characteristics. Its chief functions are to maintain and regulate female sex characteristics and behavior, command of female sexual development, and maintenance of female body characteristics and behavior. As stated in the book Handbook of Vitamins, Minerals and Hormones, "deficiency of estrogen will cause "delayed maturation," "female accessory and reproductive organs recess," "decreased female behavior pattern," "senescence" (aging), and "menopause." Here is further proof that neuroleptic drugs program the body to self-destruct, to grow old and die, and proof that these drugs prevent reproduction.

Another female hormone that is stimulated by the hypothalamic hormone, through the pituitary hormone luteinizing hormone is progesterone. Neuroleptics inhibit the production of this hormone as well. According to Handbook of Vitamins, Minerals and Hormones, progesterone "is indirectly essential for life, since it is a precursor to aldosterone and cortisol, which is essential. Its chief functions are to synergize the actions of estradiol (estrogen) in the female organs, especially during pregnancy. Its importance stems from the fact that it is a precursor to all the steroid hormones and that estradiol (estrogen) requires its presence for many of its actions. ...Deficiency conditions [include]... dysfunctional uterine

This book also states that deficiency of progesterone causes "termination of pregnancy," "decreased production of steroids," decreased ovulation," "loss of normal cyclic changes" and "decreased development for implantation and gestation." This is shocking because neuroleptics are routinely given to pregnant women who commonly have miscarriages, and then the prescribing psychiatrists deny that the drugs were the cause!

Testosterone's chief functions are: "development and maintenance of the male organs, male sex characteristics and behavior, as well as stimulation of growth (anabolic), metabolism of muscles, liver and kidney. The chief importance of testosterone lies in its major command of male sex development, body characteristics, and behavior. Deficiencies include eunuchoidism, and male hypogonadism. ... Testosterone is formed mainly in the testes (interstitial cells) but also in small amounts in the adrenal cortex and the ovary[s]." (Handbook of Vitamins, Minerals and Hormones, p. 431) According to this book, deficiency of testosterone will cause, "involution of accessory organs (prostate, seminal vesicles)," (progressive decline of normal functioning, or decrease in size), "decreased male behavior patterns and libido," "decreased secondary sex traits," "poor muscle development and function." Neuroleptic drugs will destroy sexual function in men and produce sterility, and will cause musculature to waste away, since neuroleptic drugs suppress the production of testosterone. All neuroleptics

will cause testicular atrophy due to hormonal suppression.

According to *Handbook of Vitamins, Minerals and Hormones* (p. 401), since aldosterone is "one of the most essential of all hormones; absence can be fatal in [a] short time period." According to *Facts and Comparisons*, after the administration of neuroleptics, "sudden death has occasionally been reported." Could this be partly due to the inhibition of aldosterone secretion by these neuroleptic drugs? Aldosterone secretion is partly governed by the pituitary hormone ACTH, which is in turn governed by release of the hypothalamic hormone corticotropin-releasing hormone, or corticotrophin-releasing hormone.

According to Handbook of Vitamins Minerals and Hormones (p. 342), ACTH is "one of the most essential hormones-Absence causes notable shortening of normal life span." This book also states that deficiency of ACTH causes "decreased weight of adrenal (atrophy)," "decreased mobilization of free fatty acids" (so fat can be burned as fuel), "decreased steroids in blood, urine (17-hydroxy and 17-keto)," fasting hypoglycemia" and "increased insulin sensitivity." Ketones are produced as a biproduct of the burning of fat as fuel. Since difficiency of ACTH decreases ketones, this means that fat is not being utilized as fuel which will lead to weight gain.

It is also common for people on neuroleptic drugs to be glucose intolerant. Since neuroleptic drugs inhibit the production of all the hormones described above, they also cause all the problems as ociated with deficiency of these hormones. Neuroleptic drugs not only shorten life span, but also destroy sexual function and fer lity.

Neuroleptic drugs also suppress the release of pituitary growth hormone, GH, also called somatotropin. You may think that this is not a problem because most of the people taking these drugs are adults, however, a growing number of children with ADD or similar "conduct disorders" are being given these drugs. In addition, growth hormone has other functions in adults. According to Handbook of Vitamins Minerals and Hormones (p. 307), "because growth hormone controls the nitrogen balance of an organism, it is thought to be involved in the aging process." This source also explains that absence of growth hormone will result in a "decrease in normal life span,"

and that deficiency will result in "increased fat deposition." Here is further evidence that neuroleptic drugs shorten life span. Therefore, the compulsory administration of neuroleptic drugs by court order of the state is a violation of one's right to life.

#### **Comparison to Nerve Gas and Insecticides**

Neuroleptics also have "anticholinergic blocking effects." Acetylcholine is a neurotransmitter.

The brain produces an enzyme called acetylcholinesterase to break down excess acetylcholine, to prevent it from accumulating to abnormal levels. Neuroleptic drugs have "anticholinergic blocking effects," meaning they cause the accumulation of acetylcholine to abnormal levels. Nerve gas causes death by its anticholinergic blocking activity. Insecticide kills insects by the same method; by causing an abnormal build up of acetylcholine in the brain and nervous system of the insect.

According to Facts and Comparisons "antipsychotic agents" exert "anticholinergic and alpha-adrenergic blocking effects." The following excerpt is from Richard M. Restak, M.D.'s book Brainscapes (p. 57):

"After a neurotransmitter and it's receptor have reacted, the process must be brought to a halt, which is accomplished either by the There is proof that neuroleptic drugs program the body to self-destruct, to grow old and die, and proof that these drugs prevent reproduction.

destruction of the neurotransmitter and recycling of it's constituents, or by a so-called reuptake system, whereby the neurotransmitter is recaptured and stored once again within the vesicle. In the case of acetylcholine, the process involves a breakdown brought about by the enzyme acetylcholinesterase, which cleaves the neurotransmitter back to its original chemical building blocks. This process can be interfered with by compounds responsible for some of the worst horrors of twentieth-century warfare. ... Nerve gases, such as the deadly Sarin released into the subway system in Tokyo in March 1995, form irreversible bonds with anticholinesterase [acetylcholinesterase], thus inhibiting the enzymes' ability to break down acetylcholine in the synapse."

#### Dr. Restak also states (p. 121):

"Many pesticides are designed to attack the nervous system of insects by altering the breakdown of acetylcholine. Not surprisingly, these agents also act on our brains and nervous systems to produce symptoms like weakness, difficulty in breathing, visual disturbances, and in some cases explosive violence. With low rates of

exposure the problems are more subtle, a prevailing sense of tension, disturbed sleep, restlessness, chronic anxiety, and nervousness when standing in lines."

All of these symptoms can be observed in people on neuroleptics; for instance "visual disturbances." According to *Facts and Comparisons*, neuroleptics will cause "glaucoma; photophobia; blurred vision; miosis; mydriasis; ptosis; star-shaped lenticular opacities; epithelial keratopathies; pigmentary retinopathy. Eye lesions may regress after drug withdrawal." Also, as Dr. Restak reports, insecticide exposure will cause "restlessness" and or "nervousness when standing in lines." This has been given a name "Akathisia." Facts and Comparisons states that neuroleptics also cause "a condition of constant motor restlessness [called akathisia] and may include feelings of muscle quivering, an inability to sit still and an urge to constantly move about." In addition, insecticide exposure will cause "difficulty breathing." Neuroleptics also cause "laryngospasm; bronchospasm; increased depth of respiration; dyspnea (shortness of breath)." Insecticide exposure will cause "weakness." Neuroleptic drugs will also cause "cerebral edema, headache, weakness, tremor, staggering gait; twitching; tension; jitteriness; akinesia; ataxia; fatigue; slurring [of speech]; abnormal cerebrospinal fluid proteins." (Facts and Comparisons.)

Dr. Restak reports that insecticide exposure will cause "disturbed sleep." Facts and Comparisons states that neuroleptics cause "insomnia," "nocturnal confusion," and "bizarre dreams." Restak also reports that insecticide exposure will cause "a prevailing sense of tension." Facts and Comparisons states that neuroleptics cause "tension." Also he reports that insecticide exposure will cause "anxiety." According to James W. Long, M.D. in The Essential Guide to Prescription Drugs (Revised, 1980, p. 344) the drug haloperadol (a neuroleptic drug) can cause "anxiety." Also Dr. Restak reports that insecticide exposure causes "in some cases, explosive violence." The book Facts and Comparisons reiterates that neuroleptics can cause "hyperactivity" and "agitation."

Nerve gas and insecticides are poisons, and neuroleptics have blatantly poisonous properties in that part of their function is the same as that of nerve gas and insecticides, by way of causing an abnormal build-up of acetylcholine. In fact, the very molecular base of one class of neuroleptics called phenothiazines is used as an insecticide! According to the book AHFS 96 Drug Information American Hospital Formulary Service, "Phenothiazine [a class of neuroleptics] is still used as an anthelmintic in veterinary medicine and as an insecticide." The very insecticides that Dr. Restak is referring to are being given to those labeled mentally ill as a claimed "beneficial medical treatment"! Here is further evidence that neuroleptics shorten life span. All neuroleptics interfere with the breakdown of acetylcholine, so don't assume that because the drug isn't a phenothiazine that it will not have these effects.

#### An Interesting Star Trek Episode

The well-known effect of excess acetylcholine was even the theme for an entertaining Star Trek Voyager episode called "The Chute." In this episode, two members of the crew were abducted and placed aboard a space station prison. In order to keep the prison population down the prisoners where unknowingly exposed to a chemical that caused the build up of acetylcholine by interfering with its breakdown. This caused the prisoners to be violent and enraged, often killing each other. After the crew members were rescued, the "holographic" doctor on Voyager revealed that it was interference with the breakdown of acetylcholine that was causing the violence, and that the prison's operators must be using the chemical to keep the prison's population down. (Could this be why many prisoners in the USA are forced or coerced into taking neuroleptic drugs?) Ironically, neuroleptic drugs are often prescribed under the pretense that they will prevent violence when in reality they can promote it.

#### The "Reward System"

This leads to another problem with neuroleptic drugs. Within the limbic system of the brain is an electrochemical cascade called the "reward system." This system is responsible for giving a person their sense of well-being. As a result of disruption of this electrochemical neuronal cascade, one's sense of well-being is supplanted with negative emotions, anxiety, depression and anger. The end result of the reward system's neuronal cascade is stimulation of dopamine D2 receptors within the nucleus accumbens and the hippocampus, which are located within the limbic system of the brain.

Neuroleptic drugs block or destroy dopamine D2 receptors preventing their stimulation by the neurotransmitter dopamine. According to Facts and Comparisons, "antipsychotics block postsynaptic dopamine receptors in the basal ganglia, hypothalamus, limbic system, brain stem and medulla. ... The phenothiazines appear to act at both D1 and D2 receptors, whereas haloperadol appears to act primarily at D2 receptors." This is very self destructive to the body and will result in a premature death, if one doesn't commit suicide first. Ironically, these drugs are prescribed to people to prevent suicide when in reality they can promote it. Perhaps the designers of these drugs want to give the person that extra amount to push them over the edge. Both times I was on these drugs for extended periods, I attempted suicide because of them.

According to American Scientist magazine (March-April 1996) "If the activity of the dopamine D2 receptor is deficient, the activity of neurons in the nucleus accumbens and the hippocampus is decreased, and the individual experiences unpleasant emotions or cravings for substances that can provide temporary relief by releasing dopamine." This article states that disruption of the stimulation of D2 receptors as part of the "reward cascade" will "supplant an individual's feeling of well-being with anxiety, anger or a craving for a substance that can alleviate the negative emotions." This article explains that "reward deficiency syndrome" is the cause of behavioral disorders such as attention deficit disorder (with and without hyperactivity), personality disorder, conduct disorder, antisocial personality, aggressive behavior, and autism (abnormal introversion and egocentricity, acceptance of fantasy rather than reality).

The damage caused by neuroleptics to the dopaminergic system is long term. After reading this article, I came to understand the source of many of my own problems and why neuroleptics were exacerbating them; and also why I had an insatiable craving for alcohol whenever I was on neuroleptics, which persisted for a long time after they were discontinued. These drugs cause restlessness, hyperactivity, agitation, depression, and paranoid reactions (*Facts and Comparisons*), as well as "anxiety" and a "reduced capacity to deal with stress." (*The Essential Guide to Prescription Drugs Revised Edition*)

#### **Connection to Eugenics**

The motivation behind the administration of antipsychotic or neuroleptic drugs to the "mentally ill" and others is eugenic in nature. Eugenics is the idea that the human race can be improved by preventing "inferior stock" from reproducing, and by inducing an early death. Eugenics got its start with psychiatrists in the USA. Later Hitler shocked the world with the holocaust of millions of people, basing his program on eugenics practices that were already being carried out in the USA. The first to be killed in Nazi Germany was the "mentally ill."

Before Hitler did the things he did, the forced sterilization of the "mentally ill" in the USA was common practice. But, as you are probably starting to see after reading the evidence centered on neuroleptic drugs, the same eugenics program is being covertly carried out under the guise of a "beneficial medical treatment." In the 1960s, the Eugenics Society of England adopted what they called "Crypto-eugenics," stating in their official reports that they would do eugenics through means and instruments not labeled as eugenics. Abortion and the push of birth control drugs is also part of this eugenics conspiracy.

Following World War II, one third of all psychiatrists in the USA were former Nazis. The following excerpt is taken from a public service publication entitled "Psychiatry Destroying Religion in the Name of Salvation" by the Citizens Commission on Human Rights:

"While psychiatry has tried to expunge any connection between itself and the racial genocide of the Nazi Holocaust, the hard fact is that psychiatry spawned "eugenics" almost three decades before the Nazis took power in 1933. It was psychiatry that turned the Nazis into the mass murders, not vice versa. And it was their ideology which fired Hitler's mania to eradicate religion."

As early as 1895, German psychiatrist Alfred Ploetz wrote: "Should it turn out that in spite of it the newborn is a weakly and ill-bread child, then a gentle death will be provided for him by the medical board, which decides over the citizenship papers of the society, let's say through a small dose of morphine.... [The parents] will not give themselves over to rebellious feelings for long but will try it fresh and happily a second time, if they are permitted to do so and have a certificate granting them the right to the procedure." [Dr. Thomas Roder and Volker Kubillus, *Manner hinter Hitler* (Malters: p Pi-Verlag fur Politik und Gesellschaft, 1994) pp. 65-661

As Dr. Thomas Ruder, Volker Kubillus, and Anthony Burwell relate in their book *Psychiatrists: The Men Behind Hitler* (Los Angeles: Freedom Publishing, 1995) p. 94:

"Within ten years, Ploetz founded the German Society for Racial Hygiene, joining with another psychiatrist, Ernst Rudin who would later turn sterilization operations into one of the Nazis' most prolific death machines. Declaring racial hygiene a 'spiritual movement,' Rudin and his associates worked to disseminate their ideas and principles to the public. Despite 'quietly and gradually winning over the hearts and minds of our best Germans,' they could not gain support at upper government levels. Eventually they found a willing collaborator in Adolf Hitler. 'Only through [the Fuhrer] did our dream of over thirty years, that of applying racial hygiene to society, become a reality,' Rudin said."

"Hitler was also influenced by two psychiatric books: The Release of the Destruction of Life Devoid of Value (1920, Hoche and Binding) and The Principles of Human Heredity and Racial Hygiene (1921, Bauer, Fischer and Lentz). Lentz wrote, 'I have heard that Hitler had read the second edition of Bauer-Fischer-Lentz during his incarceration in Landsberg. Some parts of it are mirrored in Hitler's phrases. In any case, with great mental energy, he had made the basic ideas of racial hygiene and their importance his own, while most of the academic authorities still look upon these issues rather unappreciatively." [Roder, Kubillus, and Burwell, op. Cit., p. 37.]

According to the 1920 work by Hoche and Binding referred to above, the suffering of a sick or wounded person who is about to die can be shortened through the use of a medical drug. The accel-

eration of the death process is not an act of murder but "in truth a pure act of healing." A doctor should be allowed to employ euthanasia on any unconscious person without legal consequences. There are, the authors believe, people who are worthless to society. Primary among these are the inmates of the "idiot institu-

tions," who are "not only worthless, but of absolutely negative value," according to Hoche and Binding. In addition, the two doctors advised that "The incurably dumb who can neither agree to survive or to be killed should be killed. Their death will not be missed in the least except maybe in the hearts of their mother or guardian.... When we become more advanced, we will probably be saving those poor humans from themselves." [Ibid., p.41.]

The growth of the nightmare is described in Psychiatrists: The Men Behind Hitler:

"With Hitler providing the public face and vehicle for implementation, the next few years saw an avalanche of legislation which legitimized psychiatry's demonic plans. On July 4, 1933, the Sterilization Act was enacted, clearing the path for wholesale euthanasia. July 4, 1933 saw the Law for the Prevention of Genetically Diseased Children passed."

"By 1936, the first systematic transfers of the mentally ill from various institutions to the concentration camps began. In 1937, criminals and repeat offenders were relocated to the camps, followed by "vagrants, alcoholics, work dodgers, welfare recipients and even already-sterilized, feeble minded women." That same year, the Third Reich embarked upon a cleansing of the churches and charitable establishments. People were relocated first into state institutions, then ultimately to the death camps."

"The number of sterilizations performed in Germany between 1934 and 1945 is estimated to be as high as 350,000. And while German psychiatric hospitals held 300,000 to 320,000 patients in 1939, only 40,000 were alive in 1946. The rest had met their deaths at the hands of psychiatry."

In addition, Fredric Wertham, M.D., in A Sign For Cain: An Exploration of Human Violence (London: Robert Hale Limited, 1966), reports that in 1941, the German Hadamar psychiatric institution "celebrated the cremation of the ten thousandth mental patient in a special ceremony. Psychiatrists, nurses, attendants, and secretaries all participated. Everybody received a bottle of beer for the occasion."

## **Book Reviews**

Penetration: The Question of ET and Human Telepathy, by Ingo Swann, Twiggs Company, SD, 1999, \$18.95.

In his new book, *Penetration*, Ingo Swann offers evidence that our moon is a man-made satellite and is quite possibly occupied by extraterrestrials. He suggests that the American government and higher echelons at NASA have long had evidence of this, but we are "entrained" not to think about it. This is an

Officially, our government has to know much more about the unusual features of the moon than it has openly admitted: the fact that large objects move around on it, that lights have been seen moving on it, and vehicle tracks as well as huge artifacts have appeared in satellite pictures. Isn't it also curious that the moons of Mars weren't seen before 1877 even though there were people studying Mars all along? Were these various satellites placed in orbit only a little over a hundred years ago as the space stations of an advanced ET race?

Swann's interest also involves the subject of telepathy. Swann is a talented psychic and was involved for many years in the government remote viewing program at Stanford Research Institute. Swann wonders what might be the secret government's obsession with human telepathy? Does it really pertain to a Soviet psychic Cold War (see article on Remote Viewing), or are "deep black" agencies attempting to find out if humans are up to the task of a telepathic War of the Worlds? Are ETs here on Earth among us? Is our full conscious

awareness shrouded by some kind of remotely-caused "stupor" when it comes to realizing that certain bodies in our solar system may be man-made constructs?

fictional. Even the well-stacked lady squeezing the artichokes in the produce section ain't no lady. She's an extrater-restrial. It's not that these ideas haven't waltzed the fringes before. It's just that nobody has been allowed to discuss Black-Ops programs dealing with earthbound ETs without putting it in fictional format. It's curious that Swann is being allowed to do this now. Is it part of an ETI "Acclimation Program" believed to be in effect?

Penetration reveals the story about a deep cover agency that utilized Swann's psychic talents in order to "remote

view" man-made artifacts and humanoid occupants on the moon. Two very strange "twins" would meet him and take him to secret meetings with a "Mr. Axelrod." The "Axelrod Affair," which took place in 1975, was so undercover that there was to be only a verbal secrecy agreement lasting ten years. Ingo

was taken to an underground facility outside of the D.C. Beltway where his remote viewing sessions of the moon took place.

The focus of the first part of *Penetration* is on these bizarre "twins." who seemed to be telepathic. Somehow they even knew the combination to Swann's locked office at SRI. This makes him wonder who Axelrod is really working for: the CIA, KGB, Mossad, M-5, military intelligence, or ... "worst of all was the speculation that they, themselves, might be extraterrestrial." He wonders, could ET troops be fighting a war on our very own turf?

If such a reality were true, how might this information be managed

and controlled? This is largely the topic of Part II of *Penetration*. Swann writes that reality cannot be manipulated without the total and covert management of information pertaining to it. In this way, "reality-making" and "information management" are interrelated.


Swann asserts that humans have what he terms an "information comfort zone." They tend to prefer familiar information which they have processed before, and which is consistent with their agreed-upon ego-based reality, rather than new information which creates discomfort. The construction and deconstruction of a "comfortable" reality requires the creative management of information as well as the "willful" introduction of "useful illusions." What we have, essentially, is similar to Big Brother's creation of a completely indoctrinated belief system called "2+2=5," which was set forth so terrifyingly in George Orwell's 1984.

Perhaps the most startling point Ingo makes, however, is that Earth people seem to be caught up in a "broadly shared amnesia" which, he suspects, is induced in a "wholesale way." This amnesia dulls our memory of events, and keeps us from adding up 2+2. For instance, if NASA were to admit that the moon is indeed hollow, how many people would realize the meaning of this anomaly? Would most people be able to add up 2+2, which in this case equals "manmade"? Or, out of fear of ridicule, or of seeming "uninformed," would we just draw a blank and assume someone else, presumably a "specialist," is working on the problem? If you're waiting for the "last word" from NASA, however, don't hold your breath. This "civilian" agency seemingly holds the patent on the dissemination of useful illusions which add up to whatever they say it adds up to.

Swann deduces that "ET factors" could cause "major wreckage within information comfort zones typical of Earthside information packages." But who is it, ultimately, that wants our reality confined to this planet? According to Swann, "Earthsiders assume that Earthsiders themselves construct their realities." However, he makes the following rather alarming deduction: "WHO it is that constructs the realities is NOT at all clear." What we have assumed to be an "Earthside" power conglomerate has long known how to indoctrinate the thought processes of humans in order to keep it "earthbound." But, Swann suggests, reality may be engineered not by "Earthsiders" but by "Spacesiders," utilizing some type of telepathy or mind control technology.

If such a condition were being manipulated from the 'outside,' would it require some type of field command or ground

troops? Does this imply that certain factions within government agencies, perhaps with commands coming from "higher up," are either extraterrestrial in origin, or are hybrids, or are working for ETs? This is one scenario that most people are not ready to handle, but it needs to be examined as a possibility. This is where another new book enters the scene just in time to complete the picture.



MILABS: Military Mind Control and Alien Abductions, by Dr. Helmut Lammer and Marion Lammer, Illuminet Press, GA, 1999, \$14.95.

It has been reported that a human agency is somehow involved in alien abductions. The suggestion that humans are aiding and abetting in certain incidences of alleged alien abduction is outlined in a new book called MILABS: Military Mind Control and Alien Abductions. Military-type abductions, reported primarily in the U.S. and Canada, mimic the alien abduction scenarios without the reported supernatural motifs. Instead of UFOs, they use unmarked helicopters, vans, and buses in order to kidnap victims and bring them to underground facilities. Whereas alien abductors appear through a closed window or a wall,

and paralysis occurs via telepathy, MILAB abductions induce compliance with a syringe.

The MILAB theory suggests three hypotheses: (1) covert military and intelligence agencies are carrying out mind control projects under cover of "alien abductions," (2) covert agencies are carrying out clandestine biological and genetic engineering research in underground facilities under the "alien" cover, (3) a covert task force is monitoring real alien abductees in order to debrief the victim, as well as to install full amnesia regarding both abduction incidents. In either case, covert units seem to be up to "something extremely strange and secret hidden behind a criminal veil of kidnapping and narco-hypnotically induced mental screens." The agenda. points out Richard Sauder in the book's foreword, may be "dark and occult."

There is a fourth possibility being left out in the above theory, however. Could it be that alien-human hybrids have already infiltrated ground forces on Earth? Skeptics point to these covert 'military maneuvers' as evidence that most alien abductions are "staged" by the intelligence community as a cover-up for their illegal mind control and genetics experimentation. This theory suggests that

military intelligence is field testing brain implants, virtual reality implants, holographic image projection, cloaking devices, mind altering weapons, and genetic research.

This, however, may be a simplistic explanation, since the MILAB-type abductions represent a *fraction* of the information in abduction research files. Dr. Jacobs, author of *The Threat*, suggests that MILAB abductees "mistake human-like alien hybrids dressed in military-like clothes and uniforms for U.S. military personnel." The military association may be a ruse pulled off by alien-human hybrids. On the other hand, they could be mind-controlled Virtual Reality Scenarios. Yet, the question still remains; are they "Earthsiders" or "Spacesiders"?

The timing of the publication of these two books, and the consideration of both avenues of thought, takes the conspiracy to a higher level. You will lay-awake assured there's a method to this madness. Both of these books are highly recommended. •


