

It is composed of the Grand Master, the holders of the four High Offices (Grand Commander, Grand Chancellor, Grand Hospitaller and Receiver of the Common Treasure) and six other members. Apart from the Grand Master, they are elected by the Chapter General, by a majority of the Knights present. The Sovereign Council is called by the Grand

Master and meets at the seat of the Order at least six times a year and whenever special circumstances require it." [38]

After a short experience in the commercial sector, he taught modern languages (particularly French and Spanish) for twenty-three years at Worth Abbey School, a Benedictine Roman Catholic high school in Sussex, England. Fra Andrew was admitted to the Sovereign Military Order of Malta (SMOM) in 1956; he took Perpetual Vows and in 1981 became a Religious member. He has contributed to the government of the Order since 1981 as a member of the Sovereign





That they are able to cloud this reality is due to the Coors Corporation's high-visibility advertising campaign. The Coors family is highly influential in shaping the activities of three organizational pillars of the New Right--the Heritage Foundation, the Free Congress Foundation (FCF) and the Council for National Policy (CNP)--which comprise an influential force in Washington, DC. It involvement with these key groups provides the Coors family with a conservative political base. From this base, the family is connected to prominent activists in other New Right organizations, to groups on the Religious Right, and to allies in governmental agencies and in Congress. Power Brokers: There are other powerful New Right funders, but it is the Coors family who time and again appear in leadership roles in New Right institutions, offering a guiding hand along with their

signed checks. The family is seen, by critics and compatriots alike, as being in the front rank of conservative U.S.. power brokers. Some observers contend that the Coors empire has moderated politically because the Coors Corporation now financially supports some women's, civil rights and gay and lesbian groups. The Coors company provided Heritage Foundation with \$20,000 per month during the foundation's first year. Weyrich was Heritage president until February 28, 1974. In 1980, Heritage published Mandate for Leadership to guide the incoming Reagan Administration and its transition team.... Working the high-level inside track on these personnel hirings was Reagan's "Kitchen Cabinet," of which Joe Coors was probably the best known member. A Reagan loyalist since the 1968 GOP convention, Coors began spending a lot of time in Washington, D.C. and the White House. The attempt at governance by the Kitchen Cabinet became so elaborate that they actually established an office in the Executive Office Building across from the White House. Embarrassed by the image of a covey of millionaires seeming to run parallel and sometimes conflicting personnel recruitment operations, senior White House staff produced legal opinions saving that it was illegal for a private group to occupy government property, in this case a White House office. Although Coors produced a legal opinion arguing there was no violation of law, Coors and friends were evicted. Heritage could hardly claim diminished relations with the Reagan Administration, however, as an estimated two-thirds of its Mandate recommendations were adopted in the first year of the Administration. Further, Heritage was using a letter of endorsement from White House Chief of Staff Ed Meese in a December 1981 fundraising effort. In his letter of endorsement, Meese promised Feulner that "this Administration will cooperate fully with your efforts." After leaving the Reagan Administration, Meese joined the staff of the Heritage Foundation. (Bellant (CC) 1,9,10)" [51]

In 1947, he received the first diploma awarded by the newly formed university by then President Hugh Potter Baker and was a past

president of the University of Massachusetts Alumni Association. He received his LLB from Boston University in 1950, practiced privately until 1963 and was an assistant Holyoke City Solicitor. Mr. Donohue was president of the Massachusetts Junior Bar conference, vice president of the national Association of Claimants compensation Attorneys, President and Executive Director of the american Judges Association, President of the American Judges Foundation, a world jurist participant for the white House conference of Judges during the Nixon administration, and co-chairman of the International conferences on Violence and Terrorism in 1983 and 1986. Governor Endicott Peabody appointed him to the Holyoke District Court in 1963 where he presided as First Justice until 1989. Throughout his judicial career he worked to improve the lives of children in the community. He was co-author of Project ?R,? a school-based educational program developed to instill respect for people and property, and was a member of the Holyoke Police community Relations committee in 1981 where he originated the idea of the Holyoke summer Olympics. The Judge published a report, "the Effect of Immigration as to the Holyoke District Court." He began the first televised court proceedings on daily cable television. At the District Court, he established an affirmative action program for employees and a 7-day a week Probation Office from 7am to mignight. Mr. Donohue was chairman of the Citizens Committee that established the Holyoke Community College. He was a past **Grand Knight of KofC Council #90.** He was president of the Holyoke St. Patrick's Parade in 1961 and was a Parade incorporator. In 1989, he founded and was publisher of Hello, Holyoke. He was a member of the world Judges Association and a Knight of Malta. He was a communicant of Holy Cross Church. On his first trip home in over half a century, he and the princess of Naples, and their son, had a 20-minute audience with Pope John Paul II at the Vatican. Victor Emmanuel told the press that the audience with the supreme pontiff was "very important" to their family and that "it was almost a page in history." [65]
