#### Introduction:

This transcription was originally posted as parts I through XVI, plus a "retroactive introduction" and an addendum, to the ignition-point mailing list, to alt.conspiracy and alt.mindcontrol. This completed work contains numerous corrections of minor errors and unintelligable omissions in the original postings.

The transcription is of a tape I personally made during the presentation.

I do not endorse the information or allegations contained in this transcription. It is presented so that the reader may come to his or her own conclusion regarding the value of the content.

## The original introduction follows:

It occurs to me that not everybody in this forum, (or anyplace else this transcription might end up,) even knows who Mark Phillips and Cathy O'Brien are. Without some minimal background the transcriptions are nonsense. Let me try to remedy that with a brief introduction.

Here is a press release about their book, Trance Formation Of America:

## PRESS RELEASE U.S. GOVERNMENT MIND CONTROL

On August 3rd, 1977 the 95th U.S. Congress opened hearings into the reported abuses concerning the CIA's TOP SECRET mind control research program code named MK Ultra. The Transcription

Mark Phillips speaking:

This is quite a milestone for us, and Cathy O'Brien and myself would like to thank each and every one of you, particularly Dominic Vincintini, Rick Strawcutter and Justice Pro Se.

About eight years ago, I fantasized about bringing Cathy back to Michigan, and having her address people with eyes open, (unintelligible,) and ears to hear, of something that I have known about for many years, but did not really realize was operational. I'm only going to take a little bit of your time tonight. The real story that you need to hear is going to come from one of your own, Cathy O'Brien.

The background that I will provide you will give you some understanding of what she is going to be relating, because we are talking about a psychological warfare weapon. We are talking about something that has been kept from the public's eye for the most part, particularly in this country: MKUltra. But more than that, we are not going to offer you any bad information without offering you a solution. I don't believe in it. We have a rule at our house, that Cathy and I both abide by, that we voice no negatives without a solution. And I guess you all know what that stops. It has helped us persevere, and it certainly gives us all, both Cathy and I, peace of mind in the house, because we certainly deal with enough negatives.

My name is Mark Phillips. I was born May the seventeenth, 1943, in Nashville Tennessee. I didn't particularly want to serve in the infantry of the United States Army, and be drafted during Vietnam, so I sought an opportunity to work for a Defense Department subcontractor. I was very fortunate in that I had a job offer from the Ampex Corporation, out of Redwood City, California. Ampex was the inventor of the, for the most part, most of the video equipment that you see these days, particularly studio grade, and was involved in a number of U.S. Defense Department contracts, manufacturing very sophisticated electronics, instrumentation, and other devices that use magnetic tape and other means of recording: the forerunners to what you are seeing now in personal computers.

In around 1967, when I was being interviewed by the Ampex Corporation, I discovered that the Defense Department was much more interested in the way I thought rather than my academic achievements. Thank goodness, because there were (unintelligible) other people wanting that job: young men, as well as young women, that I believe were academically more entitled to it.

The job description was Sales Engineer, and there was going to be a fair amount of training, that would occur in Redwood City, California, in addition to some exposure to additional training which I wasn't going to be told what it was, it was quite simple, at various defense department locations. This included, among others, the Yerkes Primate Centers, in Atlanta and Denver Colorado, which is a research center for primates. Also the CDC, the Communicable Disease Center in Atlanta. Both that and the Yerkes Primate Center happened to be both located on the Emery University Campus.

And, in addition to all this, I was working in and around penitentiaries, mental institutions, on state and county level, and federal and state penitentiaries. And what we were doing, in essence, was filming, or videotaping, various accomplishments, experiments, as well as some ongoing projects, involving behavior modification, using drugs, hypnosis, along with some other Pavlovian type conditioning, repetitious conditioning.

I did not see, and this is very important, I did not see trauma based mind control played out. What I saw was something that I envisioned, I didn't know at that time, by this time it was 1969, I knew that the United States government was about 25 to 30 years ahead, in terms of technology, than the U.S. population, or for that matter, the world. So we were the technological leaders, and NASA was really going to be the end user of our product, and our product was intended to become apes that could communicate with computer boards, and other types of communications. Some of these apes are quite intelligent, but at best they've got the mind of a very temperamental six year old child, and are not, as far as I am concerned, suitable for manning a spacecraft worth billions and billions of taxpayer dollars. But, nevertheless, the United States was very concerned that we may in fact have a problem with the Saturn V liquid fuel rockets, that the Soviets had already experienced some massive problems. And, quite frankly, they did not want to take the space program and dismantle it because they didn't have a backup to cover our astronauts.

To take this a little bit further, after my initial exposure to finding out that the United States Government was more interested in testing me to see if I could keep a secret, in essence, I went through three months of exhaustive testing. And, in retrospect, it kind of frightened me, because they knew more about me than I knew about myself.

You know most psychologists and psychiatrists get into the business to learn about what's wrong with themselves, not what's right. Well, I didn't want to be a psychiatrist or a psychologist, although I had an intense interest in mind/brain research, because of something that dealt with my mother. She had a tragic accident aboard the same horse that I was on when I was about six years of age, and the horse stepped into her head and she lost the ability to logically reason. So, I was absolutely intent on finding some way to help her throughout my life. But the Ampex

Corporation, I thought, and the Defense Department was going to be one of those avenues, and when I was seeing all these wonderful things happening in the penitentiaries and at the mental institutions with what mostly we would consider hopeless cases, it turned out that, I believed, that since this technology was so far advanced, that I would eventually see our prisons and our mental institutions, for the most part, be only temporary residences and not permanent homes for these unfortunate people.

Well, I was naive. Before this evening is out, you are going to find out you are looking at the luckiest, most naive human being that you have ever met. Cathy O'Brien often says she is the luckiest person alive. I don't happen to agree with her there because I happen to know what I could have wound up becoming, and that's something akin to what she was exposed to. Anybody in the position these days to what I was exposed to in the late 60s and early 70s, in terms of MKUltra and mind control research, would have ended up a victim themselves.

The experiences that I was able to enjoy I had to keep secret. My whole family knew nothing about my other job. They knew nothing other than the fact that they could call my office, and my office would cover for me. And usually I was someplace else, either outside this country exchanging information, with the State Department's blessings, with the Soviet Union. I was not aware that there was a Cold War going on. I was aware there was a technological war going on, and I was also aware that the Soviets were quite friendly with us. And I didn't really relate to politics, I never voted in my life until 1992, when I rode off and got stupid and voted for Perot. Well, look at the choices!

The point was, I just walked around, and I did my job, and I never saw any violence until really mid 1973, and then I began getting hints that these electroshock treatments were not always low voltage. And I also was getting hints that there was going to be some trauma that I would be witnessing in the near future.

So Ampex was enjoying, or enduring, I should say, some serious political problems, because they were a California based corporation. Ronald Reagan was governor, and he was going to implement mind control in the California State Prisons, and also at the state owned and run mental institutions, and the people rose up against him. They almost cost him the governorship, and ultimately, of course, we all know he ultimately became President for two terms.

So, Ampex, I thought, was a dead horse. And I had befriended a bunch of scientists and a bunch of spooks from the intelligence community and from NASA, and they formed a company called Laser Systems and Electronics in (unintelligible) Tennessee, and, fortunately enough, they asked me to become their Director of Sales and Marketing. They did this because I had a clearance, and because they were working research and development with a number of other companies like General Medical and (unintelligible), on implants and telemetry products. That's a way to monitor people's heartbeat and other systems. Now its very commonplace in your hospitals, but in 1971, 72, 73 and 74 it wasn't common: it was just kind being introduced.

Well, Laser Systems and Electronics exposed me to more, let's say, medical stuff, that I didn't particularly want to see. I didn't want to become a doctor, and I just really

don't like to see surgeries and that sort of thing, and I decided that I wanted to find a job that was a glamour business. So, one day, I talked to this friend of mine, who, (pardon the pun,) shadowed me a great deal, and I explained to him that I wanted something else besides this kind of (unintelligible.) So he suggested that I go to work for something much more glamorous, like an airline.

And I said, "Well, that's what I was thinking about - an airline".

And he said, "Well, I happen to know where there is a job opening." He said, "I have stock in this company, and I really believe that you ought to investigate it." And he scribbled out on a napkin exactly the name of the fellow that I was supposed to see, the president of the company. And then he wrote down the senior vice-president of the company.

And I said, "What's the name of the airline?"

And he said, "CIA."

And I said, "Well, wait a minute. What's that?"

And he said, "Oh, its Capital International Airways."

Well, I said, "Oh, wow! What a nice name. They named it after Nashville, because the president was from Nashville, Tennessee. (Unintelligible.)"

He said, "No, actually not. It actually started in Virginia, somewhere around Alexandria, back in the fifties."

Listen. You think I just fell off the truck? You haven't heard the rest of this thing. It gets worse.

After one interview, I found out that they did not have a job opening. But they suddenly created one, and that was in the advertising department. So they hired me as the advertising manager. Well, they didn't have any advertising: it was all handled by agencies. So I sat there, just looking at my desk.

And one day, I decided after about a week of this, I was going to see what was going on, and went in to see the boss.

And he said, "Well, we're fixing you an office up right now."

I said, "Well, what am I going to be doing?"

He said, "You're going to be the director of sales."

I said, "Well, that's wonderful."

So, after a week or so passed by, sure enough, I got the most luxurious office you ever seen in your life. And, matter of fact, the boss gave me his Louis the whatever - fourth, fifth - whatever it was desk, and this place was like a palace. I was absolutely

in heaven, because the next job, they told me was, "You're going to be hiring our flight attendants."

I thought, "Well, for once I got lucky."

After a short period of time, I learned very quickly that this was not a glamour position, and I wasn't hiring flight attendants much longer. They had a guy they were actually bringing into that job who was married and was reasonably content with his relationship, (unintelligible.)

After a relatively short time, I also learned that the airline business was absolutely the hardest business as far as work goes. They have no respect for hours. Airplanes fly 365 days a year, and problems. Every one of them has got at least 250 problems on board, and there was about six hundred million dollars worth of revenue coming in a year, that I knew about.

Until one day the U.S. Marshals came in and literally swarmed the place. And they were going down, office to office, padlocking offices, and executives and secretaries and everybody else coming out, they would grab their purses and their wallets and whatever else they could get their hands on quickly. And I was sitting at my desk when I was introduced to one of these marshals, and he explained to me, he said, "We're looking for Mark Phillips."

And I said, "He's next door." I said, "Who are you?"

He said, "I'm a U.S. Marshall."

I said, "He's absolutely next door."

So I was going to just scoot on out by the water fountain and find out what in the world the guy wanted. Well, he wasn't going to sit still for that. He knew who I was. So I tried to be a tough guy.

He told me, he said, "We're going to put you into guarding the integrity of the files."

I says, "What is going on?"

He said, "Do you know anything about Paperclip?"

I said, "I got a desk drawer full of them. What kind of a problem is that?"

He said, "If you don't know, then its no problem."

Well, what he was talking about is going to lead right into what you are going to hear about tonight. Well the long story made short, the president of the airline was so stressed out by this that he crawled into a bottle and stayed there and literally died from it. He was an elderly man anyway. He brought in a fellow from Air America named George Clamatson(?), a Russian-American, who had been one of the founders of Air America, as well as a number of other CIA operations.

George came in, more or less put the airline together for sale. And George said to me, he said, "Let's go to Alaska."

Well, I thought, "Well, my goodness." I couldn't find another job, I couldn't seem to be able to get away from that place, and it was crumbling under my feet. And I was terrified that the U.S. Marshals were going to come back, because nobody would tell me what that was all about.

So, I went on to Alaska with George Clamatson(?). We founded an airline up there called Great Northern Airlines, we flew over another company's routes, and then that airline was sold to Southern Air Transport.

Now, I've been listening out there to see if you folks knew what I'm talking about. So far, I have named nothing but CIA operations. I was unaware that I was effectively working for the CIA. I thought everybody worked for the CIA. I thought that every major corporation in America had some interface with the CIA whether they knew it or not, so I didn't pay any attention to it.

After a bout with George Clamatson(?), that airline being sold, and I had a one year contract, I decided the only way I was going to get away from the CIA, because I did know by the time I got to Alaska what I was doing, I decided that I would absolutely go into business for myself.

Well, I knew antiques was safe, and I had an antique business. I had a number of customers, and enjoyed myself, and literally wouldn't take a partner, wouldn't take anybody on board, and just operated independently. I was very happy doing this work. But on the flip side of it, it wasn't exactly a mental challenge. I had been use to high finance and working on huge marketing plans and sales plans for multi conglomerate corporations. So I wasn't happy.

Well, about that same period of time, we're now at about 1985, I was approached by a young friend of mine, same age as me. And he said, "Mark," he said, "I've got a fella that is in the country music business."

And I said, "Well, I don't like country music."

He said, "Well, that doesn't make any difference. He doesn't sing and he doesn't pick. He's a ventriloquist, he's a stage hypnotist, and (unintelligible)."

I said, "Who is he?"

He said, "Alex Houston."

I said, "Well, I never heard of him."

He said, "That's because you don't like country music."

I had interviews with Alex Houston. You remember I had by this time about 20 years of mind/brain research under my belt. I was a master of Neuro Linguistics, which is the language of the unconscious. I was familiar with what they call PSI, which is

watching the micro muscles around somebody's eyes to see when they are lying, if they can (unintelligible), or when they are deliberately trying to deceive me, by telling me mixed truths. I am also a graphologist: that's the study of handwriting analysis. All these things were tools that I used in my trade of marketing, and also of (unintelligible), I did a lot of that (unintelligible.) If they had a choice for most people they were given the chance of either going to a shrink or submitting a handwriting sample to me and talking to me. Most people thought that was a (unintelligible.) So they submitted a handwriting sample and dropped in and over the years (unintelligible) found I had a great record for who was shooting straight and who wasn't. (Unintelligible.)

Nevertheless, Alex Houston would approach me with a viable idea put together, a joint venture, a Pacific Rim operation, primarily with the People's Republic of China. And this venture would in essence be a company manufacturing great big huge capacitor banks for the mining industry in China. See, China had just more or less opened their so-called Iron Door to free trade, and they didn't want to imbalance the payment like we did with the Japanese, so they preferred to be able to export rather than to import. So they had an energy shortage, and this energy shortage was causing them to shut down their mining industries every other day, which, if you know anything about mining, is almost like shutting down a steel mill. It is so counter productive it is almost not worth doing.

So, I worked with a fellow out of Hong Cong by the name of William Yoon, and by the way, when you do business in China, you have a Hong Cong representative. Well, William Yoon was an arms dealer that Alex Houston had referred to me and others, a friend of mine in the state department had also given me his name and told me he was very honest, which I found him to be, in spite of the fact that he was an arms dealer, and dealing Silkworm missiles to anybody with a pocketful of money and a user certificate.

But nevertheless, he only (unintelligible), and I had a good marketing plan and a sales plan. And we took it to Beijing, and we met with the Defense Department Ministry and the Mining Ministry, both, um, all the other metallurgy groups, and I sold the thing, a 31 million dollar package startup. The production, at the current rate of production that they were capable of putting together for us, I would have netted somewhere, for my company, UniPhayze Corporation - I was the president, I was smart enough to do that - about five million dollars the first year. My payoff, up front, was one million dollars US, given in the form of a line of credit, which Alex Houston suggested we put in his New York Bank, which was the Bank of Credit and Commerce International.

Well, BCCI, as most people refer to it as, was unknown to me. But my Korean counterpart, William Yoon, he did not like Alex Houston, he told me, he said, "Um, you could do a lot better with your choice of banks."

I said, "Well, that million dollars isn't going to stay in there very long anyway. I am going to move my portion out of it."

He said, "Where you going to move it?"

I said, "I don't know. Off shore. Somewhere. I know if it sits there, something always happens to it. It has all my life, and I got a funny feeling it is going to happen again."

Well, at least my intuition wasn't too bad. My choice of people was though. But I looked at Alex Houston's handwriting, I talked to him, he couldn't tell the truth, and he had some of the most peculiar habits of anybody I ever run across, for being a pathological liar. But I could not put my finger on it. I just wanted to stay away from him.

So I spent most of my time in the air, traveling back and forth, and working the other countries, the Phillippines and Taiwan and was bouncing all over the place on the Pacific Rim, setting up contracts, which, in essence, see, I could deal with Taiwan because I was having the goods relabeled. It was quite legal: relabeled as being made in Hong Kong. And even though they wouldn't buy from the People's Republic of China, they would buy Chinese made goods in Hong Kong. We were not using slave labor in China. As a matter of fact, they were paying a good wage, so I was surprised by this slave labor thing. But apparently, the Chinese have gone the same route they have always gone, and when production got so high, they started drawing form every labor source that they could find.

But, after signing the contract, I was presented at this banquet that they threw in my honor, I was presented with a rather peculiar request to talk with this gentleman who was standing there, looking quite nervous over in the corner. And as he started approaching me, all of those politicos and my partner, everybody else just kind of parted, like Moses did to the Red Sea, and I was standing there, left alone. I thought, "Well, here it comes. Nobody gets this much money this quick without big problems." And I was absolutely right.

This fellow came over, and he began to open up a little case that he had, and the first thing there was absolutely terrified me. He opens up a little folder that begins to show me that, truly, national security in this country was gone, because he had pictures of myself that the military and the defense department had taken. He had pictures, and he had records showing where I had been assigned to various jobs. Some of those documents were eyes only, some of them secret, most of them top secret, they had the original initials, could have been color photographs, but they were original initials on the sides, stamps, and some cases where I had initialed them and turned them back over to my superior.

So, I had now a national security problem on my hands, because I realized that I had to go back to my country and explain to my government that national security had been breached, and that my past had been revealed. I had two files, and they were sealed well into the next century. Why, I don't know, other than the fact that secret knowledge equals power, and that's how they control each and every one of us is with secret knowledge and technical knowledge, and that is more about what you're going to hear tonight.

But that was not the interest of this Chinese intelligence officer. He was not interested in the fact that I had done time with the CIA, he was not interested in the fact that I had worked for other intelligence agencies, directly and indirectly, or for

that matter the Defense Department. His concern was solely Alex Houston, and he told me so. He said, "This was just to get your attention."

And I said, "Well, you certainly managed to do that."

So he proceeded to show me Alex Houston's file. As he thumbed through slowly, and watching my eyes and my reactions, he began to tell me that Alex Houston was a very bad fellow, in essence. How many of you folks in here have know a really bad guy? Let me see a show of hands. Ok. Well, I had too, but nothing like what I was going to hear.

He began to tell me that Mr. Houston was involved in child and adult pornography, which, by the way, pornography, in China, is an instant death sentence if you get caught with it. He was involved in drug running, money laundering, the CIA. And I said, "Wait a minute. What? It's coming back to haunt me."

He said, "The CIA. Mr. Houston works for the CIA."

And I said, "Huh."

He said, "He's an intelligence officer."

And I said, "Mr. Houston has not got enough sense to wipe his nose."

He said, "He does work for the CIA." And he continued to show me, very stoically, page by page, some of Mr. Houston's history, and telling me that Houston was also involved in white slavery. But the key to all this was, he said, "Alex Houston does this, in essence, of the White House."

I said, "What do you mean, of the White House?"

He said, "It's of the White House."

I said, "You mean the White House approves this, sanctions this?"

He said, "Yes. It's always the White House."

Houston lived in a little town in Tennessee, right next, the county seat sat in a little place called White House. I said, "Wait a minute. He lives there."

He said, "No, he lives in Tennessee."

I said, "That's what I'm saying."

This is of the White House."

I said, "What White House?"

He said, "The White House. Your government"

I said, "Oh my God."

So, I said, "You mean to tell me that Mr. Houston is involved in some CIA black operation involving prostitution, child and adult pornography, and all this stuff, and it is sanctioned by the White House?"

He said, "That's right." He said, "And you've got to get rid of him."

I said, "I'm not gonna get rid of him like that."

He said, "No no." He said, "You get rid of him any way you want to."

I said, "Well, um..."

And just as he said that, he opened up the page where there is Alex Houston engaged in sex with a small black boy, who was absolutely terrified. And I saw the stuff on the side, handwritten, the word, "Haiti."

I thought, "Oh my God." And I said, "Alright, look. I'm not going to give back all my money that you just gave me to buy Mr. Houston out, and now that this company is now suddenly worth 32 million dollars, its going to cost me a whole lot more money. So why don't I go back, and you just hold this contract, and give me that million dollars, and let's get some more money together, and we'll buy Mr. Houston out."

That's exactly what we did. I brought a delegation of Chinese and Mr. Yoon back to the United States, and we got a Chinese lawyer in Nashville and did the whole deal, and I got rid of Houston.

And in the meantime, I went to see a friend of mine from the U.S. Intelligence, and he was a General, he was. And I explained to him what I had heard and what was going on, and I said, "This looks and smells and tastes exactly like mind control."

He said, "That's exactly what it is." He said, "The country is just saturated with it. That's one of the reasons I got out of the business."

And I said, "Wait. It's not in the private sector."

And he said, "No, they have been put in the private sector." He said, "Mark, there are some things going on that you didn't even know about when you were working. Now, its unbelievable. You know there's no mob any more."

I said, "Well, I've heard that."

He said, "No, there isn't. Things are not the same any more."

I said, "Well, all I want to do is find out about this woman that Alex Houston handles, and this little bitty girl, because they are being used, under mind control, and their being prostituted." And I gave him as much information as I could, and I contacted him again for the very last time, I never seen him again because he passed away.

And he told me, he said, "Mark, this is the craziest thing you have ever done in your life. Just forget about it. You didn't cause this. You didn't have anything to do with it. Mark, you just walk away from it. Go on back to China. You don't have to worry about me or anybody else."

I said, "No, I'm going to give a little something back. I'm independently wealthy right now. I've got several months before I absolutely have to be back in China, and I don't need the money to get out and beat the bushes around here. So I'm going to see if I can find this woman and this little girl some help, and then I'm going to go back."

He said, "Why don't you take them with you? You're not going to find any help in this country."

I said, "Why?"

He said, "Because all that information you saw in the sixties and seventies has been detained, for reasons of national security."

I said, "You mean memory work, and behavior modification work?"

He said, "Yes."

Well, I decided right then and there I needed to do something, and I made a decision that any one of you would have made, had been armed with the information that I had. Any one of you, and you would have probably done as good a job or better than I did, that I decided that I was going to do something to help.

So I embarked upon a course of getting in touch with a whole lot of other spooks that I did trust and I didn't trust and I didn't know what to do, until finally I got hold of one that told me exactly how to do it.

He said, "While were in China, there was some information leaking back to the CIA that is eventually going to leak out to Houston that may become compromised, and the whole deal is going to go down the tubes. So they know about your money, they know what you're doing, and you better move fast".

Well, Alex Houston happened to be gone on his annual vacation that he took to a place called Boy's Town, in Lincoln, Nebraska. Now, Mr. Houston (unintelligible) was bisexual, but he much preferred boys. So he goes up there on vacation, like a lot of others do, I later found out from another case. I guess you folks have heard about the Senator John DeCamp's case called Franklin Coverup. Anyway, there was a (unintelligible) case in Nebraska, involving some of these very same players. George Bush was named as a pedophile, and had been there, and Alex Houston was named in this suit, and the whole thing was stopped because it was just destroyed from the inside. They didn't even get to the national security issue part.

So I learned the formula for springing Ms. O'Brien and her daughter out of their system. There's one thing that is absolute, and that is trauma based mind control. No one escapes from it. There is only two ways out. One is if a person receives a serious

head trauma and somebody else listens to their ranting while they are in the hospital. They are the ones that sometimes escape.

There's just no escape from trauma based mind control because these people have no free will and cannot think to get out. It just doesn't cross their mind. Period. The bottom line is they either get thrown from the proverbial Freedom Train, or thrown from slavery when they are no longer useful. Or they receive the proverbial bump on the head, or, in cases of pure, stark insanity, people like me come along and pull them out.

Well, I pulled Cathy O'Brien and her daughter out, took them to Alaska, left my money in New York, and I left my money in Tennessee, part of it. Part of it I did take, and sold my house and liquidated everything I had and went to Las Vegas and tried to get help there, and finally wound up going to Alaska and put Cathy back together.

Now, here's what I put Cathy back together from. In the 1930's, Adolph Hitler assigned his right hand man, Heinrich Himmler, the task of researching Northern European multi generational incest abused families. These are families that mistreat each other literally from birth. The father and mother usually wind up psychologically and physically and always sexually abusing their own children in generation to generation to generation.

Well, something happens when a child is horribly tortured and horribly abused before age five. It develops Dissociative Identity Disorder, usually called MPD. That's the worst name on earth. It is not multiple personality disorder. Even though these people have multiple personas, they are not all developed. They don't have one complete persona. It's like fragmented. They are tortured literally out of their minds, and even though the symptoms are very, very subtle, and these people appear extremely normal in most cases, they have enormous difficulties in life once they get over the age of 30.

But prior to that age, they function, some of them, very well in society, and some of them extraordinarily well, because they can develop abilities that almost appear super human, like 44 times visual acuity. Now guess where those kind of people wind up? As mercenaries.

You see, Hitler wanted to build a perfect soldier. He wanted to build a perfect espionage agent, somebody that literally could not be tortured into remembering something. Because unless you know the exact code, key and trigger, you're not going to get into that fellow's head or that woman's head to find out what secrets they were carrying. They'll (unintelligible) the secrets first. There are methods, obviously, but for the most part, in the 30's and 40's, they didn't know what they were.

Hitler was also extremely interested in what was actually taking place in the mind and the compartments that were being formed. When we were doing research, back in the 60's and 70's, I was aware of this research that Hitler had done. And I was aware that John March, who wrote "The Manchurian Candidate," and Frank Sanatra and some other stars appeared in it back in the 50's, the movie was not entirely, even though it

was fictional, it was not really fiction. It was a fictional account of something that was operational. Mind control. Trauma based mind control.

Now, if you want to know if this is new, it's not, because trauma based mind control, the formula for it, is in the Egyptian Book of the Dead. I mean, that's how long its been around. And all of us in here, for the most part, have never even heard of it. Because it is maintained as almost a secret.

Now, how in the world you keep a secret that is written on the side of cave walls and ancient pyramids is beyond my wildest expectation. I just can't imagine it. I can't fathom it. But you see, the news medias in this country try after, ah, I shouldn't even say Nazi Germany fell. It was moved over here.

You know that paper clip I told you about? "Project Paper clip, Secret Agenda," was a book by Linda Hunt. This book describes in detail how Capital Internation Airlines, for a period of 40 years, running in conjunction with a couple of other carriers, imported Nazi and Fascist scientists from all over the world, secretly and covertly planted them in all of our universities, our Defense Department, subcontractors and NASA. They were supposedly divided between psychiatrists and rocket scientists. Propulsionists. Bomb makers. And we had tried to stop Project Paperclip in 1951, well actually in 1949 and again in 51. It was unsuccessful. Well, the way it was told to me it had been stopped just like MK Ultra had been stopped. And three presidents have said, "We're never going to do this anymore. We're never going to do this anymore." It doesn't stop. The Army had it, the Army gives it to the CIA, the CIA gives it to so-and-so, and they are just playing "Hot Potato" with this thing. The fact is each time it gets tossed, more money sticks to it and it gets bigger.

Hitler found out that he wanted to be a One World Order ruler, and he couldn't do all the work. He couldn't possibly run the world, because communications. technologically speaking, hadn't reached the proportions that they had today. One person could rule the world today, as frightening as that sounds, very efficiently. And I think that the One World Order ruler is is what we are all going to have shoved down our throats very soon, unless we continue meeting like this, and opening other peoples' eyes, and keep raising cain. Each of us has got a job. Every person in here is a hero, and think of yourselves that way, because you've got a job to do. And that's just running your mouth! Just talk! And share the information you get out of here, share our book, share what other information, whatever topic that you can deal with. Cathy and I are giving you a tool of the New World Order, which is a very vibrant, important one, because Adolf Hitler, all he wanted to do was to take what he considered a few "chosen ones," victims of hideous child abuse, whose brains had been scarred literally before they had reached their full maturity, before age 5. And he wanted to take these people and literally program them to run the various governments around the world. And as their puppetmaster, there, invisibly, he would be in control of the world.

Now, he could have pulled it off. He called them "chosen ones," so did George Bush. Did you know that Nero was the one that actually formed the New World Order idea, and Nero was looking into mind control as well? It's been around a long time. And here I am, in 1996, talking about a (unintelligible) that is ancient history, and I feel like a fool. Because there are some other technologies that you also need to

know about, that are highly technical, that at the end of Cathy's presentation, I want each and every one of you that wants to, to write questions out and give them to us. We don't answer verbalized questions. We will take your question and we'll answer it as best way we can, as long as it pertains to the material we are talking about. But technologically speaking, I'm hoping people will ask us about things like the Montoc(?) Project and the Philadelphia Experiment, because I happen to have some inside information on both of them, because I knew some of the analysts that were writing, that set up a few years ago, that wrote the dialogue that was spread out through the various mediums, like (unintelligible) and some of the other outfits as disinformation, to confuse people and to get them fighting among themselves.

Our government is engaged in psychological warfare against each and every one of us. I would imagine that every one of you would know that I can't walk out on the street corner and buy a Cuban cigar, but I could sure buy a gram of cocaine. Now, I wonder why that is? Cocaine is a real problem, it's real illegal. I wonder why.

I've got a bumper sticker on my car that says, "Dare to keep the CIA off drugs." I pulled into a gas station, not long ago, in a little bitty town in the middle of nowhere, and this gas station attendant says, "Mister, I'll give you five dollars for that sticker."

I said, "You give me your name and address and I'll see if I can find out where it came from and I'll mail you one."

He said, "Well, I want to tell you, I know its true."

I said, "How would you know its true?"

He said, "Mister, anybody who deals in more than 50 grams a week knows that their boss is the CIA, and if you don't play games with the right people, you're going to get caught. And the price goes up and up and up and up, until finally you don't make any money, you just delivering drugs for them. But if you stop delivering drugs, you gonna be either dead or locked up. They've eliminated all their competition."

I said, "You know all this?"

He said, "That's why I want a bumper sticker."

I said, "No, I'm not going to send you one."

I'm (unintelligible) of all these criminals. I have a hard time with criminals with a change of heart. I just really have a hard time with them. Born again criminals just bug the you-know-what out of me, so forgive me for not being as forgiving as I should be. But people who say, "Well, I've attended only two satanic rituals, and I only partook in cannibalism once." Well, that's fine. I want to test you and see if you are a victim, cause if your not, I would just as soon you step out in front of a car. I am not your maker, and frankly, I'm working real hard on following in Christ's steps, but I'm not there yet.

So, tonight, you're going to hear, after you take a break, I'm hoping those of you who are interested in knowing about MK Ultra and trauma based mind control and project

Monarch will buy a book from us. It's a love story. Oh God. See, I said that with a straight face. It is a love story. It is a love story for my country, for humanity, for Cathy, for our daughter, who is still, by the way, a political prisoner of the state of Tennessee. And by the way, the book is in its second printing.

And I have some good news, not all good. The judge is relaxing some of those orders. I am allowed to see Kelly, she is allowed to see us. We can begin being a family again on a very limited basis. Kelly has been warehoused for all these years. Can you imagine growing up, first of all, in a literally a satanic trauma base, and then moving into that, from that into a mental institution? She's now sixteen, and she was a little bitty girl when she went in. It's horrible.

And I'm going to tell you something. When I told the feds, a few years ago, that as soon as I got through educating mental health and law enforcement, I was going to move out to the streets with this message. Well, Cathy and I have survived long enough to do this, thanks to really three factors. One, I'm naive. No, I wouldn't believe that one. First of all, God's support and help for us. I am a very spiritual person, and now that Cathy has got free will, she is too. And the second reason is we've had some extraordinary support from what you all call the "bad guys". They are not. All of our government is not rotten, it just smells that way. They've got some good people in all of those alphabet groups, NSA, CIA, DIA, I could go on and on and on, but there's plenty of them out there who are destroying this beast from the inside. Yes, it's happening!

They can't do it alone. They depend on these kind of meetings, and Cathy and I have been going to one after another after another after another. There are thousands and thousands of these things occurring as we speak, right now, are the ones that are going to be the most successful, because you don't ever want to get a central organization. This is as big as you want to get. You don't want to get any bigger than this, because you'll get infiltrated. How many bad guys in here? Would you please raise your hand? Ok, just one. See me after the meeting. I have got something I want to show you. Just kidding. That guy ain't no bad guy. Bad guys don't sit up that close. They are always back there.

I want to close this part of the show off and tell you how dearly dearly much we appreciate you all, and again, Justice Pro Se, and Rich Strawcutter, who I found to be as delightful in person as I did over the phone. I'm anxious for him to get his radio show up and going because I want to do a show with him. I don't know how people, the word gets out. There is a kind of a grapevine, and Cathy and I are tapped into it. I'm hearing all the horror stories too. But folks, we are causing all the bad guys to scramble, and they are scrambling hard. Now there's a lot of folks out there who want to talk about revolution, and that's a change in government. We don't need a change in government, we just need to change some of these people that are in there, and put some clean folks in. That's all. And we are real close to doing it.

Now, whether you want to say, "Well, Fifth Column is real, the Fifth column isn't real," I got a thing that somebody handed me that's dated 1940 that talks about the Fifth Column, and FDR is just beating them over the head, calling them a bunch of Commies. But the point is we've got people on the inside that are tearing these boys all to pieces, and they are doing it right through where it hurts, (unintelligible) a lot.

They are getting them, and they are getting them good, and although I didn't understand how they could be effective and not be the leaders, I quickly learned a lesson when I thought about it. A leader is only as strong as his followers, and when the followers lead, the leaders follow.

So now, you guys are getting in the lead, by meeting like this, and learning and taking this information with you. I would hope that for those of you who like to research, and are the ones that would say, "Whew! Man, I just can't believe anybody would be that bad." Well, I felt the same way. I hope you will look in the index of the book, I hope you will go a little bit further and prove us wrong in one case, just one, and I bet you only find a typo.

I had somebody come up to me the other day, and they said, "Well, I found an error in the book."

I said, "Well, what is it."

He said, "Well, it just bothered me."

I said, "What is it?"

He said, "We were in Alaska a week ago, and this woman said you didn't land in Anchorage, you landed in Haines."

I said, "I didn't put that in there"

They said, "You wrote the book!"

I said, "No, my editor changed that, because nobody knows where Haines was."

So, those kind of errors I have to live with, and I don't mind you beating me over the head with them. But all the other stuff, unfortunately, is very true. We just had a United States general, General Russell Boeing(?), who is now living in Peru, bless his heart, I wish I was there, and General Boeing(?) left us his files, almost seven hundred pounds of them, involving MK Ultra, involving Operation Watchtower, which is the initial setup of the drug operation out of Central and South America. And it has just been one of these guys right after another that are burying us in documentation. We've got at least fifty United States (unintelligible), that are ready to step before Congress to testify in this case. But we have been stopped, for reasons of national security. And I want you to understand, after what you've heard, what in the world does it have to do with national security, that is the rape and molestation of women and children? I want you to think about that, because I don't understand it. And if you all could please help me with that one, then I will be OK again.

## Cathy O'Brien speaking:

I'd like to thank Justice Pro Se for having Mark and I come in and speak to all of you, and I'd like to thank each and every one of you for coming out here this evening, to arm yourselves with information on a tool that is being used to usher in what Adolph Hitler and George Bush term "New World Order," and that is mind control. You have a right to know and a need to know these secrets that the perpe-traitors\* in control of our country have been controlling all of us by for far too long. Knowledge is our only defense against mind control.

\*(Transcriber's note: Cathy distinctly says, "Perpe-Traitors". It is also a term that is used repeatedly in their book.)

I know I am extremely fortunate to have survived my CIA MKUltra mind control victimization. I know I am extremely fortunate to have survived to this point, to be able to relay this information to all of you. Many government secrets and personal reputations were staked on the belief that I could not be deprogrammed to remember those things that I was supposed to forget. They were wrong. They never considered the strength of the human spirit. They never considered what would happen when a good man like Mark Phillips found out their secrets and used them for good: used them for the betterment of humanity, used them to restore a mind and a memory, rather than to destroy one and control one.

Now that I am in control of my own mind, and ultimately my free will, I'm telling all that I've witnessed and experienced behind the scenes as a White House/Pentagon level mind controlled slave. I know that my victimization was extreme, and I certainly am not interested or intending to traumatize you with the information of my victimization. Instead, I want to provide you a comprehensive understanding of the components of mind control, and what the plan is for controlling all of us in this world dominance New World Order effort. Many government secrets and personal reputations are now being revealed. Much is coming to light in society today, because people all across this country are beginning to ask questions as to why has our country been

eroding morally and constitutionally. Tonight, this information is intended only to provide you with detailed answers, so that you can be far more effective in this ongoing effort to take back our country.

These perpe-traitors in control of our country have operated on the belief that secret knowledge equals power. The more we tell their secrets, the more their power erodes, and the better our chances are for effectively taking back our country. These people that have been in control of our country for far too long are extremely intelligent, yet they don't think deep. They are limited in their thinking by their own immorality. That's where we all have the edge on them. They never counted on good people all across this country to spread information in any means available, and it certainly isn't through our controlled medias. Information has to be spread word-of-mouth, through meetings such as these, as this one is tonight, that are occurring all across this country, through shortwave radio, through various radio stations and public television. There are ways for each of us to get the information out. There are ways to spread the secrets that they would not want you to know.

As you hear this information tonight, please bear in mind that we are all enduring a mind war. They refer to it as "psychological warfare." Mind control is a psychological warfare weapon. Because it is psychological, we must deal with it in a logical manner, and that's exactly what they aren't counting on. What they want all of us to do is to hear this kind of information, become hysterical, become emotional, and listen to all the "hate crimes" that are being built up in our controlled medias, and start shooting at each other. They would like nothing more than for everyone to be confused as to who the problem is, and for all of us to end up shooting at each other, instead of logically taking this information, seeing how it effects us, seeing how it has affected us from various aspects of society, and take careful action in an ongoing effort to take back our country.

When the people lead, the leaders follow.

I'd like to begin by giving you a very comprehensive understanding of mind control through my own victimization. Although my victimization is extreme, it certainly is no more horrific than what is happening in society today, from the erosion of our constitutional values, to the drug wars being brought to our streets, to all the horrors that we are enduring through such things as Waco, Ruby Ridge, the Oklahoma City bombing. Instead, by giving you this information on mind control, I hope that each and every one of you will have a much better understanding of exactly what is going on in our country.

I was born in 1957, in Muskegon, Michigan, to a multi-generational, incest based family. My father had been sexually abused as a child, my mother had been sexually abused as a child, and they were sexually abusing me. As far back as I can remember, my father was sexually abusing me. And I've often heard them brag that he began substituting his penis for my mother's nipple while I was still an infant. This confused my primitive sexuality. It put it into an area of pure survival. It was the same, to me, as eating and drinking. It was for this reason that I was targeted as a sex slave in the MKUltra project.

Another reason that I was targeted is because in multi generational families, as the Hitler/Himmler research discovered, and as has certainly been elaborated on since then, was discovered that when a person endures trauma that is literally too horrible to comprehend, the mind's sane defense to that kind of trauma is to compartmentalize the memory of that event in a certain portion of the brain, so that the rest of the mind... (lost about 5 seconds here.) ..."Dissociative Identity Disorder," as it is now termed. It used to be called "multiple personality disorder," but that was not an accurate description of exactly what really is going on.

(Unintelligible) the compartmentalization of memory. I developed a memory compartment to deal with my father's abuse. The part of my brain that dealt with my father's abuse would actually open up. The neuro-pathways would actually open up to a part of me that dealt with my father's abuse could deal with him again and again and again, as needed. That part of my mind was closed off behind that amnesic barrier, and I would function absolutely free of any memory of that horrific abuse. I really had no place to put such horror anyway. It's not that what my father was doing was morally wrong, that I comprehended. I was just a little bitty kid. There was no way I could know that it was morally wrong. But, instead, I endured the pain and the suffocation of his abuse.

The government understood, from a study that has long since been (unintelligible), that this compartmentalization of memory should prove ideal for keeping their perverse secrets. Behind these amnesic barriers in the memory compartment is a photographic memory, because the mind photographically records events around these traumas. Most people know exactly where they were and what they were doing when John F. Kennedy was assassinated. This is an example of how the mind photographically records events surrounding trauma, because that was an event that traumatized the whole nation.

This kind of photographic memory certainly had the interest of the government, because they knew that Dissociative Identity Disorder children, such as myself, were highly suggestible and could be easily programmed photographically to deliver messages, as it were. In my case, since I had been sexually abused, I was used as a sex slave, and therefore my suggestible mind was programmed to carry out and fulfill perversions of certain politicians who did not want their perversions known to the rest of the public. They truly believed that their secrets would be kept secret forever. Had I not been expertly deprogrammed, I would not ever have been able to think to tell you about what happened, and what I witnessed, as a White House/Pentagon level mind controlled slave.

I developed another compartment in my mind to deal with my mother's psychological abuse. My mother suffered from Dissociative Identity Disorder, or Multiple Personality Disorder, as it was known back then, as well. This is why I don't really hold her responsible for her actions, but, nevertheless, she was extremely psychologically abusive, and the effects on me were

devastating. I felt that, I developed another compartment to deal with my mother's psychological abuse.

I developed another memory compartment to deal with the pornography that my father was subjecting me to. My father had a sixth grade education, and earned his living as a worm digger, and supplemented the family income with proceeds from child pornography. The child pornography that he was subjecting me to was also being manufactured by my mother's brother, my Uncle Bob Tanis, also of the Muskegon, Michigan area. Uncle Bob was part of the Air Force Intelligence, and also claimed to have been working for the intelligence arm of the Catholic Vatican, the Jesuits. My uncle Bob was heavily involved in the manufacture of pornography at that time.

When my father made a pornography film with me and my uncle's dog, Buster, which was a kiddy porn bestiality film, they were caught sending this child pornography through the U.S. mail. When this happened, my uncle Bob Tanis came to him and explained to him that there was an operation going on here in the United States called MKUltra. He told my father that if he would agree to sell me into the CIA's MKUltra mind control, that he could receive immunity from prosecution. My father thought this was a great idea. He thought that the government actually condoned child abuse. He went on to have five more children to raise in the project. There were seven of us in all.

At that time, the child pornography that was being manufactured was being circulated through the local Michigan Mafia pornography ring. Also at that time, a certain criminal faction of our government was sanctioning this kind of child pornography, because they were interested in finding out which children were being used in the pornography; which children could be targeted for mind control, because they knew that if a child was abused prior to the age of five, before their minds and brains could be completely formed, that they were far more receptive to mind control. Therefore, a certain faction of our government was interested in mind control experimentation and use, that actually were covering up the Mafia's child pornography ring.

Once my father agreed to sell me into the CIA's MKUltra project, we were visited by the head of the local Michigan Mafia pornography ring - or rather the politician that was covering up all of these kinds of perverse crimes in our area. His name was Gerald Ford. This is the same Gerald Ford that went into the office of President.

Gerald Ford came out to our house, and he explained to my father how to raise me in the project. He explained to him how to manipulate my subconscious mind, because since I couldn't consciously comprehend the horror, (I mean, where in the world would I place something so horrible in my mind anyway?) I was functioning on subconscious level. The subconscious mind does not comprehend - does not question or reason or rationalize things that it is told. Information that is fed in is readily accepted, through either hypnotic language, language of the subconscious, or neuro-linguistic programming, as it is officially called. My father called it "reverse psychology,"

and he was immediately flown off for a two week course on what he termed "reverse psychology" in Boston, Massachusetts.

When he came back, my victimization became much more horrific, because of the information and the knowledge that my father had learned. My father began applying what he had learned, and in his attempt, he was attempting to scramble fantasy with reality, so that what was happening to me would seem like it was just happening in a dream, or it was just a storybook, or something that wasn't real. It was much easier for me to believe something like that than to actually have to deal with reality, that my father was so perverse, and the abuse that I was enduring was actually being condoned and sanctioned by a criminal faction of our government.

At that time, my father had been instructed to take me to Mackinac Island, Michigan. Mackinac Island, as I am sure most of you are well aware, is located between the U.S. and Canadian border, in essence, and it's where the Michigan Governor's Mansion is located. It is a political retreat, where politicians from all over the country meet and discuss their political agendas. At that time, the governor of Michigan was Governor George Romney.

It was my experience that Governor Romney was interested in implementing mind control into various aspects of society. He truly believed that mind control was a necessity in society. He believed in the kind of mind control that I was being subjected to. He also believed that bringing mind control into the school system would be very beneficial for teaching children greater amounts of information. The Michigan Education System ranked first in the nation for quite some time during those years. It was actually a forerunner of global education, or "Outcome Based Education," as it is now called. This was one area that I was aware Governor Romney was particularly interested in.

It was also in Mackinac Island, Michigan, that I was subjected to the perversion of Gerald Ford. Gerald Ford had been sexually abusing me for a long time anyway. It is not that he was a typical pedophile, like another one of my abusers was, but instead it was more that he was interested in traumatizing the minds in sexual abuse so that he could gain control. He's what I refer to as try-sexual. He'd try anything, with anybody, any age, any time, anywhere. It didn't matter. What mattered was the perversion of power.

Another one of my abusers at that time was then Michigan Senator, later U.S. Congressman, Guy VanderJagt. Guy VanderJagt was an absolute pedophile, and had been sexually abusing me for quite some time. Unlike Gerald Ford, he did not abuse me throughout my victimization. He did not abuse me through the Reagan/Bush administration, and when that reached into adulthood. Instead, he was sexually abusing me as a child, and preparing my mind for mind control, and for the role that I would be forced to participate in, in this MKUltra project.

I'm telling you these names, not because I think there's any kind of glamour in being sexually abused by politicians. Really, quite the contrary. I've named names in our book, "Trance Formation of America," in order that you know

exactly who and what is in control of our country, and for what purpose. I realize that here in Michigan many of you are familiar with these names. There has been a deliberate smoke and mirrors illusion created to fool the American population into believing that their "New World Order" effort is an effort toward world peace of some kind, when in fact it is a world dominance effort that has been in motion for guite some time.

It was in Mackinac Island, Michigan, that I first learned some of these components of New World Order mind control, and other aspects of mind control victimization. Since I was being traumatized, I was photographically recording conversations, and I learned how people such as myself, with Dissociative Identity Disorder, were considered prime candidates, or "chosen ones," for mind control. Not only because of the compartmentalization of memory, but also because when a person is so traumatized and operating through these various compartments, they have no memory of events that had occured previously, and therefore they don't know to be tired, and endurance is increased tremendously in a person suffering from Dissociative Identity Disorder.

Likewise, a person develops 44 times visual acuity. I believe it is an effort to see things before they happen, in an effort to see the trauma before it actually occurs, and the eyes are open wide, and it's as though the victims develop eyes in the back of their heads. 44 times visual acuity means that a person so trained would be able to shoot and never miss their mark. They would never miss their target, because with that kind of visual acuity they are far more apt to be able to see and to aim and to shoot, and therefore Dissociative Identity Disordered persons were targeted themselves for mind control for military operations, for military intelligence, mercenary operations, paramilitary operations, and espionage.

I was never trained in that particular area because I was being raised as a sex slave. I was being raised to carry out and fulfill the perversions of certain politicians in control of our country. And they certainly didn't want someone who was being prostituted to politicians to even know how to shoot a gun.

I also learned at Mackinac Island Michigan about the Catholic's involvement in mind control. Now this is certainly not to say that all Catholics are bad. Not any more than I'm saying that all CIA is bad. I've since learned that seems to be a criminal faction running through most aspects of our society, and it was my experience, having come from a predominantly Catholic area and being raised a Catholic, that I was subjected to the Catholic aspects of mind control. At that time, then Prime Minister of Canada, Pierre Trudeau, who claims publicly to be Jesuit, was very much interested in mind control, was interested in mind control of the masses. He was a part of that intelligence arm of the Vatican that was interested in becoming the one world church in the New World Order. I heard many conversations pertaining to how criminal covert activity is going on in this country and around the world, would be funneled through the Catholic Church and designated immune, for implementing what Adolph Hitler and George Bush term "New World Order."

It was around that time, 1966 to be exact, that I made first communion at our local Catholic Church, Muskegon St. Francis de Salles. At that time, Father Don was the head of our church, and was bringing mind control in on a mass scale. I'm sure many of you all know the Catholics have been sued for vast amountsof money for child abuse proliferated in the church. And this is one reason why. In 1966, after I made my first communion, I was subjected to what was termed "The Rite To Remain Silent." That's R-I-T-E, as in ritual. And I was subjected to an occult ritual. Occultism is of course a reversal of the Catholic Mass, and this was in keeping with that "reverse psychology" that my father learned. This was in keeping with the language of the subconscious, and this was in keeping with the incomprehensible.

At that time, VanderJagt came in and joined Father Don in exposing me to a blood trauma that was so horrific to me that it just blew my mind. When this happened, they used the hypnotic language, the language of the subconscious, to manipulate my subconscious in such a way that I lost control of my own switching processes at that time.

In other words, that compartmentalization that I was talking about, like where I had that compartment that would deal with my father's sexual abuse, as needed. I no longer had the ability to switch into that compartment that dealt with his abuse. I completely lost that ability with the "Rite To Remain Silent." Instead, they placed a series of hypnotic codes, keys and triggers in place of my natural switching mechanism, so that they could decide when, where and how that particular compartment of my brain could be accessed. That way, when I was programmed later on with specific government messages, and with specific perversion that I was forced to carry out, that they would decide when and how it would be accessed, by using those codes, keys and triggers to access that part of my brain.

After this "Rite to Remain Silent," I no longer heard voices in my head, which really was my own voice, because I used to make decisions by pulling from different compartments and perspectives of my brain, and trying to forumulate a decision by arguing back and forth to make the decision. After the "Rite to Remain Silent," it was silent. All I heard from then on were the voices of my abusers telling me exactly what it was I was supposed to do. I had no ability to express any free will at all after that, and I certainly would not have participated in any of these events that I was forced to participate in of my own free will.

After this "Rite to Remain Silent," I was exposed to and dedicated to who would become my owner in the MKUltra project, U.S. Senator Robert C. Byrd. Senator Byrd had been in office as long as I had been alive. He's still in office today. He's head of our Senate Appropriations Committee. He's holding our country's purse strings, and his agenda is for New World Order control, and has nothing to do with the constitutional values and freedoms that we've enjoyed in this country.

As my owner, Senator Byrd would decide where I would be taken, for what purposes, and how I would be programmed. He decided which various

military and NASA installations I would be taken to for sophisticated mind control programming, and later on, throughout the Reagan/Bush administration, it was Senator Byrd who decided what criminal covert operations I would be forced to participate in.

Senator Byrd was extremely brutal in his perversions, which further compartmentalized my memory of the horrors that I was experiencing and being subjected to. One of the first things that Senator Byrd ordered was that I be sent to Muskegon Catholic Central High School. At Muskegon Catholic Central, the groundwork for the Outcome Based Education was already in full swing. They were testing the effects of trauma on the human mind, because it was my understanding, from everything that I heard and experienced, that the Catholics had long since learned the effects of trauma on the human mind, through such things as the Spanish Inquisition. They have been gathering information for centuries. And they were taking that knowledge, that certain criminal faction within the church that needs to be exposed and taken out of the Catholic Church. They had gathered up information and combined it with the information that the CIA had gathered through the Hitler/Himmler genetic mind control research. Together, it was very powerful mind control information. It was extremely effective.

At Catholic Central, I was subjected to occult rituals during school hours, as were many others who attended Catholic Central. As a result, I was photographically recording everything that I learned in school. I got straight A's in school. I was doing excellent, but yet I wasn't comprehending anything. I didn't know how to use the different knowledge I was gaining. But, nevertheless, my brain was being packed in full of knowledge because of the trauma that I was enduring.

It was while I was in Catholic Central that Gerald Ford went into the office of President. This furthered what I had been conditioned to believe: that I had no place to run and no place to hide. Of course, since then, since I've been deprogrammed, I know I do have a place to run, and it's right at them. And I'm not the one with anything to hide. They're the ones who are hiding their secrets under this cloak of so-called "national security." But, nevertheless, that then was absolutely devastating to me because I sensed, I really couldn't think or rationalize, but yet I sensed that the whole world condoned child abuse, that the whole world was somehow involved in this, and that I'd long since lost my hope that there was a place in the world where good people even existed.

I truly felt that there was no place to turn to or run for help. Who was I to run to? My parents? The church? My school? Local politicians? Now I knew I couldn't even turn to the President of the United States. I felt totally trapped in mind control, which is exactly what they want, because the more helpless I felt, the more control that they had.

In 1977, Senator Byrd ordered that I be transferred to Nashville, Tennessee. In Nashville, Tennessee, mind control was in full swing. The CIA operations that were being to run through the country music industry. Drugs were being

distributed throughout the country, particularly cocaine. And the proceeds were going into the CIA's "black budget." This was funding New World Order control. Even now I wonder at how we could have any kind of a national debt, when I know that all the money that was being generated in this country was being used to fund these New World Order controls. If we had access to the money that was being used against us, we wouldn't have any national debt.

Yet the country music industry was very much a part of the CIA's criminal covert operations at that time, and Senator Byrd had strong connections into Nashville Tennessee because he fancied himself an entertainer of sorts. He fancied himself a fiddler. Even though he was from West Virginia, he was a Nashville (unintelligible) that he'd fiddle on the Grand Old Opry. On the occasions that I was sent to Nashville, Senator Byrd was fiddling on the Opry.

At that time, there was a musician playing music behind him named Wayne Cox. Later, Wayne Cox told me that musically wasn't the only way that he also backed Senator Byrd, but that he backed him politically as well. Wayne Cox subjected me to an occult ritual during which I was so traumatized that my suggestible mind accepted the program that Wayne Cox would become my first handler in this CIA MK Ultra project. As my handler, Wayne Cox would follow orders from Senator Byrd, to make sure that I was at designated places at specific times for whatever purposes Senator Byrd ordered.

The first thing that happened is I was taken to Wayne Cox's home state, to Chatham Louisiana. Senator Byrd wanted Wayne Cox to become my first handler because he knew that I would be subjected to further trauma. Senator Byrd wanted more compartments developed in my brain. He wanted more compartments to be programmed for the criminal covert operations that I would be forced to participate in. And therefore I was subjected to numerous occult rituals. This manipulated me by my religion, and made me feel totally hopeless in what was going on.

Wayne Cox was using trauma to trigger other mercenaries into operation at that time, because in the state of Louisiana, under the direction of Louisiana Senator J. Bennett Johnston, there was a mercenary operation in full swing. And these mercenaries had all been Dissociative Identity Disorder children who had been targeted by the CIA for mercenary purposes. They had been trained to carry out these secret operations, and to keep the secret within the compartments of their brain. J. Bennett Johnston was directing them. And Wayne Cox, under the direction of J. Bennett Johnston, would go and trigger through trauma these mercenaries into operation while delivering J. Bennett Johnston's orders.

By 1978, it was determined that I had endured sufficient trauma to be programmed on a more sophisticated level, and J. Bennett Johnston took to me Tinker Air Force Base in Oklahoma. It was there that I endured the first extensive military mind control programming that would force me to participate in a trial run operation. At that time, J. Bennett Johnston was sending the mercenaries into South America, and he firmly believed that when the airplanes went to South America with the mercenaries, that they should not

come back empty. Therefore, the airplanes were coming back full of cocaine, that would further fund the CIA's criminal covert operations, and usher in the New World Order.

I was programmed to deliver a large quantity of cocaine from the state of Louisiana into the neighboring state of Arkansas. I took a large quantity to a remote airport in Ouachita Forest, which I have since identified as Mena Airport. It was 1978. Bill Clinton was governor of Arkansas. After delivering that large amount of cocaine, I delivered a personal stash of cocaine, as ordered by J. Bennett Johnston, along with a message from him and a packet of information. At that time, I witnessed Bill Clinton snorting two lines of cocaine. Yes, he did inhale.

This was not the last time I would be exposed to Bill Clinton. I would know him throughout the 1980's, throughout my victimization, until my rescue and my daughter's rescue in 1988.

My sexual experience with Bill Clinton was extremely limited, because it was my experience that Bill Clinton is bisexual, leaning far more toward the homosexual end. It is for that reason that we can consider why Bill Clinton ordered, this year, in the Outcome Based Education system, that our children have to endure a "Gay Celebration Month." Throughout the month of October, our children were taught all the glories of homosexuality because of Bill Clinton. This wasn't "Gay Awareness." This was gay celebration.

I have witnessed Bill Clinton involved in homosexual activity, and it was Hillary who accessed my mind control programming as a sex slave, and used my sex programming. It was my experience that Hillary, too, leans far more toward homosexuality.

J. Bennett Johnston, back in Louisiana, was still traumatizing my mind, and confusing my mind. He told me he was an alien. That was pretty easy for me to believe! What he was doing certainly was alien to my (unintelligible.) He told me the story about how he had been part of the Philadelphia Experiment. He said when the ship disappeared, it came back a spaceship. At that time he took me through a high security area of General Dynamics and showed me the then top secret Stealth Fighter. I mean, here it was, the triangular Stealth Fighter, that I hadn't learned anything about in my text books or read about in the newspapers. It was still classified. I saw this triangular technology, and I truly believed it was a spaceship. I truly believed that J. Bennett Johnston was an alien. I tell you this because I know for a fact that those in control of our government will go to any length to make all of us feel totally helpless.

Technologically, they are 25 years ahead of us. They are 25 years ahead of us in information, because they have been using that blanket of national security for a long time to withhold information from all of us. You can imagine what has happened over the last 25 years technologically, what those advances are: computers, microwave ovens, all the things that are in our households in the last 25 years, and consider that they in Washington are at

least 25 years ahead of anything we know technologically. In order to make us feel helpless, it is their plan to reveal some of that technology, and claim an alien invasion has occurred. This certainly isn't to say there aren't any aliens. Just because it wasn't my experience doesn't mean that it there aren't any. But in order for us to have the accurate information, we need to know what government misinformation is being planned for all of us, and how we are all being conditioned to feel totally helpless, and surrender to New World Order control. That is the plan.

My abusers always claimed to be aliens or demons or gods, something that I thought was beyond my realm to effect. And I am here to tell you all now that they are just people, and they are subject to the same laws that the rest of us are, and this criminal activity that they are proliferating behind their blanket of national security has got to be exposed. By shining the proverbial spotlight of truth on their criminal activities, they will have to flee.

By 1980, my daughter Kelly was born. She was born right into the MK Ultra mind control project, on a much more sophisticated, high tech level of victimization than I had ever been subjected to as a child. The technology had advanced. Kelly was exposed to harmonic mind control programming at NASA installations and military installations literally since birth.

When I was just a little girl, way before that "Right to Remain Silent," back when I had a free thought to myself on occasion, I thought how wonderful it would be to have ten children. Because (unintelligible) number, but I also felt like that would be ten children in this world that I knew would not be abused. I didn't believe in child abuse. And yet, by the time my daughter Kelly was born, I had no ability to prevent her abuse. I certainly didn't contribute to it in any way, but I couldn't think to prevent it. I couldn't think to stop what was happening (unintelligible). My own survival instincts had long since deteriorated. So instead they would use my daughter, Kelly, to manipulate me by my maternal instincts, and for the rest of our mind control victimization, I carried out every criminal covert operation that I was forced to participate in as though Kelly's life depended on it, because I truly believed that it did.

As soon as Kelly was born, Senator Byrd ordered that we be transferred back to Nashville, Tennessee, where we would be under the control of our second mind control handler, Alex Houston. Alex Houston was the stage hypnotist and ventriloquist in the country music industry that Mark referred to earlier. Alex Houston would provide a means of Kelly and I traveling throughout the United States to various military and NASA installations for mind control programming, in and out of Washington DC, into Canada, throughout Mexico, and throughout the Caribbean.

The country music industry would provide the perfect cover because I dressed like a prostitute and I acted like a total air head, and people tended to think that was probably the norm for the life of a country music entertainer. That was the public image that was protected.

When Senator Byrd ordered that Kelly and I were taken in for mind control programming, we were subjected to sophisticated mind control programming by our primary mind controller at that time, programmer, Lt. Col. Michael Aquino. This is the Lt. Colonel of the psychological warfare division, and founder of the occult Temple of Set, that is proliferating on our military bases. The same Lt. Col. Michael Aquino that is named in the Presidio daycare scandal.

He uses occultism as a trauma base for mind control, and it is my experience that his satanic power was in the form of a stun gun. This high voltage stun gun was used in conjunction with sleep, food and water deprivation, to compartmentalize memory of programs into my child's brain. He knew that this method of mind control would be sufficient for carrying out government operations.

In 1983, Senator Byrd ordered that I attend a White House cocktail party, and he acted in the capacity of a pimp, and prostituted me to then president Ronald Reagan. Ronald Reagan, as you all well know, is an actor, and he was acting to create an illusion of something entirely different to the American populace, while behind the scenes he was very much involved in implementing New World Order controls and eroding our constitutional values.

I heard Ronald Reagan say to then Prime Minister Brian Mulroney of Canada, who was also involved in this New World Order effort, that he believed the only way to world piece was through mind control of the masses. I know from personal experience that there can be no peace of mind under mind control, and I wonder what kind of a world peace could we possibly have with people that have no peace of mind? Since I wasn't in control of my own mind, I had no free will, and without a free will, I had no ability to express soul. I had no ability to express spirituality, and I am deeply concerned for a plan of mind control of the masses, and deeply concerned for the plan for a totally robotic society for the purposes of world peace? It certainly isn't my definition of peace, and certainly is one more reason why it is so imperative that all of you know what mind control entails, so you can think about it and take action now, while there is still time.

At that point in time, I also heard Senator Byrd talking about how he was counting on the American populace to do absolutely nothing about all of this. Because he said good people don't think to look for criminal activity. Good people don't have criminal minds and they don't think criminally, and therefore when we have something put in front of us like "world peace," something that we all hold so precious and dear, we're not apt to look behind that, at what the reality is behind the scenes, and they were counting on good people to do absolutely nothing and to assume absolutely nothing.

Once again they were wrong, because I am seeing all across this country where people are gathering, sharing information, absolutely disgusted by the way their churches are being infiltrated with occultism, by the way their children are being abused horribly, sexually, in the churches, in the day cares. They are appalled at the way the so-called "war on drugs," which in

essence is no more than the CIA eliminating their competition, has been brought to our street corners, and our streets have been turned into a bloodbath.

The erosion of constitutional values and morality in this country have reached such proportions that people are beginning to ask questions. And as we begin to ask questions, we must provide them with specific details, so we can be more effective in taking back our country.

During the 1980s, I was forced to work under President Reagan's Secretary of Education, Bill Bennett. Bill Bennett publicly claims to be a Jesuit, but he does not define the faction of the Jesuit Order that he is talking about. He, along with Lamar Alexander, who is also a victimizer in all of this mess, are responsible for bringing the Outcome Based Education into our school system. The Outcome Based Education was designed to increase our children's learning capacity, while decreasing their ability to critically analyze. By decreasing their ability to critically analyze, they will readily accept information. And I'm seeing now where people all across the country are absolutely upset with the way that they send their children to school, and their children come home completely different and robotic, completely different from anything that they recognize, with values of Socialism and New World Order control.

Home schooling has become the norm in this country. Senator Byrd has said that he would withhold funding to the various states until it reached a point where state governments would be reliant on the federal government to come in and help them with the education system. This year, every state in the United States accepted the Outcome Based Education financing, because they were told it was the only way they could receive any federal funding or any grant money. Every state in the United States accepted Outcome Based Education but one. One governor said the federal government has no business meddling with our children's minds, and that is Fob James Jr. of Alabama. I applaud him for having the (unintelligible.)

This Outcome Based Education is a very serious problem for all of us, and it's setting the groundwork of controlling the minds of our children for New World Order control, which is exactly what Adolf Hitler said in 1936. He said he didn't care who didn't want to accept the New World Order, because he had the minds of the children. I have heard it discussed in Washington D.C. how they believe that they can control the future by controlling our children. We must be alert to what is happening in our school systems. It is said that the price of freedom is eternal vigilance. We must be vigilant with this last freedom that we've got - freedom of thought.

Throughout the eighties, I was forced to participate in the CIA's so-called "war on drugs," and mule copious quantities of drugs into this country against my will, and I want you all to know that our government is involved in that erosion of our morality and that erosion of our society.

In 1988, Mark Phillips rescued my daughter Kelly and I. I certainly couldn't think to escape our mind controlled system. He rescued us and took us to the safety and serenity of Alaska, and it was there that we were safe for the first time in our lives, and the memories began flashing across our mind's screen. And as these memories flashed, I became enraged. Enraged at all the years that had been taken from me. Enraged at the federal covert operations I was forced to participate in against my will. I was enraged at what had been done to my daughter, and I was enraged at what the plan was for New World Order controls on all of us.

This rage was absolutely blinding me from any recovery. It was totally immobilizing, were it not for Mark's wisdom in telling me that recovery is the best revenge. And the best way to recover my memory and my mind was through using logic. And the best way to logically deal with what happened was to write out my memories of those events rather than verbalize them. By writing out these memories, I used a portion of my brain that bypassed emotions. Having a new conscious awareness, and having this kind of logic brought into the deprogramming process, I was finally able to question, to reason, to critically analyze, and to begin to finally understand the incomprehensible. As fast as their information was deprogrammed, it was verified by concerned members of law enforcement, the intelligence community, and members and factions of our government. This information was disseminated widely and vastly, because we knew that by not keeping any secrets, that we could survive, to reach this point in telling you all exactly what's going on behind the scenes in our government.

It's a fact that 95% of the people are led by 5%. This really holds pretty much true, because not everybody can accept this information or act on this information, or even wants to hear it. All we need is 3% of that 5% to be back in control of our country. That's a small number, but we've got to get this information out. We have got to spread this information as far and fast as we can.

My daughter Kelly was not so fortunate. Through a series of events, she ended up in the custody of the State of Tennessee, where she remains a political prisoner today. She was 8 years old when Mark rescued she and I, and she enjoyed one year of family love and a loving relationship. Mark and I fell in love throughout this process, and I feel extremely fortunate to have found the kind of love that most people spend a lifetime looking for and seldom ever find. But we have got a beautiful, loving relationship, which gave Kelly a view of life that she has never experienced before. And this is the hope that she maintains, waiting, while she is locked up in a political prisoner environment, where she is denied rehabilitation, due to who and what she knows is involved in MK Ultra.

It certainly raises the question, what "national security" has to do with the rape and molestation of innocent children's minds and bodies. Because the violations of laws and rights continue to proliferate in Kelly's so-called "legal case" is all happening under a blanket of so-called "national security." This is a national security that is threatening the security of our nation, when it covers

such crimes as child abuse, political perversion, the CIA's involvement in drugs, manipulation of our children's minds through Outcome Based Education, and exactly what mind control is.

For this reason, Mark and I went to tremendous lengths to circumvent any national security censorship, and self published our book, "Trance Formation of America," that provided far more detail than I could give you tonight, in order that you could be armed with sufficient information that you have a right to know, so that we can all be far more effective in our efforts to take back our streets, to take back our churches, to take back our schools, to take back our country, and to take back our world. It is truth that sets us free. Please help us to spread this word. Thank you.

## Mark Phillips:

(Lost several seconds - responding to question about why they won't take any verbal questions, only written ones.) ... like yourselves. We've been doing a lot of work with the mental health folks. Therapists are known as "rapists" and mental health is known as "mental hell" and I learned real quick around doctors, you don't allow them to ask verbal questions, because they get in heated arguments and (unintelligible.)

## Cathy O'Brien:

Verbalizing goes into the emotions, and by writing, it certainly keeps it logical, and logical is the key for us all to deal with this psychological warfare tactic.

#### Mark Phillips:

Question: Is there a Masonic connection to this sexual abuse?

Quite frankly, all secret societies are involved or infiltrated in some way. I know a lot of Masons that are as surprised and as shocked as you are to learn about this. But yes, Cathy was abused in some Masonic halls, and I'm sure, by the names I checked and the names that some of our friends within the FBI checked that not all of them were Masons that were in there that were in fact sexually abusing Cathy. So I guess you could say Masons are involved, but it is not a Masonic issue so much as it is a criminal issue.

Question: What role does NLP play in mind control?

I wish every child and every adult in this country understood Neuro Linguistic Programming. Neuro Linguistics is the language of the unconscious, and until you understand it, you can become a victim of it. Not in absolute robotic mind control, but you may find yourself impulse buying in the grocery store, or you may find yourself falling victim to a very clever automobile ad or perfume ad or, I don't think you'd call it the military, but the military uses NLP and subliminal (unintelligible) heavily in their marketing campaigns to recruit.

Question: Is NLP comprehensive in Colorado and Ohio and involved in this in any way?

No. NLP, I believe, should be taught to everybody because if you understand something, it is not nearly as dangerous, and NLP is the language of our unconscious.

Question: How does the HAARP project play into mind control of the masses?

The Soviets were the first to developed this type of technology. It is based on Nicola Tesla's work, and it is tapping into the Van Allen belt, among other things. This book called, "Angels Don't Play This HAARP," by Doctor Nick Begich out of Anchorage Alaska, and it is one of the most comprehensive. His father was a Senator of Alaska, and along with the Senator from Louisiana (unintelligible), neither one of them have ever been found. Their plane went down a few years back and (unintelligible.) But Nick, his son, went on to become a doctor, and has written a wonderful book exposing this. Haarp, among other things, is a behavior modification device. It is a mind control device. Among other things, it is wreaking havoc, I believe, on our crops and certainly our weather pattern. But you need to get his book and read about that.

Question: Are you on the World Wide Web?

Yes. We are.

Question: If yes, do you have an internet address to give out?

Oh, I feel awful. Yes, I do have an address, and if you'll write us, we'll give it to you. And you can now hear us talking, do all kind of things on this particular web site, (unintelligible.) There's one of them that went into operation just last Friday which is, um, I'm really illiterate when it comes to the Web and to the net, and we've had people, supporters, putting us on there. But we have an address: PO Box 158352, Nashville, Tennessee, 37215, it is in our book. If you write to us, we will immediately get back and give you that internet number.

We want to get as many questions as we possibly can.

Question: What are you going to say about the Philadelphia Experiment and Montauk?

Ok. First of all, for those of you who don't understand about Montauk, there are a number of people that are going around the countryside stating that we've been involved in all sorts of things involving aliens and this sort of thing. I'm not saying that there's not aliens, I'm not saying that some of our problems couldn't be alien related. All of it seems alien to me, but in my experience and all of the experience of those that I know in the various intelligence communities, no one has coughed up the information that this is aliens behind this stuff. And I'd like to understand, for you all to understand

what I understand is the bad guys go to a whole lot of trouble to convince us it's aliens, and that ought to tell you something right there.

But the Montauk Project is very simple. Montauk is out on Long Island, New York. It is at the very tip of what was a super-secret military installation, most of which was underground, which was using sea water as an antenna to monitor the soviet submarines that were based out of Norway. Now this project was so super-secret, like many other military operations, they put everybody in there under mind control. They used multi-generational victims of mind control, or I should say incest, and they recruited them into the military, and there's lots of them in there, and by the way, if you look into the backgrounds, so many of the people who walk into the McDonalds or the Burger King and open up a Mak 10 or an Uzi on a bunch of little children, maybe those people were programmed to go in there and do that, but the bottom line is look at their backgrounds. They all came out of the military and they all came from a sexual abuse based family, and they were all Dissociative Identity Disorder. That doesn't mean all DIDs are dangerous. It means that DIDs are manipulated and I believe this is what happened.

But the Montauk project, there's a lot of wild tales about it. But the truth of the matter is, those wild tales, I happen to have the luxury of knowing two of the psychological warfare agents, if you want to call them that. I call them "officers," that actually put together some of the information that was released to the populace through various newspapers, through various radio programs, through various individuals, who by the way will fully tell you they were victims of it, and these victims are standing there talking about some claims that go well beyond the realm of believability, like invisibility and time warping and all this sort of thing, when in fact, if our government could do that, then we ain't really here. But Montauk, all it is is a cover for what really happened, and the government has done a remarkable job in coverup before.

The Philadelphia experiment, where they were testing paint on a ship, and they were testing some electronics, some electromagnetic compressed. compressed electromagnetic pulse beams, they wound up frying the brains of the few people that were on board a ship in a Philadelphia harbor, and so they wound up saying that they made the ship invisible and the people came back and they were sticking out of the hull and all this kind of nonsense. Don't you just imagine that George Bush would be right behind me, kicking my derriere, if in fact these people could be invisible? Do you think that I'd be out here doing this if these folks could be invisible? Well heck, it doesn't make any sense. The bottom line is the places we hear this information, if we track it, the information you are hearing tonight on MK Ultra, every bit of it, we even gave you a road map in the back of the book to look into it on a credible basis. Go to your public library. Go to your medical library. Go see your psychiatrist. God help you if you got one. But see him and ask him about DID or MPD. Ask him about the fact that in 1980 there were 200 cases, and in 1990 there were a quarter million, and by 1995 two and a half million, and this represents a fraction of what is out there.

Question: Where can you get information on NLP?

Oh, this is tacky. Buy the book. It's right in the back.

Question: Does the Gospel play a role in your life?

I want to tell you all something right here and now. Rich Strawcutter is a good example. He didn't even ask me. He knows better. But I had a fellow come up to me yesterday, or the day before yesterday, and he got me right in the face and he said, "Are you a Christian?" And I looked right back at him and said, "It takes one to know one." We're supposed to be Christian, not just tell folks we are. Its like saying, "Are you a member of my little club?"

Question: (I can't begin to answer this.) Please explain the difference in mind control as per Saint Ignatius (unintelligible.) I'm sorry. I can't do it.

## Cathy O'Brien:

Contrasted to CIA adaption of it. It was not meant to be used for evil purposes. It is my understanding too that it was not meant to be used for evil purposes, and I don't know that that has anything to do with a certain faction of the Jesuits using mind control information. But I have heard from some people high up in the Catholic Church since the release of this information, very supportive information, about how the Vatican II was what they claim that I was exposed to, that there was an enormous change within the church when the corrupt faction did take over certain influences within the church. This doesn't mean that they are in control of the church. Absolutely not. There's a good many Catholics who are disgusted with the way that the children are abused, used in the church, and there is an enormous effort going on toward the church to be restored to its original intent.

## Mark Phillips:

Question: Is this 200 mile copper cable in the Michigan Upper Peninsula about MK Ultra?

I don't know, but there's millions of miles of copper cable all over this country. I really don't know about that particular one but I think Michigan somehow plays a part in this HAARP thing, I'm not sure.. Please don't hold all of our credibility based on that statement. I usually don't comment on it. Question: This is one of my favorite questions, and I'm hiding behind this thing, so if there's any Scientologists out there, don't get mad at me, because I'm going to say some nice things and I'm going to say some honest things. The Church of Scientology: Do you know anything about the Church of Scientology?

Yes I do.

Question: They have thousands of churches (unintelligible) in all the magazines and they're talking about global expansion and group unification and they all wear military uniforms when they dress up.

Well, they dress up in those sailor suits.

Question: Is this the New World Order church?

No.

Question: NLP Mind Control?

Yes. The Church of Scientology was founded by a, he was a naval intelligence officer who became familiar with all this information back in the late 40s like everybody else did, and he got so excited about it, he was a very brilliant man, matter of fact, he went on to become a tremendously popular science fiction writer, he wrote a book called "Dianetics." Actually, he call it "Bible." Well, he is dead now. Well, his people say he is still alive. But the fact is L. Ron Hubbard is a genius, and he developed what I consider one of the greatest potential mental self help books that I've ever seen in my life, except for one little thing. Listen. When anybody tells you that they're going to change the language of anything, in other words, when you take, and you say, "This is a kitty cat, but from now on you gonna call it a dog," then there is something wrong with this picture. Go along with the established protocol with whatever that thing was called originally and you're going to stay safe. All he did was just make up his own language, and that's how cult churches work. They take the Gospel and they turn it around and they rename everything and they set up their own languages and all of a sudden you go, "Uh." Well that's what happened with the Church of Scientology. They've attracted a lot of real rich folks, because, let me tell you something. A lot of survivors of this stuff are not dirt poor. They are entertainers, and they got lots and lots and lots of money that the IRS and their handlers haven't taken away from them yet, and they wind up, and if you think about it, who would be a better actor than an MPD? Somebody asked about Michael Jackson. I don't know about Michael Jackson, but I can tell you that I saw Elizabeth Taylor's bodyquard in charge of all her security get on international television. and it is easy to get a copy of this, international television, and she got on every access cable group I think in America, or the cable network and at various times of the day and night you could see the show. He talked about the fact that after Ms. Taylor rescued this young man and carried him to England, and then was going to, had him in front of some doctors, his "handlers" came and absolutely kidnaped him away from these doctors and carried him back to this country, and then this child molestation case was settled. Now there are lots of rumors abounding about Michael Jackson, but I don't have any proof and I'm not going to stand up here, cause I sure don't want to be sued by that guy.

Question: Is there anybody running for president who is honest and not involved in all this?

Yeah. There is. There really is. ("Who?" from the audience.) That's the problem. The problem is these people don't, it's too late in the game, and right now, the bad guys are in control of all of this, whether you know it or not. And you can accept it. We are the underbelly. We are ripping them apart. So it doesn't matter who goes in. The president is not going to make the difference. It's the rest of the government. It's that other handful of criminals

that, it's not just our government, it's the whole world. Just a handful of criminals running our government and the whole world, and I don't even know who's at the top, and I don't know who would be the perfect candidate for president. I wouldn't have the job no matter what you promised me! I can't imagine anybody taking that job right now, because you've got a criminal element that's in charge of them!

#### Cathy O'Brien:

When the people lead, the leaders follow. It's up to all of us to take back the...

## Mark Phillips:

Yeah, we're doing it. Whether you all realize it or not, we're actually accomplishing the impossible. All of us.

Question: Where can you be contacted?

Oh please. Look in the second page of our book. It gives our address.

Question: Do you know where you will be speaking next?

I'm just grateful to be speaking anywhere!

(Shouted from audience: "How come you're still alive?")

You gotta read the book! I'm not gonna take any questions from you. You just gotta read the book.

Question: Usually I thought the CIA takes the book from the authors?

Uh huh. That's exactly why I self published it. Because I had more publishers running into us, with all of this wild money that would have ended all my problems, and some people said, "You're a criminal! You could take this money and put Kelly back together." I said, "Let me tell you something, pal. \$200,000, and that was the top offer, wouldn't even begin to put Kelly back together. All that's going to do is get me killed, because then I lose control of this information for 17 years and I'm done." I said, "No thank you. I'm going to open my own dang publishing company."

I appreciate you all asking about that New World Order Church on, oh, here's another one.

Question: I'd heard John Lennon's assassin was inducted into CIA mind control?

Yes.

Question: And in Algiers and was manipulated to murder Lennon. Have you heard anything about this, or anything similar?

Yes. There's a fellow name of Walter Bower, and I won't give your name up, but if you'd contact me, and you know my address, if you'd contact me, I'll give you the information and the background research from two CIA officers and a couple of FBI guys, and they (unintelligible) to you like that.

(From the audience: "Excuse me, Mark. There were two other questions on there and the first one on the yellow piece of paper, that was my most important one. I had one, two, three on the..")

Ok. Ok. Oh. Bear with me. Oh, yes.

Question: Doctors, drugs, surgery and medical tests are killing people.

You better believe it. Listen. I wouldn't go to a doctor if you all ran over me with a truck. Unless I could find, I know some that I trust, who even know how to use a knife.

Question: Also processed foods, NutraSweet and sugar?

Uh, stop. Stop. Plain old processed, or processed sugar is bad for you. But unprocessed sugar, that's what the bad guys want you to think. Because let me tell you, the first thing we take somebody off of is sugar. The first thing, in order to maintain mind control on somebody and lower their blood sugar, you take them off of sugar, and you put them on NutraSweet. I want to tell you all, right here and now, NutraSweet is harder to get somebody off of than heroin.

## Cathy O'Brien:

I know. I went through it. It is absolutely terrible, because NutraSweet actually does something where a person becomes more suggestible and more receptive and not so clear thinking on their own, and that was something that they wanted, so I was forced to consume copious quantities of the NutraSweet. It was horrible getting off of it.

#### Mark Phillips:

Question: I heard there's a pill the CIA can give somebody that would cause him to have a heart attack.

There's over 1100 of them, and that was in 1967. You don't have to give them a pill. You can program it in. She had death programs, and I almost lost her. Most of the ones like Cathy are not vocal because they are dead. Because once that programming it tripped over, and it's in there, you know it right up front, because, and I'm not going to get into those issues right in front of this audience, because they are clinical and somebody could get hurt in here. But there are certain indicators up front that let you know they are there. And I haven't, not that I've seen anybody in Michigan that's been programmed with a death program, but I don't know.

Question: Can this happen to anybody?

Well, no, it can't. But yes, it can. They can spray you in the face with Hypogaine and you gonna be nuttier than a fruitcake for the rest of your natural life, until you take the antidote, and if you wait more than 44 days, you can forget the antidote. Hypogaine comes from a root or a vine in South America. A lawyer just got hit with it down in Texas the other day because he's a constitutional lawyer, and now he's just wackier than anything you ever heard of. He thinks that things are molesting him. He absolutely thinks he's got things crawling all over him. And we got him on the antidote, and couldn't keep him on there because it's against his rights, the court said, even though he was improving. So it's very sad.

There's a million things they can give you against your knowledge. That's just too broad to even cover.

Question: If one never goes to bars, and is 100% of what goes on around him, how could you market, oh. Oh. I see what you're saying. In other words, how could you fall victim to it?

I'll tell you how you can fall victim to it. They can rub it on the doorknob. But listen. You go and get paranoid, and thinking they are going to come and get you, you're just as good as dead, and you might as well just go off somewhere and you're not going to be any good to anybody. Listen. Fear is your worst victim, or your worst victimizer, I should say. If Cathy and I walked around paranoid about what we are doing, we wouldn't be here. I would be in a looney bin somewhere, and she would have suicided. But that's not going to happen.

## Cathy O'Brien:

Incidently, neither one of us is suicidal.

#### Mark Phillips:

Oh, please! Neither one of us is suicidal. (Unintelligible.)

Question: (Unintelligible) this book without being stopped, they would have (unintelligible) and the way the law doesn't allow government employees to (unintelligible.)

I was not a government employee. I was paid by Ampex Corporation. And since I was a civilian employee, and I was not an officer, I was an operative, it makes a big distinction there. For one thing, there are things that I can't talk about, and there's no sense of me telling you about a key, down in the Florida Keys, that isn't on the map, called Inner(?) Key. Oh no. I can't talk about that. (Unintelligible) down there. (Unintelligible) But I can't tell you about that key.

Listen, these people are smart, they're sociopaths, and they're just plumb dangerous, and I'm not going to make light of it. And I'm going to tell you right now that there are things you can do to protect yourself. First thing you better do though, and I'm not making light of this, first thing you might better do is

make sure that your relationship with yourself and your God is intact, because (unintelligible) matters.

Question: Do you know how someone could find out if they were a victim of MK Ultra experiment?

Yes. Assured. As a matter of fact we get a number of requests for this, and I have a standard test I send them out, and it is very revealing. It tells me everything I need to know, and if you want to write to me, I wish somebody would give me a break though, and put two dollars in an envelope, a copy, making a copy, it takes time to do it, but I'll do it. I'll send it to you, you can fill it out, I'll even show you how to fill it out, it's real simple, and mail it back.

Question: Would you all say that Jim Jones was an experiment in MK Ultra?

I'll just tell you this. We have copies of the CIA's deed for the land in French Guyana, and Jonestown. They even bought the property for Jim Jones. It wasn't intended (unintelligible) experiment, it was for biologicals. And there's two more encampments still there that you all don't know about. Contact the Guyanese government, and ask them what's going on down there, next to Jonestown, within 100, 120 miles. They still got two encampments, and they're still testing. The Mossad is down there, the French are down there, MI6(?) is down there, and the CIA is down there.

## Cathy O'Brien:

Question: Kelly's 16 years old now. Will you be able to free her at the age of 18 years old, and where is Kelly being held?

## Mark Phillips:

What a good question.

## Cathy O'Brien:

Yeah, excellent. Unfortunately, Kelly must be deprogrammed in order that she not be a threat to herself or to society. She wants to be a contributing factor to society, and she wants to be able to live as she knows she is inside. She wants to be able to express soul, free of any mind manipulation and mind control. Until she is deprogrammed, she is still accessible, and therefore is a threat to herself and to society, because she was genetically born and raised and mind control programmed to go into espionage, so she has the programming that is accessible, and she lives in fear of someone accessing that program before she gets some help. So we've got to continue to increase public outcry to this point where the State of Tennessee and the government must release the information on her victimization and the technology in order that Kelly and so many others like her can be helped. So please, I implore all of you and encourage all of you, to write Kelly with letters of kindness and support, through the address in the book, and also please write the state of Tennessee and demand to know what national security has to do with Kelly.

#### Mark Phillip:

Question: Many authors offer riveting tales in published books. Can you

dispel the rumor that you have simply authored a fantastic tale through the vulnerable mind, (then they scratched all that out,) of a DID patient, I.E. Cathy O'Brien.

Yes. I sure can. If you will buy the book and look at the evidences that support it, and please, please follow through with what I am talking about, and remember one thing in your head. I am not insane, I (unintelligible) mental illness, and I left a lot of money in the bank to insure the fact to insure the fact that the CIA would think I was crazy. Now anybody in this room can go back and check me out, I've given you enough information, I've given you my date of birth, my place of birth. Any of you in here can get in there and start checking. So the point is people don't do these things that Cathy and I are doing, for one thing, how many of you, would you please hold your hand up, would like to be up here doing what I am doing, and make yourselves a cool 2500 bucks a year. No takers. Well, I can make you a published offer. Get me a manuscript. I've got my own publishing company now.

Question: Do you feel Bill Clinton himself could be manipulated by MK Ultra?

Boy, I'll tell you, there's a lot of conjecture on that one. I don't think so. I don't think (unintelligible.)

We've run out of time. We've gotta be out of here by eleven o'clock, and I've only go a couple of minutes, and every one of your questions is important. But we're here strictly by the grace of God, Rich Strawcutter and Dominic Vincintini, and our book sales. And any of you that would buy a book from us, I would appreciate it, and this is, perhaps your question, you can mail it to us if you don't mind waiting a while, I wish I had the names here, but that would make somebody paranoid. And by the way, that's how we get to these speaking engagements are people in the audience who say, "Hey, my church would like to sponsor you," or "My group in such and such would like to sponsor you in." We don't charge to come in. We only ask that you cover our basic expenses, if it is over 500 miles, cover our air fare. In this case, there is no air fare because we had a whole tour planned. The only thing that we ask is that we are able to sell our book, and be able to get to the people. Now sometimes we get help from donations and that sort of thing. God knows I'm not insane, we accept them. But we have to sell our book in order to survive and in order for you to get the information and share this information and to write us and to write Kelly and to write the state of Tennessee and be doers like I know you are, you gotta get the book. It's only fifteen bucks, it's gonna cost you eighteen if you write to me, and I got fourteen minutes. Thank you very much.

#### Transcriber's note:

I have tried to be absolutely faithful in the transcription of this presentation. The grammatical errors are in the original. When there was any doubt as to what was said, I wrote (unintelligible) rather than risk a misinterpretation of

meaning because of a transcription error. The only modifications were the expansion of a few spoken contractions, such as "it's" and "they're".

A careful look at this material will reveal nothing whatsoever supporting their specific claims as to who they are or what they have been through, although the package made very interesting reading and provided me with many leads for subsequent research.

I was then told that Mark and Cathy would be in my area on June 4, and that they were willing to spend "as much time with me as I needed." I prepared a series of interview questions, along with some specific documentation requests. I also prepared the document requests in written form, in case something precluded us from meeting as we had planned, and so they would have something to take with them.

A trusted friend accompanied me to their presentation on June 4, 1996. I openly audio taped the presentation along with several others. The event was also video taped, but I do not know by whom. I found Mark to be a brilliant speaker and audience handler. He was entertaining and a pleasure to listen to. Cathy wasn't so comfortable, but she did well also. It was interesting to note that she would often lose her place mid-sentence, appear to be "reading the air" for a couple of seconds, then pick up on the next word and continue as if there had been no pause.

The meeting ran longer than expected, and Mark and Cathy were occupied selling their books until we were all thrown out of the building by the janitorial staff. I waited in the parking lot while they carried on separate conversations for quite a while.

My patience began to wear thin as the hour approached midnight, so I approached Mark to speak to him. He grabbed the person he was talking to and moved further away from me. I finally walked up to him and told him I wasn't going to be able to wait any longer, as I had to work the following day. He expressed regrets and offered to meet me for breakfast, if that would work better. I decided it wouldn't, handed him my prepared written document requests, and we parted.

During my time in the parking lot with them, I noted that Mark and Cathy were traveling in a new Chrysler Imperial with an Alabama vanity plate which reads, "MONARCH."

Mark called me the following day, assuring me that all of my requests for documentation would be easily fulfilled, and that he would give them prompt attention upon his return to his home.

The documents I specifically requested were medical documents covering diagnosis and treatment of Cathy's physical scars, mutilations and eye damage, legal documents demonstrating their struggles with the courts regarding both Cathy and Kelly, and anything at all he could give me to demonstrate any single aspect or event of Cathy's story while she was still under mind control, since they adamantly claim to be "fully documented." Again, I was assured all of this was available, that it would be sent to me promptly, and that I would be welcome to share it with anybody I wished, in any way I wished.

After nearly a month of waiting, I received call from Mark telling me that the documentation had finally been assembled and it was on the way.

The second documentation package contained the following:

A color photograph taken of an eye under a slit lamp, with the note that
this showed the damage to Cathy's eye. I had the image checked out
by a certified ophthalmic technician, who said that the image did not
seem to show any damage, but that it was a very difficult image to
read.

- Letter from Mark Phillips to "To Who It May Concern" detailing the lack of answers as far as rehab for trauma base mind control victims.

At this point, I decided to quit pursuing this matter, and to publish all that I had gathered on them.

The documentation is available, but copying it or scanning it all would be a monumental task. I will honor any specific requests for copies of parts of it, providing I am sent an SASE. If the copying amounts to more than a few pages, I will have to ask for reimbursement for copying charges.

The tapes are of miserable quality, and further duplication will result in nearly a nearly useless copy. I also have witnesses to all contacts except for the second and third phone conversations with Mr. Phillips.
