Dear Mr. Jinnet:

On January 4th, 1955 an agent of the Federal Bureau of Investigation visited Eustace C. Mullins at his parents' home at # 834 Spring Hill Road, Staunton, Virginia.

An obvious reason for the visit was the fact that Mullins' was cited by the Congressional Committee as a fascist and that his name also appears as a leading fascist writer in the committee's report.

Mullins is a very intelligent person, one of the very few intelligent rightist extremists in the United States. He is not subversive or dangerous, merely anti-Semitic. He does not believe everything he writes; sometimes he engages in horrible journalism of a low caliber, at other times he can write as a scholar, as witness his writings on the international financiers. Mullins stands out among U.S. nationalists because of his learning and his intelligence. He is by no means a crackpot or to be identified with the assorted lunatics in this field.

In his interview with the F.B.I. agent Mullins posed as a crackpot. He affected the pose of a crazy extremist and deliberately did not act intelligently when he talked with your bureau's agent. Why he did this is not too clear. He says that he wants to give the federal authorities the impression that he is not intelligent, but just another stupid fanatic. He evidently thinks that this will spare him possible future trouble. I do not follow his reasoning.

One reason why some people think like this is that they believe the F.B.I. is under Jewish control. They fail to make a distinction between the F.B.I. and the other parts of the Department of Justice which are more or less under Jewish influence. I have nothing against individual Jews, in fact get along well with them. It is only various leftist agents that I have been opposed to, and occasionally the Anti-Defamation League. Also, many persons are misled when they read articles, such as the recent one in the Anti-Defamation League bulletin by the assistant director of the F.B.I., in which he gives a silly endorsement or flattery to the Anti-Defamation League. Such things are politically expedient or necessary courtesies. They mean nothing. Both the F.B.I. and the Anti-Defamation League are well aware of what each thinks of the other.

Mullins has not returned to New York in over a month and will remain in the south a while. His New York address is Apartment 19, 60 East 4th Street, New York 3, N.Y.

Mullins wrote Frederick C. F. Weiss a letter last winter. It was merely to compliment Weiss on his writings and to exchange theories and a political philosophy with him. I did not object to Mullins' writing Weiss. He reported it to me. However, the letter never reached Weiss. Mullins never wrote Weiss again, as far as I know. Mullins sent his letter to Weiss' mailbox in Yorkville, where the Anti-Defamation League agent, Charles G. Smith, took Mullins' letter and handed it over to his bosses. The mailbox is in a private place and Smith pays the rent on same. I pointed Mullins' mistake out to him, but people like Mullins are so unmindful of hostile agents that they don't even think of how to get letters through. Mullins' mail in New York rarely arrives at his apartment and I never write him there.

In the January 4th, 1955 interview with the F.B.I. Mullins was generally evasive with your agent. It was no loss to your bureau, however, as he has little to tell, and nothing that in the course of time would not be reported by me anyway.

Letter of 1-7-56 from Eustace C. Mullins, Staunton, Virginia, congratulates the Director on his fight against Communism. Mullins' letter states there are, however, reasons why the Director has not been able to pursue this struggle more forcefully. Mullins offers to be of service against Communism and Zionism.

Bufiles reflect that Mullins has been described as being vehemently anti-Semitic. A security investigation of him was opened by New York Office in 1953; however, the case was closed because there appeared to be no violation within Bureau's jurisdiction.

In February, 1955, Bureau received a leaflet entitled "Impeach Eisenhower" by Eustace Mullins which contained a scurrilous attack against the President. Copies of the leaflet and data in Bureau files were furnished to the Special Assistant to the President, Secret Service and the Department.

Newark Office by letter of 7-8-55 forwarded a letter received from Edward A. Fleckenstein, president of the Voters Alliance for Americans of German Ancestry, Weehawken, New Jersey. Fleckenstein's letter reported he was informed by Eustace Mullins that when he, Mullins, was interviewed by a Bureau Agent at Staunton, Virginia, on 1-4-55 Mullins deliberately was evasive and endeavored to give the impression that he was a crackpot in order to spare himself possible future trouble. Fleckenstein's letter claims that Mullins is an intelligent extreme rightist, who is not a subversive, but merely anti-Semitic. His letter added that Mullins will return to New York City in near future.

RECOMMENDATION:

In view of the information in Bureau files concerning Mullins, no acknowledgment be afforded his letter. Attached letter be sent to Richmond and New York Offices, informing that no acknowledgment is being given Mullins' letter.

### POSTERS IN U.S. NEGRO TAVERNS

From D. B. W. (New York):

A very important document came to me in the mail this morning, which really should be distributed all over Europe.

I had heard that such a poster was being put out, but had not been able to see one. While in Chicago, I met a friend, a man of great personal courage, and he promised to go into Negro areas and try to find one of these posters. He did so in the first Negro poolroom he went into, and ascertained that these posters are exhibited in Negro barbershops and taverns all over America. They read as follows:

#### YOUNG NEGRO MEN!

Are you the victims of race prejudice? Do white girls refuse to go home with you? As a United States soldier, you can travel abroad and be stationed in the homelands of our allies, where your high pay will make you wealthy in the eyes of the people. Your money is worth five times as much as theirs!

Negro-Americans, the white girls of Germany and England are waiting eagerly to see your healthy smiles!

JOIN THE UNITED STATES ARMY TODAY!

At the top of the poster is a picture of a grinning young Negro and resting on his shoulder is the face of a blond white girl.

This group has sent out invitations to many persons to join this organization and the letterhead includes the name "ALICE JOHNSON" as the secretary; the name "ALICE JOHNSON" is being used as a cover name for MATT KOEHL who is from Milwaukee, Wisconsin and active in "hate groups", according to [redacted]

The files of the Chicago Office disclose that MULLINS, who has been living in Chicago recently, is closely associated with MAYNARD NELSEN of the Realpolitical Institute.

EUSTACE MULLINS has written numerous anti-Semitic articles for "Women's Voice", a publication of We, the Mothers, Mobilize for America, Inc. MULLINS has also visited with WILLIAM WERNECKE, 6250 North Wayne Avenue, Chicago, Illinois, who is head of the Nationalist Conservative Party.

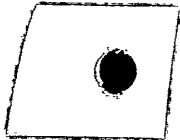

Investigation at Staunton, Va., reflects R. WALLACE ROSEN has been Postmaster at the Staunton P.O. since 1951, having previously served as Supt. of Mails and Assistant Postmaster. ROSEN has been employed by the Post Office Dept. in Staunton for over 35 years, the only previous government employment being as a messenger with the War Dept. in Washington, D.C., during World War I. ROSEN highly regarded by fellow employees and acquaintances in Staunton despite the fact that he has been drinking in excess during the past two years. Post Office authorities aware of fact that ROSEN is drinking excessively and while on the job but have taken no action because they anticipate his retirement in the very near future. One source connected with the Post Office Dept. advised that last fall, ROSEN made a very bitter enemy of one CLARENCE EUSTIS MULLINS, a former resident of Staunton now working as a writer for a New York City publication. He stated that during a West Coast investigation by the Post Office Inspection Dept. of Reverend GERALD L. K. SMITH, it was determined that SMITH had quoted CLARENCE EUSTIS MULLINS of Staunton in some literature. He said that ROSEN contacted MULLINS' brother in Staunton to ascertain CLARENCE's address at the request of the Postal Inspectors Dept. and when CLARENCE learned that ROSEN had made inquiries about him, he became angry and wrote letters of criticism to the Postmaster General and Congressman BURR HARRISON of Virginia. This source claims that MULLINS, who worked for the Library of Congress at one time, has the reputation of being a prolific letter writer and also being a "crack pot". ROSEN has been very cooperative with Agents of the Richmond Office and has frequently expressed his high esteem for the

Dear Colonel Morgan:

As I told you on the telephone, my Government has made efforts to find out, who has spread in Germany the information about the poster allegedly issued by the U.S. Army and soliciting Negroes to join the U.S. Army with the expectation that in England and Germany they would find white girlfriends.

The news was distributed to the German press by the Argus Presse Bureau und Verlag (Argus Press and Publishing House), 5 Libanonstrasse, Stuttgart 13, Germany.



Letter enclosed leaflet captioned "Impeach Eisenhower" by Eustace Mullins, reprinted from "Women's Voice," concerning whom Governor inquired.

Leaflet has previously come to attention of Bureau and in February, 1955, copies were made available to White House, U. S. Secret Service, Department and Post Office authorities. Leaflet demands impeachment of Eisenhower because of alleged association with communists, opposition to Senator McCarthy's anti-communist campaign and association with Jewish advisors.

"Women's Voice" is official publication of organization "We, the Mothers, Mobilize for America, Inc.," subject of Internal Security - X investigation, last report submitted 3/15/56 and disseminated to Records Administration Branch, U. S. Secret Service, Post Office Department and intelligence agencies of Armed Forces. Organization is violently anti-Eisenhower Administration, anti-Semitic, anti-Masonic, anti-Catholic, anticommunist and opposed to all foreign elements in U. S. Main interest of organization is securing subscribers to "Women's Voice." Occasional meetings of organization are attended by less than 100, consisting mainly of women past fifty years of age. Organization located Chicago, Illinois.

Mullins has contributed articles to "Women's Voice." He was discharged from employment with Library of Congress following World War II as result of acknowledged authorship of racist writings. He has written number of anti-Semitic articles and is opposed to Eisenhower Administration. In 1952, investigation of Mullins was initiated on basis that he reported on 5/14/52, alleged speech delivered by Rabbi Emanuel Rabinovich before special meeting of Emergency Council of European Rabbis in Budapest, Hungary, 1/12/52,

## THE ATLANTA REPORT

One of the most shocking examples of judicial tyranny since Roosevelt tried to imprison 32 of his critics as "seditionists" is now taking place in Atlanta, Georgia. Five young anti-Communists have been arrested on a charge of dynamiting a Jewish synagogue. The only evidence against them is the fact that they were arrested on July 27 for picketing the leftwing newspaper, the Atlanta Constitution & Journal. Police found anti-Communist literature in their homes, and, for reasons we cannot understand, took this as conclusive evidence that the boys had committed the crime.

Police claim that the boys met on May 5 and plotted to blow up the synagogue on Oct. 12. No reason is advanced for the delay of five months, nor are there any reports of subsequent meetings or plottings. The youthful patriots were indicted by a grand jury headed by Robert C. Van Camp, music director of a radio station owned by the Atlanta newspaper which the boys were picketing. Thus we see the first strange coincidence.

More important, the boys are accused of being anti-Jewish, although we are not told what this implies, or how the statutes define it as a crime. If opposed to the machinations of Jewry, the boys have been singularly obliging in furnishing the national Jewish fund-raising drive with priceless ammunition. In fact, Irv Kupcinet, Jewish columnist of the Chicago Sun-Times, reported on Oct. 19, 1958, that Rabbi Jacob Rothschild, of the dynamited temple, had told the press, "We are in the midst of a fund-raising drive for the temple, and we're off with the biggest BANG in our history!"

The Atlanta press did not report this gleeful exclamation of Rabbi Rothschild, nor did it identify as a negro the scar-faced man who drove into an Atlanta filling station a few hours before the bombing and asked the way to the synagogue. Yet the Northern newspapers and radio reports identified this man as a negro. Authorities are making no effort to locate him.

Thus a pattern emerges. The Jewish temple is in the midst of a fund-raising drive; the Atlanta newspaper wishes revenge against the picketers, and an explosion takes place which is a combination fund-raising stunt and a circulation-building operation for a newspaper whose violent liberalism is despised by a large percentage of the community in which it is published.

More important, the national Jewish fund-raising drive which annually raises one hundred million dollars for its myriad network of espionage groups, the Anti-Defamation League of B'nai B'rith and a host of lesser groups, faces a \$25,000,000 deficit this year. Contributions dropped 15% last year, and Jewish leaders have been estimating a 25% drop this year. Recent editorials in the Jewish press have stressed the need to "wake up the Jewish community." Now Rabbi Rothschild reports that the fund-raising drive is "off with a BANG."

Would these youths meet on May 5 to plan to dynamite a synagogue in October during the fund-raising drive? Or would the Jewish leaders import a scar-faced negro to dynamite a small hole in the rear of the building (which is heavily insured), so that they could have an "issue" at a crucial moment in their campaign?

The synagogue, a splendid building, shows no damage from the street. Yet Rabbi Rothschild immediately issued a statement that the damage of the building was \$200,000. Of course he did not mention that it was fully insured. Later estimates range below \$100,000, and one contractor said the rear wall could be replaced for \$4,000, but this will not prevent Rothschild from raising \$200,000 to pay for the damage, even though the insurance will pay it also. Much of the money will come from gentile businessmen, who dare not refuse the demands made upon them by the Jewish leaders.

Christian leaders and politicians, from Eisenhower on down, in bemoaning the dynamiting of the synagogue, in which no one was injured, make no reference to the 3,000 churches destroyed in Germany during the Jewish vendetta against that unfortunate nation during the Second World War, or the 287 churches and temples destroyed by a single Hell Bomb at Hiroshima, Japan. Dear Sir;

I wish to offer an important clue in the dynamiting of the Atlanta synagogues. Contributions to the Jewish funds have been lagging this year, and the Jews hire people to blow up their synagogues, to frighten the little Jews into contributing to the millionaire Jewish leaders. This has been a notorious practice of the Jewish communities for thousands of years, a huge fund is raised to rebuild the building, and gentile businessmen are forced to contribute or their businesses are closed down. Yet these synagogues are insured. Once again the Jews, while mostly exploiting the gentiles, raise the cry that they are being persecuted!

I can testify to important aspects of this practice, because Anti-Defamation League leaders offered me money to carry an anti-Jewish campaign, and then persecuted me because I refused to cooperate with them. As you may know, all of the anti-Jewish agitation is directed by Jews, such of it under the leadership of Benjamin Freedman, a Jew, 1914 Square, who publishes a paper at 225 Lafayette St. N.W., N.Y. can also testify that the Anti-Defamation League finances and assists anti-Jewish agitation.

I suggest that the leaders of the Jewish community be arrested at once and questioned night and day until they confess to this foul crime against their own people.

Also, another purpose in the Jews dynamiting their own synagogues at this time is their hope of declaring martial law and executing all Americans like myself who have a record of being opposed to Communism. This is their last chance to get the integration program through in the South, according to a prominent Jewish leader. However, I am serene in the Love of Jesus Christ, and I know that although the Jews do, indeed, that the body of Christ be crucified, they have never been able to eradicate the benign effect of His spirit on human civilization.

Reference is made to your memorandum dated December 26, 1956, with which you forwarded letter of December 19, 1956, and the enclosure directed to you by Governor Milward L. Simpson of Wyoming. The enclosed leaflet entitled "Impeach Eisenhower" by Eustace Mullins, reprinted from "Women's Voice," has come to the attention of this Bureau and a Photostat thereof was transmitted to Assistant Attorney General William F. Tompkins by my memorandum dated February 15, 1955, captioned "We, the Mothers, Mobilize for America, Incorporated, Internal Security - X."

The Governor requested information concerning "Women's Voice" and Eustace Mullins. Examination of our files discloses that "Women's Voice" is the official publication of an organization known as We, the Mothers, Mobilize for America, Incorporated, established in Chicago in 1941. The organization maintains an office in Room 800, 537 South Dearborn Street, Chicago, Illinois. This organization is violently anti-Eisenhower Administration, anti-Semitic, anti-Masonic, anti-Catholic, anticommunist and opposed to all foreign elements in the United States. The main interest of the organization is securing subscribers to its publication, "Women's Voice." Occasional meetings of this organization are attended by less than 100 individuals, consisting principally of women past 50 years of age. Additional details concerning this organization appear in the report of Special Agent Lloyd O. Bogstad, Chicago, dated March 15, 1956, a copy of which has been made available to your Records Administration Branch.

Eustace Clarence Mullins has contributed articles to "Women's Voice." This individual reportedly was discharged from employment with the Library of Congress following World War II as a result of acknowledged authorship of racist writings. On January 9, 1957, this Bureau received a copy of a letter which was being distributed through the mails requesting that contributions be sent to captioned fund to establish a college for all races, colors, and creeds and that such donations be sent to the Honorable Adam Clayton Powell, House Office Building, Washington, D. C. This letter also alleged that the mother of President Eisenhower is the daughter of a white abolitionist and a Negro girl. The letter listed the honorary trustees of this fund as Chief Justice Earl Warren, Eleanor Roosevelt, and Adam Clayton Powell. Copies of the letter were furnished to the Honorable Sherman Adams, The Assistant to the President, Chief Justice Warren, and the Attorney General.

Chief Justice Warren advised a representative of this Bureau that he had never heard of the fund; that he knows nothing about it; and that he gave no authority

A Washington City News Service release dated January 11, 1957, stated that Powell had advised that the use of his name on the appeal was "completely phony"; that he knew of no such college; that he had not been asked nor had he authorized the use of his name in this regard; and that he had turned his information over to the Department of Justice to determine whether there is a case of mail fraud.

On January 31, 1957, William Pinsley, Anti-Defamation League, B'nai B'rith, 343 South Dearborn Street, Chicago, Illinois, advised the Chicago Office of this Bureau that he had obtained the following information from a source, which he described as reliable, close to William Wernecke, 6250 North Wayne Avenue, Chicago, Illinois, who is head of the Nationalist Conservative Party in Chicago:

At a New Year's Eve party held at the Wernecke farm, Huntley, Illinois, one Eustace Mullins is alleged to have stated that he is writing a book concerning President Eisenhower and that this book alleges that "a colored woman named Millie Stover was Eisenhower's grandmother"; that he (Pinsley) has no information as to whether this book is to be printed or whether any additional information has been distributed in this matter; and that about two weeks previously Mullins was residing in the home of Lyril Clark Van Hynning, head of "We, the Mothers, Mobilize for America, Incorporated," LaSalle Towers, 1211 North LaSalle Street, Chicago, Illinois.

The Chicago Office of this Bureau has advised it has received information indicating that the local office of Secret Service in Chicago is conducting an investigation in this matter. For your information, the FBI Laboratory has conducted an examination comparing known specimens of literature disseminated by Mullins in the past with the copy of the afore-mentioned letter but was unable to identify the printing in such specimens with the printing in the letter.

This Bureau is not conducting an investigation in this matter and the Chicago Office of this Bureau is being advised to furnish the afore-mentioned information to the Chicago Office of Secret Service.

It is to be noted that the Nationalist Conservative Party was organized by the afore-mentioned Wernecke and several of his close friends as a duly constituted political party which intended to run candidates for the offices of President and Vice President of the United States in the 1956 national elections. It held a convention in Chicago, Illinois, for this purpose; however, plans never materialized and it did not run any candidates for those offices.

It is noted that "We, the Mothers, Mobilize for America, Incorporated," was organized in approximately 1940 and its official publication is "Women's Voice." The policies of this organization are dictated by the afore-mentioned Van Hyning, editor of "Women's Voice," which policies are set forth in that publication as violently anti-Eisenhower Administration, anti-Semitic, anticommunist, anti-Masonic, opposed to all foreign elements in the United States, and anti-United Nations. Its policies are pro-German and claim to follow the teachings of the Bible. This Bureau is not conducting an active investigation concerning this organization.

Furnish the afore-mentioned data to the Chicago Office of Secret Service.

In view of the investigation being conducted by Secret Service in this matter and the fact that Powell referred this matter to the Department of Justice as a mail fraud case, over which the Post Office Department would have primary jurisdiction, you are instructed that no further investigation is to be conducted by your office in this matter. However, any information received by your office concerning it should be furnished the Bureau promptly.

Reference is made to your memorandum dated December 26, 1956, with which you forwarded letter of December 19, 1956, and the enclosure directed to you by Governor Edward L. Simpson of Wyoming. The enclosed leaflet entitled "Impeach Eisenhower" by Eustace Mullins, reprinted from "Women's Voice," has come to the attention of this Bureau and a Photostat thereof was transmitted to Assistant Attorney General William F. Tompkins by my memorandum dated February 15, 1955, captioned "We, the Mothers, Mobilize for America, Incorporated, Internal Security - X."

The Governor requested information concerning "Women's Voice" and Eustace Mullins. Examination of our files discloses that "Women's Voice" is the official publication of an organization known as We, the Mothers, Mobilize for America, Incorporated, established in Chicago in 1941. The organization maintains an office in Room 500, 537 South Dearborn Street, Chicago, Illinois. This organization is violently anti-Eisenhower Administration, anti-Semitic, anti-Masonic, anti-Catholic, anticommunist and opposed to all foreign elements in the United States. The main interest of the organization is securing subscribers to its publication, "Women's Voice." Occasional meetings of this organization are attended by less than 100 individuals, consisting principally of women past 50 years of age. Additional details concerning this organization appear in the report of Special Agent Lloyd D. Bogstad, Chicago, dated March 15, 1956, a copy of which has been made available to your Records Administration Branch.

Eustace Clarence Mullins has contributed articles to "Women's Voice." This individual reportedly was discharged from employment with the Library of Congress following World War II as a result of acknowledged authorship of racist writings. He has written numerous anti-Semitic articles and also is opposed to the Eisenhower Administration.

The last paragraph of this document states that FBI Agents made an agreement in 1938 with the Anti-Defamation League in which they agreed to have access to each others files; that FBI Agents reporting on investigations which involve Jewish interests furnish copies of their reports to ADL headquarters in New York for which they receive \$100.00 and that some Agents receive as much as \$600.00 a month for sending these reports to the ADL. It also indicates that the Director's book, "Masters of Deceit" was largely written for him in the ADL office in New York for favors received.

One photostat copy of this document is attached herewith for Chicago.

Undoubtedly the Bureau and Chicago are already aware of this particular document. It was received through the mails, postmarked Chicago, December 10, 1958, by HORACE SHERMAN MILLER, Box 5062, Waco, Texas.

reasons we cannot understand, took this as conclusive evidence that the boys had committed the crime.

Police claim that the boys met on May 5 and plotted to blow up the synagogue on Oct. 12. No reason is advanced for the delay of five months, nor are there any reports of subsequent meetings or plottings. The youthful patriots were indicted by a grand jury headed by Robert C. Van Camp, music director of a radio station owned by the Atlanta newspaper which the boys were picketing. Thus we see the first strange coincidence.

More important, the boys are accused of being anti-Jewish, although we are not told what this implies, or how the statutes define it as a crime. If opposed to the machinations of Jewry, the boys have been singularly obliging in furnishing the national Jewish fund-raising drive with priceless ammunition. In fact, Irv Kupcinet, Jewish columnist of the Chicago Sun-Times, reported on Oct. 19, 1958, that Rabbi Jacob Rothschild, of the dynamited temple, had told the press, "We are in the midst of a fund-raising drive for the temple, and we're off with the biggest BANG in our history!"

The Atlanta press did not report this gleeful exclamation of Rabbi Rothschild, nor did it identify as a negro the scar-faced man who drove into an Atlanta filling station a few hours before the bombing and asked the way to the synagogue. Yet the Northern newspapers and radio reports identified this man as a negro. Authorities are making no effort to locate him.

Thus a pattern emerges. The Jewish temple is in the midst of a fund-raising drive; the Atlanta newspaper wishes revenge against the picketers, and an explosion takes place which is a combination fund-raising stunt and a circulation-building operation for a newspaper whose violent liberalism is despised by a large percentage of the community in which it is published.

More important, the national Jewish fund-raising drive which annually raises one hundred million dollars for its myriad network of espionage groups, the Anti-Defamation League of B'Nai B'Rith and a host of lesser groups, faces a \$25,000,000 deficit this year. Contributions dropped 15% last year, and Jewish leaders have been estimating a 25% drop this year. Recent editorials in the Jewish press have stressed the need to "wake up the Jewish community." Now Rabbi Rothschild reports that the fund-raising drive is "off with a BANG."

Would these youths meet on May 5 to plan to dynamite a synagogue in October during the fund-raising drive? Or would the Jewish leaders import a scar-faced negro to dynamite a small hole in the rear of the building (which is heavily insured), so that they could have an "issue" at a crucial moment in their campaign?

Lyle Stuart, a Jew whose real name is Simonson, and who publishes a newspaper called the Independent (formerly Expose), at 225 Lafayette St., New York City, wrote a series of articles a few years ago exposing the fact that the Anti-Defamation League financed many of the so-called "anti-Jewish" figures in the United States. He printed documented stories and affidavits that those speaking or writing against Jewish subversion were receiving money from the ADL, either

and won. These activities have been common in the Jewish communities of the world for centuries, because the Jewish group life is built around a myth of persecution. The Jewish leaders, in order to maintain their iron rule over their communities (a classic example of Marxist Communism in practice) have always depended upon terrorism against their own people. The publicizing of these anti-Jewish acts enables the Jewish leaders to keep their people in a state of fear, so that they unhesitatingly obey these leaders, and contribute large sums to them.

We have only to remember that the head of the Spanish Inquisition, Torquemada, notorious for his tortures of Jews, was himself a Jew, and that the official in charge of the Nazi concentration camps was a Jew, Eichmann, who is now living quietly in Israel.

The damage done to the Atlanta synagogue, a hole in the rear wall, was so slight that police seeking the site of the explosion could not find it. The synagogue, a splendid building, shows no damage from the street. Yet Rabbi Rothschild immediately issued a statement that the damage of the building was \$200,000. Of course he did not mention that it was fully insured. Later estimates range below \$100,000, and one contractor said, the rear wall could be replaced for \$4,000, but this will not prevent Rothschild from raising \$200,000 to pay for the damage, even though the insurance will pay it also. Much of the money will come from gentile businessmen, who dare not refuse the demands made upon them by the Jewish leaders.

Christian leaders and politicians, from Eisenhower on down, in bemoaning the dynamiting of the synagogue, in which no one was injured, make no reference to the 3,000 churches destroyed in Germany during the Jewish vendetta against that unfortunate nation during the Second World War, or the 287 churches and temples destroyed by a single Hell Bomb at Hiroshima, Japan. In most cases, these churches in Germany and Japan were filled with worshippers, helpless women and children, refugees from the terror unleashed against them by Jewish politicians in the United States and England.

The five anti-Communist youths in Atlanta may be railroaded to prison (they can be executed according to an ancient statute which was obligingly dug up by Jewish lawyers) or they may be released as soon as the goal of one hundred million dollars is reached. Already the press has dropped its fantastic claims of a national plot against the Jews, as well as the statements of FBI agents that they were prepared to make arrests in a dozen other cities of important "conspirators."

Few Americans know about the agreement made by the Anti-Defamation League and the FBI in 1938, in which they agreed to have access to each other's files; or that FBI agents, when reporting on an investigation which involves Jewish interests, send a carbon copy of their report to the ADL headquarters in New York, for which they receive \$100, a sum which is not reported on their income tax. Some FBI agents receive as much as \$600 a month extra for sending these reports to the ADL. J. Edgar Hoover's recent book, "Masters of Deceit," was largely written for him in the ADL offices in New York, for favors received.

2. Will check records of the Institute of Contemporary Arts, Washington, D. C., for information concerning MULLINS' being awarded a Master of Fine Arts degree at that institution as well as other pertinent background information.

3. Will also obtain specific dates of MULLINS' attendance at the Escuela Des Bella Artes, San Miguel, Mexico, in the event such information is available at the Institute of Contemporary Arts.

4. Will report any additional information concerning MULLINS' "hate" activities which are contained in the files of the Washington Field Office. Will also conduct a credit and criminal check.

THE CHICAGO DIVISION

1. Will contact logical business establishments and additional neighbors in vicinity of MULLINS residence in efforts to establish his whereabouts on October 12, 1958.

2. Will consider requesting authority to interview MULLINS after evaluating information obtained from leads set forth above.

The investigation in this case was based upon instructions set forth in re Bureau airtel dated October 22, 1958, which directed that investigation be conducted on suspects who may be affiliated with any of the various "hate" groups and/or who have indicated they may result to violence. When all outstanding leads have been covered in this case, consideration will be given to requesting authority to interview EUSTACE CLARENCE MULLINS.

MULLINS was viewed by SA [redacted] on November 14, 1958, at MULLINS' residence, 2239 North Lincoln Avenue, Chicago. Mr. CRIST TEISTER, Custodian of the apartment building in which the subject resides, has been advised of the Bureau's interest in MULLINS, and agreed to furnish whatever information he could concerning the subject, on a highly confidential basis. TEISTER was extremely cooperative and has indicated an awareness of MULLINS' affairs and is considered a reliable neighborhood source.

SA RICHARD L. STRAIN has been designated as alternate agent responsible for background information on MULLINS, and is fully aware of the subject's residence and established neighborhood source.

A suitable photograph of EUSTACE CLARENCE MULLINS is available in the files of the Chicago office.

Information provided by the Security Unit, Chicago Police Department on December 5, 1958 was furnished by Patrolman ELMER PRICE to Investigative Clerk HARRY WILLIAM CROON.

By letter dated December 29, 1958 the St. Louis office was requested to review MULLINS Army Service Record at the Department of Defense, Military Personnel Records Center and submit in report form all pertinent information contained therein.

Employment records at the Chicago Motor Club and Institution Magazine, Chicago were not reviewed inasmuch as the principal background information in instant report, as furnished by CG T-1 on 11/13/58 was obtained from those records.

ALLEN MANN, Internal Security - X (Chicago) that the Postal Inspector's Office is attempting to prosecute MANN in connection with MANN's mailing of Anti-Semitic literature. According to the USA's office such mailing may come within the purview of the USC, Title 18, Section 1461. The USA's office has corresponded with the Criminal Division of the Department of Justice, but as of the present has not received an opinion from the Department. WILLIAM B. WERNECKE, as of November, 1955, maintained close ties with well known "hate" representatives throughout the United States.

This letter was signed EUSTACE MULLINS under the typed signature, Rev. EUSTACE MULLINS. Pertinent portions of that letter are set forth below:

"I, too, offer an important clue to the dynamiting of the Atlanta synagogue. Contributions to the Jewish funds have been lagging this year, and the Jews hired people to blow up their synagogue to frighten the little Jew into contributing to the millionaire Jewish leaders. This has been a notorious practice of the Jewish communities for thousands of years.....Once again the Jews, while busy exploiting the Gentiles, raise the cry that they are being persecuted.

".....I suggest that the leaders of the Jewish community be arrested at once and questioned night and day until they confess to this foul crime against their own people."

The M and N Associates (M&NA), Box 1785, Chicago, 90, Illinois, is a paper organization set up by EUSTACE MULLINS and MAYNARD O. NELSEN, both of Chicago and both with records of association with anti-Semitic and anti-Negro type organizations. "Hate" type literature is

Nelsen", was made available on April 10, 1958, by Captain WILLIAM F. REYNOLDS of the Baltimore and Ohio Railroad Police Department at Baltimore, Maryland. This pamphlet, which bore the handprinted date, February, 1958, stated that "by 1980 the United States will be an underpopulated, impoverished country with a standard of living fifty per cent lower than the 1958 level." The basis for that prediction according to the pamphlet was that "white leadership will vanish with intermarriage with the darker peoples". The pamphlet stated that "that condition will come about as a result of forcing the white men to marry with the colored, which situation was caused primarily by the white man being legislated out of existence in efforts to gain the pivotal Negro vote".

On November 1, 1958, Mr. JOSEPH SCHAEFFER, 626 South Federal Street, made available a leaflet captioned "The Atlanta Report", which stated therein that it was written by EUSTACE MULLINS. SCHAEFFER stated it was distributed during the latter part of October, 1958. This leaflet reflected it was issued through M&NA, Box 1785, Chicago 90, Illinois. The names E. MULLINS and M. NELSEN also appeared on this leaflet.

This leaflet charged that "the bombing of a Jewish synagogue in Atlanta, Georgia, on October 12, 1958; was carried out as part of a program by Jewish leaders to maintain the myth of persecution for the Jewish people." According to this leaflet, "the publicizing of anti-Jewish acts enable Jewish leaders to keep their people in a state of fear so that they unhesitatingly obey their leaders and contribute large sums to them."

The Nationalist Conservative Party (NCP)

Records of the Assumed Name Section file of the Clerk of Cook County, Chicago, Illinois, disclosed that the NCP was registered under certificate number 100439 on January 27, 1955. This certificate disclosed that WILLIAM B. WERNECKE of Huntley, Illinois, was operating the organization as a political party.

Literature distributed by the NCP in 1955 described its aims and purposes as favoring the capitalistic system in this country, advocating the incarceration of all corrupt labor union officials, the dissolution of corrupt unions and demanding the "open shop" to all Americans. The NCP was opposed to gifts of assistance to any nation and to United States participation in the United Nations. The NCP also favored a rigid government-controlled economy looking to a balanced budget and a reduced debt.

WILLIAM B. WERNECKE, Leader of the NCP as of November, 1955, maintained close ties with well known "hate" representatives throughout the United States in efforts to obtain support for the NCP. EUSTACE MULLINS was to be the editor of a monthly publication to be issued by the NCP.

National Renaissance Party (NRP)

The NRP as of 1955 was a neo-Nazi, anti-Semitic, anti-Negro organization with activities generally confined to the New York City area. The leader and founder of the NRP is JAMES H. MADOLE.

The NRP was the subject of a preliminary report on neo-fascist hate groups published by the Committee on Un-American Activities, United States House of Representatives, on December 17, 1954, which report stated that that neo-fascist groups' activities and propaganda are clearly subversive and un-American.

NELSEN's main activity in that organization has been the occasional circularizing of printed and mimeographed pamphlets. The only apparent money used to promote this organization is obtained from NELSEN's own funds and an occasional contribution that he might receive.

During December, 1954, Mrs. DOROTHY S. KELLEY, Mrs., 2504 NE. 8th Street, Oklahoma City, Oklahoma, made available a leaflet captioned, "Abominable Yet True", bearing the printed signature "EUSTACE MULLINS." The leaflet also bore the address, "Women's Voice, Room 803, 537 South Dearborn Street, Chicago, Illinois". The material in this leaflet according to the information contained therein allegedly was from a speech given by Rabbi RABINOVICH, in Budapest, Hungary, on January 12, 1952.

According to this leaflet, Rabbi RABINOVICH stated on January 12, 1952, that "within ten years every Jew would be a king and every Gentile a slave." This alleged sermon included a resume of Jewish propoganda in using the issue of anti-Semitism to pit the United States against Germany in World War II and which again would be used to promote a war of mutual self-destruction between the United States and Russia at the conclusion of which a neutral Israel would emerge as the dominating power of the world.

The rabbi then prophesied, according to the leaflet, "an era of 10,000 years of peace and plenty" during which the Jewish race would rule undisputedly over the earth as its superior intelligence would enable it to obtain mastery of the world of dark peoples."

The "Abominable But True" pamphlet written by EUSTACE MULLINS concerning Rabbi RABINOVICH's speech in Budapest, Hungary, on January 12, 1952, was a figment of MULLINS' imagination.

WV is the official publication of "We, The Mothers, Mobilize For America, Incorporated". That organization was originated in 1941 and maintains headquarters at 537 South Dearborn Street, Chicago, Illinois. The editor of WV, Mrs. LYRL CLARK VAN HYNING, is responsible for the policy and views set forth in that organization. Articles contained in WV are violently anti-EISENHOWER; anti-Semitic; anti-Masonic; anti-Catholic and opposed to all foreign elements in the United States.

Communist campaigns and because he has inaugurated a policy of appeasing Russia under the tutelage of sinister Jewish Socialist MENDEZ-FRANCE." The leaflet referred to EISENHOWER and his "little gang of white house Jews". It continued:

".....Impeach Eisenhower at once!.....Arrest the real Communists in America, the Jewish international bankers who finance the growth of world Communism from New York City."

On December 15, 1955, EDWARD M. HORAN, 43 Parkview Drive, North Lake, Illinois, made available an undated printed leaflet captioned, "Investigate Jewish Criminal Conspiracy". This leaflet, among other things, contained a two paragraph item entitled, "Jewish Assassin Kills President" by EUSTACE MUELLINS. This item stated, in regard to the assassination of President RAMON of Panama, that, "A miserable Christ-hating Jew, Martin Irving Lipstein, was being held incommunicado for that assassination." The item continued, ".....These criminally insane Jews are the only people today who still practice assassination as a form of politics. How many millions of Christians have been slaughtered in Russia by these warped and hateful Kikes?"

On July 19, 1956, G-2, Chicago, advised that a EUSTACE MUELLINS, 126 Madison Place, Staunton, Virginia, had caused information to be circulated concerning an alleged United States Army poster soliciting Negroes to join the United States Army with the expectation that in England and Germany "they would find white girl friends". MUELLINS, in regard to the alleged poster, reportedly commented that he hoped it would force "Jewish policy makers" to deal more fairly with "our allies and force them to stop bartering white girls of friendly nations to American Negroes to encourage them to enlist for military duty".

During November, 1956, DONALD TAYLOR, 1942 South 29th Street, Philadelphia, Pennsylvania, made available a one page undated printed leaflet captioned, "Why Do Jews Hate America?" by EUSTACE MUELLINS. This

leaflet stated among other things that:

".....while the United States is the legendary promised land of the Jews, where they can lie and cheat and rob to their hearts content and scream for tolerance when the population mutters against them, the Jew hates America. The reason for this hate is that Americans are tolerant and will not persecute the Jews, who want above all things to be despised and hated."

Other Activities

A group of "Fascists or anti-Semites" of which EUSTACE MULLINS reportedly was a member were planning some type of disturbance at the Democratic National Convention to be held in Chicago, Illinois, during August, 1956.

(CG T-2, 7/31/56)

MATTHIAS KOEHL, supra, and EUSTACE MULLINS as of October, 1958, were co-authoring a book entitled "The Parasite Theory". This book will seek to debunk the idea that there is such a thing as a good Jewish person.

(CG T-11, 10/16/58)

III. MISCELLANEOUS

On October 12, 1958, a Jewish synagogue in Atlantic, Georgia, was bombed.

On December 12, 1958, Mr. CRIST TEISTER, Custodian of the apartment building located at 2239 North Lincoln Avenue, where EUSTACE MULLINS resides, advised that to the best of his recollection EUSTACE MULLINS was at his apartment during the week end of October 10 to 12, 1958. Mr. TEISTER advised that on that week end he was performing repair and cleaning work on the stairway in back of MULLINS' apartment. He advised that he recalls that he observed MULLINS at his apartment at that time and that MULLINS during that week end was doing considerable typing.

Mr. P. GRANSBORG, Resident Manager, Delta Air Lines, 67 East Monroe Street, advised SA JOHN W. TOEDT on December 10, 1958, that passenger lists for that air line to Atlanta, Georgia, during the week end of October 10 to 12, 1958, did not list the name EUSTACE MULLINS. Mr. GRANSBORG further stated that Delta Air Lines and Eastern Air Lines were the only two air lines providing service from Chicago to Atlanta, Georgia.

On December 23, 1958, Mr. FRANK HERDJE, Reservation, Sales, and Traffic Manager, Eastern Air Lines, Merchandise Mart, Chicago, Illinois, advised SA TOEDT that all passenger lists for the week end of October 10 to 12, 1958, for flights to Atlanta, Georgia, had been destroyed inasmuch as that air line maintained passenger lists for 45 days only.

David Lawrence, Editor of "U. S. News and World Report" received a scurrilous letter from E. Mullins, M and N Associates, Box 1785, Chicago 90, Illinois, bitterly criticizing Lawrence's column of January 26, 1959. The letter was highly derogatory of the Jewish people. M and N Associates is reported to be a paper organization of Eustace Mullins, Jr., and Maynard Nelsen. The association is known to publish rabid anti-Semitic and anti-Negro literature. Mullins and Nelsen are known to be associated with a number of "hate" groups in the Chicago, Illinois, area and to be prolific writers of "hate" literature. A confidential informant in Chicago, Illinois, believes Mullins to be a homosexual.

Jones to DeLoach Memo

DETAILS

David Lawrence, Editor of "U. S. News and World Report," advised Inspector J. J. McGuire on February 3, 1959, that he had received a scurrilous letter from E. Mullins on stationery bearing the title "M and N Associates, Box 1785, Chicago 90, Illinois," allegedly an organization run by E. Mullins and M. Nelsen, who describe their business as political engineering and creative propaganda. The letter criticizes bitterly Lawrence's column of January 26, 1959, pertaining to racial hatred and Mullins' letter is highly derogatory of the Jewish people. (McGuire to Tolson memorandum dated 2-4-59 captioned same as this memo)

INFORMATION IN BUFILES:

For the purpose of this memorandum all the references concerning M and N Associates were reviewed, but only main files and summaries were reviewed concerning Mullins and Nelsen.

M and N Associates

According to Chicago sources who have furnished reliable information in the past in November and December, 1958, M and N associates, Box 1785, Chicago 90, Illinois, is a "paper organization" set up by Eustace Mullins and Maynard O. Nelsen, both of Chicago and both with records of association with anti-Semitic and anti-Negro type organizations. "Hate" type literature is disseminated through that organization. E. C. Mullins, as of February 2, 1958, was a writer for M and N associates. (105-15727-23, pages 7 & 8)

"The Mullins Report" and "The Atlantic Report" are two pamphlets circulated by this organization. "The Mullins Report" purports to be a confidential report prepared in August, 1957, for a group of American industrialists, which subsequently was again released "as a public service by an impartial research organization." By its interpretation of American history the report concludes this country was energetic and productive only when the races were segregated and the North European immigrants were predominant. Now, because inferior races have been given equality and the privilege of intermarrying, this country is doomed to become a second rate power overpopulated and impoverished by 1980. (62-10187-490)

"The Atlantic Report" was distributed during October, 1958. This anti-Jewish leaflet charges that the bombing of a Jewish synagogue in Atlanta, Georgia, on October 12, 1958, was part of a program by Jewish leaders "to maintain the myth of persecution for the Jewish people." The leaflet claimed the explosion was a combination fund-raising stunt and a circulation-building campaign for a newspaper whose violent liberalism is despised by a large percentage of the community in which it is published.

Jones to DeLoaceh Memo

The leaflet also charges that an agreement existed in 1938 between the FBI and the Anti-Defamation League (ADL) which they agreed to have access to each other's files. It also claimed that FBI Agents sent carbon copies of their reports involving Jewish interests to the ADL for which they received \$100 which amount they failed to report as income. (105-15727-23, pages 8,20)

The writing done under the name of M and N Associates is only a small part of the neo-Nazi, anti-Semitic and anti-Negro activities conducted by Mullins, Nelsen and their associates.

EUSTACE CLARENCE MULLINS, JR.

Summary

Mullins is subject of pending "Racial Matters Case" with Chicago as office of origin. He is a white male, born 3/9/23, Roanoke, Virginia. He has been active in the following organizations during the past several years:

American Humane Church

The American Humane Church is said to have been organized by William B. Wernecke, Huntley, Illinois and was actually no church but was organized for tax purposes by Wernecke who appointed himself Bishop. Wernecke, as of November, 1955, was said to be closely aligned with well-known "hate" representatives throughout the United States. Reverend Eustace Mullins is carried as director of the American Humane Church on its letterhead which was in use in October, 1958. A copy of such a letter in Bufiles is rabidly anti-Semitic. (105-15727-20; 23 pages 6 & 7)

The Nationalist Conservation Party (NCP)

The NCP was being operated in 1955 as a political party by its leader, William B. Wernecke (described above). A Chicago source advised in 1955 that NCP literature favored the capitalistic system demanding "open shop" union practices and opposing gifts of assistance to any nation and to United States' participation in the U. N. Eustace Mullins was to be the editor of a monthly publication of the NCP. (105-15727-23 page 9)

National Renaissance Party (NRP)

The NRP as of 1955 was a neo-Nazi, anti-Semitic, anti-Negro organization with activities generally confined to the New York City area according to a Chicago source. As of July, 1953, Eustace Clarence Mullins, then residing in New York City, took an active part in the affairs of NRP. The Chicago source stated Mullins was associated with the NRP for several years and participated in its meetings. (ibid page 10)

Jones to DeLoach Memo

National State's Rights Party (NSRP)  
Formerly the United White Party

Another Chicago source advised in 1959 that the NSRP is a group of persons composed of former Ku Klux Klan members, persons with strong state's rights feelings and in general, persons with strong hatred for Jews and Negroes. Eustace Mullins attended and spoke at the NSRP convention in August, 1958, and attended a meeting of officials of the NSRP in Louisville, Kentucky, in September, 1958, according to several Chicago sources. (ibid pages 10 and 11)

✓ The Realpolitical Institute (RI)  
Box 1785, Chicago 90, Illinois

The RI was started by Maynard Orlando Nelsen in Chicago in about November, 1954; his purpose was to create a political party which is anti-communist, anti-Semitic and favors the white race. Apparently the organization is supported mainly by Nelsen's own funds. A leaflet used by the RI in 1955 recorded Eustace Mullins as an officer of RI and Mullins was a writer for the RI in Chicago as of 1958. (ibid pages 11 & 12)

Women's Voice (WV)

WV is the official publication of "We, The Mothers, Mobilized for America, Incorporated." This organization originated in 1941 and maintains headquarters in Chicago, Illinois. Articles contained in WV are violently anti-Eisenhower, anti-Semitic, anti-Masonic, anti-Catholic and are opposed to all foreign elements in the U. S. Eustace Mullins was a writer for WV in Chicago in 1955 and 1956.

In addition numerous miscellaneous articles of anti-Semitic and anti-Negro nature have come to light bearing the name Eustace Mullins as author. (ibid pages 12-15) (62-88217-1043)

Eustace Mullins is believed by a confidential informant, who has furnished reliable information in the past, to be a homosexual who left New York City in 1956 to be near a homosexual with whom he had previously lived in New York City. (105-15727-23 page 6)

MAYNARD ORLANDO NELSEN

Summary -

Nelsen is also the subject of a pending racial matter case in which Chicago is office of origin. Nelsen is a white male, born January 1, 1924, Minneapolis, Minnesota. He has been active in the following organizations:

Jones to DeLoach Memo

✓ The Realpolitical Institute (RI)

He was founder of the RI, Post Office Box 1785, Chicago, Illinois, in late 1954. From literature of the RI it is readily observed that the organization is anti-communist, anti-Semitic, anti-Negro. (100-351528-6 pages 4-11)

Democratic Nationalist Party (DNP)

Nelsen is also described as the former head of the defunct DNP, a "hate" group which advocated persecution of racial minorities. (ibid page 11)

Patriotic Research Bureau (PRB)

In October, 1947, Nelsen was arrested for writing threatening letters, and at the time of arrest, plans for a Fascist organization (not further described) and anti-Semitic and Fascist literature from the PRB were found on his person. The PRB was reportedly organized in 1938 and accumulated, compiled, and published anti-Semitic and anti-Communist propaganda.

American Committee for Advancement of Western Culture (ACAWC)

In June, 1955, a Chicago source (files of G-2) disclosed that Nelsen was a member of the ACAWC, an organization reported to have former top Nazis in its international leadership. The group had as its goal the advancement of the struggle of western civilization against the Asiatic barbarism.

It is recommended that this memorandum and its attachment be routed for the attention of the Investigative Division and the Crime Records Division and it would be well to summarize information in the Bureau's files regarding M & N Associates and E. Mullins and M. Nelsen as undoubtedly Mr. Lawrence will make further inquiry concerning these persons. It is noted from the enclosure that E. Mullins is apparently Eustace Mullins, state chairman of the Constitution Party of Illinois.

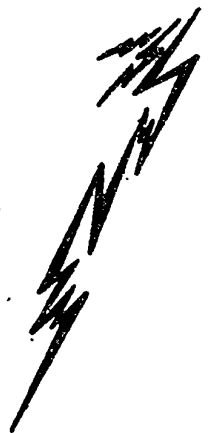

I. BACKGROUND INFORMATION

Residence and Employment

On January 28, 1959, Mr. CRIST TEISTER, 2239½ Lincoln Avenue, Chicago, Illinois, custodian of the apartment building located at 2239 North Lincoln Avenue advised SA CARYL E. SHUPE that EUSTACE MULLINS resided in apartment 20 at that building and was unemployed.

Military Record

On January 26, 1959, Investigative Clerk CHARLES W. DENNY reviewed Military Service Records on file at the Department of Defense, Military Personnel Records Center (MPRC), St. Louis, Missouri regarding EUSTACE CLARENCE MULLINS, JR. The following information concerning EUSTACE CLARENCE MULLINS, JR., born January 9, 1923, at Roanoke, Virginia, Serial Number 33537453, was contained in the above records:

MULLINS was inducted into the United States Army Air Corps on December 26, 1942 and entered on active duty on January 2, 1943, at Camp Lee, Virginia. He was honorably discharged on February 5, 1946, as a Corporal at Greensboro, North Carolina, by reason of demobilization. He served in the Enlisted Reserve Corps, inactive status, from December 26, 1942 to January 1, 1943. No additional Reserve Service was shown. MULLINS had no foreign service. His character and efficiency ratings ranged from unknown to excellent. However, he received two summary court martials for absence without leave and for failure to report to an appointed place.

Health

Records of the MPRC reviewed on January 26, 1959, by Investigative Clerk DENNY reflected the following information concerning the health of EUSTACE CLARENCE MULLINS, JR.:

MULLINS was hospitalized from September 11, 1943 to September 17, 1943 with a diagnosis of "constitution psychopathic state, inadequate personality. EPTI" and from December 14, 1944 to February 29, 1945 with a diagnosis of "Constitutional psychopathic state, unqualified. EPTI" After each period of hospitalization he was returned to duty as "unimproved."

The above records further reflected that when hospitalized on the second occasion "the patient was brought in as a prisoner. At the time of arrest he had in his possession a gun and bullets and he made the statement to two officers THAT HE HAD PURCHASED THE REVOLVER WITH THE INTENTION OF COMMITTING SUICIDE sometime during the afternoon of his arrest. His reason \_ were because he was tired of living."

The records further reflected that MULLINS had written numerous sarcastic letters in which he used extremely foul language and made very sarcastic remarks about the President, the Army, the Post Chaplain, the Medical Officers and the Government of the United States.

"MULLINS also exhibited both psychopathic and neurotic trends, both due to the same dynamic latent homosexuality as shown by his 'fat hips' and having to urinate while sitting down, dreams of snakes (typical feminine dream), with aded castrations anxiety expressed symbolically by fears of going blind and heart failure. The case was presented to the Section VIII Board for disposition and after a two to two deadlock patient was ordered back to duty."

In connection with the above hospitalization of MULLINS "the chart in his case was taken from the Office on the ward. Later it was discovered that MULLINS had asked another patient who had already been diagnosed as dementia praecox, hebephrenic type, and who had proven himself well gifted in pilfering small objects, to obtain the chart for him. The chart was later found almost completely destroyed in the sterilizer. The doctors and nurses who worked on the case did their best in trying to duplicate all necessary information."

It was reflected after completion of various tests that MULLINS was determined to be a "malingerer" and "that disciplinary action rather than medical action should be taken" in his case.

II. MISCELLANEOUS

On October 12, 1958, a Jewish synagogue at Atlanta, Georgia was bombed.

In efforts to determine the whereabouts of MULLINS during the period of October 10 - 12, 1958, the following individuals residing in the vicinity of MULLINS' residence were interviewed on January 6, 1959, by SAs JOHN W. TOEDT and ROBERT J. DOLAN. None of these individuals could furnish any information regarding MULLINS' specific whereabouts during the period October 10 - 12, 1958.

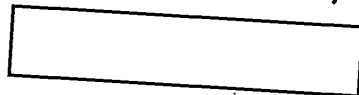
