- I hold it as a self-evident truth that anyone who has knowingly and voluntarily participated in the Kol Nidre and/or has knowingly and voluntarily sworn any kind of secret oath is of questionable character and morally unfit to sit in judgment over this Affiant.
- Anyone who has participated in the Kol Nidre and/or sworn any kind of secret oath has
 disqualified himself from being involved in any legal action against this Affiant. Anybody
 who attempts to impose upon me his jurisdiction and authority unlawfully is deemed by me
 to be guilty of one or both of the below-mentioned criminal offences:
 - A) an attempt to pervert the course of justice as perinsert relevant legislation.....

 B) enticement to slavery as perinsert relevant legislation.....
- As a sane and self-respecting man I have the indisputable right to protect myself from harm when dealing with anyone who is not personally known to me. I claim the right to be presented with evidence of the following!!!

- There **MUST** be a current Oath of Office which is on file. There **MUST** be a valid bond. Failure to submit the requested evidence is deemed to be tacit admission that the judge or magistrate is impersonating a judicial officer.
