

I, Terry L. Nichols, 08157-031, of Fremont County, Colorado, do hereby declare, under penalty of perjury, that the following is true and correct:

1.)- I have been trying to reveal the truth about the Oklahoma City (OKC) bombing since I returned to the Florence ADX on Aug. 24, 2004 from my Oklahoma State trial on charges regarding the same crime.

2.)- On Sept. 03, 2004 I mailed a letter to then-Atty. Gen. John Ashcroft informing him that I had information & evidence regarding "others unknown" in the OKC bombing and sought his help in this matter but never heard from him.

3.)- I tried to do what was right and follow logical & lawful means by contacting Atty. Gen. Ashcroft but when my request fell on deaf ears I found little choice but to seek other avenues.

4.)- An inmate, Gregory Scarpa, Jr., had heard of my efforts of finding someone in Congress and approached me with a proposition in that he had a forensic investigator by the name of Angela Clemente who ~~was~~ was working for a congressional committee that was investigating gov't. corruption, particularly the FBI, and Mr. Scarpa said that he could get my information to that committee and they could get the OKC bombing case reopened.

5.)- I provided Scarpa with certain information that would reveal where some physical evidence was located, but unknown to me at the time was that Scarpa had an evil scheme cooked up which resulted in compromising the evidence.

6.)- Once I learned of the full extent of Scarpa's evil scheme and receiving from him a handwritten threat to harm my family members & friends I turned all (approx) 176 pages of documents over to the BOP's SIS unit relating to exposing Scarpa's evil scheme. They in turn contacted the FBI. This occurred in March/April 2005.

7.)- Since then I've had the assistance of a true friend, an inmate, Emilio Bravo, pursuing one avenue, as I pursued another, of Mr. Bravo contacting the BATF, Secret Service, congressmen, etc., to stir up interest but the FBI & DOJ have stepped in and interfered here as well. Mr. Bravo can testify to this and offer evidence of such as well.

8.)- On April 01, 2005 the FBI recovered a full case of little tubes (≈ 1oz. size) of red tinted nitromethane from my former Kansas home. Nitromethane is the liquid part of the binary explosive component known as "Kine-stik". The other component is ground (powdered) ammonium nitrate.

9.)- That case of Nitromethane came directly from Roger Moore's Royal, Arkansas home on Nov. 05, 1995. I know this

with absolute certainty because I am the one who took that from his home along with numerous other things that day.

10.)- My attempt since Aug. 2004 has been to get an independent investigation done on the OKC bombing and not by the FBI because they have a conflict of interest. This is detailed more so in a 9 page document dated Aug. 28, 2006 that I had sent to Kathy Sanders, a journalist currently associated with CBS News. NOTE: The FBI are well aware of what this document states and it's not favorable them.

11.)- Kathy (Wilburn) Sanders, who lost 2 grandsons in the OKC bombing, and I have been trying to do a video camera interview thru FOX News and/or CBS 60 Minutes for over 2 years now and the BOP continues to deny such.

12.)- Since March of 2006 Kathy, through CBS 60 Minutes, has been trying to set up a telephone interview with me to reveal the truth of the OKC bombing & expose the gov't. cover up but the BOP (through the direction of the FBI & DoJ) have systematically, selectively & deliberately held my mail, both incoming & outgoing, for excessive periods of time (2 weeks to a full month is not uncommon and one piece was for 60 days), or they destroy my mail to prevent Kathy & me from coordinating a times & days for a phone interview.

13.) - This destruction of my mail also occurs with others I correspond with, especially when I write about the OKC bombing and the gov't. coverup.

14.) - On Oct. 23, 2006 I filed a BP-8 Administrative Remedy grievance with the ADX prison after other informal written inquires failed to resolve my mail problems. I'm currently at the BP-9 level with 2 more to file but their reply is that they are not at fault and try to blame the U.S.P.S.

15.) - On (I believe) Oct. 24<sup>th</sup> I made phone contact with Kathy because I had not yet received any letters from her informing me of times & days of our planned upcoming interview. I had only rec'd. on Oct. 12<sup>th</sup> Kathy's Oct. 03<sup>rd</sup> short one page letter stating that she had sent me 3 earlier letters, one each on Sept. 16, 19 & 28<sup>th</sup>.

16.) - Kathy did resend a copy of those 3 "lost" letters by certified mail, return receipt, on Oct. 18<sup>th</sup> which I rec'd. on Nov. 01<sup>st</sup>. This was totally unnecessary expense for Kathy and was due to the BOP's (etc!) deliberate interference. Those 3 letters discuss our phone interview schedule, topic to discuss, and the planned Nov. 15, 2006 congressional hearing.

17.) - Kathy & I finally were able to coordinate dates & times for our phone interview with Kathy being in NYC and me calling

on her cell phone # and being recorded by CBS 60 Minutes. This was scheduled for Nov. 07 & 09<sup>th</sup> at 10 A.M. & 12 Noon each day. Of course the BOP, as well as the FBI & DOJ, knew of our schedule by monitoring my mail & phone calls.

18.) - On Nov. 05<sup>th</sup> I submitted a written Request To Staff (R.T.S., aka: Cop-out) through the normal channels requesting 2 phone calls on Nov. 07<sup>th</sup>, one at 10 A.M. and the other at 12 Noon. (NOTE: Phone requests must be submitted at least one day prior of your planned call and can be made only on Sundays, Tuesdays & Thursdays.)

19.) - I declined my outside recreation time (a beautiful sunny 75°+ day) to be sure I could make my calls and not have them forfeited because I went to rec.

20.) - Everyone from the warden to the unit manager to the unit officers tried their best to avoid me on Tuesday, Nov 07<sup>th</sup>, especially once 10 A.M. went by and I started asking for the phone. Finally ~~at~~ at 12:40 P.M. when the officers came by to pick up the lunch trays, and before I could ask, one officer shouted out - "No cop-out, no phone." They claimed no one received a cop-out (R.T.S.) from me for the phone.

21.) - Then at 2 P.M. Mr. Knox (the unit counselor) came by and said to sign this form. I asked what it was, and he

said - a phone # has been restricted by the BOP. I looked at it and saw it was Kathy's cell phone #, the very # I intended to call to do our interview that day.

22.) - When I make my written phone requests I do not write down the phone # I intend to call, therefore no one really knows who I'm going to call until I actually dial the #. But on Nov. 07<sup>th</sup> they never even brought me the phone to see who I would dial. The BOP does have the ability to cut off my calls at anytime but they didn't do such. They also have the ability to block any call to any # with their computerized phone system at anytime but didn't do this until after notifying me in writing at 2 PM on Nov. 07<sup>th</sup>. They made their assumptions based upon my mail from Kathy and my earlier call to her.

23.) - I did use the phone on Sunday, Nov. 05<sup>th</sup>, for the specific purpose to see if Kathy's phone numbers were still good (not restricted). I dialed, the calls went through the B.O.P. system, but I hung up just prior to it ringing.

24.) - Also on Sunday, Nov. 05<sup>th</sup>, I dialed Rita Cosby's MSNBC office phone # but heard a recording stating that Rita's # was - "restricted by the Bureau of Prisons" - however I was never notified of such in writing. Two months earlier when I checked it was not restricted and it only

became restricted when the BOP received 3 Fed Ex Overnight letters addressed to me from 3 individuals <sup>①</sup> asking me & pleading with me to call Rita immediately to do an interview to help get the congressional hearings moving.

25.) - Rita Cosby's phone # was restricted for the very same reason Kathy's # was - To manipulate the outcome of the congressional hearings scheduled for Nov. 15, 2006 by NOT allowing me to speak to any media nor survivor/victims of the OKC bombing and ~~#~~ thus not allow the public to hear my voice not what I had to say.

26.) - Special arrangements were made for our Nov. 07<sup>th</sup> & 09<sup>th</sup> telephone interview to happen as planned. Kathy lives in Arkansas but travelled to CBS 60 Minutes headquarters in NYC to anxiously wait for my phone calls which of course was deliberately prohibited by the BOP as directed by the FBI & DOJ. Also Ed Bradley had made special arrangements for this exceptional event.

#### FOOTNOTE :

① - I rec'd. one Fed Ex Overnight letter from each of the following people: Rita Cosby, mailed on Oct. 23<sup>rd</sup>, I rec'd. it on Nov. 01<sup>st</sup>. Angela Clemente, mailed on Oct. 26<sup>th</sup>, I rec'd. it on Nov. 01<sup>st</sup>. And V.Z. Lawton, an OKC bombing victim/survivor, mailed on Oct. 27, I rec'd. it on Nov. 02<sup>nd</sup>.

27.)- The BOP has no interest nor issue with me regarding my knowledge of the OKC bombing and could really care less what I may say about the bombing to a reporter by phone. The entities that have a concern & fear are the FBI & DOJ (Dept. of Justice), for what I have to say affects them directly. Thus they are directing the BOP in what to do to prevent me from exposing them and their coverup.

28.)- The BOP continuously & boldly claims that they <sup>②</sup> are not interfering with my mail. BUT with their latest actions of restricting me from calling Kathy on her cell phone (and Rita Cosby at her office) is clear & compelling evidence that they <sup>②</sup> are taking aggressive steps to prevent me from getting the truth out on the OKC bombing & govt. coverup. And thus they <sup>②</sup> are not only interfering with my mail but my phone privileges as well. And why? - To suppress the truth!

29.)- This truth is made even more clear by the fact that the BOP did NOT restrict my ability to call Kathy on her home phone # in Arkansas, ~~far~~ far away from CBS 60 Minutes

② I include both the FBI & DOJ because the BOP & FBI are both under the authority of the DOJ and are thus working in concert to obstruct justice, interfere with my mail, restrict my phone privileges, and ~~may~~ to obstruct my right to speak the truth to expose corruption.

studio in NYC. Thus it's very clear they do NOT want me to talk to the media but rather want to keep me quiet and their cover up in place.

30.) - These acts of <sup>the BOP, et al, in</sup> interfering with, holding, and destroying my mail, as well as interfering & restricting my phone privileges simply <sup>prevent me from</sup> <sup>ing</sup> to reveal the truth to the American people is clearly a form of undeserved punishment being put upon me, and disrespect for the nation.

31.) - I'm also being punished in other ways such as no longer being able to get photocopies made of important documents which pertain to this issue and other issues. I was recently told that if copies are not "ordered by the court" copies will not be made. This action severely limits my abilities to effectively pursue these issues, which clearly is another deliberate action done by the BOP, et al, to prevent the truth from being known.

32.) - I would attach exhibits as supporting evidence but as noted above I can't get photocopies made by the prison (even if I pay for them) because it's not "ordered by the court." And I'm afraid that if I send by mail my originals as exhibits or to get copied they will be deliberately "lost" and then I have nothing. That's exactly what they are hoping for.

33.)- Because of this latest unwarranted act of retaliation I cannot trust them (the BOP) to make copies of critical documents nor in properly handling my mail.

34.)- I also firmly believe that if an attorney would visit me and I provide him or her with documents that once out of my presence he or she would be forced to turn over my documents to the FBI or other govt personnel under the guise of the Patriot Act or National Security Interest or such unless the attorney has an order from the court prohibiting such people from such acts.

35.)- I do have substantial evidence & information that clearly reveals the involvement of "others unknown" and Federal government coverup.

36.)- The American People deserve and have the right to know the truth. And the BOP, FBI & DOJ personnel are public servants who work for the people, are accountable to them, and should not be allowed to use their power & authority to suppress & hide the truth nor to manipulate any congressional hearing.
