

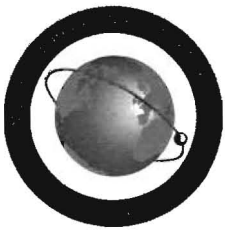

Dear Mr. Greenewald:

This is in response to your requests dated 28 April 2018 and received in the National Reconnaissance Office (NRO) on 30 April 2018. Pursuant to the Freedom of Information Act (FOIA), you requested, **"the *NRO Evolution and Overview*" video, dated September 11, 1995 (C1280-88). Include a copy of any scripts and each draft submitted for this video, if available"**.

We have processed your request in accordance with the FOIA, 5 U.S.C. § 552, as amended. A thorough search of our files and databases located five videos responsive to your request, which are being released to you in part, but located no scripts or drafts.

Material withheld from release is denied pursuant to FOIA exemptions (b)(1) as properly classified information under Executive Order 13526, Sections 1.4(c), (e), (g) and (b)(3), which is the basis for withholding information exempt from disclosure by statute. The relevant withholding statute is 10 U.S.C. § 424, which provides (except as required by the President or for information provided to Congress), that no provision of law shall be construed to require the disclosure of the organization or any function of the NRO; the number of persons employed by or assigned or detailed to the NRO; or the name or official title, occupational series, grade, or salary of any such person.

You have the right to appeal this determination to the NRO Appellate Authority, 14675 Lee Road, Chantilly, VA 20151-1715, within 90 days of the above date. You may also submit an appeal electronically through the National FOIA Portal at www.foia.gov or via email to FOIA@nro.mil. Please include an explanation of the reason(s) for your appeal as part of your submission. The FOIA also provides that you may seek dispute resolution for any adverse determination through the NRO FOIA Public Liaison and/or through the Office of Government Information Services (OGIS). Please refer to the OGIS public web page at www.ogis.archive.gov for additional information.
