January 1, 2011 Woodbridge, Suffolk, England - On the evening of Tuesday, December 28, 2010, there was a gathering of some 400 people in the Woodbridge Community Hall on the 30th anniversary of aerial lights, beams and craft of unknown origin reported after midnight on three consecutive early mornings of December 26, 27 and 28, 1980, at the then joint U. K. and American RAF Bentwaters/Woodbridge air base. This 30th anniversary event was organized by Suffolk County resident Gordon Goodger to raise money for the U. K. TreeHouse national charity for autistic children and their families. Speakers included Nick Pope, who once was in charge of the U. K. Ministry of Defence UFO desk; Earthfiles Reporter and Editor Linda Moulton Howe; and *Left At East Gate* co-author Peter Robbins.

The main speakers returning to Woodbridge and Rendlesham Forest for the first time together since December 26, 1980, were former USAF Airman 1st Class John Burroughs and former USAF Staff Sergeant James Penniston. An American television crew followed them for a possible 2011 TV special about the RAF Bentwaters mystery.

Thirty years ago on December 26, 1980, around 3 AM, USAF Airman 1st Class John Burroughs, USAF Staff Sergeant James Penniston and USAF Airman Ed Cabansag were in Rendlesham Forest under orders to investigate highly strange and colorful aerial lights. According to signed and dated statements at the time, John Burroughs and Jim Penniston came close to the lights and a triangular craft on the forest floor that Jim Penniston describes approaching and touching its black, glassy surface. As his fingers went over raised symbols “like Braille” in a 3.5 foot long section of the craft, S/Sgt. Penniston's mind was telepathically flooded with binary code and some information about the intelligence behind the craft and lights.

Airman John Burroughs did not remember the craft or S/Sgt Penniston touching symbols.

Burroughs has never been able to fully recall what happened to him that night, but the rumors have long been that he “jumped up on” a craft in the forest or was taken up in a beam of light.

At the time, USAF Airman 1st Class Richard Bertolino remembers being on Bunker Hill at RAF Bentwaters that night listening to S/Sgt. Penniston in their radio channels describe the “woods are all lit up” and Airman Bertolino could see a large, football field-sized dome of light in Rendlesham Forest.

Richard Bertolino, 091509 Earthfiles: “I hear him (Sgt. Penniston) and he was taking control and he was doing all the transmissions to Central Security Control (CSC). As they were going into the woods, I’ll never forget the one transmission that first made my hair stand up and it still does to this day. You could hear a little heavy breathing as he was walking through the woods. Penniston says, ‘Security Control, the object is about 150 feet in front of us.’ And then it was just a matter of a couple of seconds and he (Penniston) comes back on the radio and his breathing is a little heavier and he asks, ‘Security, do you copy that the object is behind us now?’ And that’s one I’ll never forget!

We relayed some of the transmissions from Bunker Hill until Penniston left Cabansag behind to do a (radio relay). We had a great triangulation being on the hill to them in the Rendlesham woods to the object and to Security Control. ... They still had their same radios, but we could no longer pick up transmissions after we had been out there for about 45 minutes to an hour.”

Where Was the December 26, 1980, Encounter?



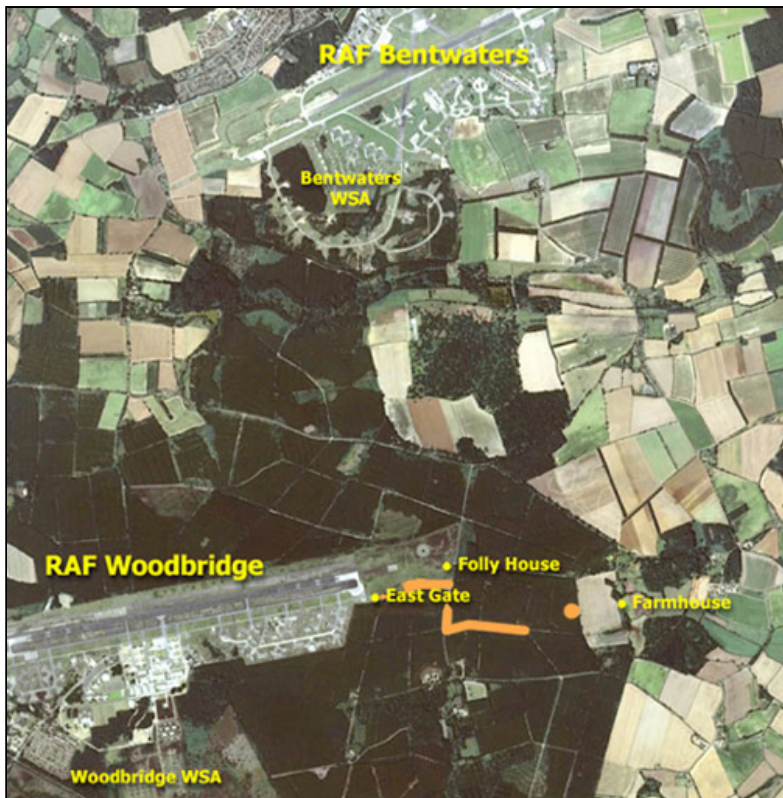

On Christmas morning, December 25, 2010, I joined John and Jim returning to Rendlesham Forest for the first time together since 1980. We drove from the East Gate down the same road they traveled thirty years ago. The question for both of them was exactly where did they have their closest encounter with the lights and why don't they remember the same details?

Over the three decades since the Rendlesham Forest phenomena, various maps and sites have circulated, including the one below produced from statements by Jim Penniston about where he and John Burroughs and Ed Cabansag had the dramatic December 26, 1980, encounter at 3 AM. This map shows the orange-colored route from the East Gate to a right turn on a logging road and then a left onto a road through the forest toward an open farm field where an orange circle marks the alleged site of the encounter.

After walking through the forest at day and night on December 25-26, 2010, John Burroughs did not feel that the site at the center edge of the farmer's field now marked by a picnic table and UFO signs was correct. He remembered that he and Jim Penniston could only see the Orford lighthouse light after they moved across a short field and past a farmhouse. At the currently marked site by the picnic table and signs, there is a farm house

straight across the open field. Then there is a second farm house to the right of that one and a *third* farmhouse at the eastern end of a treeline that extends into a large field. We drove by the third farmhouse that does have animals. In his memory and December 1980 statement, John Burroughs described hearing a noise “like a woman was screaming” Jim Penniston remembers farm yard animal sounds and deer running straight towards him when he and John were walking in Rendlesham Forest following the aerial lights towards the open field.

John Burroughs' Original USAF Statement

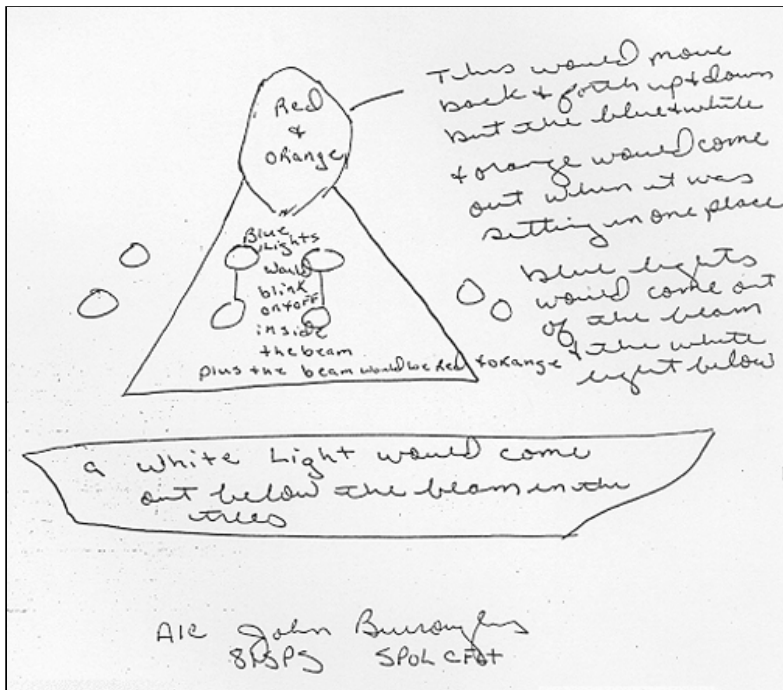
John studied his original hand-written statement written soon after the December 26, 1980, Rendlesham Forest incident and decided that we should go back to the logging road and the left turn toward the farm field and keep going straight to the field as far as we could.

on the night of 25-26 Dec at around 0300 while on patrol down at east gate myself & my partner saw lights coming from the woods due east of the gate. The lights were red & blue the red one above the blue one & they were flashing on & off. Because we never saw anything like that coming from the woods before we decided to drive down & see what it was. We went down east gate road & took a right at the stop sign & drove down about 10 to 20 yards to where there is a road that goes into the forest. at the road I could see a white light shining onto the trees & I could still see the red & blue lights. we decided we better go call them so we went back up towards east gate. I was watching the lights & the white light started coming down the road that lead into the forest. we got to the gate & called it in. The whole time I could see the lights & the white light was almost at the edge of the road & the blue & red lights were still out in the woods. a security unit was sent down to the gate & when they got there they could see it to. we asked permission to go & see what it was & they told us we could. We took the truck down the road that lead into the forest. as we went down the east gate road & the road that lead into the forest the lights were moving back & they appeared to stop in a clearing.

bunch of trees. We stopped Dave
truck where the road sloped
& went on foot. We crossed a small
open field that lead into the
trees where the lights were
coming from & as we were coming
into the trees there were strange
noises, like a woman was screaming
also the woods lit up & you could
hear the farm animals making
a lot of noises & there was a lot of
movement in the woods. All three
of us hit the ground & whatever
it was started moving back towards
the open field & after a min or 2
we got up & moved into the trees &
the lights moved out into the open
field. We got up to a fence that
separated the trees from the open
field & you could see the lights
down by a farmer's house. We climbed
over the fence & started heading towards
the red & blue lights & they just
disappeared. Once we reached the
farmer's house we could see a
beacon going around so we went
towards it. We followed it for
about 2 miles before we could it
was coming from a light house. We
had just crossed a creek & were
told to come back when we saw a
blue light to our left in the
trees. It was only there for a
min & it just disappeared away. After
that we didn't see anything so
we returned to the truck.

Orford Light House Only Tiny, Intermittent Glow Low On Horizon Between Farm House 1 and 2

The first night we were there, we could see the faint, tiny point of light from the lighthouse beacon pulse once every six seconds low on the eastern horizon opposite the picnic table site.

So, John became increasingly certain that he and Jim Penniston must have been further to the south where the row of trees growing in a watery marsh juts out into the open field.

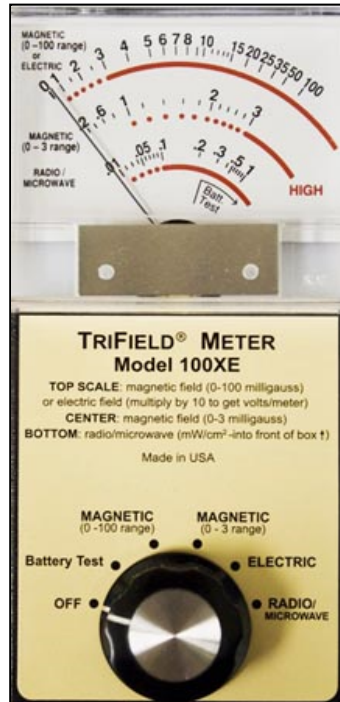

John and Jim walked together after midnight on December 26, 2010, around the finger of trees that juts westerly out into the field from the third farmhouse in image above. At the red circle area, the TriField meter, provided by U. K. engineer Winston Keech during our

three nights exploring along the edges of the open field. pegged as high as it would go with a loud noise.



Winston Keech's TriField meter pegged out at maximum high making a loud noise on both December 26 and 27, 2010, after midnight at a site near the end of the grove of trees surrounding a watery marsh. Both times, John Burroughs was near the meter.

[Editor's Note: The TriField Natural EM Meter was designed to do field measurements for special research. It detects changes in extremely weak static (DC or natural) electric and magnetic fields, and signals with both a tone and the movement of a needle-type gauge if either the electric or magnetic field changes from previous levels. The meter is sensitive to magnetic changes of as little as 0.5% of the strength of the Earth's magnetic field, and the tone will sound whether the field increases or decreases. A radio and microwave detector is also included, which reads radio power directly. Because man-made AC electric and magnetic fields are very common and could interfere with readings of static fields, the meter has been designed to ignore AC fields. Normal construction materials don't block magnetic fields, so the meter can be placed indoors and will work equally well, and due to the built-in tone, it can be used in the dark and will sound the tone at whatever level of field the user sets. The next night after midnight on December 27, 2010, I went with John and Winston Keech back to a place near the finger of trees for a night watch with Winston's IR (infrared) cameras and his TriField meter. I videotaped the men in infrared while John and Winston walked to the area at the west end of the finger of trees to see if the meter would peg again at the highest level. It did and John thought he saw one or two pale blue lights move in the trees around the same time.

On December 28, while John, Jim and I were at the Woodbridge Community Hall to speak, Winston Keech returned in his van with IR cameras and the TriField meter for another night watch near the finger of trees. This time without John Burroughs, Winston took his meter out to the same spot marked by the red circle where the meter had pegged highest both December 26 and 27 after midnight. But the needle remained calm with little movement. Winston wonders if John's presence is the key to the meter's previous strong readings?

January 2, 2011 Woodbridge, Suffolk, England - I have learned that human eyes and visible light sensitive cameras are not adequate for monitoring the environment where highly strange phenomena have been reported. Near and Far Infrared and the mid-range in between are the

frequencies where many phenomena “hide” from human retinas.

A crop circle research colleague in England understands this challenge and has assembled over the past couple of decades several infrared and night vision video and still cameras to try capturing unseen energies that have been putting down cereal crops in geometries and complex patterns. He is Winston Keech, an engineer who has worked for IBM and Rolls-Royce in England, who had pilot training in the RAF, and has a degree in microelectronics. He is now the owner of The Power Collective in Whitby, Yorkshire and invented the Ridgeblade micro windmill. See website below.

Winston has done many night watches in Wiltshire County, England, during the crop formation season with his infrared and night vision cameras and has captured some unusual phenomena. See: [Archived 071907Earthfiles](#).

So I asked Winston if he could join me in Woodbridge for Rendlesham Forest and farm field night watches on December 26 - 28, 2010, on the 30th anniversary of the original phenomena as part of my current research into the December 1980 RAF Bentwaters/Woodbridge investigations with John Burroughs and Jim Penniston. Our IR camera work included my videotaping Winston and John Burroughs after midnight on December 27, 2010, as the two approached the finger of trees in the Capel Green farm field carrying Winston's TriField meter to the same approximate location that John and Jim Penniston saw and heard the TriField meter pegging as high as it could go on December 26, 2010.



After midnight on December 27, 2010, Winston Keech and John Burroughs (white center frame) approached the finger of trees extending westerly into the farm field. In the above image, they are holding Winston's TriField meter which suddenly pegged at its highest position with loud noise near the end of the trees, as it had also pegged the night before when John was with Jim Penniston in about the same place near the same trees.

Over those three nights as I helped videotape with one of the IR cameras while Winston worked time lapse and other cameras and the TriField meter, we never saw any anomaly on site. But later back in his Whitby home office, Winston discovered unexplained red glows in one of his Nikon time lapse images and emailed on December 29, 2010:

“I have started reviewing all the footage I recorded over the three days - and thought you might find this colour snap from one of the time lapse cameras I had running on December 27 past midnight into December 28th. This was looking at the finger of trees that extend into the farm field and caught these anomalous light sources at 2:55 a.m. (Dec. 28, 2010). I have yet to fully analyze it and correlate it with the IR cams,

but it looks interesting.

This is a 3x zoom with the gamma raised for clearer viewing and a gamma raised copy of the full pic. I will be a few days reviewing it all, so who knows what else I may find.”

Report on anomalous activity – Rendlesham Forest 30th Anniversary

by Winston Keech, January 1, 2011

Due to my experience in night time photo and infra red surveillances of the crop circle fields of Wiltshire over many years – Linda Moulton Howe, Reporter and Editor of Earthfiles, asked for my assistance in observing and understanding the situation in the landing site areas of the Rendlesham Forest Incident, on its thirtieth anniversary.

Consequently, I was present at Capel Green (smaller field on southern side of the finger of trees that extends westerly into the large farm field from the third house) at night over the three nights of the anniversary ... after midnight on December 26, 27 and 28, 2010.

Night One started sedately whilst myself, Linda of Earthfiles and an American camera crew re-visited the famous 'East Gate' as named in the book 'Left at East Gate' by Larry Warren and Peter Robbins. From the East Gate we went onward to the 'Col. Halt' site marked by a picnic bench. It was plain that the Orford Ness lighthouse is not visible, even via super sensitive night vision equipment as we traveled through the forest. Due to the flat nature of the landscape, you are looking literally through nearly a mile of closely packed forest eastward in the direction of the lighthouse. We could see the lighthouse from the picnic bench, but it is completely obscured from the further south Capel Green location – quite obviously so - that we later investigated.

From the picnic bench, we moved through the forest to attempt to locate the landing site of the craft on Night One. Having found a particular area that John Burroughs and Jim Penniston recollected as being most familiar - it was so familiar in fact that Jim Penniston was hesitant when asked to stand on the spot ... and had to refuse to do so, such was his anxiety. I was asked to survey that spot – and found no environmental anomalies - background alpha, beta and gamma counts were entirely normal; there were no IR anomalies nor Earth field electrostatic or magnetic variations. This was a little disappointing, but was the observation at the time.

As John and Jim were being interviewed at the scene ... all three of us suddenly became aware that we were all simultaneously going on 'alert' ... I found myself drawn to scanning the field with my eyes in expectation of spotting 'something' ... something unseen. I was entering a state of 'fight or flight' ... and so were Jim and John.

As the interview continued, I alerted Linda to this situation – and the two of us entered the field with EM field meter in hand.

Very quickly the EM field reading rose to very significant levels, with peaks and trough roughly every metre. The signal strength increase led both of us to the right, setting us on a course for the 'finger' of trees at the bottom of the field. Half way into the field the readings went off scale alarmingly ... so much so that I stopped Linda advancing any further for her own safety. At this point the hairs on both of our bodies were starting to tingle with the energy present. Discrimination measurements showed this energy to be electrostatic in origin. We returned to the picnic bench and reported our observation.

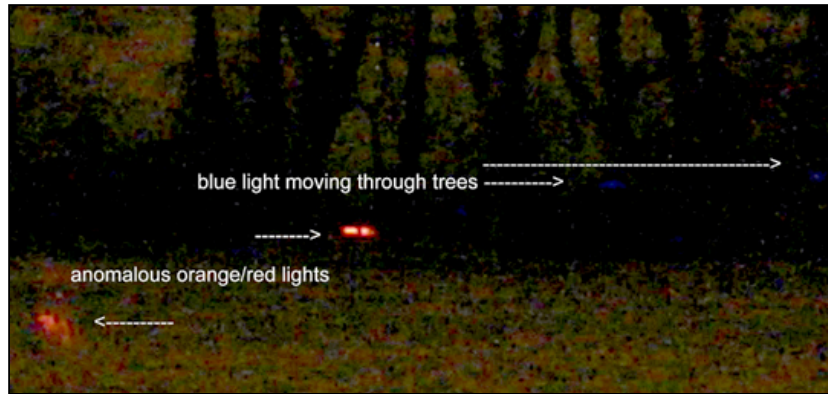
Jim and John then entered the field with my TriField meter and walked in a wide clockwise loop past the first and second houses. Although nothing visibly happened, when they reached the finger of trees at the third house that separates the smaller Capel Green field from the larger field, they located marshy water that could be the answer to a question both men have asked for thirty years - how did they get wet on December 26, 1980?

Then as Jim and John reached the west end of the finger of trees, the TriField meter pegged with loud noise as far as it could go.

On the second night (Boxing Day) in view of what we measured on the first night – John decided that he wished to return without the film crew. Jim did not want to go back to the field that night, so John, Linda and I returned to explore, record and face whatever we might find. We set up an observation post at the reported site of the 'marshalling point' at the Capel Green field's edge from reports about the third night of the event (December 28, 1980, between midnight and sunrise) – and set forth to re-measure the field and its energy.

Linda stayed at the observation point, filming on one of my IR cameras, whilst John and I went into the field. The field was still quite literally 'electric'. The EM field meter was at full scale deflection right across the field – and by a spot at the edge of the tree 'finger' it was not only off scale, but sounding an audible alarm at a continuous intensity that was unprecedented in my experience and in fact quite alarming. That's the same spot where Jim and John reported the same effect the night before when they borrowed the meter during their 'circuit' of the field. This spot is also near where Larry Warren reported an object of unknown origin to be on either the second night (December 27, 1980) or the third night of the events (December 28, 1980).

As we marveled at the intensity of this energy reading – hairs tingling yet again in the frosty, snow dusted field, both John Burroughs and I independently witnessed ping pong-sized balls of blue/blue-white light appear amongst the trees in front of us and move briskly through the tree 'finger'. I concluded that the area was so energized that it was producing pockets of charged air that were emitting a blue glow.

John and I surveyed the rest of the field, navigated back to the Night One site and surveyed the logging roads around the field. From this it became plain to John that at first entry to the field, the tree-line and low altitude meant the lighthouse at Orford Ness wasn't at first visible – it only became visible as the treeline and *third* farmhouse we realized was there at the end of the finger of trees was approached. Then the intermittent lighthouse light was only a pinprick of light five miles distant.

The second and more exciting observation was that the ‘burning’ light of the farmhouse in the ‘Col. Halt tape’ was explained. It is a quirk of that line of entry to the field only. The lights from the windows of the second farmhouse illuminates the trees directly behind it. The light is a soft orange- red colour and due to the tree shapes, it looks rather like a wall of orange flame to the fully night-adapted eyes. This was another breakthrough.

After this, we returned to Linda and reported our findings. John was excited and awed by the immediacy of re-visiting and re-experiencing these details – and wanted to return to inform Jim. So we all headed home for the night.

The next day – Day Three of our re-visit ... I had to sleep until the afternoon, ready for the all night observation due for that night. As I slept - Jim, John, Linda and the film crew returned to the field in the daylight. As I was not present, I can only recount what was reported to me as I left for the all night observation:

On the way out to the 4x4 ATV that I use on such nights – I met John. He told me point blank, that he felt the energy had ‘gone’. I could not see how this could be so - the anomalies were so enormous and I thought that John must be mistaken ... wishful thinking on his part perhaps? John then went on to tell me that Jim had ‘a moment’ of recall during the day whilst they were at the spot we identified. Essentially something connected with him and then the field energy changed. That is how John perceived it. I was not present, so naturally I discounted this and headed back to take more measurements.

When I arrived – I was wrong. John was completely right ... and the meter simply reinforced his ‘told you so’. The field was energetically ‘flat’ ... nothing more than normal background readings anywhere to be found. I was disappointed and had a full night of watching a now completely normal field ahead of me, but set up the cameras and carried on as planned, wishing I'd been there during the day when Jim was present.

The night was quite lively in other ways though – right up until midnight, there was an endless stream of people re-visiting the field, most often flashlight in hand. Tracking them around the field edge helped while away the hours ... and eventually a small group entered the field exactly where Larry Warren stated he entered the field on the third night. Such was the accuracy of this, I was convinced that it had to be Larry – so left my cameras recording and walked up to the small group ... who were initially a little startled at my sudden appearance out of a pitch dark night. I can't say I blamed them as after three nights of lost sleep and stolen daylight hours to archive and process video ... I'd have been startled to see the bleary eyed, disheveled figure looming in front of them from the inky blackness myself.

I introduced myself to the barely visible group – and confirming my first thoughts ... Larry Warren piped up and said 'hi'. We chatted a while and I let the group survey the field through an IR cam that I was carrying, before the group had to move on to its next point of interest. Having seen how changing lighting can make that area and its terrain appear so different from night to night ... the precision with which Larry entered the field and returned to the spot, told me – as if confirmation was really necessary – that the event was so indelibly etched into Larry's memories, he could do no other. It was burnt into his very psyche. I returned to my observation greatly impressed by this – and the same obvious process working within Jim and John.

I felt an outsider to the original event, but the strength of its echo, ringing through these three airmen, struck a profound chord with me. The personal magnitude of that event in these people's lives must have been enormous. I could never know, because I simply wasn't there – and from that instant I could understand their anguish at trying to convey this to people like me, who just weren't there. No book, no sat-map, no after the fact visit could ever convey the enormity of how these men stood there, unarmed in the dark of a forest clearing and unswervingly faced into the jaws of the unknown. If you could have stood there with me in the dark of that night, with thirty years of safety between me and it – you would understand this ... I doubt you would enter that field with me then ... never mind thirty years ago on that night. These men were true heroes – and we should never forget that. After my three nights there, I could never doubt that to be so.

After Midnight, the field was calm – three deer ambled gently through munching the crop as they went – the odd rabbit – the odd distant car headlight or flashlight. Nothing of real interest? ... Or so I thought. Around three AM a hail storm moved in destroying visibility and seemed set to last, so I carried out one last measurement sweep and packed up for the last time.

Reviewing the last hour of recordings, however, showed that all was not as quiet as my eyes would suggest:

At 2:46 AM, the No. 2 IR wide field cam recorded two human-sized black figures in the larger field, approaching the finger of trees and retreating. As Linda noted when using one IR cam – people just don't look 'black' in IR. Indeed clothing that is black, often appears white or gray – and faces are invariably grey. Whoever these people were, they didn't reflect or emit IR in a normal way ... which to me suggests a possible military origin ... or some really, really good thermal clothing.

This was preceded by a short duration light in the centre of the field at 2:19 AM ... so faint, I could not see it – accompanied by a short duration light at ground level near the tree 'finger' on wide field IR cam No 1. at 2:20 AM.

The short duration lights on the IR camera exited the field around five minutes before my last foray towards the 'finger' ... perhaps I disturbed them – I certainly didn't see them. I then left the field and set about dismantling the equipment ... whilst the last remaining colour time-lapse camera remained snapping away. On its very last exposure, it caught two anomalous orange/red lights near the finger, plus two extremely faint blue glows amongst the trees (images in above Earthfiles report). They were invisible to my eyes – and I can only conclude that they were in some way connected to the two black figures. The light nearest the trees was close to the 'smudge mark' or perhaps landing spot of historic Night Three (December 28, 1980).

No more can I deduce, but I provide digitally enhanced and annotated copies of these recordings for the record. (Please note when viewing the IR frame grab images, that there is not a 'ufo' fleet in the noise of the images. Those roundish spots are normal hot pixel and noise reduction artifacts associated with these types of Night Vision cameras – and each camera sensor has its own unique noise distribution, which on the one hand is an annoying defect from a perfect image, but on the other establishes a unique 'watermark' for each camera.)

Summary of 5 pages of Jim Penniston's December 1980 hand-written binary code after December 26th encounter with lights and triangular craft of unknown origin in Rendlesham Forest near Capel Green farm field in Woodbridge. Translation by Dr. Horace R. Drew and Dr. Mike Reed on November 11, 2010.

Return to **Part 1**

January 2, 2011 Woodbridge, Suffolk, England - Around 3 AM on December 26, 1980, USAF Airman 1st Class John Burroughs and Staff Sergeant James Penniston, that night assigned as RAF Woodbridge Security Supervisor, were on foot running through the eastern end of Rendlesham Forest that bordered the Capel Green and larger farm fields. Time was distorted for both of them as John and Jim felt like they were moving in slow motion. Each man says their skin tingled and hair on their heads and necks rose as if in a strong electrostatic field, similar to the atmosphere before a big thunderstorm. But it was a cold, clear winter night.

At some point in that run through the eastern end of that thick, tall Rendlesham Forest, Sgt. Penniston "lost John." For at least forty-five minutes, Jim Penniston was stunned and mesmerized by a black, triangular, glassy-surfaced craft of unknown origin resting on the forest floor not far from the open farm field at Capel Green.

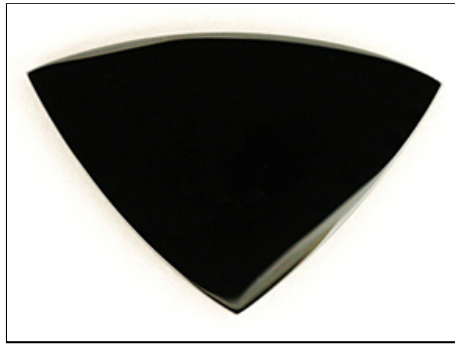

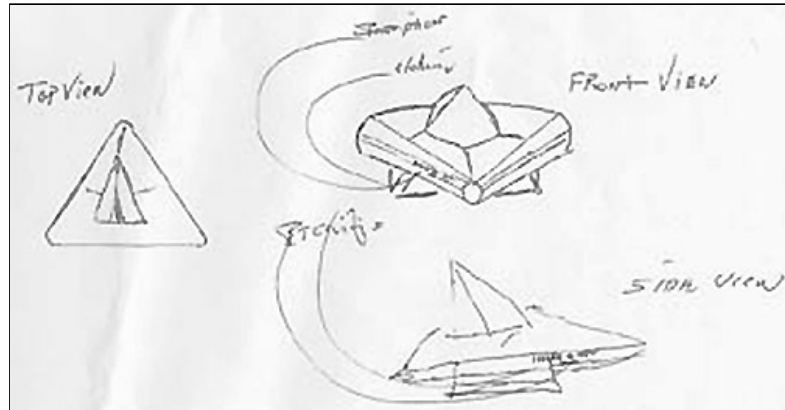

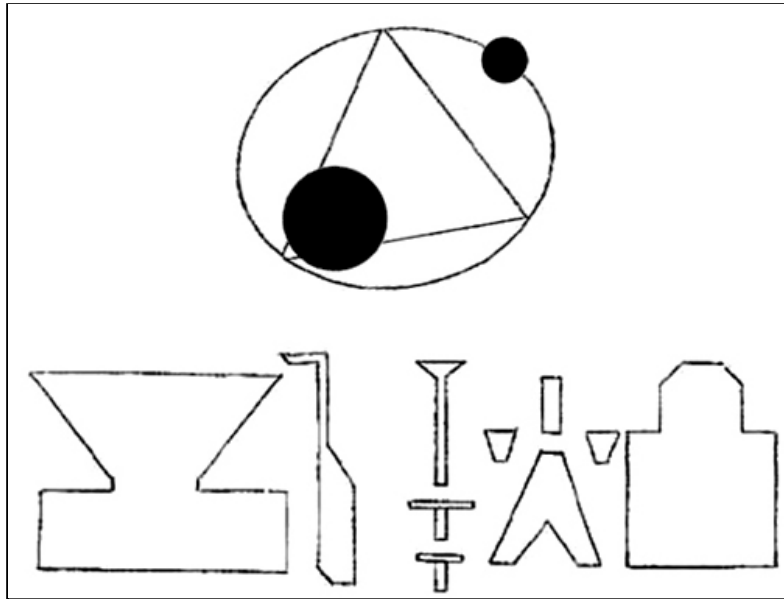

Former USAF Staff Sgt. James W. Penniston: "It was a triangular craft. The fabric of the craft was black like glass. And then throughout the fabric of the craft, there was some coloring varying from saucer-shaped to pie-shaped circles that moved around the craft. Some were red and blue, some yellow – or orange – I guess more orange.

... there were markings on the craft, which were very unusual.

Probably 2.5 to 3 feet wide. If you had a sheet of smooth glass and you took a piece of sandpaper and you laid it on that glass, running from the glass to the sandpaper – that's how it felt.

Here's something that is odd. I lost track of John for like 45 minutes or so. I don't know where he was. There was like a 45-minute gap of time there, which seemed like – I don't know – a couple of minutes. I don't know what caused the distortion."



Updated and corrected symbol shapes by James Penniston on December 16, 2010, after Earthfiles discussed his August 26, 1994, hypnosis transcript (below) with Jim. He said the symbols were raised like Braille on the surface of the black, glassy, triangular craft and each symbol had the texture of sandpaper. The symbols covered about 3 feet of the craft's surface, each symbol averaging about 3 inches high, according to hypnosis.

WHEN IS YOUR VERY NEXT MEMORY OF JOHN BURROUGHS?

When the light on the craft started to generate to a more white, brilliant light is when I backed away from the craft. John (then) was maybe 15 feet away, 20 feet away, standing there.

BECAUSE YOU WERE AFRAID OF WHAT WAS HAPPENING WITH THE INCREASING LIGHT?

I was not sure what it was going to do. I don't know – explode? Or? The craft lifted off the forest floor, went to treetop level, and took off at an extreme rate of speed and John and I stood up. Nothing that I know of could be gone in a blink of an eye.

I had this feeling and the feeling was that there would be a return sometime of that craft. I don't know. It was just a very odd thought."

Like John Burroughs, Jim Penniston has been frustrated by memory blocks about what happened on December 26th in Rendlesham Forest – and what happened to him a few days later when Sgt. Penniston was ordered to report to the Bentwaters Air Force Office of Special Investigations – also known as AFOSI. There Jim was further ordered to undergo hypnosis with sodium pentothal. After that, Sgt. Penniston wondered what the U. K. and American intelligence people did during the several hours that Sgt. Penniston was hypnotized? What did they learn from his mind about his and John's encounter on December 26, 1980, with the lights and craft that he could not remember clearly himself?

So, fourteen years later, on August 26, 1994, Jim underwent his own hypnosis with a hypnotherapist to see if he could find out more. Here is a brief excerpt from the first of two hypnosis sessions in which Jim moves his hands and fingers in the air over the raised symbols that remind him of Braille.

“This ain’t even a prototype, I figure. I don’t know what it is. I gotta touch those.

Hypnotherapist: ARE YOU TOUCHING IT?

The side of it. The symbols.

WHAT DO THEY FEEL LIKE?

Braille! (smiles)

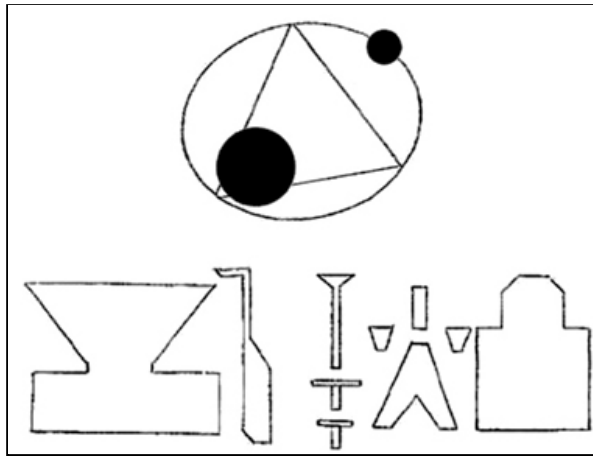
RAISED ABOVE THE SURFACE?

Yes. I’m just touching it lightly.

IS IT WARM? COLD?

I can’t tell with my fingers.

WHAT DO THE SYMBOLS LOOK LIKE?



I know some. The first one's a triangle. The second one looks like a musical note. The third one like a triangle with a flag on it, a flag pole on it.

The other one looks like a heart we shoot at with a head.

WITH A HEAD?

Yeah. That's strange. Top is a large triangle with a – it's not a circle because it's not completely round. Now it's warm.

DOES IT FEEL LIKE METAL OR PLASTIC?

No, it's smooth. Very smooth. I hear noise.

WHAT KIND OF NOISE DO YOU HEAR?

The background. Branches. John's here!

JOHN'S WITH YOU?

Yeah, I don't understand.

HOW LONG HAS JOHN BEEN THERE?

I don't know. He just ... he's there. And I'm not by the craft anymore.

WHERE ARE YOU?

Thirty feet away.

DO YOU REMEMBER GOING THIRTY FEET AWAY?

No.

LET'S GO BACKWARDS A LITTLE BIT. LET'S GO BACK TO THE CRAFT AND YOU'RE FEELING THE SYMBOLS. WHAT HAPPENS THEN?

It's a bright light.

WHERE'S THE BRIGHT LIGHT?

The ship ... the black is white, it's bright!

GLOWING BRIGHT?

Yeah. Gotta squint. It's that light! Everywhere I look, that's all I see. Jeez!
How can it be that bright?

WHEN THE SYMBOLS WERE IN YOUR MIND, DID YOU GET A SENSE THAT THERE WAS AN ENTITY ATTACHED TO THE SYMBOLS?

Yeah, communication.”

James W. Penniston (S/Sgt. Ret.) Hypnosis Session, September 10, 1994

In his second hypnosis session on September 10, 1994, Jim Penniston breaks through an apparent post-hypnotic suggestion by the AFOSI hypnotizers to keep him from talking. The following are excerpts from that second session in which the American and British intelligence people seem to have anticipated *before* their sodium pentothal hypnosis that Jim Penniston received a telepathic download of binary numbers - as if the intelligence operatives have had experience with this kind of encounter and telepathic download of numbers before.

Penniston: “They are asking me if I see binary code!? I see the binary code. ...They are time travelers. They are us.”

A long time. Very long time.

WHAT DO THEY NEED?

Not sure, but it has to do with chromosomes? Or something like that.

HOW DO THEY GET THAT?

They take it.

FROM WHERE?

From the other people’s bodies. ... They (time travelers) were interrupted (in Rendlesham Forest). They are having problems. ... The odds are against them.

YOU TOUCHED THE SYMBOLS AND YOU SET OFF A PROGRAM?

Yes. The craft was repairing itself. All they wanted was a place to stay while it repaired itself.

AND BY TOUCHING THE SYMBOLS, YOU DISRUPTED THE REPAIR PROGRAM?

I activated a binary code. The two (govt.) men want to know why. ... They ask me if I ever had any other encounters with them (lights and time travelers)? I haven’t.

ARE THEY USING US SOMETHING LIKE BREEDING STOCK?

No. Like Band-Aids.

DO THEY EVER TAKE FETUSES?

If it is tasked, they do. There are different ships for tasking. The government agents know about this. ... That’s why they want to contain the situation.

THEY SEE YOU AS (REQUIRING) DAMAGE CONTROL?

(Yes), they see me and John Burroughs and they’re worried about Col. Halt. They know all about us.

DOES THE GOVERNMENT BELIEVE WHAT YOU ARE SAYING ABOUT THEM COMING FROM THE FUTURE?

Oh, yes. ... This time they (time travelers) were having problems, but they got their machine off. They have to be out in space to travel. They need speed to travel.

TO TRAVEL THROUGH TIME?

To go backwards. They can't go forward.

THEY CAN'T GO INTO THEIR FUTURE?

They go to their past. It's impossible to go into the future. It takes too much energy.

HOW FAR INTO THE PAST CAN THEY GO?

These ships can go forty or fifty thousand years. They can't go back much further. They might not be able to get back.

WHY DO THEY COME BACK SO FAR?

So it doesn't affect the time line. The farther it is, the better, the least affect it has on changing the future. ... They can't control it. It's too cumbersome.

WHAT ARE THE INTELLIGENCE AGENTS GOING TO DO WITH YOU?

They tell me when I was at the East Gate with John, they have five different stories to tell. It's *important to scramble dates* (which confuses and undermines consistency of eyewitness testimonies so no credibility with public and media.)

... They're going to give me a warning. ... They tell me that I will hurt the world. It will breach national security and can destroy the system, cause wars, chaos in the streets. That's why it's important to keep it quiet. (But) ... it doesn't make any difference if I talk about the story. It's too unbelievable."

TV Production for *Ancient Aliens*



Earthfiles Reporter and Editor Linda Moulton Howe on October 2, 2010, in Phoenix, Arizona, interviewing former USAF Staff Sergeant James Penniston for an *Ancient Aliens* production first broadcast on December 30, 2010, The History Channel.

Then on October 2, 2010, during interview production for the History Channel's *Ancient Aliens* series, Jim Penniston had his notebook from December 1980, in which he had sketched the triangular craft and announced to John, me and the TV crew that he had also written in his notebook a series of zeroes and ones that he said came into his mind when he touched the craft symbols. For thirty years, according to Jim, he had not shown or

discussed the binary code with anyone. John Burroughs told me he was very surprised to learn for the first time that Jim had binary code in the notebook.

Jim said he thought it was the morning of December 27, 1980, when he was off duty after the Rendlesham Forest and farm field encounters the night before that he kept seeing the same series of zeros and ones in his mind. He sat down and wrote the numbers in his notebook.

Recently he shared five of some dozen pages of zeros and ones with me and the TV production company to have analyzed to see if there is any meaning. I sent the scanned pages to the Australian scientist and retired astronomer who have helped me with geometries and an implied mathematical language embedded in some of the worldwide crop formations. The Australian scientist describes himself this way:

“Dr. Horace R. Drew, Caltech Ph.D. 1981, well known for producing the first high-resolution x-ray structure of DNA, for discovering certain aspects of the genetic code used to curve DNA in chromosomes, and for serious crop circle studies under the name ‘Red Collie.’”

The American retired astronomer is Michael A. Reed, University of Arizona, Ph.D., and former astronomical instrumentation specialist, University of Arizona, now retired in Timberlake, North Carolina. Dr. Reed discovered that the June 1, 2008, Barbury Castle barley formation had a ratcheted spiral pattern he calculated to be a surprising and new way to show the number Pi encoded to ten decimal places: 3.14159265358. See **Archive 060808 Earthfiles**.

[Editor's Note: *Wikipedia - Pi* (Greek word for perimeter) is a mathematical constant, which represents the ratio of any circle's circumference to its diameter in Euclidian geometry, which is the same as the ratio of a circle's area to the square of its radius. It is approximately equal to 3.14159, but Pi is an “irrational number” in which the decimal expansion never ends and does not repeat.]

We kept Dr. Drew's and Dr. Reed's analysis confidential until the December 30, 2010, *Ancient Aliens* broadcast on the History Channel.

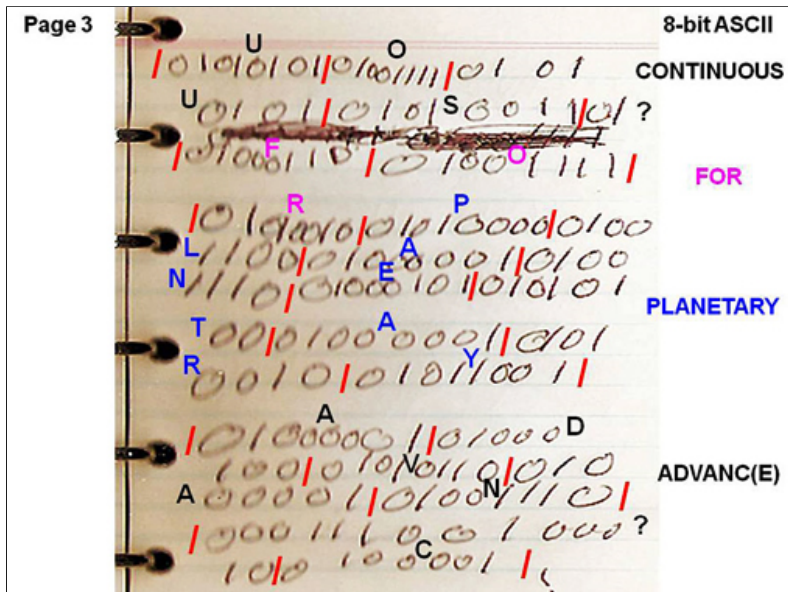

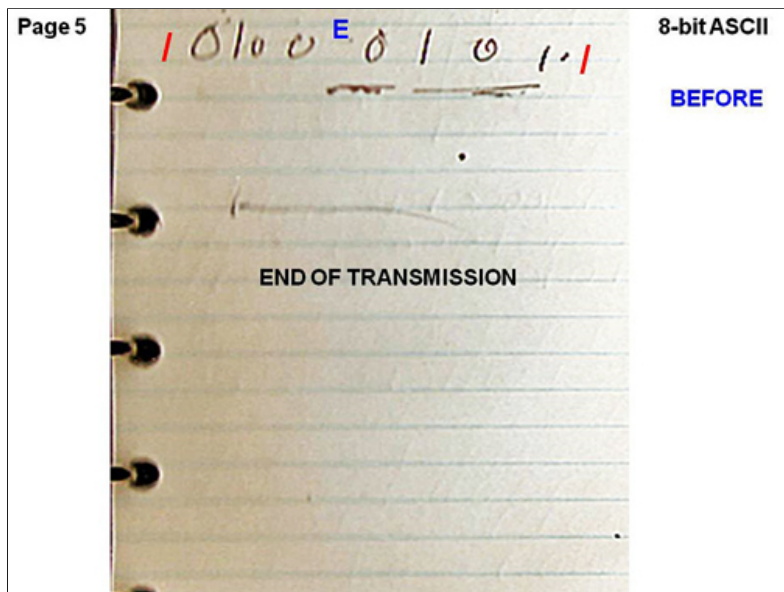
Scan of Page 2 binary code.

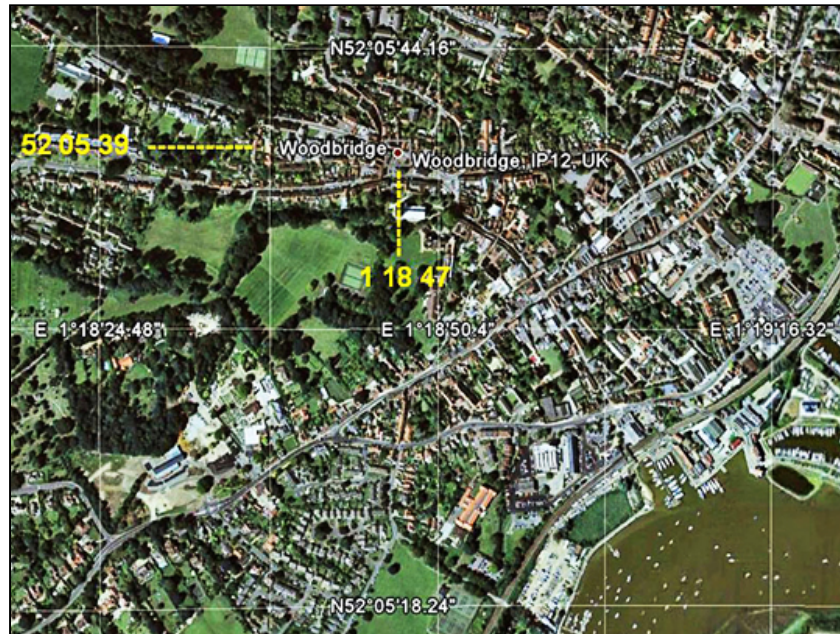

Latitude and Longitude Location in Binary Code

Dr. Drew and Dr. Reed, who analyzed the binary code for me, provided the image below that shows the latitude and longitude they derived from Jim Penniston's binary code at the Woodbridge town center. Jim Penniston also told the Woodbridge Community Hall audience on December 28, 2010, that he still has several more pages of binary code in his notebook that he has not yet released for public consideration.



The yellow highlighted latitude and longitude converges at the town center of Woodbridge, Suffolk County, England - “the most logical option,” according to the scientists. If the black craft were a time machine, it would probably be broadcasting its coordinates at all times. The *Ancient Aliens* computer tech chose a latitude and longitude further west off the coast of Ireland in the ocean supporting one of the TV show's underwater themes such as the mythological Atlantean Hy Brazil. However, no decimal point was provided in Jim Penniston's binary stream and thus, there are 24 geographical options from the binary stream. Further, in the latitude and longitude section of the binary stream, Jim placed a 1 inside a 0, making translation uncertain. Map graphic by Dr. Horace Drew.

ASCII 8-Bit Code: Character to Binary used by Dr. Drew and Dr. Reed.

The American Standard Code for Information Interchange (ASCII), is a character-encoding scheme based on the ordering of the English 26-letter alphabet. ASCII codes represent text in computers, communications equipment, and other devices that use text. Most modern character-encoding schemes are based on ASCII, though they support many more characters than did the 7-bit ASCII typically used in 1980.

Historically, ASCII developed from telegraphic codes. Its first commercial use was as a seven-bit teleprinter code promoted by Bell data services. Work on ASCII formally began on October 6, 1960, with the first meeting of the American Standards Association's X3.2 subcommittee. The first edition of the standard was published during 1963. Then a major revision followed in 1967. The most recent update was an expansion from 7-bit to 8-bit in 1986.

ASCII includes definitions for 128 characters: 33 are non-printing control characters (now mostly obsolete) that affect how text and space is processed; 94 are printable characters and the space is considered an invisible graphic. Today the most commonly used character encoding on the World Wide Web is UTF-8.

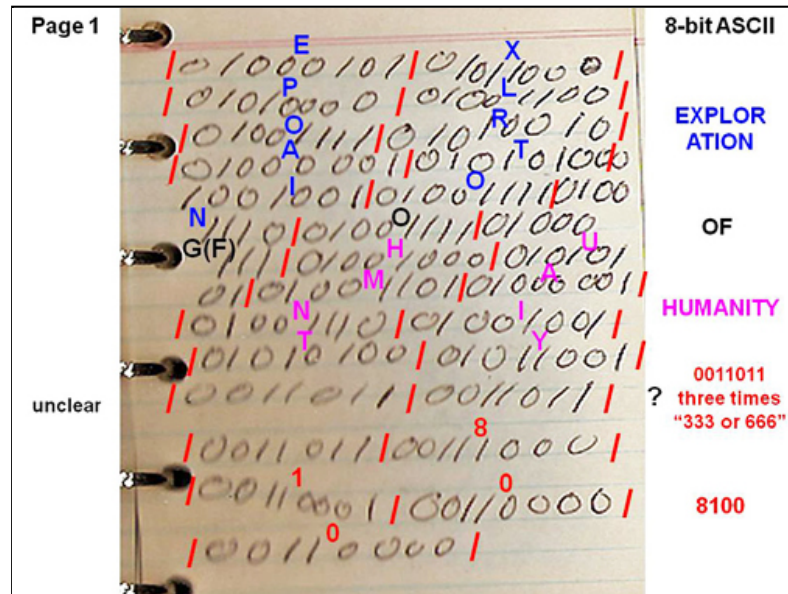
At the time that lights, beams and craft of unknown origin interacted with the RAF Bentwaters/Woodbridge AFB near Woodbridge, England in December 1980, standard ASCII was 7-bit. Later in 1986, ASCII expanded to 8-bit. There was a revision to ASCII code in 1986, to allow for the extension from 7 bits to 8 bits, now UTF-8, a universal code, that includes many characters for work in other languages such as Swedish and German.

So the issue of taking any binary stream and decoding it, assuming you are going to stick with something like ASCII and see if it produces normal letters and numbers is: Do you

try 7-bits or 8-bits?

Interview:

Michael A. Reed, Ph.D., Astronomy, University of Arizona, and former astronomical instrumentation specialist, University of Arizona, now retired in Timberlake, North Carolina: “In the first binary stream of the Jim Penniston scanned pages of zeros and ones, Dr. Drew assumed to try 8-bits first from the start and that worked as we got down through **EXPLORATION OF HUMANITY**.

Then Dr. Drew reached confusing repetitive 7-bit code, **0011011**, that repeated three times. He thought perhaps it was a mistake, maybe 333 or 666 from 7-bit ASCII code where six is 0110110 and three is 0110011.

But also in 7-bit ASCII, **0011011** is an **Escape Key** character you find on a computer keyboard.

SO THE ESCAPE KEY IS REPEATED THREE TIMES AFTER ‘HUMANITY’?

Yes, there are three repeated patterns of 7 bits, each equal to the **Escape Key**:
0011011 0011011 0011011

Then Dr. Drew jumped back to 8-bits to get the next numbers that are: **8100**.

COULD THE THREE ESCAPE KEYS MEAN A SPACE BEFORE THE LATITUDE AND LONGITUDE INFORMATION?

Normally if you are doing an ASCII sequence, you would not switch gears in the middle and go from an 8-bit code to a 7-bit code. To go to a 7-bit code right in the middle of 8-bit code is very strange.

But Penniston’s zeros and ones definitely have 8-bit ASCII English alphabet letters at the beginning of the binary stream. Dr. Drew tried to make sense of it after the three identical 7-bit Escape Keys – the “break” – and decided he didn’t know what to do with the

number **8100**.

Otherwise, you could read this as **8100520942**, all strung together. There is no indicator in the number stream from Penniston that **8100** is separate. But Dr. Drew and I figured that since 52 was the latitude of England, when **52** showed up right after the **8100**, it might be part of a latitude and longitude.

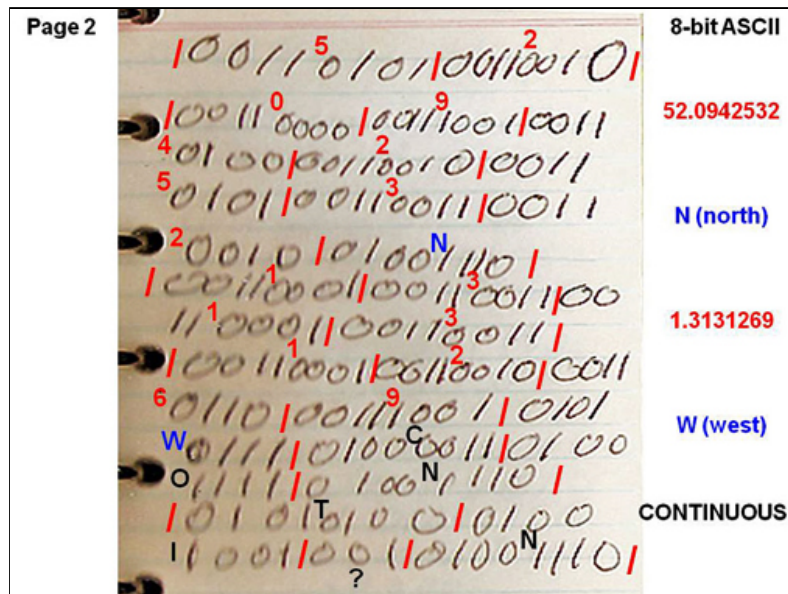
WHAT HAPPENS IF YOU INCLUDE 8100 AS PART OF A LATITUDE AND LONGITUDE COORDINATE?

You'd be way up in the Arctic! 81 degrees North, you're 9 degrees from the North Pole. But how to relate that to the rest of the numbers we're now using as Latitude North and Longitude East or West? Dr. Drew decided to set the **8100** apart and try to translate the rest of the numbers in whatever latitude and longitude was there beginning with the **520942**, since England is 52 degrees latitude.

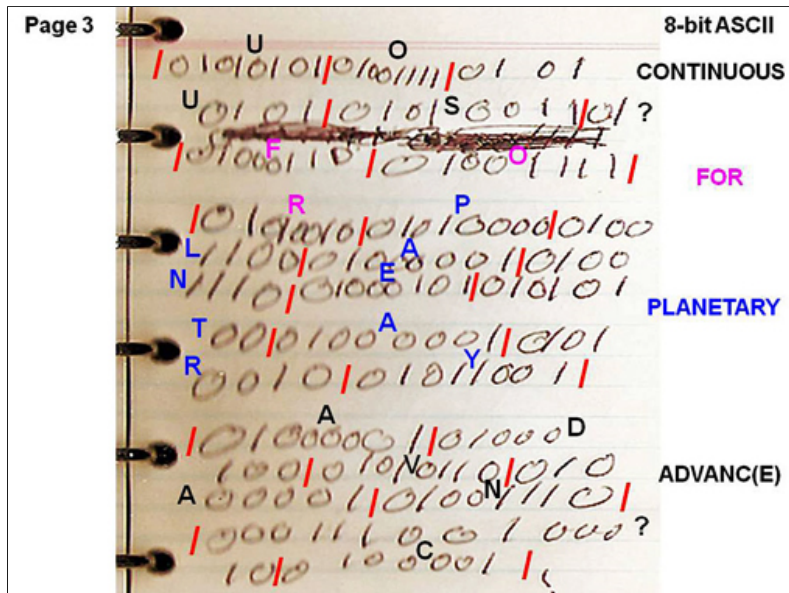
The Latitude and Longitude Issue

After the 7-bit repeating code, we went back to 8-bit for the latitude and longitude information. Given the number of digits translated, if there had been any interspersing of 7-bits, the thing would be completely out of sync. A 7-bit there would produce garbage. So those are definitely 8-bit codes oddly mixed with 7-bit in the middle, but most of the message seems to decode as 8-bit until you get to the very end and the word: **CONTINUOUS**.

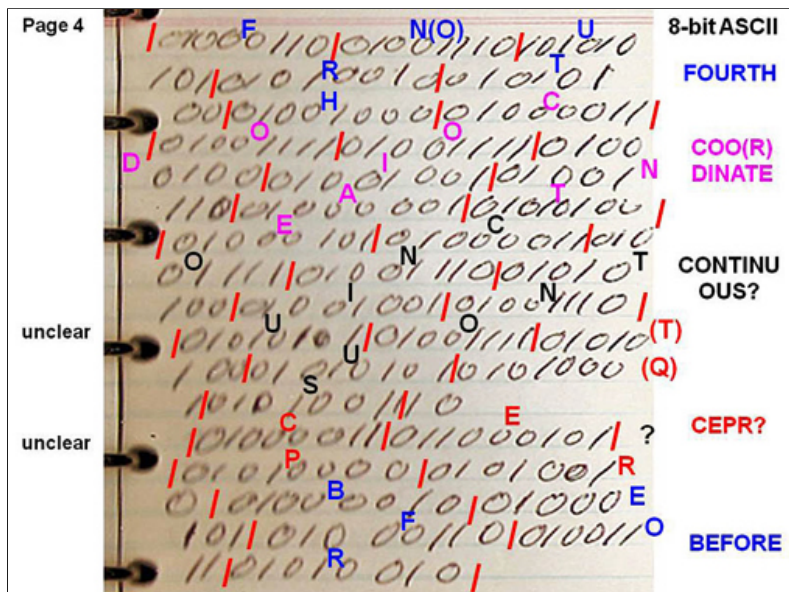
Then there is something that looks like "**CEPR?**" The code for the "**C**" is 8-bit. At the code for the "**E**," Dr. Drew included 9-bits, perhaps by mistake, which would have thrown the next pattern out. When you're doing it by hand, it's very easy to get out of sync. It's clear now that we need to do it on a computer that can show us every possible decode using 7-bit and then 8-bit. There could be layers of code that we haven't discovered.



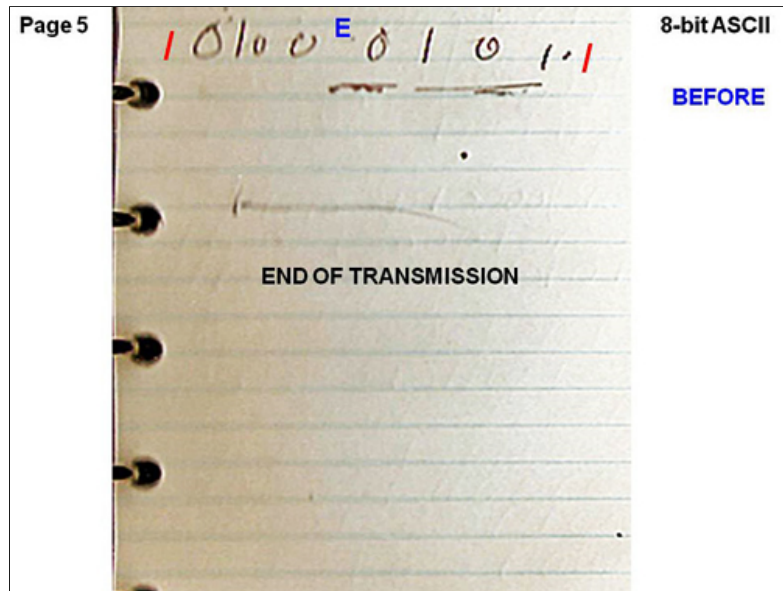
Scan of Page 2 binary code.

Where Should Decimal Point Be in Lat. and Long.?

CAN YOU DISCUSS THE OTHER BIG ISSUE THAT THERE IS NO CLARIFIER IN PENNISTON'S BINARY STREAM ABOUT WHERE THE DECIMAL POINT SHOULD GO WHEN YOU GET TO THE STRINGS OF NUMBERS THAT ARE INTERPRETED AS LATITUDE AND LONGITUDE?

Right. In the bits we are interpreting as latitude, there is first a total of 9 digits [520942532] and then the letter N. Then in the longitude, there is a total of 8 digits and possibly the letter W. But there is some question about the letter W because one of the bits has a 0 with a 1 in it. So, we really don't know which it is. If it's a 0, it translates as W, a longitude. If it's a 1, that is an underscore character (_) without any meaning to us.

Three Latitude Options

However, there is no specification for a decimal point for longitude or latitude. So there are three options in latitude:

0.5209 N. Or it can be **5.209 N.** Or it can be **52.09 N.**

Eight Longitude Options

In longitude, you can start at **0.1313 W**. Or **1.313 W**. Or **13.13 W**. Or **131.3 W**.

Now given that the West character is not clear, we have to consider the East as well:

0.1313 E. Or **1.313 E**. Or **13.13 E**. Or **131.3 E**.

[Editor's Note: The ASCII binary code for a period is: 0101110.

So there could have been this code in the Penniston binary stream that would have indicated where to place the decimal point. Wherever it was placed, it would be a definite decimal point in the latitude and longitude number sequence. But there was no such code there, so we have to consider all 24 possible latitude and longitude locations.]

Far left vertical column: possibilities of latitudes North, depending upon placement of the decimal point. Top, extending left to right, are the possible West Longitudes.

Those latitude and longitude combinations produce 12 possible options. Then the same latitudes North are placed with the left to right East Longitude possibilities. Those latitude and longitude combinations produce another 12 possible options for a total of 24 latitude and longitude options.

If you go to Google Earth and drop in each of the possible 24 coordinates, some are in the ocean off the Gulf of Guinea or the Ghana coast. For the ones with the latitude at 52.09 N on the West Longitudes,

- if you go to **.1313 W**, that's an open field north of Guilden Morden, England, which is not even a town – more like a few buildings southeast of Cambridge.

- If you go too **1.313 W**, you're in an open field northeast of Banbury, England, north of Oxford.
- At **13.13 W**, you're in the ocean off the southwest coast of Ireland, with no apparent undersea features on Google – it's just kind of sea bottom there.
- At **131.3 W**, it's in the ocean right off the edge of Kungkit Island west of British Columbia, Canada.

Then if you go East and do the same thing, the southerly locations are either in the ocean or the jungle in Africa somewhere, except if the decimal point is placed at 52.09 N latitude.

- At **52.09 N latitude and 0.1313 E longitude**, you end up at an airport runway in Doxford, England, southeast of Edinburgh on the coast.
- Then at **1.313 East**, you're in the town of Woodbridge, Suffolk, England, and that's the one that Dr. Drew – when he was trying both east and west longitude directions – thought it was significant because it came out right in the middle of the Woodbridge town near RAF Woodbridge and Rendlesham Forest.
- If you go further to **13.13 East**, you're on the west side of the little town of Luckewalde, Germany.
- Then if you go to **131.3 East**, you're out in a mountain wilderness area in the middle of China.

So of all the 24 possible latitude and longitude sites, the one that stands out is the town of Woodbridge in the east direction. In the west direction, you are either in the ocean or in an open field. Because there is that one zero that has a 1 drawn in the zero, it means we have to look at the East longitude, too, and that is the one that includes Woodbridge, England. After we checked all of the 24 options, Dr. Drew decided the Woodbridge site seemed to have the most relevance to the RAF Bentwaters mystery with Jim Penniston and John Burroughs.

WHY WOULD ANY INTELLIGENCE TRANSMIT LATITUDE AND LONGITUDE COORDINATES WITHOUT SPECIFYING A DECIMAL POINT?

Yes, it seems like a glaring oversight if you are trying to transmit coordinates that a human can understand.

IN YOUR LOCATION TABLE FOR BINARY CODE, ARE YOU ALSO ASSUMING DEGREES, MINUTES AND SECONDS?

Yes, Dr. Drew and I took it as decimal-based. Whoever wrote the binary code, or put it in Jim Penniston's mind, understood the basics of ASCII, and certainly most of the message seems to be 8-bit. But we haven't translated the whole thing in 7-bit and we haven't moved an 8-bit filter and a 7-bit filter through each potential start point to see if the message changes. If you move what we have now over 1 bit, all the letters and numbers go away and you might end up with nothing but control characters or some other letter and number combination.

7-bit and 8-bit Computer Code Filters Are Needed

We really need someone who is skilled in software programming who can take the original Penniston binary stream of zeros and ones and go into it analyzing all the way through in 8-bit and then 7-bit with no variations in each run – apply 8-bit all the way through and see what that produces. Then apply 7-bit all the way through, see what that produces and compare with the 8-bit translation.

After those runs, we need to move over one bit and do it all over again in 8-bits and 7-bits. Then move over one more bit and keep repeating the analysis process – putting the extra numbers from the front at the end – and keep moving through Penniston’s binary stream number-by-number with an 8-bit filter and a 7-bit filter to see how each translates.

With the combination of those translations, we might be able to put together a more coherent message.”
