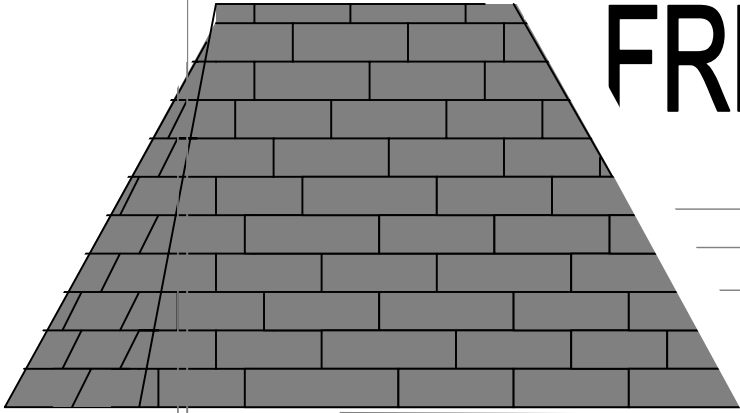
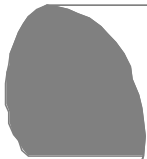

It ain’t worth it, folks, to break God’s law.

PROLOGUE

What this book is. This book simply states some of what has happened to this country. There is extensive detailed documentation available for those who choose to seek it out. Due to the diligent searches of dedicated researchers, light is beginning to dawn. This book is a short summary of a little of what has been uncovered.

What this book is not. This is not a long elucidating, elaborating tome purporting to make things difficult and obtuse for the average reader. It is not full of convoluted statements that end up saying nothing. Neither is it saturated with numerous technical details. Complete details of all aspects are beyond the scope of this book within its limited pages. However, the details are available for the finding for the reader so inclined to seek them out.

Footnotes: When you understand the significance of who said what, the traditional historical picture will crumble and new awareness will come in its place. Things that before did not make sense, or which you noted and wondered “why”, you will now see. History will come to new life. Even though a little cumbersome, the notes are placed directly after the quotes (in parentheses). This immediate close proximity of “quote and note” helps impact the significance of who said what. Further details on some of the sources are available in the Bibliography.

Undoubtedly, as you proceed through this material, the question will arise as to why you have not heard some of these things before.

David Rockefeller, in June, 1991, in a speech to the Bilderbergers in Germany stated: “We are grateful to the *Washington Post*, the *New York Times*, *Time Magazine*, and other great publications, whose directors have attended our meetings and respected their promise of discretion for almost forty years. It would have been impossible for us to develop our plan for the world if we had been subject to the bright lights of publicity during these years....”

The Beginning

This story has several aspects that intertwine together. There is the political/historical aspect. There is the economic aspect. There is the individual aspect. These all blend and intertwine with each other.

Starting with the arena of political power and rule, up until now, when there was an attempt at world domination, it was obvious who was the intended conqueror, and who was the conquered. When brute force was the mode of operation, it was obvious who was attempting to do what.

Two hundred years ago, the method of conquering changed. No longer were the forces at work and the would-be conquerors as obvious. Subtle events began to happen behind the scenes.

Keep in mind, though, as Franklin D. Roosevelt said, “In politics nothing happens by accident. If it happened, you can believe it was planned that way.”

“So you see, the world is governed by very different personages from what is imagined by those who are not behind the scenes.” (Benjamin Disraeli, in *Coningsby*, 1844 as quoted in *Newswatch*, 1/1/99, p. 17)

So, what began to happen behind the scenes?

We will start with more recent history. While the roots of the situation go back into the far past, this information will deal with the last 200+ years.

There was a man in Frankfort, Germany named Amschel Moses Bauer. He later changed his name to Rothschild. He ran a goldsmith shop, and also a fractional reserve bank. This is what the current Federal Reserve System is involved with—fractional reserve banking. From 1743-1773 Amschel was involved with smuggling operations, fractional reserve banking, and lending money to governments. Finally, when he had reached a certain level of funds and influence, he called a secret meeting with 12 of the most powerful men of the time. His plan was to control the world. This involved the ideas of (very briefly):

1. Might makes right
2. Preach liberalism and gain more and more power
3. Money is all powerful
4. Any means to accomplish the goal of world domination is justified
5. The size, scope, and power of the behind-the-scenes group must remain hidden
6. Alcohol, drugs, and moral corruption should be used to weaken the people
7. Wars should be planned and created that both sides would be in debt to the behind-the-scenes group
8. Control the flow of information so as to influence public opinion
9. Manipulate economies to weaken the people and governments, ultimately creating a one-world government with the behind-the-scenes group as the rulers

On May 1, 1776, this group, under Adam Weishaupt, founded the society called the Illuminati. Over the years, the name/group has parented many terms/organizations familiar to us. One symbol of the group was the uncapped pyramid with an “all-seeing eye” at the top (see the back of any one dollar Federal Reserve Note).

The Illuminati sought out members among the well-educated and upper class Europeans. These people wanted to be the supreme rulers. They believed in ruling society through the control of a superior race.

To become the supreme world rulers the Illuminati planned for world conquest *from within* rather than by conquering armies. The objectives to accomplish this included abolishing the following: the family, religion, government, private property, inheritance, patriotism, nationalism, individual and national sovereignty. They relied on secrecy and concealment to those they attracted to accomplish these goals.

Weishaupt wrote: “These people swell our numbers and fill our treasury; get busy and make these people nibble at our bait...but do not tell them our secrets. They must be made to believe that the low degree that they have reached is the highest.” (*Newswatch*, 4/15/99, p.6)

The Illuminati was divided into groups, into inner and outer circles. Some of the terms used in these groups were “knights” and “masons”. The ***outer circle*** was told that the purpose of the Illuminati was “to make of the human

race, without distinction of nation, condition, or profession, *one good and happy family.*” (as quoted from *Encyclopedia Britannica*, 11th edition, 1910, in *Newswatch Magazine*, 4/15/99, p. 5)

Weishaupt wrote: “The most admirable thing of all is that great Protestant and reformed theologians (Lutherans and Calvinists) who belong to our Order *really believe they see in it the true and genuine mind of the Christian religion. Oh man, what can not you be brought to believe?*” (*World Revolution*, p. 13, as quoted in *Newswatch* 4/15/99, p. 6)

Those who joined took an oath, part of which was, “If you are a traitor and perjurer, learn that all our brothers are called upon to arm themselves against you. Do not hope to escape or to find a place of safety. Wherever you are, shame, remorse, and the rage of our brothers will pursue you and torment you to the innermost recesses of your entrails.” (as quoted from *World Revolution*, by Nesta Webster, London, 1921, p. 14 in *Newswatch*, 4/15/99, p. 5)

One of Weishaupt’s plans was to destroy the Catholic Church. Protestants liked the idea. Princes and rulers of Germany sought to join the Order. These individuals were members of the Masonic Order. Here is an extremely significant point. Weishaupt used a term that had more than one meaning. He had masons in his group. He had the Freemasons join him. Only later did the some of the Freemasons realize the difference.

George Washington was one of the first to see the confusion of terms and the dual objectives of the Illuminati. In 1798, in a letter to G.W. Snyder, he stated, “It is not my intention to doubt that the doctrine of the Illuminati and the principles of Jacobinism had not spread in the United States. On the contrary, no one is more satisfied of this fact that I am.... The idea I meant to convey was that I did not believe the Lodges of Freemasons in this country had, as societies, endeavored to propagate the *diabolical tenets*.... That individuals of them may have done it, or that the founder or instruments employed to found the democratic societies in the United States may have had this object, and actually a separation of the people from their government in view, is *too evident* to be questioned.” (*The Writings of George Washington*, published by the U.S. Government Printing Office, 1941, Vol. 20, p. 518 as quoted in *Newswatch*, 4/15/99 p. 7)

The issue of words needs to be elaborated on a little. Weishaupt, the Illuminati, and the modern day offshoots, are 1) adept at using words in a way to attract the unknowing to the work, *often under the umbrella of philanthropy or a good cause* 2) use dual or multiple meaning terms to hide what is going on and 3) convolute vocabulary to confuse the true issues. As we recently heard in a statement familiar to everyone, “It all depends on how you define the word ‘is’”. People laughed and joked about this statement, but unfortunately, the individual that made this statement was correct. This play on words is all too true and typical of the Illuminati and other names the group has gone by. And unfortunately, when you plummet these things to the depth, it *does* depend on who is defining the word “is” and how and why and for what purpose. In this and untold numbers of other cases of verbiage, it “is” all in the definition.

In this case the *Freemasons* joined with the Illuminati who also had *masons* on July 16, 1782.

“What passed at this terrible Congress will never be known to the outside world, for even those men who had been drawn unwittingly into the movement, and heard for the first time the real designs of the leaders, were under oath to reveal nothing. One honest Freemason, the Comte de Virieu, when questioned on the ‘tragic secrets’ he had brought back with him, replied: ‘I will NOT confide them to you. I can only tell you that all this is very much more serious than you think. The CONSPIRACY which has been woven is so well thought out that it will be, so to speak, IMPOSSIBLE for the Monarch and the [Catholic] Church to escape from it.’ From that time on, says his biographer, M. Costa de Beauregard, ‘the Comte de Virieu could only speak of Freemasonry with horror.’” (*World Revolution*, Webster, p.18 as quoted in *Newswatch*, 4/15/99 p. 6)

It is important to realize that the same deception, the same confusing of terms, the same painting one picture for the outer group while holding different intentions entirely for the inner group, has gone on for all these years under different guises and forms. “*Those in the outer echelons usually are idealists with an honest desire to improve the world. They never suspect an inner control for other purposes, and only those few who demonstrate a ruthless capacity for higher leadership are ever allowed to see it.*” (*The Creature...p. 272*) Weishaupt said of the way in which he duped those Protestant leaders, rulers, princes, and Freemasons, “The most admirable thing of all is that great Protestant and reformed theologians who

belong to our Order really believe they see in it the true and genuine mind of the Christian religion. Oh man, what can you not be brought to believe?" (*World Revolution*, p.13, as quoted in *Newswatch*, 4/15/99, p. 6.

While there have been great leaders, such as Washington, and others could see beyond the duplicity, it is critically important to realize how much emphasis that Adam Weishaupt placed on secrecy and concealment. This tactic has continued until this day. "*The great strength of our order lies in its concealment. Let it never appear in any place in its own name, but always covered by another name and another occupation.*" Adam Weishaupt (*Proofs of a Conspiracy*, p. 195 as quoted in *Newswatch*, 4/15/99, p. 7)

Before he began the Illuminati, Amschel was a banker. Amschel (Rothschild) had 5 sons. Four he sent to different countries to gain control of the central banks of those countries. Those countries were England, France, Italy, and Austria. Rothschild and his fifth son remained in Germany. Not only did the Rothschilds run banking in these five nations, but they also did banking for Spain, Belgium, Brazil and other countries.

By running these central Banks, the Rothschilds could manipulate economies by creating panics and wars. Financing for the wars came from the banks. Regardless of who won, the bankers profited.

There were certain principles the Rothschilds, Illuminati, and all the groups, which eventually evolved by whatever name, followed. These principles are outlined in *The Creature from Jekyll Island*, by G. Edward Griffin, p. 230. (Hereafter abbreviated in footnotes as "*The Creature....*")

1. War is the ultimate discipline to any government. If it can successfully meet the challenge of war, it will survive. If it cannot, it will perish. All else is secondary. The sanctity of its laws, the prosperity of its citizens, and the solvency of its treasury will be quickly sacrificed by any government in its primal act of self-survival.
2. All that is necessary, therefore, to insure that a government will maintain or expand its debt is to involve it in war or the threat of war. The greater the threat and the more destructive the war, the greater the need for debt.
3. To involve a country in war or the threat of war, it will be necessary for it to have enemies with credible military might. If such enemies already exist, all the better. If they exist but lack military strength, it will be

necessary to provide them the money to build their war machine. If an enemy does not exist at all, then it will be necessary to create one by financing the rise of a hostile regime.

4. The ultimate obstacle is a government which declines to finance its wars through debt. Although this seldom happens, when it does, it will be necessary to encourage internal political opposition, insurrection, or revolution to replace that government with one that is more compliant to our will. The assassination of heads of state could play an important role in this process
5. No nation can be allowed to remain militarily stronger than its adversaries, for that could lead to peace and a reduction of debt. To accomplish this balance of power, it may be necessary to finance both sides of the conflict. Unless one of the combatants is hostile to our interest and, therefore, must be destroyed, neither side should be allowed a decisive victory or defeat. While we must always proclaim the virtues of peace, the unspoken objective is perpetual war. (*The Creature from Jekyll Island*, p. 230)

Shortly after the formation of the Illuminati, May 1, 1776, an obstacle appeared to the Illuminati plan. It was the formation of the United States of America. This was a government by the people, rather than by a hierarchy. Clearly, a new tactic had to be employed.

Therefore, after the American Revolution and the formation of the country, the Rothschilds began to try to gain control of the money. They tried to establish a central bank to issue “debt money” which would be paid back to the bankers with interest. Alexander Hamilton was paid to work on the bankers’ (Rothschilds) behalf. He was also given money to bribe members of Congress to vote for the central bank.

Thomas Jefferson understood what was going on and the bankers’ ultimate end and objectives. He stated in 1791, “If the American people ever allow the banks to control issuance of their currency, first by inflation and then by deflation, the banks will deprive the people of all property until their children wake up homeless on the continent their forefathers conquered.”

However, the bribes won out and the first Bank of the United States was founded in 1791.

There were those besides Jefferson who were aware of what was happening and tried to warn the people and governments. One was a scholar named John Robison. John Robison had been invited into the Illuminati by Weishaupt. Weishaupt miscalculated the integrity of this Robison who used the opportunity to study the tenets of the Illuminati, and later exposed it. Another individual named Abbey Barruel also wrote a book to warn the world. (Newswatch, 4/15/99, p. 4-5) George Washington also wrote in 1798 of “the diabolical tenets of the Illuminati....” (previously quoted).

Meanwhile, the insiders of the Illuminati continued to work from within, establishing themselves in positions of power both in the United States and Europe.

In 1811, the first charter of the Bank of the United States expired. To keep the demand for a bank going, Rothschild, through the Bank of England, bought interests in both the North and South of the United States. He manipulated the textile industry in the North, and the cotton supply in the South. This caused fluctuations in both prices and profits and wages. This manipulation created money problems and a public demand for *something to be done*. The idea was planted that there needed to be more “banking stability”. And so, *the public, not realizing* the problems had actually been created by the bankers, *fell into the trap* of thinking a new central bank would solve the problem. So, public opinion began to grow in favor of what the Rothschilds had as an ultimate goal.

However, there still wasn’t enough favorable opinion for the bank charter to be renewed. The bankers needed to employ another tactic. They created a war.

The War of 1812 was supposedly fought over the impressment of American Sailors into the British navy. In reality, the British had given up that practice many years before. It was a reason, a front, given to an unknowing people to cover-up the truth of what was going on.

The end result of the cost of the war, as well as the inflation created by it, was the formation of a second bank. This bank created boom/bust cycles which finally culminated in the Panic of 1819.

Finally, again, in 1828, there was a statesman and President, Andrew Jackson, who recognized the damage, rather than stability, that the

manipulation of the Central Banking was doing to the United States economy. He also recognized that the Bank was a tool of the Illuminati to destroy the United States from within (remember that the new conquerors now worked subtly from within?) He stated, “Is there no danger to our liberty and independence in a bank that in its nature has so little to bind it to our country?... [Is there not] cause to tremble for the purity of our elections in peace and for the independence of our country in war...Controlling our currency, receiving our public monies, and holding thousands of our citizens in dependence, it would be more formidable and dangerous than a naval and military power of the enemy!” (Herman E. Krooss, ed., *Documentary History of Banking and Currency in the United States*, 1983, Vol. III, pp. 26-27, as quoted in *The Creature*...p. 257)

Unfortunately, although the President was aware of what was going on, by that time most of Congress had been bribed or bought off. Congressman John Randolph from Virginia stated, “Every man you meet in this House or out of it, with some rare exceptions, which only serve to prove the rule, is either a stockholder, president, cashier, clerk, or doorkeeper, runner, engraver, paper-maker, or mechanic in some other way to the Bank!”

President Jackson’s views brought an attempt on his life by a man who later claimed that he was “in touch with the powers of Europe” who promised to intervene in any attempt was made to punish him. Soon after this attempt on his life, Jackson reiterated to the bankers, “You are a den of vipers. I intend to rout you out, and by the Eternal God, I will rout you out! If the people only understood the rank injustice of our money and banking system, there would be a revolution before morning!” (Herman J. Viola, *Andrew Jackson*, p. 86)

Jackson won. The charter for the Second Bank of the United States expired and was not renewed in 1836. As punishment and in retaliation, the banks drastically reduced the available money supply. This caused economic disruptions. Similar tactics were being employed in other countries.

These kinds of economic disruptions brought about revolutions and uprisings. The time was ripe for the publication of a document.

This document was created in 1848. A man named Karl Marx along with Frederick Engels were commissioned to write the “Communist Manifesto”. Though Communism is attributed to Karl Marx, in reality Marx’s and

Engle's names did not appear on the document for at least 20 years. This document was in truth was a disguised version of the Rothschild plan. The planting and creation of this document started a new phase in the Rothschild plan.

Meanwhile, in spite of the popular opinion created through controlled media and publishing houses, the Civil War broke out, but did not begin over slavery. It was the result of the Rothschild plan of pitting one section of a country against another in order to weaken and in-debt both.

In Lincoln's first inaugural address, he stated, "Apprehension seems to exist among the people of the Southern States, that, by the accession of a Republican administration, their peace and personal security are to be endangered. I have no purpose, directly or indirectly, to interfere with the institution of slavery in the states where it now exists. I believe I have no lawful right to do so, and I have no inclination to do so!" (Don E. Fehrenbacher, ed., *Abraham Lincoln: Speeches and Writings, 1859-1865*, p. 215, as quoted in *The Creature...*, p. 370) [The 9th Amendment of the Constitution reads, "The enumeration in the Constitution of certain rights, shall not be construed to deny or disparage others retained by the people." The 10th Amendment reads, "The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people."] Even after the war broke out in 1861, Lincoln restated, "My paramount objective in this struggle is to save the Union, and it is not either to save or destroy slavery. If I could save the Union without freeing any slave, I would do it, and if I could save it by freeing all of the slaves, I would do it, and if I could save it by freeing some and leaving others along, I would also do that." (Robert L. Polley, ed., *Lincoln: His Words and His World*, p. 54, as quoted in *The Creature...*, p. 370)

"After having emphasized over and over again that slavery was not the reason for war, Lincoln later explained why he changed his course and issued the Proclamation: 'Things had gone from bad to worse until I felt we had reached the end of our rope on the plan we were pursuing; that we had about played our last card and must change our tactics or lose the game. I now determined upon the adoption of the emancipation policy.'" (Quoted by Charles Adams, *Fight, Flight, Fraud: The Story of Taxation*, 1982, p. 229, as quoted in *The Creature...*p. 379)

So, if slavery did not spark the Civil War, what did? Remember, the Bank of England had controlling financial interests in both the North and South and could manipulate the economy to cause chaos and distress. However, ultimately, the Rothschilds needed something to create a war of two opposing sides. The real issues of economic control had to be hidden, so the issue of slavery was brought in, again, to deceive an unknowing people as to what was really going on. This tactic has been and is used often, up to and including today's issues. Remember this quote. "*The great strength of our order lies in its concealment. Let it never appear in any place in its own name, but always covered by another name and another occupation.*" Adam Weishaupt (*Proofs of a Conspiracy*, p. 195)

Otto Von Bismarck, the Chancellor of Germany at the time, explained it this way. "The division of the United States into two federations of equal force was decided long before the Civil War, by the high financial powers of Europe. These bankers were afraid that the United States, if they remained in one block and as one nation, would attain economic and financial independence, which would upset their financial domination over the world! The voice of the Rothschilds prevailed. They saw tremendous booty if they could substitute two feeble ***democracies, burdened with debt to the financiers, in place of*** the vigorous ***Republic***, sufficient unto herself. Therefore, they sent their emissaries into the field to exploit the question of slavery and to open an abyss between the two sections of the Union." (Conrad Siem, *La Vieille France*, No. 216, March 17-24, 1921, pp. 13-16, as quoted in *The Creature...p. 374*)

The Civil War progressed. The bankers reduced the money supply to the North. They then offered Lincoln loans at 27% interest. Lincoln refused. Countering their attempt to gain control of the nation's money, Lincoln authorized the printing of Green Backs. He understood the fraud of how paper money is created and he figured that if the bankers printed money based on nothing, he could as well. The banks were afraid and outraged. Someone was standing against their power. What if other countries started printing their own money? The banks would lose their power. Lincoln recognized how he had angered them. He said, "I have two great enemies, the Southern Army in front of me, and the financial institutions in the rear. Of the two, the one in the rear is the greatest enemy." So by bribes and threats of Congressional members, the banking cartel got the National Banking Act through Congress on February 25, 1863.

This Act created banks similar to the Bank of the United States, but used money not backed by gold. Lincoln opposed the act with this statement. "The money power preys upon the nation in times of peace and conspires against it in times of adversity. It is more despotic than monarchy, more insolent than autocracy, more selfish than bureaucracy. I see in the near future a crisis approaching that unnerves me and causes me to tremble for the safety of my country. Corporations have been enthroned, an era of corruption will follow, and the money power of the country will endeavor to prolong its reign by working upon the prejudices of the people, until all the wealth is aggregated in a few hands, and the **Republic** destroyed!" (A letter to William F. Elkins, November 21, 1864. Archer H. Shaw, ed., *The Lincoln Encyclopedia: The Spoken and Written Words of A. Lincoln*, 1950, p. 40, as quoted in *The Creature...*p. 389)

The Secretary of the Treasury at that time was Salomon P. Chase, later of Chase Manhattan bank, one of the banking cartel banks. (Remember that the Rothschild's plan was to infiltrate from within. So here a banking interest held the position of Secretary of the Treasury) Of course, Chase supported the National Banking Act. While it was a step in the direction the Illuminati wanted, in that the banks could again collect interest from government war debt, the system was still not all the conspirators wanted. It was a foundation, but not quite the totalitarian banking system they desired. However, to insure that their greatest threat to this new foundation would cause no more obstacles or obstructions, they eliminated Lincoln, who was knowledgeable as to what they were doing and who would not be intimidated or bribed.

The true successful outcome of the Civil War, not as the textbooks teach it, but in terms of the Illuminati objectives is this. In freeing the slaves, through the 13th and 14th amendments, there was created a new class of citizen (due to the freeing of the slaves). This class of citizen was created by the federal government, and subject to the federal government, as opposed to a Constitutional Sovereign Citizen, who is creator of the government and superior to the government. The trick was now to get Sovereign Citizens to give up their freedom by becoming citizens of the federal government in voluntary servitude to that federal government. So the end result was two groups of citizens, one Sovereign and superior to all governments, federal, state, and local, and another type of citizen inferior to or subject to all governments, federal, state, and local.

For the next 45 years, from 1865-1910, there were few major external changes. There were some market manipulations for profit and gradual encroachments in federal government.

Behind the scenes, during these 45 years, the international banking conspiracy/cartel was laying the groundwork for the final deathblow to the obstacle of one-world government. This obstacle was—Sovereign American Citizens superior to the government they created.

The trick was to get voluntary relinquishment of Sovereign Citizens of their Sovereignty and to get them to admit to being citizens of the federal government. By this point in history, this has been done through things so familiar to us that nowadays we don't give it a second thought—birth certificates, social security cards, driver's licenses, business licenses, marriage licenses, bank cards and the numerous things signatures are placed upon creating contracts with the government.

What the banking cartel did has been highly successful. America is in the death throes of this final step. The target date for the New World Order is 2000-2005.

“Permit me to control the currency of a nation, and I care not who makes its laws.” Meyer Amschel Rothschild

What allowed the bankers to finally gain total control of the currency? It was the formation of the Federal Reserve. Five bankers, one Senator (Nelson Rockefeller) and the Assistant Secretary of the Treasury held an ultra-secret meeting at Jekyll Island. It was held under the pretense of a hunting trip. The purpose was to design a central bank with more power than before. Senator Aldrich was there to make sure it would pass Congress.

Years later, Frank Vanderlip, one of the seven conspirators, wrote for the February 9, 1935, issue of the Saturday Evening Post: “I do not feel it is any exaggeration to speak of our secret expedition to Jekyll Island as the occasion of the actual conception of what eventually became the Federal Reserve System...We were told to leave our last names behind us. We were told, further, that we should avoid dining together on the night of our departure. We were instructed to come one at a time as unobtrusively as possible to the railroad terminal....where Senator Aldrich's private car

would be in readiness....Once aboard the private car we began to observe the taboo that had been fixed on last name.....The servants and train crew may have known the identities of one or two of us, but they did not know all, and it was the names of all printed together that would have made our mysterious journey significant in Washington, in Wall Street, even in London. Discovery, we knew, simply must not happen, or else all our time and effort would be wasted. If it were to be exposed publicly that our particular group had got together and written a banking bill, that bill would have no chance whatever of passage by Congress.” (“From Farm Boy to Financier,” by Frank A. Vanderlip, *The Saturday Evening Post*, Feb. 9, 1953, pp. 25, 70, as quoted in *The Creature... p. 11*)

“To convince Congress and the public that the establishment of a banking cartel was, somehow, a measure to protect the public, the Jekyll Island strategists laid down the following plan of action:

1. Do not call it a cartel or even a central bank.
2. Make it look like a government agency.
3. Establish regional branches to create the appearance of decentralization, not dominated by Wall Street banks.
4. Begin with a conservative structure including many sound banking principles knowing that the provisions can be quietly altered or removed in subsequent years.
5. Use the anger caused by recent panics and bank failures to create popular demand for monetary reform
6. Offer the Jekyll Island plan as though it were in response to that need.
7. Employ university professors to give the plan the appearance of academic approval
8. Speak out against the plan to convince the public that Wall Street Bankers do not want it.”

(*The Creature from Jekyll Island*, p. 438)

Vanderbilt said what transpired there eventually became the Federal Reserve. What’s wrong with the Federal Reserve? A simple explanation is “The Federal Reserve System is a legal private monopoly of the money supply operated for the benefit of the few under the guise of protecting and promoting the public interest.” (*Wall Street and F.D.R.*, by Anthony C. Sutton, 1975, p. 94 as quoted in *The Creature... p. 23*)

It is not federal, and there is no reserve. Instead of letting Congress coin gold and silver money, the Federal Reserve prints money. They print it out of thin air, and loan it to the government. There is nothing to back it. The only expenses that they pay for the paper and ink, that is all. It does not matter if the bill is a \$1 bill or a \$10,000 bill. The cost to the Federal Reserve is only \$.025/bill. The Federal Reserve then loans the money to the U.S. Government at face value (remember, this is just paper printed from nothing) plus interest. Thus the American people are in debt to money printed out of nothing! This is how private loans work as well, and if a person can't pay back a loan of money that was printed out of thin air, at \$.025/bill, they lose their house, their car, their farm, their business etc. It is bookkeeping manipulation at its highest (or in this case lowest). This is why, since its inception in 1913, the national debt has grown to over 7 trillion dollars. Beyond this, when new money is printed and added into the economy, the flood of money causes the value of paper money to go down, inflation occurs, what everyone has is worth less, and now people have to work two or more jobs to equal what they used to have before. Then, two jobs put them in a higher tax bracket and they lose more through taxes. And the cycle continues, disguised in various forms and by economic and political verbiage, but this is the underlying structure. Remember, the Federal Reserve is owned by the bankers.

So, by 1913, while the power thus far gained over the years by the banking cartel was impressive, it was not yet total. The purpose of the creation of the Federal Reserve was for the purpose of total control.

Historian Ralph Epperson, author of The Unseen Hand, states, "So the American people, who had suffered through the American Revolution, the War of 1812, the battles between Jackson and the Second Bank of the United States, the Civil War, the previous panics of 1873 and 1898, and now the Panic of 1907, were finally conditioned to the point of accepting the solution offered by those who had caused all of these events: the international bankers!"

In order to ensure passage of the Federal Reserve Act, it was necessary to have a President favorable to signing. Taft, up for re-election, already said he would veto the bill. Wilson said he would sign it. To ensure Wilson's victory, Teddy Roosevelt was talked into running by the bankers in an attempt to split the vote, divert votes from Taft to Roosevelt, and ensure Wilson's victory. It worked. (The same tactic was used in the 1992

elections.) To get the bill passed, it was introduced twice under different names. One of the original seven of the Jekyll Island meeting later stated to the Saturday Evening Post, "Although the Aldrich Federal Reserve Plan was defeated when it bore the name 'Aldrich,' its essential points were all contained in the plan that was finally adopted."

The final tactic was to hold the final vote December 22, 1913, after most of the Congressmen had gone home for the holidays. December 22, 1913, the day before President Woodrow Wilson signed the Federal Reserve Act into law, one Senator, Charles Lindburgh, Sr. recognized what was happening. He spoke that day and said, "The money trust deliberately caused the 1907 panic, and thereby forced Congress to create a National Monetary Commission, which led to the ultimate creation of the Federal Reserve. This Federal Reserve Act established the most gigantic monetary trust [monopoly] on earth. *When the President signs this bill, the invisible government of the monetary power will be legalized. The people may not know it immediately, but the day of reckoning is only a few years removed. The people must make a declaration of independence to relieve themselves from the monetary power. This they will be able to do by taking control of Congress. Wall Streeters could not cheat us if you Senators and Representatives did not make a humbug of Congress. The greatest crime against Congress is its currency system. The worst, legislative crime of the ages is perpetrated by this banking bill. The caucus and party bosses have again operated and prevented the people from getting the benefits of their own government.*"

In spite of this, the damage was done. The Federal Reserve System was created.

Peter T. Whittie, a *National Geographic* writer, presents this interview with a spokesperson for the Federal Reserve as to where the money comes from.

"We created it," a Fed official tells me...."It's money that didn't exist before," he says. "Is there any limit to that?" I asked. "No limit."

Dr. Anthony Sutton, author of *Wall Street and the Bolshevik Revolution*, explains the purpose of the banking cartel in all this. "The financiers, could by government control, more easily avoid the rigors of competition. Through political influence, they could manipulate the police power of the state to achieve what they had been unable to achieve under the private

enterprise system. In other words, the police power of the state was a means of maintaining a private monopoly.”

Is the Federal Reserve part of Congress? The House Banking Committee states, “the Federal Reserve is, in practice, independent of that body [Congress] in its policy making. The Federal Reserve neither requires nor seeks approval of any branch of government for its policies. The system itself decides at what ends its policies are aimed, and then takes whatever actions it sees fit to reach those ends!”

After the establishment of the Federal Reserve System, was the birth of the graduated income tax.

This was started February 25, 1913, becoming the 16th amendment to the Constitution. First of all, a “graduated” income tax is one of the planks of the Communist Manifesto. Also, the Constitution states that “income tax” cannot be levied against its citizens. However, this is where the manipulation of the two definitions of citizens came into play and the American people were tricked into declaring they were not Sovereign Citizens. Therefore, as civil citizens they became subservient to the federal government, instead of the master of government. As civil citizens they then owed taxes to the federal government.

So, by the end of 1913, the Federal Reserve created the money from thin air, had it printed, loaned it to the U.S. Government at interest, and had a seemingly “legal” way to get that money (that was created from nothing) back through income tax through manipulating the definition of citizen.

The law created a crime—theft of the American people—by behind-the-scenes laws and manipulated definitions. It was theft of the American people’s wealth into the bankers’ pockets.

“I have betrayed my country.” Woodrow Wilson

WWI started due to the subversive activity of the Federal Reserve. The assassination of Ferdinand of Austria was again a front, an excuse to cover up the real reason for the war. The war turned into great profits for the bankers. “Not only did England and France pay for their supplies with money furnished by Wall Street, but they made their purchases through the same medium...Inevitably the house of Morgan was selected for this

important task. Thus the war had given Wall Street and entirely new role. Hitherto it has been exclusively the headquarters of finance; now it became the greatest industrial mart the world had ever known. In addition to selling stocks and bonds, financing railroads and performing the other tasks of a great banking center, Wall Street began to deal in shells, cannon, submarines, blankets, clothing, shoes, canned meat, and the thousands of other articles needed for the prosecution of a great war.” (John Moody, *The Masters of Capital*, pp. 164-165, as quoted in *The Creature...p. 236*) While Morgan protested that he was a pacifist and hated war, “His hatred against war did not prevent him, citizen of a neutral country, from furnishing belligerent powers with 4,400,000 rifles for a matter of \$194,000,000.... The profits were such as to compensate to some degree for his hatred of warfare... (Lewinsohn, *The Profits of War Through the Ages*, pp. 103-4, 222-24, as quoted in *The Creature...p. 237*), “The declaration of war by the United States, in addition to extricating the wealthiest American families from a dangerous situation, also opened new vistas of profits.” (Lundberg, *America’s Sixty Families*, pp. 141-42 as quoted in *The Creature...p. 239*). Another effect of the war was that European governments borrowed \$25 billion from the Federal Reserve. When these loans were defaulted, the debt was passed on to the American people to repay. This practice continues today. Presidents go around the globe promising billions of dollars in foreign aid. *American people* are forced to repay the loans when they are defaulted. The American people are asked to do their part or pay their fair share which impoverishes and quagmires them in debt. Why? Is it the objective of the bankers to destroy the United States of America and its people whose Constitution stands in the way of their purposes?

In order to collect money, there had to be a reason for money to be created and loaned. World War I was created by the manipulation of the banking cartel for just that reason—to have an excuse to loan money, created out of thin air, and then later collect the same money with interest. In the *Memoirs of Cordell Hull*, this observation was made. “The conflict (World War I) forced the further development of the income-tax principle. Aiming, as it did, at the one great-untaxed source of revenue, the income-tax law had been created in the nick of time to meet the demands of war. And the conflict also assisted the putting into effect of the Federal Reserve System, likewise in the nick of time.” In other words, the bankers planned this. They created a source of money (through the Federal Reserve), a reason to loan the money (WWI), and then a means to collect money to cover war debt (the graduated

income tax). After all these were in place so the bankers could profit, then the war was instigated.

Some behind-the-scenes information about World War I is that Max Warburg was brother to Paul Warburg, Paul being the chief drafter of the Federal Reserve Act. Paul Warburg was also a highly paid associate of the Rothschilds. Max was the personal banker for Kaiser Wilhelm and Max was also a member of the dominant German news agency, Wolff. Wolff was owned by the Rothschilds. Kaiser Wilhelm used Wolff to agitate the Germans to World War I. Max Warburg secured funding for the Germans. Paul Warburg secured funding for the opposition. This pattern, of the Rothschilds being in high places behind-the-scenes on both sides, was later repeated in World War II.

Again, for all this to occur, there had to be a President willing to go along with what the banking conspiracy wanted. Woodrow Wilson was that President, being primarily a pawn of Colonel Edward Mandell House. Woodrow Wilson was elected because he had kept the country out of the war, however, *prior* to the election, secretly; House was negotiating the agreements that later brought the United States into the war. “Ten months before the election which returned Wilson to the White House in 1916, ‘because he kept us out of the war,’ Colonel House negotiated a secret agreement with England and France on behalf of Wilson which pledged the United States to intervene on behalf of the Allies. On March 9, 1916, Woodrow Wilson formally sanctioned the undertaking. If an inkling of the conversations between Colonel House and the leaders of England and France had reached the American people before the election, it might have caused incalculable revulsions of public opinion...From this conversation and various conferences with Sir Edward Grey grew the Secret Treaty, *made without the knowledge and consent of the United States Senate*, by which Woodrow Wilson and House chained the United States to the chariot of the Entente...After the War the text of the agreement leaked out. Grey was the first to tattle. Page discussed it at length. Colonel House tells its history. C. Hartley Grattan discusses it at length in his book, *Why We Fought*. But for some incomprehensible reason the enormous significance of the revelation never penetrated the consciousness of the American people.” (Viereck, pp. 106-08, as quoted in *The Creature...*, p. 241) Ambassador Page stated, “the fatal moral weakness of the ...scheme is that we should plunge into the War, not on the merits of the cause, but by a carefully sprung trick.” (Quoted by Viereck, pp. 112-13, as quoted in *The Creature...*, p. 242.)

Other activities of House were to help create the Federal Reserve. “When the Federal Reserve legislation at last assumed definite shape, House was the intermediary between the White House and the financiers.” (Viereck, pp. 4, 35, 37 as quoted in *The Creature...*, p. 458). He also helped channel funds to the Bolsheviks for their revolution in Russia, supported the U.S. joining the League of Nations, organized the creation of the Council on Foreign Relations, had close ties with the Rothschilds, and sought “socialism as dreamed of by Karl Marx.” Wilson himself said, “Mr. House...his thought and mine are one.” (Charles Seymour, *The Intimate Papers of Charles House, Vol. I*, p. 114, as quoted in *The Creature...* p. 240) As already stated, House was also involved with making secret agreements with England and France to get America into the war.

At the end of World War I, the Treaty of Versailles was created with such severe demands on the Germans it was recognized that the peace would be short-lived. It created a situation ripe for Hitler. Lord Curzon of England said, “This is no peace. This is only a truce for twenty years.”

After the Treaty of Versailles, the practices of the Federal Reserve helped create extreme inflation in Germany. It was desired that a situation ripe for later wars be created. Through meddling from the banking cartel, the German economy almost collapsed. The Dawes plan, set up by the bankers, provided loans to Germany. It also subsidized a company headed by Paul Warburg. This company later became one of the important supply companies to Hitler.

Wilson knew what he was doing. On his deathbed, he said, “I have betrayed my country.” Prior to this, he also said, “There is a power somewhere so organized, so subtle, so watchful, so interlocked, so complete, so pervasive—that they better not speak above their breath when they speak in condemnation of it.” He also stated, “We have come to be one of the most completely controlled and dominated governments in the world—no longer a government of free opinion, no longer a government by conviction and vote of the majority, but a government by the opinion and duress of small groups of dominant men.”

Basically, WWI was created by the conspirators to collect profits and to set the stage for another war. Before they started the second war, they needed to create a political body they could slowly expand in power and authority.

When the League of Nations was formed at the end of WWI, it was the first attempt at world government. However, it was too open and obvious, so the Senate voted it down. Therefore, the conspirators created other organizations to bring about more subtle changes to world government, in a fashion that would not alert anyone as to what they were doing.

Richard Gardner “An end-run around national sovereignty, eroding it piece by piece, will accomplish much more than the old-fashioned frontal assault.” (“The Hard Road to World Order”, *Foreign Affairs*, 1974, as quote in Newswatch, 6/1/99, p. 20)

They created the Council on Foreign Relations. “Colonel House was only one man, where a multitude was needed. He has set the pattern and outlined goals for the future, and he still had a scheme or two in mind. In particular, he foresaw it would be necessary for the Fabians to develop a top level Anglo-American planning group in the field of foreign relations which could secretly influence policy on the one hand and gradually ‘educate’ public opinion on the other...To the ambitious young Fabians, British and American, who had flocked to the peace conference as economists and junior officials, it soon became evident that a New World Order was not about to be produced at Paris...For them, Colonel House arranged a dinner meeting at the Hotel Majestic on May 19, 1919, together with a select group of Fabian-certified Englishmen—notably, Arnold Toynbee, R.H. Tawney and John Maynard Keynes. All were equally disillusioned, for various reasons, by the consequences of the peace. They made a gentlemen’s agreement to set up an organization, with branches in England and American, ‘to facilitate the scientific study of international questions.’ As a result two potent and closely related opinion-making bodies were founded...The English branch was called the Royal Institute of International Affairs. The American branch, first known as the Institute of International Affairs, was reorganized in 1921 as the Council on Foreign Relations.” (Martin, pp. 174-5 as quoted in *The Creature...*, p. 273) The “President’s Report” published on August 31, 1972 has this to say about the CFR. “The origins of the Council on Foreign Relations lay in the concern of the founders at what they regarded as the disappointing conduct of the Versailles negotiations, and at the short-sighted (as they saw it) rejection by the United States of membership in the League of Nations. In 1921 they founded the Council as a privately funded, nonprofit and nonpartisan organization of individual members.”

CFR member Allen Dulles said about the CRF, “There is no indication that American public opinion, for example, would approve the establishment of a super-state, or permit American membership in it. In other words, time---a long time---will be needed before world government is politically feasible. This time element might seemingly be shortened so far as American opinion is concerned, by an active propaganda campaign in this country.”

From a CFR publication entitled “Public Opinion and Postwar Security Commitments”, we see this statement, “The sovereignty fetish is still so strong in the public mind, that there would appear to be little chance of winning popular assent to American membership in anything approaching a super-state organization. Much will depend on the kind of approach which is used in further popular education.”

A former member of the CFR, Rear Admiral Chester Ward, said in 1980, “The most powerful clique [in the CFR] has one objective, they want to bring about the surrender of the sovereignty and the national independence of the United States.” “The second clique of international members in the CFR comprises the Wall Street international bankers and their agents. Primarily, they want the world banking monopoly from whatever power ends up in control of the global government. *They would probably prefer that this be an all-powerful United Nations organization, but they are also prepared to deal with and form a one-world government controlled by the Soviet Communists, if the U.S. Sovereignty is ever surrendered to them.*”

A U.S. Congressman, John R. Rarick, said this about the CFR: “The Council on Foreign Relations dedicated to one-world government, financed by a number of the largest tax-exempt foundations, and wielding such power and influence over our lives in the areas of finance, business, labor, military, education, and mass communication media should be familiar to every member [of Congress] concerned with good government, and with preserving and defending the Constitution and our free-enterprise system. Yet the nation’s right-to-know machinery, the news media, remain conspicuously silent when it comes to the CFR, its member, and their activities. And I find that few university students and graduates have even heard of the Council on Foreign Relations. The CFR is ‘the establishment.’ Not only does it have the influence and power in key decision-making positions at the highest levels of government to apply pressure from above, but it also finances and uses individuals and groups to bring pressure from

below, to justify the high level decisions for converting the United States from a sovereign Constitutional Republic into a servile member state of a one-world dictatorship.”

The CFR has close relations with the United Nations. The United Nations is part of the transition plan to transform national sovereignty into one-world government.

“The ultimate purpose of all income redistribution is people control.”
Trotsky

After World War I, the conspirators continued to lay the groundwork for one world government. There were obstacles. Americans took pride in sovereignty and liberty. Europeans had national and ethnic pride. The Orient could not be manipulated at that point. Africa was underdeveloped. India was too poor. With all these obstacles, there was one area that was used as a testing ground—that was Russia. There were actually two revolutions in Russia. The first revolution in February, 1917 brought in a socialist government. At that point, neither Lenin nor Trotsky were in Russia. Then, October, the famous “October Revolution” took place. It was financed by the bankers, financing the Bolshevik minority.

“President Woodrow Wilson was the fairy godmother who provided Trotsky with a passport to return to Russia to ‘carry forward’ the revolution...At the same time careful State Department bureaucrats, concerned about such revolutionaries entering Russia, were unilaterally attempting to tighten up passport procedures.” (Sutton, *Revolution*, p. 25 as quoted in *The Creature*...p. 266)

Congressman Louis McFadden was Chairman of the House Banking Committee at that time. He stated: “They [the international banking conspiracy] financed Trotsky’s mass meetings of the ‘discontented and rebellious’ in New York. They paid Trotsky’s passage from New York to Russia so that he might assist in the destruction of the Russian Empire. They tormented and instigated the Russian Revolution, and they placed a large fund of *American* dollars at Trotsky’s disposal in one of their branch banks in Sweden.” After the Bolsheviks were in power, all banks were nationalized and run by the private, international bankers. The purpose of the conspirators takeover of Russia was for the future plans of pitting two

sides against each other and profiting from both, the old Rothschild's formula.

Wilson, the puppet of the conspirators, had this to say about the Revolution the new dictatorship and its slaughter of human life. "Assurance has been added to our hope for the future peace of the world, by the wonderful and heartening things that have been happening the last few weeks in Russia. Here is a fit partner for the League of Honor." Later he sent Elihu Root with \$20 million dollars designated as part of a U.S. war fund.

After the Revolution, in the attempt to stay in Power, Lenin has this to say. "Without the assistance of capital it will be impossible for us to retain proletarian power in an incredibly ruined country in which the peasantry, also ruined, constitutes the overwhelming majority---and of course, for this assistance capital will squeeze hundreds per cent out of us. This is what we have to understand. Hence, either this type of economic relations or nothing... (*V.I. Lenin, Report to the Tenth Congress of the Russian Communist Party, March 15, 1921, quoted by Sutton, Revolution, p. 157, quoted by The Creature..., p. 294*) "The Capitalists of the world and their governments, in pursuit of conquest of the Soviet market, will close their eyes to the indicated higher reality and thus will turn into deaf mute blindmen. *They will extend credits, which will strengthen for us the Communist Party in their countries; and giving us the materials and technology we lack, they will restore our military industry, indispensable for our future victorious attack on our suppliers. In other words, they will labor for the preparation of their own suicide.* (Quoted by Joseph Finder, *Red Carpet*, 1983, p. 8, as quoted in *The Creature...p. 294*)

Winston Churchill recognized these facts. He wrote in a newspaper article: "From the days of Weishaupt to those of Karl Marx, to those of Trotsky...this world wide conspiracy...has been steadily growing. This conspiracy played a definitely recognizable role in the tragedy of the French Revolution. It has been the mainspring of every subversive movement during the nineteenth century; and now at last this band of extraordinary personalities *from the underworld* of the great cities of Europe and America have gripped the Russian people by the hair of their heads, and have become practically the undisputed masters of that enormous empire." (*Illustrated Sunday Herald*, February 8, 1920 as quoted in *Newswatch*, 4/15/99)

“The hard fact is that American taxpayers unknowingly have been making monthly bank payments on behalf of Communist, socialist, and so-called Third-World countries for many years.” (*The Creature...*p. 298)

The Soviet Union had never been a valid threat until it was financed by the money interests of this country. Neither was Communist China, until the United States betrayed Nationalist China. Politically threatening scenarios are created by the bankers so that they can reap profits on both sides, while moving things along the path towards one-world dictatorship. Much aid to the USSR has come from American money and technology—(not only the USSR, but also Korea, Vietnam, Iran and now China.)

An example of what typically goes on was given by Representative James Traficant from Ohio. “America gives billions to Russia. With American cash, Russia builds missiles. Russia then sells those missiles to China. And China, who gets about \$45 billion in trade giveaways from Uncle Sam, then sells those Russian-made missiles to Iran. Now Iran, with those Russian-made missiles sold to them by China, threatens the Mideast. So Uncle Sam, who is concerned about Iran threatening the Mideast because of those Russian-made missiles sold to them by China that we financed by American cash sends more troops and needs more dollars....Mr. Speaker, this is not foreign policy. This is foreign stupidity.” (*Congressional Record*, April 29, 1997 as quoted in *The Creature*, p. 304-5).

Other funding in the Bolshevik Revolution came from Federal Reserve members, some through the avenue of the Red Cross, in order to disguise the funding.

The next major event of history for this country was the Great Depression. The conspiracy owns controlling interests in the media and publishing houses, and so has rewritten history according to their purposes. The true reason for the Depression was the expansion, and later reduction, of the money supply by the Federal Reserve System. Congressman Charles Lindbergh, Sr., recognized that the underlying cause of the depression was artificially induced. “Under the Federal Reserve Act, panics are scientifically created; the preset panic is the first scientifically created one, worked out as we figure a mathematical problem.” (Charles A. Lindbergh, Sr. *The Economic Pinch*, 1923 report as quoted in *The Creature...* p. 476.) Another critic of the Federal Reserve saw the same thing. Congressman Louis McFadden, Chairman of the House Banking Committee, said, “It was

not accidental. It was a carefully contrived occurrence. The international bankers sought to bring about a condition of despair here so that they might emerge as rulers of us all!” Curtis Dall, FDR’s son-in-law and a manager for one of the owners of the Federal Reserve, said about the Depression, “Actually, it was a calculated ‘shearing’ of the public by the world money powers, triggered by the planned sudden shortage of call money in the New York money market.” (Curtis B. Dall, *My Exploited Father-In-Law*)

It was the Federal Reserve and its owners that brought about the Great Depression. “In May 1920... the farmers were exceedingly prosperous....They were paying off their mortgages. They had bought a lot of new land, at the instance of the government—had borrowed money to do it—and then they were bankrupted by a sudden contraction of credit and currency, which took place in 1920.... The Federal Reserve Board met in a meeting which was not disclosed to the public—and they spent all day; the minutes made 60 printed pages, and it appears in the Senate Document 310 of February 10, 1923.... Under action taken by the Reserve Board on May 18, 1920, there resulted a violent contraction of credit.... The contraction of credit and currency had the effect, the next year, of diminishing the national production \$15,000,000,000; it had the effect of throwing millions of people out of employment; it had the effect of reducing the value of lands and ranches \$20,000,000,000. (U.S. Congress, Senate, Special Committee on the Investigation of Silver, *Silver*, Part 5, 76th Congress, 1st session, April 7, 1939, pp. 196-97 as quoted in *The Creature*...p. 476-77)

Ultimately, behind the scenes, was the Rothschild family. Eustace Mullins, *In Secrets of the Federal Reserve*, states “On February 6th, 1929, Mr. Montague Norman, governor of the bank of England [and an agent of the Rothschilds], came to Washington and had a conference with Andrew Mellon, Secretary of the Treasury. Immediately after that mysterious visit, the Federal Reserve Board abruptly changed its policy and pursued a high discount rate policy, abandoning the cheap money policy which it had inaugurated in 1927, after Mr. Norman’s other visit. The stock market crash and the deflation of the American people’s financial structure was scheduled to take place in March. To get the ball rolling, Paul Warburg gave the official warning to the traders to get out of the market.”

William Bryon, author of “*The United States Unsolved Monetary and Political Problems*” has this to say about the Panic of 1929. “When everything was ready, the New York financiers started calling 24 hour

broker call loans. This meant that the stock brokers and the customers had to dump their stock on the market in order to pay the loans. This naturally collapsed the stock market, and brought a banking collapse all over the country, because the banks not owned by the oligarchy were heavily involved in broker call claims at this time. Bank runs soon exhausted their coin and currency, and they had to close. The Federal Reserve refused to come to their aid, even though they were instructed under the law to maintain and elastic currency.”

Most of the members of Congress had been bought off. One of the few to speak the truth, Congressman McFadden stood in Congress on June 10, 1932, with this powerful speech: “Mr. Chairman, we have in this country one of the most corrupt institutions the world has ever known. I refer to the Federal Reserve Board and the Federal Reserve banks, which have cheated the government and the people of the United States out of enough money to pay off the national debt several times over. This evil institution has impoverished and ruined the people of the United States, and has practically bankrupted our government. It had done this through the defects of that law under which it operates, through the mal-administration of the law, by the Federal Reserve Board, and through the corrupt practices of the moneyed vultures who control it!

“Some people think the Federal Reserve banks are United States government institutions. They are NOT! They are private credit monopolies, which prey upon the people of the United States for the benefit of themselves and their foreign swindlers, and the rich and predatory moneylenders. In that dark crew of financial pirates, there are those who would cut a man’s throat to get a dollar out of his pocket; *there are those who send money into states to buy votes to control our legislation*; and there are those who maintain *international propaganda for the purpose of deceiving us and wheedling us into granting new concessions* which will permit them to cover up their past misdeeds and set again in motion their gigantic train of crime!

“These twelve private credit monopolies were deceitfully and disloyally foisted upon this Country by bankers who came here from Europe, and repaid our hospitality by undermining our American institutions. Those bankers took money out of this Country to finance Japan in a war against Russia. They created a reign of terror in Russia with our money. They planned and instigated the Russian Revolution.

“In 1912 the National Monetary Association, under the chairmanship for the late Senator Nelson Aldrich, presented a vicious bill called the National Reserve Association Bill. This is usually spoken of as the Aldrich Bill, although Aldrich did not write it. He was the tool, if not the accomplice, of the European bankers who, for nearly 20 years, had been scheming to set up a central bank in America. In 1912 they were spending—and are continuing to spend---vast sums of money to accomplish their purpose.

“We were opposed to the Aldrich plan for a central bank. The men who ruled the Democratic Party then promised the people that if they were returned to power there would be no central bank established here while they held the reigns of government. Thirteen months later, that promise was broken, and the Wilson administration, under the tutelage of sinister Wall Street figures, established, here in our free Country, the worm-eaten monarchical institution or the ‘King’s Bank’—to control us from the top downward and to shackle us from the cradle to the grave!

“When the Federal Reserve Act was passed, the people of these United States did not perceive that a world banking system was being set up here. A super-state, controlled by international bankers and international industries acting together to enslave the world for their own pleasure. Every effort has been made by the Federal Reserve Board to conceal its powers, but the truth is: The Fed has usurped the government! It controls everything here, and it controls all our foreign relations! It makes or breaks governments at will!” (Congressman McFadden, Congressional speech June 10, 1932)

A Representative of today who is aware of the damage of the Federal Reserve is Ron Paul of Texas. “The Federal Reserve is unconstitutional, pure and simple. The only Constitutional money is gold and silver, and notes redeemable in them. Not Fed funny money. Without the Federal Reserve, our money could not be inflated, at the behest of big government or big banks. Your income and savings would not lose their value. Just as important, we wouldn’t have this endless string of booms and busts, recessions and depressions, with each bust getting worse. They aren’t natural to the free market; they’re caused by the schemers at the Fed.” (Letter, summer, 1998 as quoted in *Newswatch*, 1/1/98, p. 22)

The near collapse of the economy during the Depression, created subversively by the Federal Reserve, led for a cry for government

intervention. FDR came into power. FDR wrote House (the man who controlled Woodrow Wilson) and FDR said, "The real truth of the matter is, as you and I know, that a financial element in the larger centers has owned the government ever since the days of Andrew Jackson."

Regarding Roosevelt, his own son-in-law, Curtis Dall, had this to say. "For a long time I felt that FDR had developed many thoughts and ideas that were his own, to benefit this country. But he didn't. Most of his thoughts, his political 'ammunition,' as it were, were carefully manufactured for him in advance by the CFR/one-world money group. Brilliantly, with great gusto, like a fine piece of artillery, he exploded that prepared 'ammunition' in the middle of an unsuspecting target, the American people--and thus paid off and retained his internationalist political support."

FDR came to the White House in 1933 when the United States was in the middle of the Great Depression. He was inaugurated on March 4th, 1933. Five days later "The Emergency Banking Relief Act" was passed with gave FDR the power of the Act of October 6, 1917. This Act of October 6, 1917 was the "Trading With the Enemy" Act in which at that time German citizens were placed totally under the power of the President of the United States. Now, through the War Powers Act approved by Congress March 9, 1933, all American citizens were considered to be "enemies." The American people came under the power granted to the President in the War Powers Act. This War Powers Act has never been repealed. That means for 67 years, the people of the United States have been living under martial law, and the Constitution has been bypassed.

FDR did great damage to the United States through the "The War Powers Act." Because of the Great Depression, the country was in a state of emergency, howbeit created and contrived. Nevertheless, it allowed the totalitarian dictatorship of the President.

In 1933, Congressman James Black stated in the *Congressional Record*: "I think of all the damnable heresies that have ever been suggested in connection with the Constitution, the doctrine of emergency is the worst. It means that when Congress declares an emergency, there is no Constitution. This means it's dead!"

As the new dictator, Roosevelt first seized all the gold and silver and turned it over to the Federal Reserve Banks. Emergency war currency based on

nothing but debt was issued. Also, the “sovereign states” no longer existed, and were now subject to the dictatorship of the Federal government. On June 6, 1934, the states were allowed to enter into interstate compacts, and regional government. In other words, the states, instead of being sovereign, were now corporations and sub-corporation of the District of Columbia. The former “sovereign states” were now under the control of Washington, D.C. The former “sovereign states” were no longer superior to the Federal government. All citizens of the states were now citizens of the Federal government.

Next Roosevelt ran through Congress the “*Federal Rules of Civil Procedure*” Act. This caused the courts system to no longer operate under the Constitution and Common Law, but Admiralty Law. Here is what a judge told Howard Freeman, an expert in this change of court system. “In 1938, all the higher judges, the top attorneys and the U.S. attorneys were called into a secret meeting, and this is what we were told: ‘America is a bankrupt nation—it is completely owned by its creditors. The creditors own the Congress, they own the Executive branch, the Judicial branch, and they own all the State governments! Take silent judicial notice of this fact, but never reveal it openly. Your court is operating in an Admiralty Jurisdiction. Call it anything you want, but do not call it Admiralty!’”

In Admiralty Jurisdiction, there has to be a valid international contract in dispute. If people were aware of this, and demanded to see the international contract, what would be given is the national debt and that the international bankers own the nation. Howard continues, “But the bankers, at their secret meeting in 1938, instructed the judges and attorneys that it ‘is not expedient at this time’ to admit that they own everything and could foreclose on every nation of the world. ***The reason they don’t want to tell everyone that they own everything is that there are still too many privately owned guns out there.*** There are uncooperative armies and other military forces. So, until they can gradually consolidate all armies into a WORLD ARMY, and all courts into a single WORLD COURT, it is not ‘expedient’ to admit the jurisdiction the courts are operating under. Since the courts were instructed not to call it ‘Admiralty Jurisdiction’, they call it ‘Statutory Jurisdiction’”. (*In light of this quote, note the big push to get rid of privately owned guns, which our forefathers considered in the Second Amendment to be necessary against a corrupt government. Also, note the ever increasing power of the United Nations and how Clinton has turned the U.S. Military over to it.*)

Congressman Louis McFadden, Chairman of the House Banking Committee, charged that the seizure of the gold which Roosevelt had required was “an operation run for the benefit of the international bankers.” James Warburg, son of Paul Warburg, and ***one of the conspirators admitted***, “McFadden was preparing to break the whole deal when he collapsed at a banquet and died. As two assassination attempts had already been made against him, many suspected poisoning.”

FDR created the Export-Import Bank which turned out to be a means where Americans taxpayers ended up paying interest as well as principal on loans made by the U.S. government to other nations, which the nations in turn defaulted on. He also borrowed money for the new socialist programs he created. Again, citizens ended up paying for these programs in taxes.

These gradual changes which involved fraud and deceptive words were all part of the master plan to overcome the obstacles this nation had posed to the bankers. “Norman Thomas, a Socialist that ran six times as a candidate for President of the United States on the Socialist Party ticket has stated: ‘The American people will never knowingly adopt Socialism, but under the name Liberalism, they will adopt every fragment of the Socialist program until America will one day be a Socialist nation without knowing how it happened.’ Three months before his 1959 visit to the United States, Nikita Khrushchev, then ruthless dictator of the Illuminati’s International Communism stated: ‘We can’t expect the American people to jump from Capitalism to Communism, but we can assist their elected leaders in giving them small doses of Socialism until, they awaken one day to find they have Communism.’” (*Newswatch*, 4/15/99, p. 16)

During Roosevelt’s reign, the following appeared in the February 1934 issue of the *New American*, which was circulated among the bankers. “Debts must be collected on loans and mortgages must be foreclosed as soon as possible! When the common people have lost their homes, they will be more docile and easier to govern. People without homes will not quarrel with their lenders.”

The idea that the World War II brought the country out of the depression was a lie. The money supply could have been increased at any point in time.

“From the days of Spartacus, to Weishaupt, to those of Karl Marx, to those of Trotsky, this world-wide conspiracy for the overthrow of civilization has been steadily growing.” Winston Churchill

Going back to the fact that after WWI, the treaties were created in a way to bring about a situation ripe for Hitler, what went on behind the scenes in Germany is this. After WWI, Germany was purposely left in ruins to help create the stage for the future conflict. Then, the Dawes plan gave banking money and U.S. taxpayer money to I.G. Farben in Germany. I. G. Farben supported Hitler. I.G. Farben (who supported Hitler) was connected to American I.G. which was headed by Paul Warburg, who drafted the Federal Reserve Act. Paul Warburg was also an agent of the Rothschilds, and was also one of the owners of the Federal Reserve. Paul’s brother, Max, was the head of the German central bank. Paul channeled money to Max who passed it on to Hitler. While WWII seemed to have a real cause, (the rise of Hitler), without the monetary backing of the international banking cartel, Hitler could not have risen to power. Anthony Sutton, in *Wall Street and the Rise of Hitler*, states: “Without the capital...there would have been no I.G. Farben in the first place, and almost certainly no Adolf Hitler and World War II.” Also, Standard Oil, which was owned by the Rockefeller interests, had a joint venture with I.G. Farben to discover a process to convert coal to oil, a necessary step for Germany’s war effort. In 1943, I.G. Farben produced 100 % of Germany’s synthetic rubber, 100% of its lubricating oil, and 84% of its explosives. It also manufactured gas for the concentration camps, as well as 45% of the funds to help elect Hitler to power in 1933.

The Dulles brothers, representatives of the owners of the Federal Reserve, met with Hitler on January 4, 1933, to give him the funds he needed to become Chancellor of Germany. One of the brothers (who gave these funds to Hitler) later became the Secretary of State to Eisenhower.

Another institution that helped Hitler rise to power was the Bank of England (controlled by the Rothschilds). John Hargrave, a biographer, states, “It is quite certain that Mr. Norman (head of the Bank of England at the time) did all he could to assist Hitlerism to gain and maintain political power....”

“There is considerable evidence available to indicate that Hitler had no intention of attacking Britain and of engaging in a war with a power he greatly admired...While Chamberlain was Prime Minister of Britain there was no real ‘shooting war’ with Germany. The leaders of both the German

and British governments were aware of the plans of the International Bankers to have another major war, and they were negotiations in an effort to avoid it. *Hitler wanted Britain to join him in an all-out attack on the conspirators.* The CONTROLLED press in Britain launched a bitter campaign against Chamberlain. The ‘powers that be’ wanted Chamberlain out of the way so that they could get a real war under way. Under the propaganda barrage, Chamberlain was forced to resign. He was replaced by Winston Churchill. Immediately afterward, the ‘shooting war’ started in earnest, with a British air attack on Germany. *The following year, the German High Command (unknown to Hitler) sent Rudolph Hess to Britain to contact Lord Hamilton and Churchill to tell them that if they would sign a Peace Treaty, the **German generals would get rid of Hitler and concentrate their military might on the destruction of Communism in Russia** and other European countries. **Churchill refused to agree** to the offer made by Hess. Hess was jailed in Britain for the duration of the war.” (*All Honorable Men*, by James Martin; *Bombing Vindicated* by J.M. Spaight, principle assistant secretary to the British Air Ministry, published in 1944, as quoted in *Newswatch*, 4/15/99, p. 19)*

[For those younger readers who do not know history, England and the United States were supposed to have been on the opposing side to Germany and Hitler in WWII.]

A 1940 Gallup polls found 83% of Americans were against entering into the war. Roosevelt had to find a politically acceptable way to do so. A conclusion in *The Final Secret of Pearl Harbor* by Admiral Robert Theobald was that the plans to use Pearl Harbor as the excuse actually began in June, 1940. Furthermore, Roosevelt knew about the attack a full 21 hours before it happened.

“Frank Murphy was a Supreme Court Justice when he discovered that there was indeed a plot to destroy the United States of America. Murphy had a meeting with Congressman Martin Dies, the Chairman of the House Committee on Un-American Activities. Murphy told Dies: ‘We’re doomed! The Communists have control completely. *They’ve got control of Roosevelt and his wife as well.*’ (American Opinion Magazine, February 1971, p. 145) In 1949 Murphy was to be released from a Detroit hospital completely recovered from an illness, but suddenly had a heart attack and died. Congressman Dies was convinced he was murdered.” (*The Unseen Hand*, by Ralph Epperson, p. 304) (as quoted in *Newswatch*, 6/1/99)

The conspirators' plans were working. Hitler had risen to power. WWII was in full swing. Roosevelt had brought the United States into the war. From the bankers vantage, they want to reap profits from all sides, force the United States into further debt and more socialism, and use the war to gain greater control of the U.S.S.R. To get the U.S.S.R. into the war, the U.S. government, with orders from the conspiracy, shipped arms and vehicles for the Soviets to use, supposedly against Germany. *Thus the country that later was such a "threat" was armed by the U.S.* Another way the conspirators aided Russia is that Churchill and Roosevelt made a secret pact with Stalin to delay the plan of invasion of Europe from 1943 to 1944. This allowed Russia to gain more of Eastern Europe. The U.S.S.R. ended up the way the conspirators wanted at the end of the war—with more land. The U.S. ended up with thousands of lives lost and war debts.

“First, we will take Eastern Europe, then the masses of Asia. Then we will encircle the United States which will be the last bastion of capitalism. We shall not have to attack. It [the U.S.] will fall like a ripe grapefruit into our hands.” (V.I. Lenin, *Newswatch*, 4/15/99, p. 15)

“James Forrestal, America's first Secretary of Defense, became very dismayed over the deliberate refusal of the United States to win World War II two full years before the hostilities ended. The United States, by agreement between Roosevelt and Churchill of England, rearmed Russia with Lend-Lease war material paid for by American tax payers, and then waited until Russia could march into Berlin, therefore capturing all of Eastern Europe for International Communism. This so upset James Forrestal that he stated: ‘These men are not incompetent or stupid. If they were merely stupid, they would occasionally make a mistake in our favor.’” (*The Assassination of Joe McCarthy* by Medford Evans, p. 113) “When you speak out as a government figure against the conspiracy for world government, you make enemies in high places. The following was recorded in the Congressional Record: ‘The Communists both American and European, had good reason to hate Jim Forrestal: he hated them. He emerged from the Second War dedicated to the destruction of Communism. He had opposed every concession to bring Russia into the war against Japan. He fought General Marshall's effort to force Chiang Kai-shek to coalesce with the Chinese Communists. He battled those men in the State Department who tried to give the Mediterranean to Russia.’” (*Congressional Record*, December 6, 1950, p. 16179) “Forrestal knew the world of free

enterprise was under siege the world over. In the book, *Meeting at Potsdam*, it says '(He)...was alarmed by what he took to be Roosevelt's trust in Stalin...Forrestal's nightmare was that capitalism itself was under siege all over the world. During the war his personal files fattened alarmingly—filled with names of journals and organizations and individuals who were under Communist influence.'" (*Meeting at Potsdam* by Charles L. Mee, Jr., p. 26) "Forrestal had discovered the insiders' plans. Forrestal wrote to his priest, Monsignor Sheehy, often about the threat of the overthrow of the U.S. government by Communists. Sheehy said: 'Many, many times in his letters to me Jim Forrestal wrote anxiously and fearfully and bitterly of the enormous harm that had been, and was unceasingly being done, by men in HIGH OFFICE in the United States Government, who he was convinced were Communists or under the influence of Communists, and who he said were shaping the policies of the United States Government to aid Soviet Russia and harm the United States.'" (*Death of James Forrestal* by Cornell Simpson, p. 84) (the above quotes in *Newswatch*, 6/1/99, p.7) Forrestal was considered dangerous because he exposed the conspirators. He was sent to Bethesda Naval Hospital where he supposedly died from "falling" out of window, though the coroner's report never used the word "suicide".

Before Forrestal's death, a freshman Senator named Joseph McCarthy came on the scene. "It was Forrestal who personally alerted the freshman Senator to the Communist/Illuminati menace and named names to him of KEY persons in our federal government who were 'consistently shaping our policies and programs to benefit Soviet Russia.'" (*Death of James Forrestal*, p. 147) "Just after Thanksgiving, 1949, McCarthy had three visitors come to his office. They '...showed the Senator a one-hundred page summary of Communist Subversion in the United States, including serious penetration of the State Department. The report, which had been prepared under the direction of J. Edgar Hoover (head of the FBI), had already been supplied to the White House, the Secretary of State, and heads of other federal departments concerned. It detailed the operations of spy networks operating in the U.S. government and involving a large number of State Department employees, some in VERY high positions. Senator McCarthy read the report and was so shocked by what it revealed that he committed himself to DO something about it.'" (*American Opinion Magazine*, January 1973, p. 63) "McCarthy saw a GIANT CONSPIRACY. Why wouldn't high officials in the State Department and the Secretary of State reveal the concentration of Communists if they were NOT part of that conspiracy? The State Department conducts the official policy of the U.S. with foreign

nations. Could our State Department have been taken over by Communists to aid in the overthrow of non-Communist governments? ‘McCarthy also told the American public that it was at the Yalta conference in 1945, that Roosevelt and Stalin PLANNED, not only the Korean War that the United States was then involved in, but also the Vietnamese war that was to follow some 10 to 12 years later. It was on September 23, 1950, that McCarthy charged: “Here (Yalta) was signed the death warrant of the young men who were dying today in the hills and valleys of Korea. Here was signed the death warrant of the young men who will die tomorrow (yet in 10 – 12 years from then) in the jungles of Indochina (Vietnam).”” (The Unseen Hand, Epperson, p. 311) “What can be made of this unbroken series of decisions and acts contributing to the strategy of defeat? They cannot be attributed to incompetence...” (David, *Fear of Conspiracy*, p. 4) “Senator McCarthy concluded that the purpose for this great conspiracy was ‘to diminish the United States in world affairs, to weaken us militarily, to confuse our spirit (will) with talk of surrender in the Far East, and to impair our will to resist evil. To What end? To the end that we shall be contained and frustrated and finally fall victim to Soviet intrigue from within and Russian military might from without.” (America’s Retreat From Victory by Joseph McCarthy, p. 138) “Senator Joseph McCarthy paid with his reputation and his life for exposing this great conspiracy. ‘Louis Budenz, a former member of the Communist Party, said about the Senator: “The destruction of Joe McCarthy leaves the way open to intimidate any person of consequence who moves against the conspiracy. The Communist made him a symbol to remind political leaders in America not to harm the Conspiracy or its world conquest designs.”” (McCarthy, *American Opinion*, p. 9, s quoted in *The Unseen Hand* by Ralph Epperson, p. 315) (The above quoted references about Forrestal and McCarthy as quoted in *Newswatch*, 6/1/99 pp. 6-9)

“During World War II, American influence and power in the Far East were unquestioned because of our military victory over the Japanese Empire. The U.S. military and naval forces were predominant in China, Japan, Korea, Burma and the Philippines. China was ruled by Chiang Kai-shek who was unswervingly loyal to American interest. He was educated in America and wanted a Constitutional Republic patterned after America. Although Mao Tse-tung’s Communist forces were poised to challenge the National Government...their rule in 1945 was confined to regions of rural North China. Their chances of victory were nil. In four short years, the actions of Washington, the State Department, had tossed away all this military and

political might. The story of how this happened is an amazing betrayal of America's security by its own officials." (*Newswatch* 4/15/99, p. 23)

General MacArthur realized what was going on. "It seems strangely difficult for some to realize that here in Asia is where the Communist Conspirators have elected to make their play for global conquest....that if we lose the war to Communism in Asia, the fall of Europe is inevitable, win it and Europe most probably would avoid war and yet preserve freedom... We MUST win. There is **no substitute for victory.**" (General Douglas MacArthur, *Reminiscences*, p.440 as quoted in *Newswatch*, 6/1/99, p. 14)

Regarding these matters, Lieutenant Colonel "Bud" Farrell, USAF, retired, stated : "It was the traitor, President Harry S. Truman himself, who REFUSED TO ALLOW General Douglas MacArthur, the Supreme Commander of the United Nations fighting forces in Korea, to bomb the bridges at the Yalu River over which the Chinese Communist troops came by the hundreds of thousands to kill and wound our soldiers. Truman and the Soviet General in charge at the United Nations TOTALLY HANDCUFFED MacArthur in all instances. General MacArthur was only in command of the fighting forces in Korea, not in command of the United Nations position as "Under-Secretary of the Security Council." A Soviet General held this position of POWER AND AUTHORITY OVER MACARTHUR and all the United Nations fighting forces in Korea. THE SAME WAS TRUE FOR VIETNAM. When General MacArthur WOKE UP TO THE TREASON OF PRESIDENT TRUMAN and the Soviets in the United Nations, he executed one of the greatest military performances ever ventured in modern warfare. His dangerous but magnificent, military engagement and sea landing at "Inchon" on September 15, 1950 enabled his military forces to slaughter the communist forces, destroy their massive supply dumps, and put the Red Chinese, North Koreans and their Soviet advisors on the run. MacArthur never asked permission from the United Nations Security Council (Soviet General Zinchenko) to perform this SECRET military operation. MacArthur hand-picked close and loyal military officers in doing so, and they kept a tight lid on the entire operation. Originally, our forces were to never win any battles as planned by the Soviet Generals in the United Nations. But General MacArthur realized the treason and took positive action not only to save the lives of his fighting forces and destroying the enemy and their supply dumps, but also creating the "turning point" of the Korean War with his success at Inchon. For this 'positive action', General Douglas MacArthur was relieved of his command of the

United Nations fighting forces in Korea by the traitor President Harry S. Truman. President Truman feared General MacArthur so much that just prior to General MacArthur returning to the United States from Korea, Truman hid out at Camp David for over 3 weeks in fear of being arrested by General MacArthur, who was a 5-Star General and in command of all military forces in the United States. This allowed the controlled press in the United States time to attack MacArthur on all fronts, even before he returned home from Korea. Big headlines in the monthly magazines of the United States described MacArthur ‘As like unto Hitler returning home to the Chancellery.’ With cunning control of their national news outlets over the minds...[turned] people in the United States against MacArthur, the same man who had just saved the lives of thousands of their sons with daring military moves –against the wishes of the United Nations Command, in routing the Red Chinese and North Koreans at Inchon.

General MacArthur was dismissed because he understood what was going on. President Truman said “With deep regret, I have concluded that General of the Army Douglas MacArthur is unable to give his wholehearted support of the policies of the United States and the United Nations.” (Eldorous Dayton, *Give ‘em Hell Harry*, p. 200) [Apparently the policies of the United States and the United Nations did not include victory over Communism.]

“First, we will take Eastern Europe, then the masses of Asia. Then we will encircle the United States, which will be the last bastion of capitalism. We shall not have to attack. It [the U.S.] will fall like a ripe grapefruit into our hands.” (V.I. Lenin, *Newswatch*, 4/15/99, p. 15)

Communism is a word that has been taken out of circulation. This is because “W. Cleon Skousen, assistant to FBI director J. Edgar Hoover, discover they (Communists) wanted to discredit the FBI and eliminate the House Committee on Un-American Activities. Skousen condensed his finding of Communist objectives through infiltration into 45 points. Point # 33 stated: ‘Eliminate all laws or procedures which would interfere with the operation of the Communist apparatus.’ Point #34 stated: ‘Discredit and eventually dismantle the FBI.’ Point # 35 stated: ‘Eliminate the House Committee on Un-American Activities.’ Our ability to defend ourselves from infiltration would be gone.” (W. Cleon Skousen, *The Naked Communist*, as quoted in *Newswatch*, 6/1/99)

For those unfamiliar with the term Communism, here are the:

Communist Rules for Revolution.

- A. Corrupt the young; get them away from religion. Get them interested in sex. Make them superficial; destroy their ruggedness.
- B. Get control of all means of publicity, thereby:
 - 1. Get people's minds off their government by focusing their attention on athletics, sexy books and plays and other trivialities.
 - 2. Divide the people into hostile groups by constantly harping on controversial matters of no importance.
 - 3. Destroy the people's faith in their natural leaders by holding them up to contempt and ridicule.
 - 4. Always preach true democracy, but seize power as fast and as ruthlessly as possible.
 - 5. By encouraging Government extravagance, destroy its credits, produce fear of inflation with rising prices and general discontent.
 - 6. Promote unnecessary strikes in vital industry, encourage civil disorders and foster a lenient and soft attitude on the part of the government toward such disorders.
 - 7. By specious [fair-seeming but deceptive] argument, cause the breakdown of old moral virtues, honesty and sobriety.
- C. **Cause the restriction of all firearms on some pretext with a view of confiscating them and leaving the population helpless.** (Don McAlvany, "America's Road to Ruin," *The McAlvany Intelligence Advisor*, December 1990, p.1, as quoted in *Newswatch*, 4/15/2000)

Here is what appeared in the *Congressional Record*, which was uncovered by W. Cleon Skousen for the FBI while serving as an assistant to J. Edgar Hoover. (from *Newswatch*, 4/15/99, p. 17)

- 1. "Convince the U.S. to accept coexistence as the only alternative to atomic war. This would give them free movement to spread International Communism.
- 2. Convince the U.S. to capitulate [give in] in preference to engaging in an atomic war.
- 3. Develop the ILLUSION that total disarmament by the U.S. would be a demonstration of moral strength.
- 4. Permit free trade [what about the NAFTA Treaty with Mexico and Canada] between ALL nations regardless of whether items could be used for war.

5. Extend long-term loans to Russia and Soviet satellites. They would never pay them back because they plan to 'bury us.'
6. Provide U.S. 'foreign aid' to ALL nations, thus draining the wealth of our nation and causing steady long-term inflation to 'debauch our currency.'
7. Grant recognition of **Red China** with admission to the United Nations. Thus, expelling Nationalist China from the organization. President Richard Nixon accomplished this for his bosses of the Illuminati.
8. Set up East and West Germany as separate states. When near completion of their plan for world government, they would reunify Germany as an 'electrifying overture of peace, so America would disarm.
9. Prolong the conferences to ban atomic tests because the U.S. had agreed to suspend testing as long as the negotiations were in progress.
10. Allow ALL Soviet satellites representation in the United Nations. They would have an equal vote as the United States.
11. Promote the United Nations as the only hope for mankind. If its charter is rewritten, DEMAND that it be set up as a one-world-government with its own independent armed forces.
12. Resist any attempt to outlaw the Communist Party within the U.S.
13. Do away with loyalty oaths.
14. Continue to give Russia access to the U.S. Patent Office.
15. Capture one or BOTH political parties in the U.S. (Now you can understand why no matter which party is in office, they continue toward Socialism....)
16. Use technical decisions of the courts to WEAKEN basic American institutions by claiming their activities violate their civil rights.
17. Get control of the school systems. Use them for Socialism and current Communist propaganda. Get control of teacher's associations.
18. Gain control of all student newspapers.
19. Use student riots to foment public protest against programs and organizations which are under current Communist attack.
20. Infiltrate the press, including the TV. (The nightly anchors for ALL of the major TV networks are members of the subversive Council on Foreign Relations.)
21. Gain control of KEY position in radio, TV, and motion pictures.
22. Continue discrediting American culture by degrading all forms of artistic expression – nude movies, books, perverted art, etc.

23. Control art critics and directors of museums. “Our plan is to promote ugliness, repulsive, meaningless art.”
24. Eliminate all laws governing obscenity by calling them ‘censorship’ and a violation of free speech and free press.
25. Break down cultural standards of morality by promoting pornography in books, magazine, motion pictures, and TV.
26. Present HOMOSEXUALITY, degeneracy, and promiscuity as ‘normal, natural and healthy.’
27. Infiltrate the churches and replace revealed religion with ‘social’ religion. Discredit the Bible and emphasize the need for ‘intellectual maturity’ which does not need a ‘religious crutch.’
28. Eliminate prayer or any phase of religious expression in the schools. (Communism has stated that if they have two generations of our schools without God in them they will take our nation. It has been 35 years.)
29. Discredit the American Constitution by calling it inadequate – ‘out of step.’
30. Discredit the American founding fathers. Present them as selfish aristocrats, who had no concern for the ‘common man’.
31. Belittle all forms of American [Christian] culture and discourage the teaching of American history.
32. Support all Socialist movement to give **centralized control** over any part of the culture – education, social agencies such as housing authority, welfare programs, mental health clinics, etc.
33. Eliminate ALL laws or procedures which interfere with the Operation of the Communist apparatus.
34. Discredit and eventually dismantle the FBI.
35. Eliminate the House Committee on Un-American Activities.
36. Infiltrate and gain control of more labor union. Create crippling strikes of major manufacturers or the service industry.
37. Infiltrate and gain control of big business. Create a monopoly in the market place with them in control.
38. Transfer some of all the power of arrest from the police to social agencies. Treat ALL behavior problems as psychiatric disorders.
39. Dominate the psychiatric profession and use mental health laws as a means of gaining coercive control over those who oppose Communist goals.
40. Discredit the family as an institution. Encourage promiscuity and easy divorce.

41. Emphasize the need to raise children away from the negative influence of parents. Attribute prejudices and mental blocks to suppressive influence of parents.
42. Create the impression that violence and insurrection are legitimate aspects of the American tradition: that students and special interest groups should rise up and use 'united force' to solve problems.
43. Overthrow all colonial governments before native populations are ready for self-government. [Have we witnessed nation after nation in Africa overthrown for Communism as well as the Orient?]
44. Internationalize the Panama Canal.
45. Repeal the Connally Reservation to the Genocide Convention Treaty to the United Nations, so the U.S. cannot prevent the World Court from seizing jurisdiction over domestic (internal U.S.) problems. This would give the World Court jurisdiction over nations and individuals alike. (This was accomplished on February 19, 1986, with the passage of the Genocide Convention Treaty with the United Nations and the Ronald Reagan Administration.)

By examining the extensive list of objectives, one should be able to readily acknowledge that the Illuminati's plan is nearly complete!" (*Newswatch*, 4/15/99, pp. 17-18)

Ezra Pound, a poet, exposed the conspirators on national radio. He was imprisoned as a "political prisoner" without specific charge or trail. He was labeled "mentally ill" and since the government is not required to hold trial for anyone that is "mentally ill", Pound never got one.

Soon after the war, Senator Joseph McCarthy accused many people in government of being Communists. The **government itself admitted this** on June 30, 1953, in a report "*Interlocking Subversion in Government Departments*" written by the Senate International Security Subcommittee. It said, "The Soviet international organization has carried on a successful and important penetration of the United States Government, and this penetration has not been fully exposed. This penetration has extended from the lower ranks to top-level policy and operating positions in our government. Despite the fact that the Federal Bureau of Investigation and other security agencies had reported extensive information about this Communist penetration, little was done by the Executive branch to interrupt the Soviet operative in their ascent within our government."

The Marshall Plan guaranteed that American Taxpayer would rebuild war-torn Europe, Japan, and Russia, while the bankers collected profits on American debt, loans, and their business interests. It further financed the bankers at America's expense.

“Good intentions will always be pleaded for every assumption of power. It is hardly too strong to say that the Constitution was made to guard the people against the dangers of good intentions. There are men in all ages who mean to govern well, but they mean to govern. They promise to be good masters, but they mean to be master.” Daniel Webster.

During WWII, on January 1, 1942, 25 nations signed a “Declaration by the United Nations.” This was the start of the current United Nations. After WWII, the Council on Foreign Relations acting through the State Department, established the United Nations. John D. Rockefeller donated the money to purchase land and build the headquarters in New York City. “Our own House Committee on UnAmerican Activities established the fact that **all but one of our representatives** that helped to establish the United Nations in September 1945 **were communists.**” (*Newswatch*, 1/1/98, p.3)

“The United Nations, through which a Communist-style world government is to be established, was founded by Communists from Russia and the Treasury and State Department of the United States. (Postwar Foreign Policy Preparation, 1939-45; Interlocking Subversion in Government Departments, sub-committee report June 30, 1953; also Senate Hearings on Activities of U.S. Citizens Employed by the United Nations, and Hearings on the Institute of Pacific Relations; *Newswatch*, 11/1/98, p. 11) They established a decolonization program, so colonies of the powers that won World War II could be set free. Before they could learn self-rule, the Communist/Illuminati would overthrow them for Communism's future world government.” (*Newswatch*, 11/1/98, p. 11)

Getting America to join a form of world government had been an objective of the CFR. Now began the propaganda that the United Nations was “promoting international peace, harmony and understanding”. The real purpose and ultimate end was to bring America into a one world government. Therefore *the purpose of the United Nations was to condition Americans to the idea of accepting global leadership.*

“The UN is a true world organization. Actually, the creation of a world government, in any shape or form, depends not primarily upon the structure of an international organization, but upon the willingness of *key countries* to *surrender certain sovereign rights*.” [Department of State Publication 39291]

John Foster Dulles, whom you remember was one of the men sent to help fund Hitler and later became Eisenhower’s first Secretary of State, said “The United Nations represents not a final stage in the development of world order, but only a primitive stage. Therefore, its primary task is to create the conditions which will make possible a more highly developed organization.”

Freedom from War –State Department Publication 7277 reads:

“1) The first stage would significantly reduce the capabilities of nations to wage war by reducing the armed forces of the nations 2) The nuclear capabilities would be reduced by treaties 3) UN “peace keeping” powers would be strengthened. This third stage would have the nations retaining only those forces required for maintaining internal order, but the United States would provide manpower for the United Nations Peace Force.”

In *The Fearful Master—A Second Look at the United Nations* by G. Edward Griffin, Dr. J.B. Mathews, former chief investigator for the House Committee on Un-American Activities said, “I challenge the illusion that the UN is an instrument of peace. It could not be less of a cruel hoax if it had been organized in Hell for the sole purpose of aiding and abetting the destruction of the United States.”

A top Communist Party member said, “Now as to the United Nations. If you were, let’s say, a building engineer and someone were to show you a set of blueprints about a certain building, you would know from those blueprints how that building was going to look. Organizational ‘blueprints’ can be read the same way. I need not be a member of the United Nations Secretariat to know that the UN “blueprint” is a Communist one. I was at the Moscow headquarters of the World Communist Party for nearly 3 years, and was also a leading party worker. I went to their colleges; I learned their pattern of operations, and if I see that pattern in effect anywhere, I can recognize it.”

British espionage authority Chapman Pincher stated: “Because of the protective cover they afford, all the major United Nations institutions have

been heavily penetrated. Whole books have been published listing the abuse and manipulation of the United Nations by the Soviets and their international financier backers. The area most blatantly used for active measures and espionage is the main headquarters in New York.”

In order to take over the military operations of sovereign countries, the **conspirators helped fuel the Soviet threat** so that countries would surrender their armies in the name of peace. **New conflicts are instigated** by conspirator-paid infiltrators, creating conflicts in populations that had existed in peace before. This continual turmoil throughout the globe requires more and more of the presence of the international “peacekeeping” United Nations forces. Instead of fighting between nations, there are continual internal conflicts.

March 6, 1992, *The New York Times*, in its article, “The New World Army” stated, “For years the United Nations has been notable mostly for its vocal chords. That’s changed. Nowadays the UN’s muscle—its blue-helmeted soldiers—seem to be everywhere. Never before have so many UN troops been committed to so many costly and diverse missions.”

Dr. V. Orval Watts wrote a book called *The United Nations: Planned Tyranny*. He cites several examples of simulated invasions and seizures of California cities, a Texas city, and a New York city by the United Nations.

March 10, 1962, the Institute for Defense Analysis released a report by Lincoln P. Bloomfield titled, “*A World Effectively Controlled by the United Nations*”. This stated, “A world effectively controlled by the United Nations is one in which ‘world government’ would come about through the establishment of super-national institutions, characterized by mandatory universal membership and some ability to employ physical force. Effective control would thus entail a preponderance of political power in the hands of a super-national organization. The overwhelming central fact would still be the loss of control of their military power by individual nations.”

Henry Kissinger, in a speech to the Bilderberger group on May 21, 1992, in Evian Frances, stated, “Today, Americans would be outraged if UN troops entered Los Angeles to restore order. Tomorrow, they will be grateful! This is especially true *if they were told* that there was an outside threat from beyond, *whether real or promulgated*, that threatened our very existence. It is then that peoples of the world will beg us to deliver them from this evil.

The one thing every one fears is the unknown. When presented with this scenario, individual rights will be willingly relinquished for the guarantee of their well being granted to them by the world government.” The Bilderbergers was a sister organization of the CFR with similar goals and funded by several one-world foundations, including the Rockefeller and Ford foundations.

The UN strategy has been to first create several regions throughout the world. Since this could not have been done politically without resistance, it has begun through the formation of the EEC and NAFTA. “European integration is our goal, and where the politicians have failed, we hope to succeed.” Giovanni Agnelli

The first chairman of the Bilderbergers, Prince Bernhard of the Netherlands, had this to say. “Here comes our greatest difficulty, for the governments of the free nations are elected by the people, and if they do something the people don’t like, they are thrown out. It is difficult to reeducate the people who have been brought up on nationalism to the idea of relinquishing part of their sovereignty to a super-national body.”

The International Monetary Fund/World Bank was created in 1944 by a group of international financiers and politicians. The chief drafters of the agreement made were John Maynard Keynes and Harry Dexter White. They were both followers of the Rothschilds, and also socialists. The plan of the conference was to take all of the world off of gold, which allows the international bankers to manipulate currencies freely. Also, the IMF would give loans to needy countries. When they couldn’t repay, members of the UN and IMF/World Bank, *primarily Americans, would pick up the tab in increased taxes.* This of course, would further weaken the United States, which was the original plan from 1776 on.

Warren T. Brookes in the *Boston Herald* of March 20, 1986 stated: “...the UN’s International Monetary Fund and the post-World War II monetary system has been working for almost half a century to create a centrally controlled economic system for the planet. *The IMF has also regularly created sufficient turmoil to topple governments and steer nations into the type of government-directed economic planning it favors.*”

In 1987, Senator Jesse Helms stated: “It is no secret that the international bankers profiteer from sovereign state debt. The New York banks have

found important profit centers in the lending to countries plunged into debt by socialist regimes. *Under socialist regime, countries go deeper and deeper into debt because socialism as an economic system does not work. International bankers are sophisticated enough to understand this phenomenon, and they are also sophisticated enough to profit by it.*”

John Maynard Keynes, one of the conspirators, wrote *The Economic Consequences of Peace*. In it he stated, “Lenin is said to have declared that the best ways to destroy the Capitalist system was to debauch the currency. By a continuing process of inflation, **governments can confiscate, secretly and unobserved**, an important part of the wealth of their citizens. By this method, they not only confiscate, but they confiscate arbitrarily, and while this *process impoverishes many*, it actually enriches some.”

“Lenin was certainly right. There is no subtler, no surer means of overturning the existing basis of society than to debauch the currency. The process engages all the hidden forces of economic law on the side of the destructors, and does it in a manner not one man in a million is able to diagnose.”

Economist Dan Smoot stated in 1979: “White’s Bretton Woods Conference set policies which our government has followed, without deviation, under all Presidents, since the end of World War II. These policies were intended to accomplish four major objectives:

1. Strip the United States of its monetary gold reserve by giving gold to other nations.
2. Build the industrial capacity of other nations, at our expense, to eliminate American productive superiority.
3. Take world markets—and much of the American domestic market—away from American producers to stop American domination of world trade.
4. Entwine American affairs with those of other nations until the United States could not have an independent policy, but would become an interdependent link in a worldwide socialist chain.”

Regarding Bretton Woods, Henry Hazlitt wrote of : “...the consequences of the decisions made by the representatives of the 45 nations at Bretton Woods. *These decisions and the institutions set up to carry them out, have led us to the present world monetary chaos*. For the first time in history,

every nation is on an inconvertible paper money basis. As a result, every nation is inflating (its currency), some at an appalling rate. *This has brought economic disruption, chronic unemployment, and anxiety, destitution, and despair to untold millions of families.* The world cannot get back to economic sanity until the IMF is abolished. We will not stop the growth of world inflation and world socialism until the institutions and policies adopted to promote them have been abolished.”

Both the Korean and Vietnam wars were created by the manipulation of the banking community for continued profits and world expansion. It was never the intended purpose to win the wars. That would have caused loss of Communist territory. A couple of statements concerning the Korean War are these. From Douglas MacArthur in *Reminiscences*, “(U.S. General Walton Walker) continually complained that his operations were known to the enemy in advance through sources in Washington.” Then, MacArthur quoted General Lin Piao, “I would never have made the attack and risked my men if I had not been assured that Washington would restrain General MacArthur from taking adequate retaliatory measures against my lines of supply and communications.”

General Stagemeyer, a general in the Air Force during the Korean War, said, “We had sufficient air, bombardment, fighters, reconnaissance, so that I could have taken out all of those supplies, those airdromes on the other side of the Yalu; I could have bombarded the devils between there and Mukden, stopped the railroad operating, and the people of China who were fighting could not have been supplied. But we weren’t permitted to do it. As a result, a lot of American blood was spilled over there in Korea.” (Article, “The Forgotten War in Korea” by William Hoar, *American Opinion*, November 1977, p. 18, as quoted in *Newswatch*, 6/1/99, pp. 13-14)

Meanwhile, during Eisenhower’s term in office, the president of the Socialist Party, who at the time was Norman Thomas, said, “The United States is making greater strides towards Socialism under Eisenhower than even under Roosevelt.”

The most significant event was the defeat of the Bricker Amendment. This stipulated that no treaty signed by the United States could override the Constitution. Stephen Ambrose, in his biography of Eisenhower, said, **“Eisenhower used all his persuasive powers...to kill the Bricker**

Amendment.” *If passed, it would have proven a definite blow to the conspirators.*

As stated earlier, both the Korean and Viet Nam Wars were planned events. Concerning Vietnam, the United States was sending supplies to the USSR, which in turn sent them to North Vietnam. Also, American were given inferior M-16 rifles which jammed, failed, and killed Americans.

Louisiana Congressman John Rarick had this to say about Viet Nam. “CBS tells the people that it wants them to know what is going on, and who is to blame. Why doesn’t CBS tell the American people about the CFR, and let the people decide whom to blame for the Vietnam fiasco: the planners and top decision-makers of a closely knit, financial control.”

President Lyndon Johnson was also controlled by this conspiracy. Here are a couple of quotes to compare.

President Lyndon Johnson: “We are going to take all the money we think is unnecessarily being spent and take it from the ‘haves’ and give it to the ‘have-nots’ that need it so much.”

The Communist Manifesto: “From each according to his ability, to each according to his need!”

The purpose of the Korean and Vietnam wars was to pull money from America and place it in the hands of the conspirators/communists, create profits for the bankers, allow further acquisition of territory for the communists, keep pushing America into Socialism, lend credibility to NATO, and establish a precedent for the U.S. fighting under UN authority.

The “Report From Iron Mountain” of 1966 was a confidential document prepared by a nine member U.S. Dept. of Defense group.

Here are some quotes of the general mentality of the report.

“Previous studies have taken the desirability of peace, the importance of human life, the superiority of democratic institutions, the greatest ‘good’ for the greatest number, the ‘dignity’ of the individual, the desirability of maximum health and longevity, and other such wishful premises as axiomatic values necessary for the justification of a study of peace issues.

We have not found them so. We have attempted to apply the standards of physical science to our thinking, the principal characteristic of which is not quantification, as is popularly believed, but that, in Whitehead's words, '...it ignores all judgments of value; for instance, all esthetic and moral judgments.'" (*Report from Iron Mountain*, pp. 13-14, as quoted in *The Creature...*p. 517.)

"The war system not only has been essential to the existence of nations as independent political entities, but has been equally indispensable to their stable political structure. Without it, no government has ever been able to obtain acquiescence in its 'legitimacy,' or right to rule its society. The historical record reveals one instance after another where the failure of a regime to maintain the credibility of a war threat led to its dissolution, by the forces of private interest, of reactions to social injustice, or of other disintegrative elements. The organization of society for the possibility of war is its principal political stabilizer. It has enabled societies to maintain necessary class distinctions, and it has insured the subordination of the citizens to the state by virtue of the residual war powers inherent in the concept of nationhood." (Leonard Lewin, ed., *Report from Iron Mountain on the Possibility and Desirability of Peace*, 1967, pp. 39, 81 as quoted in *The Creature...*, p. 517)

George Orwell, indicated in his novel, *1984*, that he understood the philosophy behind such things as *The Report From Iron Mountain*.

"The primary aim of modern warfare...is to use up the products of the machine without raising the general standard of living. [The 'machine' is society's technical and industrial capacity to produce goods.]...From the moment when the machine first made its appearance it was clear to all thinking people that the need for human drudgery, and therefore to a great extent for human inequality, had disappeared. If the machine were used deliberately for that end, hunger, overwork, dirt, illiteracy, and disease could be eliminated within a few generations...But it was also clear that an all-around increase in wealth threatened the destruction—indeed in some cases was the destruction—of a hierarchical society. In a world in which everyone worked short hours, had enough to eat, lived in a house...For if leisure and security were enjoyed by all alike, the great mass of human beings who are normally stupefied by poverty would become literate and learn to think for themselves; and when once they had done this, they sooner or later realize that the privileged minority had no function, and they would sweep it away.

In the long run, a hierarchical society was only possible on a basis of poverty and ignorance.... The essential act of war is destruction, not necessarily of human lives, but of the products of human labor. War is a way of shattering to pieces, or pouring into the stratosphere, or sinking into the depths of the sea, materials which might otherwise be used to make the masses too comfortable, and hence, in the long run, too intelligent.... In practice the needs of the population are always underestimated, with the result that there is a chronic shortage of half the necessities of life; but this is looked on as an advantage. It is deliberate policy to keep even the favored groups somewhere near the brink of hardship, because a general state of scarcity increases the importance of small privileges and thus magnifies the distinction between one group and another.... War, it will be seen, not only accomplishes the necessary destruction, but accomplishes it in a psychologically acceptable way. In principle it would be quite simple to waste the surplus labor of the world by building temples and pyramids, by digging holes and filling them up again, or even by producing vast quantities of goods and then setting fire to them. But this would provide only the economic and not the emotional basis for a hierarchical society... War, it will be seen, is now a pure internal affair.... waged by each ruling group against its own subjects, and the object of the war is not to make or prevent conquests of territory, but to keep the structure of society intact.” (George Orwell, 1984, pp. 153-164, as quoted in *The Creature...*, p. 558)

George Orwell’s thinking parallels a statement in *The Report from Iron Mountain*. “In advanced modern democratic societies, the war system...has served as the last great safeguard against the elimination of necessary social classes. As economic productivity increased to a level further and further above that of minimum subsistence, it becomes more and more difficult for a society to maintain distribution patterns insuring the existence of ‘hewers of wood and drawers of water.’...The arbitrary nature of war expenditures and of other military activities make them ideally suited to control these essential class relationships...The continuance of the war system must be assured, if for no other reason, among others, than to preserve whatever quality and degree of poverty a society requires as an incentive, as well as to maintain the stability of its internal organization of power.” (Lewin, *Report from Iron Mountain*, pp. 34-35, 40-41, as quoted in *The Creature...*p. 559)

“When asked how best to prepare for the advent of peace, we must first reply, as strongly as we can, that the war system cannot responsibly be allowed to disappear until 1) we know exactly what it is we plan to put in its

place, and 2) we are certain, beyond reasonable doubt, that these substitute institutions will serve their purposes.... It is far more questionable ...that [peace] would be desirable even if it were demonstrably attainable.” (*The Report from Iron Mountain*, pp. 88-90, as quoted in *The Creature...*, p. 560)

“Another possible surrogate for the control of potential enemies of society is the reintroduction, in some form consistent with modern technology and political processes, of slavery....It is entirely possible that the development of a sophisticated form of slavery may be an absolute prerequisite for social control in a world at peace. (*Report from Iron Mountain*, pp. 41-42, 68, 70, as quoted in *The Creature...*, p. 519).

“When it comes to postulating a credible substitute for war...the ‘alternate enemy’ must imply a more immediate, tangible, and directly felt threat of destruction. It must justify the need for taking and paying a “blood price” in wide areas of human concern. In this respect, the possible substitute enemies noted earlier would be insufficient. One exception might be the environmental-pollution model.... However unlikely some of the possible alternative enemies we have mentioned may seem, we must emphasize the one must be found of credible quality and magnitude, if a transition to peace is every to come about without social disintegration. It is more probable, in our judgment, that such a threat will have to be invented.” (*The Report from Iron Mountain*, pp. 66-67, 70-71, as quoted in *The Creature...*, p. 523)

“In searching for a new enemy to unite us, we came up with the idea that pollution, the threat of global warming, water shortages, famine and the like would fit the bill.... All these dangers are caused by human intervention....The real enemy, then, is humanity itself.” (Alexander King and Bertrand Schneider, *The First Global Revolution*, A Report by the Council of the Club of Rome, 1991, p. 115 as quoted in *The Creature...*, p. 528)

John Kenneth Galbraith, a Harvard professor who had been invited to participate in the report, wrote: “As I would put my personal repute behind the authenticity of this document, so would I testify to the validity of its conclusions. My reservations relate only to the wisdom of releasing it to an *obviously unconditioned* public.” (“News of War and Peace You’re Not Ready For,” by Herschel McLandress, *Book World*, in *The Washington Post*, November 26, 1967, p. 5, as quoted in *The Creature...*, p. 524)

The purpose of the “Report From Iron Mountain” was to come up with alternatives to war for controlling society.

The requirements that something would have to be fulfilled in this new alternative. This “something” would have to involve:

1. waste
2. operation outside normal supply and demand
3. a great threat
4. a logical excuse for compulsory service to the government

Possible alternatives were:

1. government health care
2. guaranteed annual income
3. space research programs
4. threat of pollution
5. compulsory military service
6. universal artificial insemination programs
7. massive social welfare program

The conclusion of the report?

“...no serious quantified studies have ever been conducted to determine the minimum levels of population destruction necessary to maintain war threat credibility under varying political conditions” and “optimal cyclical frequency of ‘shooting’ wars....”

Historian John Kenneth Galbraith of Harvard University stated, “As I would put my personal reputation behind the authenticity of this document, so would I testify to the validity of its conclusions.” (“News of War and Peace You’re Not Ready For,” by Herschel McLandress, *Book World*, in *The Washington Post*, November 26, 1967, p. 5, as quoted in *The Creature...p. 524*)

The Club of Rome, which was founded in April, 1968, was given the task of organizing the world into 10 economic and political kingdoms. The European Economic Community and NAFTA are the beginning.

Club of Rome member, Maurice Strong, who has held numerous posts within the United Nations, had a journalist Daniel Wood, at Strong’s private

ranch in southern Colorado (which at times has also hosted CFR David Rockefeller; Henry Kissinger; the founder of the World Bank Robert McNamara, the presidents of organizations such as IBM, Pan Am, and Harvard.” Strong tells a story he wishes to write in novel form. “As the plot unfolded, it became obvious that it was based on real people and real events. Wood continues the story:

“Each year, he explains as the background to the telling of the novel’s plot, the World Economic Forum convenes in Davos, Switzerland. Over a thousand CEOs, prime ministers, finance ministers, and leading academics gather in February to attend meetings and set economic agendas for the year ahead.... ‘This group of world leaders,’ he continues, ‘form a secret society to bring about an economic collapse. It’s February. They’re all at Davos. These aren’t terrorists. They’re *world leaders*. They have positioned themselves in the world’s commodity and stock markets. They’ve engineered, using their access to stock exchanges and computers and gold supplies, a panic. Then, they prevent the world’s stock markets from closing. They jam the gears. They hire mercenaries who hold the rest of the world leaders at Davos as hostages. The markets *can’t close*. The rich countries...’ And Strong makes a slight motion with his fingers as if he were flicking a cigarette butt out of the window. I sit there spellbound. This is not *any* storyteller talking, this is Maurice Strong. He knows these world leaders. He is, in fact, co-chairman of the Council of the World Economic Forum. He sits at the fulcrum of power. He is in a position to *do it*. ‘I probably shouldn’t be saying things like this,’ he says.” (“The Wizard of Baca Grande,” by Daniel Wood, *West* magazine, May, 1990, p. 35 as quoted in *The Creature*...p. 533)

Exposure of the Council of Foreign Relations went on during the 1950s and 1960s. By the 70s, Americans were beginning to realize that an elite minority controlled American industry. To overcome that image, money was fueled by the banking conspiracy into Japan and Arab nations, which were instructed to purchase American industry and real estate. A contrived oil crisis benefited the Arabs who drilled for oil. The Japanese, who made inexpensive fuel-efficient cars, also benefited. The conspiracy’s part in all this was hidden. If things didn’t go according to plans, there were now scapegoats.

The Trilateral Commission was formed by David Rockefeller in 1972. The purpose as stated by Senator Barry Goldwater in *With No Apologies*: “In my

view, the Trilateral Commission represents a skillful, coordinated effort to seize control and consolidate the four centers of power: political, monetary, the intellectual, and ecclesiastical. *What Trilateralists truly intend is the creation of a worldwide economic power superior to the political governments of the nation-states involved. As managers and creators of the system, they will rule the future.*”

A member of the Trilateral Commission, and advisor to President Jimmy Carter, Richard N. Gardener, stated, “An end run around national sovereignty, eroding it piece by piece, will accomplish far more than did the old fashioned frontal assaults.” (“The Hard Road to World Order,” *Foreign Affairs*, 1974, as quoted in *Newswatch*, 6/1/99, p. 20)

The October 12, 1977 issue of *Review of the News* states: “International Communism of the Moscow order has many features in common with David Rockefellers’ Trilateral Commission—such as undermining the national sovereignty of the United States.”

Another member of the Trilateral Commission, Zbigniew Brzezinski, had this to say in 1970 in his book, *Between Two Ages*: “...further progress will require *greater American sacrifices*. More intensive efforts to shape a new world monetary structure will have to be undertaken, with some consequent risk to the present relatively favorable American position.” “At the same time, the capacity to assert social and political control over the individual will vastly increase. It will soon be possible to assert almost continuous control over every citizen, and to maintain up-to-date files, containing even the most personal details about health and personal behavior of every citizen, in addition to the more customary data. These files will be subject to instantaneous retrieval by the authorities. Power will gravitate into the hands of those who control information.”

Edward Bernays, an associate of the conspirators, and who at one point held a top position at CBS, stated in his book, *Propaganda*, “We are governed, our minds are molded, our tastes formed, our ideas suggested, largely by men we have never heard of. Whatever attitude one chooses to take toward this condition, it remains a fact that in almost every act of our daily lives, whether in the sphere of politics or business, our social conduct or our ethical thinking, *we are dominated by a relatively small number of persons who understand the mental processes and social patterns of the masses*. It is

they who pull the wires which control the public mind, and who harness old social forces and contrive new ways to bind and guide the world.”

Dr. John Coleman, in *Conspirators Hierarchy*, states, “There is not one single aspect of life in America that is not watched over, steered in the ‘right’ direction, manipulated, and controlled by the invisible government...”

Zbigniew Brzezinski continues in his book, *Between Two Ages*: “Our existing institutions will be supplanted....This will encourage tendencies through the next several decades toward....a dictatorship—leaving even less room for political procedures as we know them.”

Brzezinski was President Carter’s national security advisor. Senator Barry Goldwater says about Carter, “David Rockefeller and Zbigniw Brzezinski found Jimmy Carter to be their ideal candidate. They helped him win the nomination and the presidency. To accomplish this purpose, they mobilized the money power of the Wall Street bankers, the intellectual influences of the academic community—which is subservient to the wealth of the great tax-free foundations—and the media controllers represented in the membership of the CFR and the Trilaterals.”

President Carter selected Paul Volcker as Chairman of the Federal Reserve Board. *Volcker supported one world government and said, “The standard of living of the average American has to decline. I don’t think you can escape that.”*

In *Shadows of Power*, James Perloff states, “One is hard pressed to find major Carter foreign policy decisions that served the interests of the American people or the free world.”

There is also a manipulation of agriculture (and weather through contrails—see websites) going on to gain global power. It is also a means of reducing population. There are classified reports of stockpiling of food in secret underground vaults and storage areas. So, if a food shortage is created for the average citizen (slave), the masters will survive.

In the *Arizona Republic* of July 20, 1992, “For 60 years the U.S. Department of Agriculture has waged war against increased farm production and lower

food prices. Since the adoption of the Agriculture Adjustment Act of 1933, the intent of the government's farm policy has been to organize scarcity."

The Trilateral Commission has been taking the last steps toward global world socialism. Roy Ash, an insider of the Nixon administration, said on May 18, 1972, "Within two decades the institutional framework for a World Economic Community will be in place [when] aspects of individual sovereignty will be given over to a super-national authority." [United Nations]

Congressman Larry McDonald attempted to expose what was going on and was killed in the conspiracy-planned downing of Korean Airlines Flight 0077.

Senator Jesse Helms attempted to expose what was going on. In a speech on December 15, 1987, he stated:

"This campaign against the American people, against traditional American culture and values, is systematic psychological warfare. It is orchestrated by a vast array of interests comprising not only the Eastern establishment, but also the radical left. *Among this group we find the Department of State, the Department of Commerce, the money center banks and multinational corporations, the media, the educational establishment, the entertainment industry, and the large tax-exempt foundations.*

"Mr. President, a careful examination of what is happening behind the scenes reveals that all of these interests are working in concert with the masters of the Kremlin in order to create what some refer to as a New World Order. Private organizations such as the Council on Foreign Relations, the Royal Institute of International Affairs, and the Bilderberger group, among others, serve to disseminate and to coordinate the plans for this so-called new world order in powerful business, financial, academic, and official circles.

"The psychological campaign that I am describing is the work of groups within the Eastern establishment, that amorphous amalgam of wealth and social connections whose power resided in its control over our financial system and over a large portion of our industrial sector. The principal instrument of this control over the American economy and money is the Federal Reserve System. The policies of the industrial sectors, primarily the

multinational corporations, are influenced by the money center banks through debt financing and through the large blocks of stock controlled by the trust departments of the money center banks.

“Anyone familiar with American history, and particularly American economic history, cannot fail to notice the control over the Department of State and the Central Intelligence Agency which Wall Street seems to exercise. The influence of establishment insiders over our foreign policy has become a fact of life in our time. The viewpoint of the establishment today is called ‘globalism.’ Not long ago, this viewpoint was called the ‘one world’ view by its critics.

“Mr. President, in the *globalist point of view*, nation-states and national boundaries do not count for anything. Indeed, even constitutions are irrelevant to the exercise of power. *All that matters to this club is the maximizations of profits resulting from the practice of what can be described as finance capitalism, a system which rests upon the twin pillars of debt and monopoly. It isn't real capitalism. It is the road to economic concentration and to political slavery.*” (Senator Jesse Helms, December 15, 1987)

“I believe there are more instances of the abridgement of the freedom of the people by gradual and silent encroachments of those in power than by violent and sudden usurpations.” James Madison

These encroachments have the final death hold on America today. Those who are aware are blackmailed or eliminated. President Kennedy, who was aware and part of the conspiracy, decided it was time to pull out. He signed Executive Order #11110. In *Vultures in Eagles Clothing*, Lynne Meredith explains this Order. “On June 4th, 1963, Executive Order #1110 authorized the issuance of 4 billion dollars in debt-free, un-borrowed United States Notes. These would have been United States Silver Certificates, redeemable in silver, against all silver bullion, silver, or standard silver dollars in the Treasury not then held for redemption of any outstanding Silver Certificates and to further coin standard silver dollars....”

Ten days before his assassination on November 22, 1963, Kennedy, at a speech at Columbia University, stated, “The high office of the President has been used to foment a plot to destroy the Americans’ freedom—and before I leave office, I must inform the Citizen of his plight!”

Lynne Meredith again writes: “After Kennedy’s assassination, one of the first Executive Orders of Lyndon Johnson, as the new president, was to rescind Kennedy’s Executive Order #11110, and have the Silver Certificates that had already been printed, destroyed....Then on July 23, 1965, in an act as unlawful as FDR’s gold robbery, Johnson signed a bill authorizing the issuance of copper coins to replace silver coins, and abolished all Silver Certificates.”

This is a violation of Article 1, Section 10 of the Constitution, “No State shall coin money, emit bills of credit, nor make anything but gold and silver coin a tender in payment of debts....”

What happened to the silver? The Coinage Act of 1965 stated “The Treasury is authorized to sell any silver in excess of that required to be held against outstanding ‘Silver Certificates’, for \$1.29 per troy ounce to the Federal Reserve.”

Lyndon Johnson again played to the tune of the conspirators. He upscaled the war in Viet Nam. He initiated the “Great Society” program and said, “We are going to take all the money we think is unnecessarily being spent, and take it from the ‘haves’, and give it to the ‘have-nots’ that need it so much.”

In 1980, at the Republican convention, Senator Barry Goldwater said, “This might be the last Republican convention, and in two weeks, the last Democratic convention. There are forces working against our country. They are selfish interests working against all Americans for their own gain.”

Prior to the 1980 Republican convention, Ronald Reagan said, “I think there is an elite in this country and they are the ones who run an elitist government. *They want a government by a handful of people because they don’t believe the people themselves can run their lives.* Are we going to have an elitist government that makes decisions for people’s lives, or are we going to believe as we have for so many decades, that the people can make these decisions for themselves?”

Nation newspaper on December 11, 1982, stated regarding the economy, “The blame for all this lies at the door of the Federal Reserve System—working as usual on behalf of the international banking cartel.”

G. Edward Griffen states regarding the Federal Reserve: “It is not stupidity that pays farmers to destroy their crops, or that purchases trillion-dollar weapons systems that are never deployed or in some cases never even completed. The overriding object behind most of these boondoggles is to waste the resources of the nation. The decline in living standards in the Western world is not the result of a widening gap between the ‘haves’ and the ‘have-nots’ as we are told. It is the result of a conscious plan to maintain and widen that gap. To that end, massive waste in governments spending is not an unfortunate by-product. It is the GOAL!”

“Never forget that the devil’s cleverest trick is to convince you that he does not exist.” Baudelaire

What about all the aid that has gone to Russia? Dimitri Manalusky, Professor at the Lenin School of Political Warfare in Moscow, 1930s Update, stated: “War to the hilt between Communism and Capitalism is inevitable. Today, of course, we are not strong enough to attack. Our time will come in thirty to forty years. To win, we will need the element of surprise. The western world will have to be put to sleep. So we shall begin by launching the most spectacular peace movement on record. There shall be electrifying overtures and unheard of concessions. The capitalist countries, stupid and decadent, will rejoice to cooperate, to their own destruction. They will leap at another chance to be friends. As soon as their [military] guard is down, we shall smash them with our clenched fist.” (*Newswatch*, 7/15/99)

General Sir Walter Walker, former NATO Commander-in-Chief said: “*I consider it my duty to tell you of the extremely dangerous threats that lie ahead. I know for certain that we are now in a period of the **greatest strategic deception**, perhaps in all history. The cold war is not over, only in a state of remission.*”

Soviet defector Anatoly Golitsyn states: “Convergence will be accompanied by blood baths and political re-education camps in Western Europe and the United States. The [conspirators] are counting on economic depression in the United States, and intend to introduce their reformed model of socialism with a human face as an alternative to the American system during the depression.”

William F. Jasper, in his article, “Deadly Deception—The Myth of the Collapse of Communism”, September, 1995, issue of the *New American*, writes: “The convergence strategy is already well on its way toward completion. A principle apostle of convergence, Mr. Gorbachev, has been given a prime piece of real estate for his ‘foundation,’ and is accorded the status of royalty. Soviet soldiers are being trained at our most advanced military bases by our elite forces. Soviet KGB officers are being welcomed into our police forces. Leading Soviet dis-information agents are given prime time to disgorge their slick ‘human face’ propaganda to American television audiences....It is not the reality of the enemy, nor the reality of the threat, which is being eroded, but the image only; the threat remains, more real than ever. Diabolical? Certainly. The Communists have ever shown their demonic capacity to mimic the deceptive techniques of the ‘father of lies.’ As the French poet Baudelaire admonished, ‘never forget that the devil’s cleverest trick is to convince you that he does not exist.’ Yes, he does exist, as do his demonic earthly minions who continue to use his deceitful wiles to spread their totalitarian empire across the globe under the rubric of the New World Order.”

“The people never give up their liberties but under some delusion.” Edmond Burke

So why don’t we hear about any of this through the media? It is because, with the exception of privately published material, the media, the publishing houses, the textbook publishing houses, all major newspapers and magazines are controlled by the conspiracy.

On February 9, 1917, Representative Callaway from Texas described what happened. He said: “In March, 1915, the J.P. Morgan interests, the steel, shipbuilding, and powder interests, and their subsidiary organizations, got together 12 men high up in the newspaper world and employed them to select the most influential newspapers in the United States and sufficient number of them to control generally the policy of the daily press....They found it was only necessary to purchase the control of 25 of the greatest papers...An agreement was reached; the policy of the papers was bought, to be paid for by the month; an editor was furnished for each paper to properly supervise and edit information regarding the questions of preparedness, militarism, financial policies, and other things of national and international nature considered vital to the interests of the purchasers.” (*Congressional Record*, Vol. 54, Feb 9, 1917, p. 2947 as quoted in *The Creature*...p. 244)

In 1953, Harry Elmer Barnes, a noted historian, described the inner workings of this censorship process.

“The *methods* followed by the various groups interested in *blacking out the truth* about world affairs since 1932 are numerous and ingenious. But, aside from subterranean persecution of individuals, they fall mainly into the following patterns or categories: 1) Excluding scholars suspected of revisionist views (in other words, patriotic views) from access to public documents which are freely opened to ‘court historians’, and other apologists for the foreign policy of President Franklin Roosevelt; 2) *Intimidating* publishers of books and periodicals, so that even those who might wish to publish books and articles setting forth the revisionist point of view, dare not to do so; 3) *Ignoring or obscuring* published material which embodies revisionist facts and arguments; and 4) *Smearing* revisionist authors and their books.

Leading members of the two largest publishing houses in the country have told me that, whatever their personal wishes in the circumstance, they would not feel it ethical to endanger their business and the property rights of their stockholders by publishing critical books relative to American foreign policy since 1933. And there is good reason for this hesitancy. The book clubs and the main sales outlets for books are controlled by powerful pressure groups, which are opposed to truth on such matters. These outlets not only refuse to market critical books in this field, but also threaten to boycott other books by those publishers who defy their blackout ultimatum.” *Perpetual War for Perpetual Peace*, Harry Elmer Barnes

Michael Parenti in his book, *Inventing Reality*, states: “Ten business and financial corporations control the three major television and radio networks (NBC, CBS, and ABC), 34 subsidiary television stations, 201 cable TV systems, 62 radio stations, 20 record companies, 59 magazines, 58 newspapers (*including the New York Times, the Washington Post, The Wall Street Journal, The Chicago Tribune, and the Los Angeles Times*), 41 book publishers, and numerous motion picture companies like Columbia, MGM, Universal, Warner Brothers, and Twentieth Century Fox. Three quarters of the major stockholders of ABC, CBS, and NBC are banks, such as Chase Manhattan, Morgan Guaranty Trust, Citibank, and Bank of America.”

“While having an abundance of numbers and giving an appearance of diversity, the mass media actually are highly centralized outlets that proffer

a remarkably homogenized fare. News services for dailies throughout the entire nation are provided by the Associated Press and the United Press International, the New York Times-Washington Post Wire Service, and several foreign wire services like Reuters. The ideological viewpoint of these news conduits are pretty much the same, marked by prefabricated standardization of news which is constricting and frightening.”

Ben H. Bagdikian in *The Media Monopoly* states: “The power to control information is a major lever in the control of society. Giving citizens a choice in ideas and information is as important as giving them a choice in politics. If a nation has narrowly controlled information, it will soon have narrowly controlled politics.”

In 1953, John Swinton, **editor of the *New York Times*** stated, (at a meeting of the Independent Press): “**There is no such thing, at this date of world’s history, as an independent press. You know it and I know it.** There is not one of you who dares write your honest opinions, and if you did, you know beforehand that it would never appear in print. I am paid weekly for keeping my honest opinions out of the paper I am connected with. Others of you are paid similar salaries for similar things, and if any of you would be so foolish as to write honest opinions [you] would be out on the streets looking for another job. If I allowed my honest opinion to appear in one issue of my paper, before 24 hours had elapsed my occupation would be gone.

The business of the journalist is to destroy the truth; to lie outright; to pervert, to vilify; to fawn at the feet of mammon; and to sell his country for his daily bread. You know it and I know it...and what folly is this—toasting an ‘independent press’? **We are the tools and vassals of the rich men behind the scenes.** We are the jumping jacks. They pull the strings and we dance. Our talents, our possibilities and our lives are all the property of other men. We are intellectual prostitutes!”

David Rockefeller, in June, 1991, in a speech to the Bilderbergers in Germany stated: “We are grateful to the *Washington Post*, *the New York Times*, *Time Magazine*, and other great publications, whose directors have attended our meetings and respected their promise of discretion for almost forty years. It would have been impossible for us to develop our plan for the world if we had been subject to the bright lights of publicity during these years....”

Not only is the media controlled, education is controlled too.

A document which defines this is *Silent Weapons for Quiet Wars*, Research Technical Manual, TM-SW7905.1.

“This manual is in itself an analog declaration of intent. Such a writing must be secured from public scrutiny. Otherwise it might be recognized as a *technically formal declaration of domestic war*. Furthermore, whenever any person or group of persons in a position of great power, and *without the consent of the public*, uses such knowledge and methodology for economic conquest – it must be understood that a state of domestic warfare exists between said person or group of persons and the public... (p. 3)

“In order to achieve a totally predictable economy, the lower class elements of the society must be brought under control, i.e., must be house-broken, trained and assigned a yoke, and long term social duties from a very early age, before they have the opportunity to question the propriety of the matter. In order to achieve such conformity, the lower class family unit must be disintegrated by a process of increasing preoccupation of the parents and the establishment of government operated day care centers for the occupationally orphaned children.

“The quality of education given to the lower class must be of the poorest sort, so that the moat of ignorance isolating the inferior class from the superior class is and remains incomprehensible to the inferior class. With such an initial handicap, even bright lower class individuals have little if any hope of extricating themselves from their assigned lot in life. This form of slavery is essential to maintaining some measure of social order, peace, and tranquility for the ruling upper class.” (p. 8)

The Rothschilds backed Cecil Rhodes who monopolized the gold and diamond industries of South Africa. He was an agent of the Rothschilds and also desired world domination. He wanted to found something to aid it, so he found the “Rhodes Scholarship” program to which he left his fortune at his death.

Carroll Quigley, in *Tragedy and Hope*, states: “The scholarships were merely a façade to conceal the secret society.” The scholarships are given to young people who then become indoctrinated into the Illuminati/Rothschilds philosophy. Bill Clinton is a Rhodes Scholar.

The Reece Committee, which did a study of major U.S. foundations such as Carnegie, Ford, Rhodes, and Rockefeller, and others, wrote that their studies: “leads one to the conclusion that there was, indeed, something in the nature of an actual conspiracy among certain leading educators in the United States to bring about Socialism through the use of our school systems. This movement was heavily financed by leading foundations.”

Congressman Eugene Cox similarly stated: “The Rockefeller Foundation’s funds have been used to finance individuals and organizations whose business it has been to get communism into the private and public schools of this country.”

This is the same philosophy as Hitler, who said, “When an opponent declares, ‘I will not come over to your side,’ I calmly say, ‘Your child belongs to us already. What are you? You will pass on. Your descendants, however, now stand in the new camp. In a short time they will know nothing else but this new community.’”

In 1969, the government-funded Commission of Mental Health and Children said in a report: “The school system, as the major socializing agency in the community, must assume a direct responsibility for the attitudes and values of child development.”

In 1973, Dr. Medford Evans, a researcher of the American education system, stated: “Government schools make it a matter of policy to spend as much money as possible, and to impart as little knowledge as possible, since spending money imparts power, **while keeping the scholars ignorant monopolizes power in the hands of the government insiders.**”

The American Opinion, May 30, 1977. “The only way to maintain control of the populations was to obtain control of education in the U.S. They realized this was a prodigious task, so they approached the Rockefeller Foundation with the suggestion that they form in tandem that portion of education which could be considered as domestically oriented be taken over by the Rockefeller Foundation, and that portion which was oriented to international matters be taken over by the Carnegie Endowment.

Concerning the Rockefeller foundation, “The purpose of the foundation was to use the power of money, *not to raise* the level of education in America, as

was widely believed at the time, *but to influence the direction* of that education. Specifically, it was to promote the ideology of collectivism and internationalism. The object was to use the classroom to teach attitudes that encourage people to be passive and submissive to their rulers. The goal was—and is—to create supervision but not enough to question authority or seek to rise above their class. True education was to be restricted to the sons and daughters of the elite. *For the rest, it would be better to produce skilled workers with no particular aspirations other than to enjoy life.*” (*The Creature from Jekyll Island*, p. 555)

At this point of the story we will take a pause. Time will not permit the blow by blow detail of every historical event bringing matters to this point. There are thousands of pages and hours of books, tapes, videos, articles, and internet information that bring out the point by point legal, political, and historical happenings that are hidden from public view. The information is abundantly there to study. It is beyond the parameters of this, or any book, to list it all. You can find it if you want to.

Instead, rather than continuing on with historical events continuing until the present day, a few ideas will be drawn together here.

Thomas Jefferson foresaw these days. In 1816, in a letter to Sam Kercheval he stated: “We must make our election between *economy and liberty*, or *profusion and servitude*. If we run into such debts as that we must be taxed in our meat and in our drink, in our necessities and our comforts, in our labors and our amusements, ...our people...must come to labor sixteen hours in the twenty-four, give our earnings of fifteen of these to the government,...have no time to think, no means of calling our mis-managers to account; but be glad to obtain sustenance by hiring ourselves out to rivet their chains on the necks of our fellow-sufferers...And this is the tendency of all human governments...till the bulk of society is reduced to be mere automatons of misery...And the forehorse of this frightful team is public debt. Taxation follow that, and in its train wretchedness and oppression.” (*Basic Writings*, pp. 749-50 as quoted in *The Creature...*pp. 553-554)

George Washington also expressed his grave concerns in his Farewell Address, delivered September 17, 1796.

He wished that “heaven may continue to give you the choicest tokens of its beneficence” and “...that the free Constitution which is the work of your hands may be sacredly maintained.... But as it is easy to foresee that from different causes, and from different quarters, much pain will be taken, many artifices employed, to weaken in your own minds the conviction of this truth....One method of assault may be to effect in the forms of the Constitution alterations which will impair the energy of this system, and thus to undermine what cannot be directly overthrown....The jealousy of a free people ought to be constantly awake, since history and experience prove that foreign influence is one of the most baneful foes of Republican government....Why forego the advantages of so peculiar situation? Why quit our own to stand upon foreign ground? Why, by interweaving our destiny with that of any part of Europe, entangle our peace and prosperity in the toils of European ambition, rivalry, interest, humor or caprice? ...It is our true policy to steer clear of permanent alliance with any portion of the foreign world...” (Farewell Address delivered by George Washington, September 17, 1796, as quoted in *Newswatch*, 4/15/99, pp. 7-8)

“In 1953 there was an investigation into whether there was an actual conspiracy against the government of the United States by Communists, therefore, the founders of the United Nations. The conclusions of the Senate Report were:

1. The Soviet international organization has carried on a successful and important penetration of the United States Government....
2. This penetration has extended from the lower ranks to the top-level policy and operating positions in our Government.
3. The agents of the penetration have operated in accordance with a distinct design...
4. Members of the CONSPIRACY helped to get each other into Government, helped each other to rise in Government and protected each other from exposure.
5. The General pattern of this penetration was first into agencies concerned with economic recovery, then the war-making agencies, then to agencies concerned with foreign policy and postwar planning, but always moving to the focal point of national concern.
6. In general, the Communists who infiltrated our Government worked behind the scenes—guiding research and preparing memoranda on which basic American policies were set, writing speeches for Cabinet officers,

influencing congressional investigation, drafting laws, manipulating administrative reorganizations....

7. Thousands of diplomatic, political, military, scientific, and economic secrets of the United States have been stolen.
8. Despite the fact that Federal Bureau of Investigation and other security agencies had reported extensive information about this Communist penetration, little was done by the Executive branch to interrupt the Soviet operatives in their ascent in Government.
9. Powerful groups and individuals within the Executive branch were at work obstructing and weakening the effort to eliminate Soviet agents from positions of Government.
10. Members of the CONSPIRACY repeatedly took SWORN OATHS denying Communist Party membership when seeking appointments, transfers, and promotions and these falsifications have, in virtually every case, gone unpunished.
11. The control that the American Communications Association, a Communist-direct union, maintains over communication lines vital to the national defense, poses a threat to the security of this country.
12. Policies and programs laid down by members of the Soviet conspiracy are still in effect within our Government and constitute a continuing hazard to our national security.” (Department of State Publication 7277, p. 49, as quoted in *Newswatch*, 9/1/98, pp. 17-18)

“Every Socialist/Communist government has always been a very brutal government. Every nation that has been overthrown for world government by International Communism has systematically eliminated by execution of firing squads or working on bread and water until collapse and death of exhaustion up to one-half of the population. The New World Order people use men and women to implement their world government agenda. When the nation that has been targeted has been overthrown, the political traitors of that country are executed along with those who resist. Why? They cannot be trusted. If they will be a traitor to their country, will they be to the New World Order? Those building the New World Order will not take a chance. All politicians and ministers will be eliminated. History bears it out.” (*Newswatch*, 9/15/99, p. 43)

DON'T GIVE UP YOUR GUNS

“President Clinton is trying to disarm America in *direct violation* of the *Constitution* that he swore an oath to preserve, protect, and defend. A policeman assigned to protect Clinton and British Prime Minister Tony Blair, “said he overheard Clinton and Blair discussing a ‘no-nonsense’ handgun ban to be imposed in Great Britain. According the bobby’s letter, Clinton’s precise comment to Blair was: *‘My situation is different. I’ve got the d--- Constitution to contend with; but if you get away with it without too much disturbance, I’ll figure out a way next year.’*” (Americans for Sane Policies, P.O. Box 1053, Cullman, AL 35056, as published in *Newswatch*, 9/1/98 p. 27)

“Killing is not good. We all know that. Our forefathers put the Second Amendment into the Constitution for one purpose—so Americans can protect themselves from a tyrannical government if it tries to impose itself upon us. The last part of the Communist/United Nations Rules for Revolution (listed earlier in this manuscript) is to DISARM THE PEOPLE—confiscate the private guns. Propaganda toward this end is the reason why all national TV networks and large daily newspapers and prestigious magazines coordinate their editorial material and have it ready when an event...takes place. The Chairmen of the Board of all these mass media are members of the subversive Council on Foreign Relations, Trilateral Commission and Bilderberger group that is working for world government—even the current president of the United States. All who come into public office are to take an oath to defend the Constitution from enemies from abroad or internal. How can they protect us from those enemies when they are part of the enemy? NONE DARE CALL IT TREASON?” (*Newswatch*, 10/1/98, p. 27)

And what’s after the recall of firearms, if Clinton can get away with it?

“A distinguished, retired military officer, winner of the Bronze Star and the Purple Heart, kept an audience of several hundred people on the edge of their seats in Spokane last month [June 1998]. Speaking at Cavanaugh’s Inn was Al Cuppett, Department of Defense veteran who spent six years on the Joint Chiefs of Staff. Cuppett presented electrifying documentation that the U.S. Constitution can now be *suspended without notice*. Cuppett discussed horrific EXECUTIVE ORDERS in the federal registry which authorize government to ignore the Bill of Rights, round up politically-incorrect

civilians for incarceration in labor camps and impose military dictatorship with the help of foreign troops.” “Cuppett said the framework of a totalitarian government has been created the Federal Emergency Management Agency [FEMA] and its military adjunct under guise of disaster preparedness. Cuppett noted that in 1994, Clinton signed EO 12919 which authorizes FEMA and the National Security Council to seize control of the nation under a state of emergency during which American could be stripped of both their rights and their property. FEMA itself is a creature of executive order....Cuppett reminded his audience that nearly forty years ago the U.S. State Department published a master plan for an authoritarian dictatorship. Published as official government policy, State Department Publication 7277 is title Freedom From War – The United States Program for General and Complete Disarmament in a Peaceful World. This document states that the United Nations is slated to become an ‘unchallengeable’ military force. It states that as the UN builds a global military machine capable of enforcing the ‘peace’ on all mankind: ‘The U.S. military must be COMPLETELY DISMANTLED, all U.S. citizens must be disarmed, all U.S. weapons must be surrendered to the UN military apparatus and an ARMED INTERNAL POLICE APPARATUS, subservient to the UN, must keep the ‘peace’ in the U.S.’....Under an unchallengeable UN dictatorship envisioned by 7277, FEMA is apparently slated to become the brains of America’s radical transformation. According to Cuppett, military forces comprised of alien troops and professional assassins may well provide the brawn. Cuppett noted that a military state in the U.S. would be possible only with the help of foreigners willing to fire on the American people if so ordered by the United Nations overlords. This is why our government is quietly authorizing the positioning of European, Russian, Chinese and Warsaw Pact troops throughout the U.S. He said that as Americans are GRADUALLY CONDITIONED to accept the skeletal framework of an alien-troop system, ‘troop fill’ will be the final step. Cuppett anticipates that our government will eventually, have imported sufficient troops under various exchange programs to keep the masses intimidated.... Cuppett said that many preparatory maneuvers preparatory for martial law are being carried out in national forest areas where even federal agents in charge of those lands are not permitted to go. This situation may tie into the UN Biodiversity land grab program through which federal lands can be shut off from public access. In such seclusion, foreign troops can be quietly trained for military rule....He said that many police and sheriffs departments are being sent police dogs that will respond to commands in foreign languages. He showed slides of signs being posted

across the U.S. that will direct foreign troops....Cuppett said that until all command installations are completed and until sufficient troops are in place, all preparations for martial law must be kept TOP SECRET. This is why! He noted most low-level government officials and bureaucrats have NO IDEA what is going on. Meantime, said Cuppett, America's military readiness is being so decimated that we are now nearly defenseless against external enemy attack. Cuppett warned that any emergency could trigger a FEMA declaration of martial law and the imposition of the kind of dictatorship outlined by 7277. He said the Agent Provocateurs are hard at work trying to stir up civil unrest and armed confrontations between various groups in America. According to Cuppett, in order precipitate martial law and effect mandatory gun confiscation as mandated by 7277, we must have crisis....Cuppett said that individuals and factions of the U.S. military which disapprove of the demonic plan for America's impending police state are being terminated. He said 3,000 military brass have died of heart attacks in the last two years, indicating that chemically-induced heart failure may be one way of eliminating loyal troops that might stand in the way of the plan for marital law. Cuppett said that TWA 800 SHOT DOWN OVER THE Atlantic was undoubtedly an assassination episode. He claimed that the missile attack was launched by a Black Hawk helicopter. The Black Hawk units are part of special forces networks working with FEMA. He said certain helicopters have jamming equipment which can prevent them from being seen on radar, which is why the TWA's attack copter did not appear on radar screens during the attack. Cuppett said it is not unusual for our government to sabotage a plane before takeoff if that plane is carry persons slated for execution. Cuppett documented an example of a military plane which recently had its fuel lines tampered [with] before it crashed, killing a number of our military personnel. He said Ron Brown's downed plane also sent a message loud and clear about what happens to those who cross the powers that be. He said that the hole in Brown's skull was probably made with an ice bullet, a clever tool which Intelligence used when it is necessary for the evidence to melt. Cuppett showed pictures of various penal [prison] facilities apparently being readied to house CIVILIAN detainees arrested under marital law. He showed a slide of an Amtrak facility with enclosed import decks which would allow train loads of detainees to be off-loaded under cover. He told of penal institutions throughout the U.S. which are now empty and awaiting political prisoners of the future. Cuppett charged that the frenetic 'war on drugs' is an excuse for building a gigantic, nationwide network of detainment camps to be used during a national crisis. He said Virginia has built 27 prisons in the last 5 years. He said several

prisons in California are nearly empty and maintain only a few guards and inmates as a front until the buildings are needed for a national crisis. He said one empty prison has 4,100 beds. Cuppett says his contacts have obtained copies of three hit lists being maintained by U.S. Intelligence. The lists are color-coded red, blue and green. These lists contain the names of people who might be rounded up when the time is right. Cuppett says there are 6.2 million Americans on the blue list alone. He noted that many upstanding citizens have been shocked to find their names on those lists. Thanks to Al Cuppett's eye-opening message, concerned citizens of the Northwest now have a clearer understanding.... (*The Idaho Observer*, article "Ex-Joint Chief Warns of Federal Tyranny," Vol. 2, No. 1, July 1998, p. 21 as quoted in *Newswatch*, 10/1/98, p. 22)

There was a lawyer who investigated behind-the-scenes happenings at Waco and came up with a 100 page document. A small amount of the material is quoted here. (as quoted in *Newswatch*, 1/1/00, pp. 12-15) To understand why he brings in this aspect of the CIA and mind control, he states in another part of the report his investigation showed that David Koresh had been an low-level CIA mind controlled individual who was not fully cooperating.

#15 Six Staged Murders in Pershing Park—2 Blocks from the White House:

"Another possible series of examples of the kind of *mind control* experimentation we have been discussing apparently occurred in Pershing Park, at 14th Street and Pennsylvania Avenue, in northwest Washington, D.C., across the street from the *Willard Hotel*, just two blocks from the White House. These occurred at the end of Reagan's 2nd term and the beginning of the Bush Administration. What happened here was the murder of six Black men – on each of six different occasions. According to the information I have received the dates of these six incidents were as follows:

1. June 10th, 1988, at approximately 7:900 p.m.
2. June 28th, 1988, at approximately 9:45 PM;
3. May 13th, 1989, at approximately 10:24 PM;
4. June 16th, 1989, at approximately 9:19 PM;
5. July 16th, 1989, at approximately 8:00 PM;
6. August 25th, 1989, at approximately 8:00 PM.

On each occasion, a Black man known only as “Sailor Hat”, because he was wearing a white sailor hat, came out of the District of Columbia Administration Building located nearby and walked over to Pershing Park. Upon entering Pershing Park, “Sailor Hat” huddled with the individual black man who was about to be killed and did the following: First, he talked to the man and/or gave him some sort of verbal instructions or signal; and Second, he also gave the man a swig of liquid out of what looked like a liquor bottle. It is conjectured that this liquid was some sort of a ‘cocktail’ – i.e., a mixture of alcohol and drugs – although nobody seems to know for sure what was in the bottle. After talking with “Sailor Hat,” receiving his instructions, and drinking his cocktail, the Black man who was about to be killed in EACH instance **immediately went berserk** and began “playing,” in a very belligerent, violent and predatory manner, the game of “Black Man’s Park” – meaning: ‘Pershing Park belongs to Black people, and, therefore, I am going to attack and beat “the living daylight” out of the first white person I see in or near the park.’ On each of these 6 occasions, the first white person this Black man encountered was Michael Fuller, the owner and operator of Wheels Across Washington, a horse-drawn-carriage limousine service, who maintained a stop where he picked up tourists for carriage rides at the far edge of Pershing Park, right across from the Willard Hotel. Michael Fuller’s background is rich and varied, but apparently includes a number of years in the covert operations section of the CIA where he may have served for some period as one of the CIA’s secret “hit” men. AT any rate, Michael Fuller is highly skilled in martial arts and hand-to-hand combat. When he was attacked by these five Black men, he was quickly and easily able to defend himself. On each occasion, he ultimately killed his Black attacker in self defense. On these first 5 occasion, no one seems to know the names of the five Black men whom Fuller killed in self-defense, or anything else about them. On the sixth occasion (August 25th, 1989), the Black man who huddled with, received instructions from, and took a swig of the “cocktail” from “Sailor Hat” was named John Wayne Tucker. Tucker was a huge man, standing about 6’2” tall and weighing about 300 pounds and extraordinarily strong. On this 6th occasion, before Tucker was able to reach Michael Fuller to attack him, Tucker came upon an innocent white bystander who just happened to be walking down the sidewalk adjoining the Park at that moment. Upon reaching this innocent bystander, Tucker immediately, viscously, and with NO provocation whatsoever, began beating “the living daylight” out of this white man. It included kicking him soundly in the crotch, injuring and frightening him to such an extent that he began screaming for help and running away as fast as he could. Fuller and a white

female District of Columbia Police Officer, Maria Weyraugh, who was a friend of Fuller's and a fellow horse enthusiast, who just happened to be cruising by the Park in her patrol car at that moment, both witnessed Tucker's attack on this innocent bystander. Both immediately telephone "911" (two separate calls from two different phones) to request emergency help from the D.C. Police Department. Before the D.C. Police could have possibly had time to respond to these calls, five squad cars immediately arrived on the scene from the U.S. Park Police Service, containing a large number of uniformed **Black Park Police Officers**. This response by the U.S. Park Police was highly unusual for a number of noteworthy reasons: First, the U.S. Park Police had NOT been called by either of the two witnesses at the scene – Fuller or Weyraugh – or by anyone else that they were aware; second, the U.S. Park Police arrived at the scene so quickly that they could NOT have had time to have been called by the D.C. Police Department's "911" dispatcher. In other words, the **only** possible explanation is that they arrived at the scene on cue – because of a special pre-arrangement. Third, the U.S. Park Police in the D.C. area is made up primarily of white officers. Thus the sudden arrival on the scene of a large number of Black Park Police Officers – when NO Park Police had been called at all – only heightened the incongruity of the situation; Fourth, and most important, the U.S. Park Police service is sometimes used a cover for CIA covert operations. Indeed, that appears to have been what was happening here. The response of these Black Park Police Officers to Tucker and their attempts to subdue him were also highly unusual. As stated already, Tucker was a huge man, extraordinarily strong, who fought ferociously to prevent these Park Police Officers from subduing him. He was throwing them off like flies, hurling them 10 feet or more into the middle of the street, and violently and unmercifully attacking any one who dared to approach him. The U.S. Park Police (Black or white) are NOT known for their kind and tolerant ways – especially when faced with trying to subdue a violent, super strong, suspect who is resisting arrest. If there was ever a time when the Park Police would have been justified in using extreme force – like the heavy handed "battling practice" used to subdue Rodney King in Los Angeles – this would have been the time. Both Fuller and Weyraugh would have backed them up 100%. In spite of Tucker's enormous strength and multiple resists and provocations, not a single one of these Black Park Police Officers drew his nightstick or used any weapon at all in their efforts to subdue Tucker. The result was that it took these officers a good 15 to 20 minutes to subdue Tucker, and that ultimately happened only when they finally wore him out. Then tragedy struck. One

of the Park Police Officers in subduing Tucker landed, accidentally, with his arm or elbow on Tucker's larynx, partially crushing it. Although Tucker was immediately rushed to the Emergency Room he died later that evening from his injury. NOTE WELL: The end result in all six of these incidents was that the Black man whom "Sailor Hat" had talked with, had given secret instructions to, and/or had given a secret "cocktail" to, then immediately went berserk attacking the first white person he encountered, for NO reason, and with NO provocation whatsoever – ended up being killed within just minutes after his encounter with "Sailor Hat." On all six occasions, "Sailor Hat" immediately returned to, and disappeared back inside the District of Columbia Administration Building located right near Pershing Park. On five of these occasions, the Black man was killed by a possible former CIA "hit" man in self-defense. On the sixth occasion, he was killed, accidentally, when a U.S. Park Police Officer landed his arm or elbow on his larynx partially crushing it while subduing him. On all six occasions, the Black man, who just minutes earlier had huddled with "Sailor Hat," was murdered – not by the person who ultimately brought his life to an end in self-defense, but by the person who had staged all six of these incidents from the very beginning. The most important fact concerning all six of these incidents is that there was an unmarked white TV camera van parked at the far end of Pershing Park, just a short distance from where Fuller and his horse-drawn carriage were positioned. This van, presumably manned by CIA personnel, was apparently filming all six of these incidents in their entirety, from start to finish. What you had here appears to be a CIA covert operation being conducted just two blocks from the White House, in which some of the secret mind control techniques we have been discussing were being tested on these six Black men – with the CIA's hidden cameras rolling the entire time – to determine if the Agency's programming techniques were sufficiently perfected to be used on "Manchurian-Candidate-type" robot assassins in foreign countries....Both Michael Fuller and Maria Weyrauch have paid a very heavy penalty for their attempts to "blow the whistle" – all of which merely underscores the extent to which the so called 'intelligence' community will go in order to bury the truth and those who seek to expose it concerning their secret mind control operations and the murderous ends for which those operations are frequently used. The Price Fuller has had to pay: Fullers' horse-draw-carriage limousine service was driven out of business through a combination of ...utterly trumped up charges...an utterly unconstitutional D.C. City ordinance with outlawed ONLY Fuller's horses and his horse-carriage business on the basis of the weight of his horses, while leaving in tact and creating a monopoly for his only competitor...

'cruelty to animals' charges against him...get this... by a federal Army Intelligence JAG brought in just to handle this one case! When Fuller and Weyraugh created a stink about these utterly trumped up charges and the fact that this Army Intelligence JAG was prosecuting them, most of the documents and evidence in the Court's files suddenly disappeared – including all reference to the Army Intelligence JAG's having been involved in the first place – and all charges were ultimately dismissed...The City ordinance outlawing Fuller's carriage service remained in full force and effect at least until 1993, with the result that he has been totally put out of business. In 1993, Fuller had been arrested and was being held in a Virginia jail without bail on apparently trumped up charges – simply to get him quiet and totally out of circulation. The Price Weyraugh has had to pay: When Weyraugh first began asking questions about these six murders in Pershing Park and demanding a full investigation, she was put on "Administrative Leave."...In Weyraugh's case, she was put on "Administrative Leave," but no charges were filed against her whatsoever...Later on, however, when she continued to demand an investigation of the six incidents in Pershing Park, and particularly when she began protesting the trumped up charges against Fuller and the City's unjust campaign to totally close down his carriage business for spurious reasons, she was again placed on "Administrative Leave." Again she was ordered to report to the Department's psychiatrist, and again directed to shut up about the six incidents and the treatment of Fuller. But when she refused to be silenced, the Department retaliated by placing her in an indefinite "Administrative Leave" limbo - but again, with no charges or specifications ever having been filed against her...The D.C. Police Department most recently (in 1993) has decided to try to terminate her employment and pension benefits on 'psychological' grounds – arguing that her "problems" with the Department over the previous 5 years had nothing to do with the Department's efforts to cover up the six incidents in Pershing Park and the treatment of Fuller, but instead relate solely to her being an "unstable" person who is no longer fit to be a police officer.

The more I (*Paul David Wilcher, Lawyer*) delve into the price Fuller and Weyraugh have had to pay for their "whistle blowing" activities, the more I become convinced that all this retaliatory and vindictive treatment is *being orchestrated behind the scenes* by persons in the so-called **intelligence community**, in order to cover with the tightest blanket of *secrecy* possible, the CIA'S *criminal use of these various mind control programming*

techniques and the **murderous purposes for which those techniques are often employed.**

From this incident it may be seen that “gun incidents” and “bombings” and other “random events” may not be as accidental as they are portrayed by the controlled media. It is obvious after reading the above that incidents can originate from some source other than what the media proclaims. “The government, controlled by Socialist, Communist Liberals, wants to get guns and ammunition out of the hands of American citizens, so America cannot resist the New World Order presently being established.” (*Newswatch*, 6/1/99, p. 3)

After sending this investigation to Janet Reno, one month later Paul Wilcher was found dead in his apartment.

At the beginning of his 100 page report he stated:

“I, (Paul David Wilcher, Lawyer) am fully aware, Attorney General Reno, that blowing the whistle on the serious government-wide corruption at issue here – even though it is the right thing to do – is by no means an easy thing to do, or something which should be done without a great deal of thought and prayerful consideration. As the *Psychology Today* article (that follows) points out, there is often a very high price – sometimes total devastation or even death – to be paid for blowing the whistle on evil, or being “an ethical resister.” But, as you can tell from my resume...I come from a strong moral background, have a deep and abiding personal faith, and have been a “whistle blower” concerning serious attorney, judicial, and governmental corruption on a number of occasions in the past. I have paid an enormous personal price for speaking the truth when those in positions of authority did not want to hear it. But the action I am undertaking here – blowing the whistle on the truth of what really happened in Waco on April 19, 1993, putting that ugly truth into its broader context, and presenting to you a detailed, comprehensive plan as to how that underlying system-wide corruption can finally be exposed and rooted out – this is something far more serious than I have ever done in the past. For in presenting all this to you, I am, quite literally, laying my life on the line. But in spite of the serious dangers involved, I have nevertheless decided to come forward and to present these matters to you because, as the courageous men and women quoted in the *Psychology Today* article said:

‘You are either going to be part of the corruption, or part of the forces working against it. There is NO third choice. Someone, someday, has to take a stand. If you don’t, maybe no one will. And that is wrong...’

‘I know that if I don’t DO something, nobody will...The only thing necessary for evil to prevail is for good men to do nothing...I feel that if I don’t do something, who will?’

‘Your conscience is something you deal with yourself. It is NOT a committee decision. It is whether you believe it is right or wrong – a question of religious faith. I am the one who is going to be held accountable by God for what I do with my life.’”

Let’s go back to the Illuminati, as it was originally called, for this is where we started picking up history. After the death of Weishaupt, “he passed the political revolutionary controls to Guisseppi Mazzini of Italy [1932]. He was joined by Albert Pike, head of the ancient and Accepted Scottish Rite of Freemasonry.” (*Newswatch* 1/1/98, p.3) “He was working hand-in-glove with Giuseppe Mazzini of Italy for world revolution as the leaders of the Illuminati. Albert Pike wrote an incredible letter to Mazzini on August 15, 1871, outlining the Luciferian plans for many revolutions and three world wars. This letter was for years on display in the British Museum Library in London, England. This plan was to be carried forward in the 20th Century. Pike state concerning this third world war: ‘We [the Illuminati and their agents] shall unleash the Nihilists and Atheists, and we shall provoke a formidable social cataclysm which in all its horror will show clearly to the nations the effect of absolute atheism, origin of slavery and the most bloody turmoil. Then everywhere, the citizens, obliged to defend themselves against the world minority of revolutionaries, will exterminate those destroyers of civilization, and the multitude, disillusioned with Christianity, whose deistic spirits will from that moment be without compass [direction], anxious for an idea, but without knowing where to render its adoration, will receive the pure light through the universal manifestation of the pure doctrine of Lucifer, brought finally out in the public view, a manifestation which will result from the general reactionary movement which will follow the destruction of Christianity and atheism, both conquered and exterminated at the same time.’” (*Newswatch*, 7/15/99, p. 27)

“There are those who can confirm what is written here on national television, in the New York Times, in the San Francisco Chronicle and who do not want their souls to go down to their death with the blemish of lie and deceit upon it and who want to clear the record for themselves and for their heirs and who will come forth and stand and state the truth at great sacrifice and price to themselves and all they own, but they recognize, that if they go into eternity with this lie upon their souls, the word is true, “What does it profit a man if he gain the whole world, and lose his own soul.” They will know the price is exceedingly high eternally, and they will not want to pay it.”
