Gary Condit U.S. Congressman

The California Democrat's former Intern Chandra Levy, was found dead in a Washington, D.C. park, and questions about their relationship - and his poor handling of the media frenzy that followed - led to Condit's defeat.

Brock Adams U.S. Senator

Washington Democrat didn't seek re-election to the Senate after eight women alleged misconduct that included harassment, sexual assault and rape.





The anti-gay rights Republican, a former State Senate Majority Leader, allegedly molested two young boys while serving as a law enforcement officer and scoutmaster, and sought to meet men on the Internet

Ted Kennedy U.S. Senator; presidential candidate

The Massachusetts Democrat has remained a major national political figure despite the Chappaquiddick incident, where his late brother's 29-year-old ex-staffer. Mary Jo Kopechne, drowned when a car Kennedy was driving went off a bridge. Kennedy pleaded guilty to leaving the scene of an accident; he received a two month suspended sentence.



Before he was a television celebrity Springer was a Mayor whose campaign the Democratic gubernatorial for nomination in Ohio was derailed by reports that he paid for a hooker using a personal check



Lyndon Johnson's longtime aide was forced to resign after being caught having sex with another man in a YMCA bathroom just before the 1964 presidential election.

The Utah Democrat was a one-term Congressman after he was arrested for soliciting two prostitutes – actually, both cops – in his home town of Salt Lake City.



The founding father had a long-term extramarital affair with Maria Reynolds, and was blackmailed by Reynolds' estranged husband.



The GOP state legislator was arrested for soliciting oral sex from a male undercover policeman. His defense: the cop was a "stocky black guy" and he gave him \$20 out of fear.



The Illinois Republican was censured by the House for having a sexual relationship with a 17-year-old female page. He lost his next election.



The California Republican was arrested for soliciting a prostitute during his first year in Congress. He's now in his $8^{\rm th}$ term.



The Mayor of Los Angeles announced last year that he was leaving his wife and was in a relationship with a TV News reporter who covered him.

Jon Grunseth Minnesota gubernatorial candidate

The GOP candidate for Governor of Minnesota in 1990 had to quit the race just weeks before Election Day after allegations that he had swum nude with a group 13-year-old girls during a swim party at his home.



The Massachusetts Democrat was censured by the House for engaging in a sexual relationship with a 16-year-old male House Page. He continued to win re-election.



New York's top Judge served jail time after making threatening phone calls to his former mistress and mailing a condom to her 16-year-old daughter.



The New York Democrat was charged with soliciting sex from a 16-year-old boy. He was re-elected two years later.



The Maryland Republican lost re-election after being charged with soliciting sex from a 16-year-old boy.



The Mississippi Republican was arrested for having oral sex in a House Men's Room. He admitted to a prior arrest for exposing himself to an undercover policeman at the lowa Jima Memorial.



The Mayor of San Francisco had an affair with the wife of his friend and campaign manager.



The former Governor of New Jersey is currently facing a lawsuit filed by an attorney in his law firm alleging that he sexually harassed her for several years.



Rudy Giuliani Mayor of New York, NY; presidential candidate

Details of an extramarital affair with his current wife helped derail his 2008 campaign for the GOP presidential nomination.



The Massachusetts Democrat was reprimanded by the House after his partner ran an escort service out of the Congressman's home.



The millionaire investment banker's U.S. Senate campaign against Barack Obama ended when his ex-wife, actress Jeri Ryan, alleged that he used to take her to sex clubs and urged that they have sex in public.



The Democratic Governor had an extramarital affair with a nursing home operator; after she broke it off, the state cited the nursing home with a bunch of violations.



The Virginia Democrats admitted to spending time with former Miss Virginia/ Playboy model Tai Collins and to getting a nude massage. He won re-election three years later.



The Democratic Assemblyman from Hudson County was shot and killed when a prostitute he had solicited tried to rob him, with the help of her pimps.



The Georgia Republican admitted to an extramarital affair with a staffer.



Rumors of extramarital affairs – and illegitimate children – didn't stop the GOP from nominating the Senator from Ohio for President in 1920.
