

Thomas Jefferson. Facts to Un-Brainwash.

The 20 volume set of 'The Writings of Thomas Jefferson' reproduced on this CD-ROM was originally published 1903-1905, that was before the falsification of American History extended beyond religious schools. This set was created under the supervision of Andrew A. Lipscomb, Editor-in-Chief, and the letters and writings reproduced in this set are as accurate as dedicated scholarship can produce. We have added a separate list of religious quotes from Jefferson, and hyperlinked these quotes to the letters in the various volumes of the set where the quotes are to be found. These are but a sampling of the quotes to be found throughout Jefferson's letters and writings, but they are typical of Jefferson's views on religion and the clergy.

Another book on this CD-ROM -- "American State Papers On Freedom In Religion" -- gives an excellent short history of the progress of the ideals of Religious Liberty in America, from Religious Establishment, and the intermingling of religion and politics under Puritan laws, to Religious Liberty as Established by the Constitution of the United States. The book includes a history of the continuous legal struggles to maintain Religious Liberty in the face of powerful and unscrupulous religious determination to destroy our Liberty, and again establish the dogmas of religious belief as the laws of our Land.

This CD-ROM has yet another book, "LETTERS AND ADDRESSES of THOMAS JEFFERSON," that contains some interesting observations of Mr. Jefferson and his writings.

The suppressions and revisions of Jefferson's religious beliefs are so extensive that no Historian could possibly document them all. The most glaring perversion is the out-of-context quote that appears around the Rotunda of the Jefferson Memorial in Washington, D.C., and this pious fraud is repeated on many Jefferson statues around our Nation -- The Jefferson statue in front of the Jefferson County Court House in Louisville Kentucky for example. A current exhibit, "Religion and the Founding of the American Republic," that is being presented by The Library of Congress is so blatant in its misrepresentation of American History that Bank of Wisdom issued its CD-ROM #7 -- "AMERICA; The Historic Facts" -- to expose this fraud by a trusted Government Institution.

One person outraged into action by this religious propaganda in the guise of American History was Lt. Col. Glen P. Goffin (USAF-Ret.). Col. Goffin did some research to find why the Library of Congress would present such a misrepresentation to the American public -- and through the Internet to the world, and also if those in charge of the Exhibition were aware of the glaring inaccuracies and omissions in the Exhibit. Col. Goffin's findings are very interesting.

Upon learning of the Bank of Wisdom CD-ROM exposing some of the inaccuracies in this Exhibit, Col. Goffin offered Bank of Wisdom his findings to publish. His "Essay of Indictment" is published on this CD-ROM. It names the official of the Library of Congress that was responsible for the Exhibition; includes the fact that 24 highly qualified scholars published a letter objecting to the historic inaccuracies of that official's interpretations of the Thomas Jefferson letter to the Danbury Baptists; and speculates on why this entire Exhibit of thinly disguised religious propaganda is being presented in the high profile manner that it is. Col. Goffin seems to answer his own speculations when he notes that the organizations that financed the Exhibit have specific religious goals as part of their philanthropic objectives.

It is time that Congress looked closely into the workings of their Library, and establish rigid rules to assure the accuracy and scholarship of the information and Exhibitions presented by that organization. If Col. Goffin's findings are correct, and I have no doubt but that they are, the first step should be the discharge of the person responsible for the "Religion and the Founding of the American Republic."
