THE PILGRIMS SOCIETY: PRIVACY POLICY

The Pilgrims Society is a not for profit membership organisation in the UK whose object is the promotion of Anglo-American good fellowship.

In order to fulfil its object and to deliver membership services the Society holds necessary personal information (or data) about its members. It is the Society's responsibility to keep this information safely and securely. The Society is also responsible for its website (www.pilgrimsociety.org).

The Society keeps the following personal information for each member:

- Full name with titles and any decorations, date of birth, gender, profession and marital status,
- Contact details: postal and email addresses and telephone numbers,
- Bank account details and Direct Debit mandate,
- Record of attendance at Society events and associated payments,
- Technical data acquired through the member's use of the Society's website and/or email correspondence with the Society.

In order to ensure that this personal information is accurate the Society asks members to inform it of any changes during their period of membership.

The Society uses this personal information to elect the individual to membership, to deliver the Society's services to him/her, to use the member's Direct Debit mandate to obtain payment for the advertised costs of the Society's services in a convenient way to him/her, and (on an aggregated, anonymised basis) to monitor the overall composition of the membership.

Access to the personal information of members is limited to the Executive Secretary, Officers and members of the Executive Committee of the Society; and as necessary to agents or contractors acting on the Society's instructions and under a duty of confidentiality.

In addition, the Society's website offers a password protected list of the Society's members (once they have given their consent) and a facility to members to post their own personal information and to make it accessible to other members if they wish.

The personal information of members controlled by the Society is set up to be protected from unauthorised access, including by other members, and will not be transferred to any third party or outside the United Kingdom and European Union.

The Society will delete the personal information of a member when his/her membership ceases, with the exception of the member's name which is kept for purposes of historical research.

Every member has a legal right to update, change or delete any or all of his/her personal information in the Society's records. A member wishing to do this is requested to contact the Executive Secretary in the first instance as it may affect the Society's ability to deliver its services to the member. If necessary a member has a right to complain at any time to the UK Information Commissioner's Office (www.ico.org.uk).
