In connection with captioned individual there are forwarded herewith as enclosures three pamphlets which were sent to this office by the Washington Field Office under date of 9/14/51. The Washington Field communication related that these pamphlets had been received by Mrs. JOHN R. APPLEWHITE, 950 North Hampton Drive, Silver Spring, Maryland. These pamphlets are apparently anti-Semitic in nature and mention the Aryan League of America, The American Policy Association, The American Research Council and the subject. Receipt of these pamphlets from Mrs. APPLEWHITE was acknowledged by the Washington Field Office.

## ROTHSCHILD-UNITED NATIONS

The Jewish bankers Rothschild, who rule the world, conceal their power through subsidiaries. The chief Rothschild group has the code name SOFINA. It is composed of the Central Banks of Europe, the Federal Reserve Bank of New York, the Chase National Bank, and the giant utility trusts. International Telephone and Telegraph, and International General Electric. Official representative of the Rothschilds was August Belmont, social arbiter of New York, after whom the Belmont Race-track was named. Belmont (Schoenberg) financed the New York subways, still controlled by Rothschilds through Kuhn-Loeb Co. Jacob Schiff, senior partner of Kuhn-Loeb Co., started with Max Warburg of Hamburg, chief German agents of the Rothschilds. During the First World War, Max Warburg was head of the German Secret Service, Sir Wm Wiseman of Kuhn-Loeb Co. was head of the British Secret Service, and Paul Warburg of Kuhn-Loeb was head of our Federal Reserve System. His son James Paul Warburg, was head of the Office of War Information 1942-44, now dictates our foreign policy through his agents the

Harrimans. So powerful are Rothschild agents that George Sokolsky noted in his book WE JEWS, 'Even in Hitler Germany the firm of Max Warburg is exempted from persecution.'

John D Rockefeller swallowed all competition because he had the Rothschild billions backing him, funds supplied by the National City Bank, (Kuhn-Loeb). The Rockefellers support Rothschild world government. The swindler and Rothschild agent J P Morgan donated millions to Harvard University, chief training or Zionists.

Enclosed herewith is a copy of a letter from Chicago to the Bureau dated August 15, 1952, entitled "Emergency Council of European Rabbis, Internal Security - C," together with a copy of the enclosure.

It appears that the enclosure was written by Eustace Clarence Mullins, whose address is 331 North Lewis Street, Staunton, Virginia. In view of the allegations contained in the attached enclosure, you are instructed to conduct a preliminary inquiry into the activities of Mullins and to thereafter advise the Bureau of the results together with your recommendations as to whether subject should be interviewed concerning the manner in which he received the attached enclosure alleging to be the speech of Rabbi Emanuel Rabinovich.

For the information of the Chicago Office, Bureau files reflect that Eustace Clarence Mullins was an informant in the case entitled "Richard Anthony Shimko, wa., Espionage - R, Theft of Government Property," (Bureau file 100-357518). Investigation was conducted by the Bureau from October, 1948, until March, 1950, but failed to substantiate any of the allegations made by subject against Shimko.

During the course of this investigation, Mullins advised that he met Shimko at Washington and Lee University, Lexington, Virginia, in October, 1947, and they decided to collaborate on an anti-Communist book about South America. Mullins stated that Shimko displayed to him what Shimko described as "hot" information of a highly confidential nature which he had gathered through his work in the Counter Intelligence Corps, Department of the Army. Mullins stated that Shimko was also desirous of forming a "spy center" in Lima, Peru, to disseminate political information to anyone who would pay for it. In June, 1948, Shimko, Mullins, and Shimko's sister went to San Miguel, Mexico, which Mullins

described as a center of the Spanish Loyalist refugees. Mullins said that Shimko associated there with international Communists and sought to influence Mullins not to write an anti-Communist book, and the partnership was dissolved. Mullins and Shimko had previously agreed to collaborate on an anti-Communist book. The investigation revealed that Shimko and Mullins did, in fact, have a disagreement over their collaboration on the book but failed to substantiate any of the foregoing subversive allegations. (100-357518-6, 10, 35)

By referenced letter from Richmond dated September 27, 1951, that office forwarded to the Bureau three printed items which had been received by the Richmond Office from the Washington Field Office under date of September 14, 1951. These pamphlets had been received from Mrs. John R. Applewhite, 950 North Hampton Drive, Silver Spring, Maryland, and were in the nature of anti-Semitic literature. One folder, purportedly published by the Aryan League of America, describes this organization as a nonprofit educational association which publishes and distributes literature on racial and economic questions. Membership was offered at one dollar. Forthcoming works were to include "Judas in the White House," "Who Owns America," and other "documented essays on treason in America." It was indicated that all communications should be addressed to Eustace Mullins, Director, Aryan League of America, 331 North Lewis Street, Staunton, Virginia. One printed article was headed "patriots, Prepare Yourselves!" with the subheading "Jews Are Betraying Us." This article purportedly originated with the Aryan League of America and the American Policy Association.

Bureau files contain no other information identifiable with Eustace Mullins, the Aryan League of America, or the American Policy Association. (105-15727)

On August 7, 1952, Mr. F. MARION POWELL, Chicago Area Director, Building Fund Campaign, Presbyterian Church in the U.S.A., Room 1307, 8 South Dearborn Street, Chicago, Illinois, furnished the following information to Special Agent HORACE H. WILLIS:

POWELL, a resident of Sharon, Pennsylvania, is employed by Ketchum, Inc., a Pennsylvania firm organized to conduct fund raising campaigns for any legitimate organization in the United States. POWELL is presently in Chicago assisting in the above-mentioned building fund campaign.

On August 6, 1952, MARGARET FUREZ, of the Hartford Secretarial Service, Room 808, 8 South Dearborn, temporarily employed by the Building Fund Campaign, Presbyterian Church, Room 1307 at the same Dearborn Street address, furnished POWELL a copy of an alleged speech supposedly delivered by Rabbi EMANUEL RABINOVICH before a special meeting of the Emergency Council of European Rabbis in Budapest, Hungary, January 12, 1952.

Miss FUREZ, who was also present during the interview, refused to furnish the identity of the source from which she obtained the attached memoranda. She said she regarded her source as reliable although she could not vouch for the reliability of the material furnished. She agreed, however, to attempt to ascertain the identity of EUSTACE MULLINS, whose name appears at the end of page two of this typewritten material, and advise this office.

The indices of the Chicago Office contain no information pertaining to EUSTACE MULLINS. Neither Mr. POWELL nor Miss FUREZ could furnish an opinion as to the authenticity of the data contained in this speech.

The material furnished by Mr. POWELL is being furnished for information purposes and no investigation in this matter is anticipated by the Chicago Division.

SPEECH OF RABBI EMANUEL RABINOVICH

The following is a speech of Rabbi Emanuel Rabinovich before a special meeting of the Emergency Council of European Rabbis in Budapest, Hungary, January 12, 1952:

"Greetings, ye children! You have been called here to recapitulate the principal steps of our new program. As you know, we had hoped to have twenty years between wars to consolidate the great gains which we made from World War II, but our increasing numbers in certain vital areas is arousing opposition to us, and we must now work with every means at our disposal to precipitate World War III within five years.

The goal for which we have striven so concertedly for three thousand years is at last within our reach, and because its fulfillment is so apparent, it behooves us to increase our efforts and our caution tenfold. I can safely promise you that before ten years have passed, our race will take its rightful place in the world, with every Jew a King and every Gentile a slave! (applause from the gathering.) You remember the success of our propagandist campaign during the 1930's, which aroused anti-American passions in Germany at the same time we were arousing anti-German passions in America, a campaign which culminated in the Second World War. A similar propagandist campaign is now being waged intensively throughout the world. A war fever is being worked up in Russia by an incessant anti-American barrage, while a nation wide anti-Communist scare is sweeping America. This campaign is forcing all of the smaller nations to choose between the partnership of Russia or an alliance with the United States.

Our most pressing problem at the moment is to inflame the lagging militaristic spirit of the Americans. (The failure of the Universal Military Training Act was a great setback to our plans, but we are assured that a suitable measure will be rushed through Congress immediately after the 1952 elections.) The Russian, as well as the Asiatic peoples, are well under control, and offer no objections to war, but we must wait to secure the Americans. This we hope to do with the issue of anti-Semitism, which worked so well in uniting the Americans against Germany.

(We are counting heavily on reports of anti-Semitic outrages in Russia to whip up indignation in the United States and produce a front of solidarity against the Soviet power. Simultaneously, to demonstrate to Americans the reality of anti-Semitism, we will advance through new sources large sums of money to outspokenly anti-Semitic elements in America to increase their effectiveness, and we shall stage anti-Semitic outbreaks in several of their largest cities. This will serve the double purpose of exposing reactionary sectors in America, which then can be silenced, and of welding the United States into a devoted anti-Russian unit.)

Within five years, this program will achieve its objective, the Third World War, which will surpass in destruction all previous contests. Israel, of course, will remain neutral, and when both sides are devastated and exhausted, we will arbitrate, sending our Control Commissions into all of the wrecked countries. This war will end for all time our struggle against the Gentiles. We will openly reveal our identity with the races of Asia and Africa. I can state with assurance that the last generation of white children is now being born. Our Control Commissions will, in the interests of peace and wiping out inter-racial tensions, forbid the whites to mate with whites. The white women must cohabit with members of the dark races, and the white men with black women. Thus the white race will disappear, for mixing the dark with the white means the end.

of the white man, and our most dangerous enemy will become only a memory. We shall embark upon an era of ten thousand years of peace and plenty, the Pax Judaica, and our race will rule undisputed over the earth. Our superior intelligence will easily enable us to retain mastery over a world of dark peoples.

(Question from gathering) Rabbi Rabinovich, what about the various religions after the Third World War?

RABINOVICH: There will be no more religions. Not only would the existence of a priest class remain a constant danger to our rule, but belief in an after-life would give spiritual strength to irreconcilable elements in many countries, and enable them to resist us. We will, however, retain the rituals and customs of Judaism as the mark of our hereditary ruling class, strengthening our racial laws so that no Jew will be allowed to marry outside our race, nor will any stranger be accepted by us.

We may have to repeat the grim days of World War II, when we were forced to let the Hitlerite bandits sacrifice some of our people, in order that we may have adequate documentation and witnesses to legally justify our trial and execution of the leaders of America and Russia as war criminals, after we have dictated the peace. I am sure you will need little preparation for such a duty, for sacrifice has always been the watchword of our people, and the death of a few thousand Jews in exchange for world leadership is indeed a small price to pay.

To convince you of the certainty of that leadership, let me point out to you how we have turned all of the inventions of the white man into weapons against him. His printing presses and radios are the mouth pieces of our desires, and his heavy industry manufactures the instruments which he sends out to arm Asia and Africa against him. Our interests in Washington are greatly extending the Point Four Program for developing industry in backward areas of the world so that after the industrial plants and cities of Europe and America are destroyed by atomic warfare, the whites can offer no resistance against the larger masses of the dark races, who will maintain an unchallenged technological superiority.

And so, with the vision of world victory before you, go back to your countries and intensify your good work, until that approaching day when Israel will reveal herself in all her glorious destiny as the Light of the World!"

This transcription of Rabinovich's speech was given me by a former Bulgarian diplomat who broke with the Communist regime and reached Budapest, Hungary, where he hid out with anti-Communist friends until March. While there, he obtained a copy of this speech, and was then smuggled to Hamburg, Germany, finally making his way to this country. A gentleman in Hamburg gave him my name, and he met me two days ago and urged me to distribute this speech at once. I sincerely hope that it will give the American people a better picture of the force arrayed against them.

Note: Mullins has previously been contacted by the Bureau but his reliability may be questionable as he appears to be a fanatic on the subject of opposing Communism. The Chicago Office furnished the Bureau with a copy of a purported speech made by Rabbi Emanuel Rabinovich in Budapest Hungary 1-12-52, indicating that the Jewish people have a plan to provoke a third world war with the hope of becoming the controlling race following such a war. The authenticity of this document may well be questioned and it is therefore felt Mullins whose name appeared on the document should be questioned for details regarding the authenticity of same.

On 11-13-52 Mr. JOHN E. JESTER of 803 St. Christopher's Road, Richmond, Virginia, forwarded to this office a letter which had been received by him postmarked November 10, 1952 in Washington, D. C. The envelope bore no return address. Enclosed in this envelope was what appeared to be a copy of an alleged speech supposedly delivered by Rabbi EMANUEL KABINOVICH before a special meeting of the Emergency Council of European Rabbis in Budapest, Hungary, January 12, 1952. It is noted that this speech is indicated as being reported by EUSTACE MULLINS May 14, 1952. Attention is directed to the enclosure which accompanied referenced letter and it appears that the material supplied this office by Mr. JESTER is identical to that received by the Chicago Office as indicated in their letter to the Bureau dated 8-15-52 under the title of "Emergency Council of European Rabbis, Internal Security - C".

The material furnished by Mr. JESTER is being retained as an exhibit and is not being forwarded herewith inasmuch as it is a duplicate of material already supplied the Bureau by the Chicago Office.

Investigation at Staunton, Virginia reflects that EUSTACE CLARENCE MULLINS, JR. has not resided at the home of his father for any length of time since approximately 1947 or since leaving Washington and Lee University. His father's address is 331 North Lewis Street, Staunton, Virginia and he evidently has claimed this as his legal address since he started traveling around the country.

Mr. E. G. KYLE, Justice of the Peace for the City of Staunton, advised that his brother, E. E. MULLINS, is the Manager of the Krogers Grocery Store in Staunton and often discusses the activities of the subject. He informed that E. E. MULLINS recently told him that EUSTACE MULLINS had written to his brother in Staunton recently as October 6, 1952 from New York City at which time he forwarded a book to him entitled, "Can the Police Protect Us". Mr. KYLE mentioned that E. E. MULLINS claimed that this book was written by a Major WILLIAMS. He said that MULLINS claimed his brother told him that he was starting on a new campaign to expose the Communists in

this country, but did not relate by what means that he intended to carry out his work. He gave subject's recent address as 526 East 6th Street, New York 9, New York. Mr. KYLE advised that he has never heard anything that would reflect against the reliability or loyalty of subject MULLINS and believes that he would be willing to do anything that he could to help the FBI. He mentioned, however, that due to the fact that he has spent little time in Staunton, Virginia since 1947, very few people, if any, know of his recent activities and no one apparently knows what he is doing at the present time, except his brother and he is not positive.

Captain R. R. CLINE of the Staunton, Virginia Police Department, advised that EUSTACE CLARENCE MULLINS has not lived in the Staunton area for a number of years, but has visited with his father and brother on several occasions since graduating from college. He also advised that EUSTACE MULLINS impressed him as being a very intelligent young man despite the fact that he has apparently become a fanatic on writing about the Communists. CLINE informed that he has no reason to question the loyalty of EUSTACE CLARENCE MULLINS and believes that he would be very cooperative if called upon for any information by the Federal Bureau of Investigation.

Lieutenant R. R. LYNN of the Virginia State Police, Staunton, Virginia, was contacted and furnished substantially the same information as given by Captain CLINE.

It is the opinion of this office the subject should be interviewed concerning the manner in which he received the alleged speech of Rabbi EMANUEL RABINOVICH.

As noted above, subject's address is now 526 East 6th Street, New York City. *RUC*

ATTENTION SAC: For your information the speech of Rabbi Emanuel Rabinovich being distributed by Eustace Mullins has been brought to the Bureau's attention in the past and has been used as anti-Semitic propaganda on numerous occasions. Bufiles reflect the name of one Eustace Clarence Mullens who was the original informant in the Espionage-R case of Richard Anthony Shimko in 1949. This Mullens and Shimko traveled in Mexico in conjunction with a book they were writing with a Latin American background, said to be anti-Communist in nature. It is not known if Mullens and Mullins are identical. (100-357518-28, page 4, and 31, page 4.)

Enclosed herewith find one mimeograph copy of the alleged speech of Rabbi EMANUEL RABINOVICH referred to in reference letter.

The following background data as to MULLINS appears in our file and is supplementary to the background data set forth in letter from Richmond to the Bureau dated 11-28-52, copy of which was provided your office by the Bureau as an enclosure with the referenced letter:

EUSTACE CLARENCE MULLINS was an informant in the case entitled RICHARD ANTHONY SHIMKO, wa, ESPIONAGE-R, Bufile 100-357518. Investigation was conducted by the Bureau in this case from October, 1948 until March, 1950 but failed to substantiate any of the allegations made by MULLINS against SHIMKO. During the course of this investigation MULLINS advised that he met SHIMKO at Washington & Lee University, Lexington, Va. in October, 1947 and they decided to collaborate on an anti-Communist book about South America. MULLINS stated that SHIMKO displayed to him what SHIMKO described as "hot" information of a highly confidential nature which he had gathered through his work in the Counter Intelligence Corps, Dept. of the Army. MULLINS stated that SHIMKO was also desirous of forming a "spy center" in Lima, Peru to disseminate political information to anyone who would pay for it. In June, 1948 SHIMKO, MULLINS and SHIMKO'S sister went to San Miguel, Mexico which MULLINS described as a center of the Spanish Loyalist refugees. MULLINS said that SHIMKO associated there with international Communists and sought to influence MULLINS not to write an anti-Communist book, and the partnership was dissolved. The investigation revealed that SHIMKO and MULLINS did, in fact, have a disagreement over their collaboration on the book but failed to substantiate any of the foregoing subversive allegations.

By letter dated 9-14-51 the Washington Field Office provided the Richmond Office with three pamphlets they had received from Mrs. JOHN R. APPLEWHITE, 950 North Hampton Drive, Silver Springs, Md. These pamphlets were in the nature of anti-Semitic literature and how, and for whom, Mrs. APPLEWHITE received the literature is unknown. One folder, purportedly published by the Aryan League of America, describes this organization as a nonprofit educational association which publishes and distributes literature on racial and economic questions. Membership was offered at one dollar. Forthcoming works were to include "Judas in the White House", "Who Owns America", and other "documented essays on treason in America". It was indicated that any communications should be

addressed to EUSTACE MULLINS, Director, Aryan League of America, 331 North Lewis Street, Staunton, Va. One printed article was headed "Patriots, Prepare Yourselves!", with the subheading "Jews Are Betraying Us". This article purportedly originated with the Aryan League of America and the American Policy Association.

On 8/7/52 Mr. F. MARION POWELL, Chicago Area Director, Building Fund Campaign, Presbyterian Church in the U.S.A., Room 1307, 8 South Dearborn Street, Chicago, Ill. delivered to the Chicago Office a copy of the alleged speech made by Rabbi RABINOVICH. Mr. POWELL received the same from MARGARET FUREZ, Hartford Secretarial Service, who refused to reveal the source from which she obtained the same.

On 11/13/52 Mr. JOHN F. LESTER, 803 St. Christopher's Road, Richmond, Va. forwarded to the Richmond Office a copy of this same purported speech stating he had received the same through the mail in an envelope postmarked 11/10/52 at Washington, D.C. but with no return address. The Chicago Office also received a copy of this purported speech in an anonymous letter received on 11/25/52.

With respect to the referenced O-1 form, the Bureau is referred to the O-1 form received at New York on 5/27/53, returned 6/1/53 designating that a report will be submitted by 6/30/53.

Investigation in instant case has been completed and a communication reflecting results of investigation is in transcription at the NYO. An administrative delay at the conclusion of investigation has been experienced in this case, inasmuch as approximately fifty articles authored by the subject had to be photostated at New York for transmittal to the Bureau.

The above mentioned articles were received from the Anti-Defamation League of B'Nai B'Rith, located in New York; said organization maintaining files on individuals who author anti-semitic literature. The specific request of the Bureau in this case was that the NYO should determine where the subject obtained a copy of the speech allegedly delivered by RABBI EMANUEL RABINOVICH, before a meeting of the Emergency Council of European Rabbis in Budapest, Hungary, on 1/12/52. MR. SIDNEY ROSE, Director, Eastern Regional Fact Finding Committee, B'Nai B'Rith, New York, has advised that he has done considerable research on this RABINOVICH speech and it is his personal, unofficial opinion that there never was such a speech delivered in Budapest on 1/12/52, but rather the subject wrote the speech himself to use it as material in furtherance of his own aims.

It is the opinion of the NYO, after a review of the articles written by the subject, that there is no violation in this case over which the Bureau has jurisdiction, nor would this material be of interest to other government agencies. It appears that the subject is an avid anti-semitic individual; beyond that, an evaluation is difficult to make.

As an enclosure to instant letter, six pages are attached of photostats of the B'Nai B'Rith indices cards. These pages represent thumb-nail sketches of the articles written by the subject, and of information about him. Where it states " See anti-lit file", that is the material presently being photostated at New York. Where it states " FREEMAN to EB " or " BRODY to SAR ", this is oral information, that cannot be documented. In the light of the information developed, the subject has not been interviewed, as it is felt that the opinion of the Bureau is desired first. The subject is in association with one MR. WEST HOOKER, 853 Seventh Avenue, New York City; both individuals believed to be starting anti-semitic feeling through meetings in Marchmont, New York. ( According to B'Nai B'Rith information.)

The referenced O-1 form has been deleted. Photostating of this material will be completed 6/30/53, and upon transcription of all information, all data will be forwarded to the Bureau for its evaluation and decision.

On 6/16/53 SA GEORGE L. PAYNE, Jr., New York office, conducted the following investigation on the above captioned individual.

A pretext telephone call to the apartment house at 526 East 6th St., New York City, determined that the residence is owned by the JOHN PETERS Real Estate Firm, 210 East 14 Street, New York, New York. Mr. GEORGE FAY, representing the Peters firm, advised at his office that he has never personally heard of the subject; a review of his records failed to disclose that any individual named MULLINS had ever resided at 526 East 6th Street, New York City. Mr. FAY advanced the possibility that the subject could have roomed with some resident of the premises, without the Peters firm being away of it.

On 6/16/53 Mrs. E. BILANUCK, operator of a candy store at 526 East 6th Street, advised that she collects the rentals for the Peters firm, and that to her knowledge no individual by the name of MULLINS ever resided with the apartment house. As a matter of information, Mrs. BILANUCK volunteered the information that the rentals for the apartments amounted to from nine to eleven dollars per month, and thus the management could not afford to keep too close tabs on the activities within the apartment.

Mrs. BILANUCK, who speaks very little English, did recall that the only single male that has lived in the apartment for some time was one FRED J. KASPER, Jr., who resided in apartment 14. She recalled that upon three separate occasions an unidentified male, height approximately 6', blonde hair, who spoke with a Southern accent, did stay with KASPER, but has not been seen in the area for approximately six months. She could offer no additional information relative to the individual, that conceivably could be the subject.

Mr. GEORGE FAY, of the John Peters Real Estate Firm, advised on 6/16/53, that FRED J. KASPER, Jr., left the apartment during January, 1953. Mr. FAY stated he knows KASPER's present address to be 711 8th Street, SE, Washington, D.C. Mr. FAY could offer no information relative to KASPER, or his possible association with the subject.

Inasmuch as the subject is allegedly authoring anti-semitic literature interviews were conducted by SA PAYNE at the Anti-Defamation League of B'nai B'rith, 212 Fifth Avenue, New York, New York on 6/18/53. Mr. JACK BAKER, Director of Information, ADL, advised that the ADL is quite cognizant of the activities of the subject, and maintains an extensive file containing all the published articles by the subject, and maintains as well, all background information that ADL is able to secure.

Mr. BAKER furnished the following characterization of MULLINS:

"EUSTACE MULLINS is a frequent contributor to much of the lunatic fringe press such as 'The Broom' and the 'National Renaissance Bulletin'. MULLINS was discharged from a minor position with the Library of Congress for admitted authorship of racist material. He has been the disseminator of a fraudulent speech of RABBI EMANUEL RABINOVICH, paraphrasing the notorious forgery known as 'Protocols of the Elders of Zion'".

Mr. SIDNEY ROSE, Director, Eastern Regional Fact Finding Committee, ADL, B'Nai B'Rith (a former New York City Detective for 14 years) advised that he has done considerable research on the alleged RABBI RABINOVICH speech in Hungary on 1/12/52, as well as closely following the activities of the subject. Mr. ROSE advised that it is his personal, unofficial opinion that there never was such a speech delivered by RABINOVICH, and that the subject authored the speech himself to be used in furtherance of his own aims.

With respect to the whereabouts of the subject at this time, both Mr. ROSE and Mr. BAKER advised that he can be located through Mr. JESSE HOOKER, Film Network, Inc., 853 7th Avenue, New York, New York. According to ROSE, HOOKER is quite wealthy, and is interested in the activities of the subject, and is thus financing his endeavours.

The subject is reported to spend a considerable amount of time at HOOKER's residence in Larchmont, New York, where both individuals are starting an anti-semitic movement. BAKER and ROSE have further stated that there is to be a mass meeting conducted by the subject and HOOKER on 7/10/53 at Larchmont, New York. Details of the nature of this meeting are not known.

The ADL maintains indices cards on all the articles that the subject has published. Photostats of these indices cards have been sent to the Bureau under date of 6/29/53. References on these indices cards refer to the complete articles, which have been photostated from copies of the "Broom" and the "Women's Circle" newspapers, as loaned to the New York office by ADL. These photostats are attached as enclosures to instant letter.

Original instructions of the Bureau were to interview the subject relative to where he obtained the copy of the alleged RABBI RABONOVICH speech. In view of the material uncovered on the subject, it is deemed more advisable by the New York office to forward all information to the Bureau for its reconsideration and decision, prior to an approach of the subject. Accordingly, the New York office is placing this matter in a closed status pending receipt of further instructions from the Bureau.



## ATTENTION READERS!

Attempts have been made to boycott our indoor political mass meetings in Yorkville, the German section of New York City. Owners of meeting halls have refused to rent them to the National Renaissance Party on grounds that their beer licenses might be revoked by Jewish Civil Officials. On August 20, 1954, Mr. HARRY L. SMITH, Office of Public Information, Virginia State Highway Department, 1221 East Broad Street, Richmond, Va., made available to this office copies of several issues of "Common Sense" which were mailed to him from P.O. Box 807 Union, New Jersey. SMITH advised that he believed that EUSTACE MULLINS was the person responsible for mailing him copies of the publication as he noted that the June 15, 1954, and July 1, 1954, issues of "Common Sense" carried articles by EUSTACE MULLINS.

SMITH continued that he is acquainted with MULLINS having formerly worked for MULLINS' father at Staunton, Va. He advised that MULLINS is single, approximately 35 years of age and he has had spotty contacts with him since 1940. He advised that MULLINS was in the U.S. Army Air Corps and after World War II worked for a period of time in Washington, D.C., for the "Times Herald". He recalled that MULLINS went to Mexico to do some articles on communist activities and that he spent a considerable amount of time in a small place just out of Mexico City.

SMITH continued that MULLINS also did a biography on ERZA POUND, however, he does not believe that this book was ever published.

SMITH recalled that while at Washington, D.C., MULLINS started one or two publications but did not make a go of them and approximately six or eight months ago he received a letter from MULLINS which was written on the stationery of the Petroleum Institute, New York City. He continued that in this last letter MULLINS stated that he has worked for Senator McCARTHY briefly and he commented in referring to McCARTHY that newspapers had succeeded in "making a man out of a shadow".

SMITH related that he did not know who was financing MULLINS in his operations and advised that this was the first time he had ever read any of his publications and he was surprised how rabid and biased the articles were. SMITH pointed out that included among the issues of "Common Sense" was a leaflet concerning "The Federal Reserve Conspiracy" which was written by MULLINS. This leaflet identified MULLINS as EUSTACE CLARENCE MULLINS born Roanoke, Va., and educated at Washington & Lee. He was further identified as a veteran of the Army Air Force during World War II, "a contributor to many periodicals in the United States, Canada and England on political and economic problems. His articles have traced the devious connections of international banking and the international communist conspiracy". It further identified MULLINS as a former member of the staff of Library of Congress, a research assistant to members of Congress and now economist with the American Petroleum Institute.

## IMPEACH EISENHOWER!

President Eisenhower should be impeached while there is still time to save America!

According to Harry Schawtriz, Soviet expert of the New York Times, the person standing next to Stalin on Lenin's Tomb is officially considered the next leader of world Communism. When this picture was flashed to the press, it began the build up of Eisenhower for the Presidency of the United States, by the sinister B'nai B'rith, a behind-the-scenes Jewish agency with an astounding record of collaboration with Communist fronts.

### EISENHOWER AND COMMUNIST SPIES

Few Americans have been permitted to know of Eisenhower's many associations with notorious international Communist agents. Communist propagandists. His Chief of Information in London was James Paul Warburg of Kuhn, Loeb, who has followed the Communist party line for many years; his Special Adviser on Political Affairs (a typical Communist title) was Captain E. M. Warburg of Kuhn, Loeb, his Naval Attache was John Schiff of Kuhn, Loeb and grandson of the backer of the Communist Revolution in Russia. Eisenhower's present political master mind in Washington is Lewis L. Strauss, senior partner of Kuhn, Loeb, who recently reinstated the notoriously pro-Communist Oppenheimer as President of the Institute for Advanced Studies at Princeton and tried to suppress a book revealing Oppenheimer's Communist connections.

#### EISENHOWER SURROUNDED BY JEWISH ADVISERS

In London Eisenhower also had with him as a Special Adviser on Jewish Affairs (which was the real title of the war) Judge Samuel Rifkind, a member of the Wall Street law firm of Weiss, Paul, and Rifkind, which has defended many notorious pro-Communists, most recently Oppenheimer and Harry Bridges. Carol Weiss King, brother of Louis Weiss, senior partner of this firm, was the lawyer for the Communist Party of America. Another member of this firm is Telford Taylor, prosecutor at Nuremberg who sent the legal heads of the German nation to the hangman in a typical example of Communist vengeance.

Telford Taylor, the hero of the Communist Daily Worker, recently delivered a vicious smear attack against the anti-Communist campaign of Senator McCarthy before an audience of West Point cadets, yet McCarthy was allowed no opportunity to reply. Then Taylor defended the Jew Communist Harry Bridges in the fight to keep him from being deported from the America he hates.

When Eisenhower started to write his book, he commissioned as ghost-writer Joseph Barnes of the Red Star, who was identified as a Communist before the House Un-American Activities Committee. Barnes is now senior editor of the Yiddish house of Simon and Schuster. This book was promptly made a Book-of-the-Month Club by Jew Harry Scherman, and Eisenhower was permitted to keep most of the million dollars he made from its sale in one of the strangest income tax deals on record, thanks to his old friend Harry Red Herring Truman, whose daughter endorsed Eisenhower's candidacy for President on a nationwide television program.

Eisenhower was plucked from obscurity as a very average-Army officer by Bernard Baruch and carefully indoctrinated in the purpose of the internationalists. He was jumped over the heads of 246 Brigadier Generals and ever afterwards owed complete allegiance to President Roosevelt and his little clique of Communist personal assistants. This explains why he fights so desperately to halt the investigation of Communists by Senator McCarthy, for the fire is getting very close to the White House.

Eisenhower stoutly defended the vicious General Marshall, who did so much to deliver 400,000,000 helpless Chinese people into hopeless Communist slavery, and inaugurated the slaughter of five million Christians. Can Marshall sleep without the use of dope, when he thinks of the blood on his hands? How can Eisenhower possibly defend this man, unless he feels that he is in the same boat with him?

#### EISENHOWER AND ROSENBERG

Eisenhower felt sympathetic to his friend, the Budapest Jewess Anna Rosenberg, who was identified as a Communist and made Assistant Secretary of Defense. However, he has been advised that it would be too reckless at this time to give her a position in his cabinet.

#### JEWISH OCCUPATION OF GERMANY

When Eisenhower set up the military occupation of defeated anti-Communist Germany, a motley crew of Jewish sadists and Com-

munists was placed in charge. These Yiddish Marxists, who had stayed well behind the fighting forces, began a systematic campaign of torture of helpless German prisoners of war; in one of the blackest pages of our military history, even forcing the wives of these prisoners to become their mistresses.

One of the authorities there was the notorious Max Lowenthal, who now faces questioning. Some of his activities were revealed in a recent speech by Congressman Dondero. His secretary in Germany, an American named George Shaw Wheeler, denounced the United States and took his family to Communist Czechoslovakia to live. Lowenthal wrote a smear book denouncing the anti-Communist work of the FBI, which was published by the leftwing house of William Sloane.

The High Commissioner of Germany was John McCloy, of the firm of Crayath, Swaine, and Moore, lawyers for Kuhn, Loeb, the financiers of the Communist revolution. Assistant High Commissioner was Benjamin Buttenwieser, a partner of Kuhn, Loeb, who kept Alger Hiss in his house while his wife defended him. This was the sinister crew placed in charge of Germany by the Eisenhower influences, and thus the pasty-faced monkeygrinning waterboy for Kuhn, Loeb began his climb to the Presidency of the United States, while the anti-Communist General George Patton died mysteriously in Germany.

#### WHITE GIRLS RAPED IN GERMANY

Eisenhower must also be held responsible for the Negro troops in his command who herded three thousand white girls into a tunnel near Dresden and systematically raped them while their Jewish officers cheered them and reportedly took moving pictures of the scene which were shown before Jewish fraternal organizations in New York City.

#### APPEASEMENT OF RUSSIA

Now Drew Pearson has revealed in his column of November 29th that Eisenhower plans a policy of massive appeasement of Communist Russia, under the leadership of Lewis Strauss of Kuhn, Loeb and the Jewish revolutionary Mendes-France of the Bank of France. Mendes-France, a lifelong agitator for Communism, no sooner took office as Premier of France than he sold out the French people, the Indo-Chinese people, and the whole anti-Communist world by concluding a shameful peace with the Indo-Chinese Communists, handing over twelve million Christians in that unhappy country and condemning them to torture and slavery in Communist concentration camps. It was later discovered that Mendes-France had previously agreed with Molotov of Russia to conclude this surrender even BEFORE he became Premier! A deputy of the Rothschild-owned Bank of France, Mendes-France is one of the principal characters in the international conspiracy of Jewish international bankers and Communist revolutionaries. These Jewish bankers hope to plunge all Christians into hopeless Communist slavery under atheistic mass murderers, and prevent Gentiles from ever recovering Jewish ill-gotten wealth, gold which reeks from the blood of the murdered Christ and the countless millions of slaughtered Christians.

It is a race against time. Can the Jewish conspirators deliver the American people into Communist slavery before the rotten Soviet Government collapses from sheer Jewish incompetence? The American people themselves hold the answer to this terrible question. Will we resist, will we defend our homes and children against Jewish, Asiatic, and African butchers, or will we let ourselves be marched to the slaughter-pits as so many Gentile cattle have been herded to shameful death in the past two thousand years, since the death of our BLESSED PROTECTOR JESUS CHRIST?

Although Eisenhower's policy of appeasing Russia until the Com-

munists are strong enough to crush us, while he strangles any American who dares to oppose Communist traitors, was dictated by the Jewish revolutionary Mendes-France, it actually was laid down by Joseph Stalin in a major party statement in 1949, as the "Policy of Co-Existence," which was first transmitted to the United States by James Paul Warburg of Kuhn, Loeb Co. Now that the Russians are shooting down more American planes and killing American boys, Eisenhower whines that probably WE were at fault! Furthermore, he does nothing to obtain the release of the American boys now rotting in Communist concentration camps.

The Daily Worker rarely criticizes Eisenhower, and indeed, has little reason to do so. The Daily Worker reserves most of its poison for McCarthy, who is also Eisenhower's chief target. If Eisenhower had devoted as much time to fighting Communism as he has to fighting McCarthy, there would be no more Communist threat in America.

#### CONSPIRACY AGAINST McCARTHY

Eisenhower's underground campaign against McCarthy reached a new low in viciousness when the Jews called a secret meeting at the White House. Max Rabb, alias Rabinowitz, dictated a sneak attack on McCarthy which resulted in the Army-McCarthy hearings and the censure debate in the Senate, bringing to a complete halt for ten months McCarthy's fearless investigation of Communism, which was getting very close to the White House. The Daily Worker and Eisenhower, in their common campaign against McCarthy, have only one legitimate complaint, that he is the implacable foe of Communism!

Before McCarthy is through with Eisenhower, Eisenhower will wish that he had stayed in London with his vivacious female "chauffeur" who was with him night and day, according to her memoirs, "Eisenhower Was My Boss," a book which has now disappeared from American libraries in a flagrant example of book-burning! Eisenhower condemns the burning of pro-Communist books, just as he fought for "academic freedom" for pro-Communist professors at Columbia University. However, he hasn't got much use for anti-Communist writers and professors, as I can testify from experience. This is the testing point for liberals. They whine for mercy for the Communist rats and traitors in this country, but anyone who dares to oppose Communism is dealt with mercilessly, fired from his job and hounded into an early grave by the pack of howling Communist hyenas in radio, television, the daily press, and the movies.

#### NEGROES FORCED INTO WHITE HOUSE

The most shameful page in our nation's history has been inaugurated with the Supreme Court and all the power of the Federal Government thrown behind the campaign to force whites to intermarry with Negroes. The purpose of this campaign is to provoke a civil war in the United States, as whites attempt to defend their homes and families from Negro rapists. This civil war, Eisenhower's Jewish advisers desperately hope, will give Soviet Russia breathing space and time to strengthen herself for the coming world war and the world victory of Communism. Jewish hatemongers have forced the Negro people to become helpless pawns in this vicious campaign in which thousands of Negroes run the risk of being slaughtered. Anything to help Russia gain time!

As of possible interest to your Service, there are enclosed a Photostat of a publication entitled "Impeach Lisenhower!" by Eustace Mullins and a Photostat of an envelope postmarked February 7, 1955, at Chicago, Illinois. The envelope contains the return address "We the Mothers Mobilize for America."

The publication and its envelope were referred to this Bureau by the Honorable Richard E. Lankford, Member of Congress, by letter dated February 8, 1955. Congressman Lankford's letter has been acknowledged.

The files of the FBI reflect that the captioned organization, which is located at 537 South Dearborn Street, Chicago, Illinois, was described in 1953 as an anti-Semitic and anti-Communist organization. It publishes monthly a publication entitled "Woman's Voice," of which approximately three thousand copies are printed monthly. In 1953 the organization reportedly had between twenty and twenty-five members with an additional following of twenty-five to thirty persons. Mrs. Lyril Clark Hynig, editor of "Woman's Voice," is the reported head of the organization. The organization depends on contributions and subscriptions to finance its publications.

NOTE ON YELLOW:

The publication "Impeach Eisenhower" demands an immediate impeachment of President Dwight D. Eisenhower because of alleged association with Communist, because he opposed Senator McCarthy, and because he has associated with certain Jewish persons. Congressman Lankford's letter was acknowledged by Bureau letter dated 2-15-55 and Photostats of the enclosures were furnished to the Department of Justice, Post Office Department, and General Robert Cutler, Special Assistant to the President.
