**THE PROVISIONS OF THE CONSTITUTION**

**ARTICLE I**

Section 1. All legislative Powers herein granted shall be vested in a Congress of the United States, which shall consist of a Senate and House of Representatives.

Section 2. The House of Representatives shall be composed of Members chosen every second Year by the People of the several States, and the Electors in each State shall have the Qualifications requisite for Electors of the most numerous Branch of the State Election.

Section 3. The Senate of the United States shall be composed of two Senators from each State, chosen by the Legislature thereof, for six Years; and each Senator shall have the Qualifications requisite for Representatives.

Section 4. The Times, Places and Manner of holding the Elections of Senators and Representatives, shall be prescribed in each State by the Legislature thereof; but the Congress may at any time by Law alter the Times, Places and Manner of holding such Elections, when it may be necessary or expedient.

Section 5. The Congress shall assemble at least once in every Year, and such Meeting shall begin on the first Monday in December, unless they shall by Law provide otherwise.

Section 6. The Congress shall be held at such Place as they may by Law determine; and until they shall so determine, they shall meet at the City of New York.

Section 7. All bills for raising Revenue shall originate in the House of Representatives; but the Senate may propose or concur with Amendments as to the Form of such Bills.

Section 8. The Congress shall have Power to lay and collect Taxes, Duties, Imposts and Excises, to regulate Commerce with foreign Nations, to borrow Money on the Credit of the United States, to define and punish Offences against the Law of Nations, to define and punish Piracies and Felonies committed on the high Seas, and Offences against the Law of Nations;
