

— NOTICE —
REFUSAL OF VACCINE FOR CAUSE

- I do not know the complete contents of the vaccine
- You have not advised me of the complete contents of the vaccine
- I believe **you do not know** the complete contents of the vaccine
- You have not advised me of all known or possible effects of the vaccine
- I believe **you do not know** all such effects of the vaccine
- I do not believe the vaccine is safe
- I know that vaccines have been found to contain toxic adjuvants and toxic foreign materials, including heavy metal compounds, mRNA, other human RNA/DNA including MRC-5, and foreign species' RNA/DNA
- **My medical records clearly indicate that I will suffer a life-threatening anaphylactic reaction if exposed to the adjuvants and/or additives in vaccines**
- I know that toxic contamination is present in vaccines and that this contamination is easily preventable with current technology. This suggests **intentional** contamination of vaccines with toxic agents
- I know that many vaccines are not effective and actually **cause** the ailment they are purported to mitigate
- I know that the adjuvants in vaccines are intended to 'shock' the human immune system into an extreme response, and that they are known cause a biological 'crisis', cytokine storms and other damage to the immune system, blood and the whole body
- I know that the vaccine is likely to cause an iatrogenic reaction with other medications
- I know that vaccine death and injury statistics and information are suppressed by media which receives billions of dollars in pharmaceutical advertising annually
- I know that vaccine death and injury statistics and information are routinely suppressed by governments, and that pharmaceutical regulatory agencies are largely run and controlled by pharmaceutical industry executives, loyalists and lobbyists
- I know that vaccines kill hundreds of thousands of people per year
- I am aware of peer-reviewed evidence that vaccine experiments have caused tens of thousands of cases of sterilisation, NPAFP, autism and other diseases and injuries globally
- I know that vaccines are so hazardous that the vaccine industry lobbied for, and received in 1986, legal indemnity from the harm vaccines cause
- I know that taxpayers have paid billions of dollars to families whose members were injured or killed by vaccines
- I do not trust the vaccine industry, government agencies or international agencies which seem to be acting on behalf of vaccine sales and promotion, and suppressing information of vaccine hazards
- **I know that no vaccine has ever been tested or proven safe using a controlled, double-blind study using an inert placebo group**
- I know that, under current law, a physician or healthcare worker must have my consent to administer medicine to me. **My consent is hereby denied and refused**

- I know it is possible to mitigate and control all alleged contagious diseases with safer and more effective means than vaccination
- No—you may **not** vaccinate me or any member of my immediate family
- Anyone who claims privilege to inject substances into my body without my consent is my enemy, and commits a criminal act if they inject, or forcibly attempt to inject, such materials
- I will treat anyone who threatens to violate my body, or the body of my family member, as a criminal assailant
- If you attempt to do so, it is highly probable **I will form a reasonable belief that I, or another, face an imminent threat of being killed or grievously injured, and I will exercise my right to self-defence/defence of another, against you and your accomplices, to the full extent afforded by Common Law**
- The administering of a vaccine is a medical service. Section 51 (xxiiiA) of ‘The Constitution’ states that laws may **not** be made so as to authorise the conscription of a medical service. If there is a law, regulation or other statutory ‘mandate’ for forced medication, it is unconstitutional, unlawful and therefore unenforceable
- You may not attempt or threaten non-consensual vaccination, and if you do, you will be brought before an authorised officer to be dealt with according to law
- Your ignorance, wanton or otherwise, of vaccine hazards and medical rights and your inability to understand the facts above do not give you any legal immunity or any license, implied or otherwise, to medicate me or my immediate family without my consent
- You have not offered to personally take full responsibility to pay or compensate me for any harm your vaccine causes
- Ipso facto, you do not have the authority or privilege to forcibly administer vaccines
- If you fail to immediately cease all threats of vaccination against me or my immediate family, I cannot assure your physical safety
